(57) **CLAIM**

The ornamental design for a non-pneumatic tire, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a non-pneumatic tire showing my design;

FIG. 2 is a front view thereof;

FIG. 3 is a top view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a rear view thereof;

FIG. 6 is an enlarged section view taken along line 6-6, between 6-6 in FIG. 2; and,

FIG. 7 is another perspective view thereof, showing the non-pneumatic tire in use.

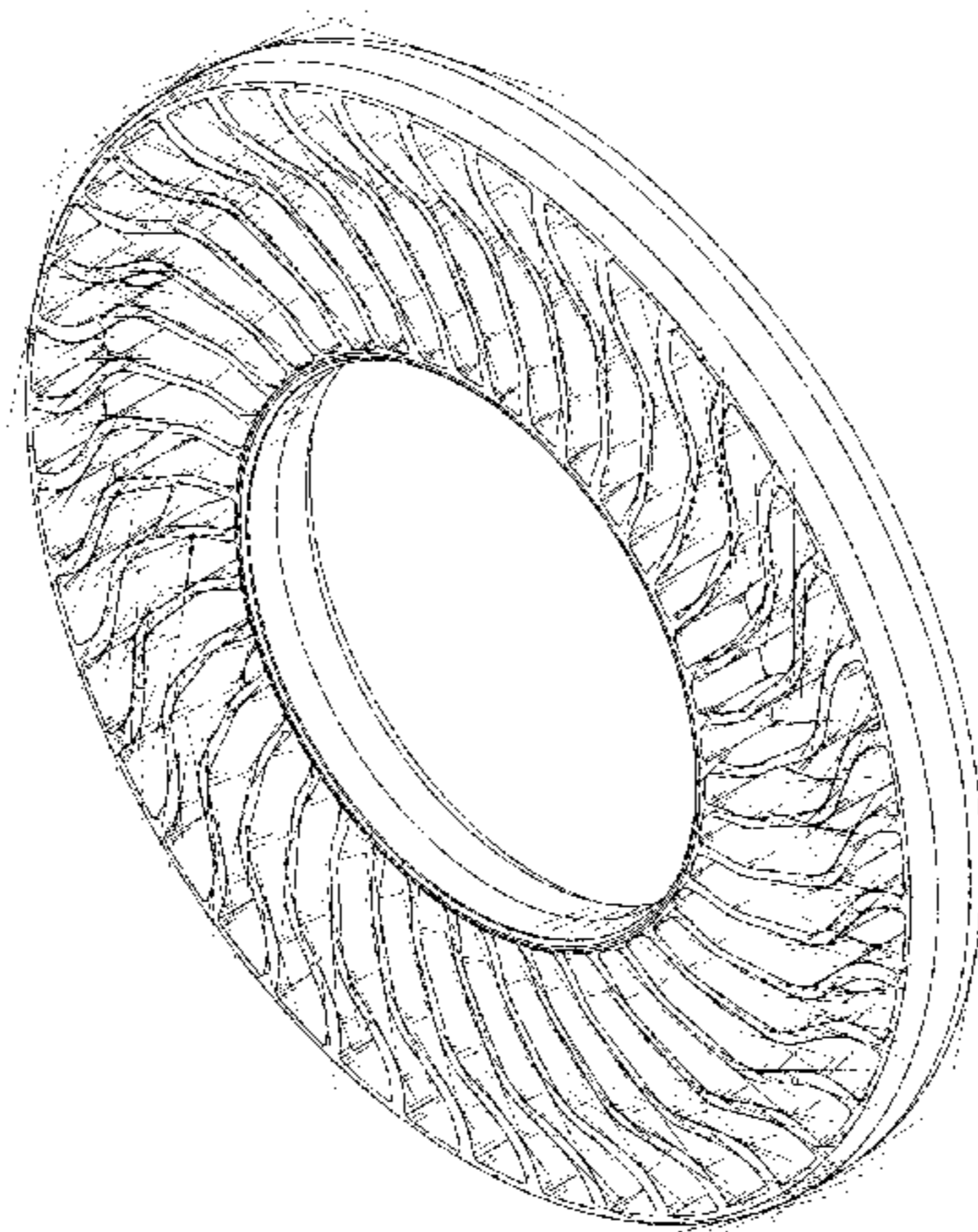

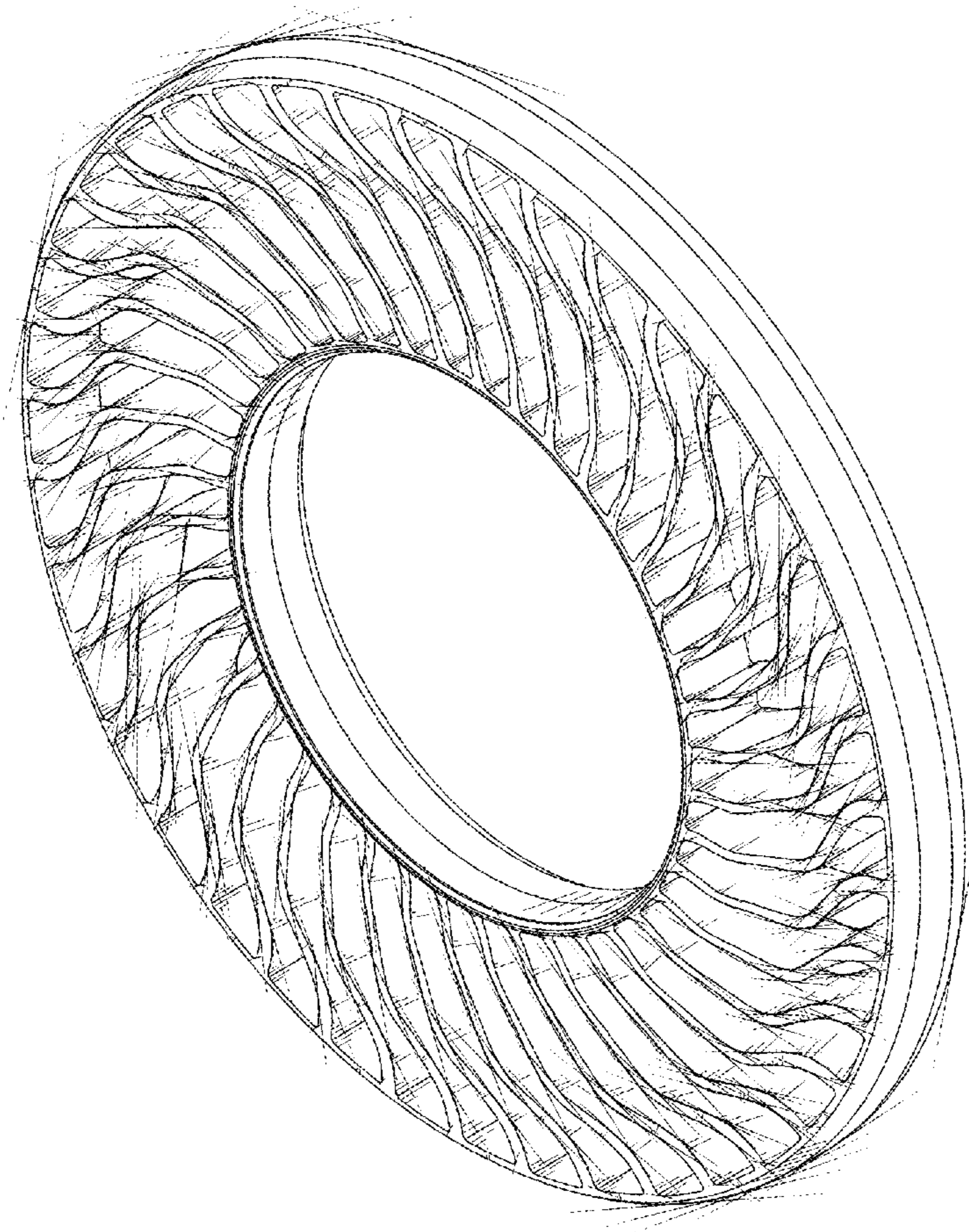

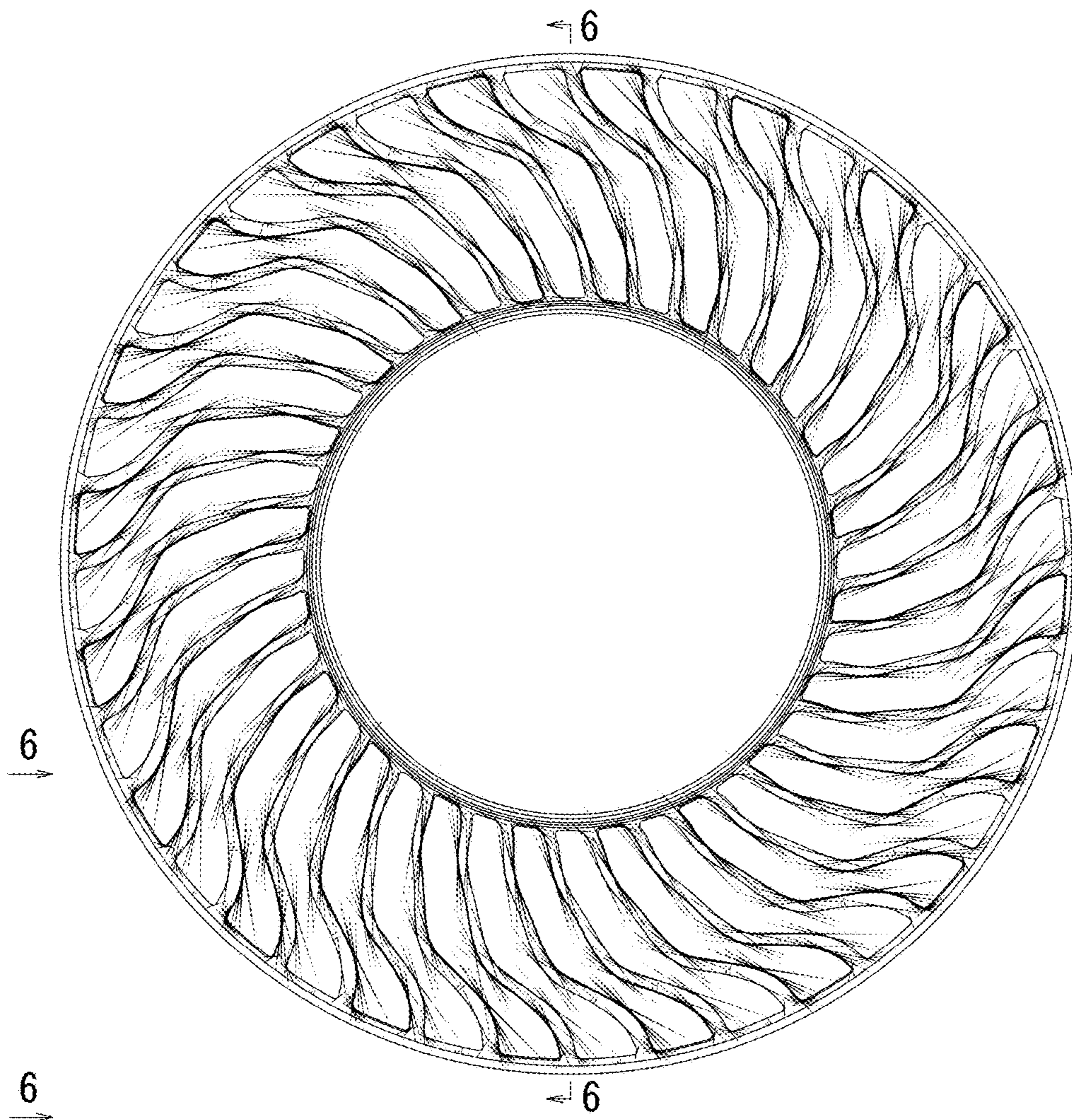

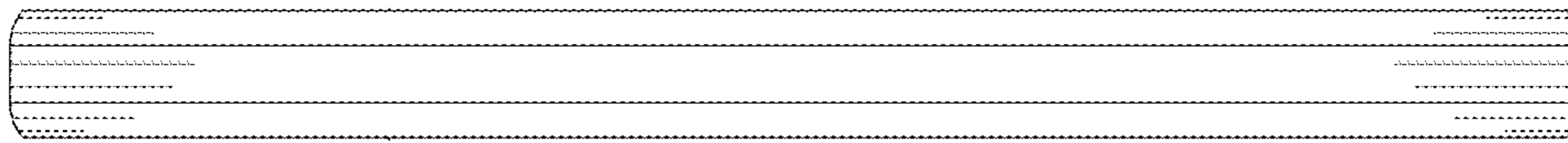

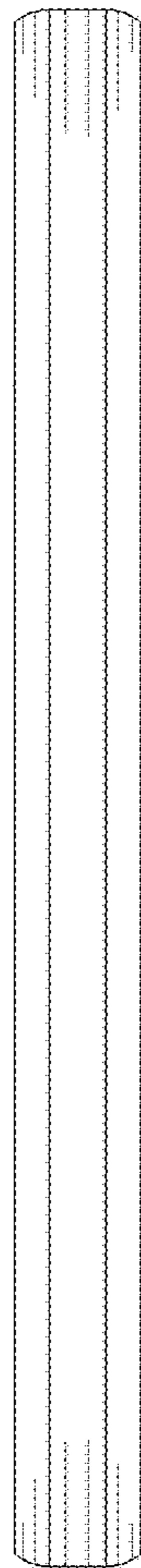

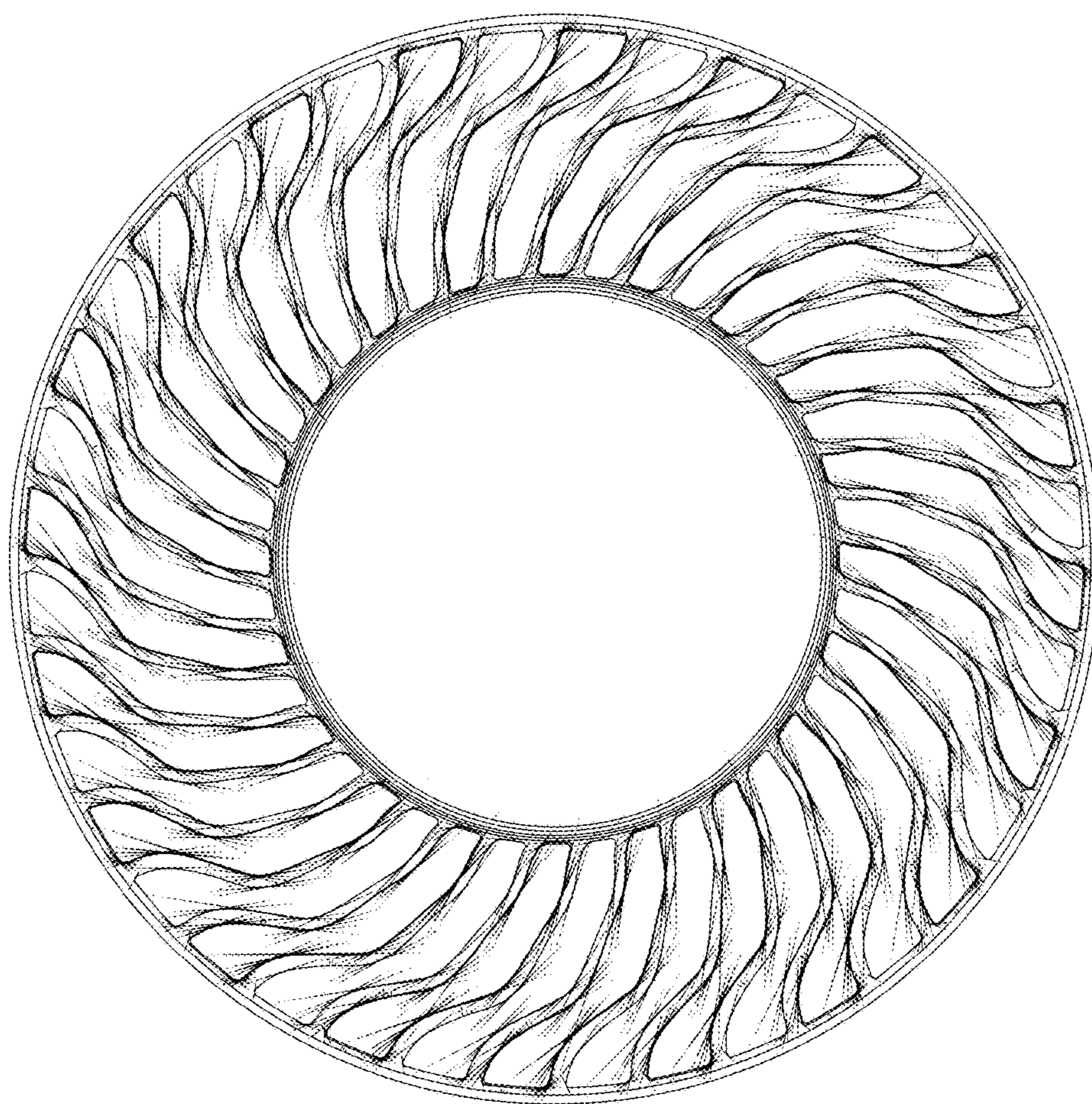

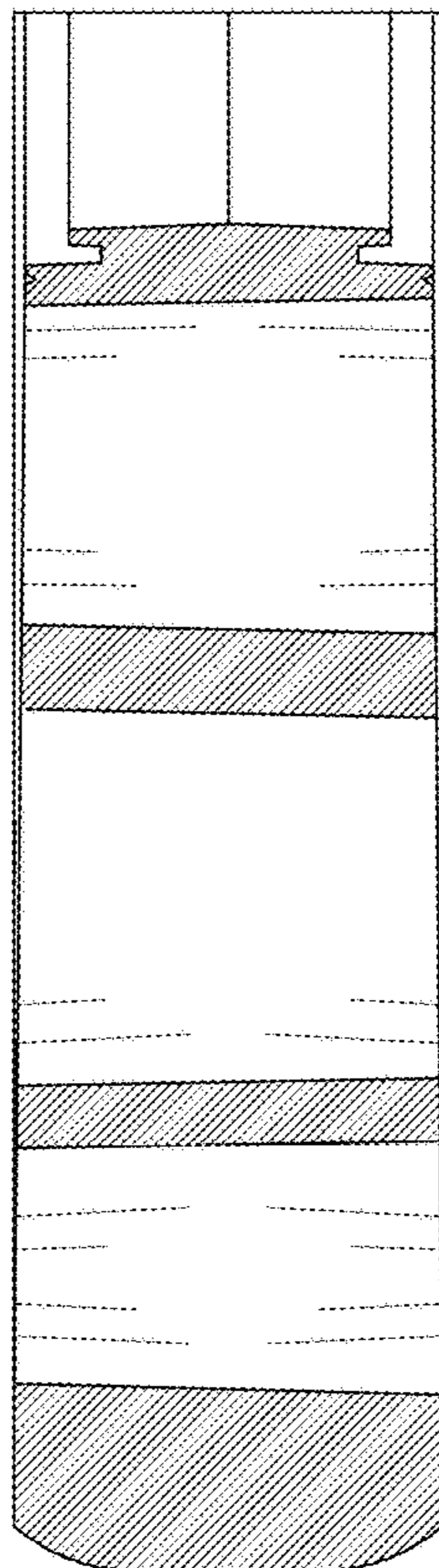
