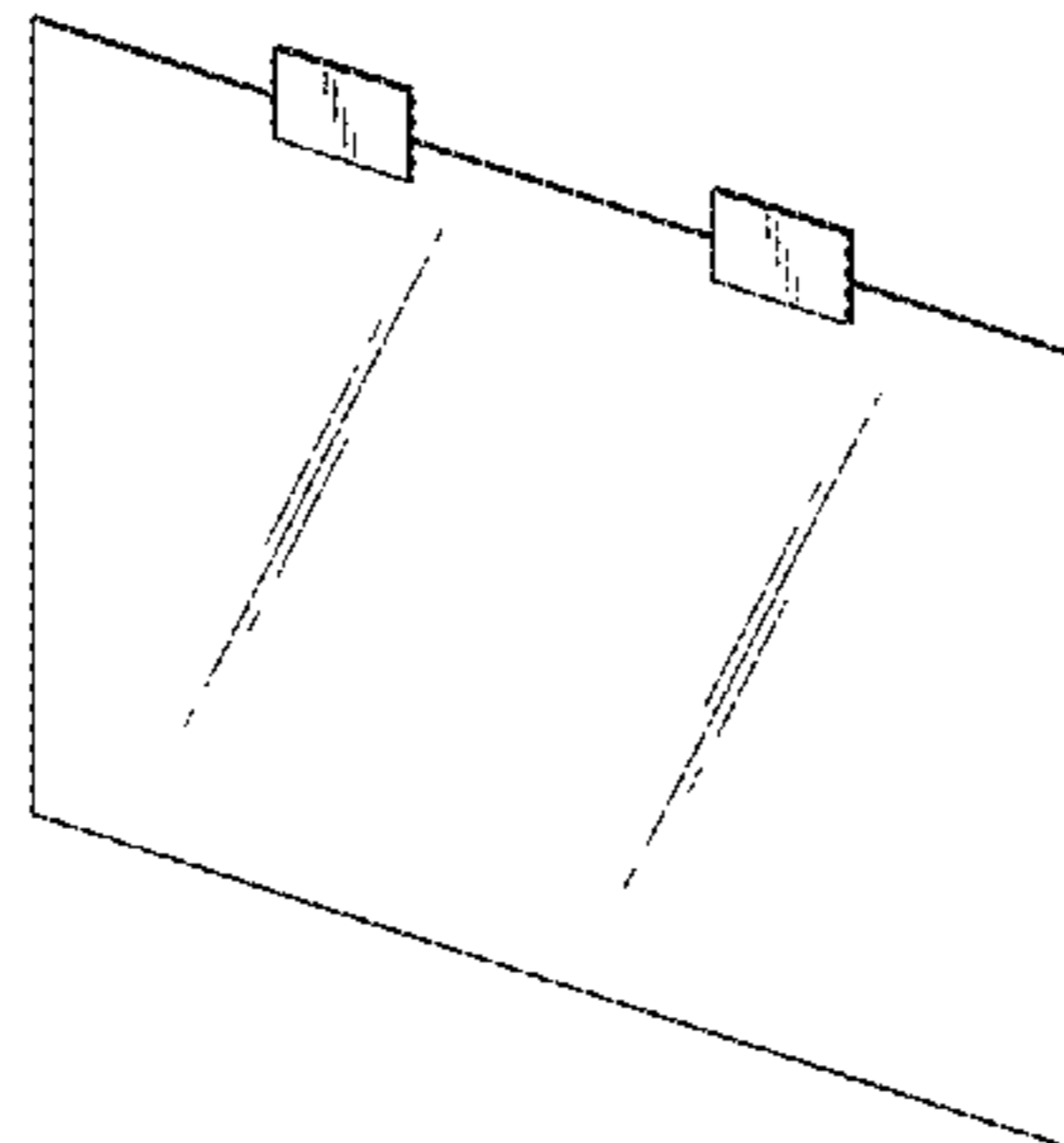
(57) **CLAIM**

The ornamental design for a privacy filter with mounting tape for electronic display device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the new design for a privacy filter with mounting tape for electronic display device; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a left side view thereof; and, FIG. 8 is a perspective view showing the privacy filter with mounting tape for electronic display device in an environment of use. 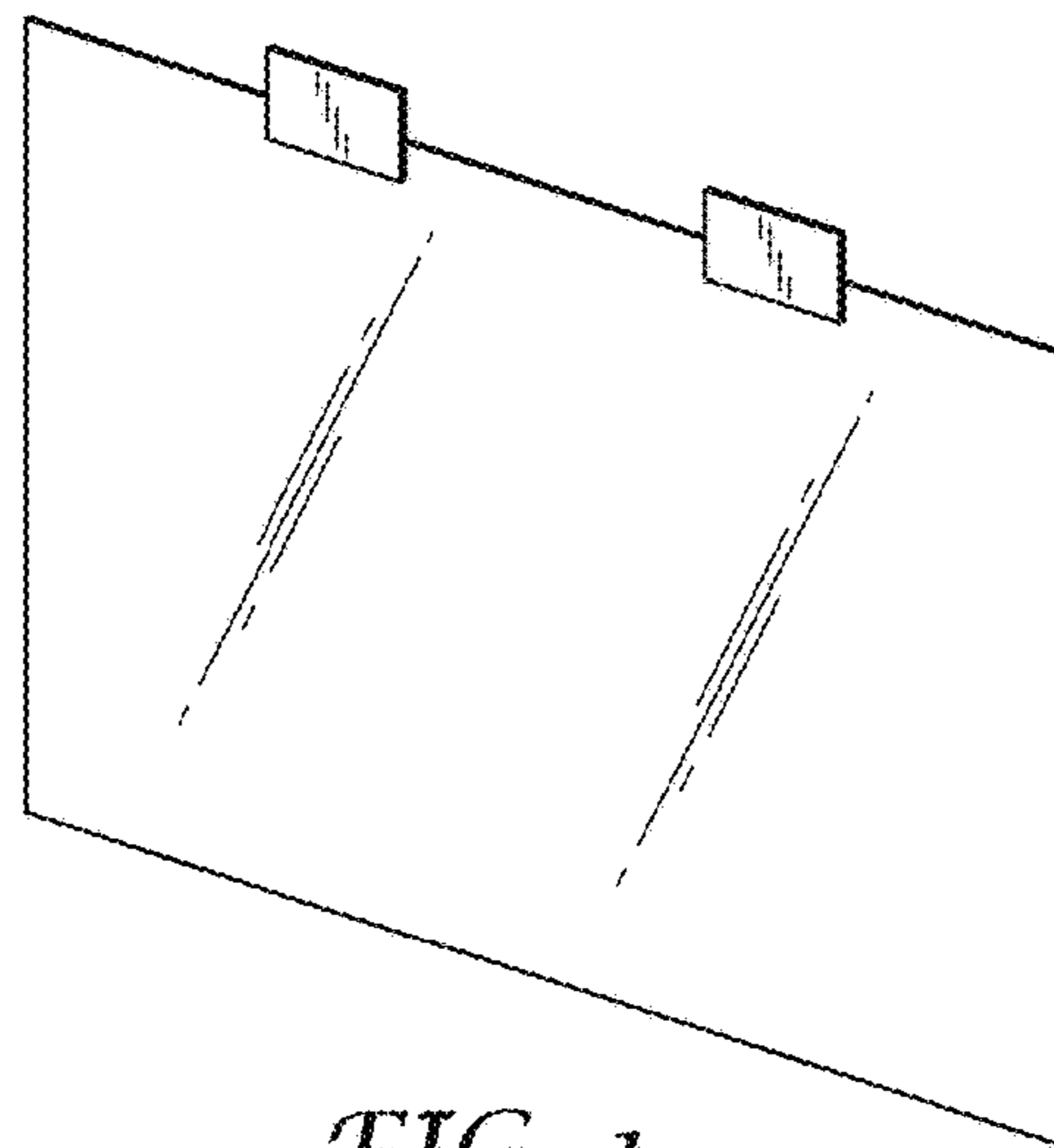

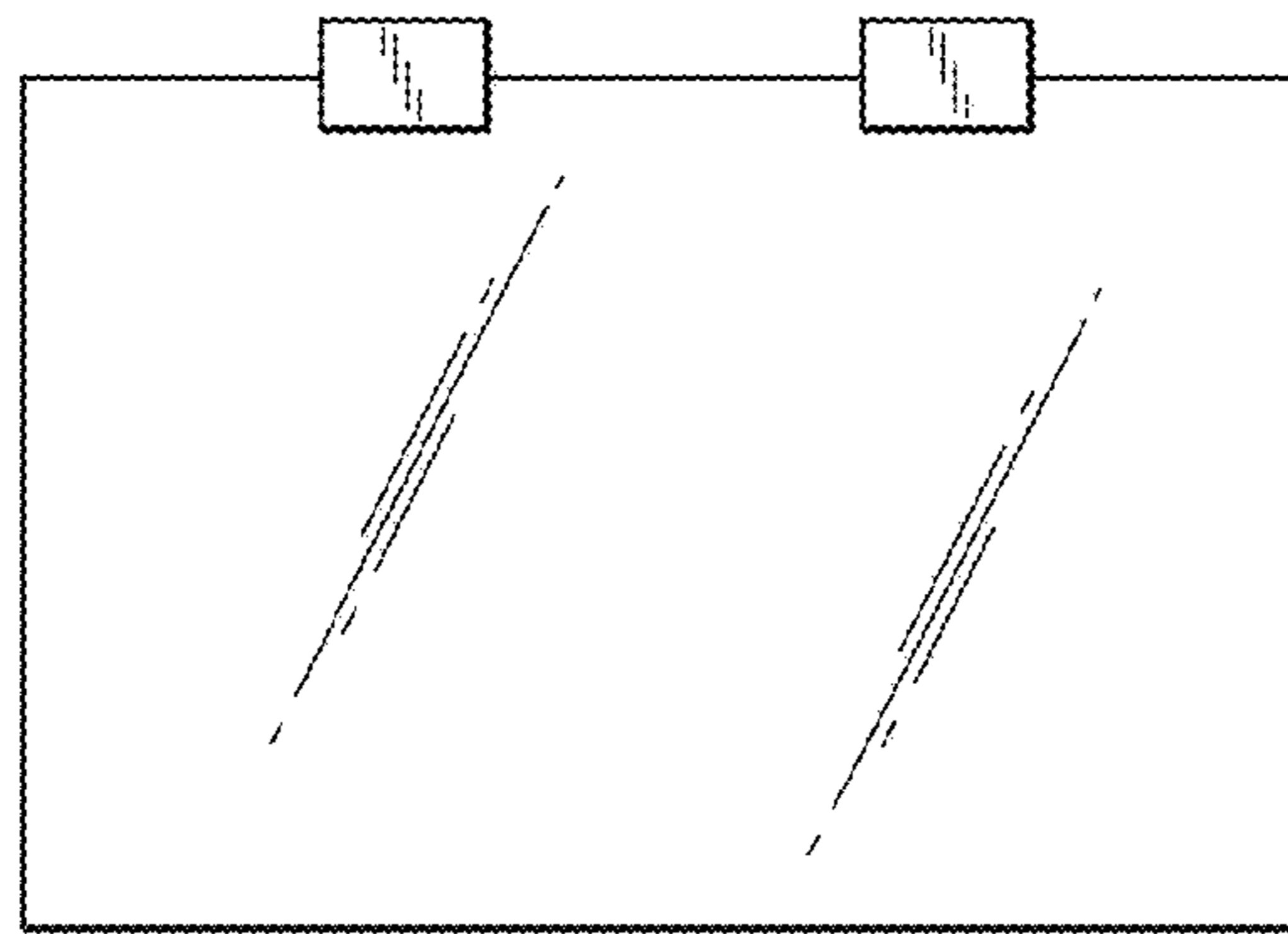

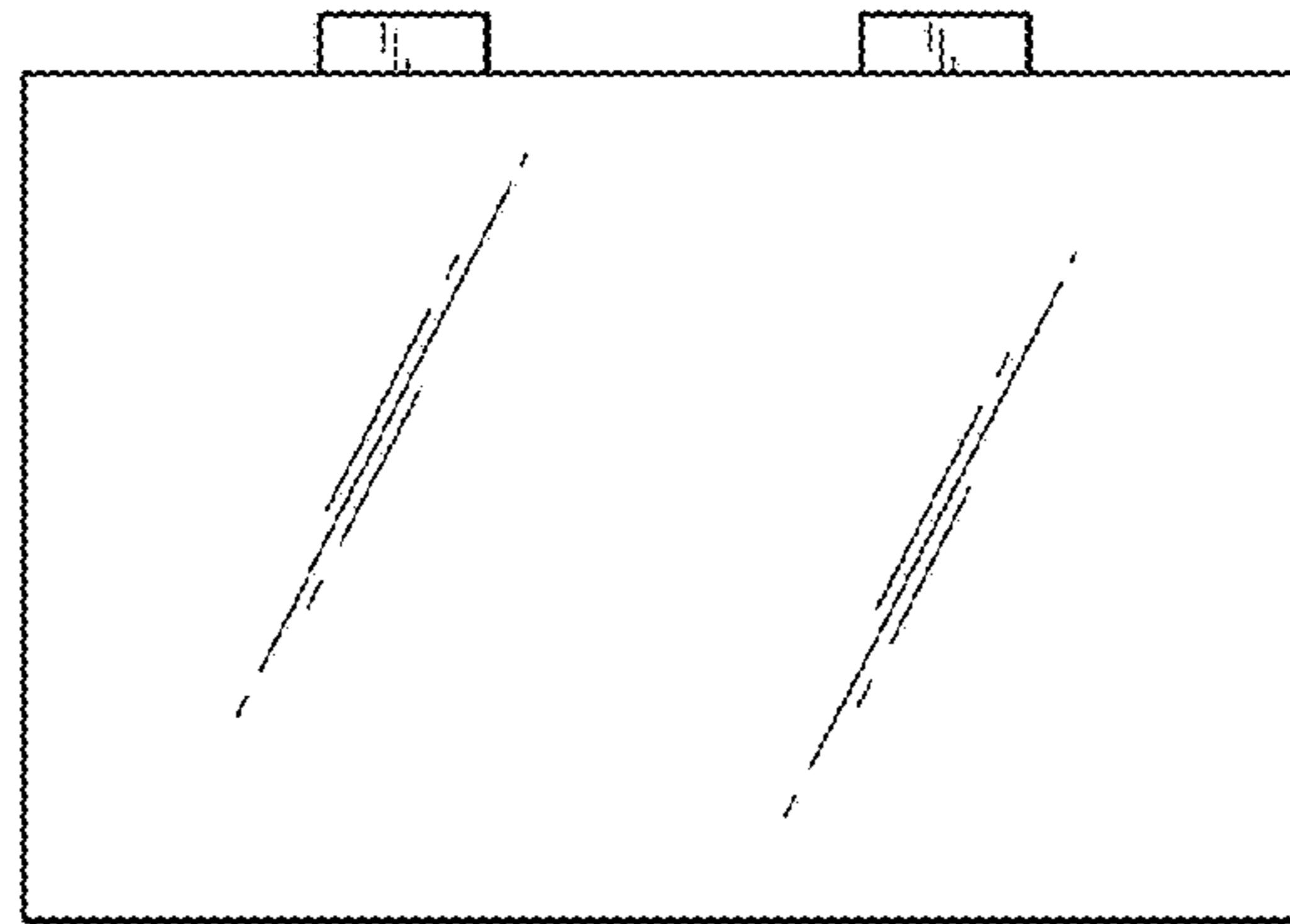

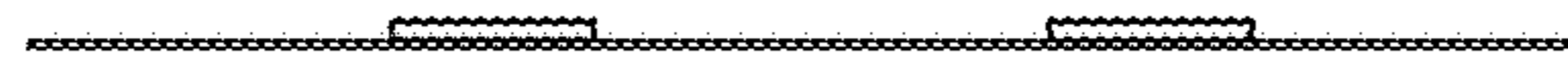

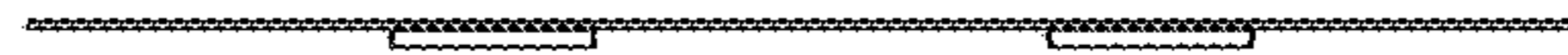

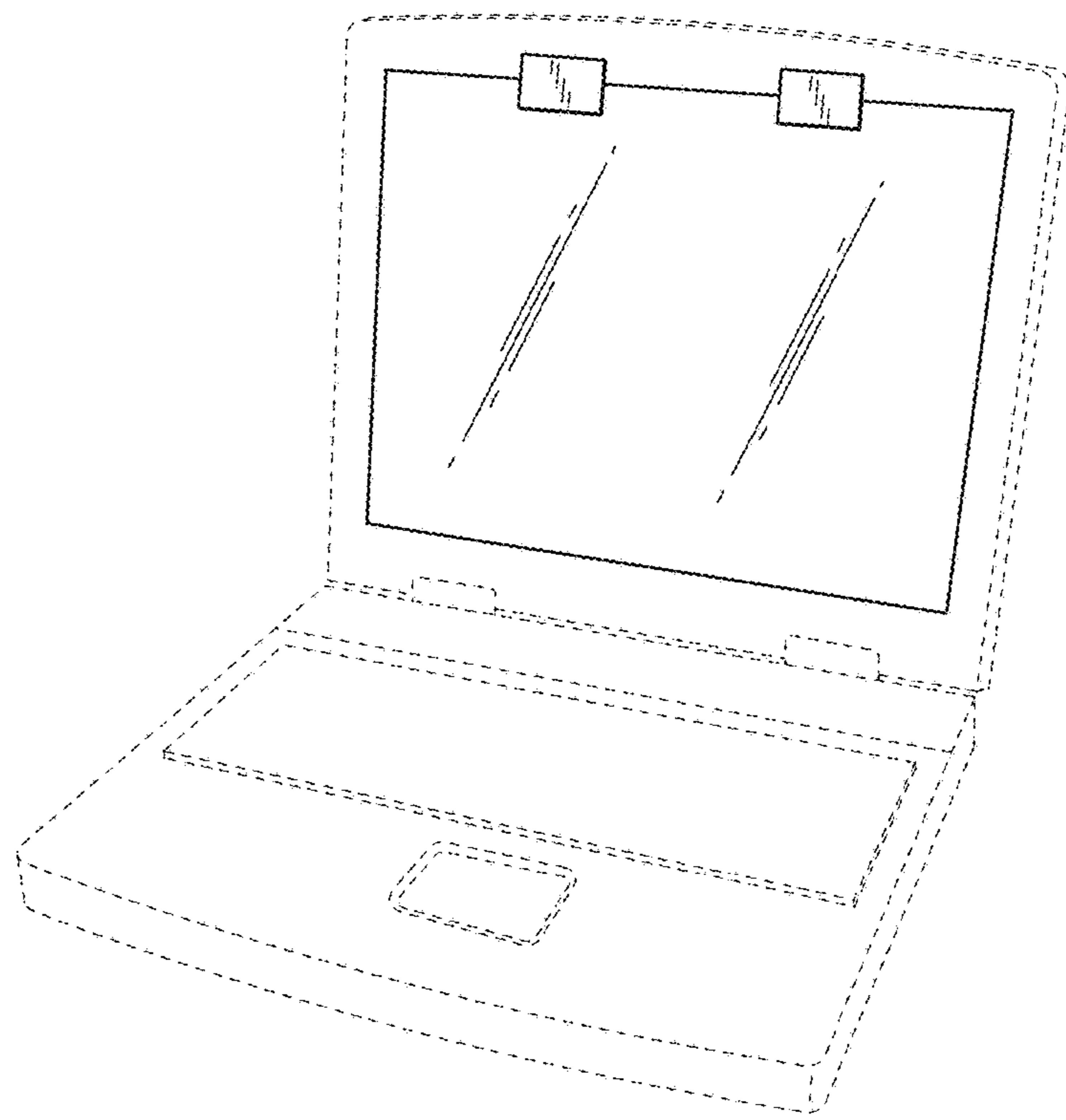
