(57) **CLAIM**

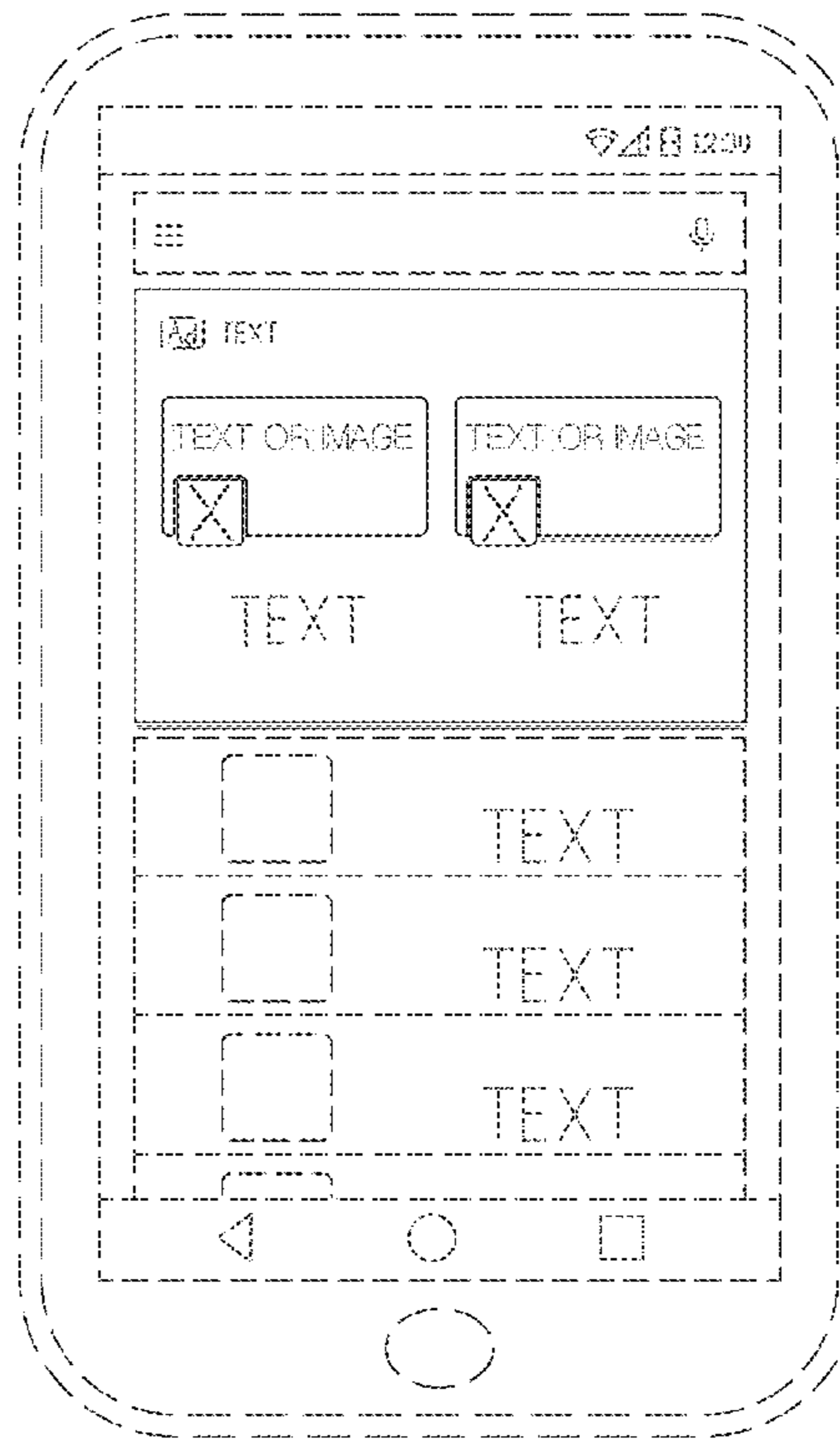
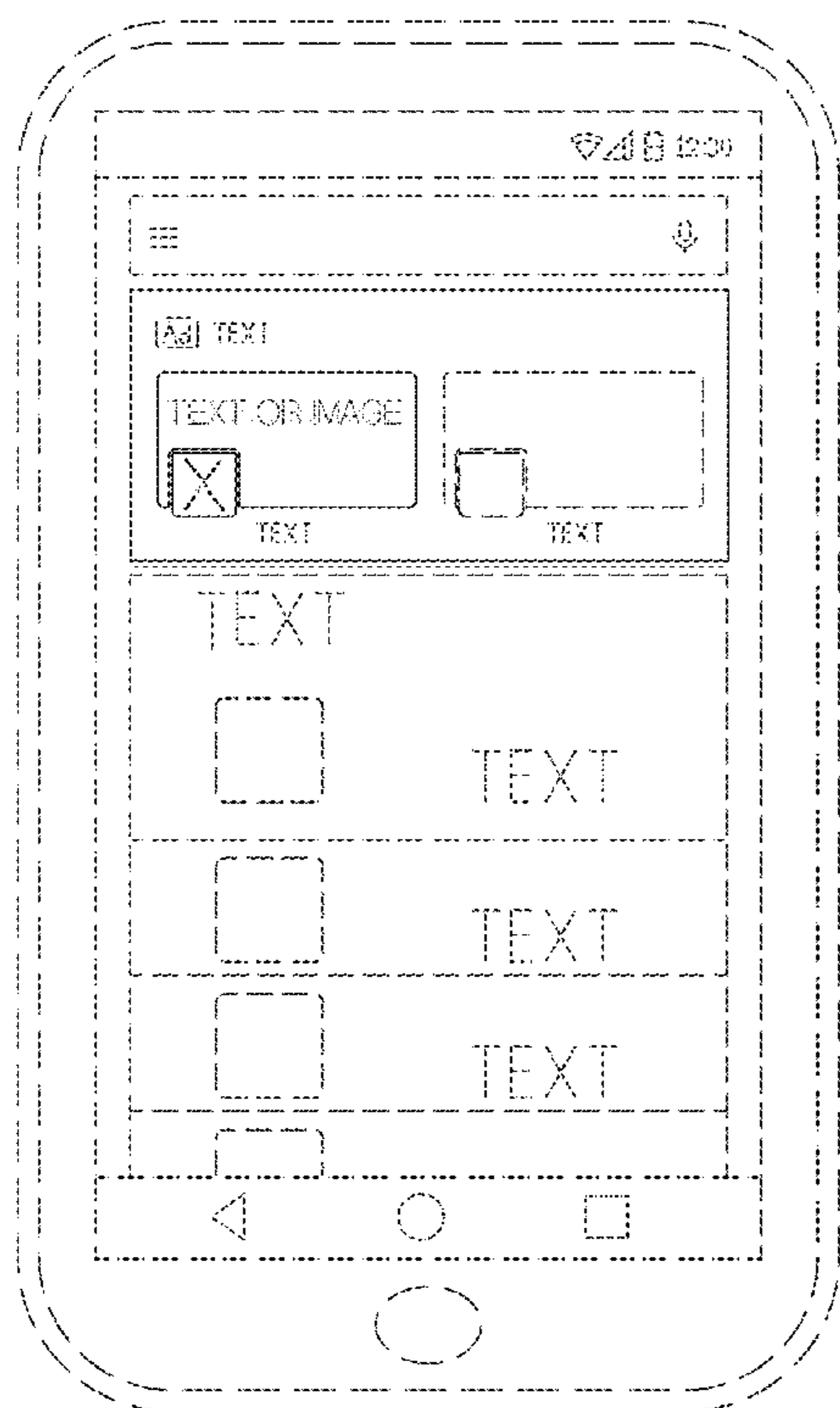
The ornamental design for a computer with icons in a graphical user interface, as shown and described.

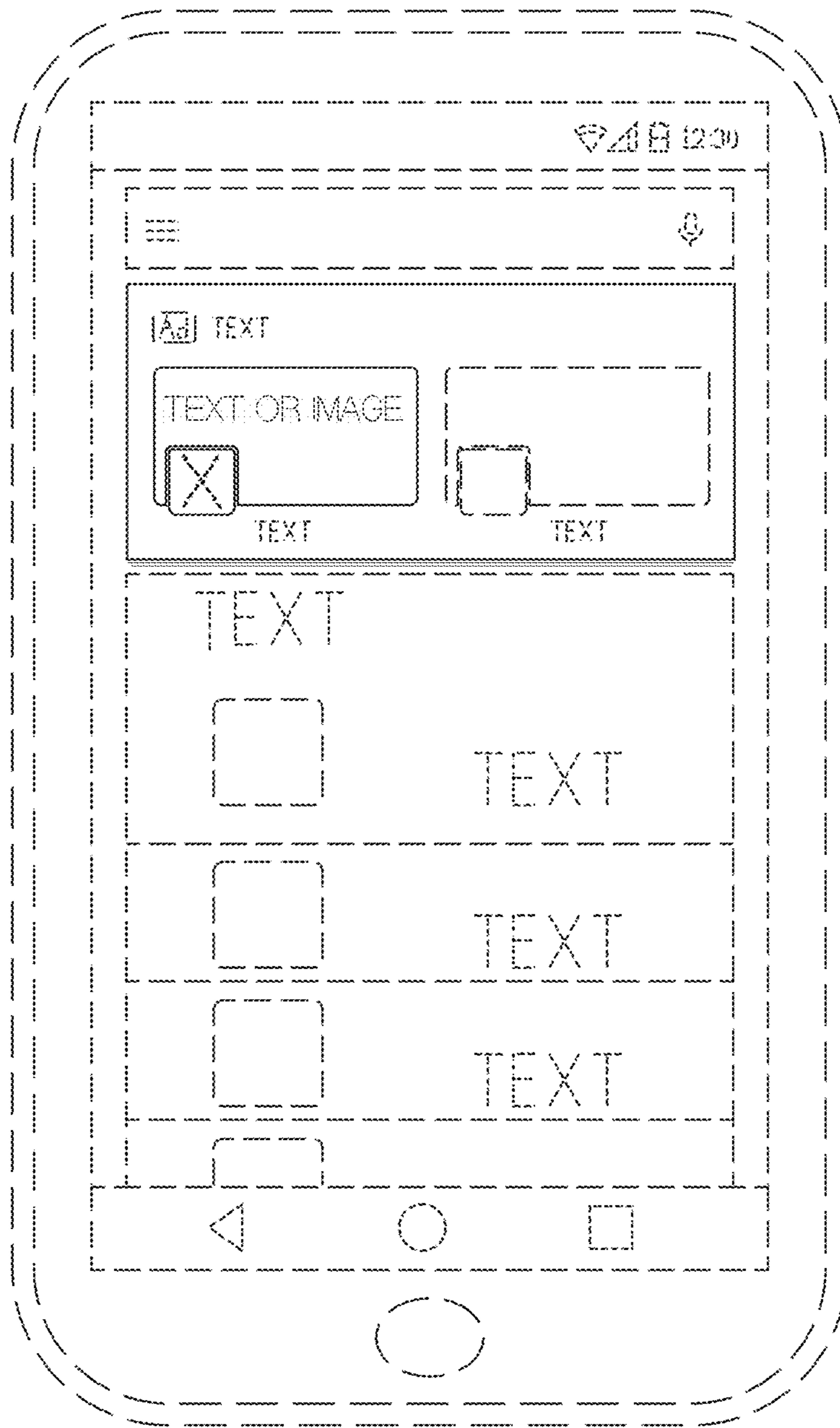

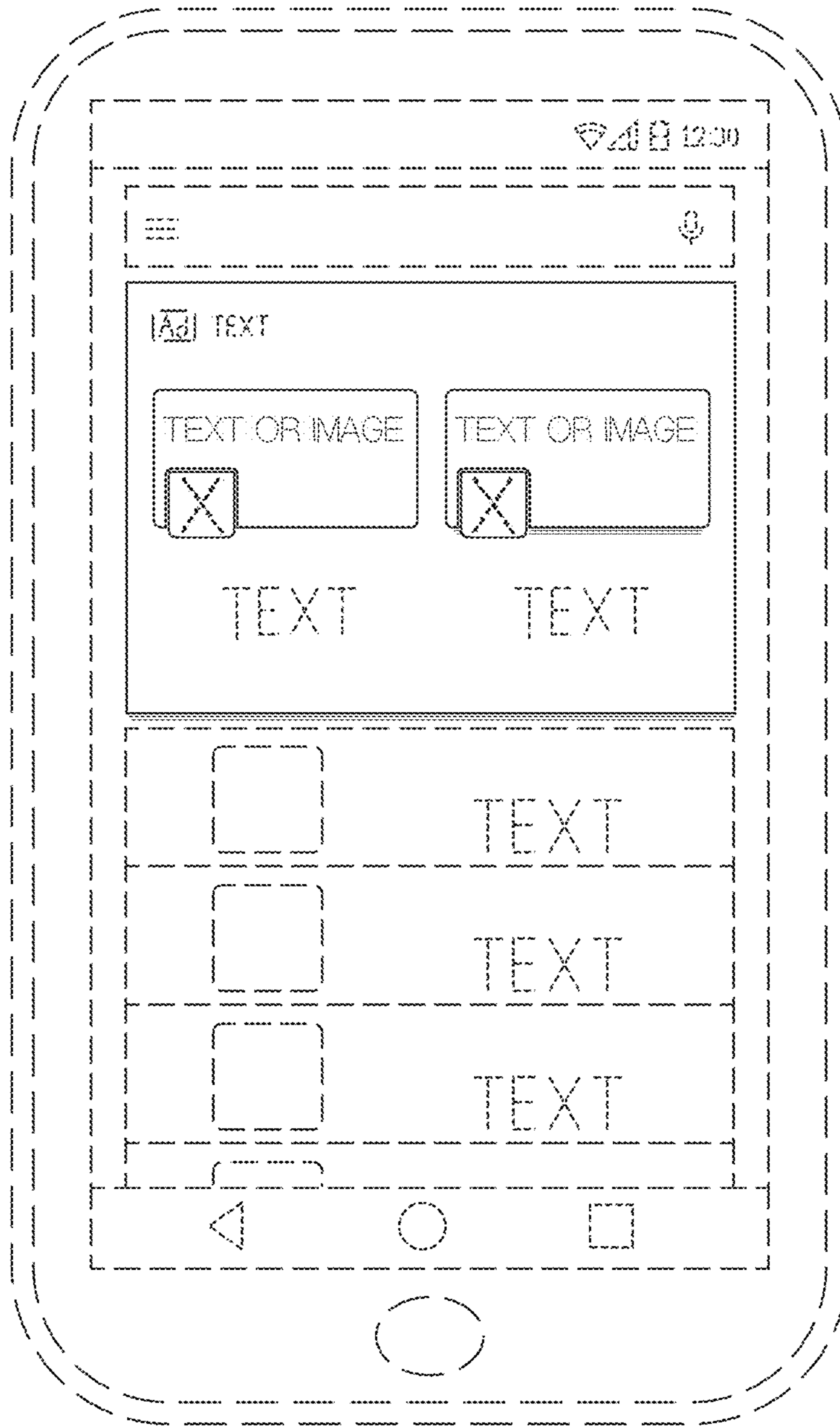
