FIG. 1 is a first image of a display screen with animated graphical user interface;

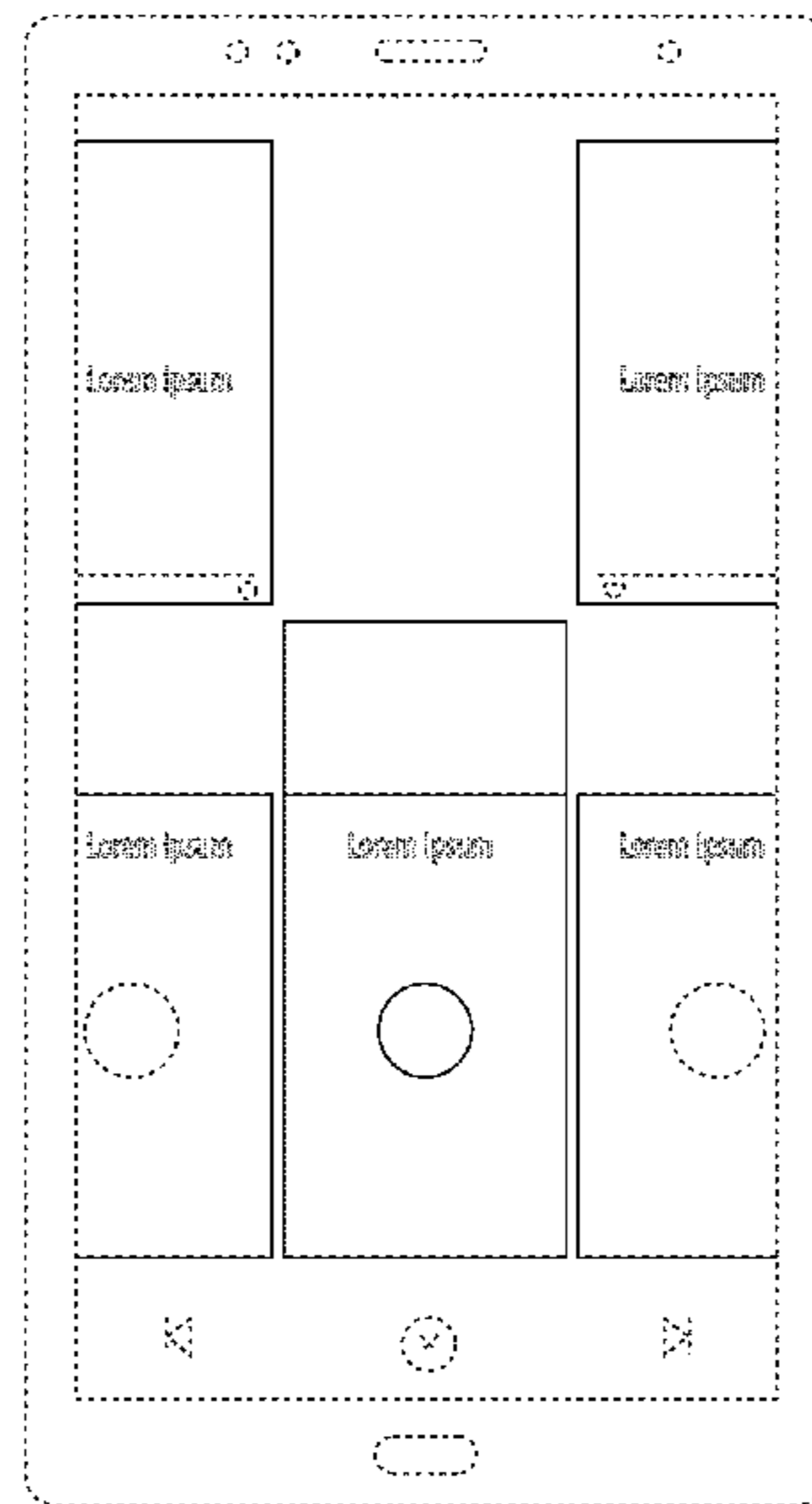
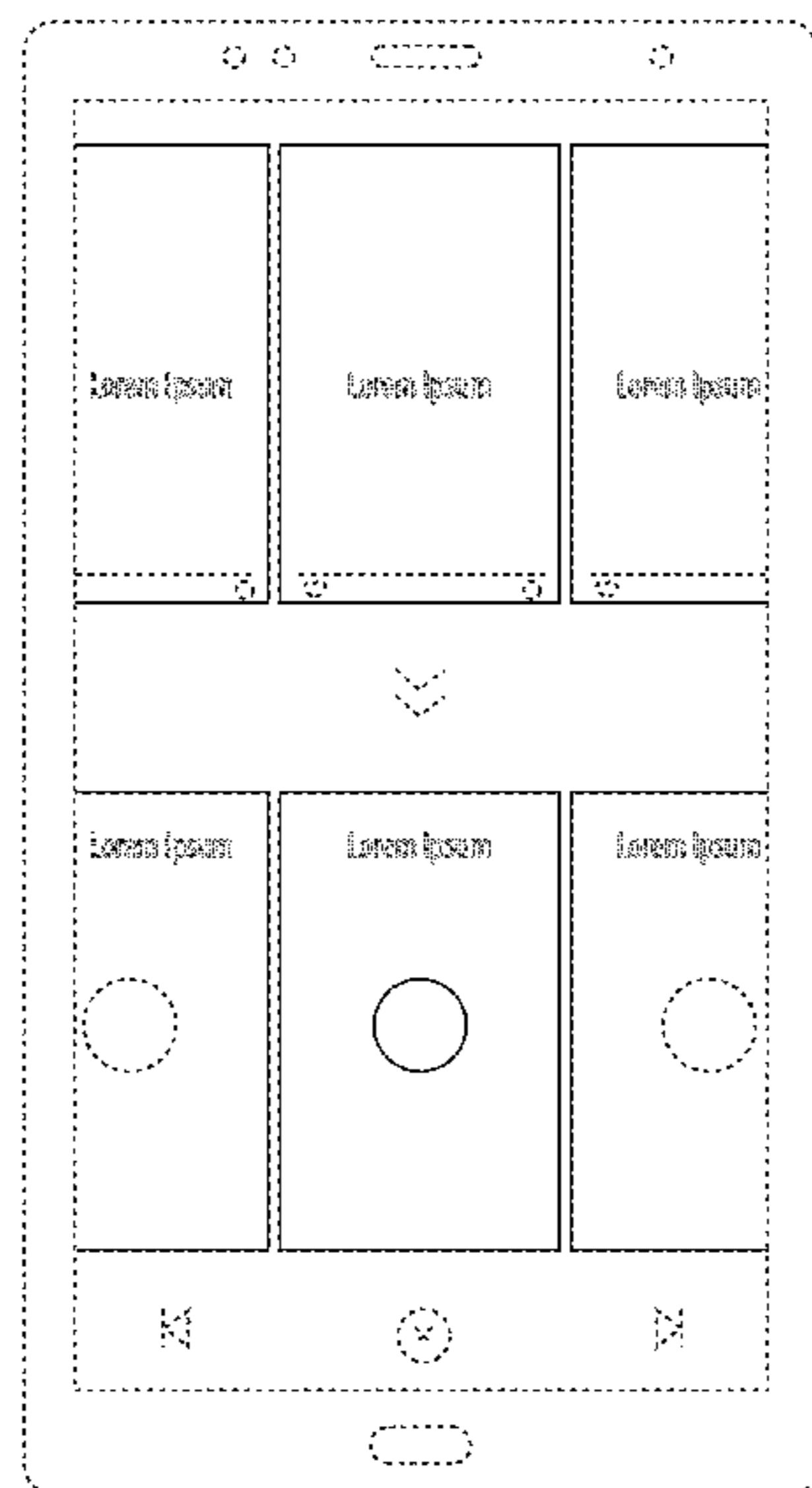
FIG. 2 is a second image thereof;

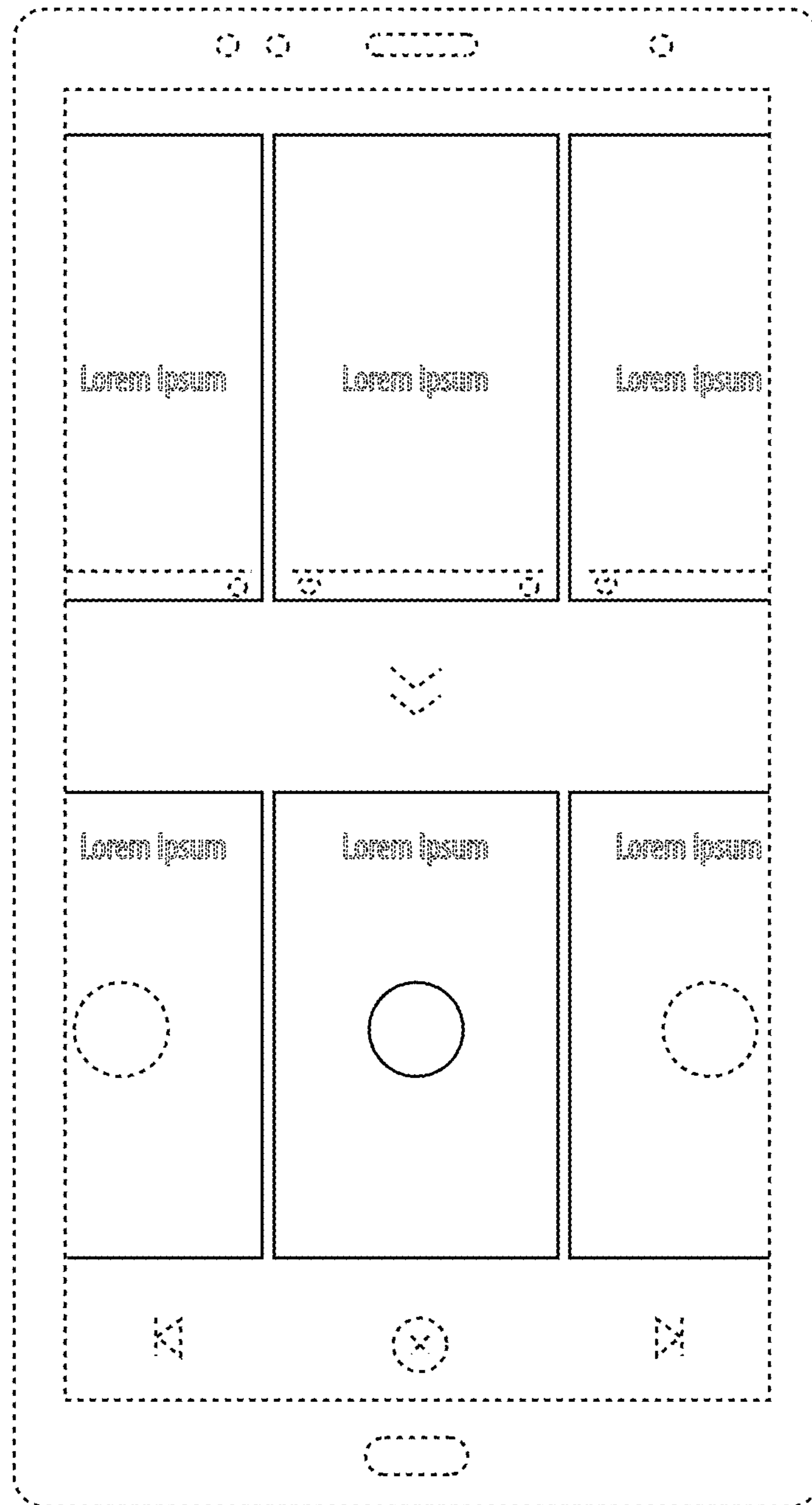

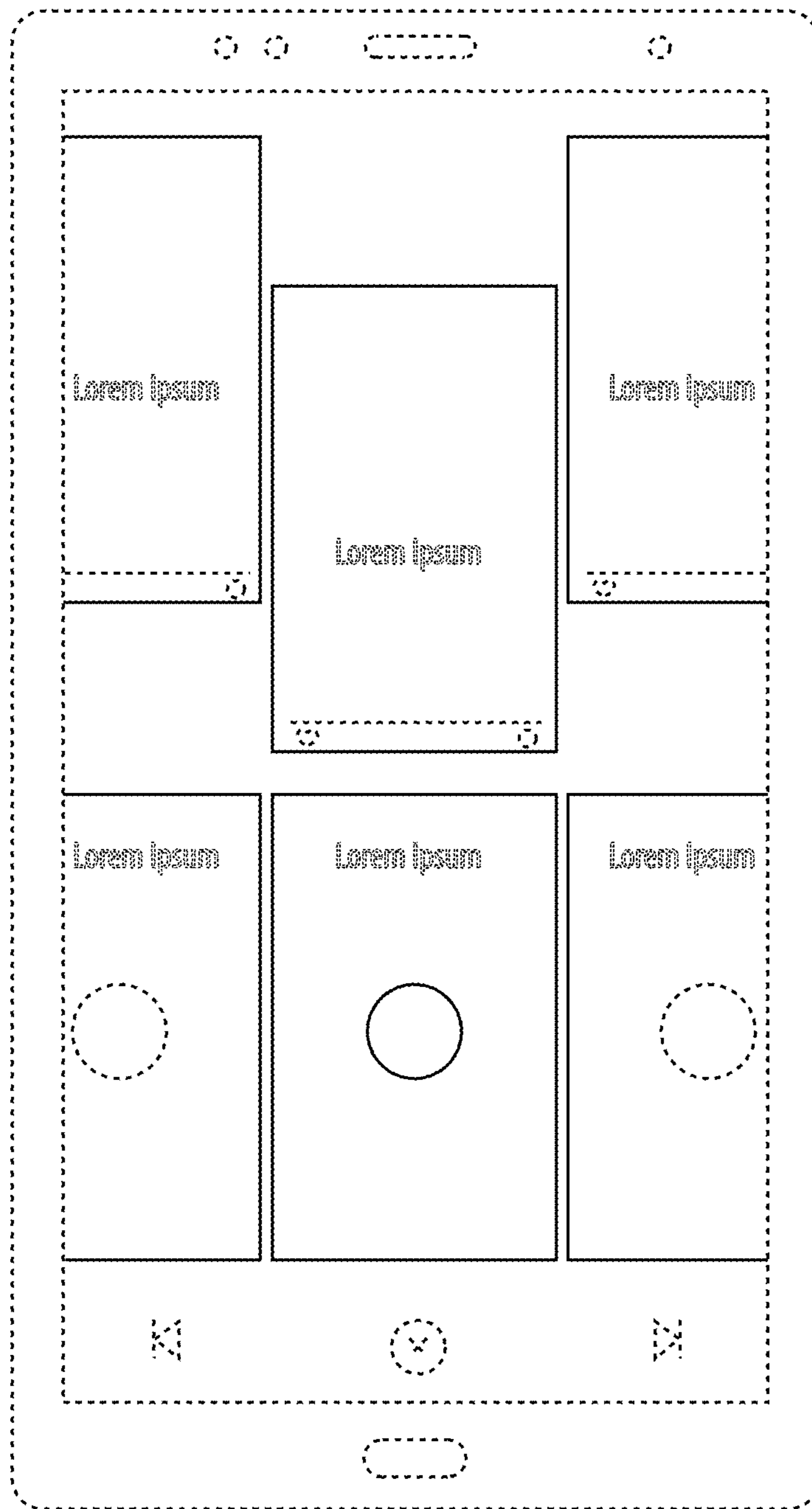

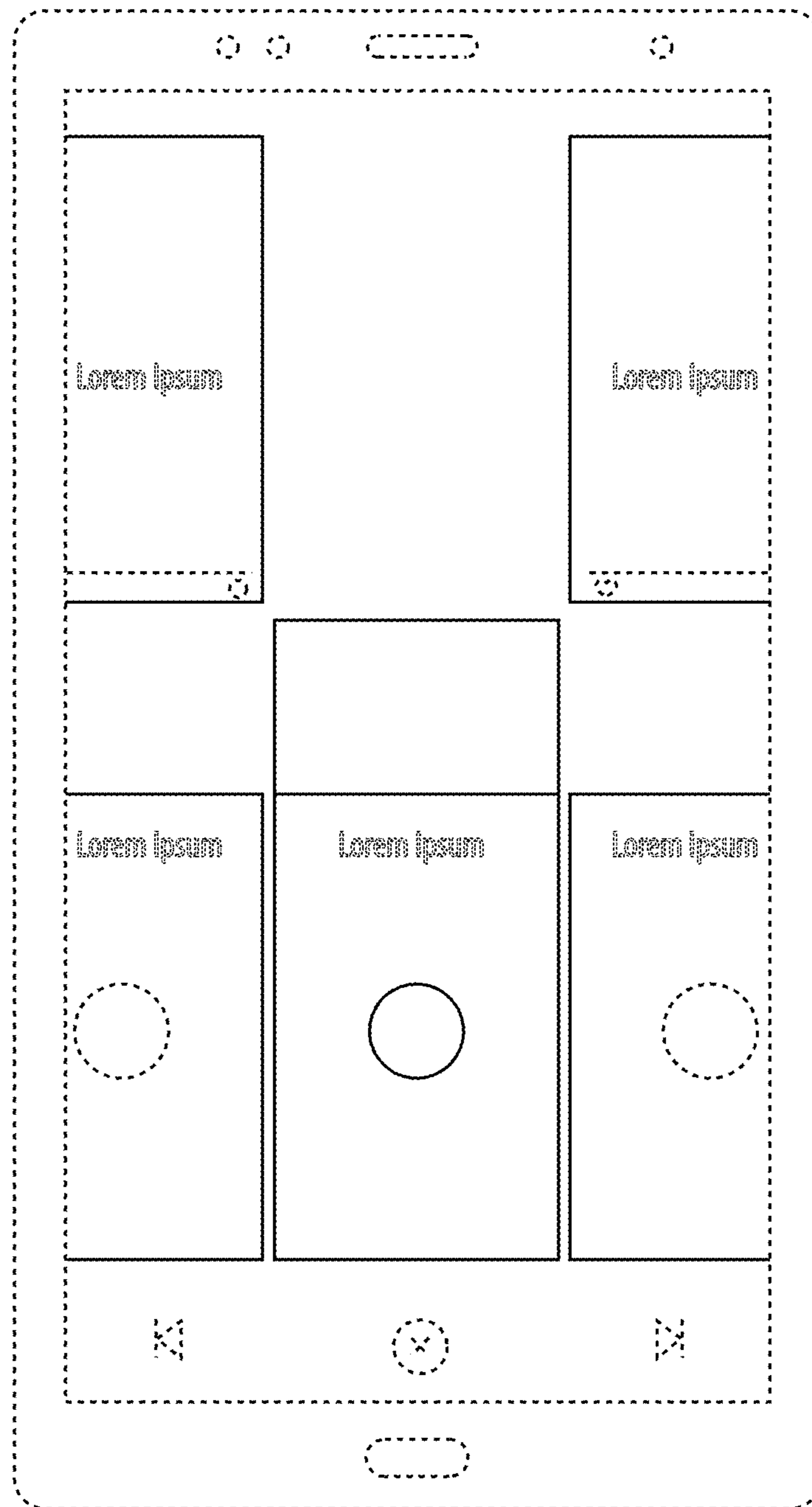

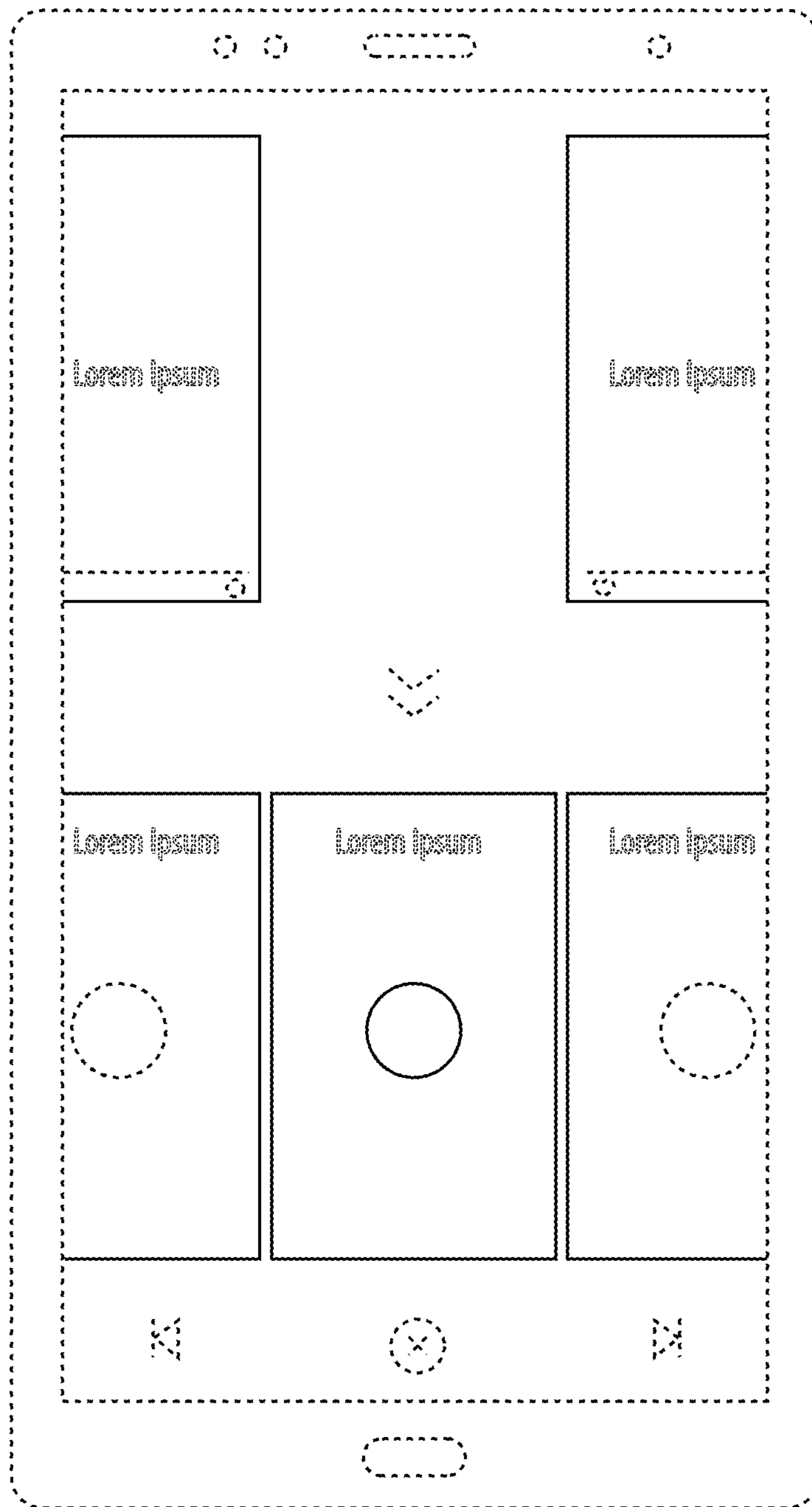
