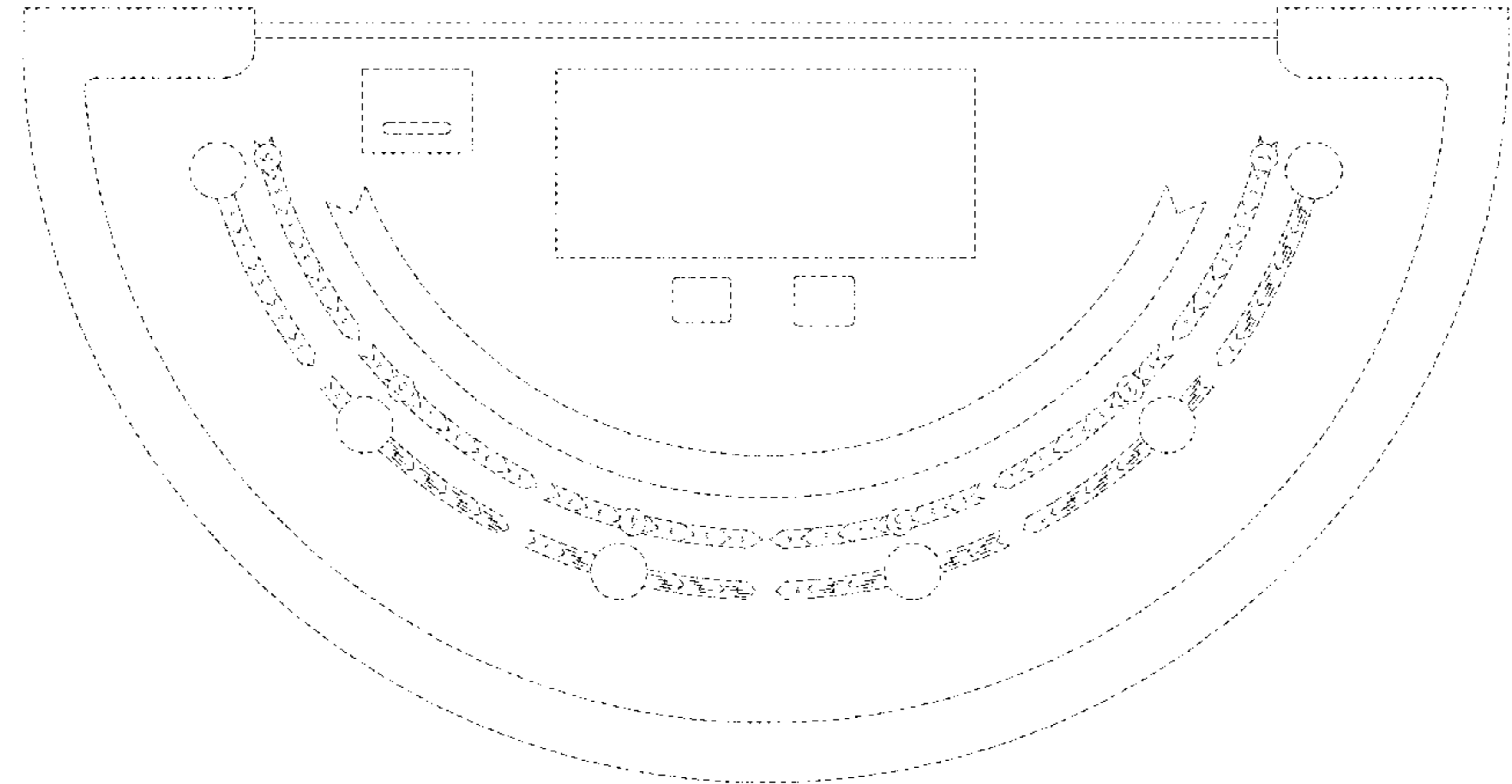

(57) **CLAIM**

We claim the ornamental design for a gaming table layout, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a gaming table layout illustrating our new design;
FIG. 2 is a an enlarged partial view of a first area of the gaming table layout of FIG. 1;
FIG. 3 is an enlarged partial view of a second area of the gaming table layout of FIG. 1;
FIG. 4 is an enlarged partial view of a third area of the gaming table layout of FIG. 1;
FIG. 5 is an enlarged partial view of a fourth area of the gaming table layout of FIGS. 1; and,
FIG. 6 is an enlarged partial view of a fifth area of the gaming table layout of FIG. 1.
The dash-dot-dash broken line enclosing the enlarged partial view in FIG. 2, shown for clarity of disclosure, forms no part of the claimed design. The claim comprises only the shaded surfaces of the gaming table layout; the unshaded surfaces

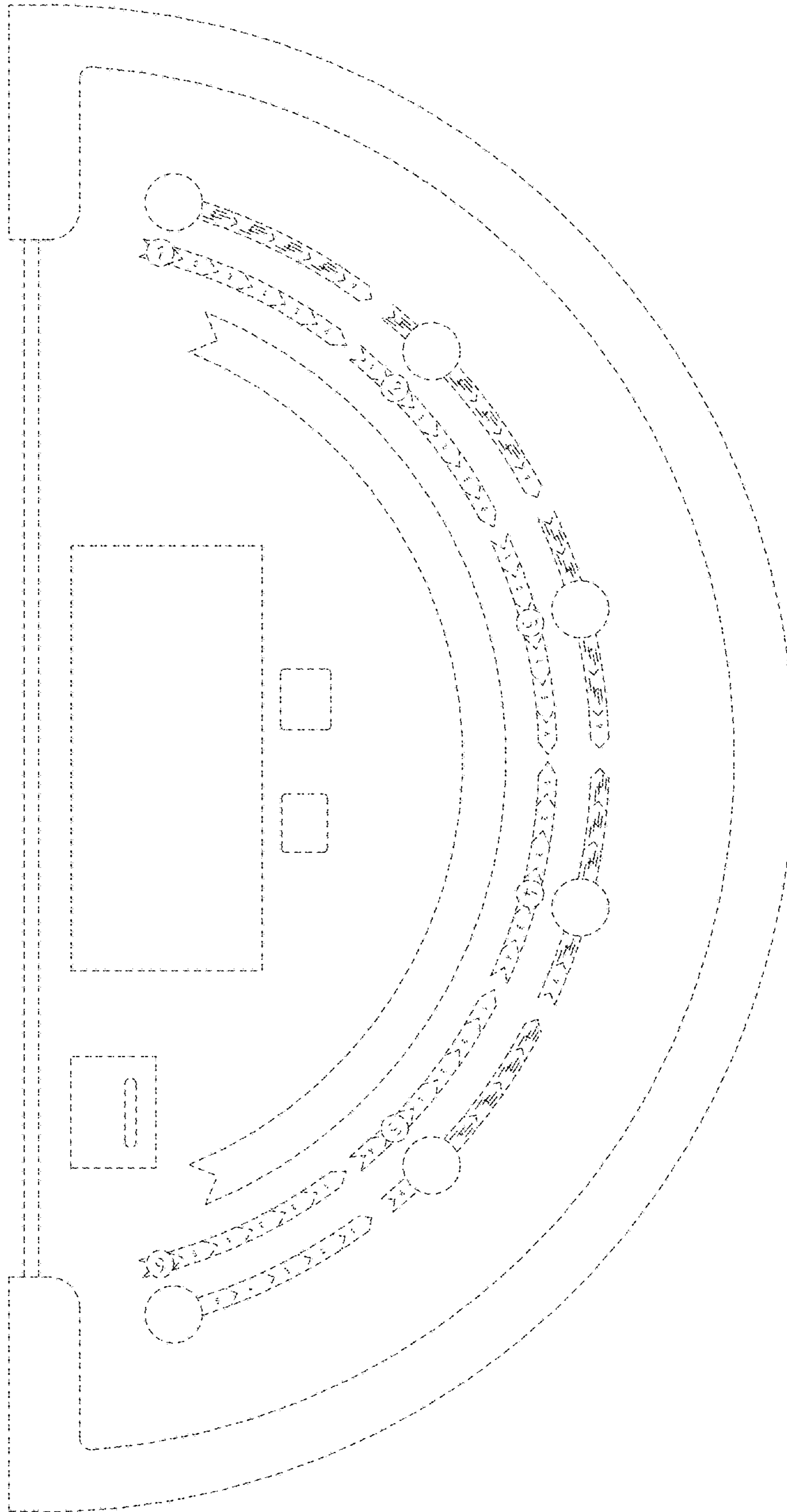

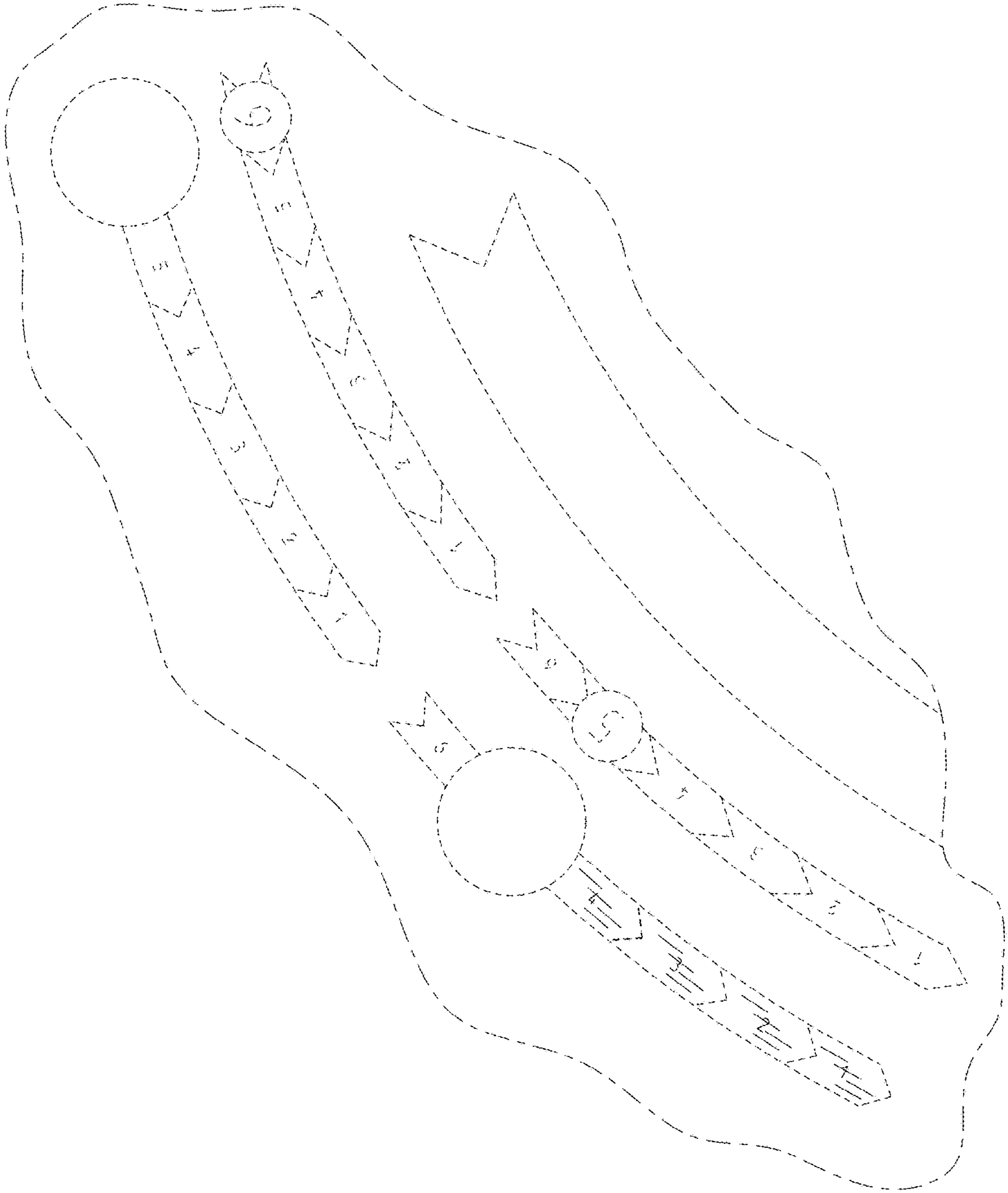

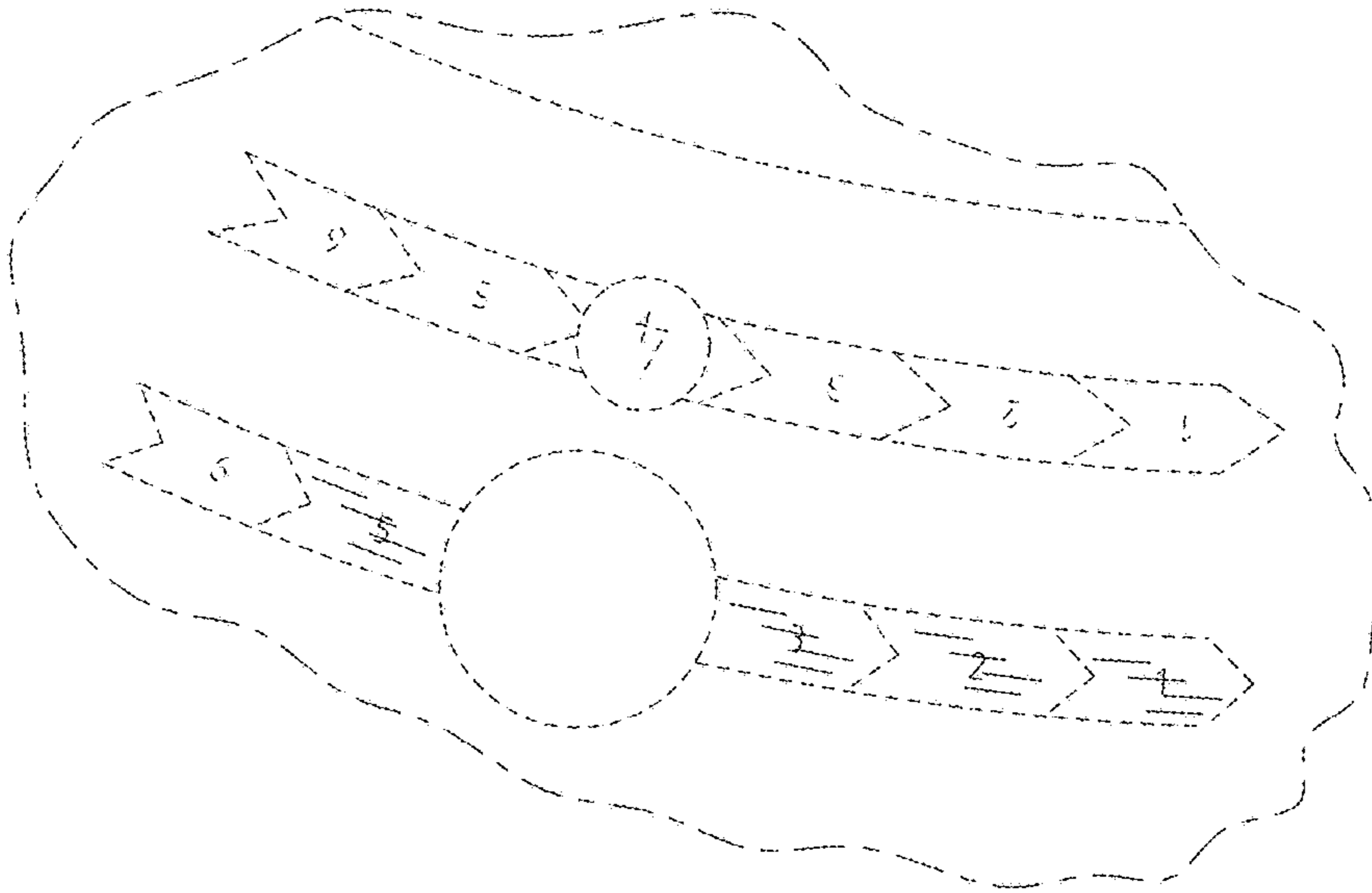

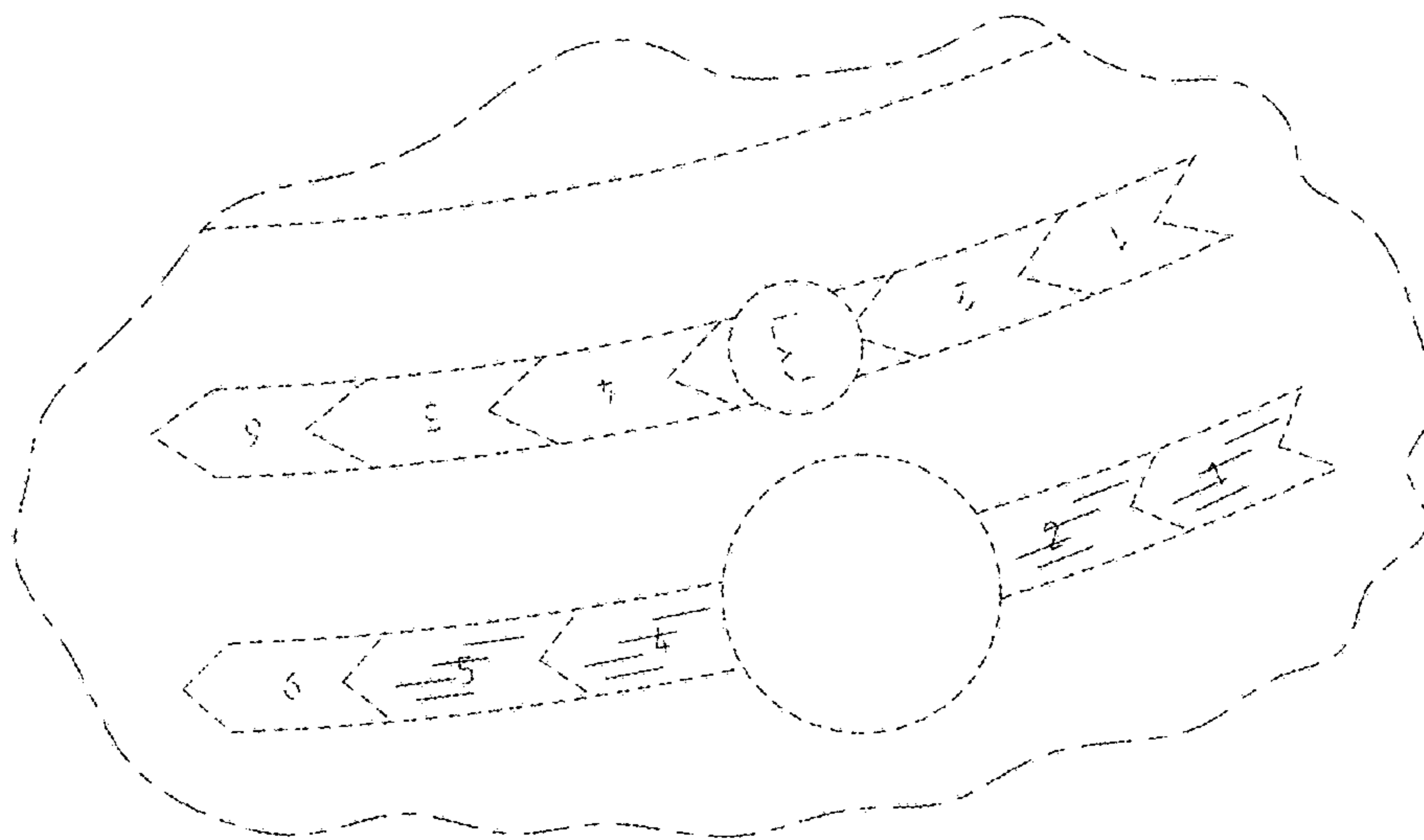

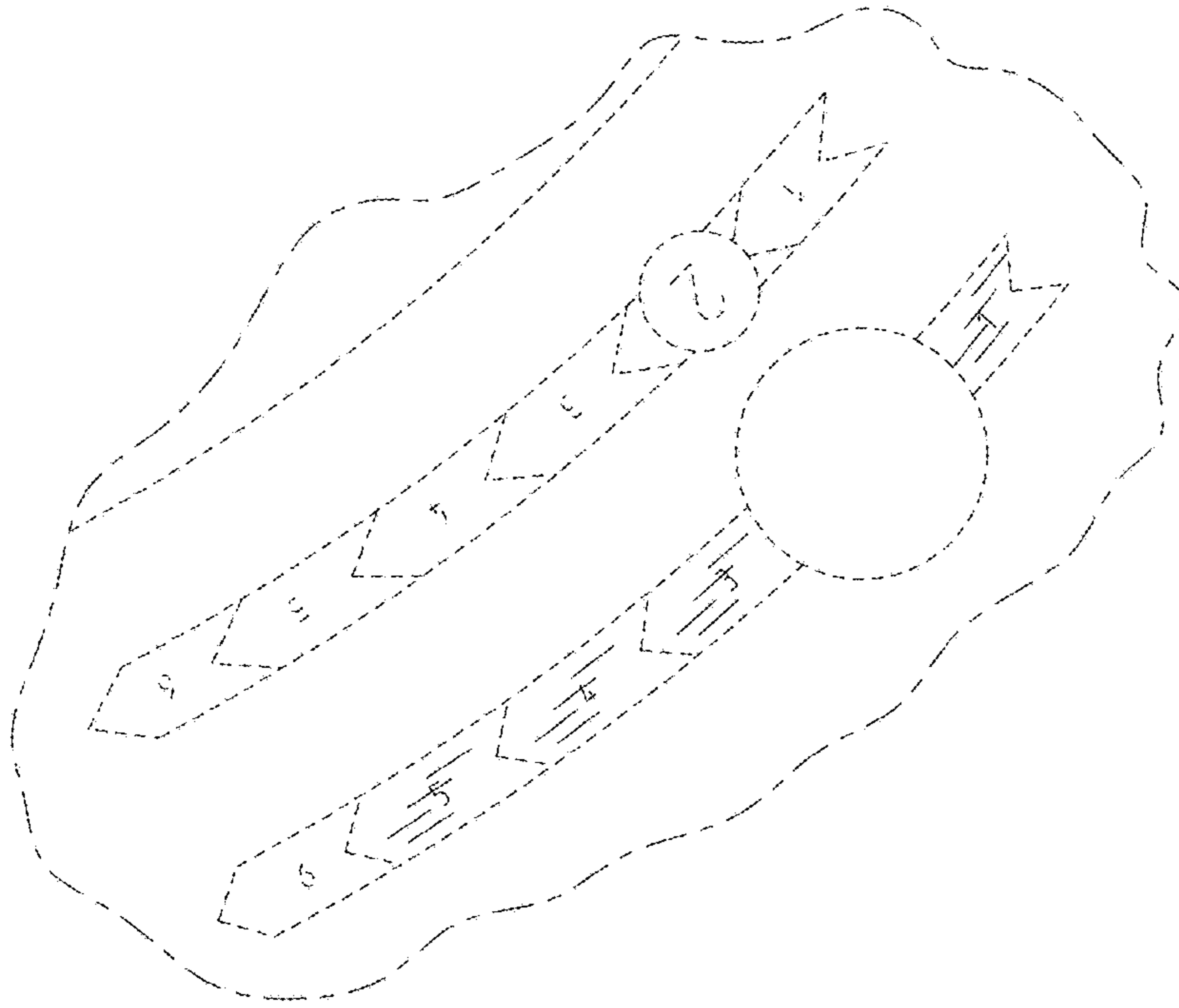

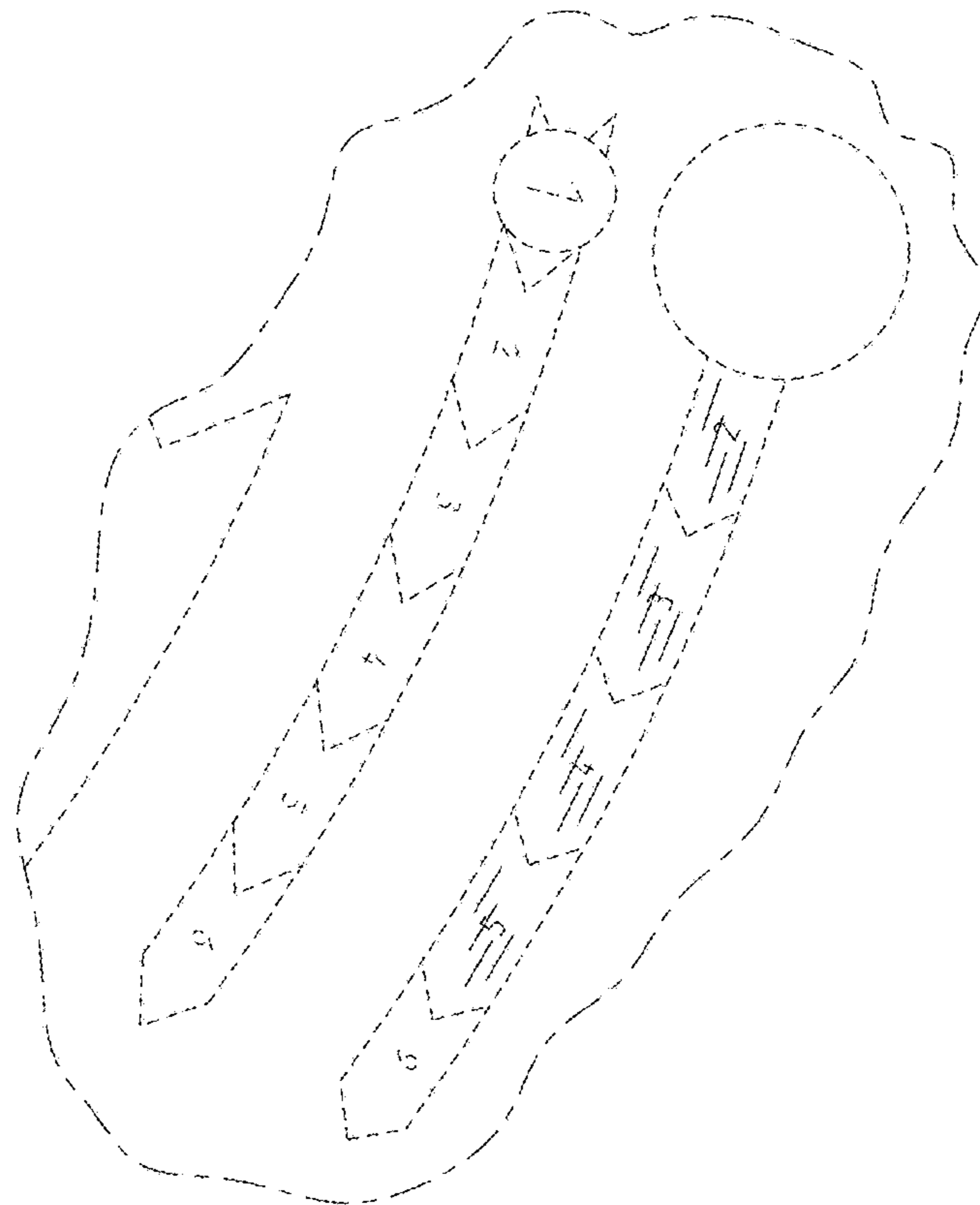
