**DESCRIPTION**

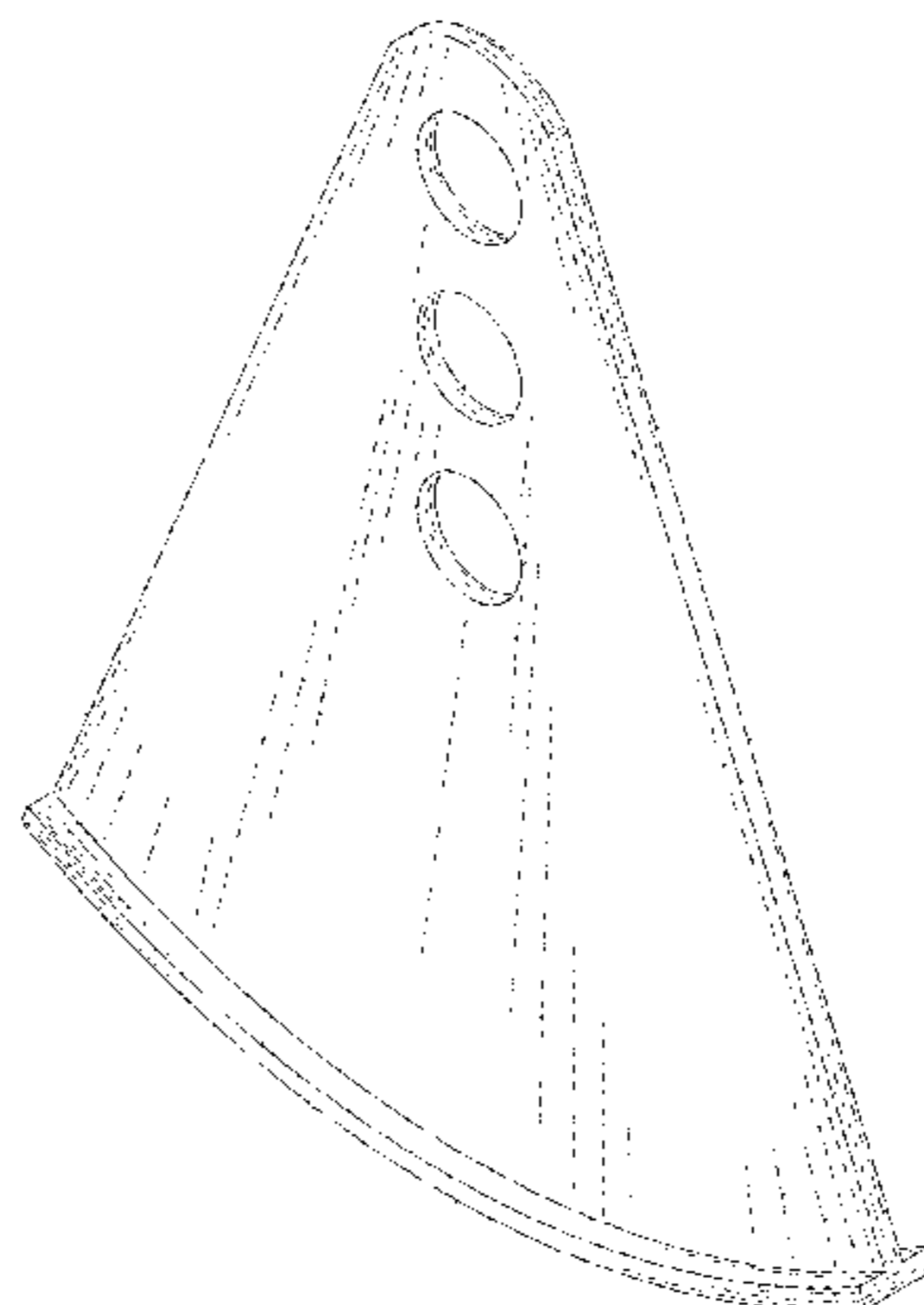
FIG. 1 is a top right perspective view of an adjustable height

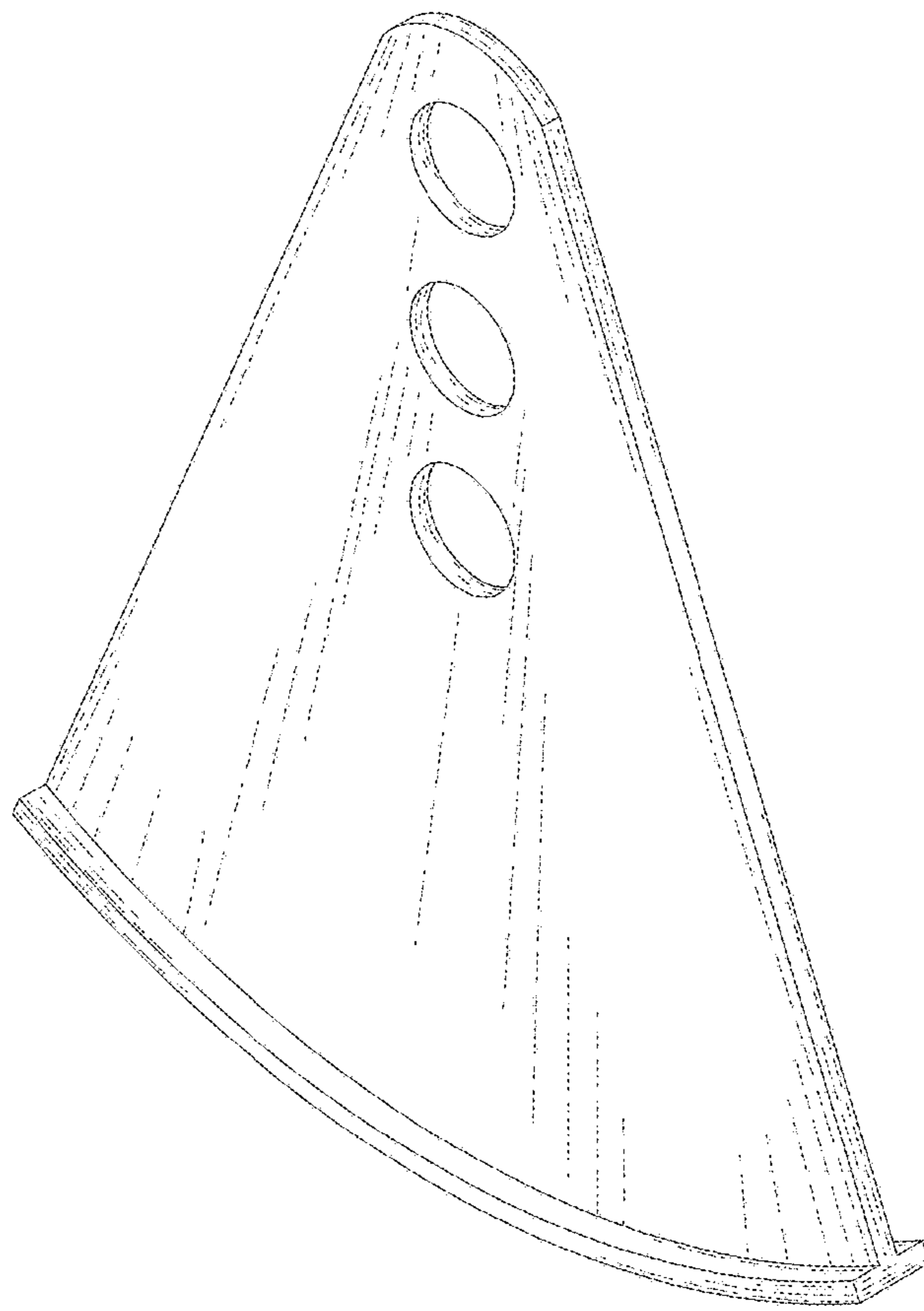

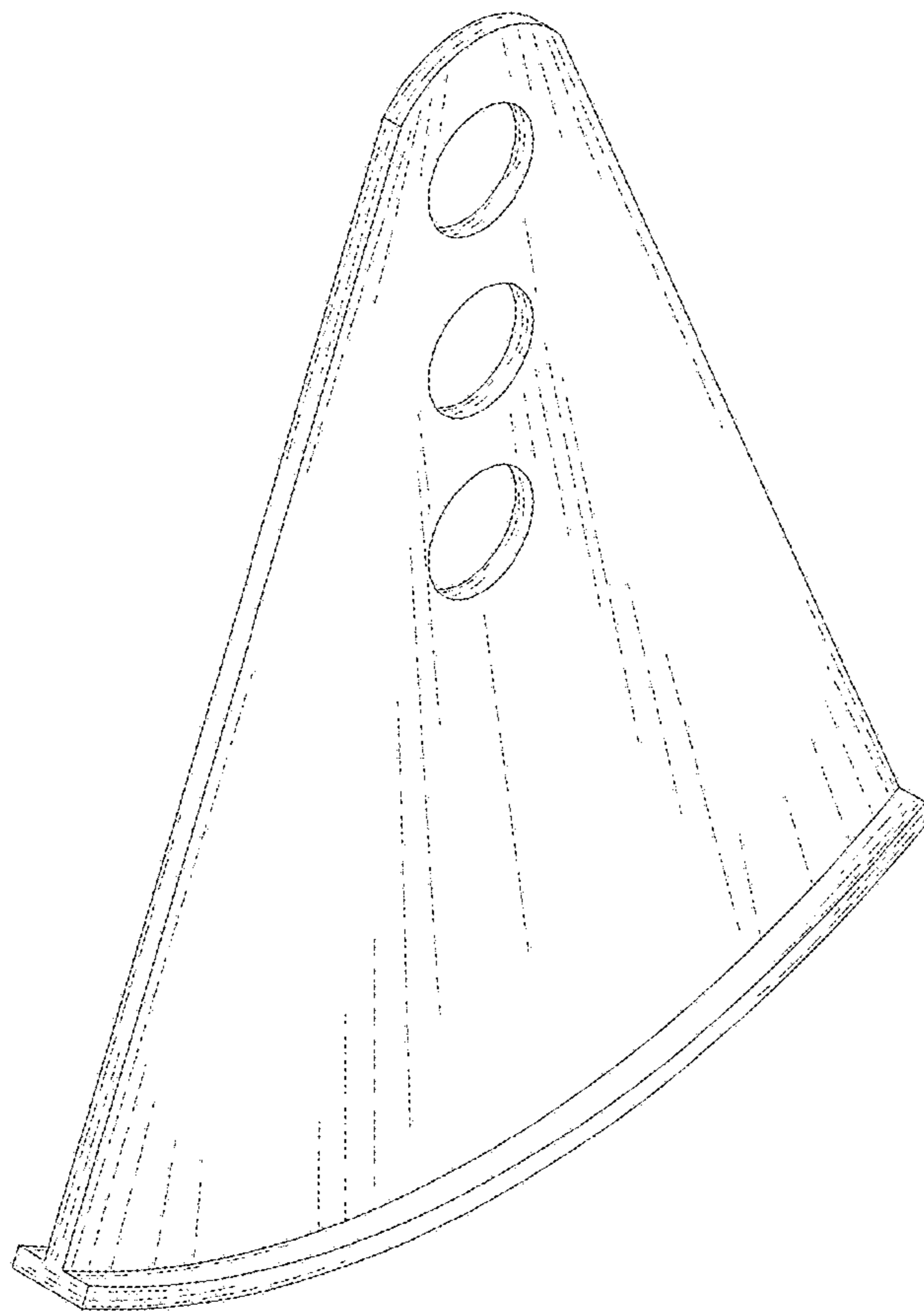

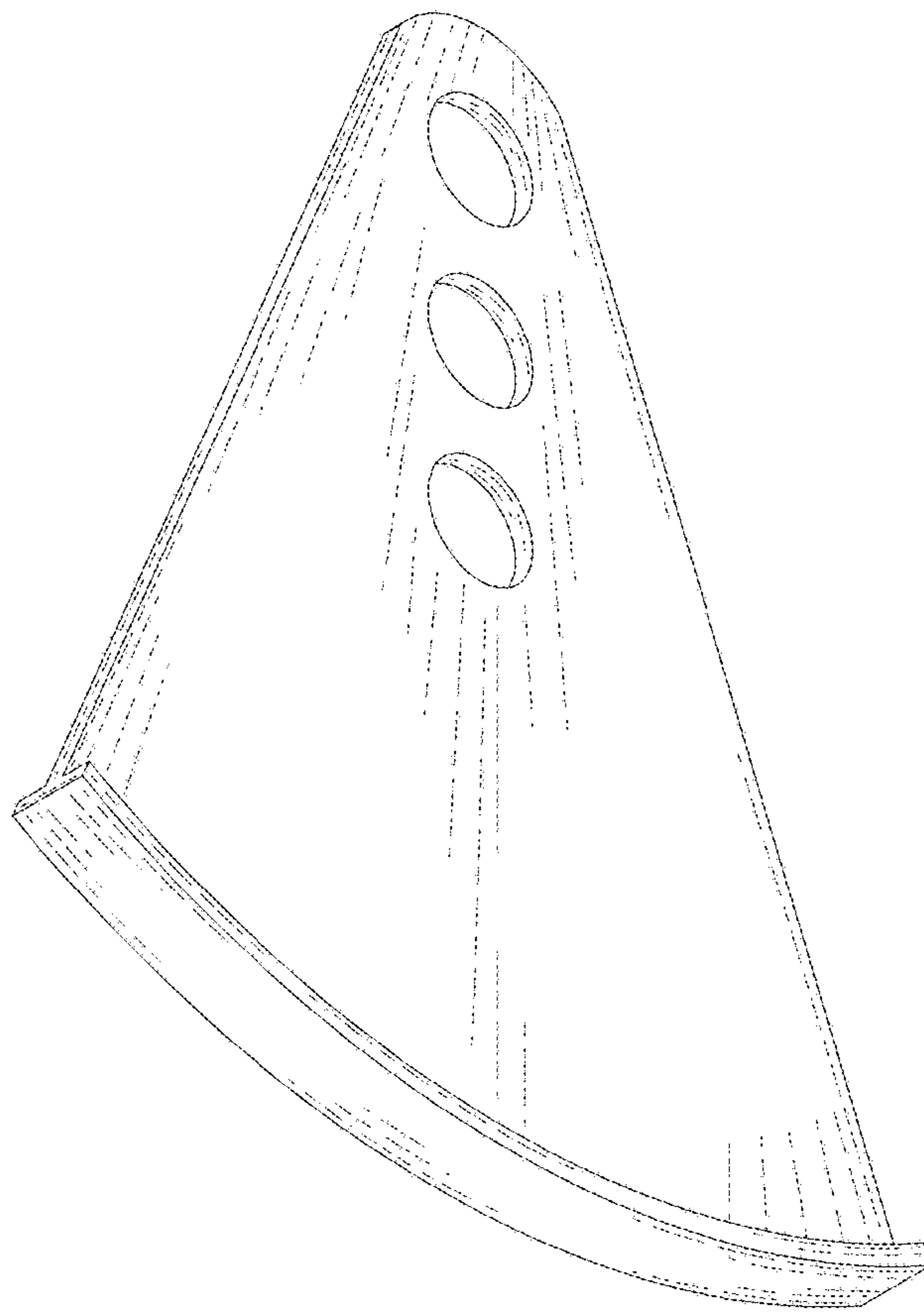

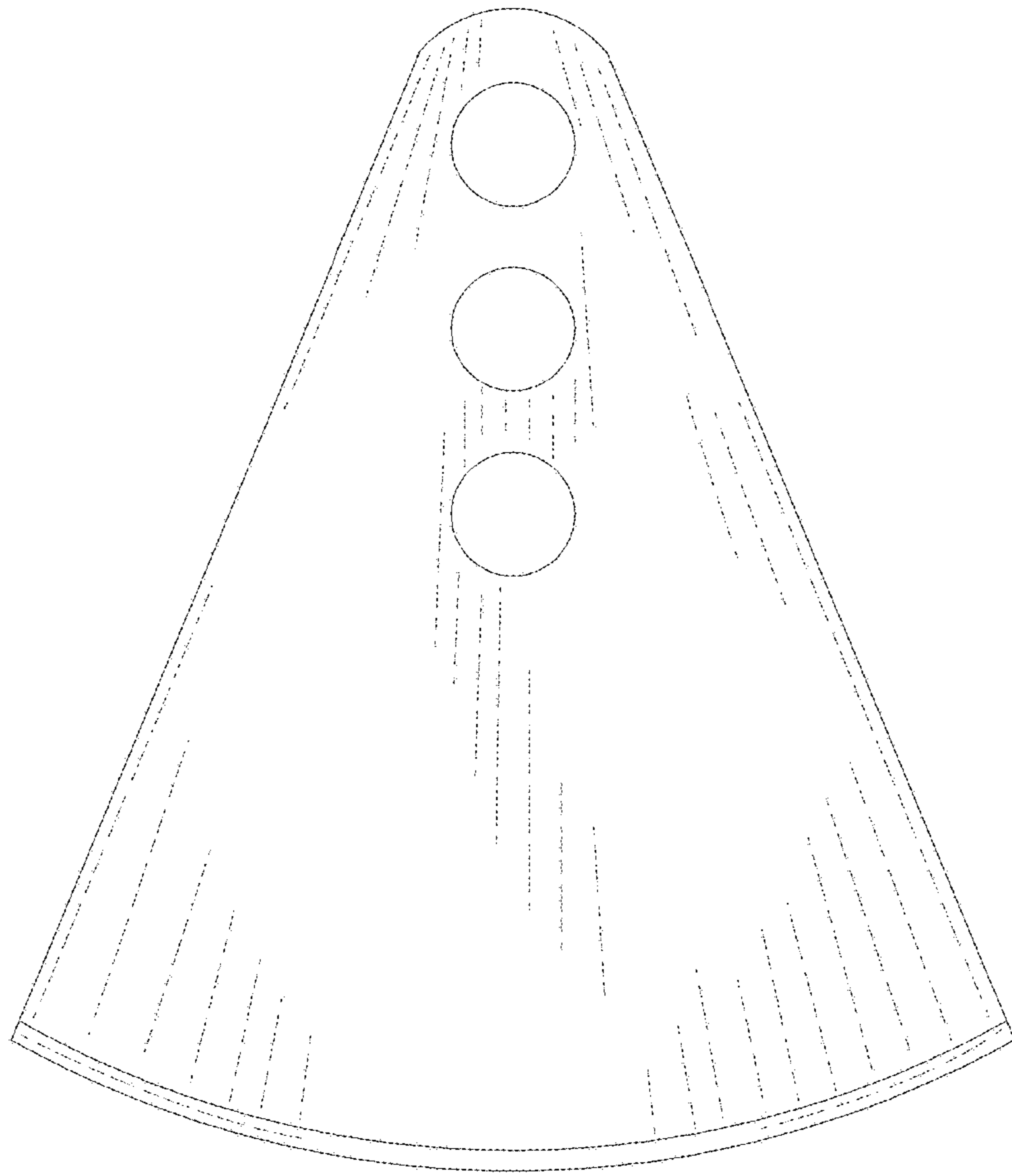

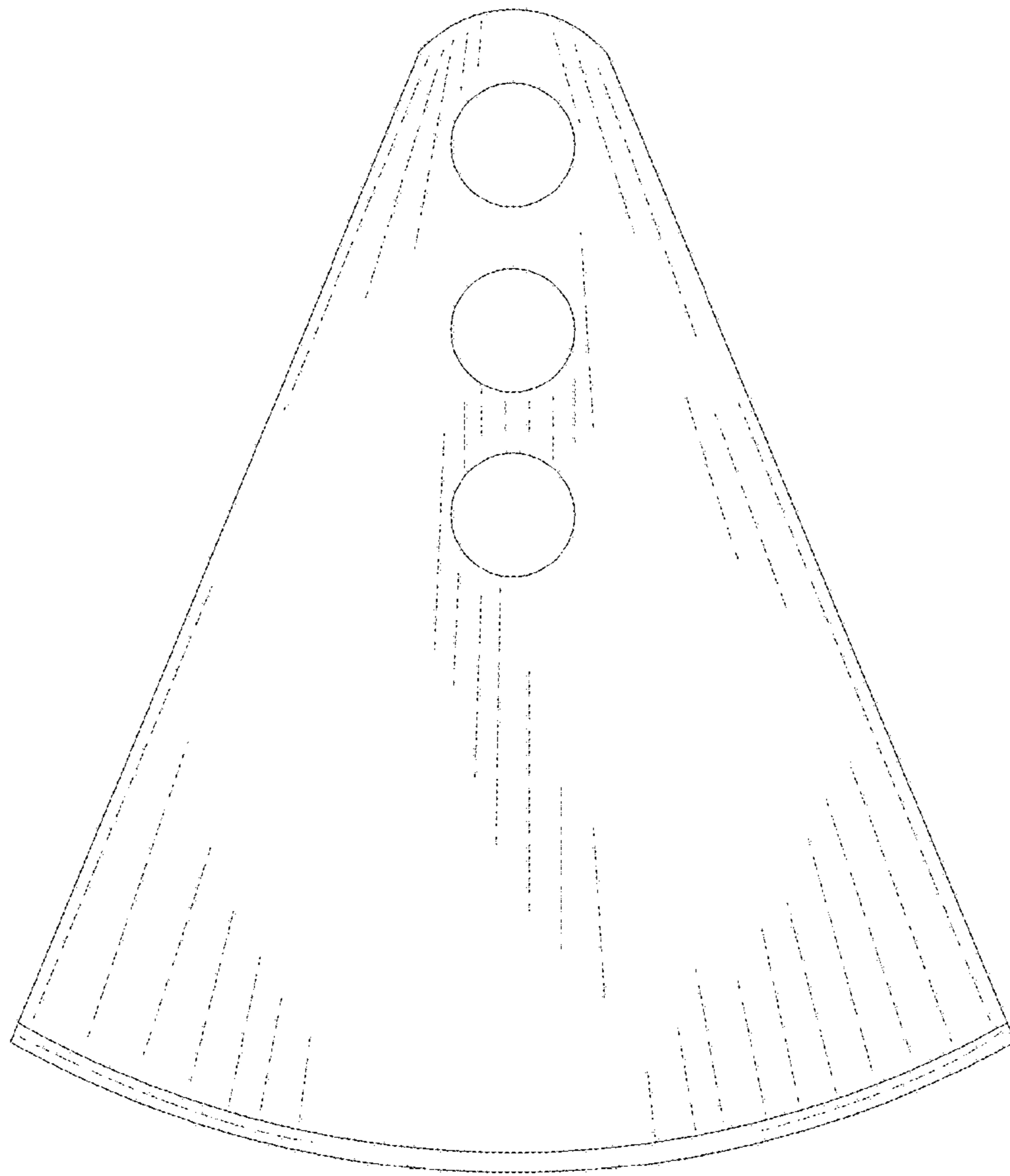

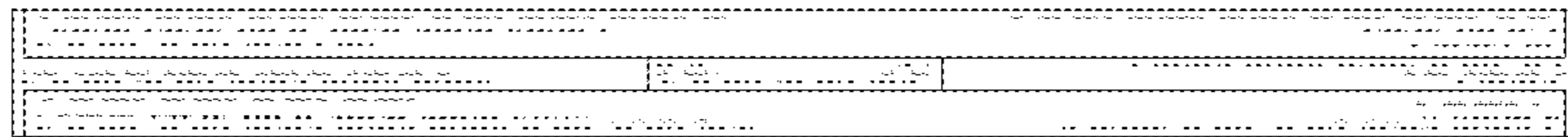

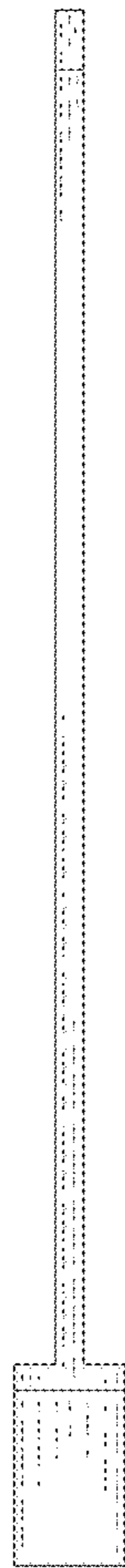

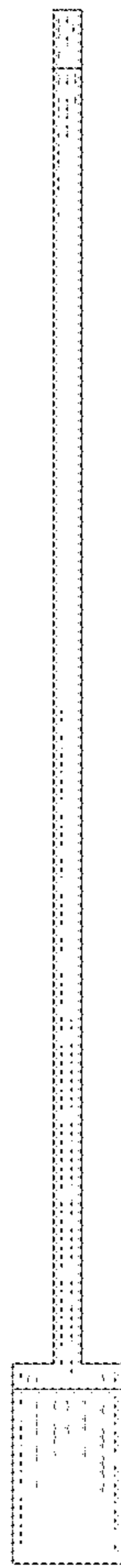
