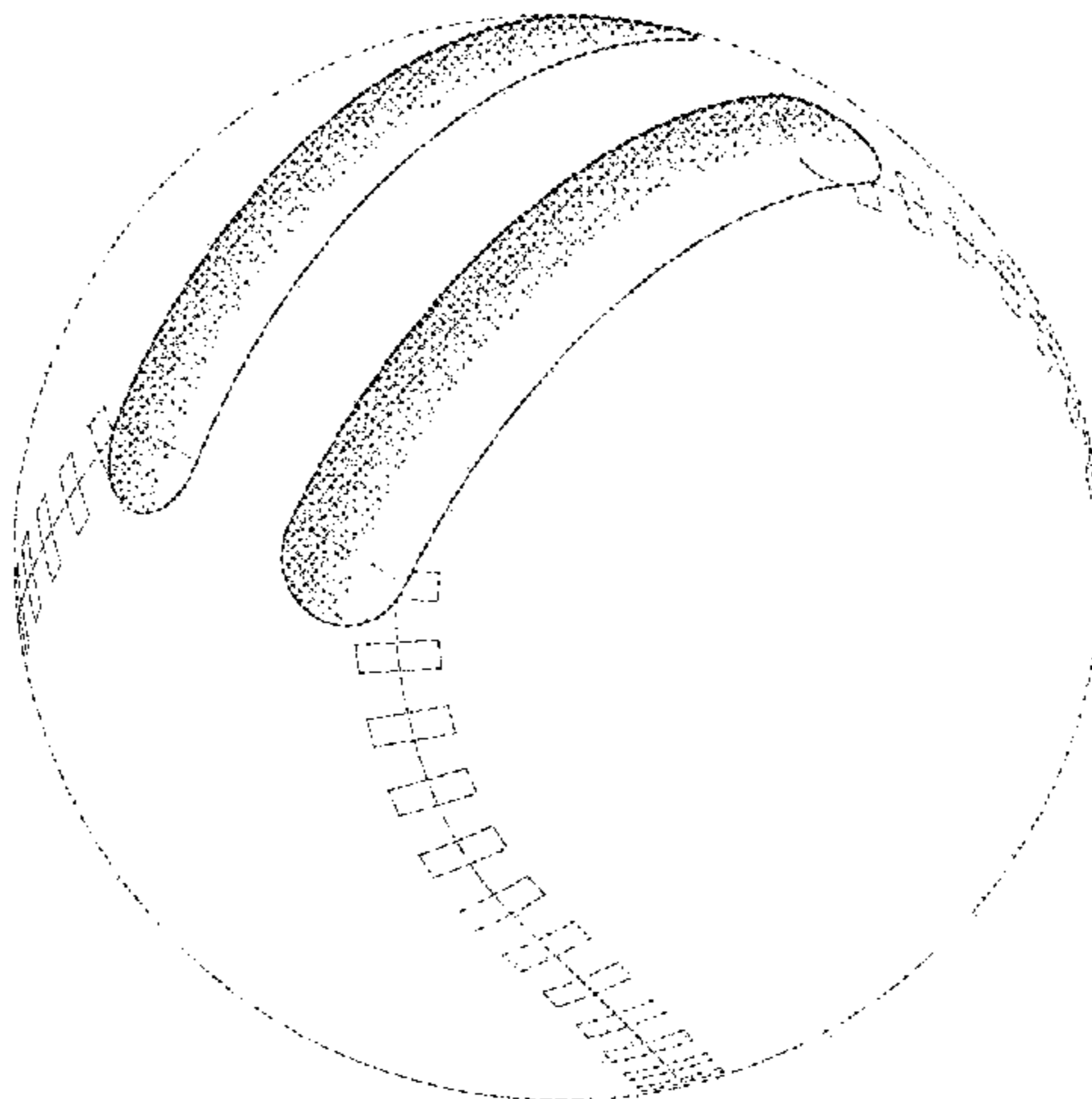
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of an athletic baseball training tool showing my new design.
 FIG. 2 is a front elevation view thereof.

 FIG. 4 is a right side view thereof.

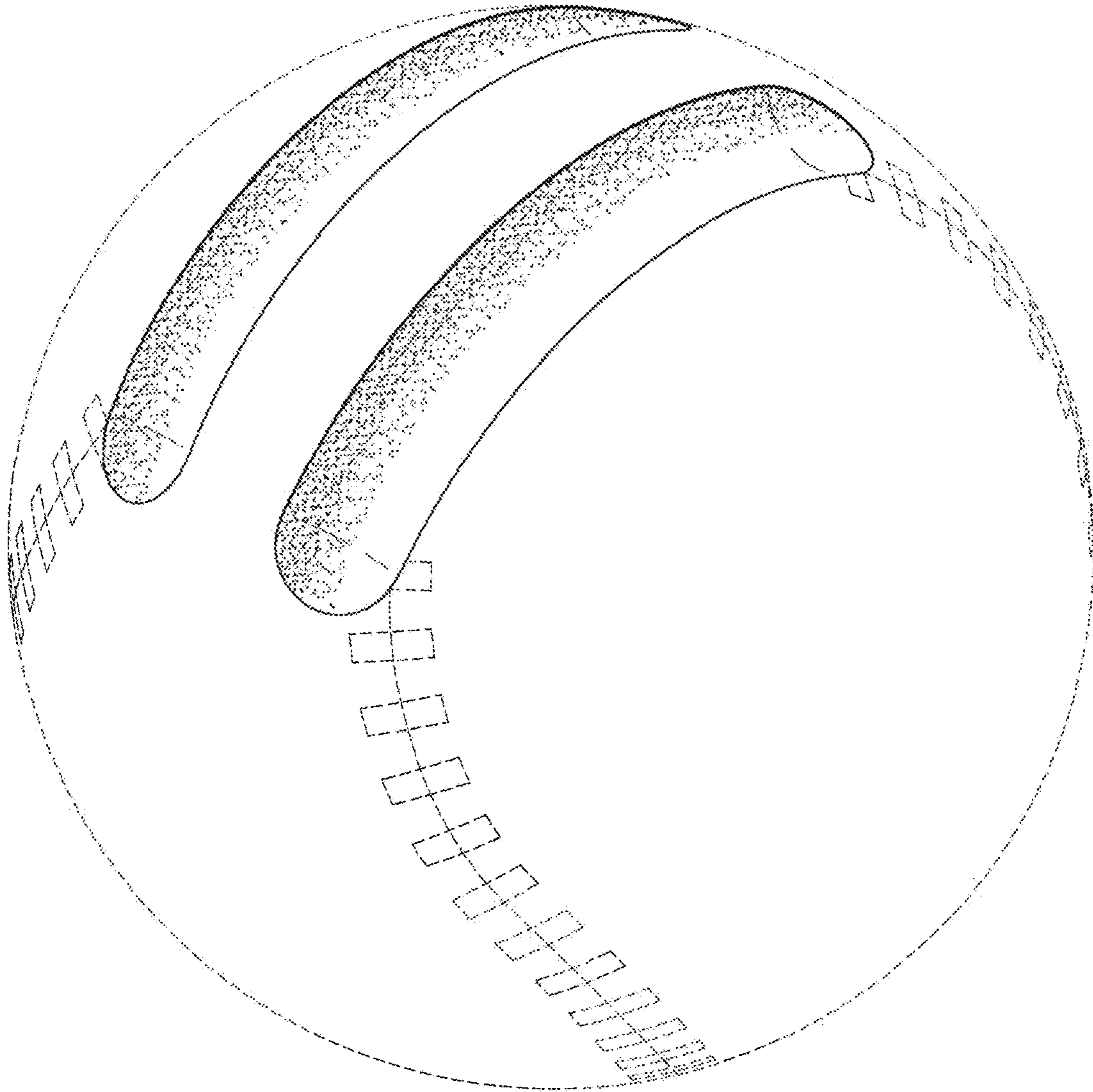

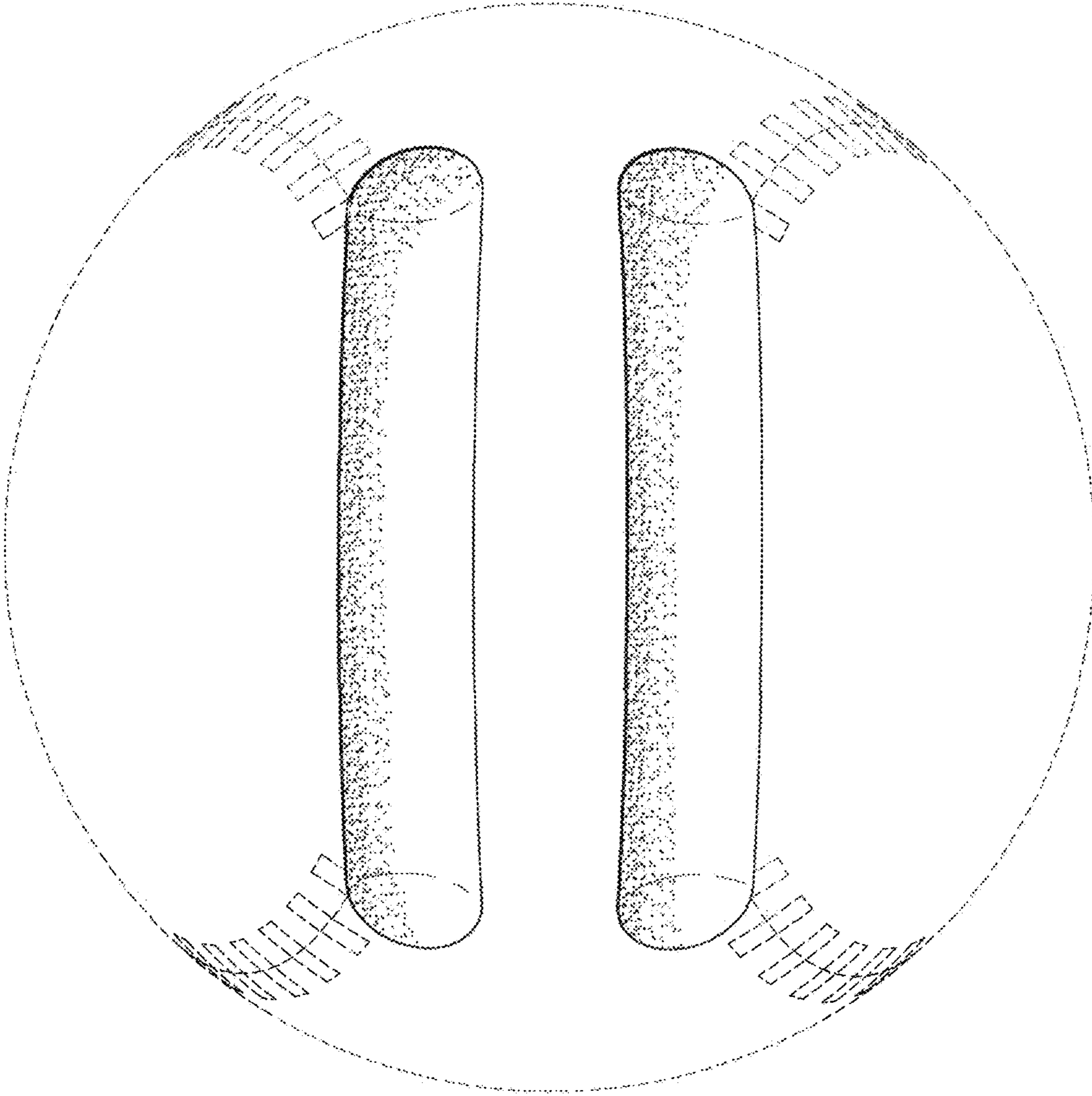

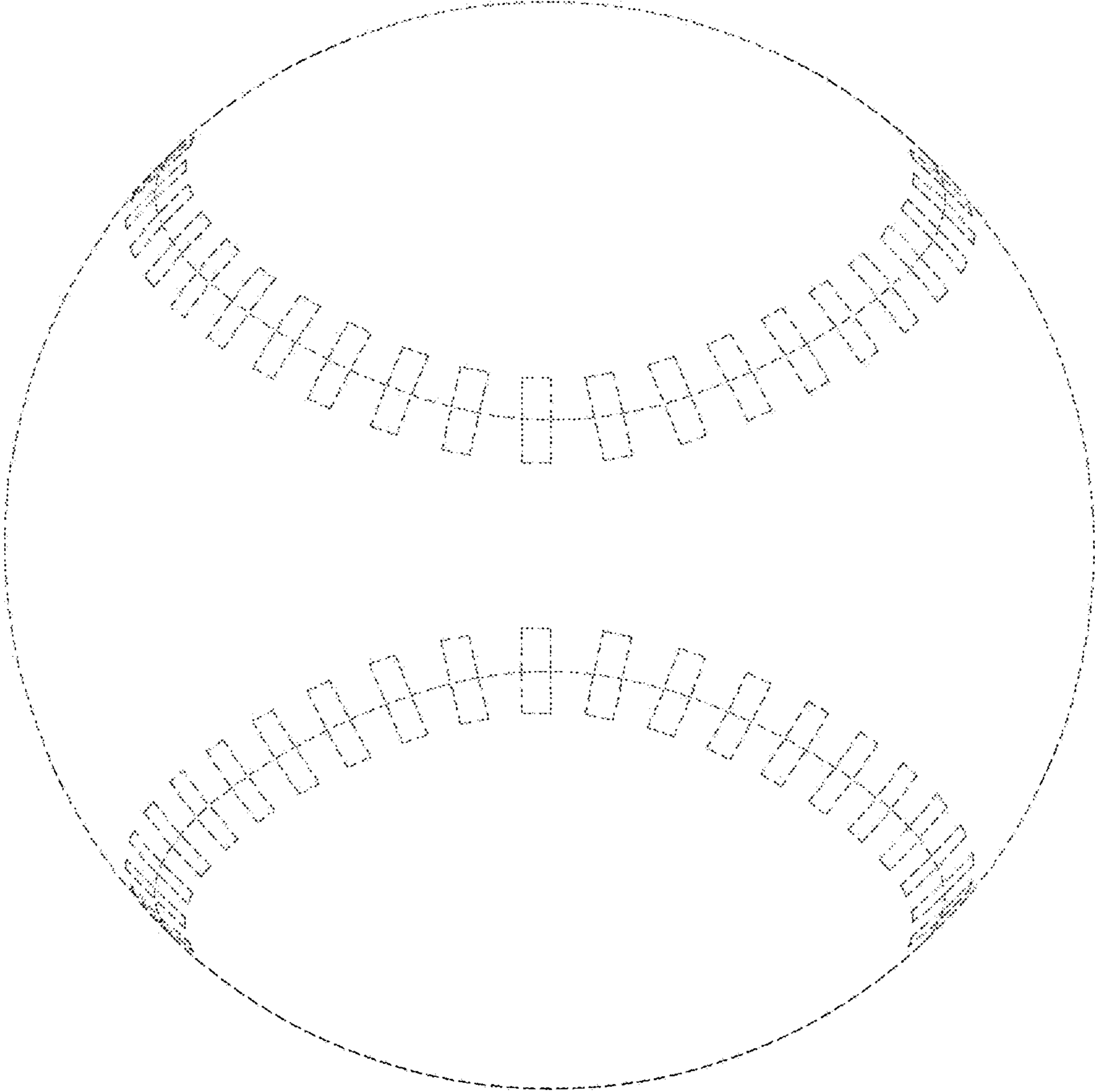

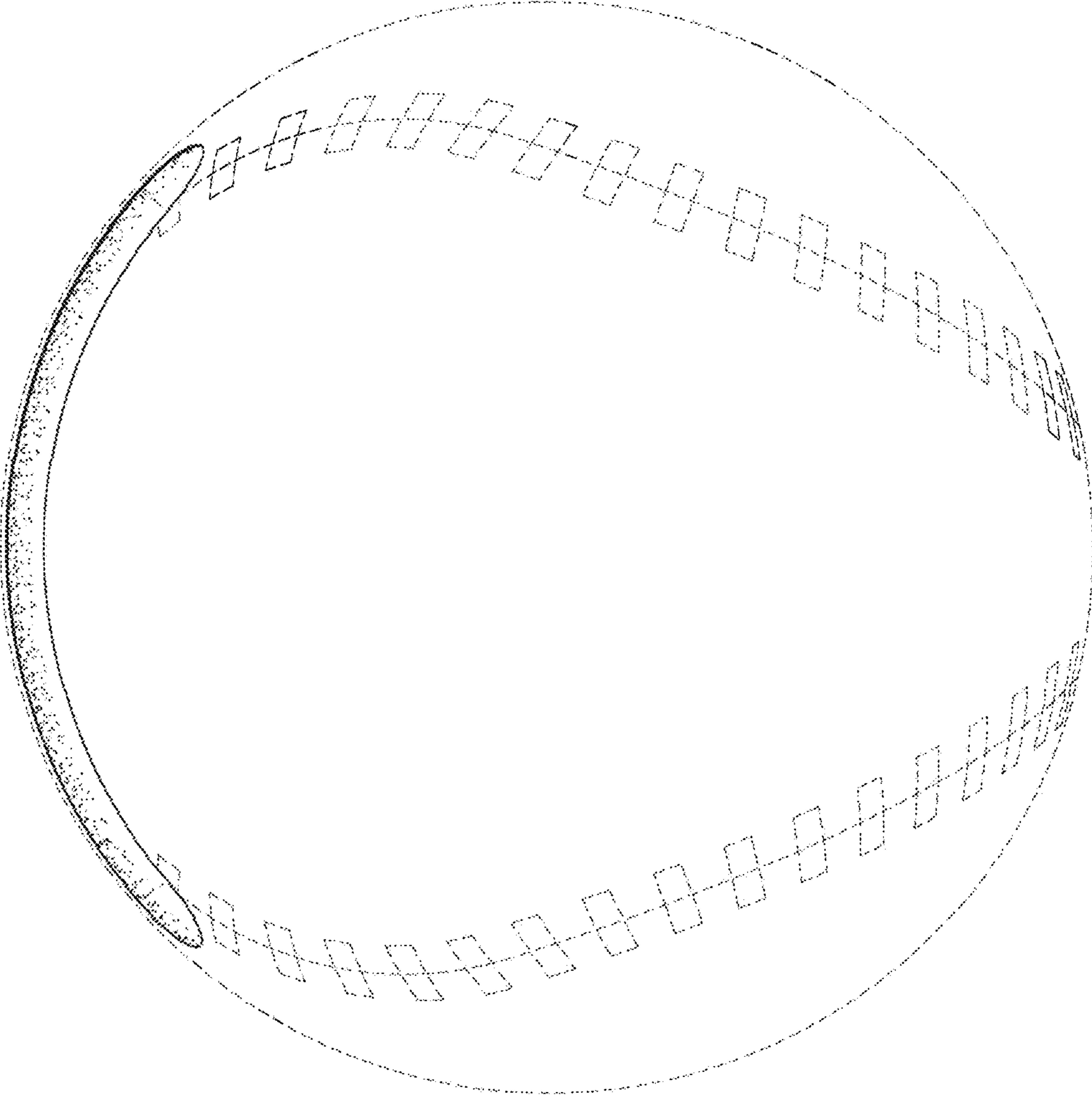

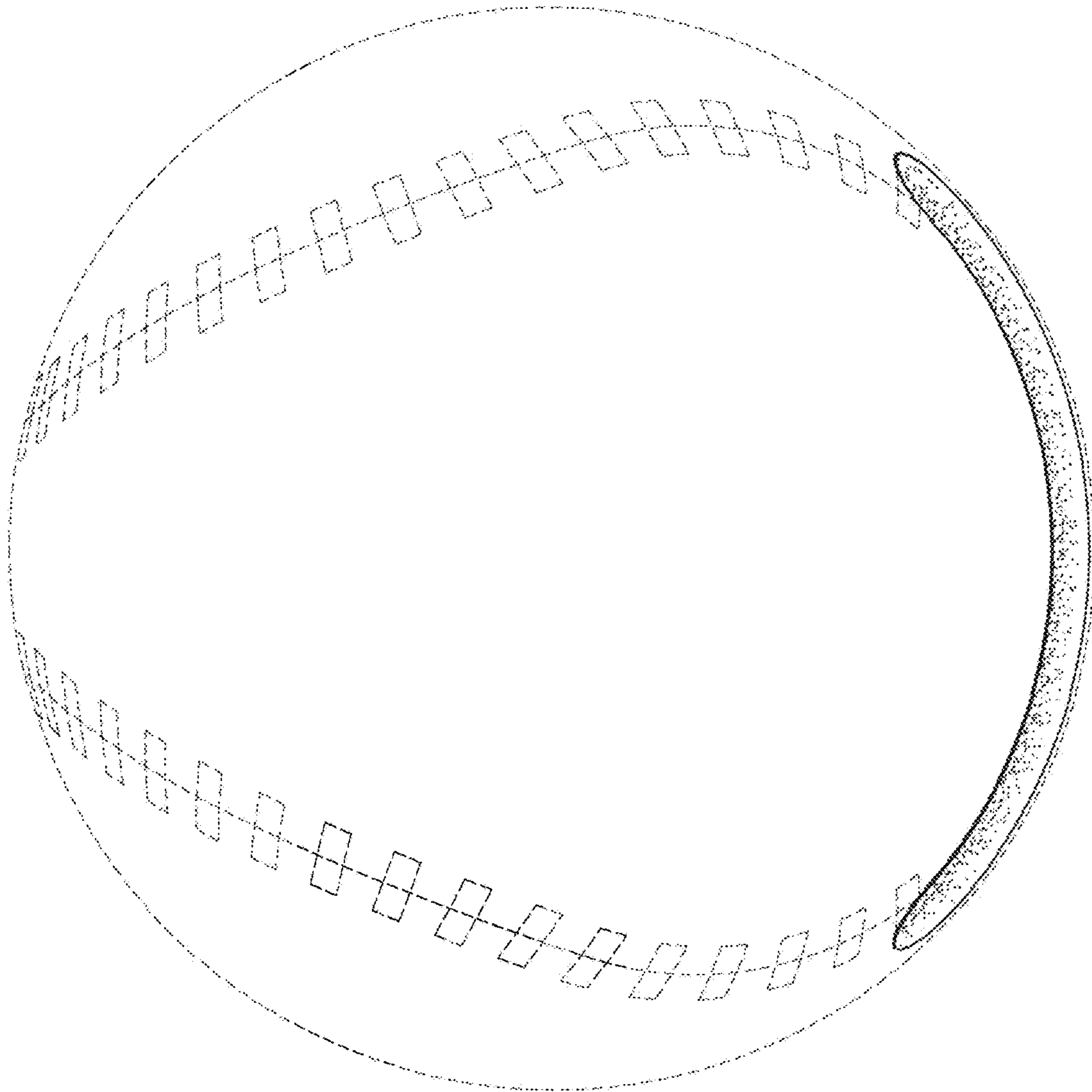

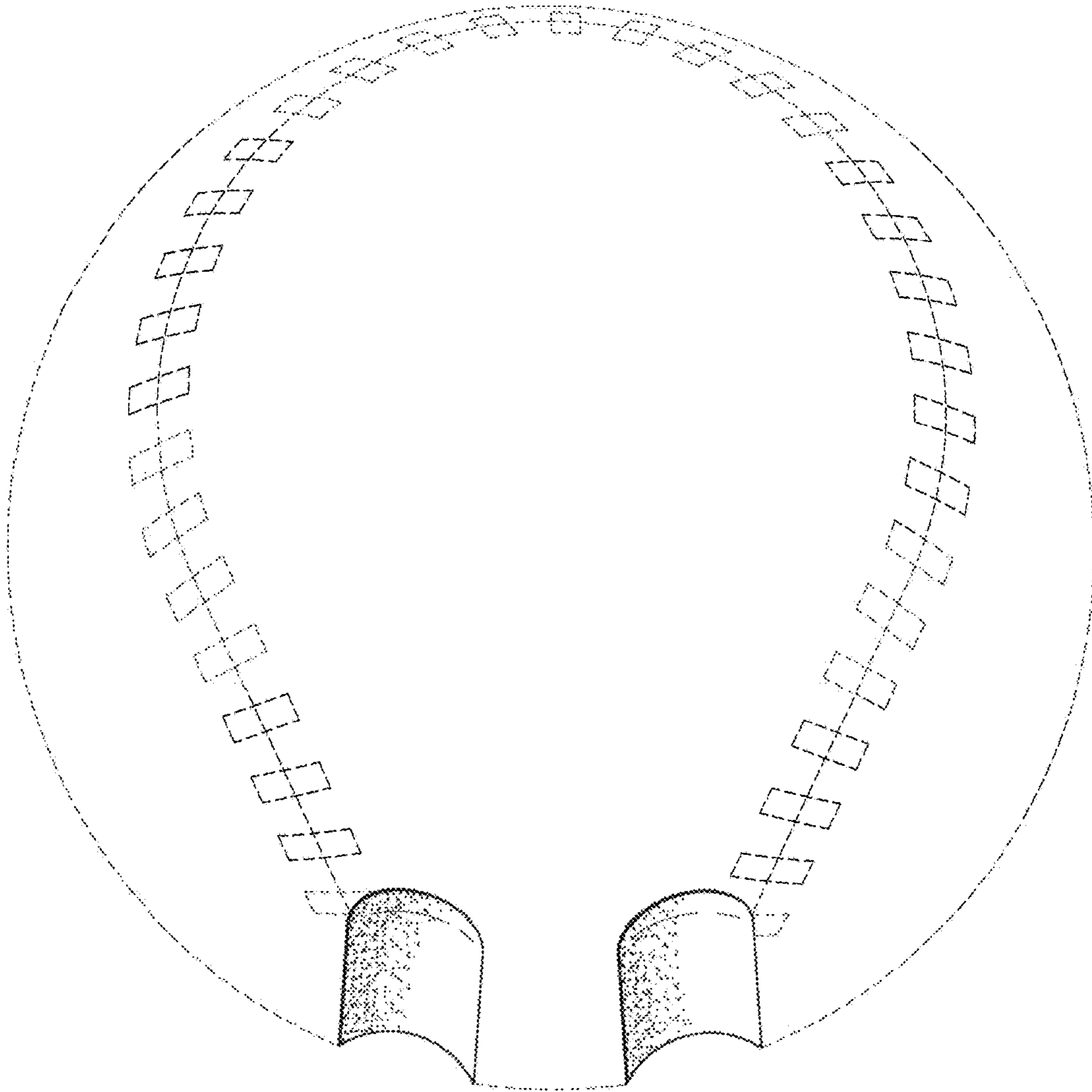

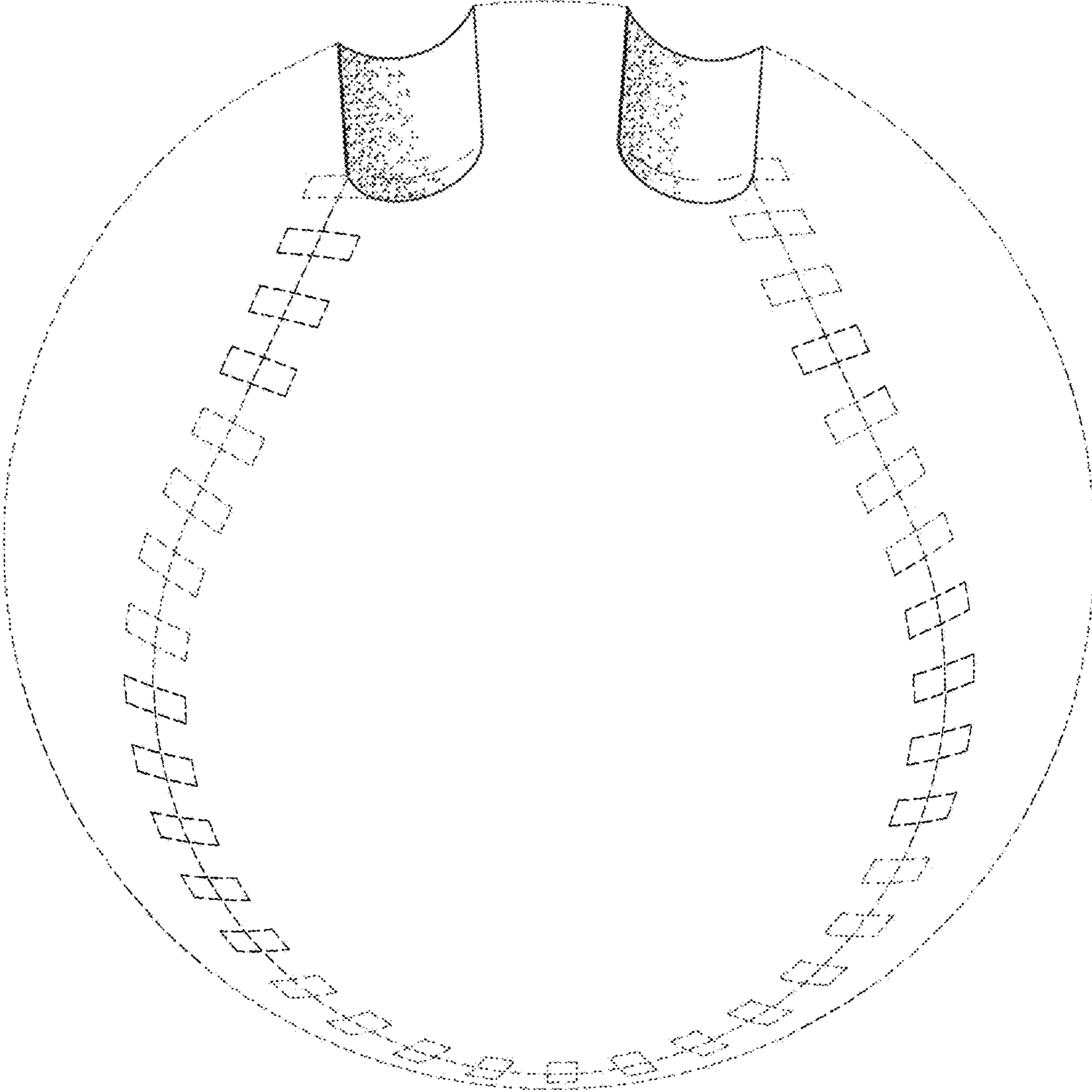
