The ornamental design for a cat door, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a cat door;

FIG. 2 is a front elevation view of FIG. 1;

FIG. 3 is a bottom plan view of FIG. 1;

FIG. 4 is a rear elevation view of FIG. 1;

FIG. 5 is a right elevation view of FIG. 1;

FIG. 11 is a left elevation view of FIG. 8;

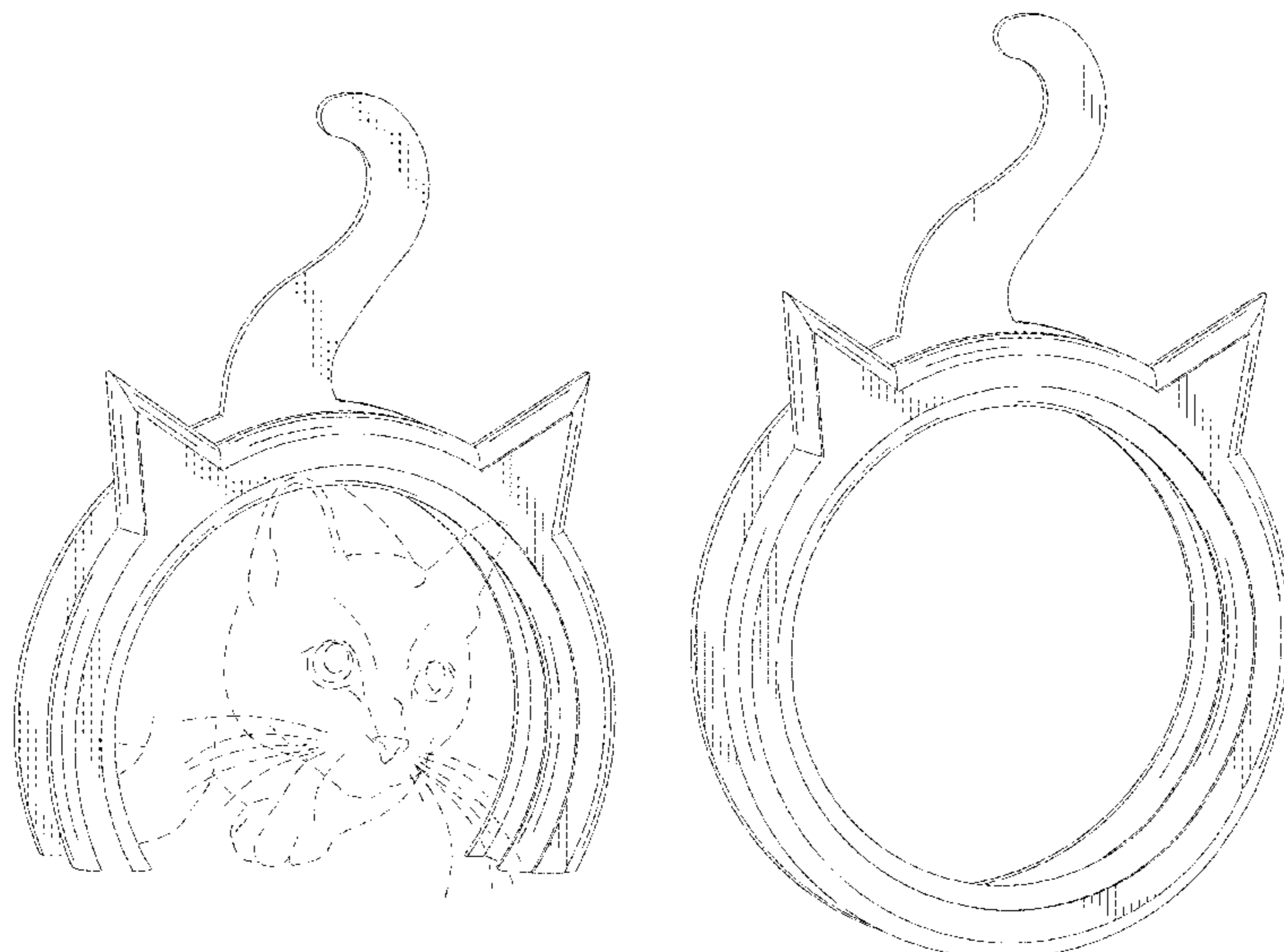
FIG. 12 is a bottom plan view of FIG. 8;

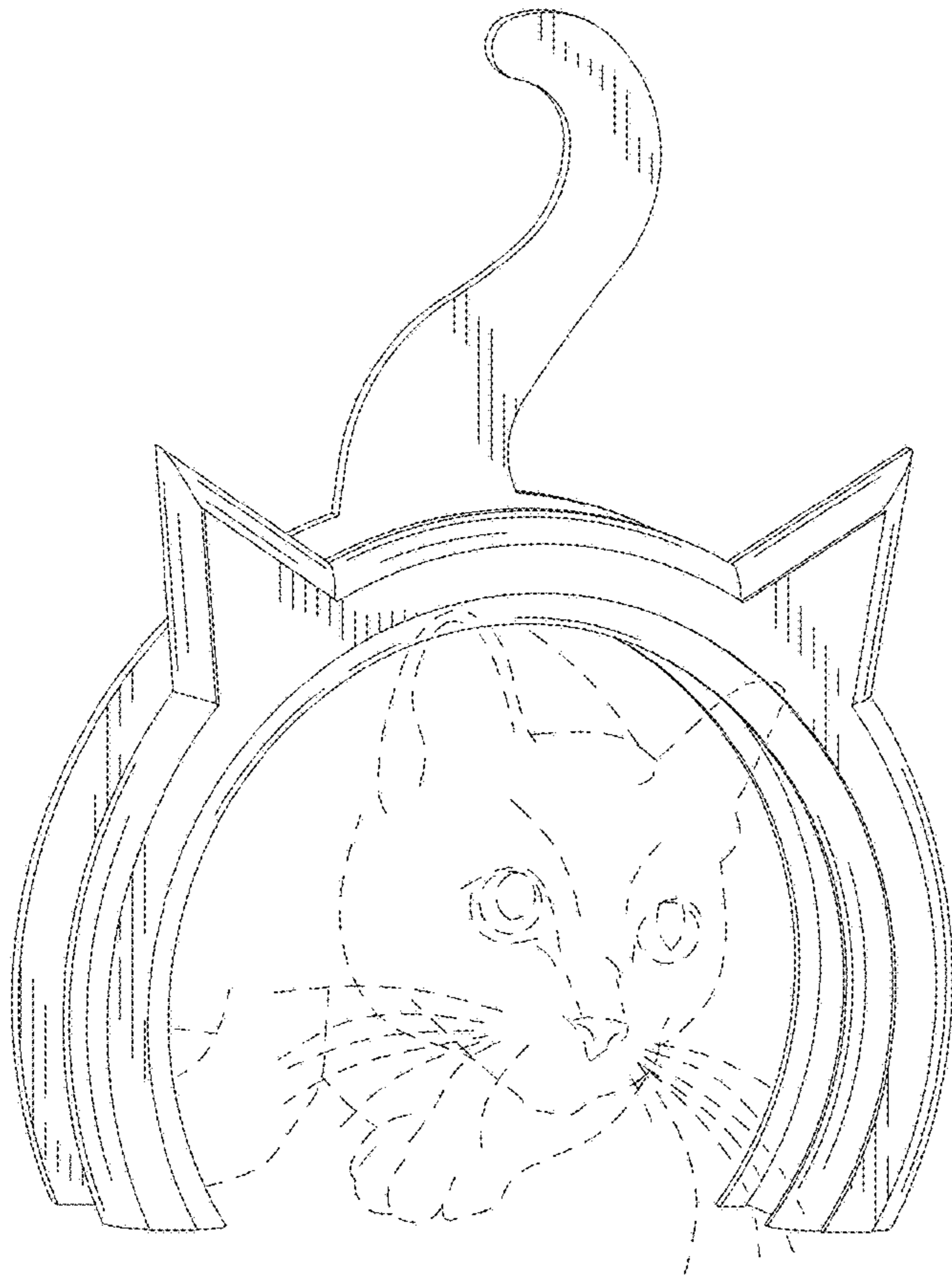

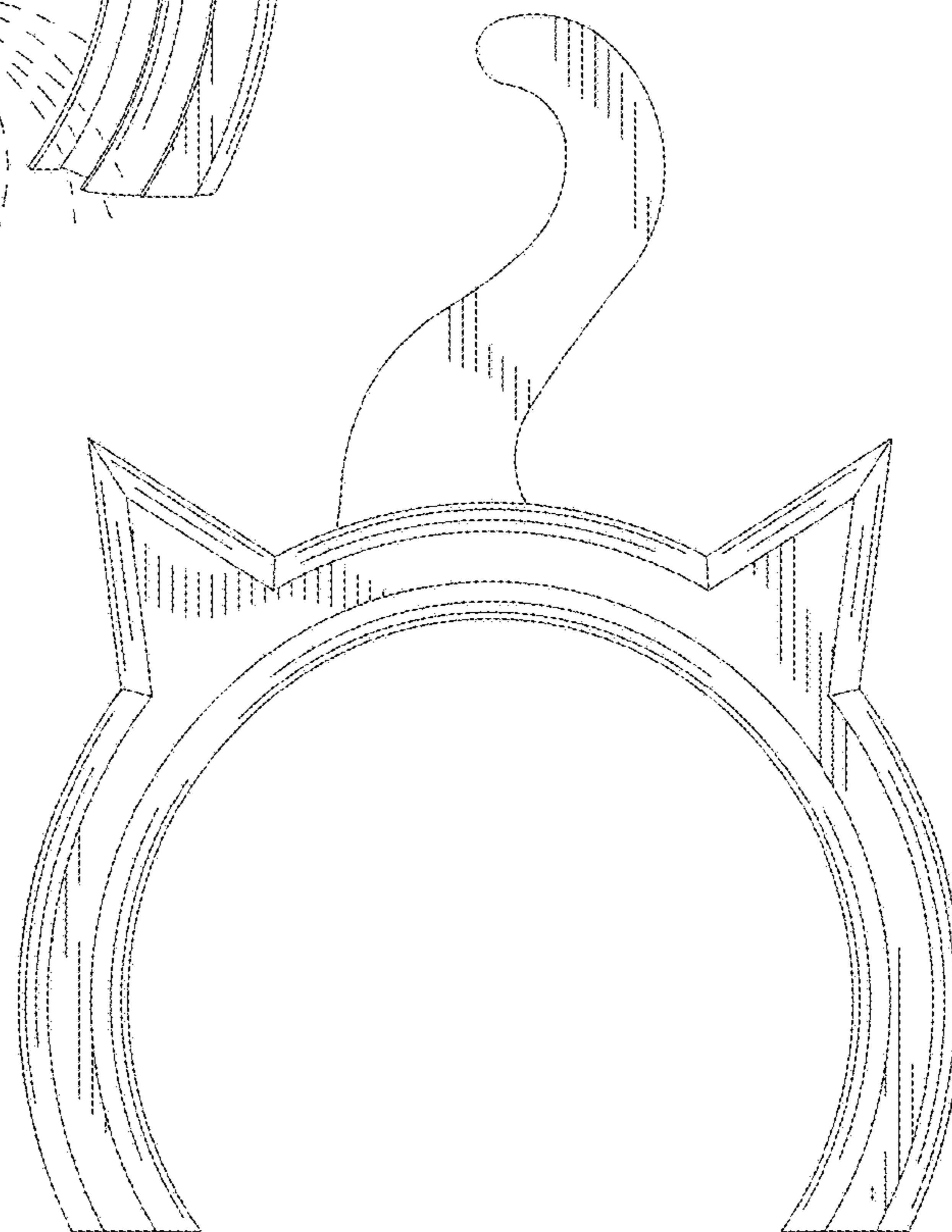

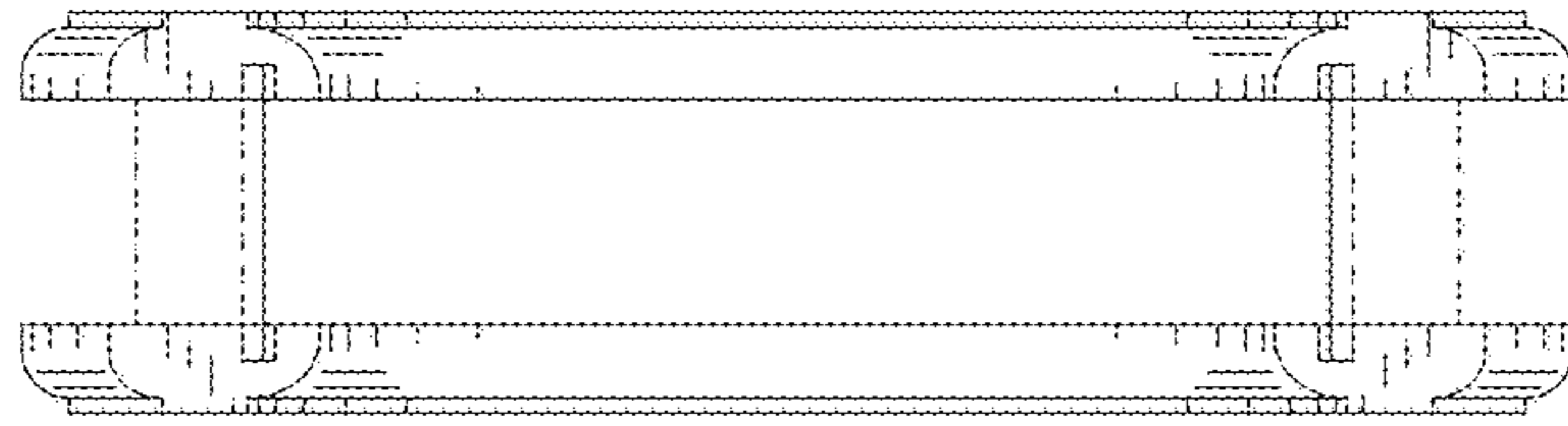

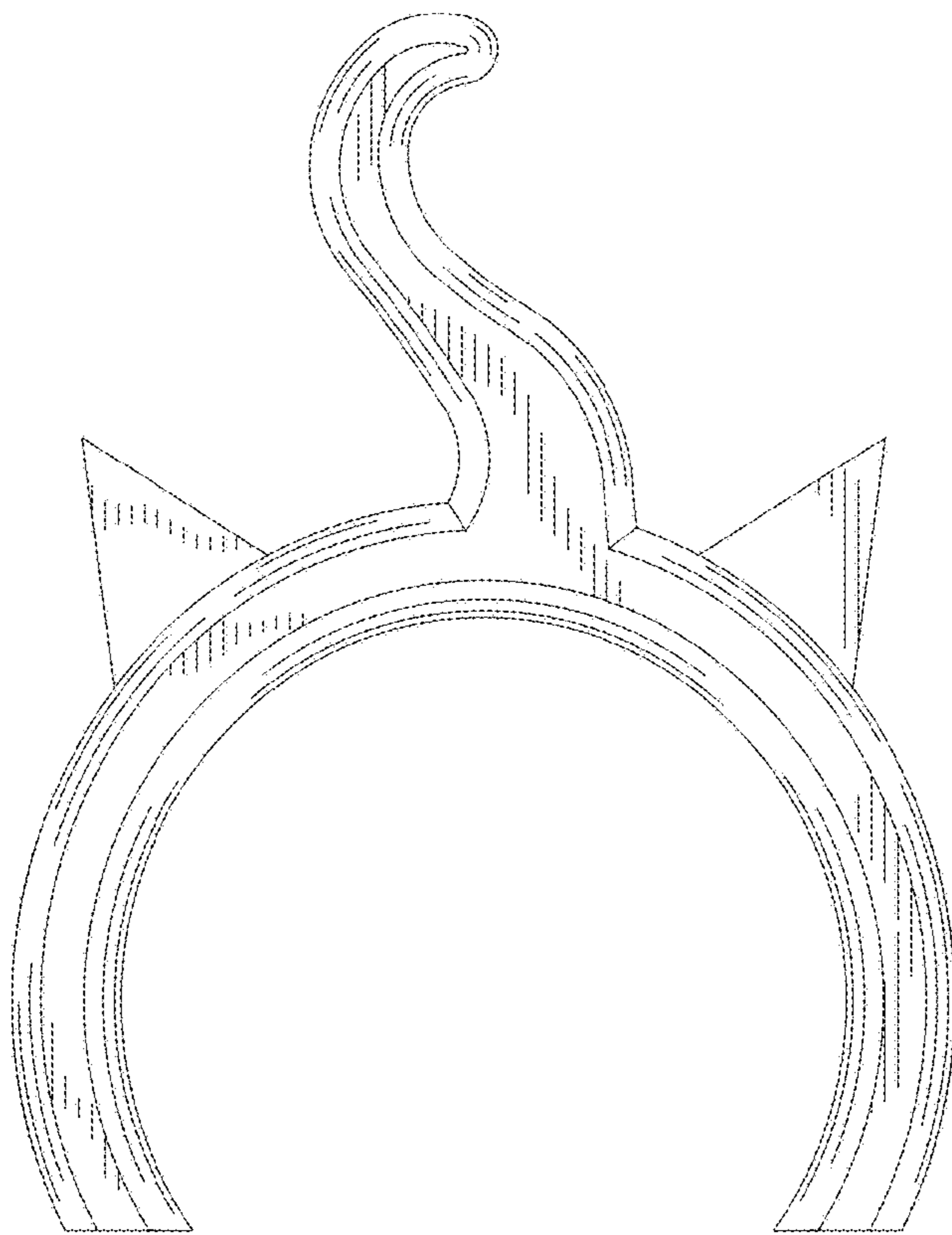

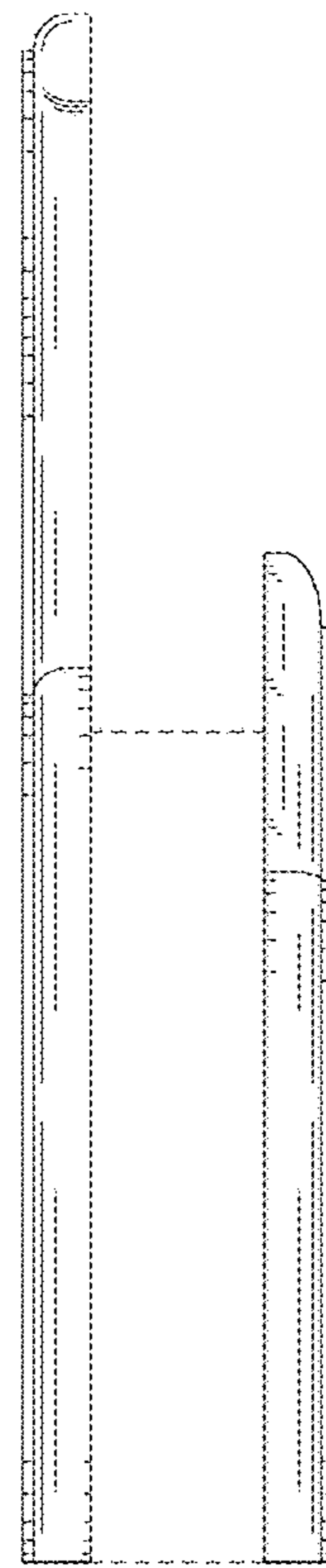

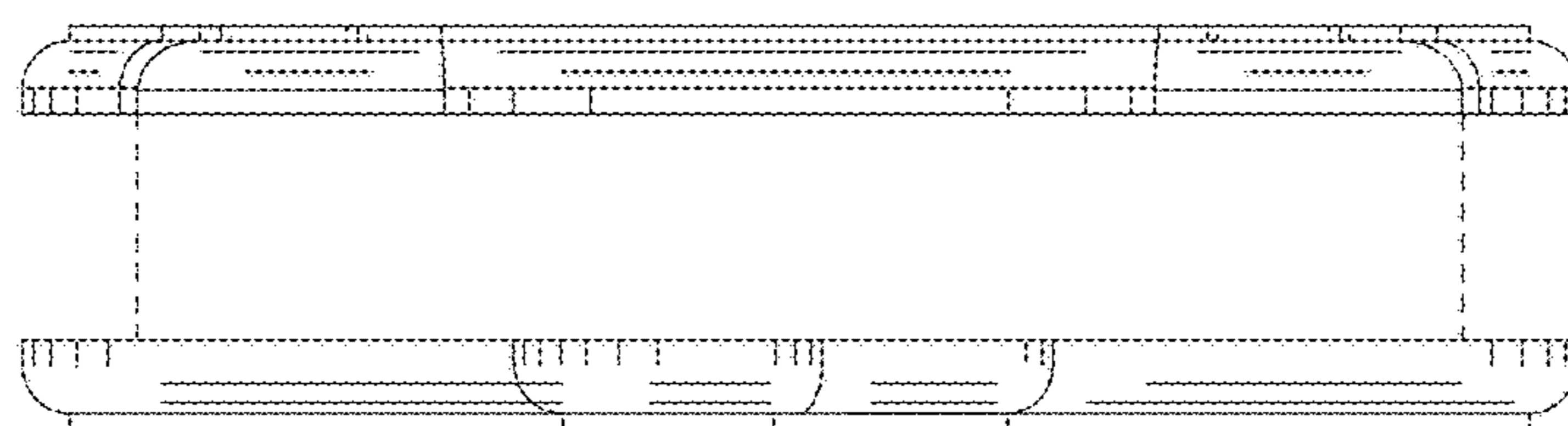

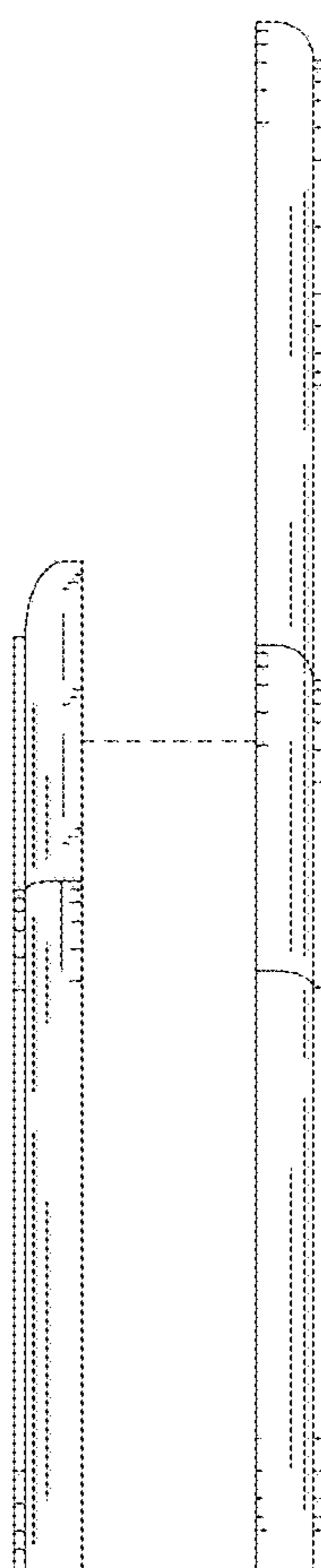

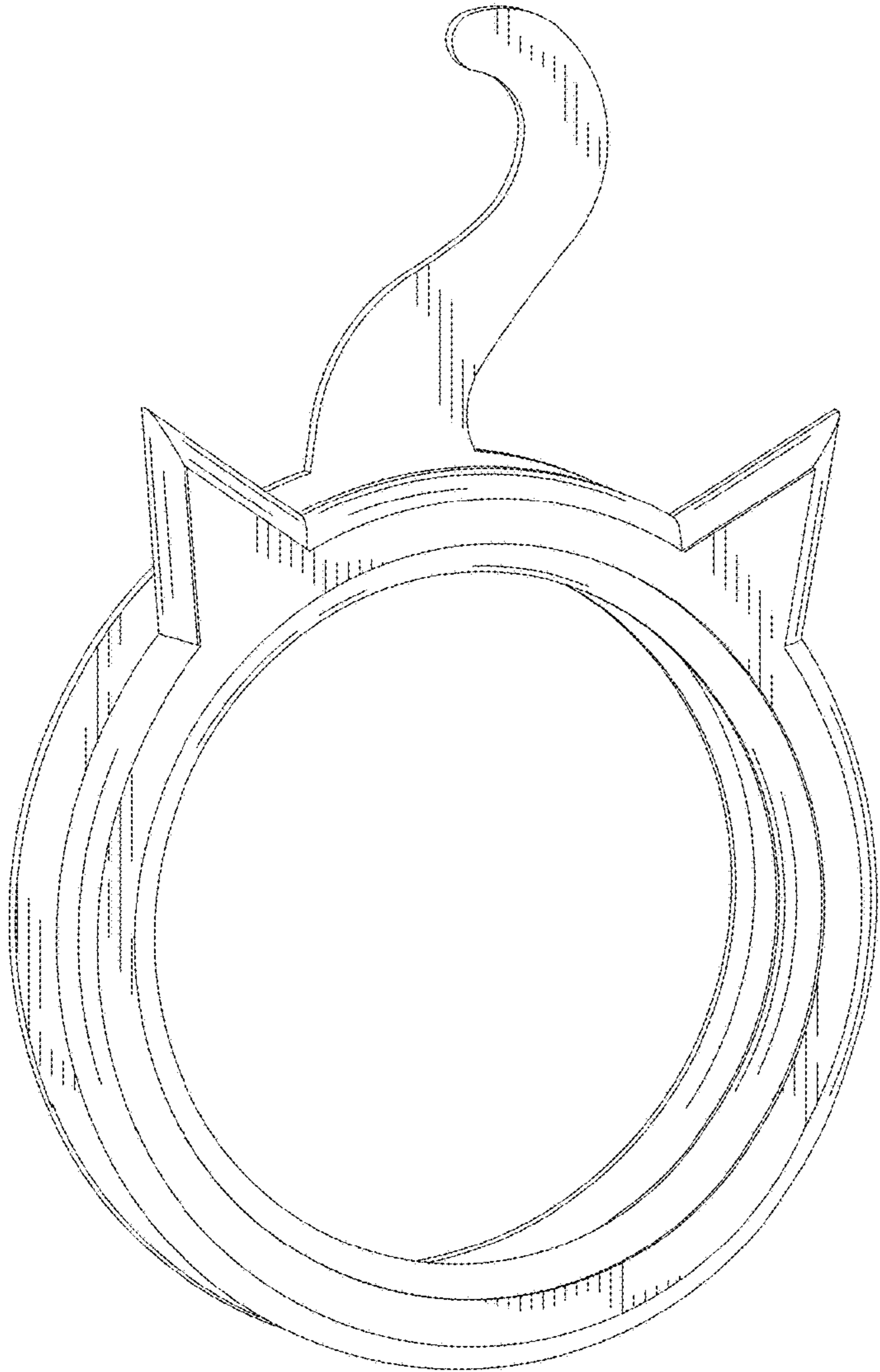

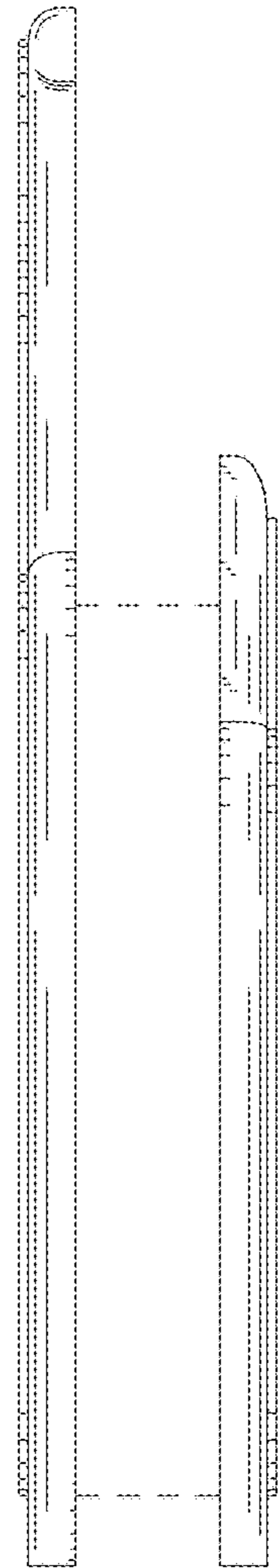

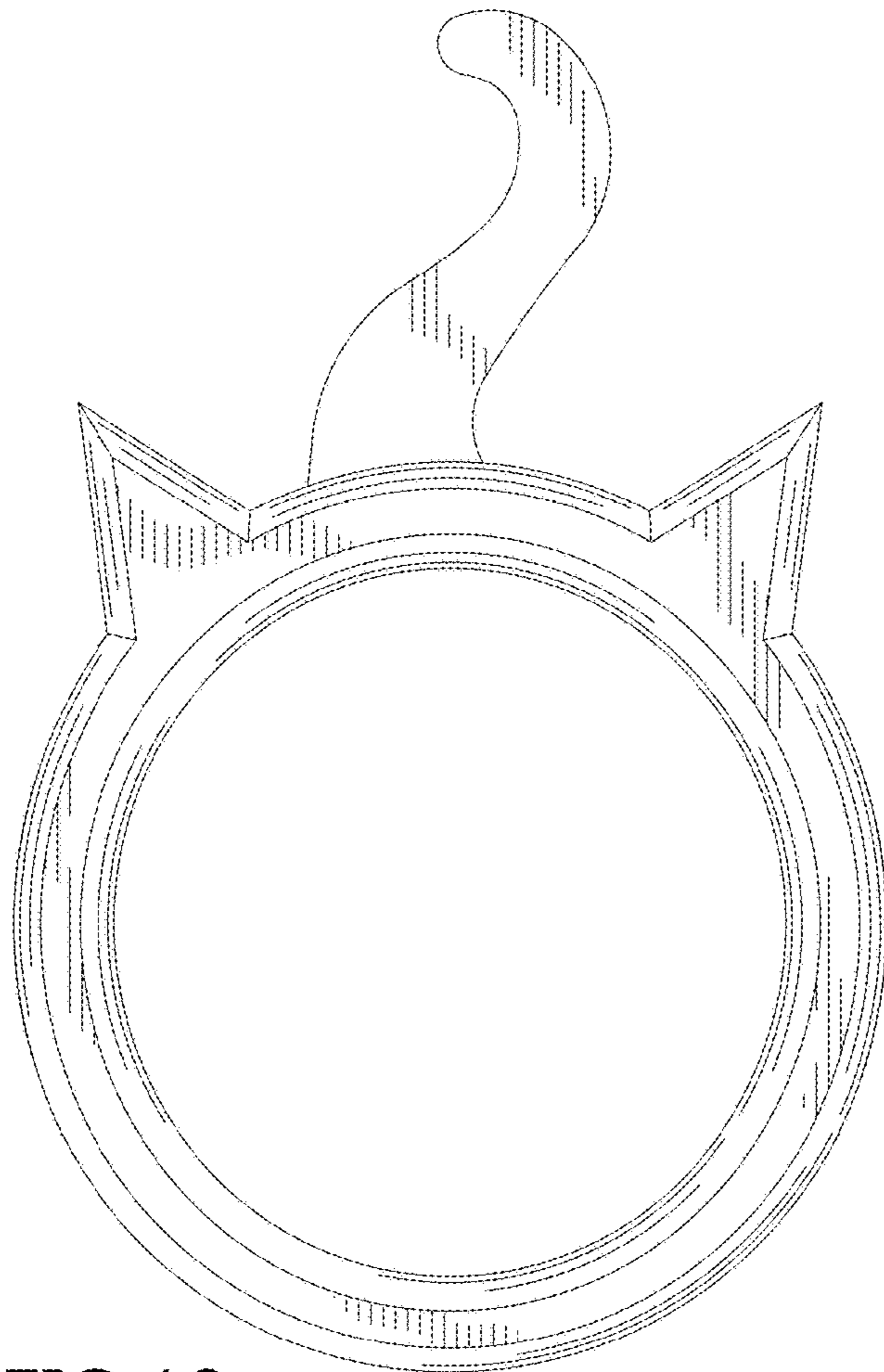

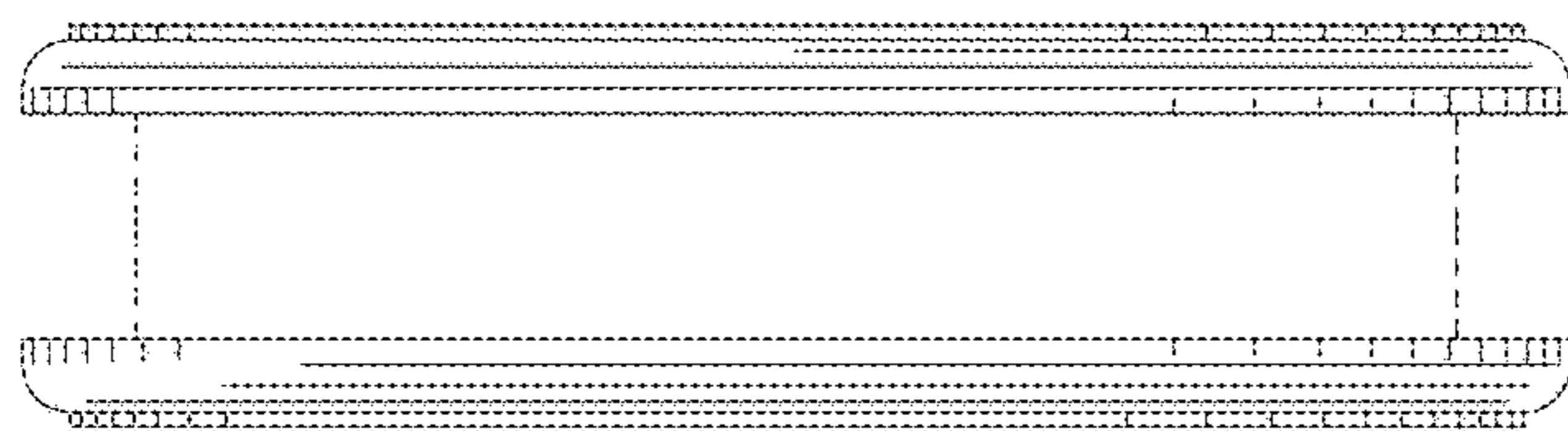

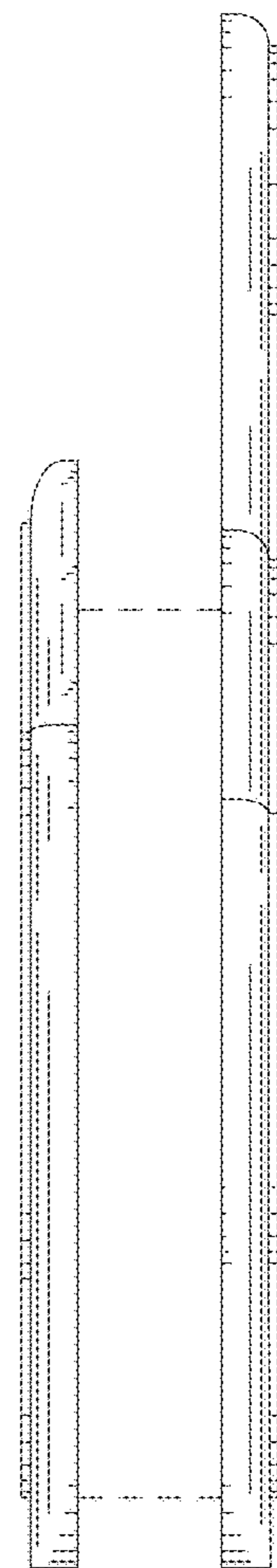

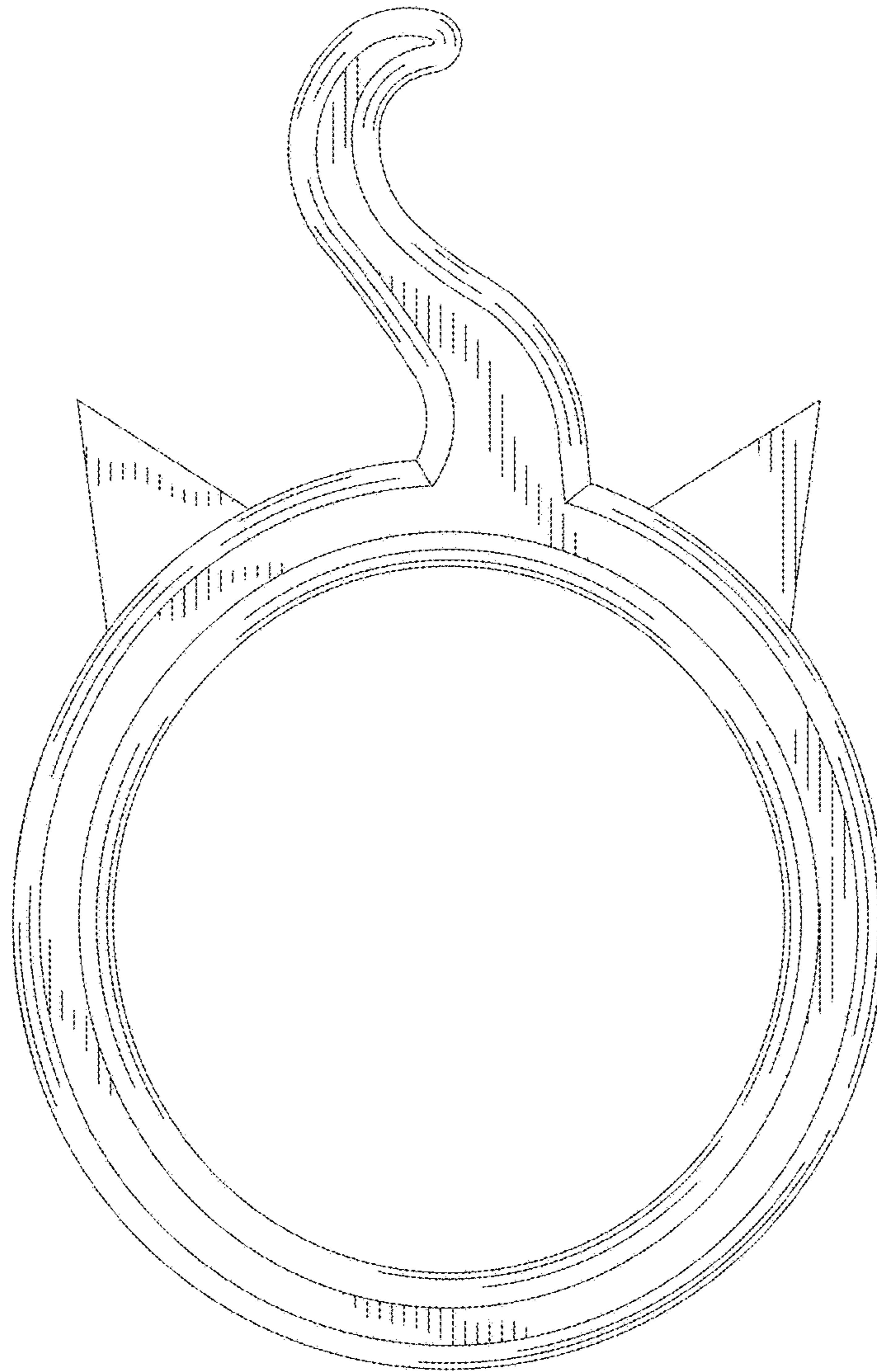

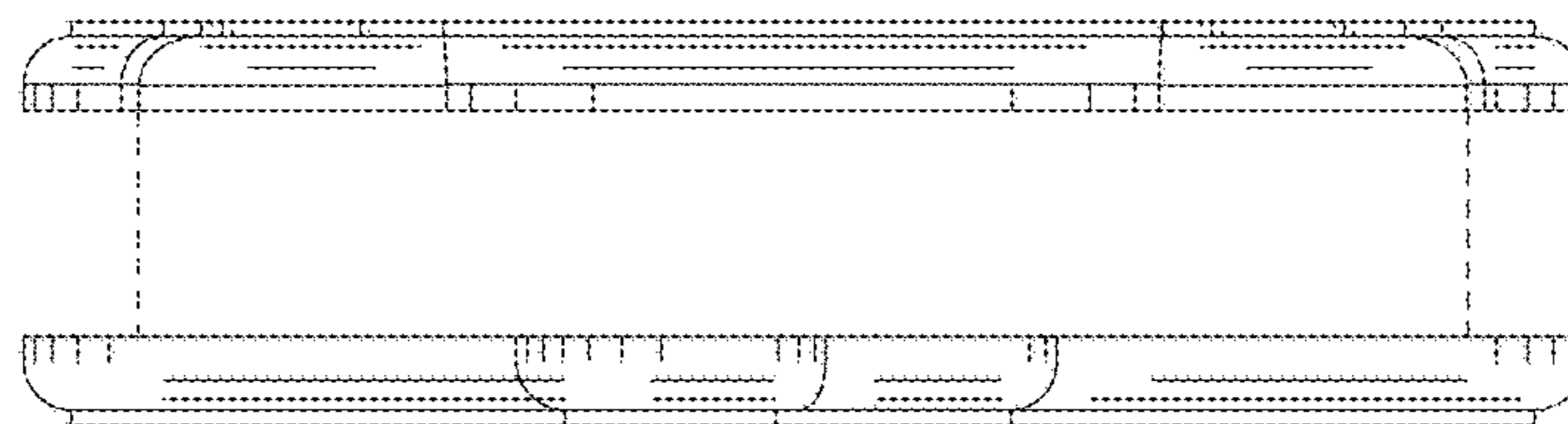
