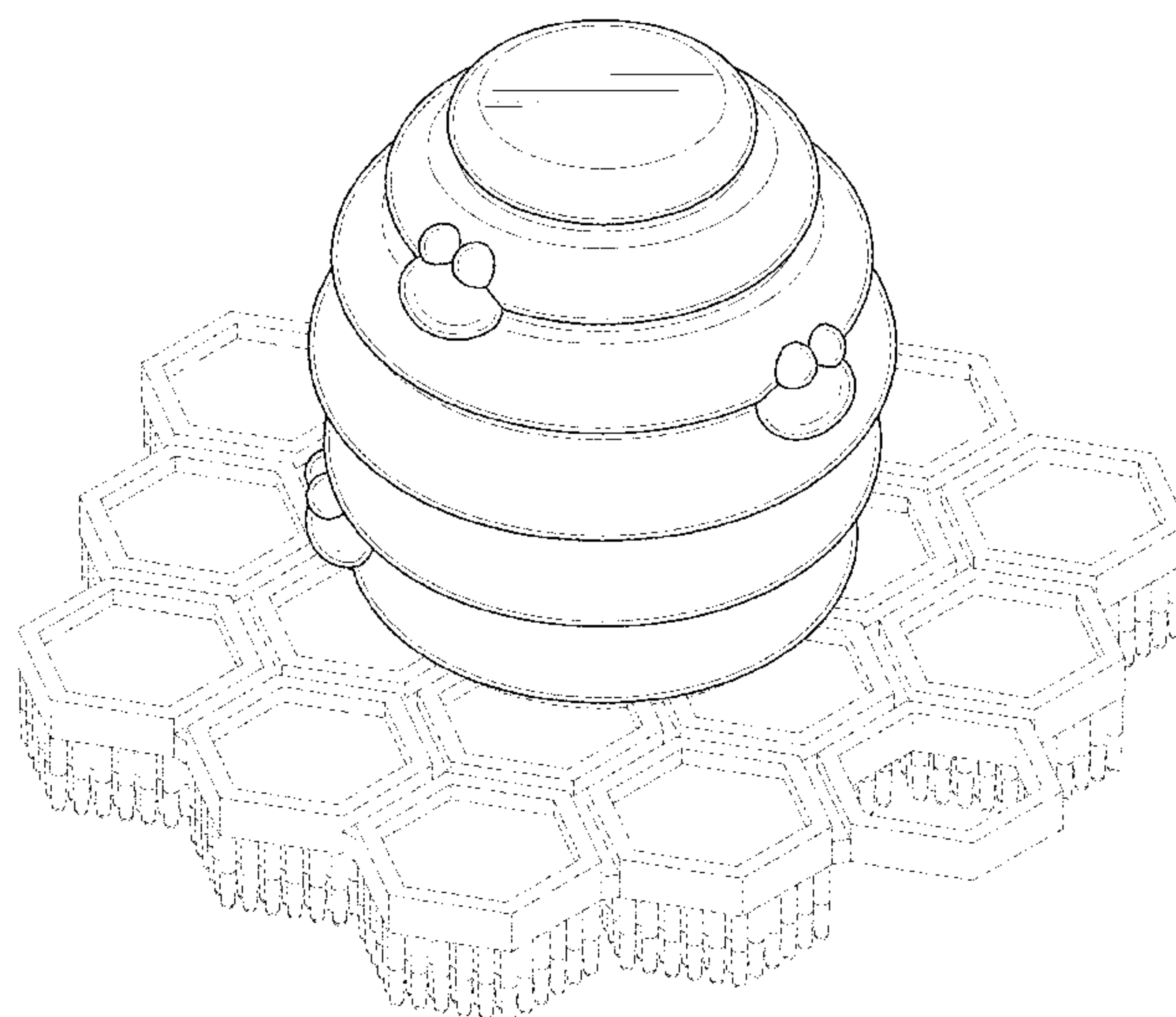
(57) **CLAIM**

The ornamental design for a bath scrubber, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a bath scrubber having a hive shaped handle embodying my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a front elevation view thereof;
FIG. 6 is a left side elevation view thereof; and,
FIG. 7 is a right side elevation view thereof.
The broken lines illustrate unclaimed portions of the bath scrubber that form no part of the claimed design.

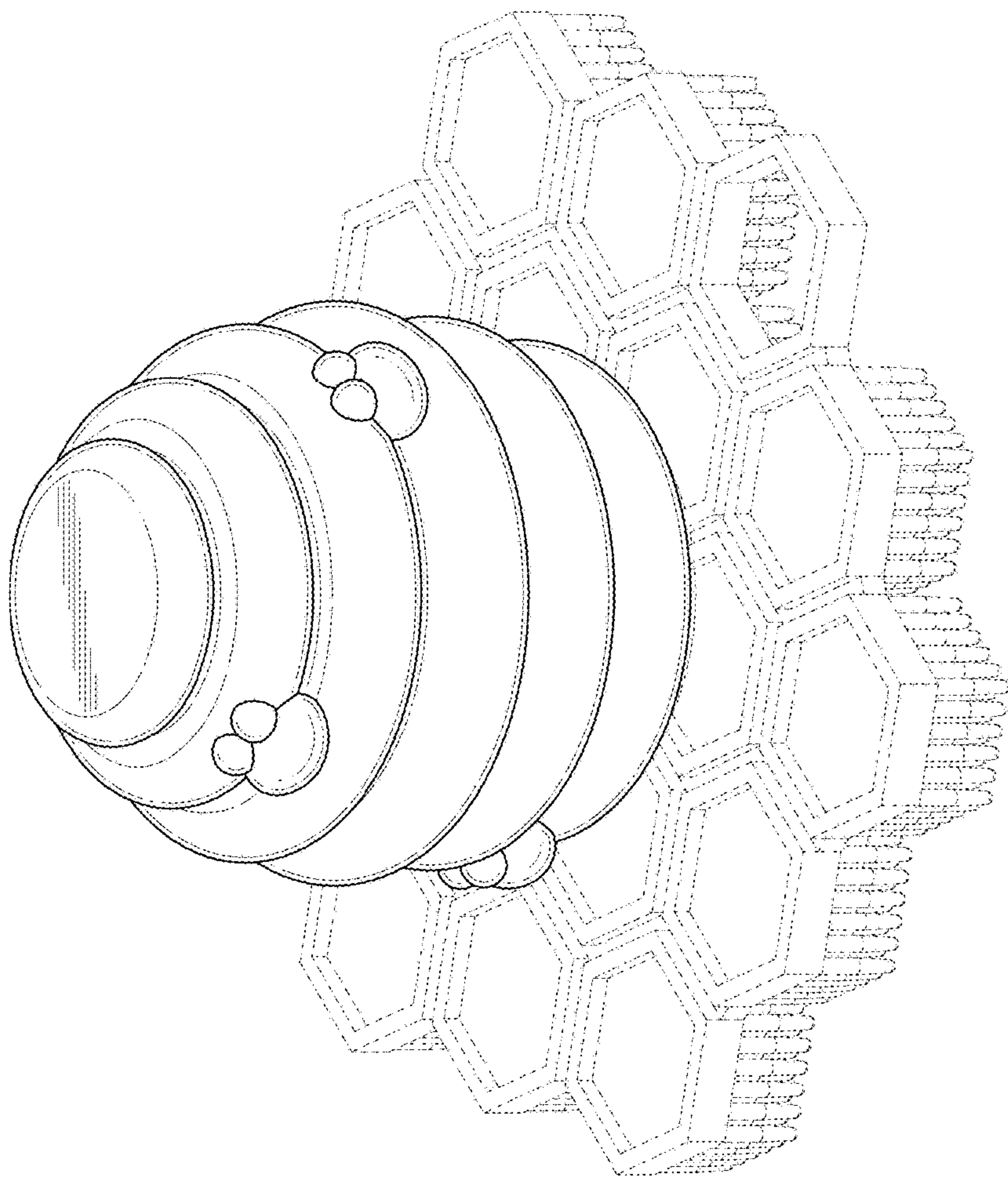

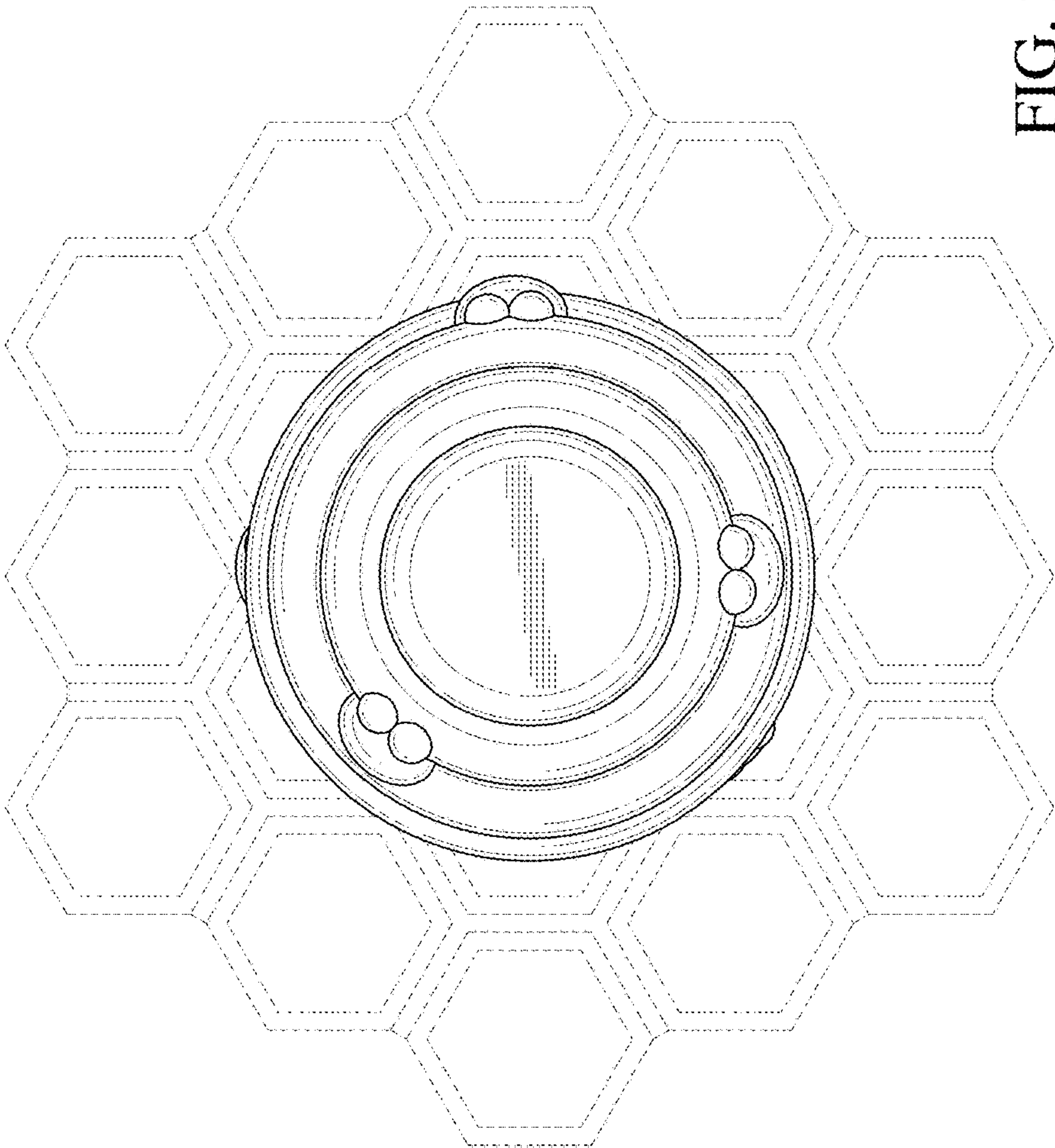

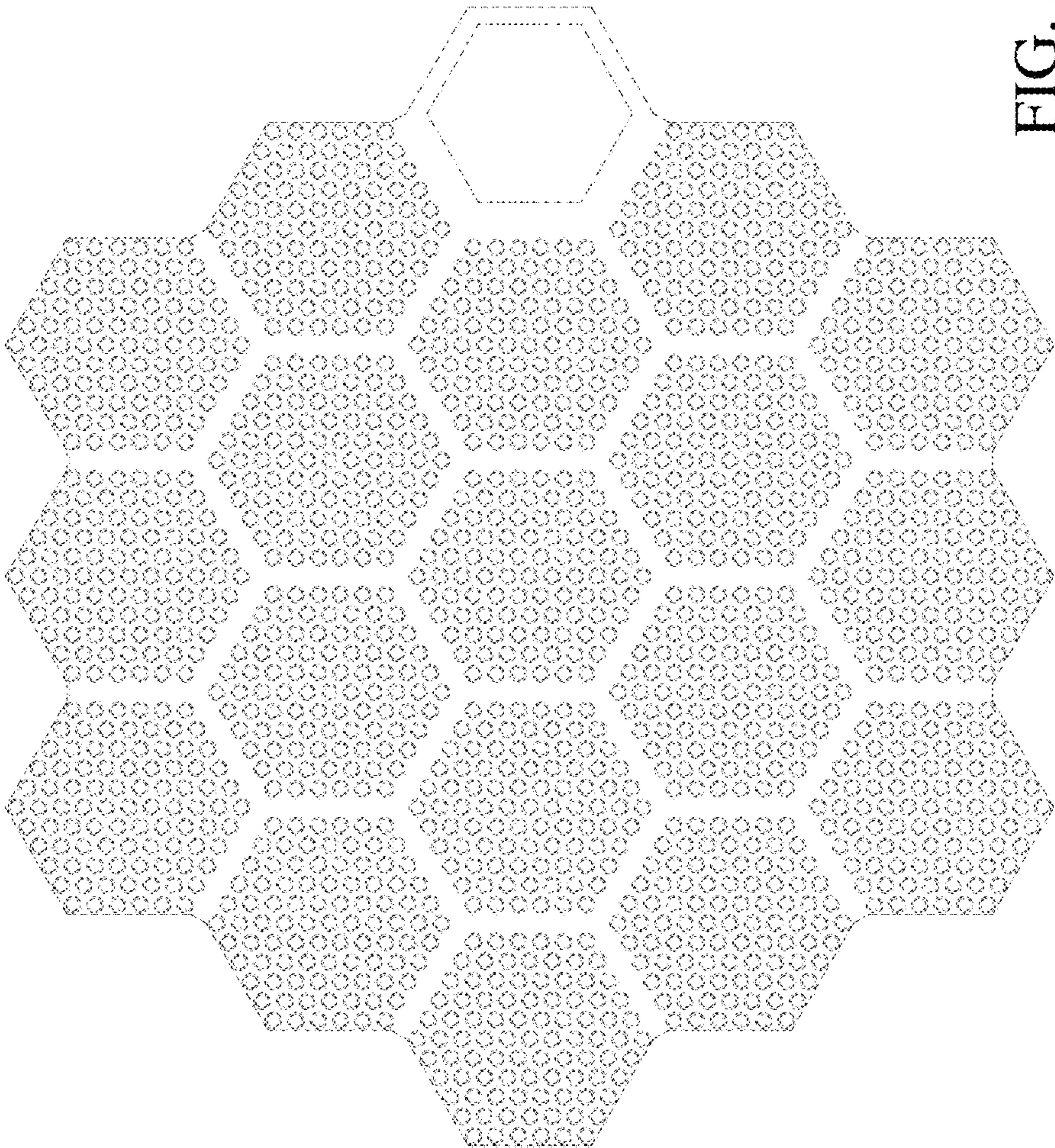

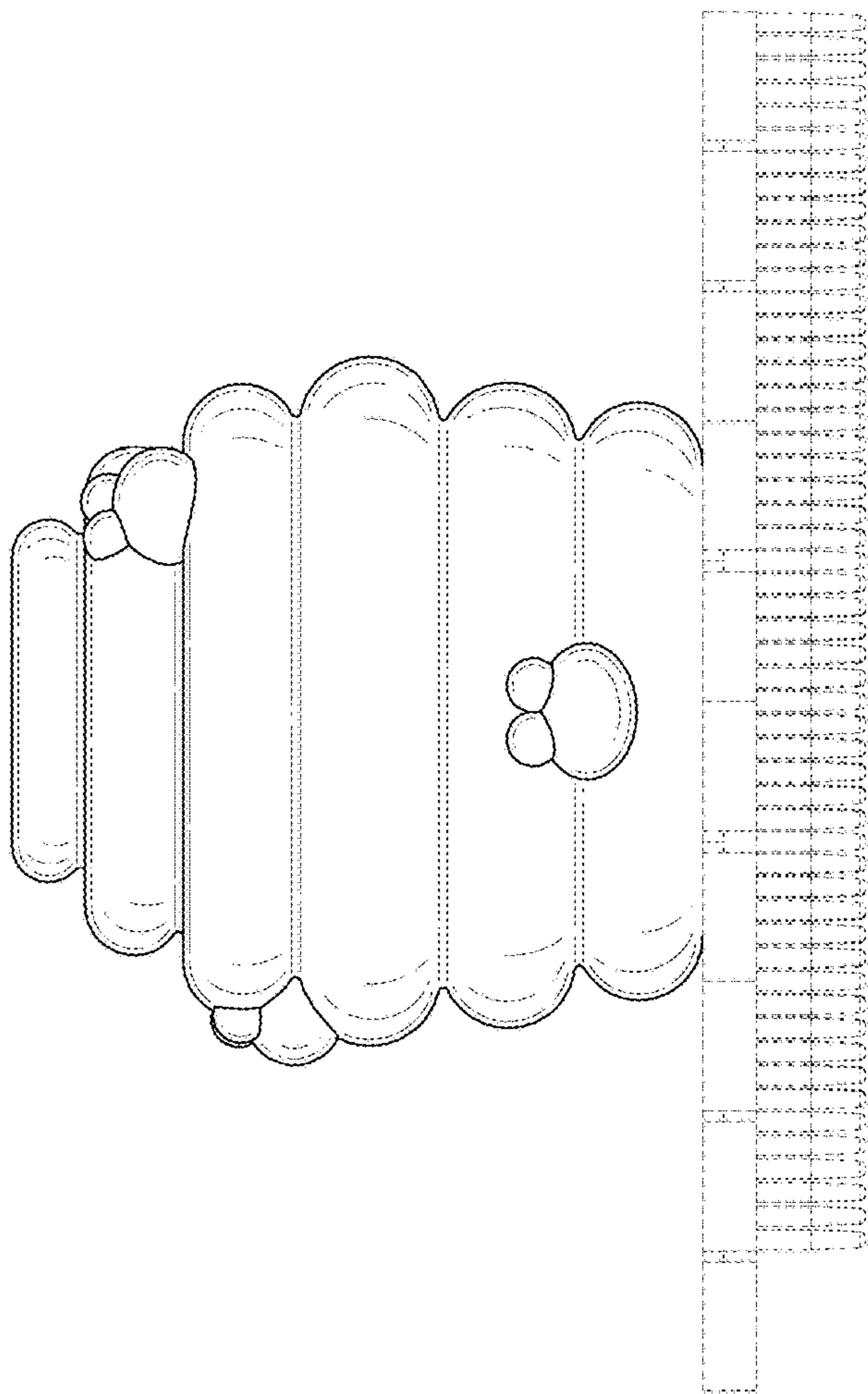

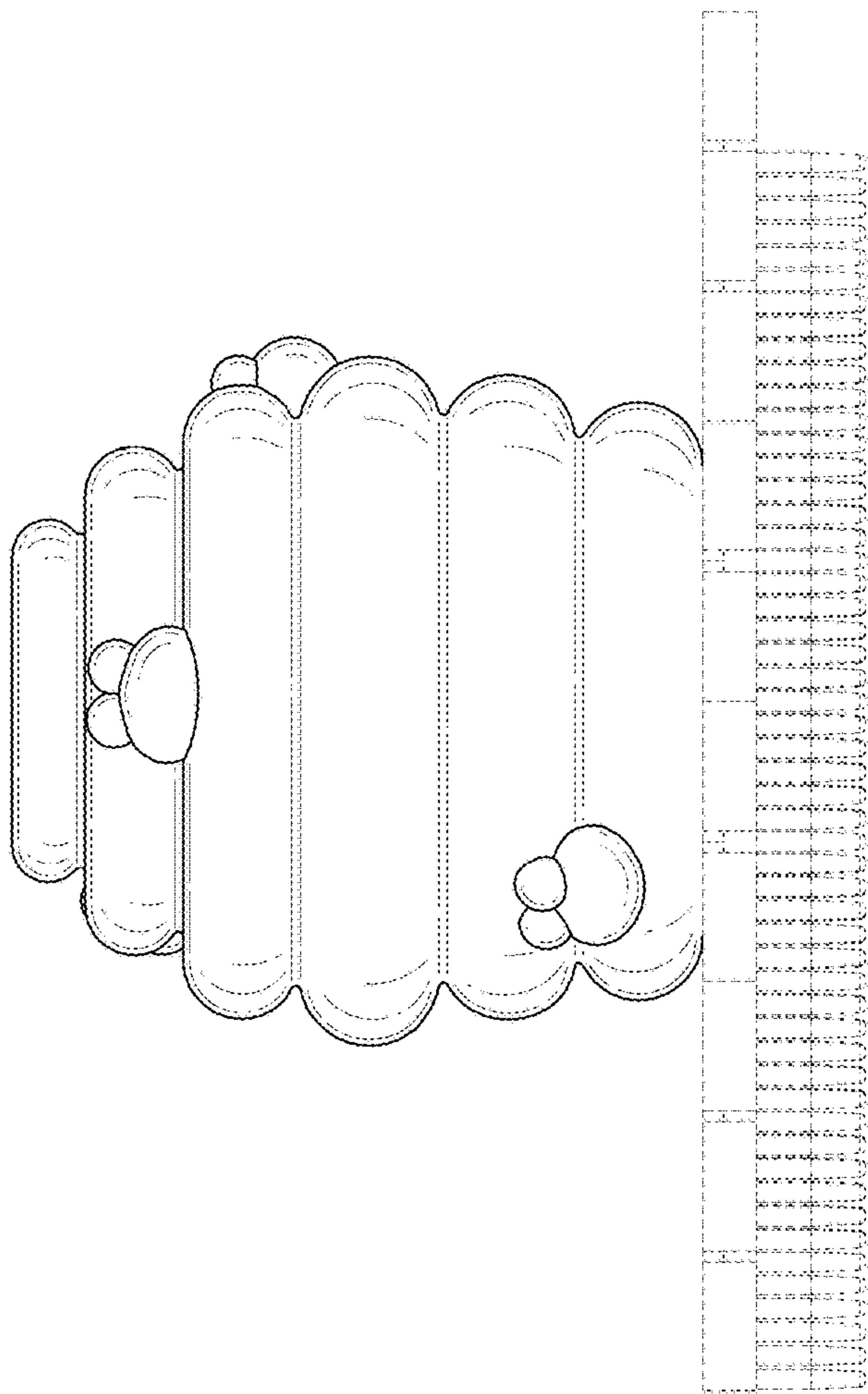

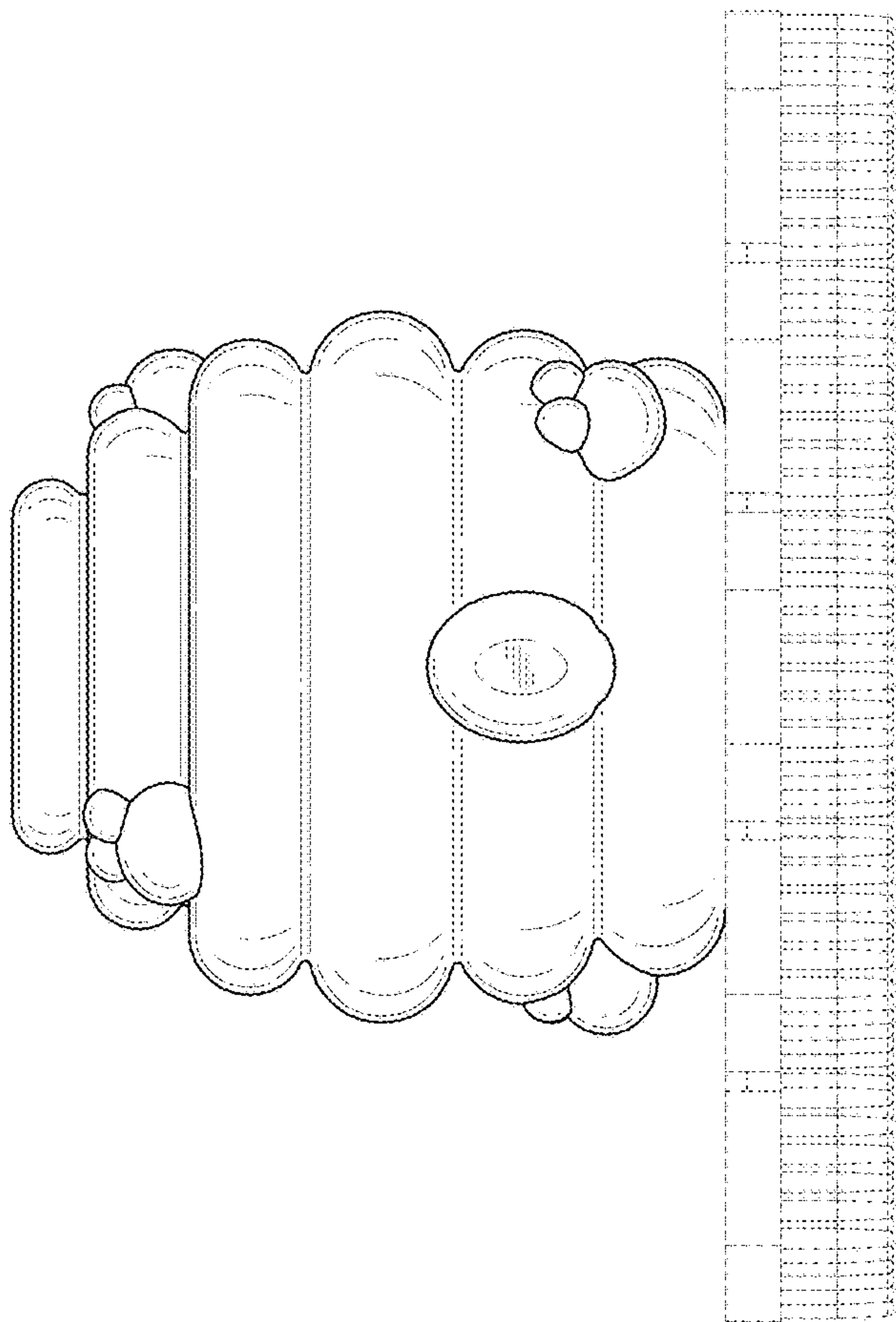

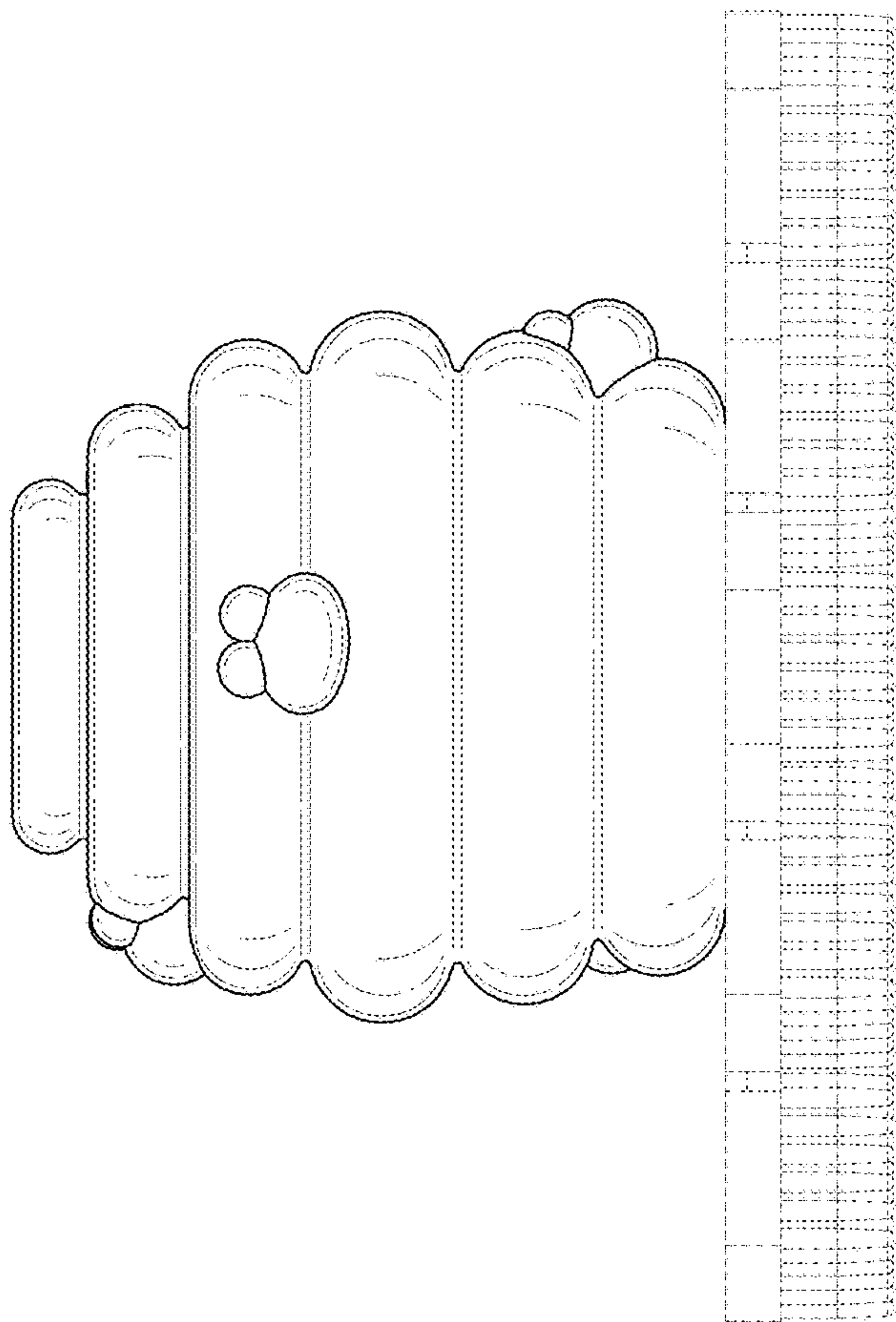
