The broken lines in the drawings depict environmental portions that form no part of the claimed design.

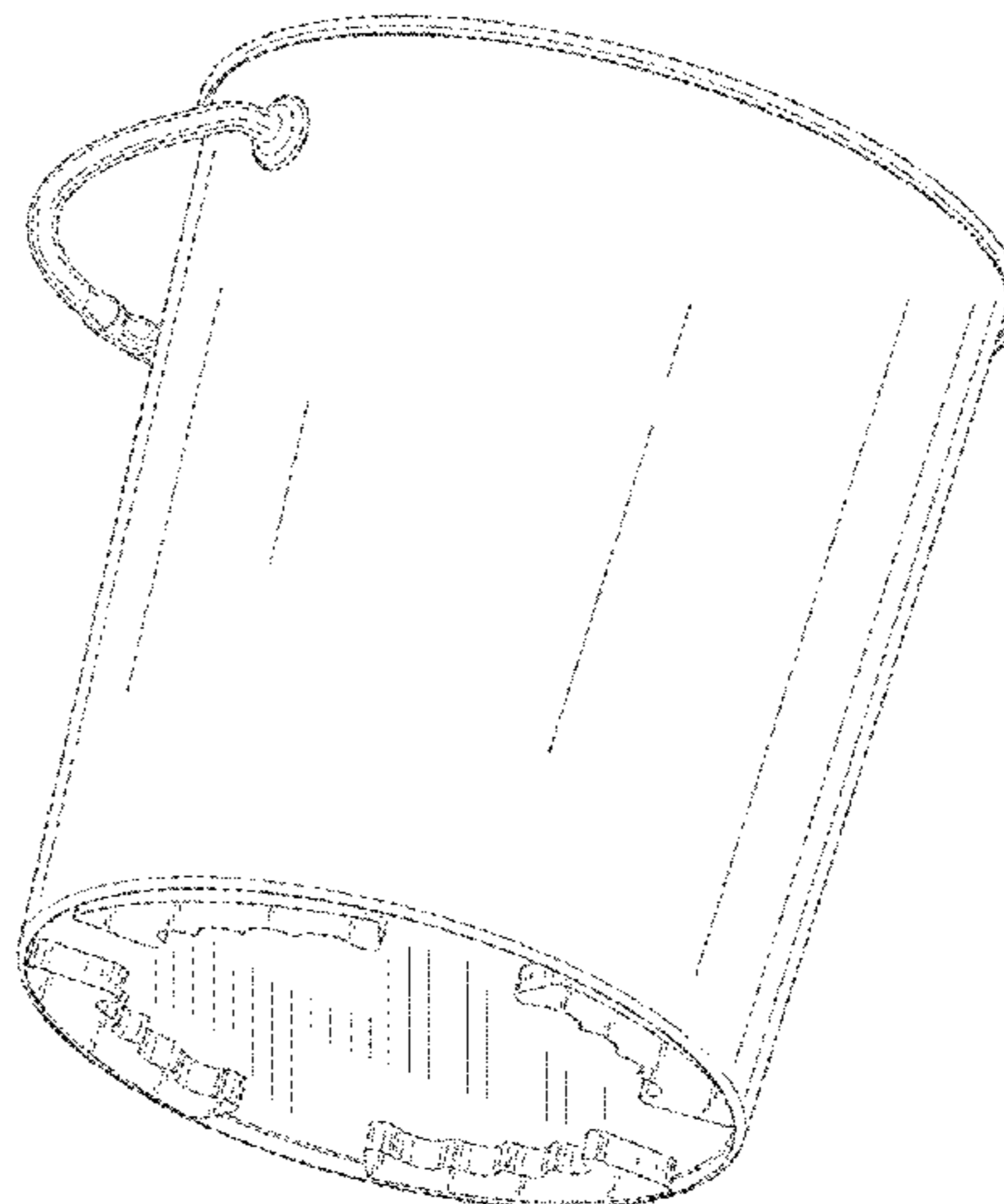
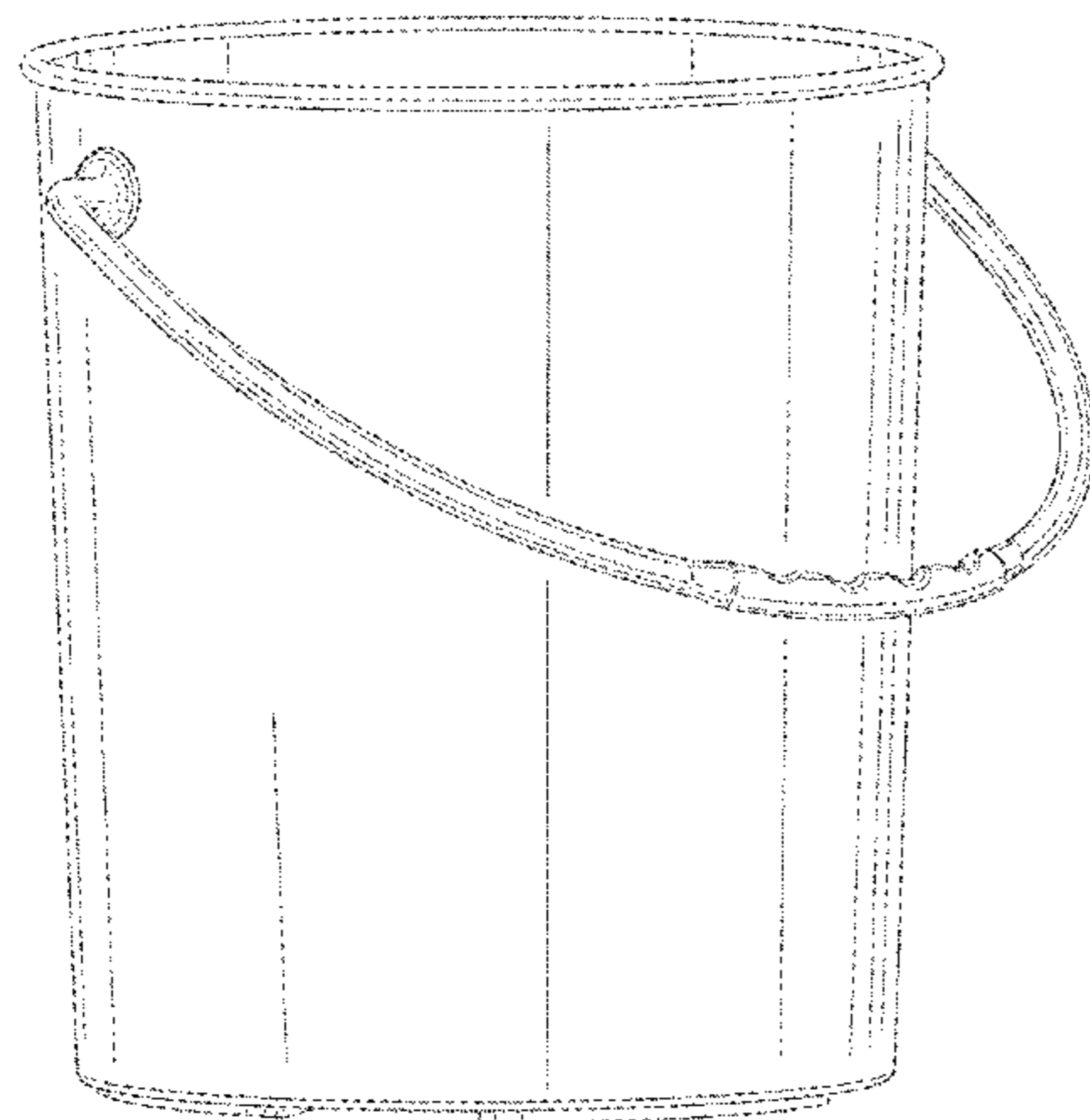

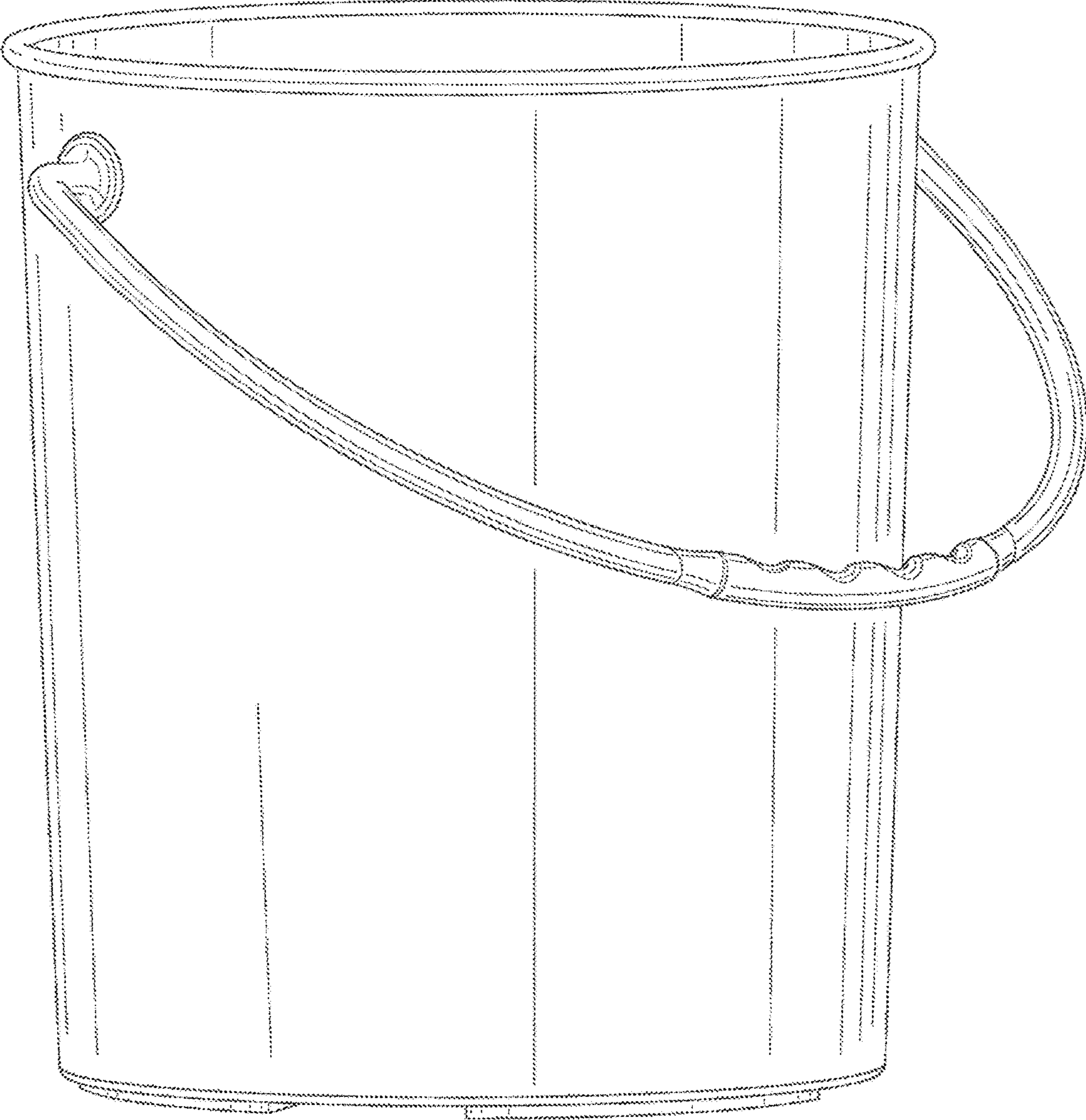

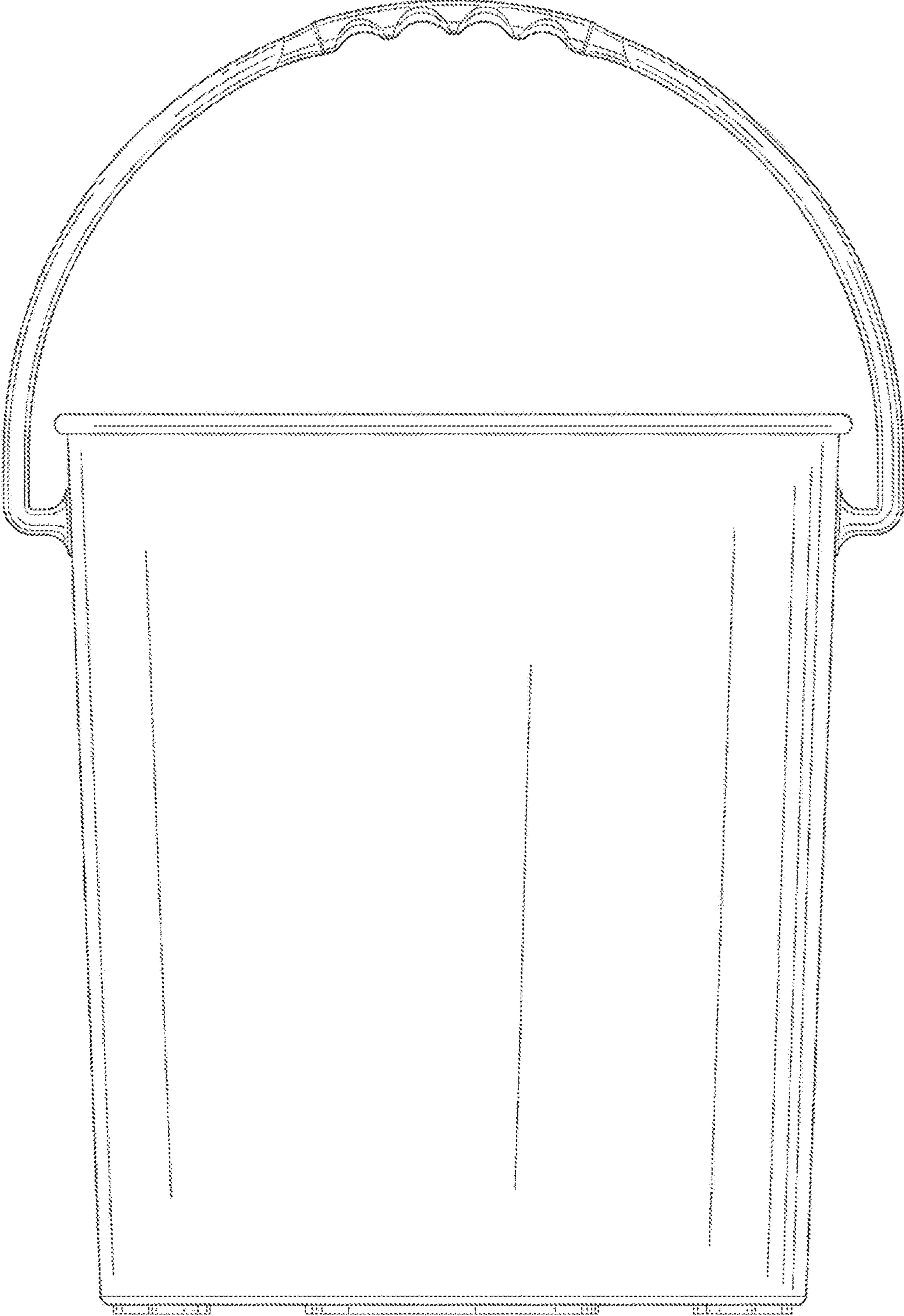

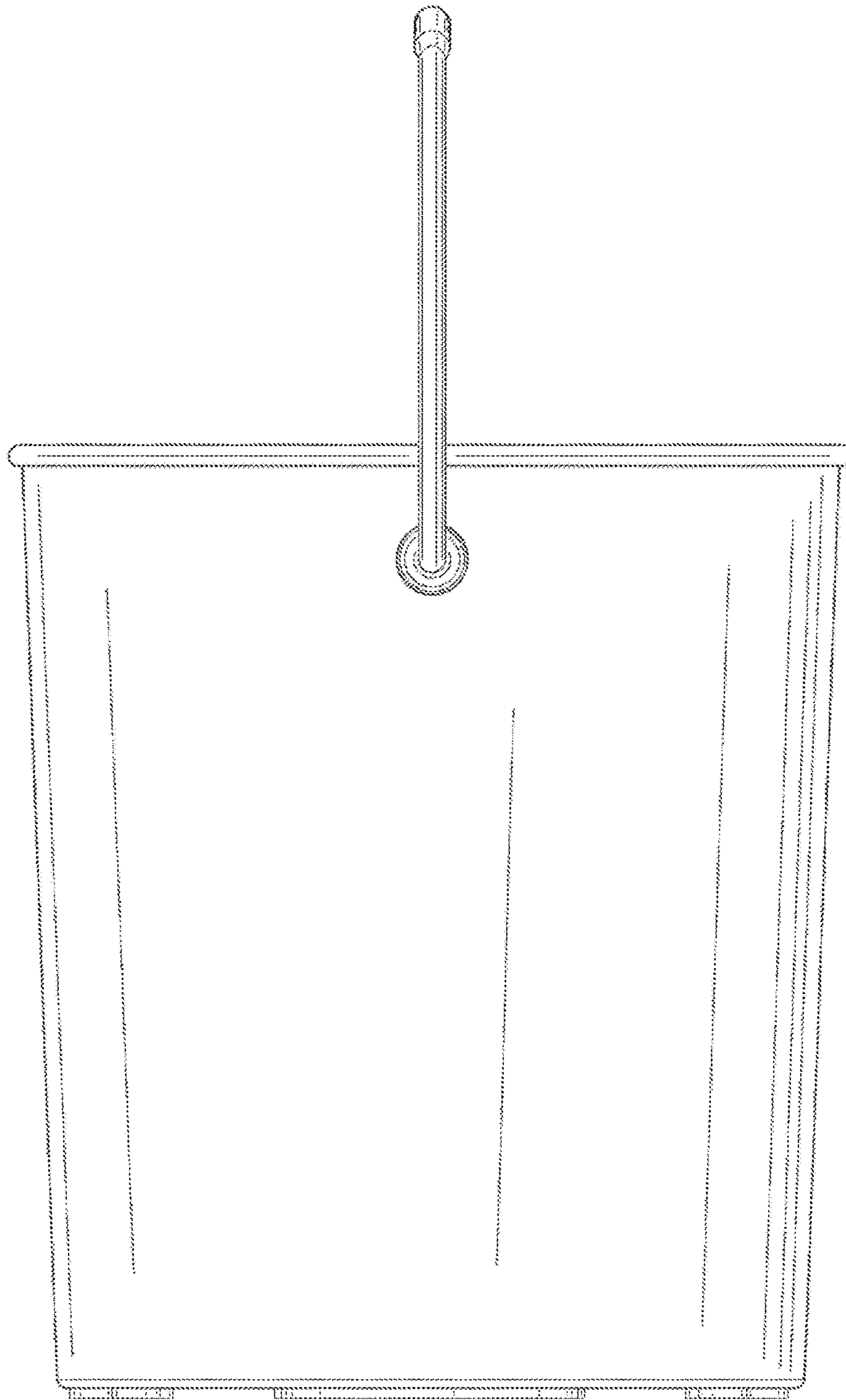

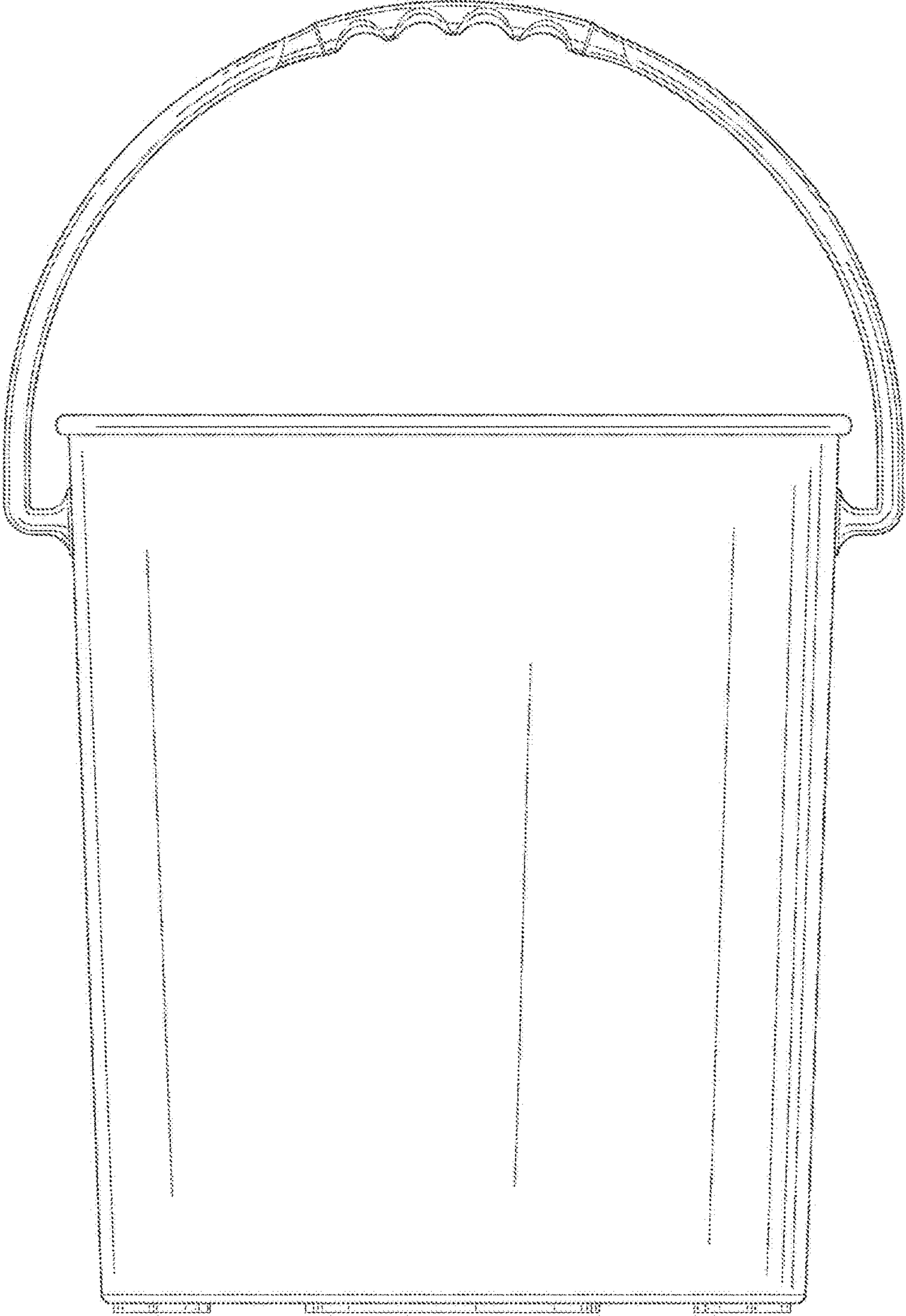

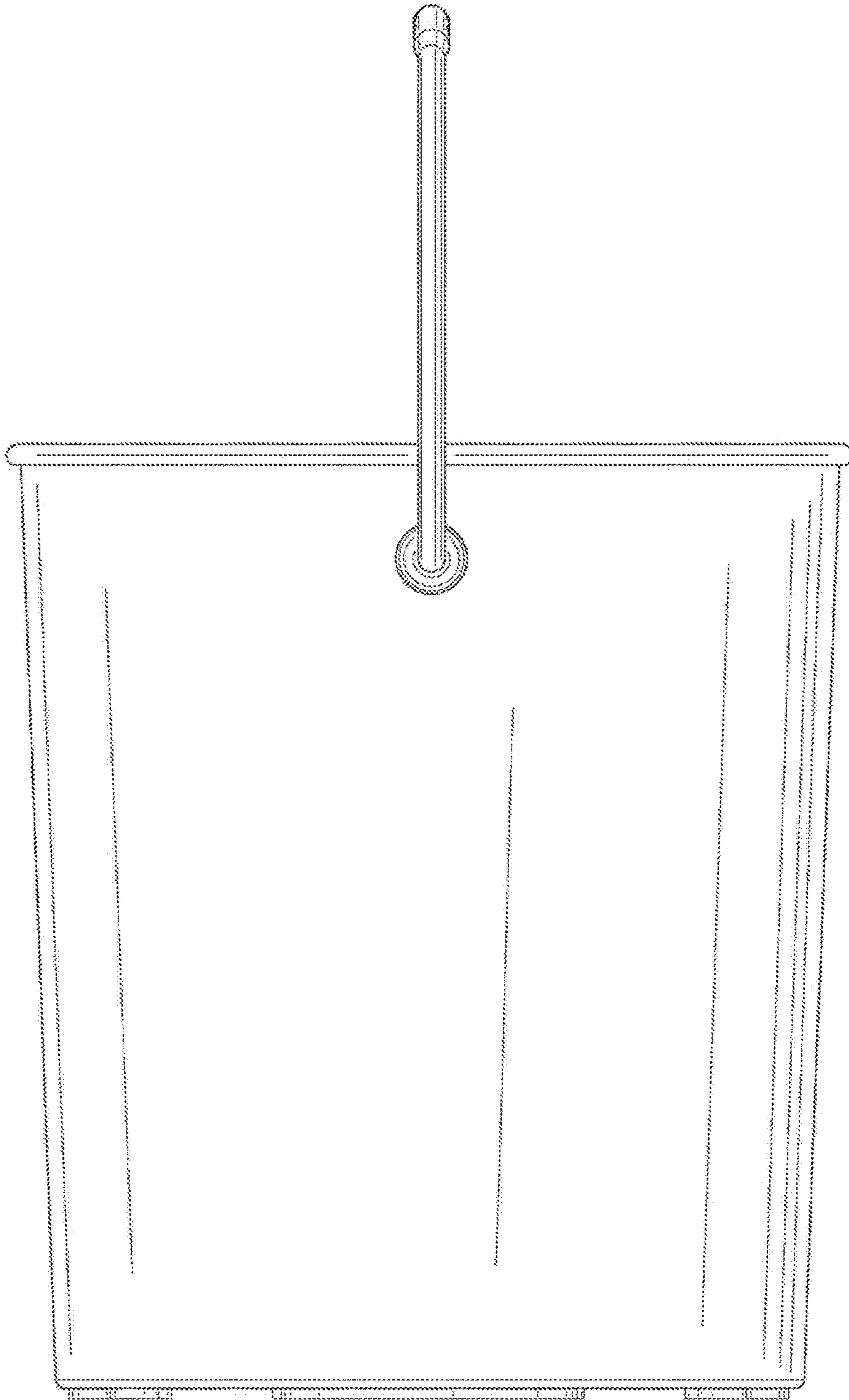

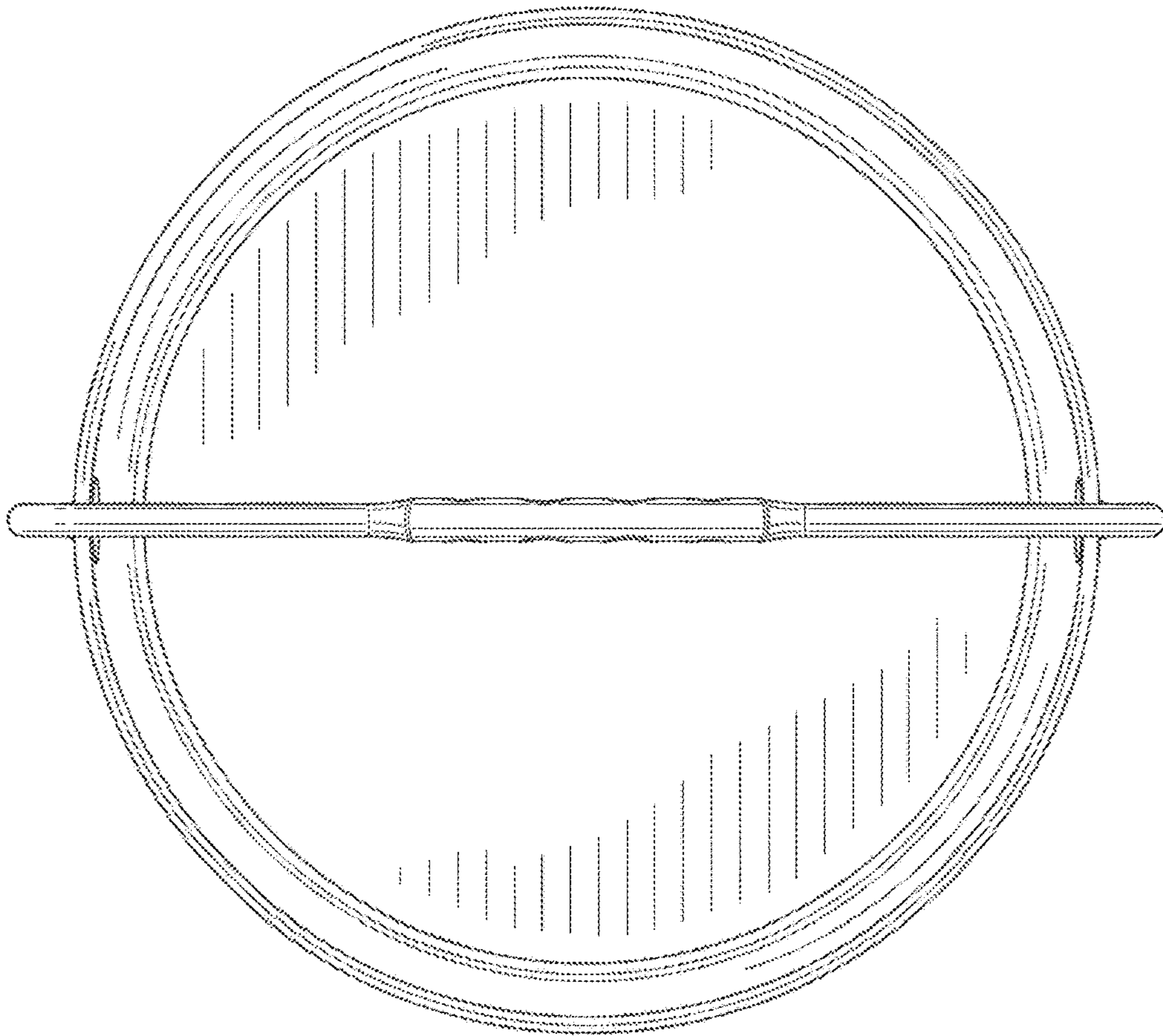

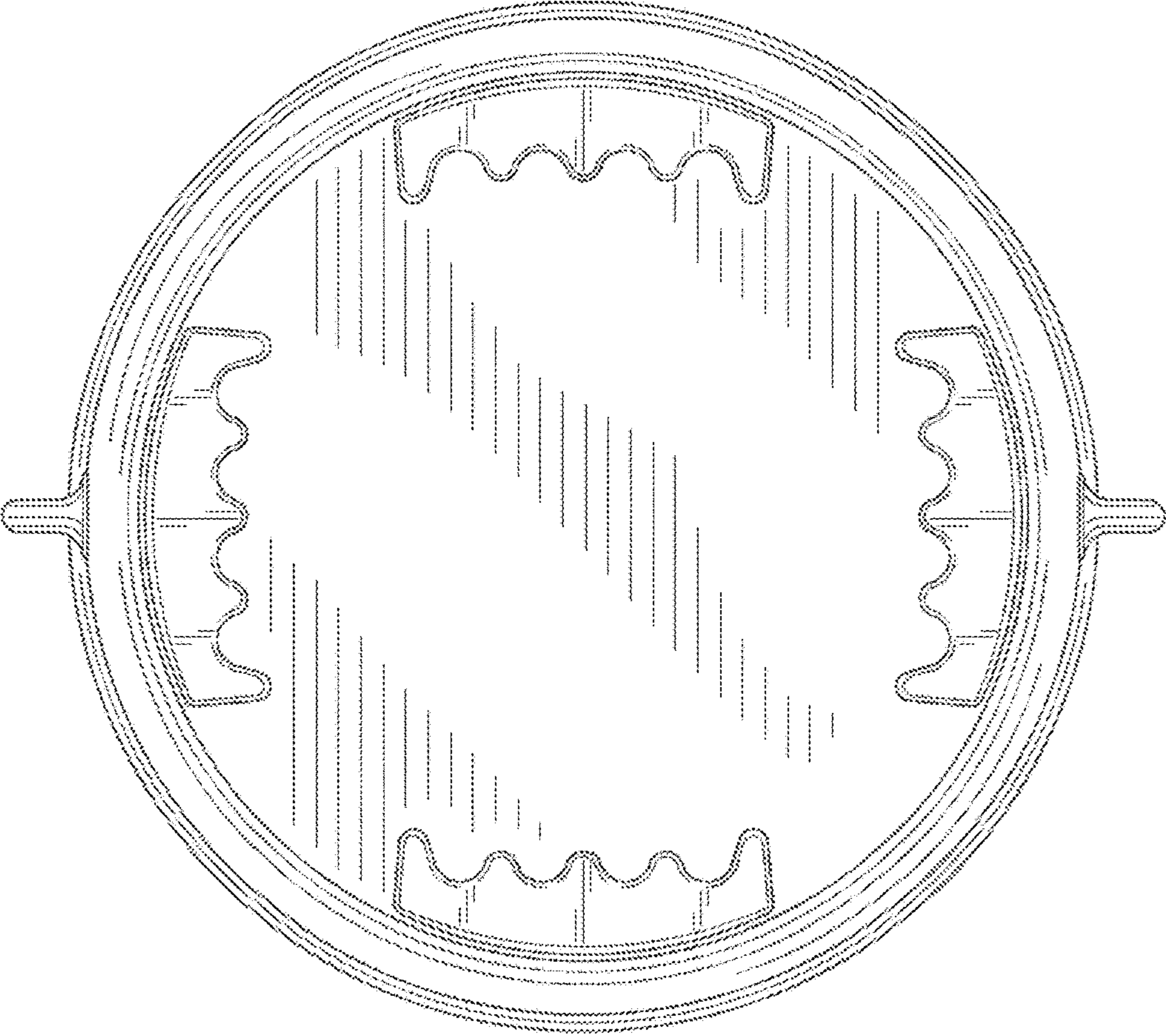

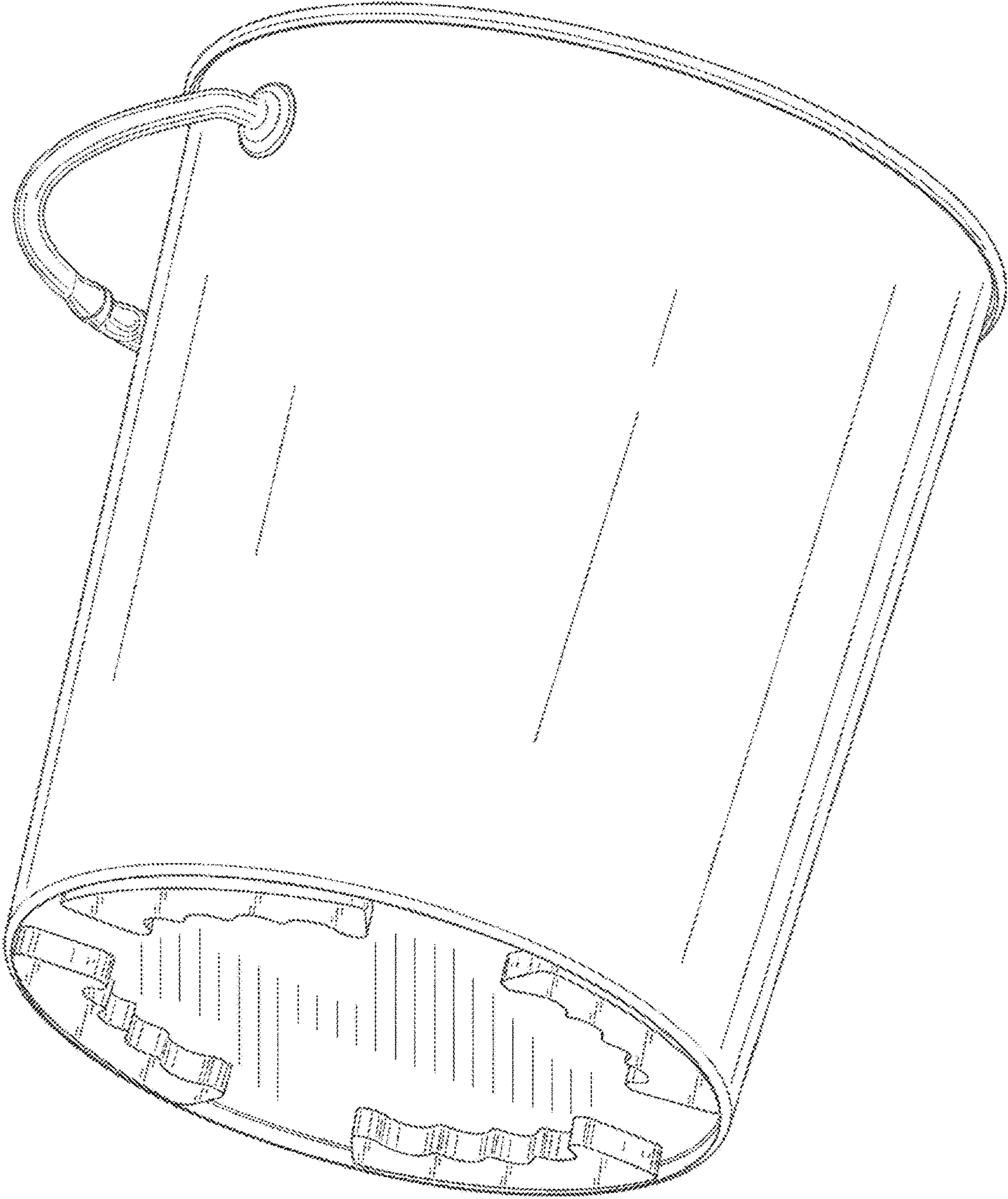

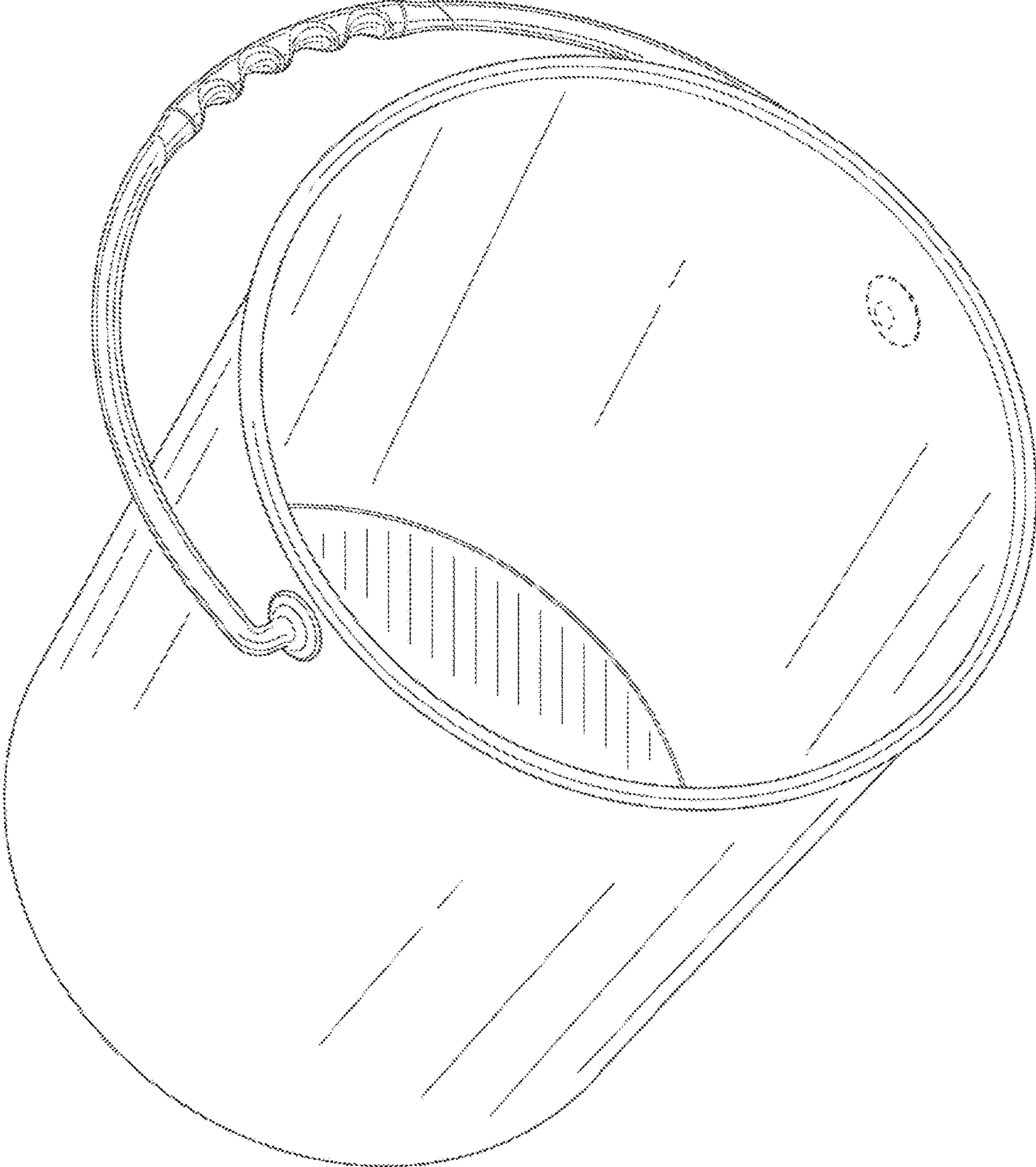
