FIG. 1 is a top, front, and right-side perspective view of a
container-storage enclosure module showing our new design
comprising boards and with an attached second enclosure
module shown in broken lines, the top, front, and left-side
perspective view of said enclosure module being a mirror
image of that shown;

FIG. 2 is a top, front, and right-side perspective view of the
combined enclosure modules of FIG. 1 on the top of each of
which a container is positioned transversely as shown in
broken lines;

FIG. 3 is a top, front, and right-side perspective view of the
enclosure module of FIG. 1, wherein the front door and the
top lid are in opened positions to show the interior of the
enclosure;

FIG. 4 is a top plan view of the enclosure module of FIG. 1,
FIG. 5 is a front elevation view of the enclosure module of
FIG. 1;

FIG. 6 is a bottom plan view of the enclosure module of FIG.
1;

FIG. 7 is a left-side elevational view of the enclosure module
of FIG. 1;

FIG. 8 is a right-side elevational view of the enclosure
module of FIG. 1; and,

FIG. 9 is a rear elevational view of the enclosure module of
FIG. 1.

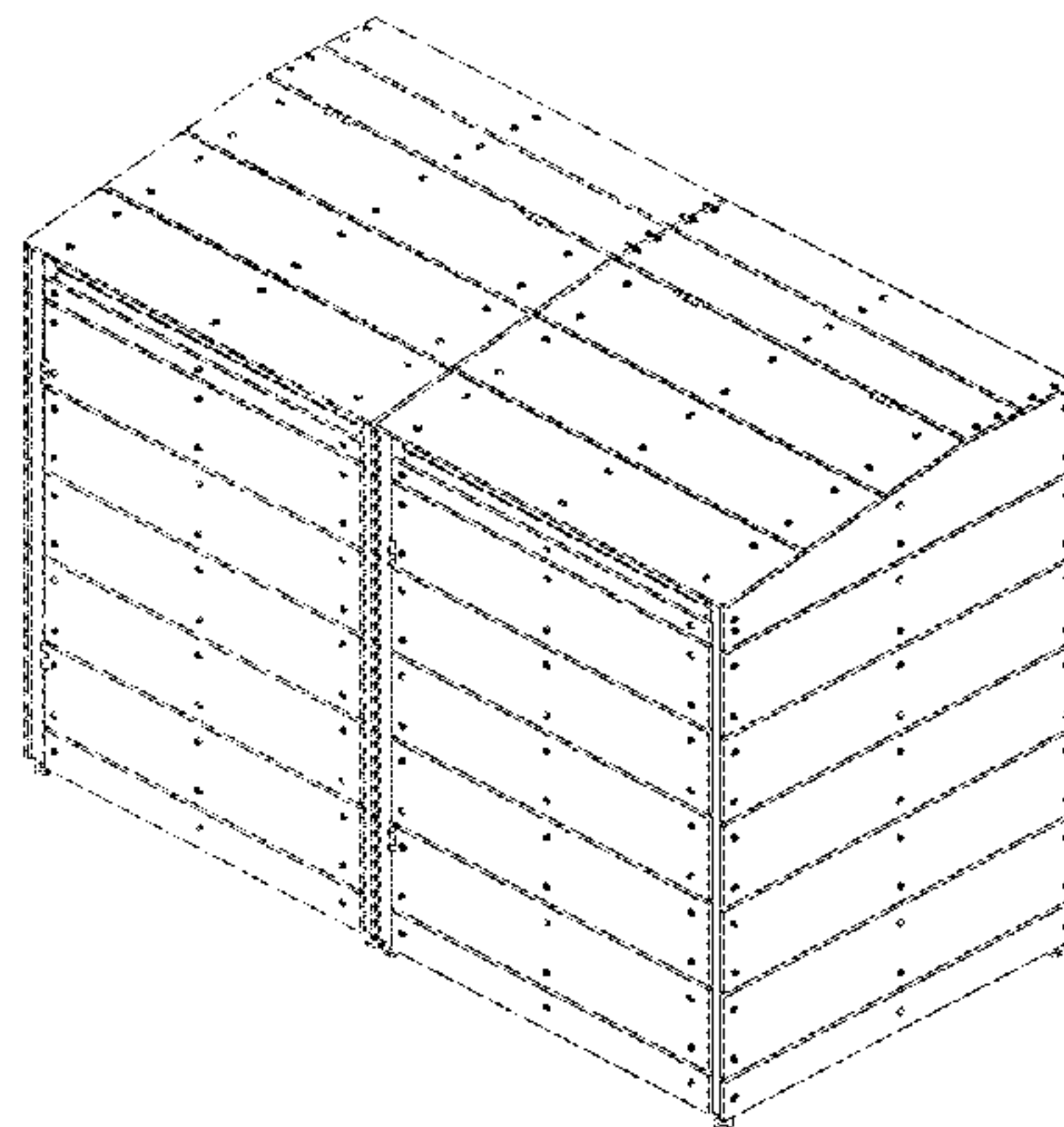

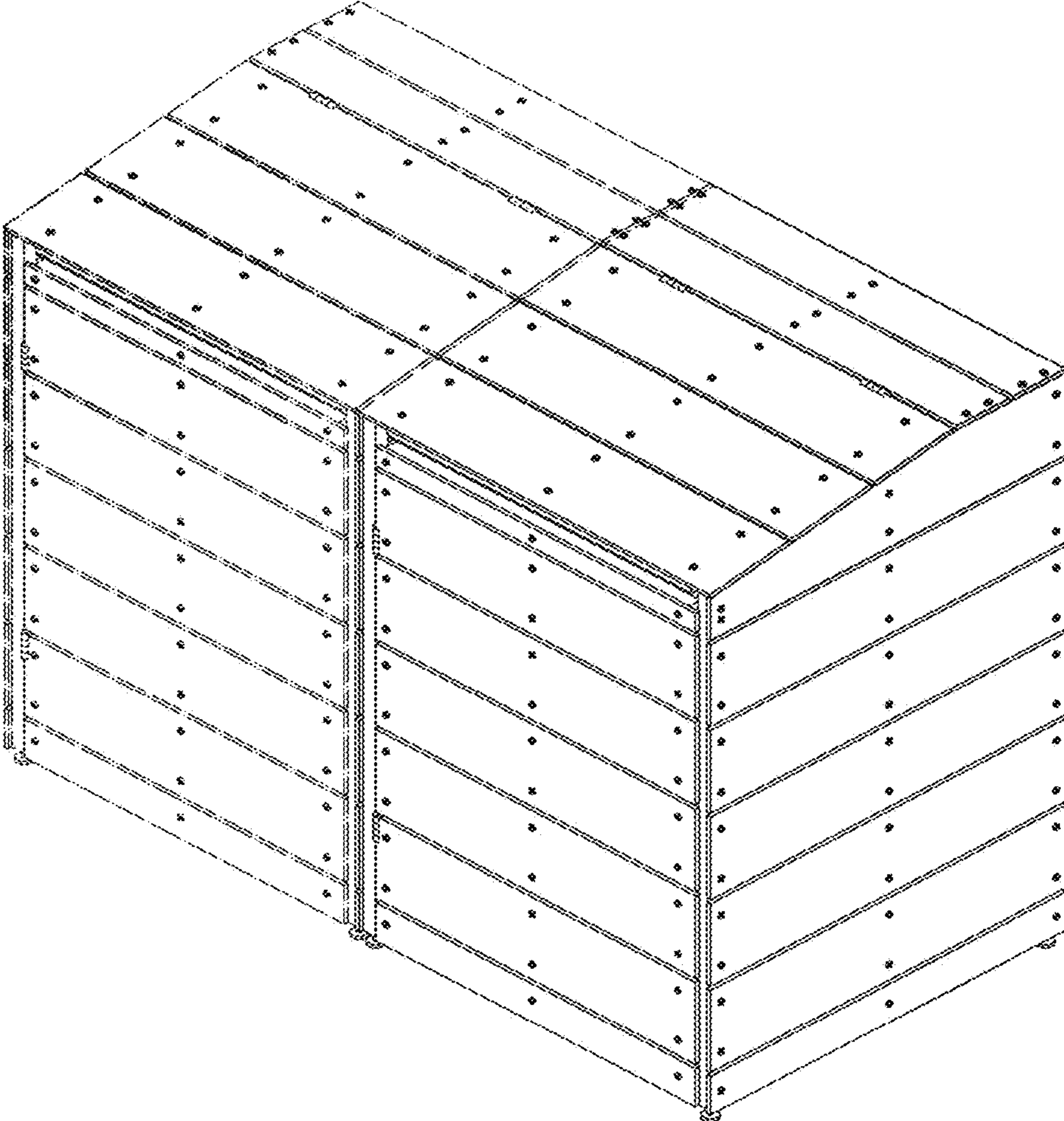

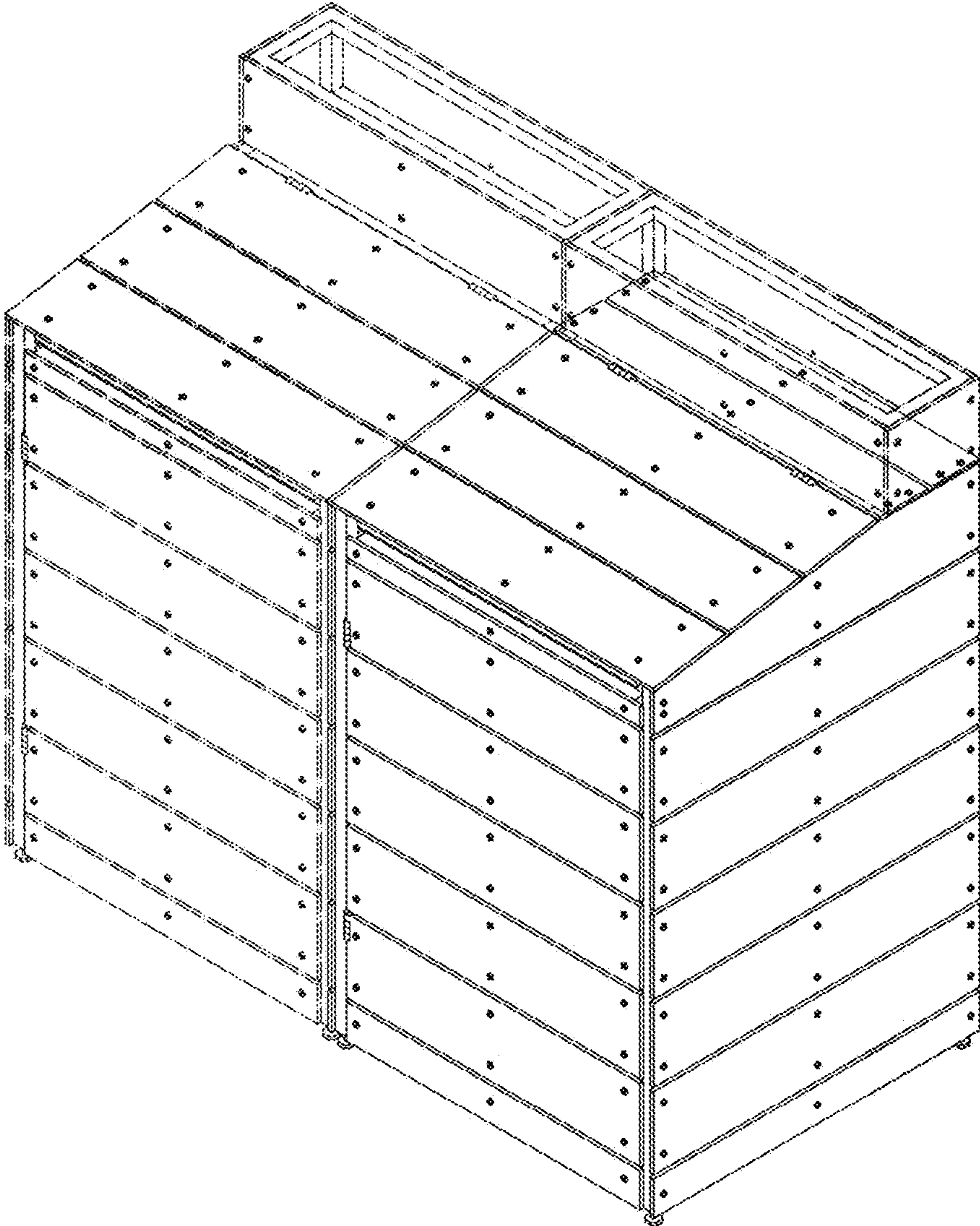

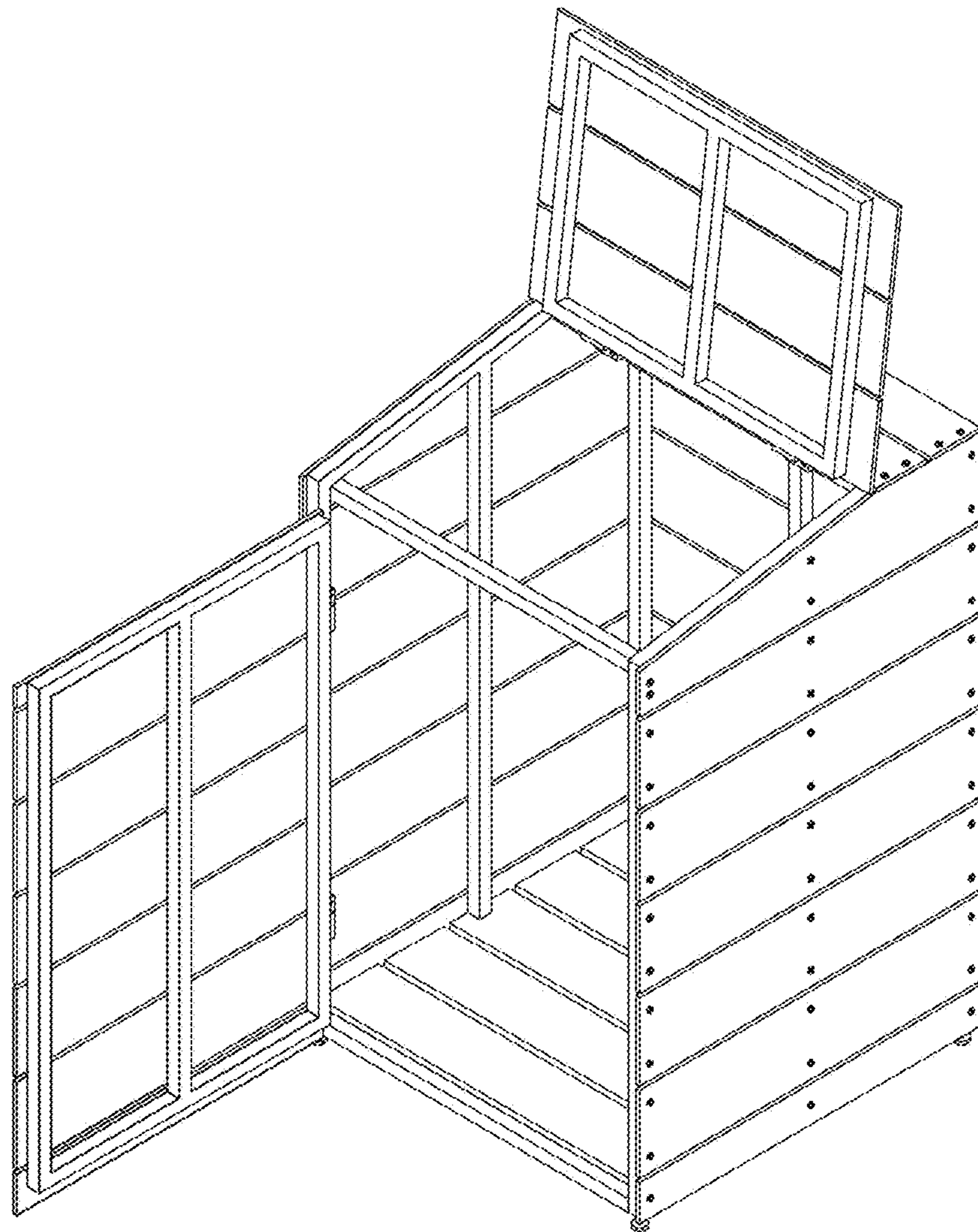

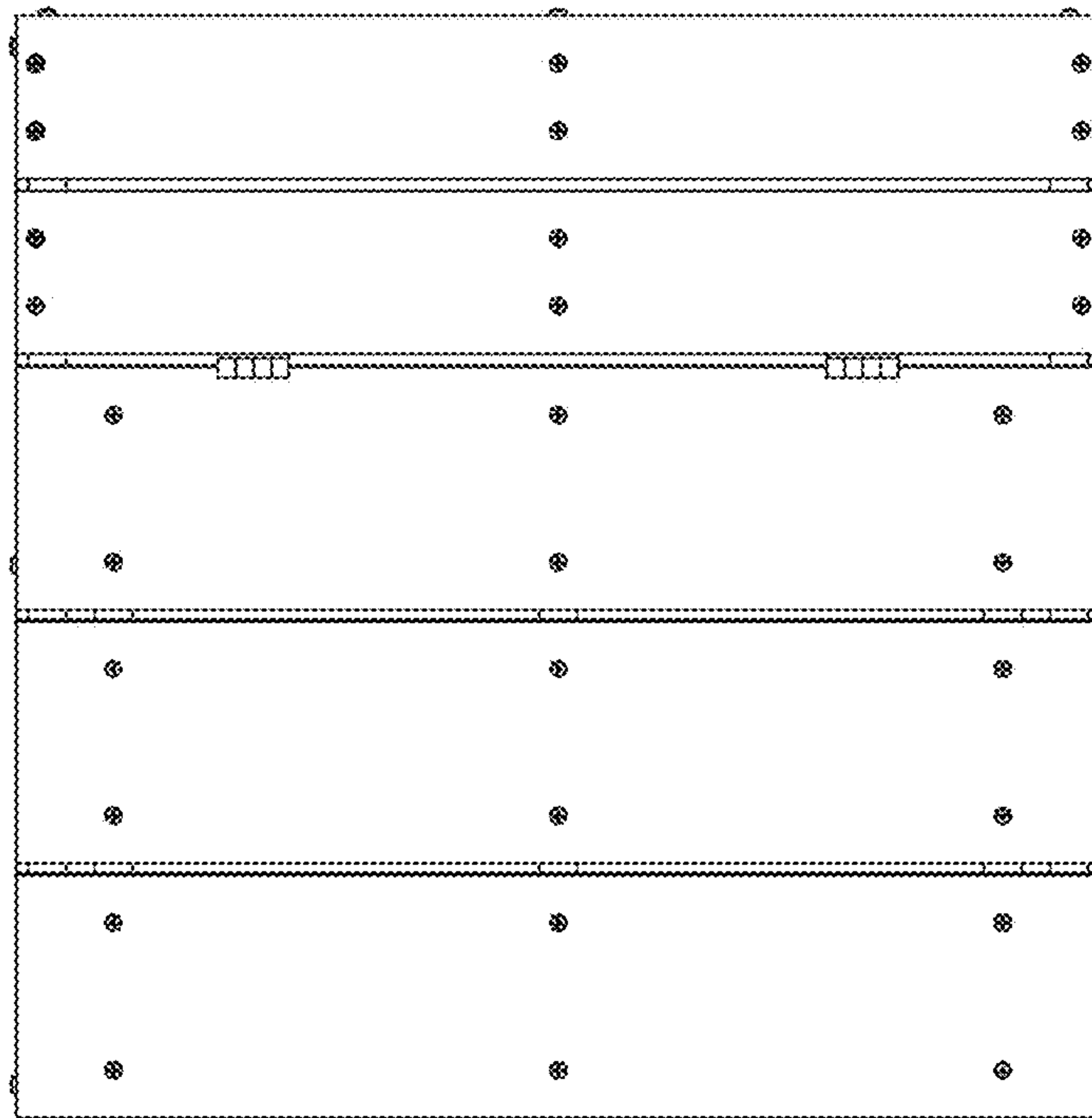

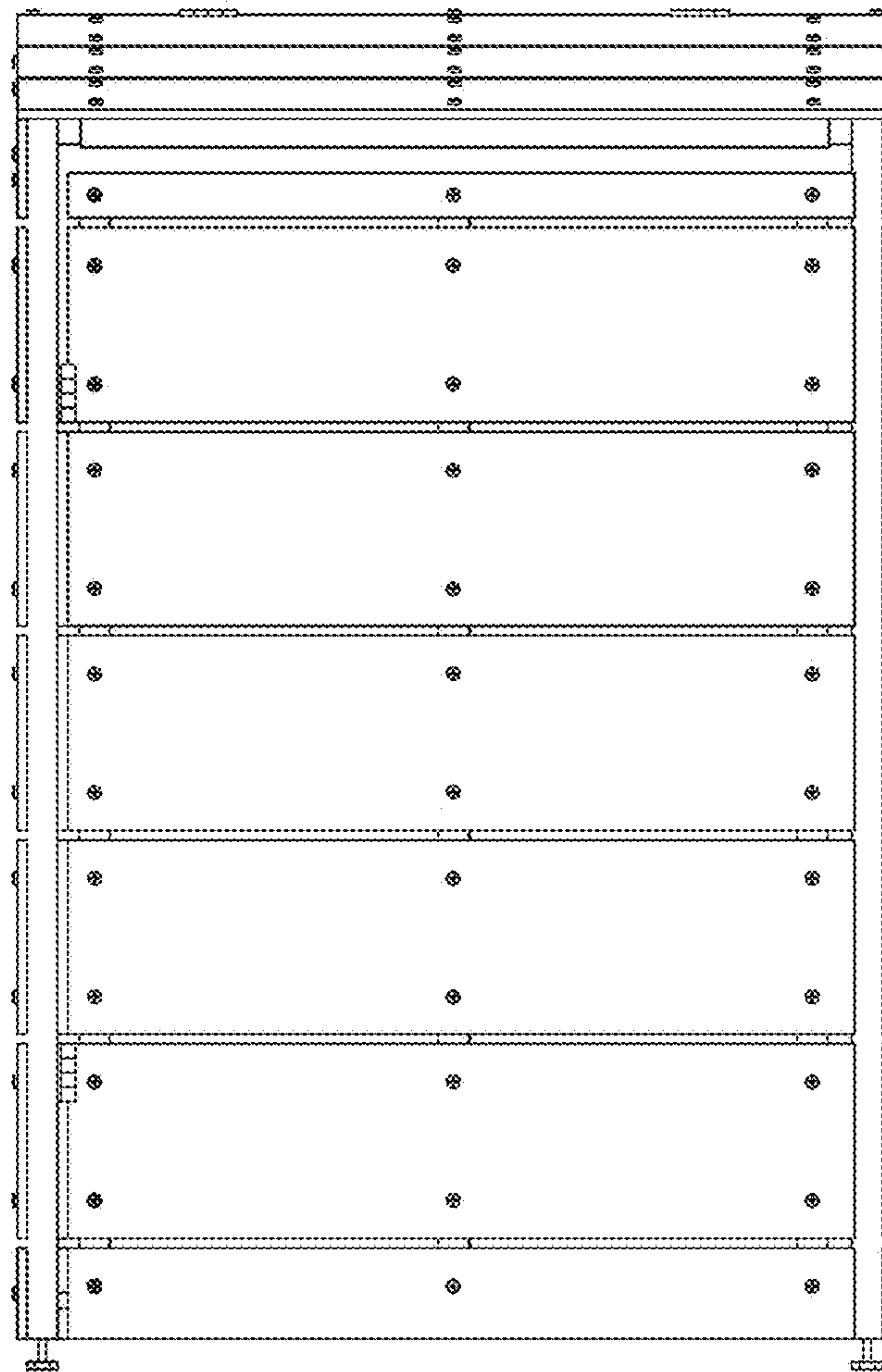

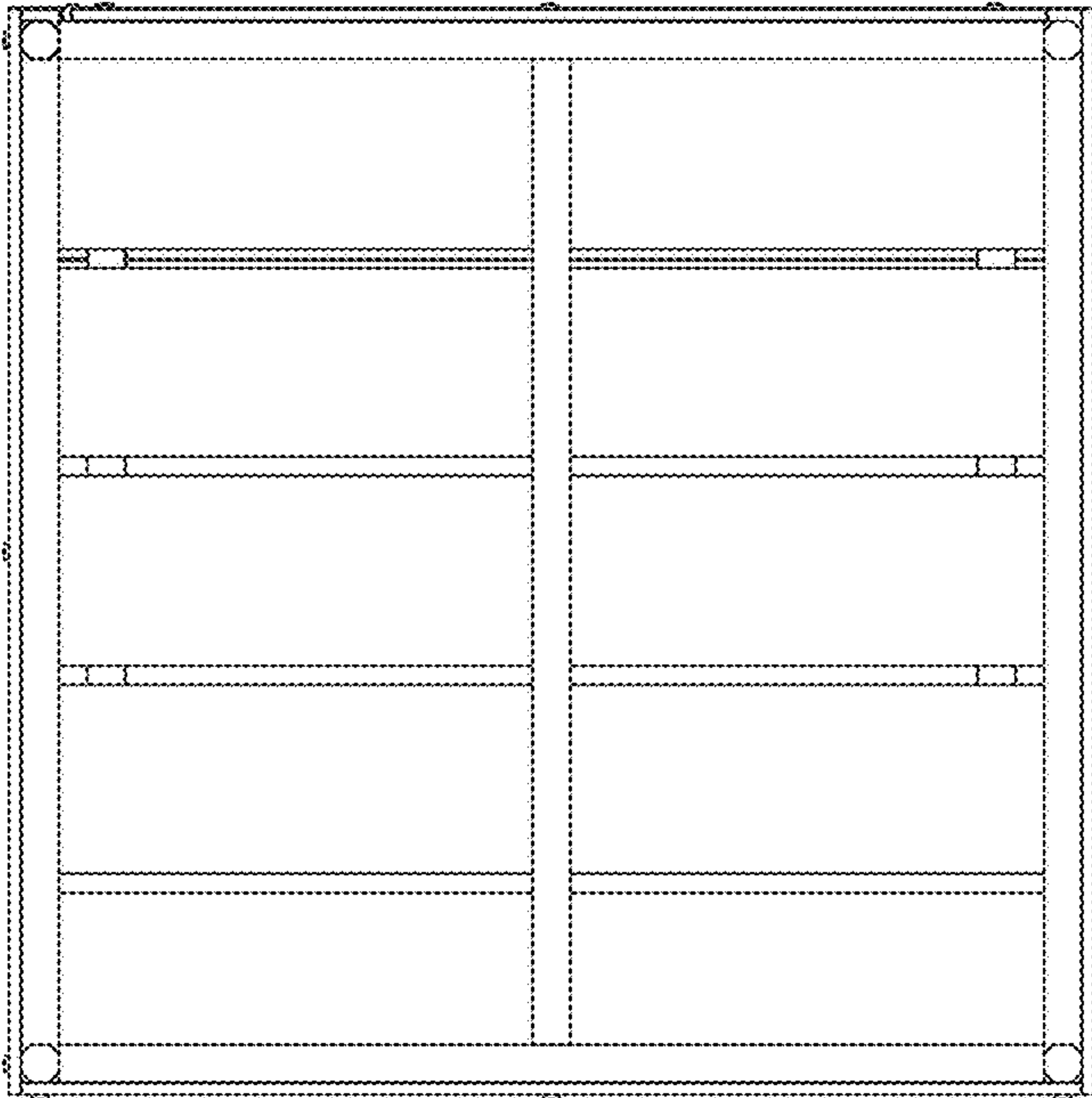

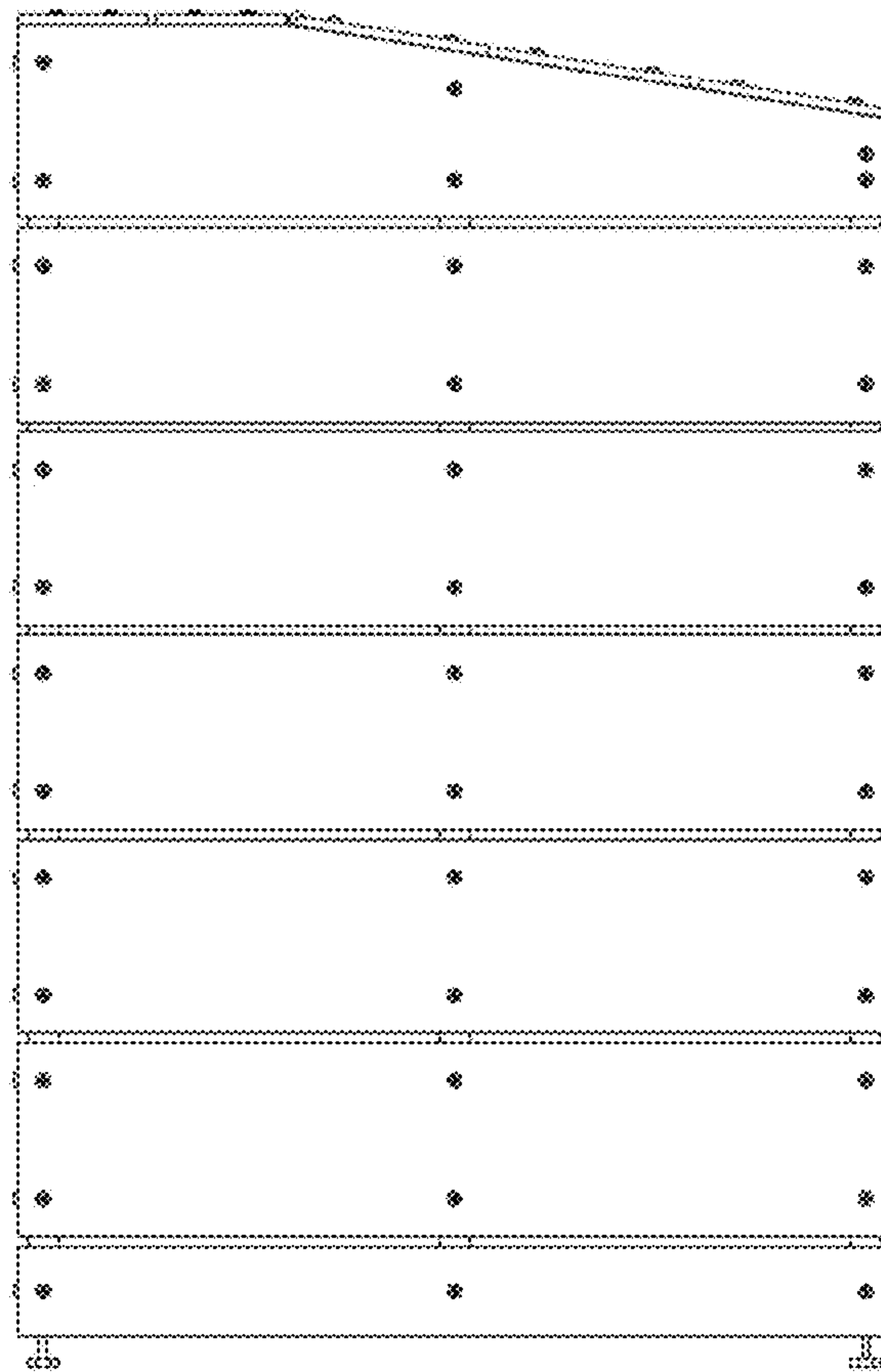

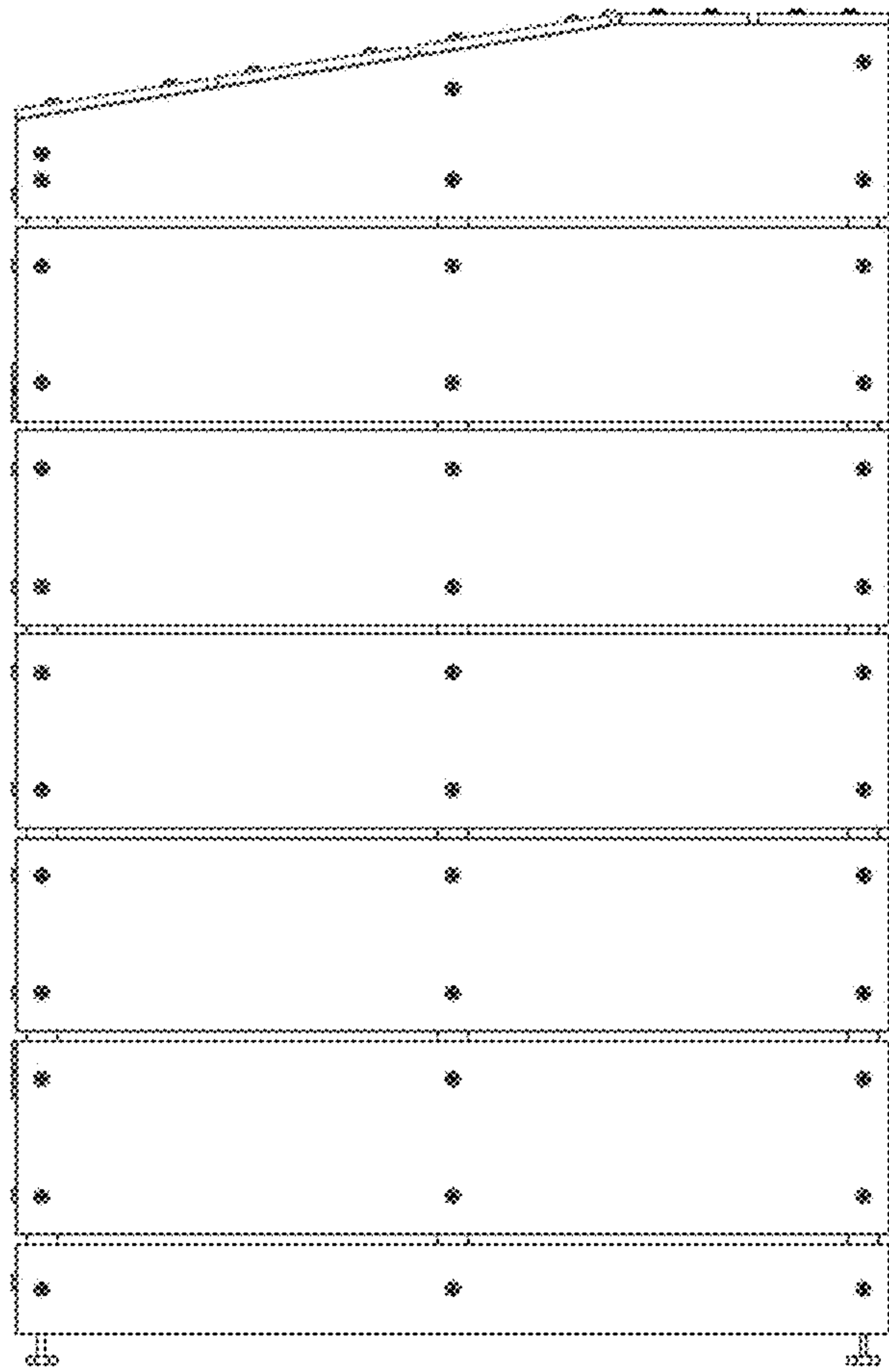

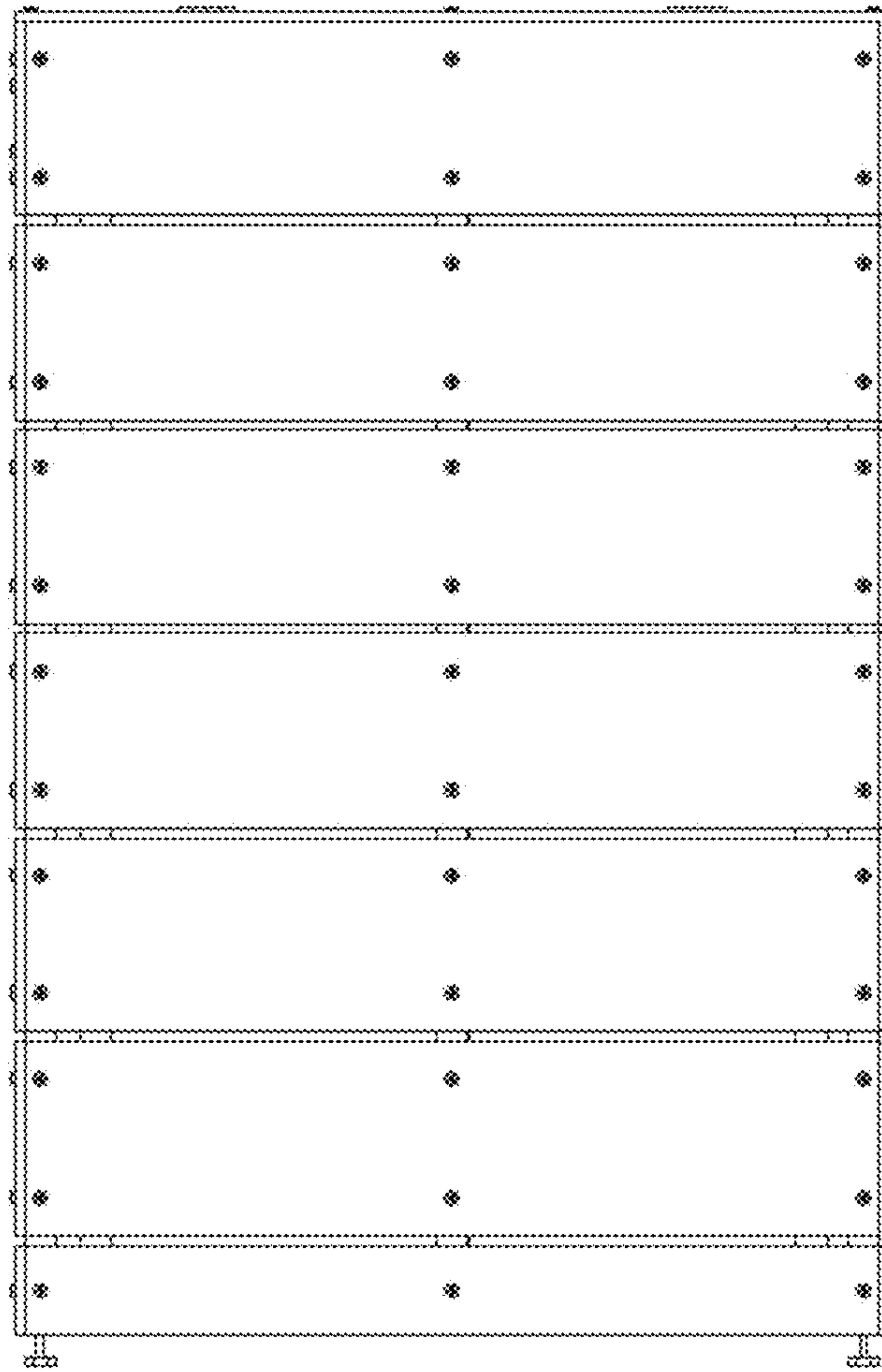
