DESCRIPTION

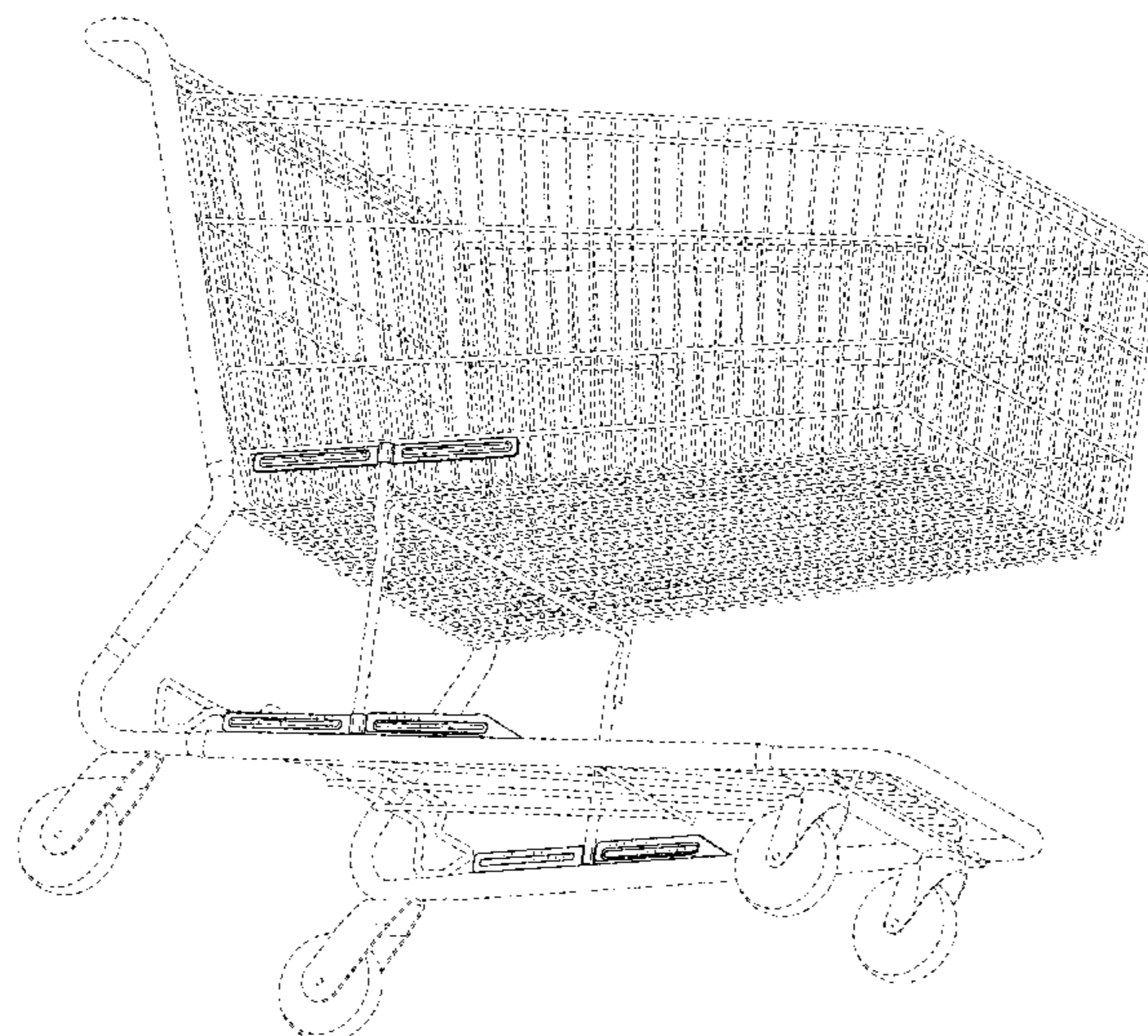
FIG. 1 is a bottom, front, right perspective view of a first embodiment of a cart showing my new design;

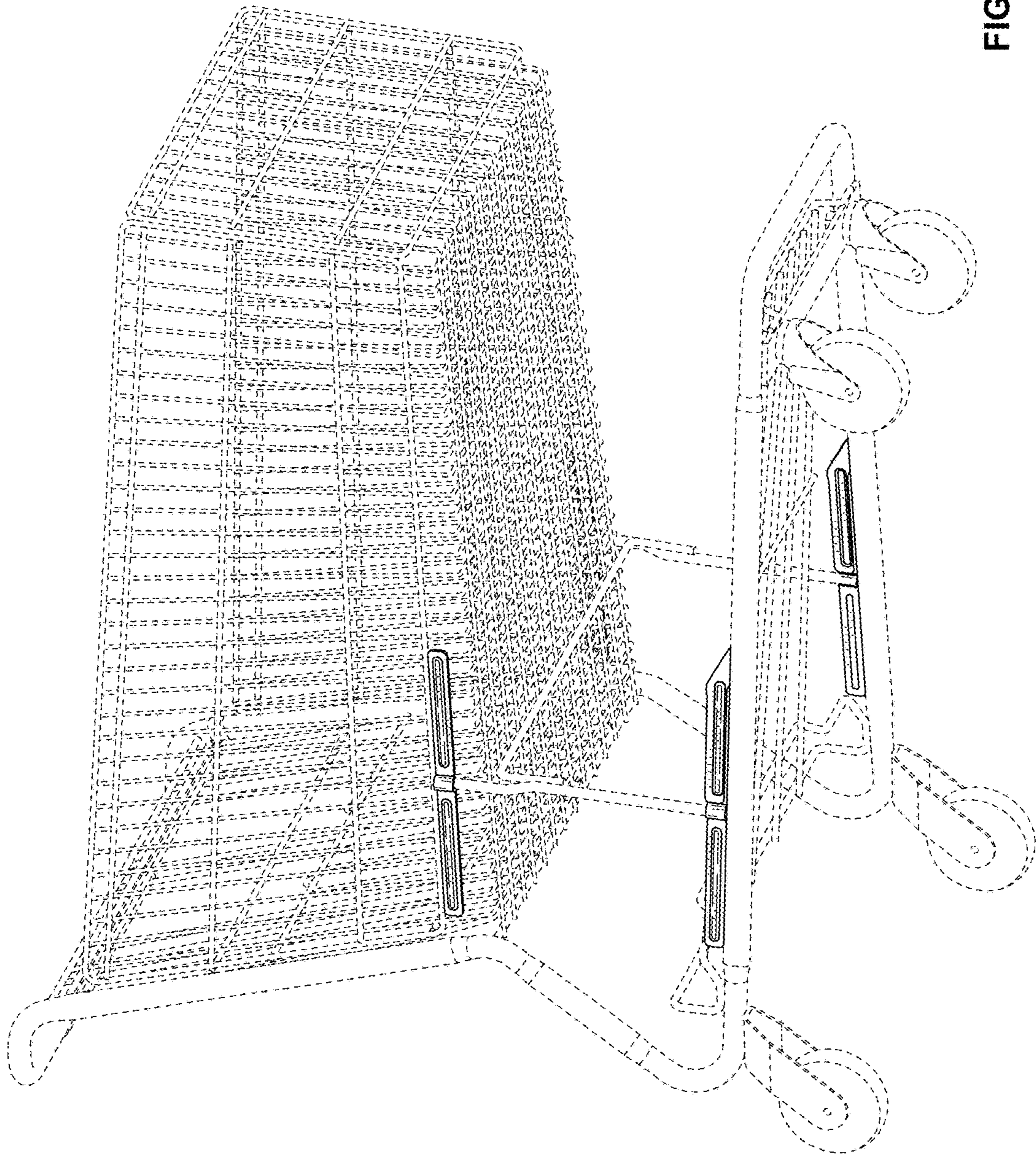

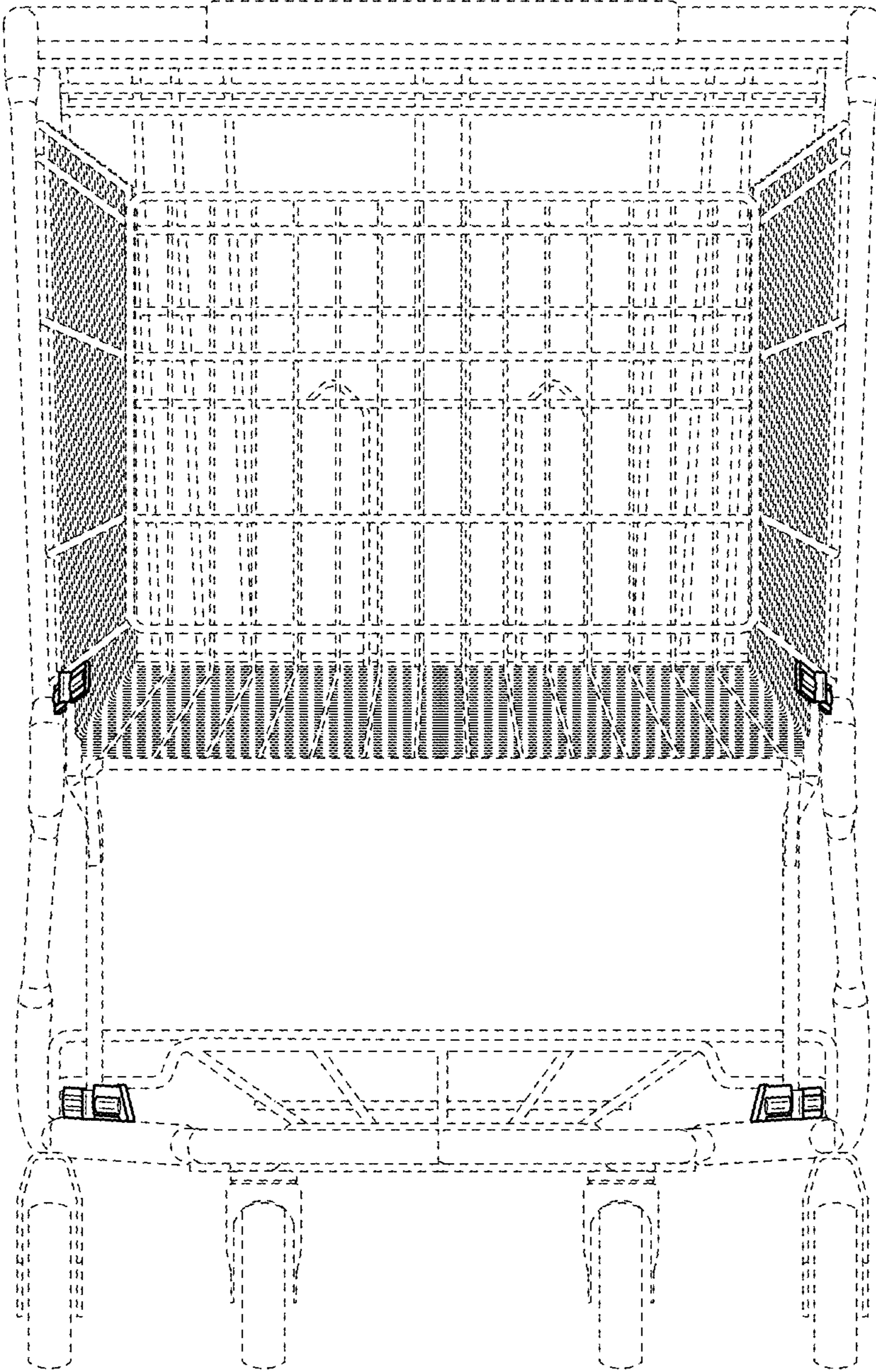

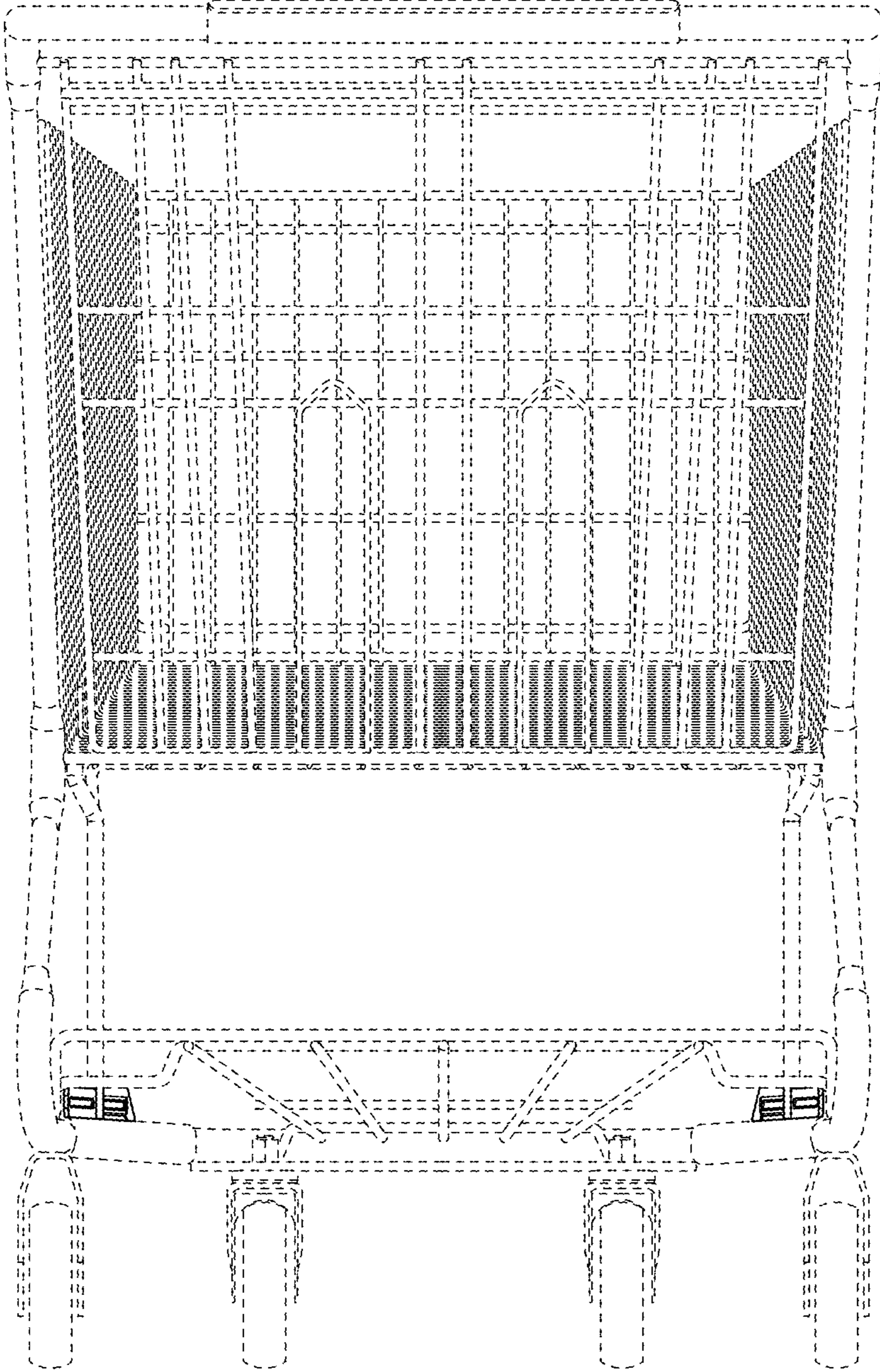

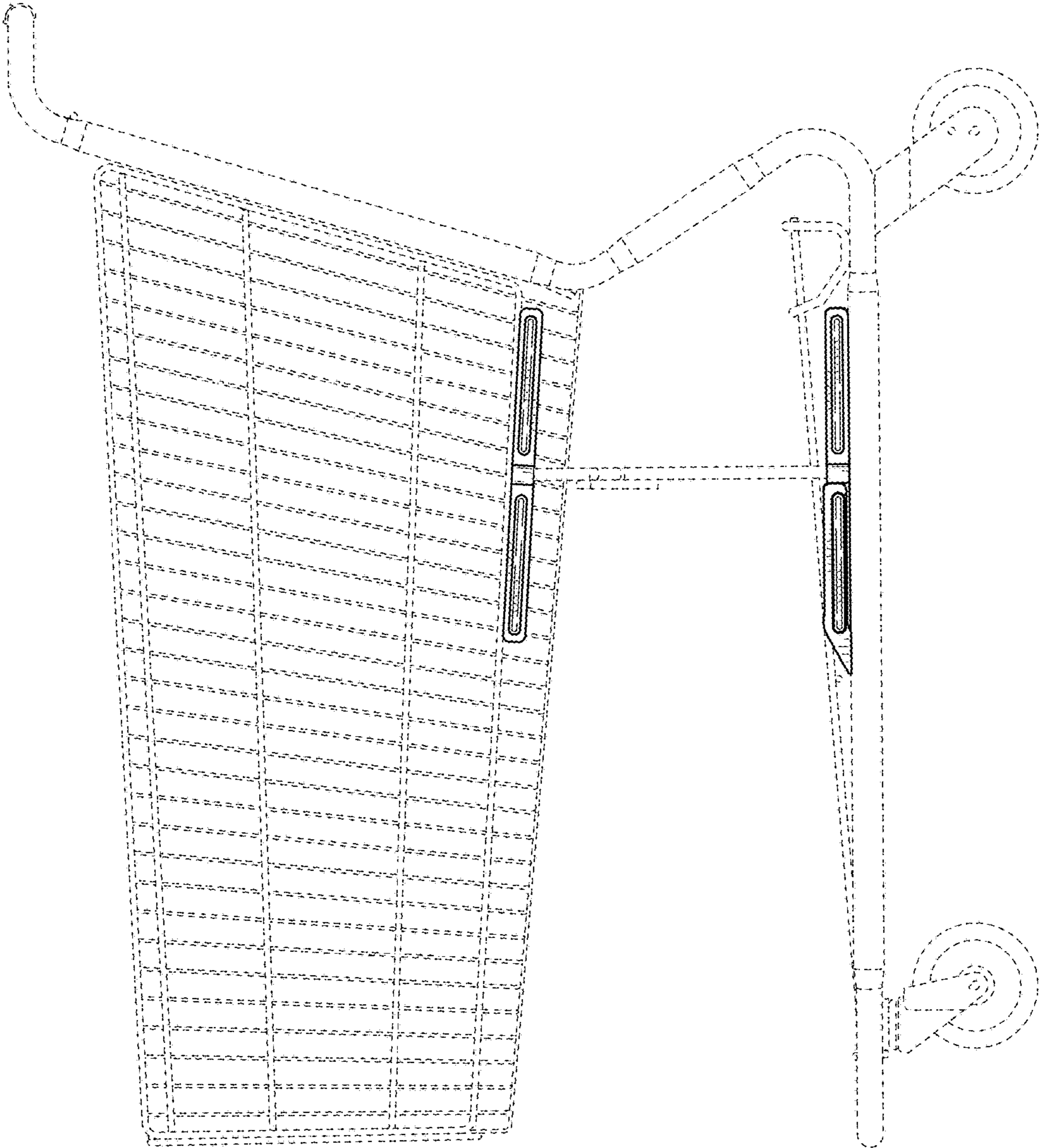

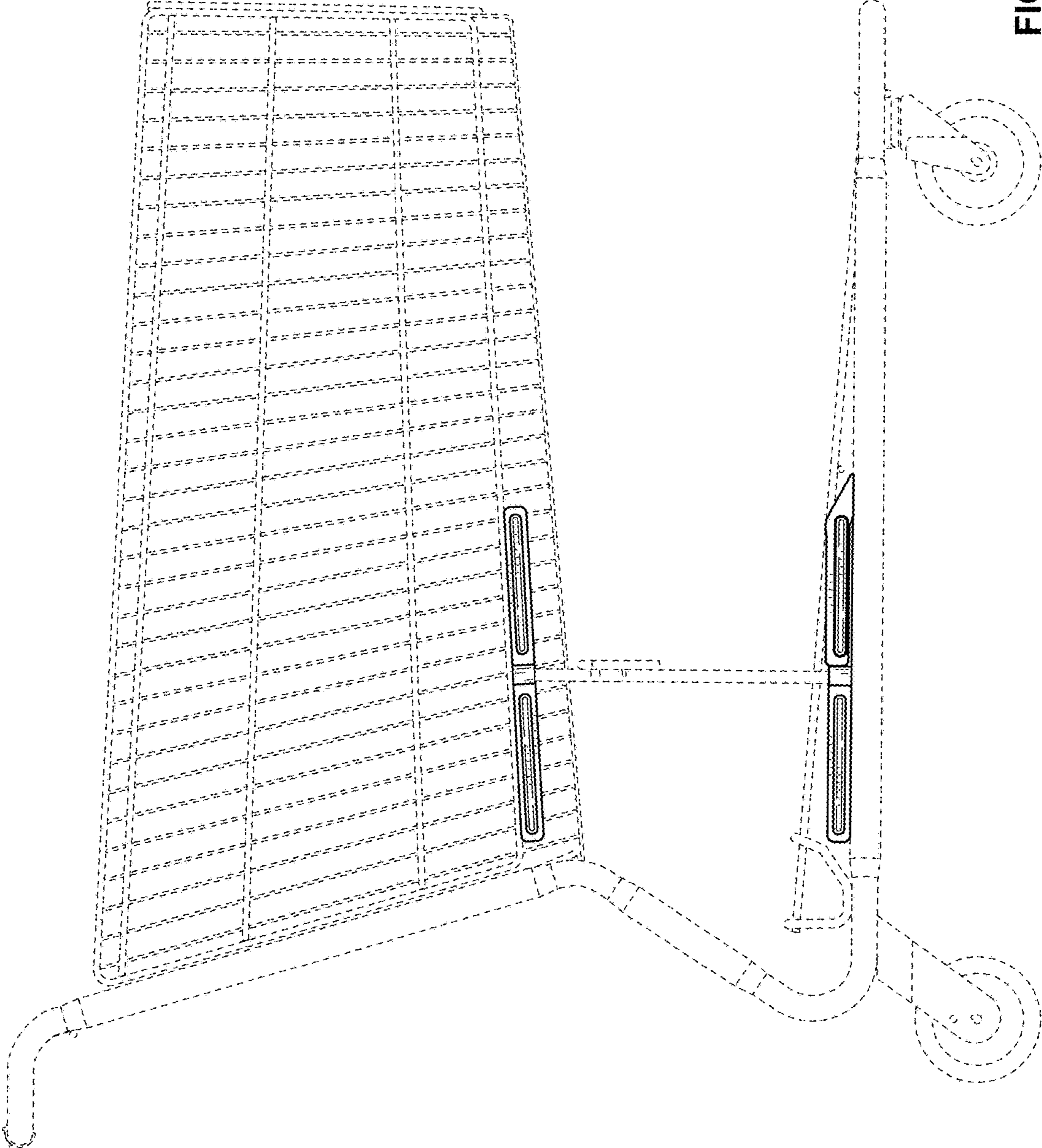

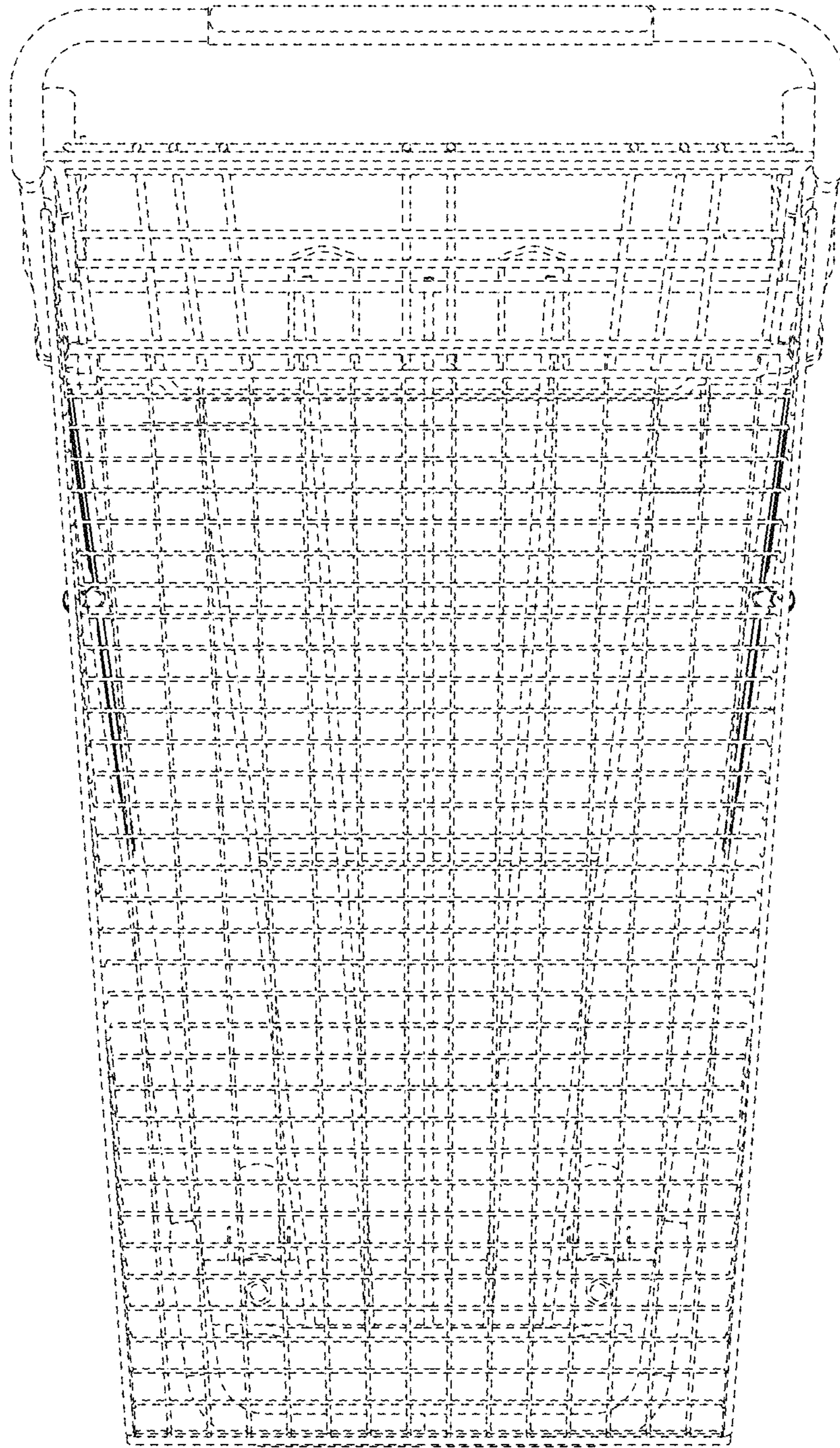

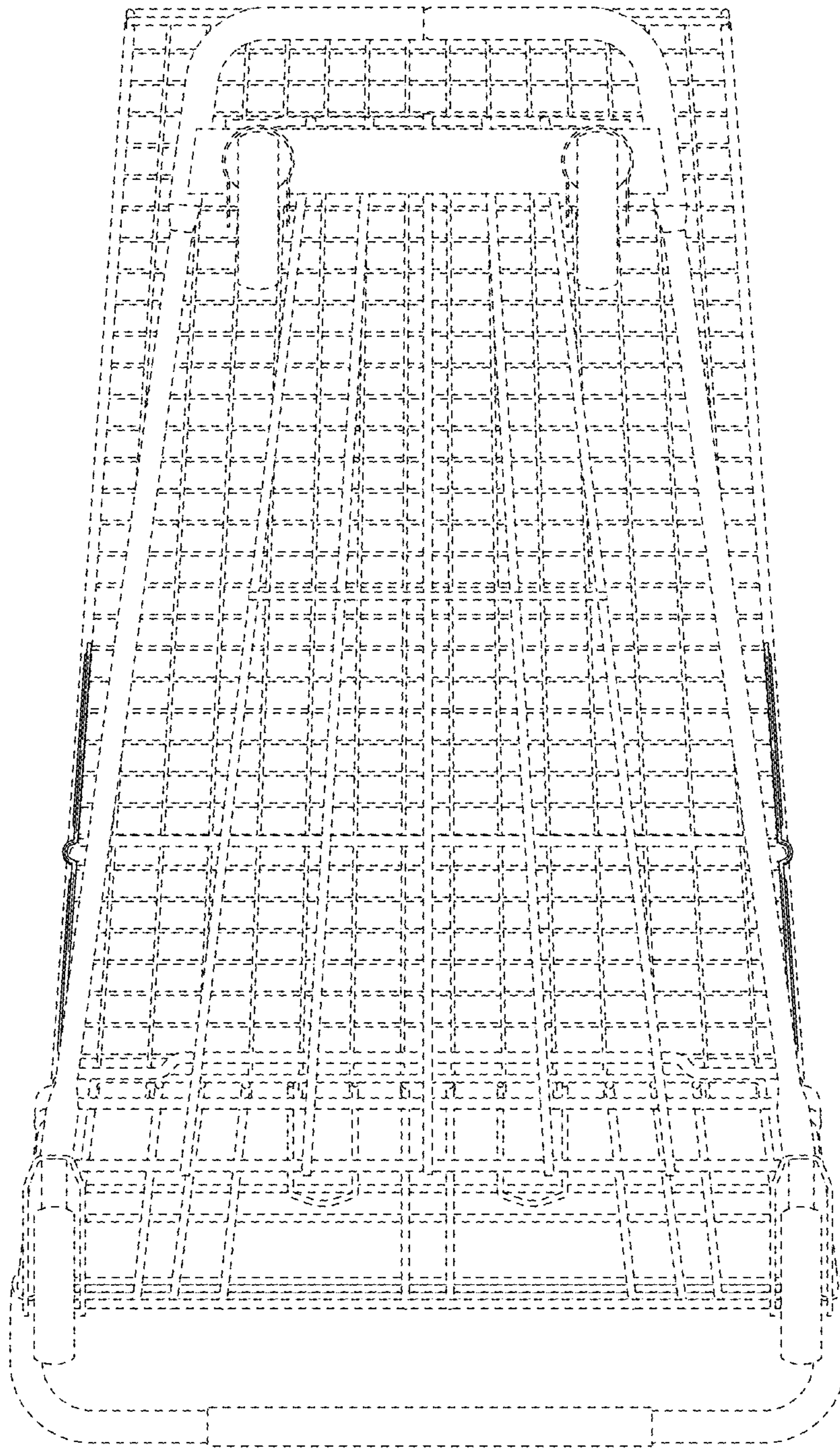
