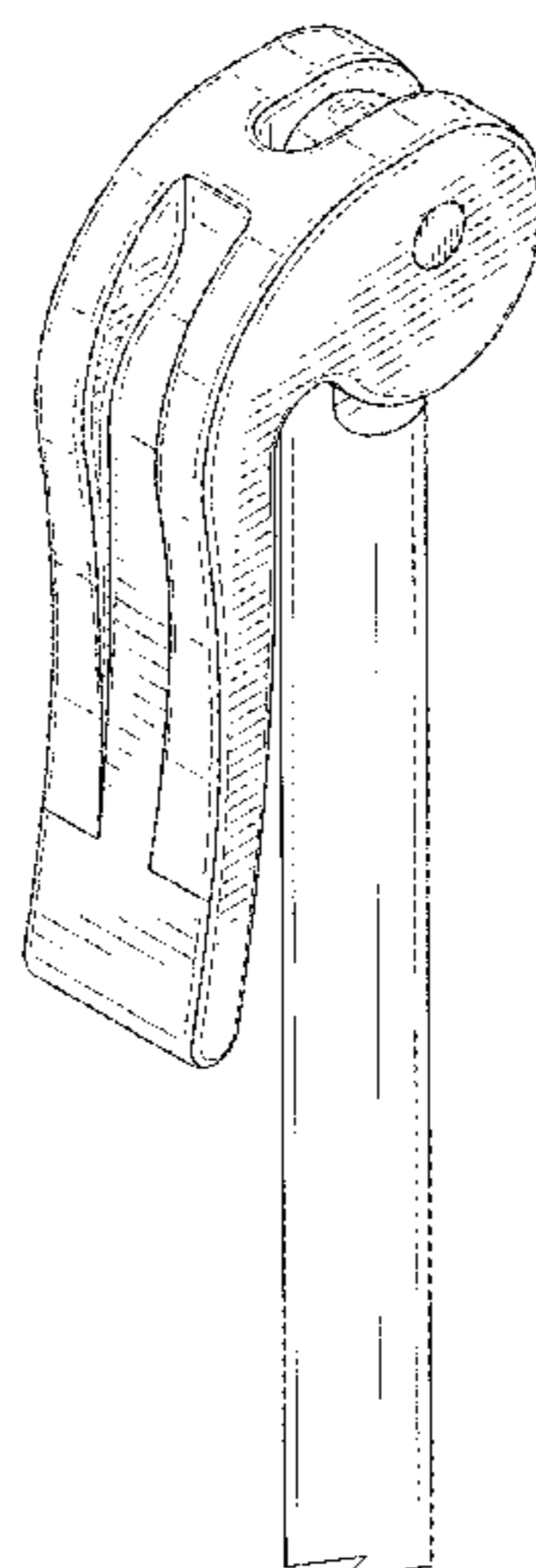
(57) **CLAIM**

DESCRIPTION

FIG. 1 shows a right side perspective view of the dish caddy adjusting lever.

FIG. 4 is a top plan view thereof.

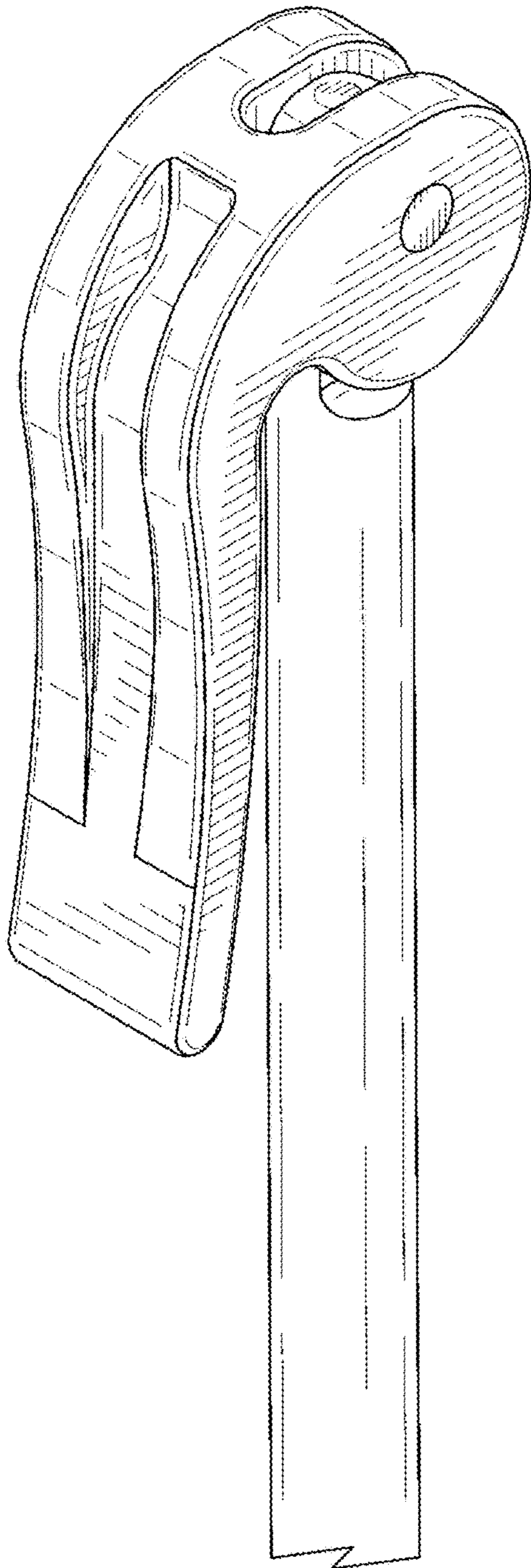
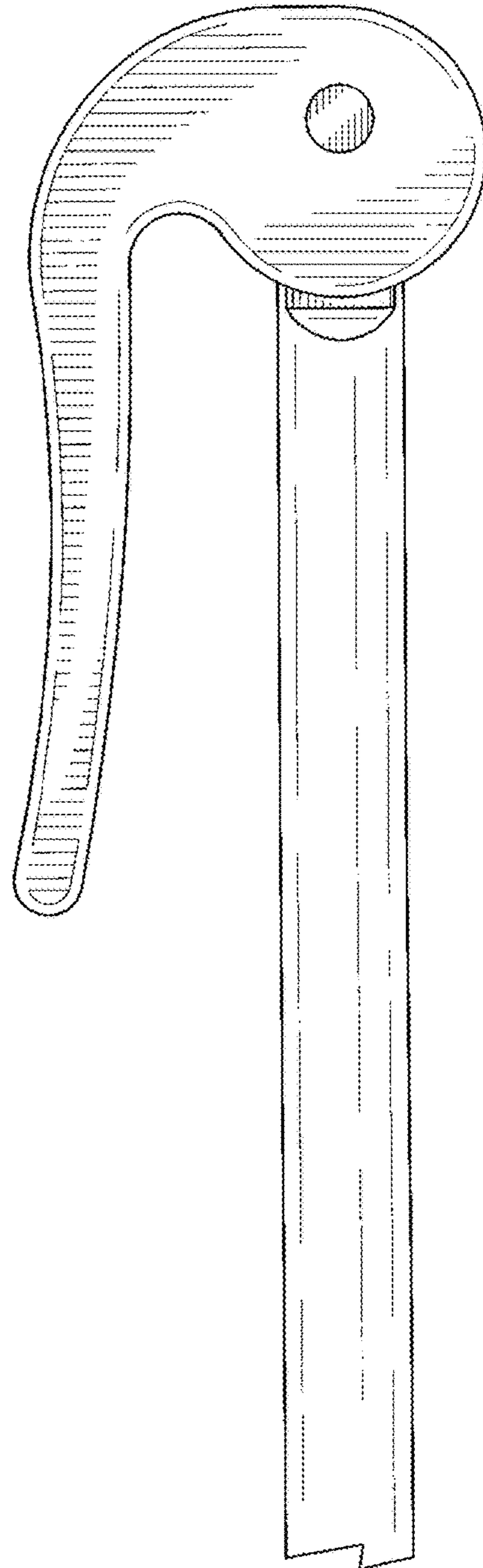

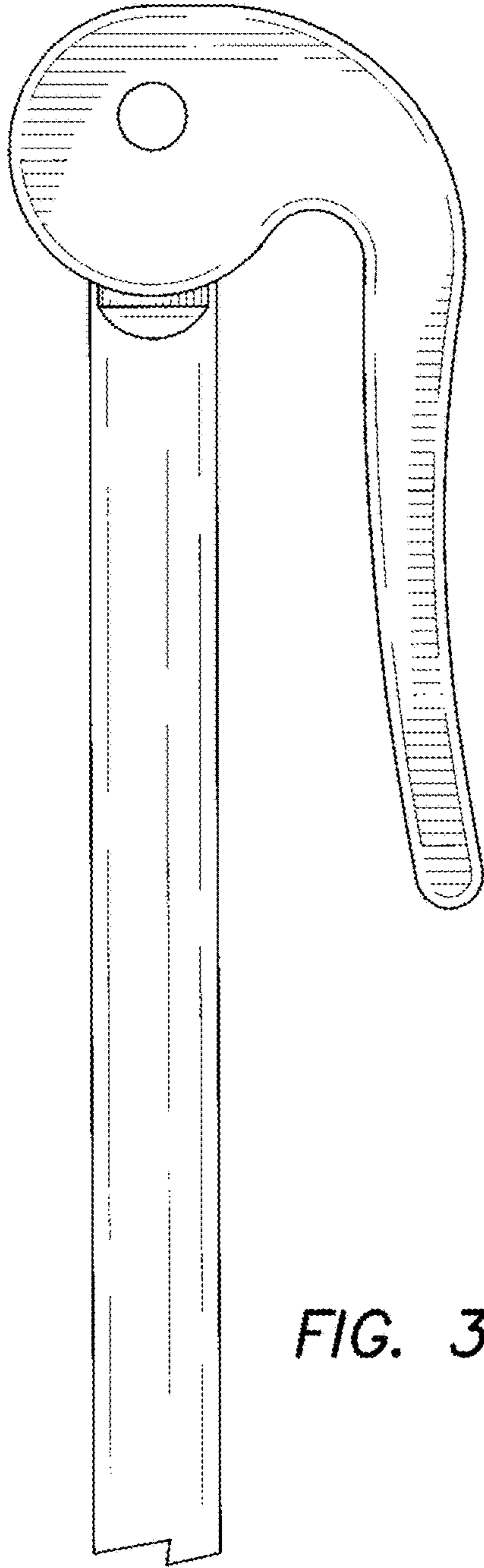

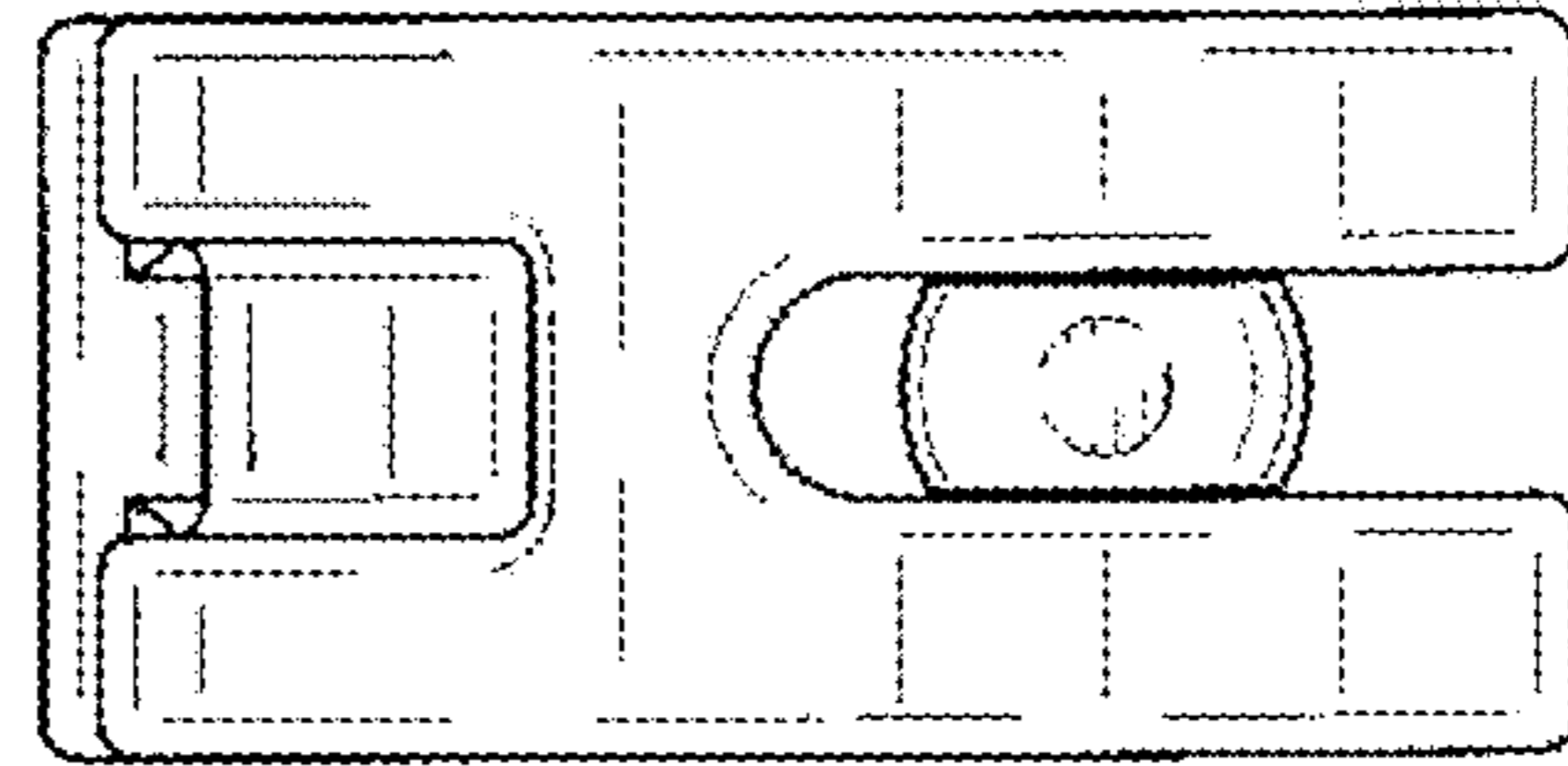

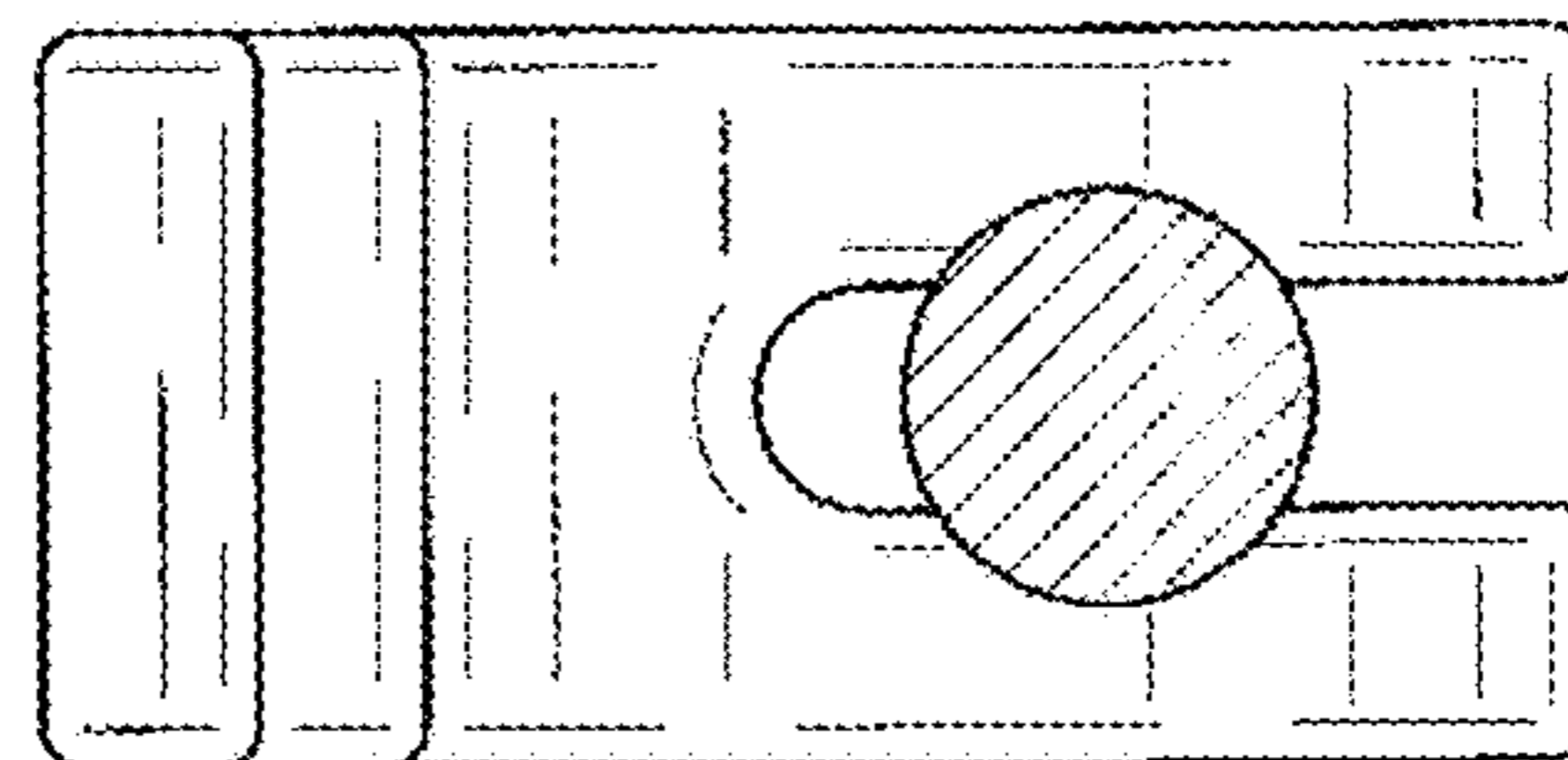

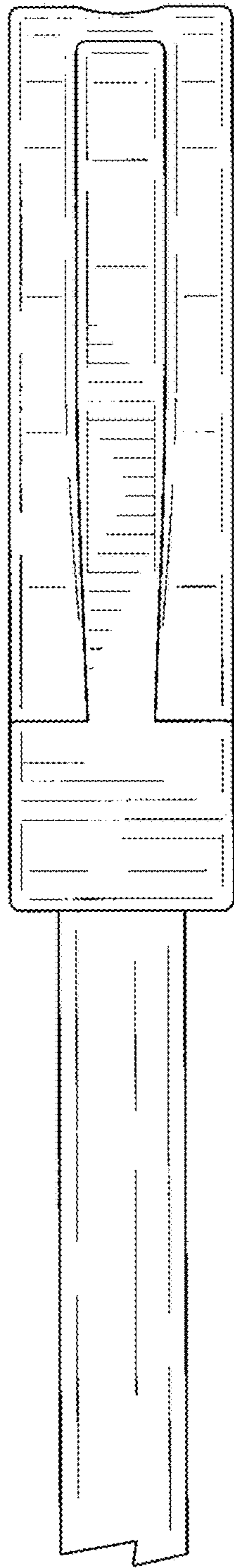

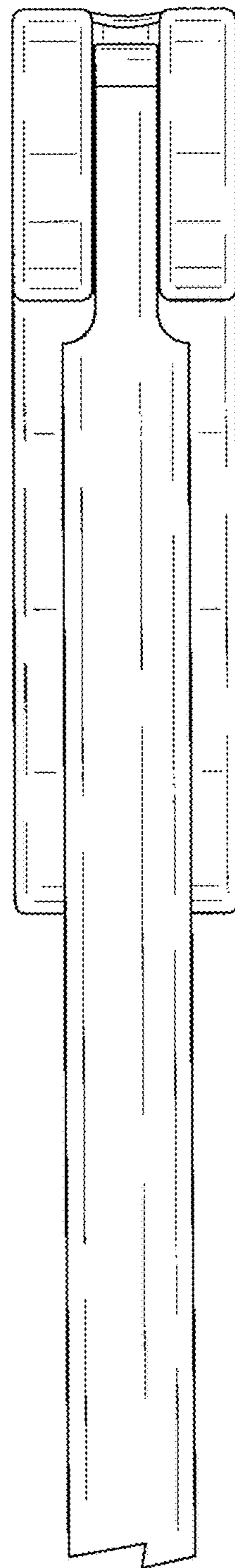

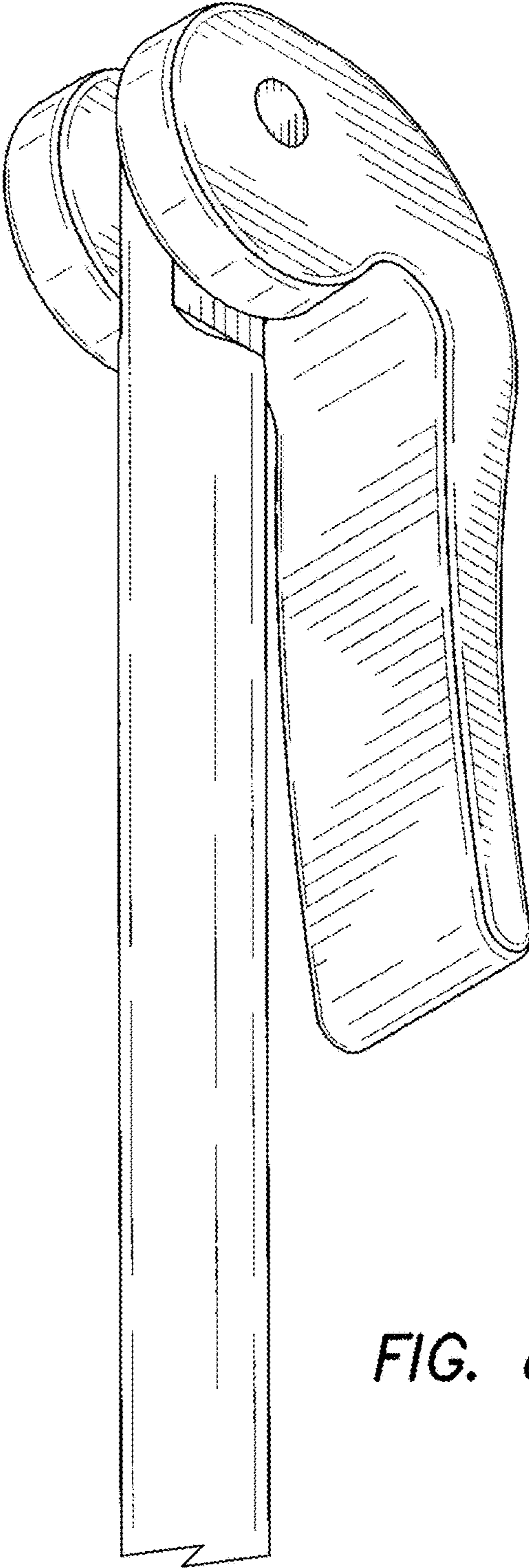
