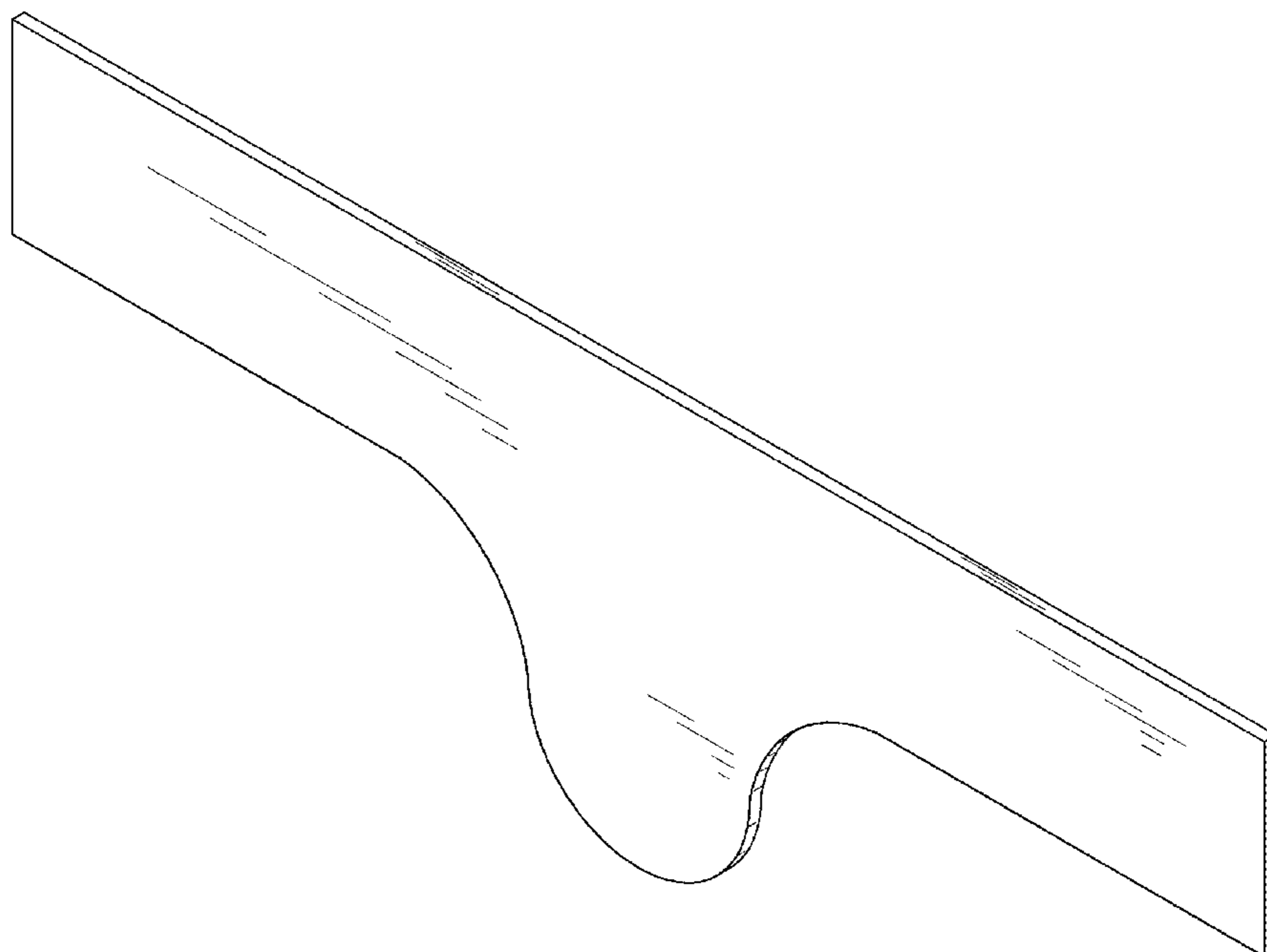
(57) **CLAIM**

The ornamental design for a clerical tab collar, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a clerical tab collar showing my new design, a rear view being identical;
FIG. 2 is a left side view of the clerical tab collar, a right side view being identical;
FIG. 3 is a top view of the clerical tab collar;
FIG. 4 is a bottom view of the clerical tab collar; and,
FIG. 5 is a front top side perspective view of the clerical tab collar.

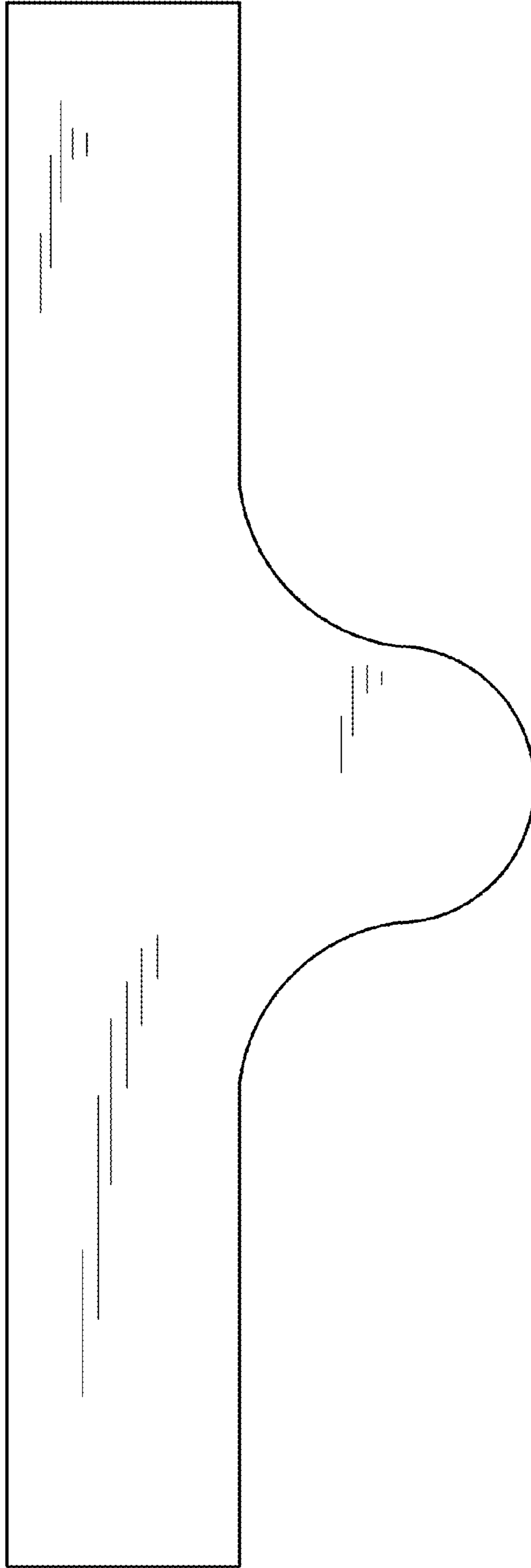

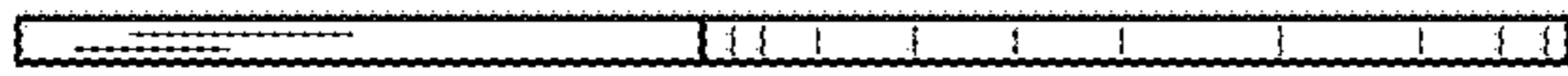

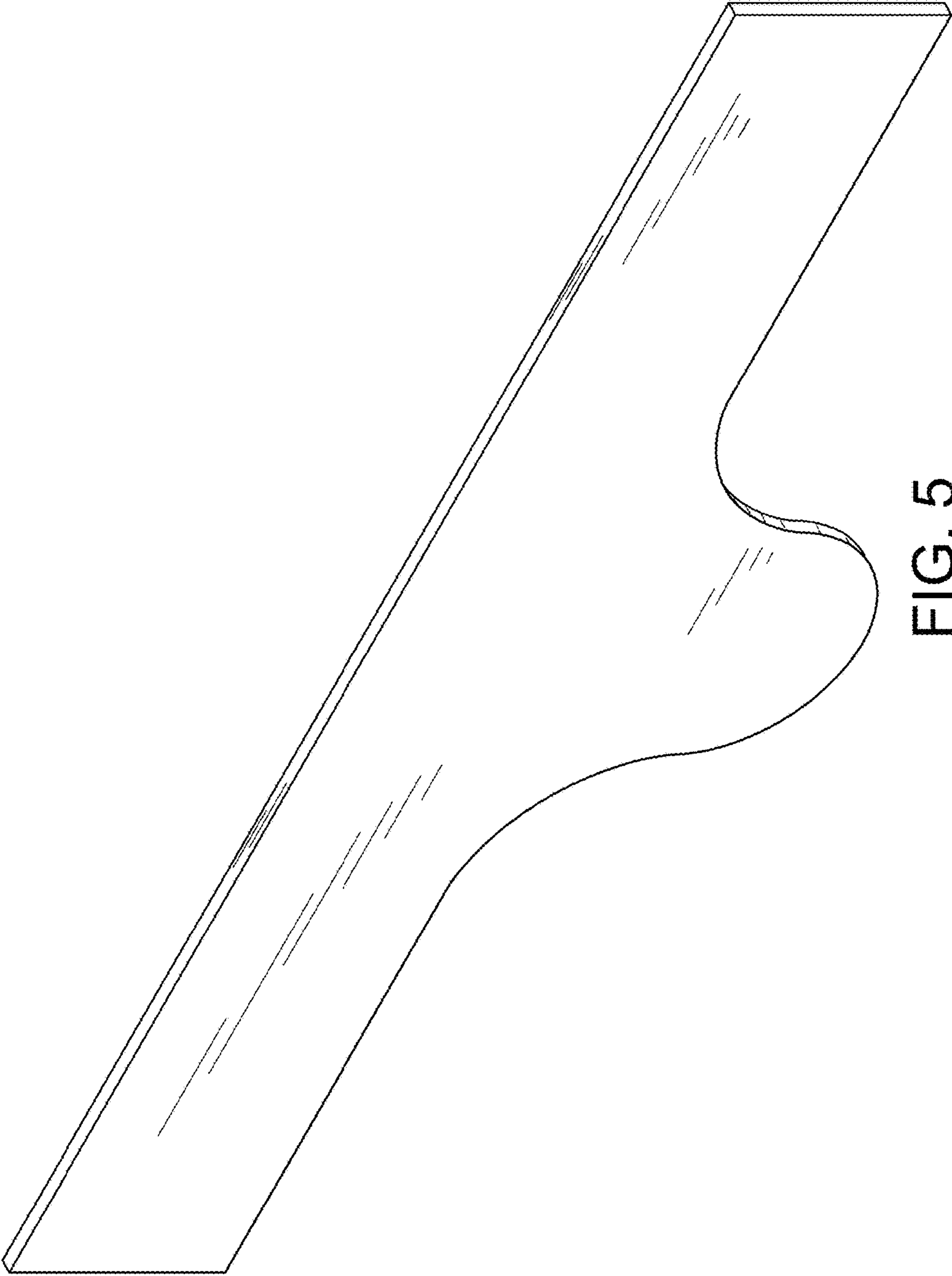
