DESCRIPTION

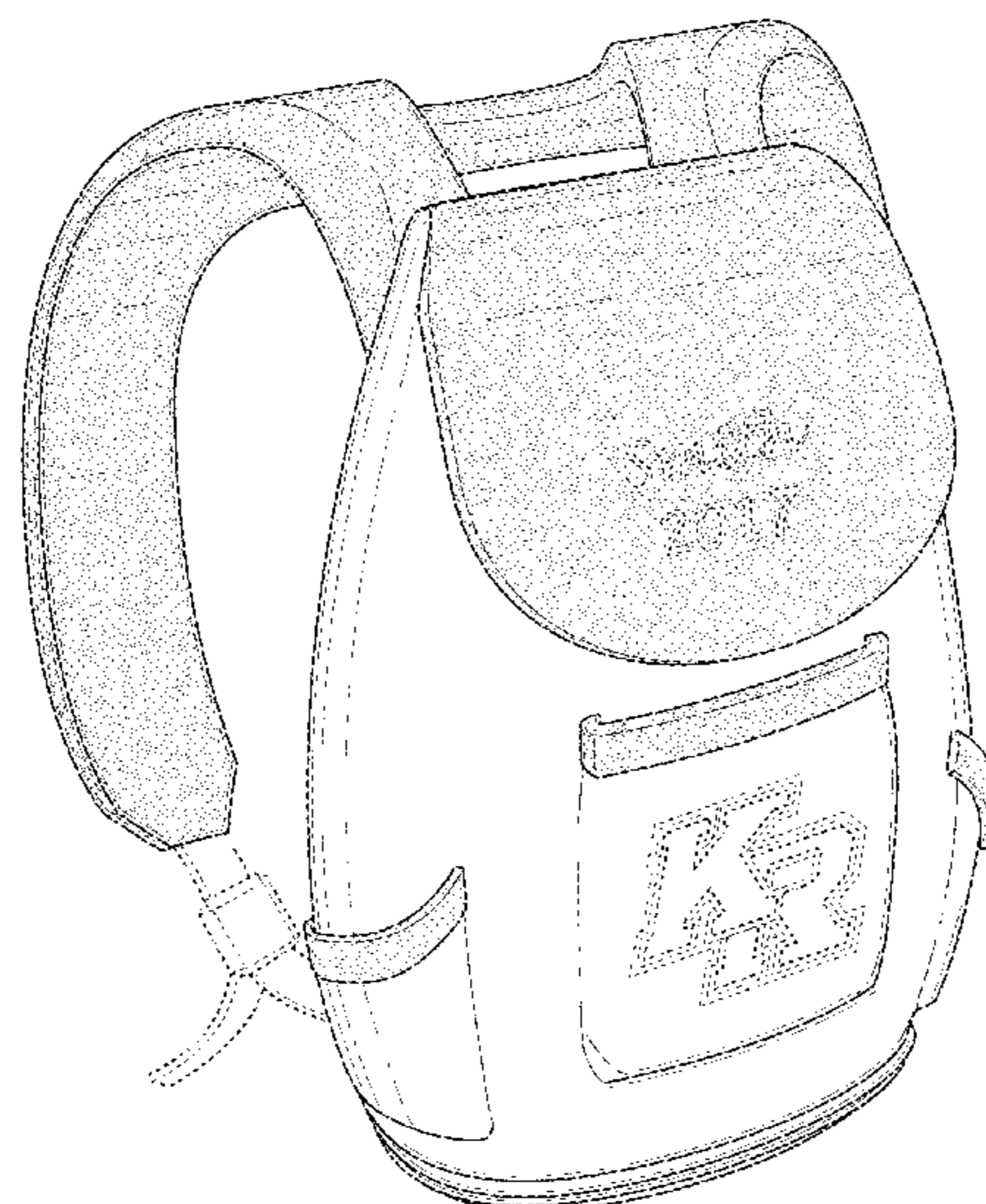
FIG. 1 is a frontal perspective view of a backpack showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear perspective view thereof;
FIG. 4 is a right side view (in relation to the front elevational view) thereof;

FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

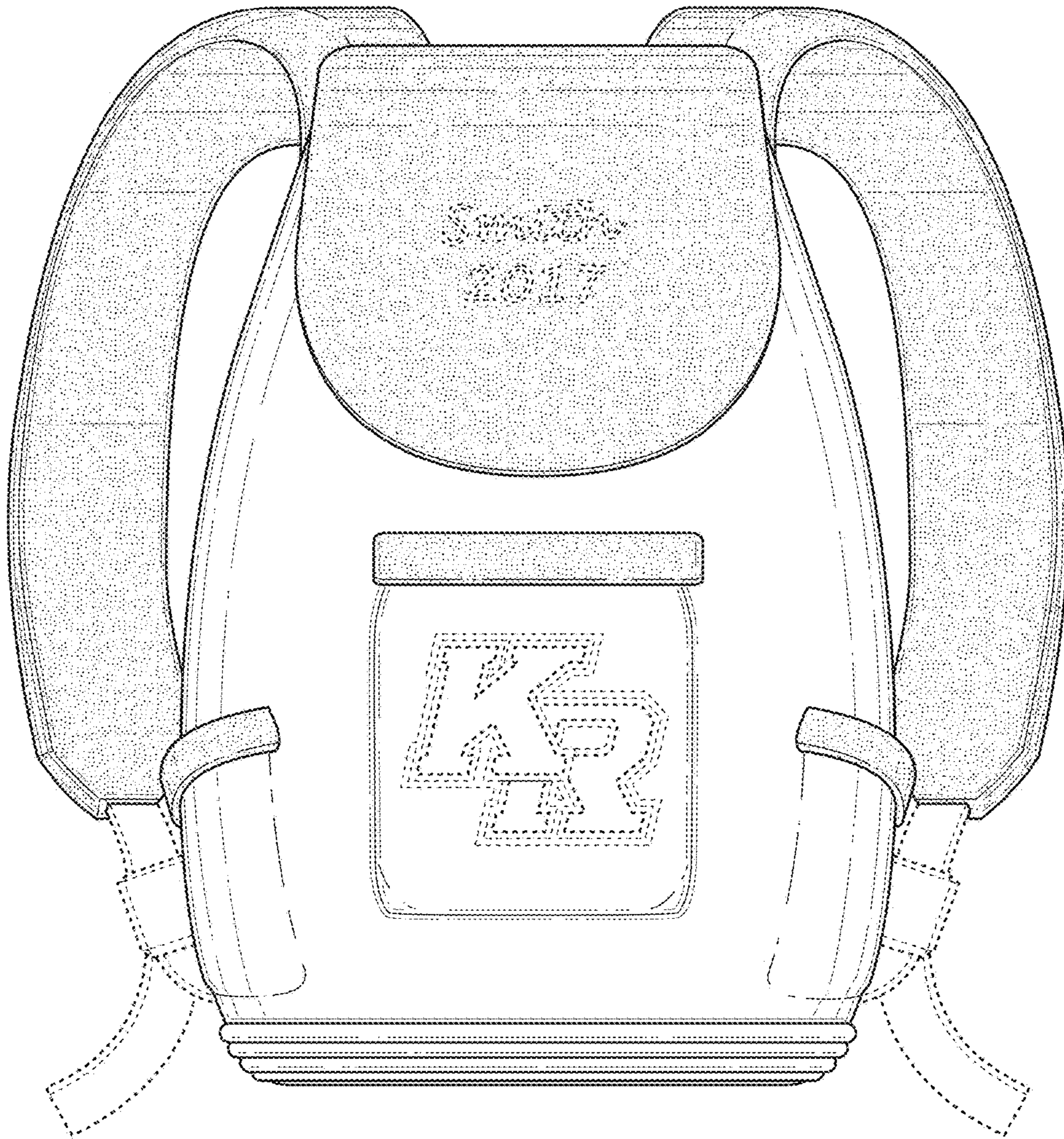

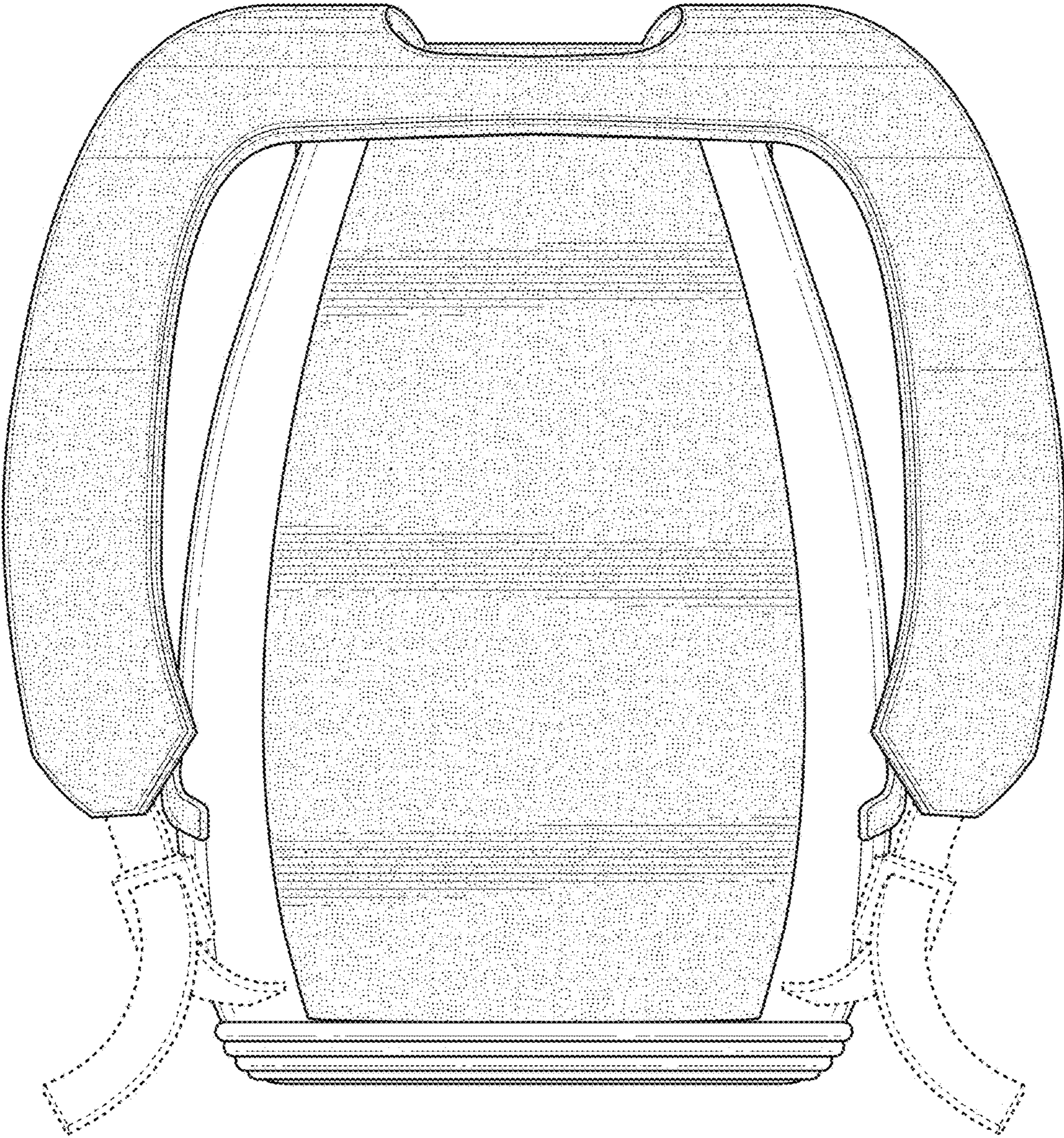

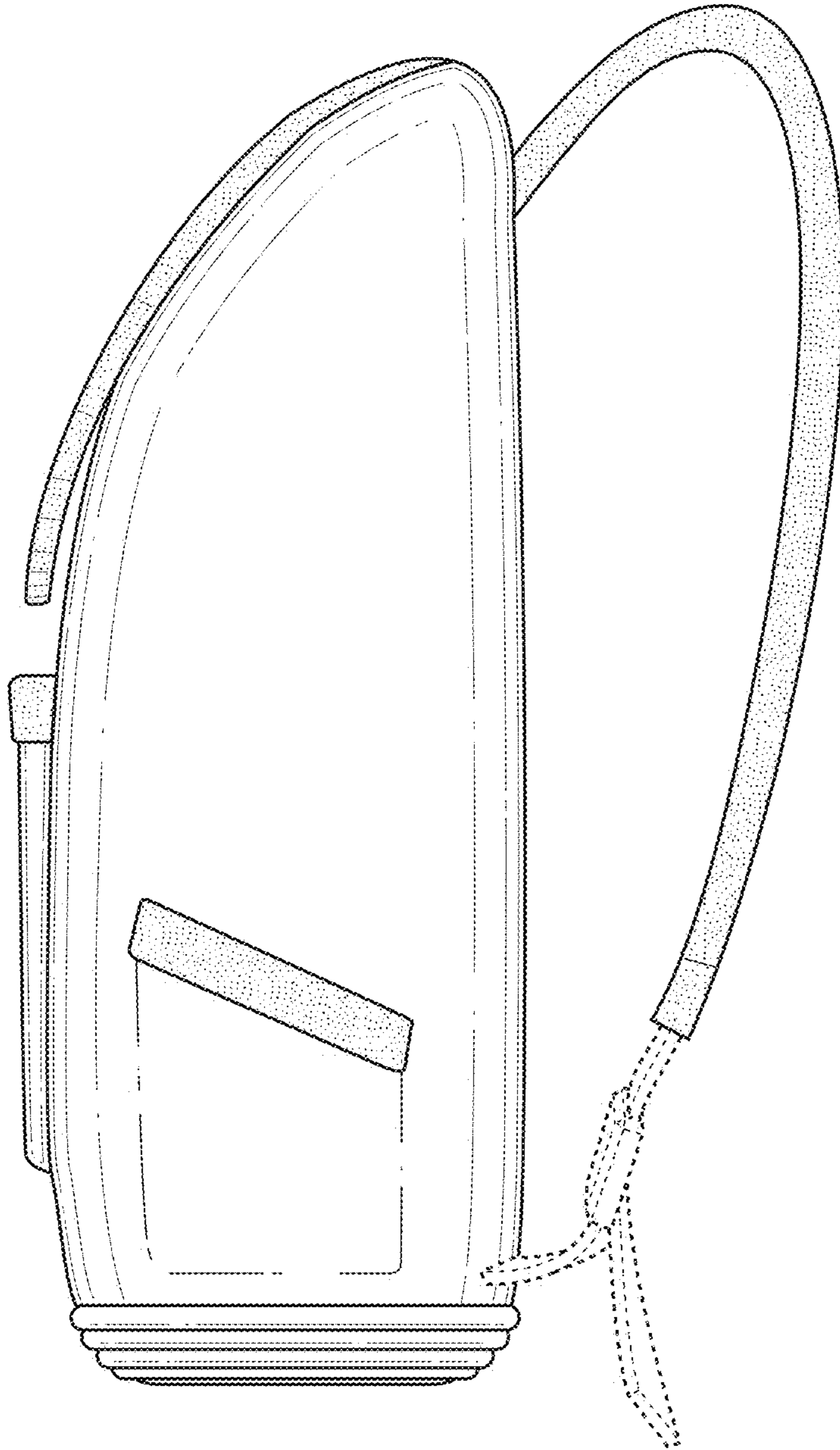

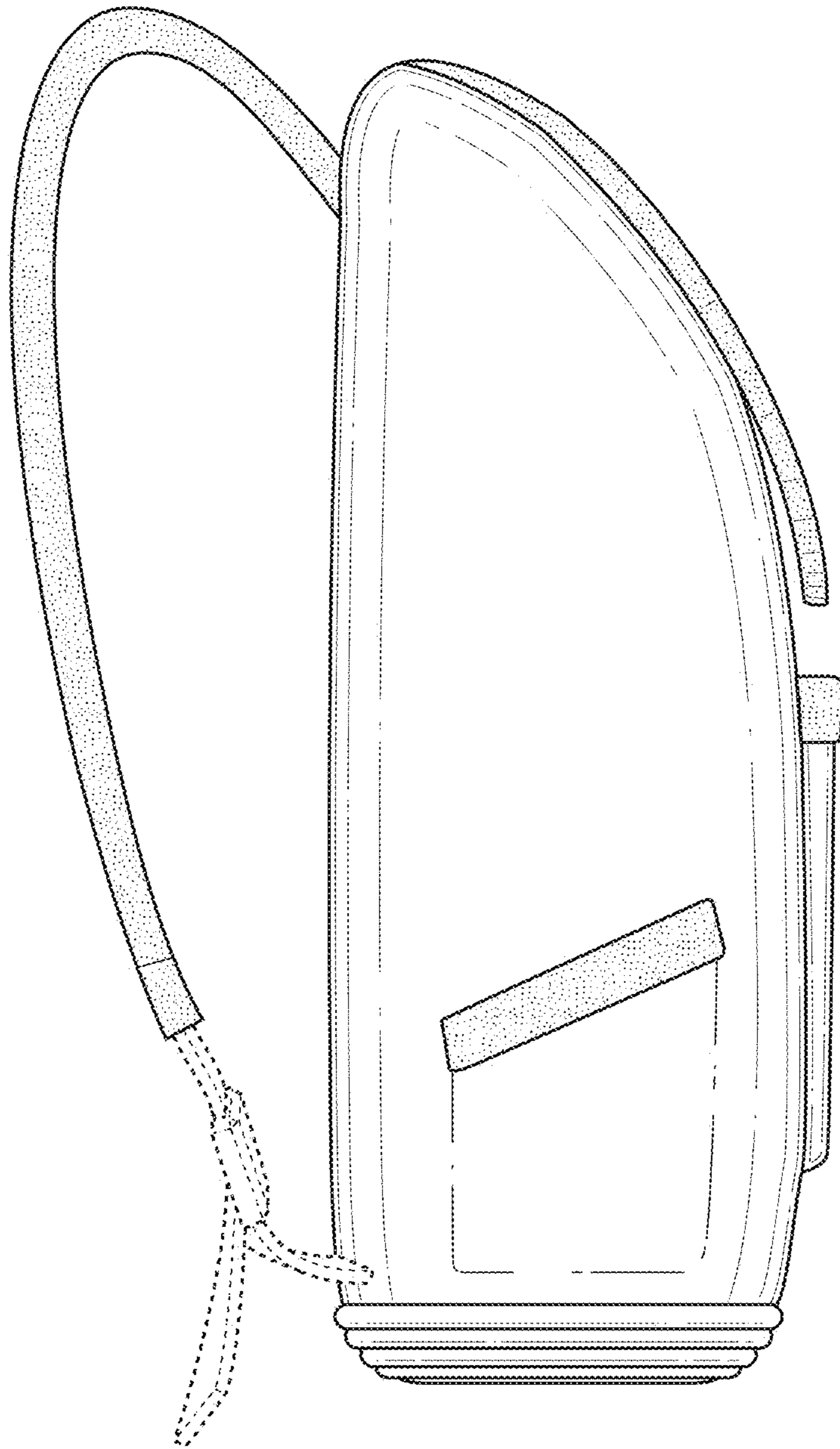

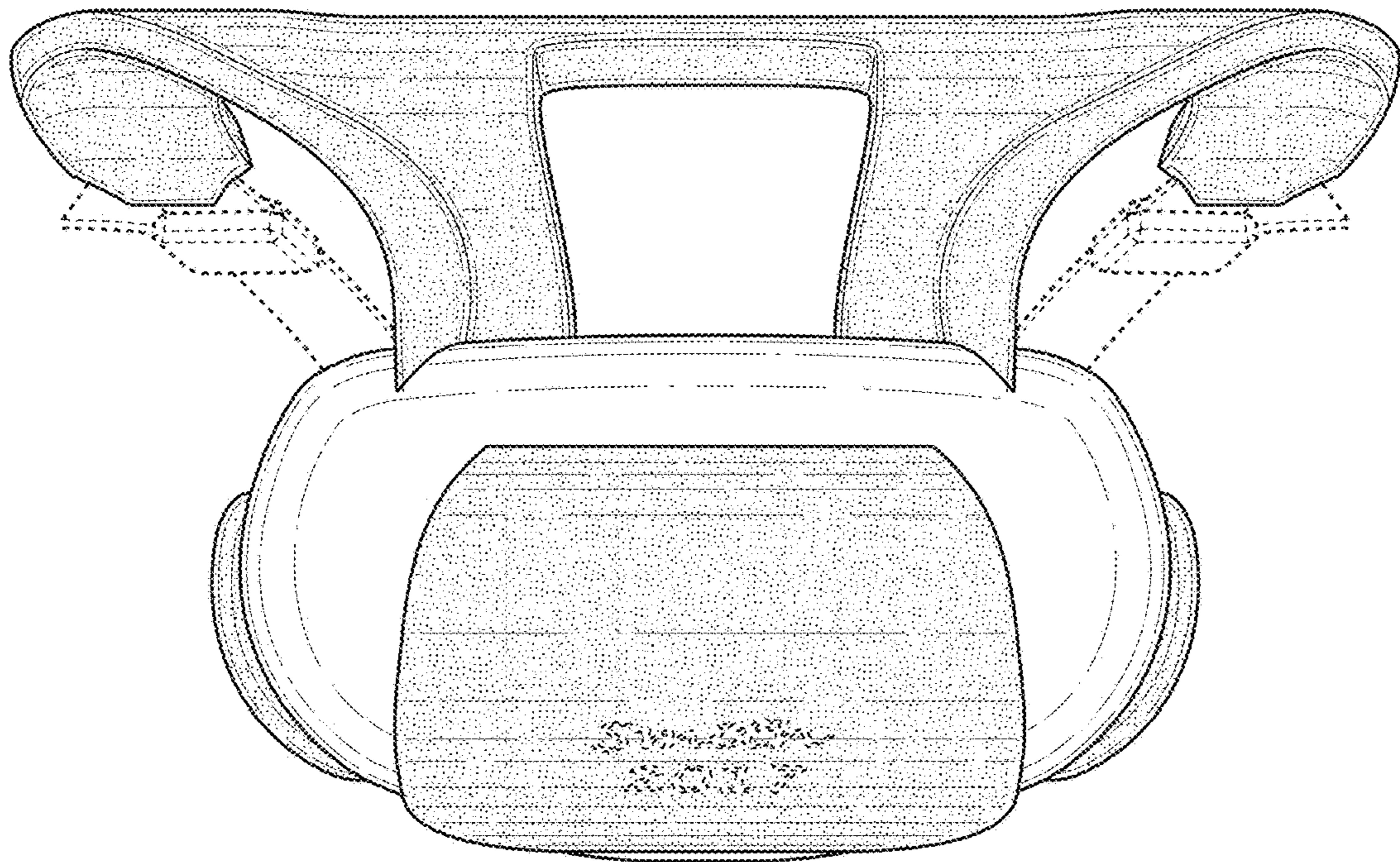

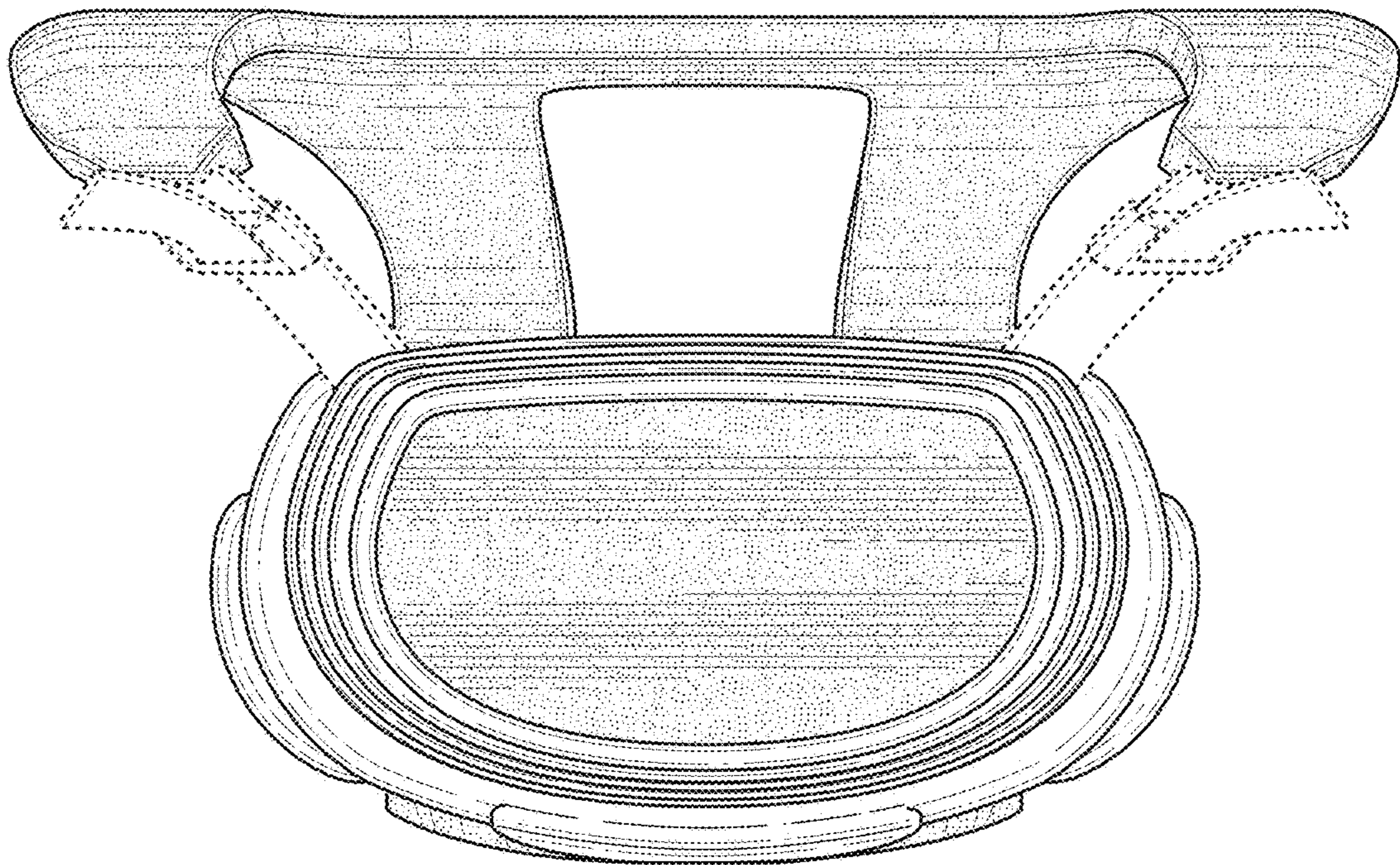
