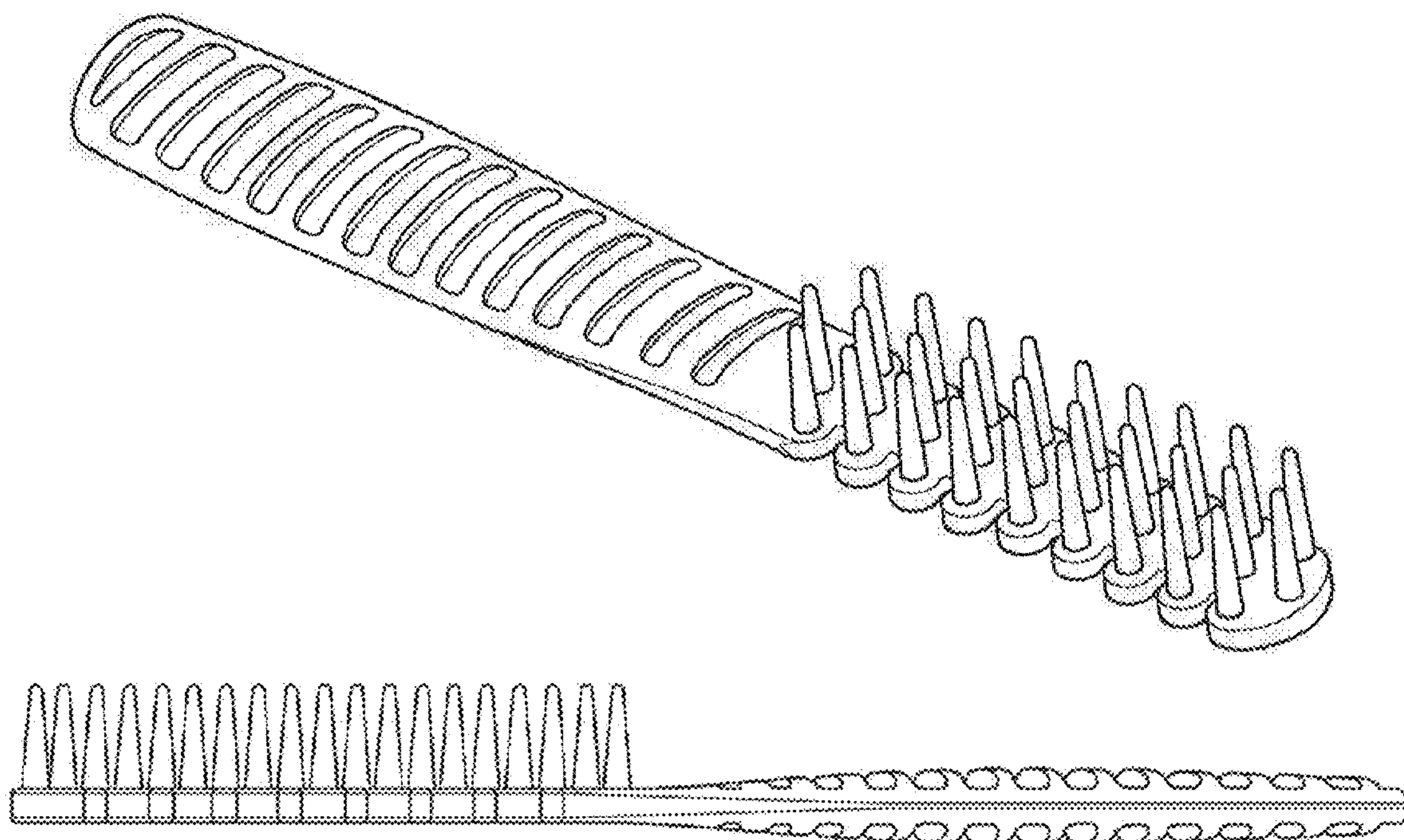
(57) **CLAIM**

The design of the hair salon styling brush, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the hair salon styling brush of the present invention;
 FIG. 2 is a top view of the brush as taken along line 2-2 in FIG. 1;
 FIG. 3 is a bottom view of the styling brush of the present invention;
 FIG. 4 is a cross-sectional side view of the styling brush of the present invention;
 FIG. 5 is a left side view of the styling brush of the present invention, the right side being a mirror image;
 FIG. 6 is a bottom end view of the styling brush of the present invention; and,
 FIG. 7 is a top end view of the styling brush of the present invention.

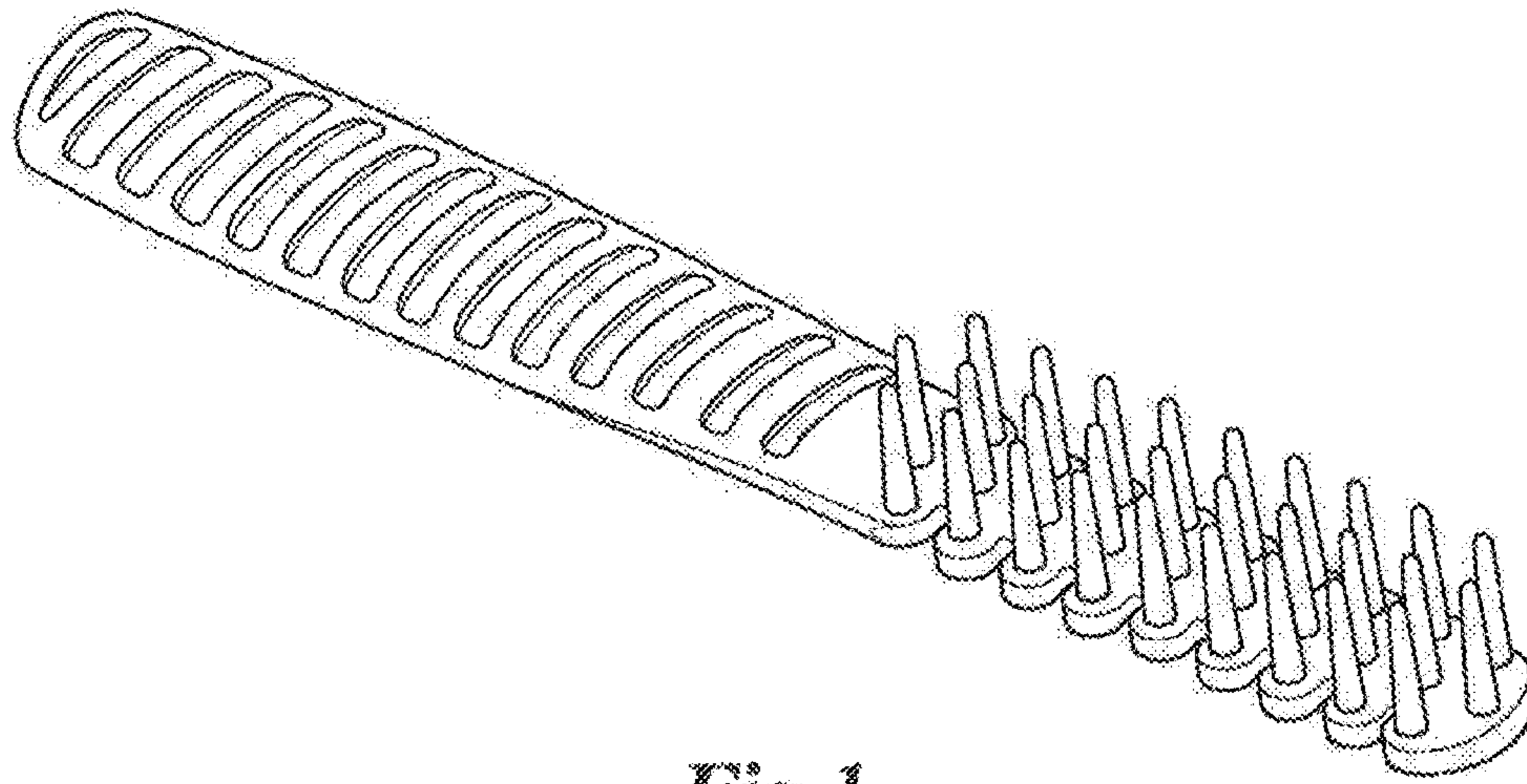

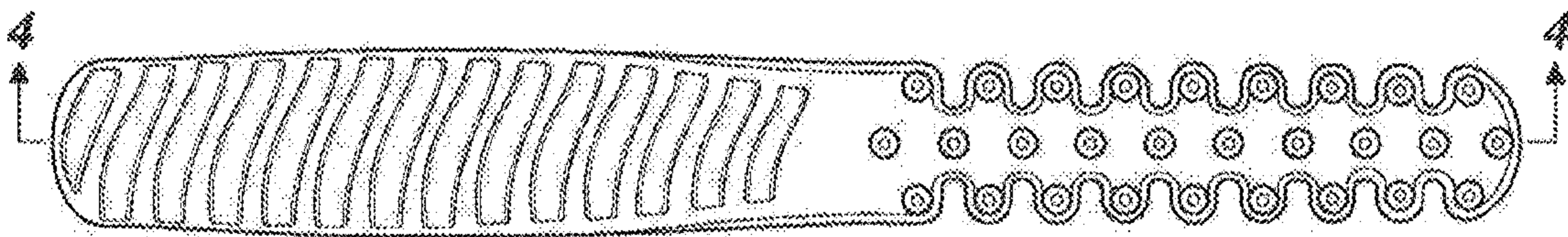

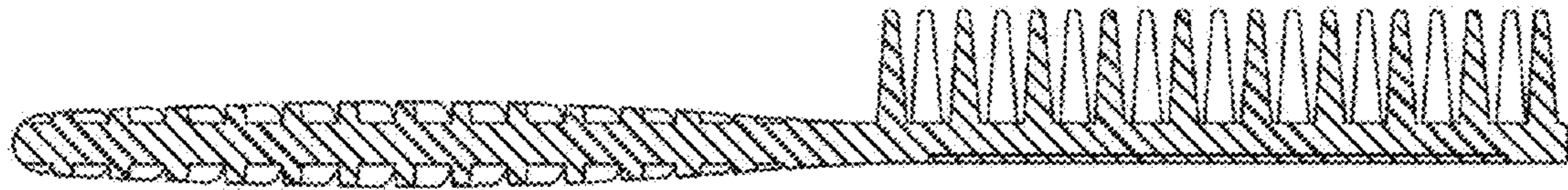

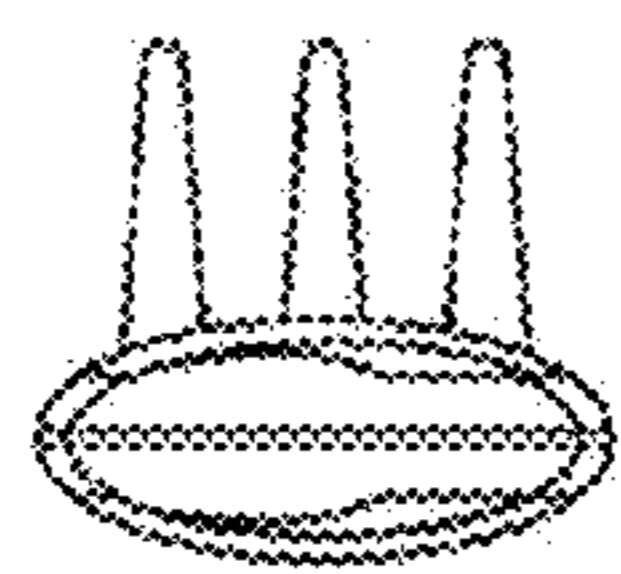

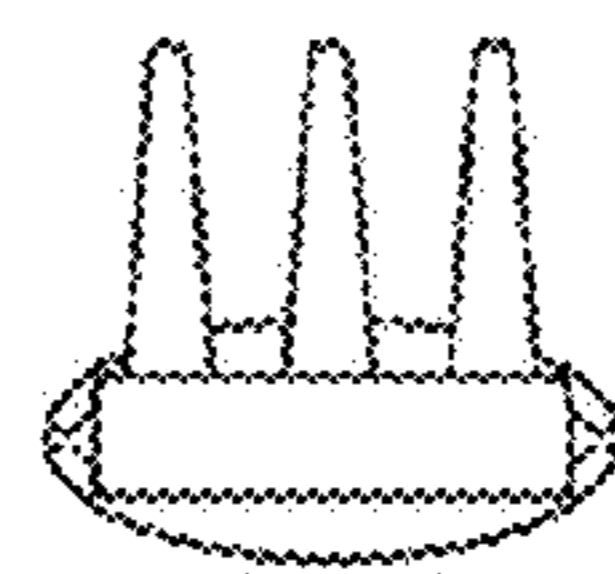
