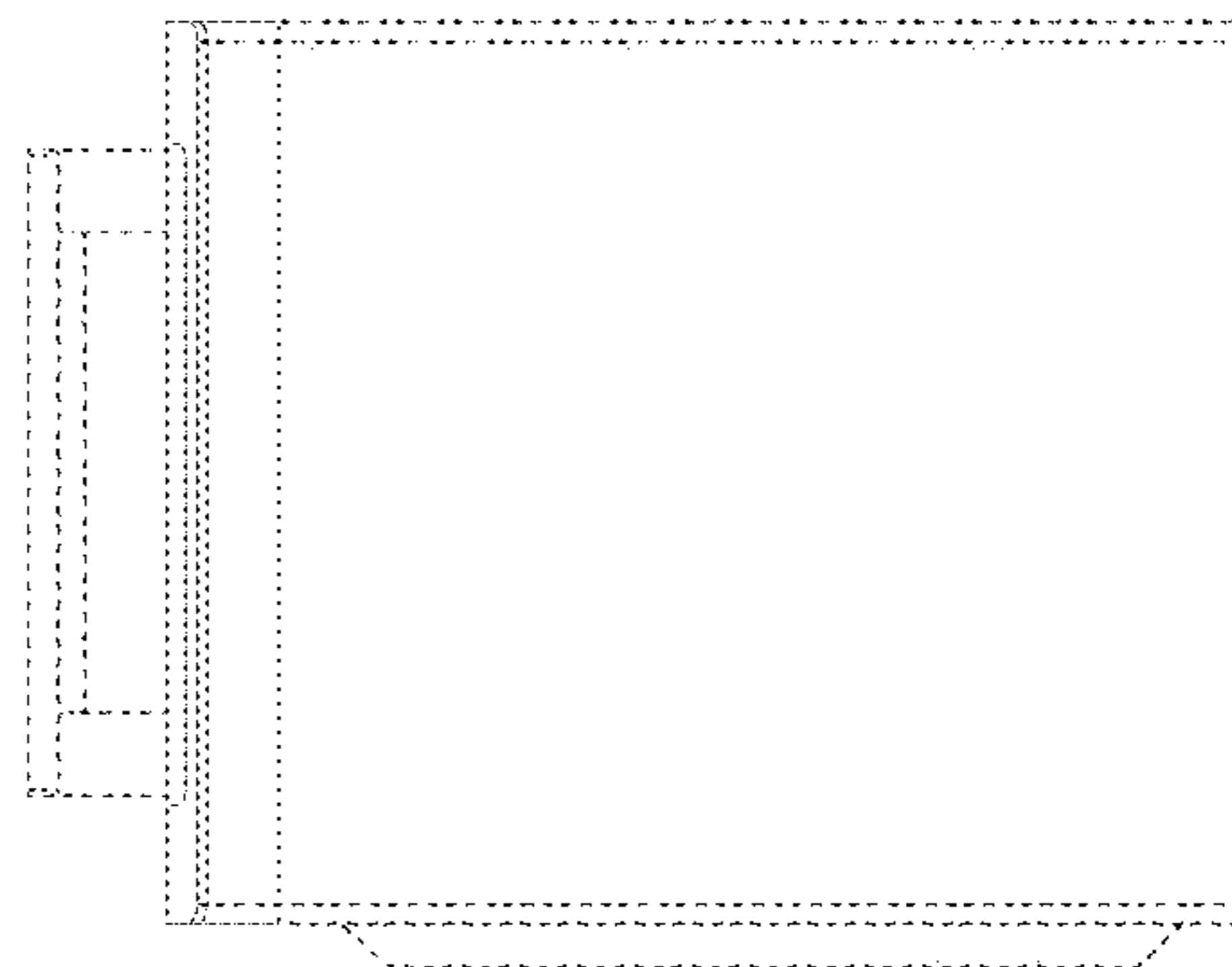
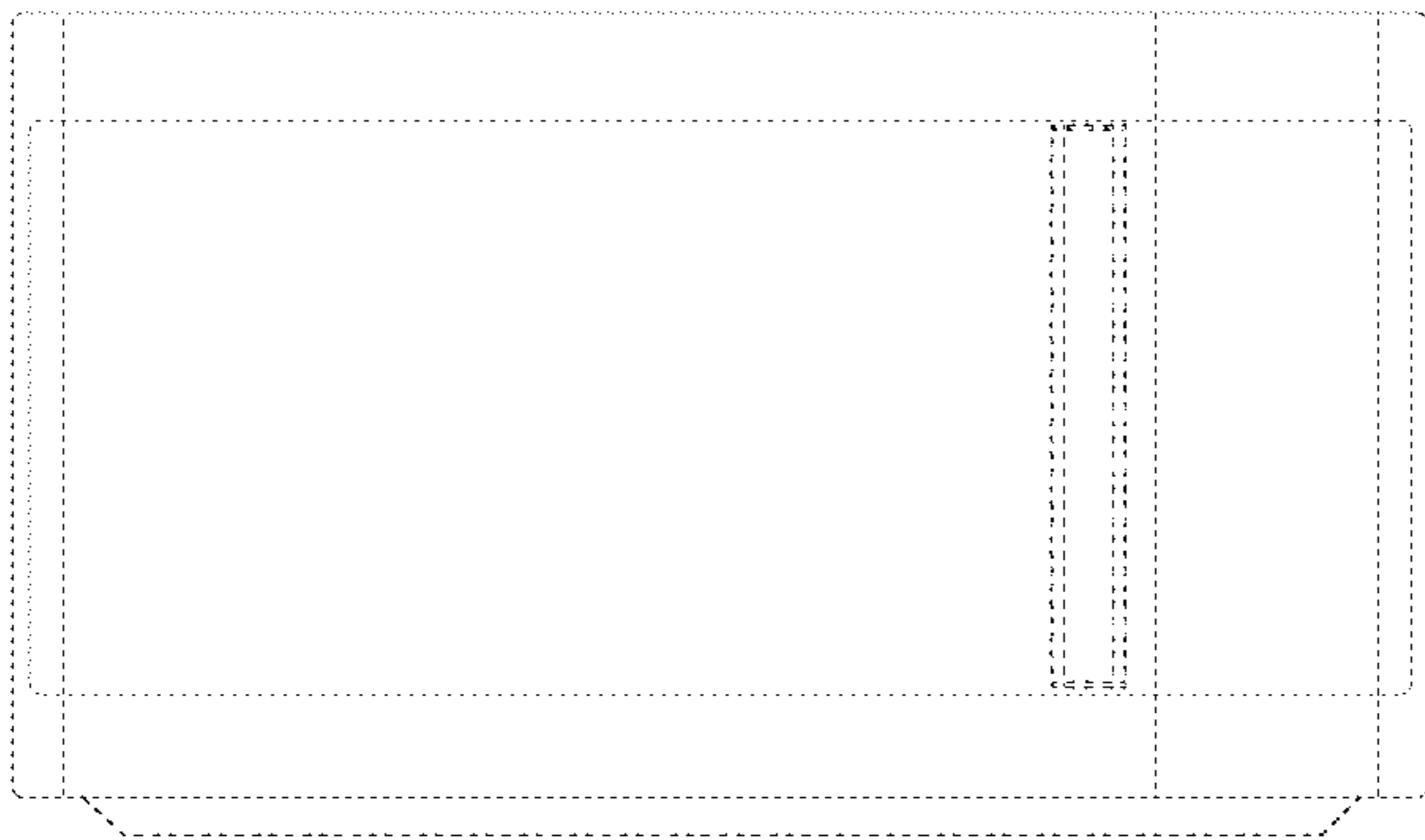
The ornamental design for a microwave oven, as shown and described.

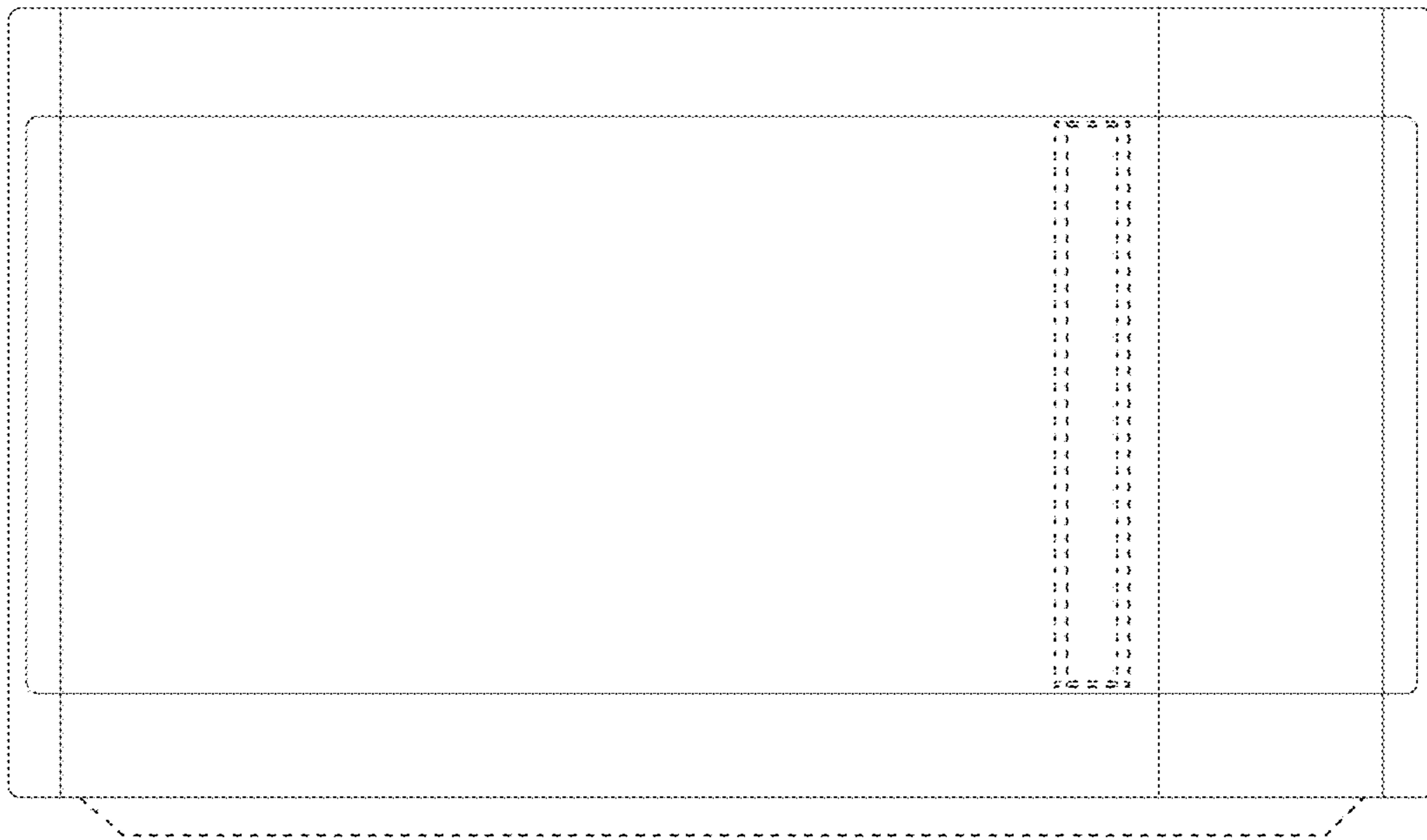

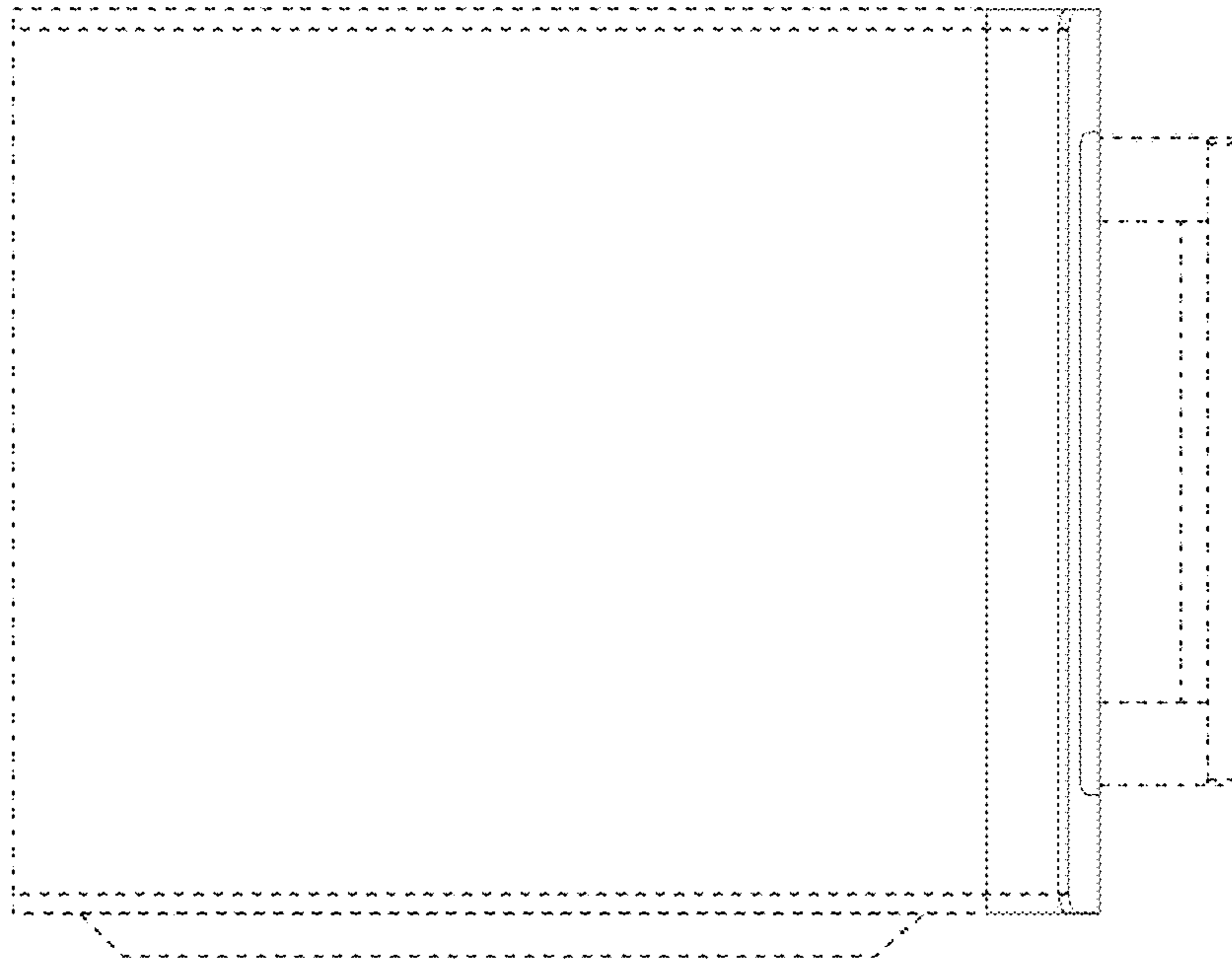

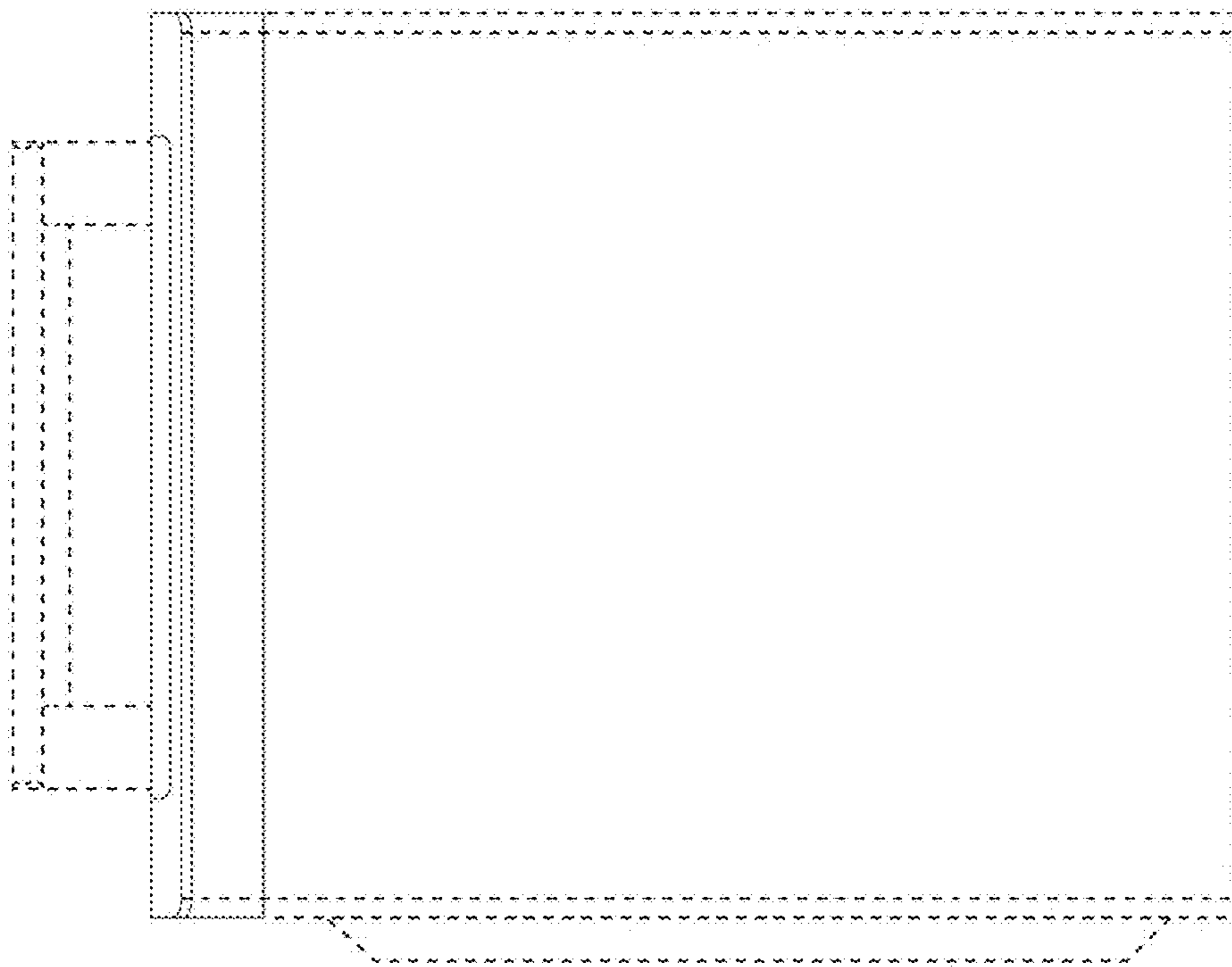

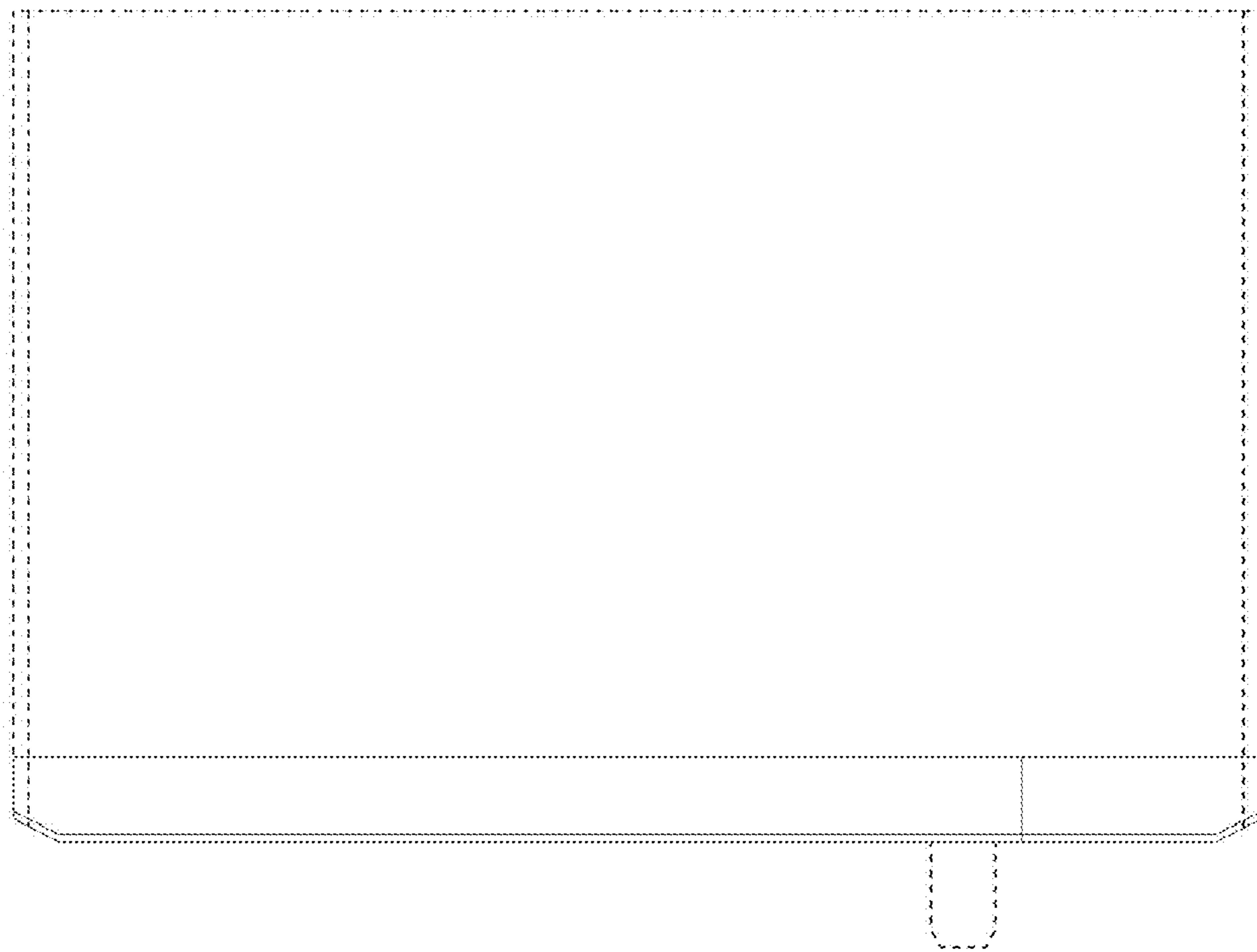

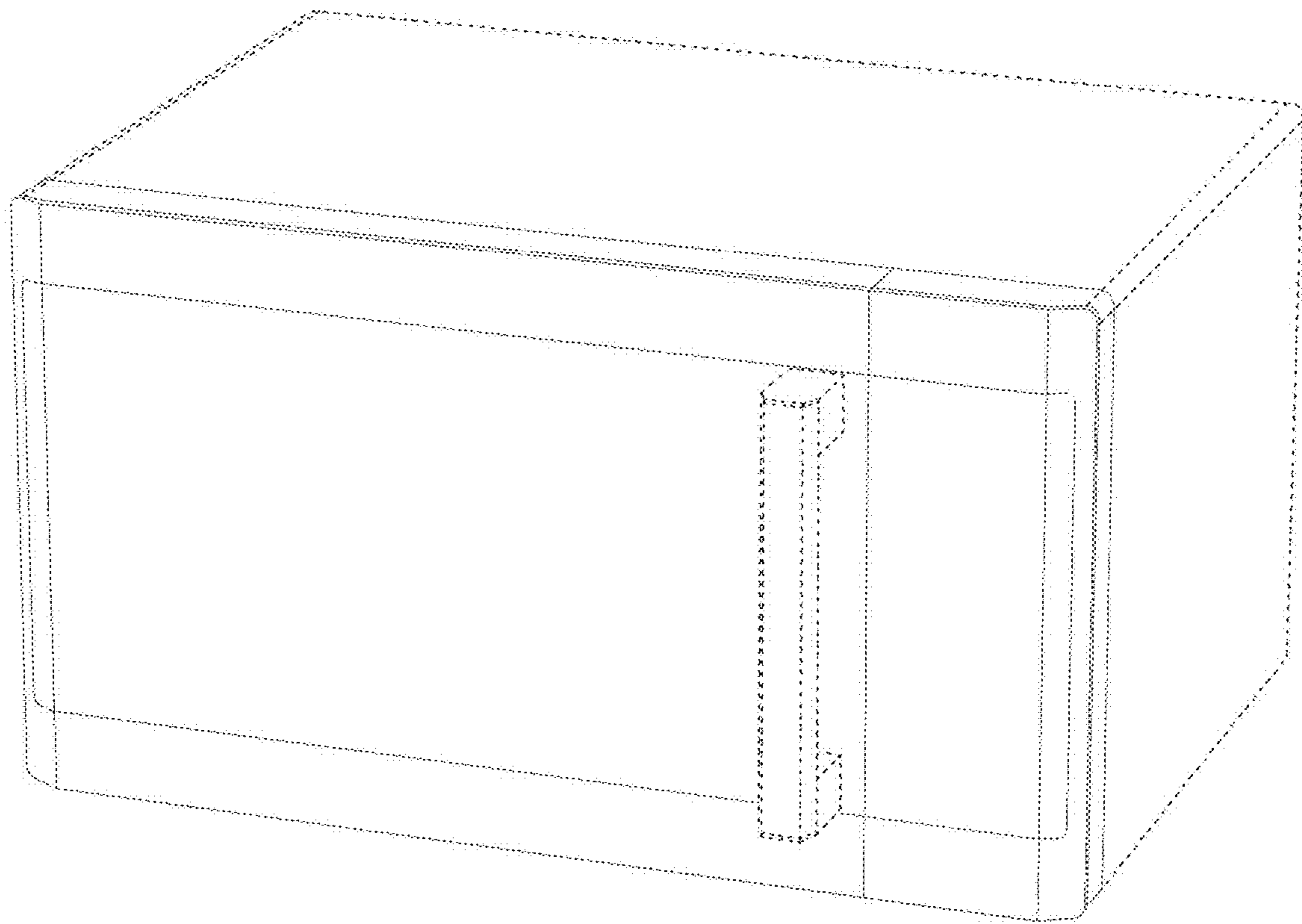
