**DESCRIPTION**

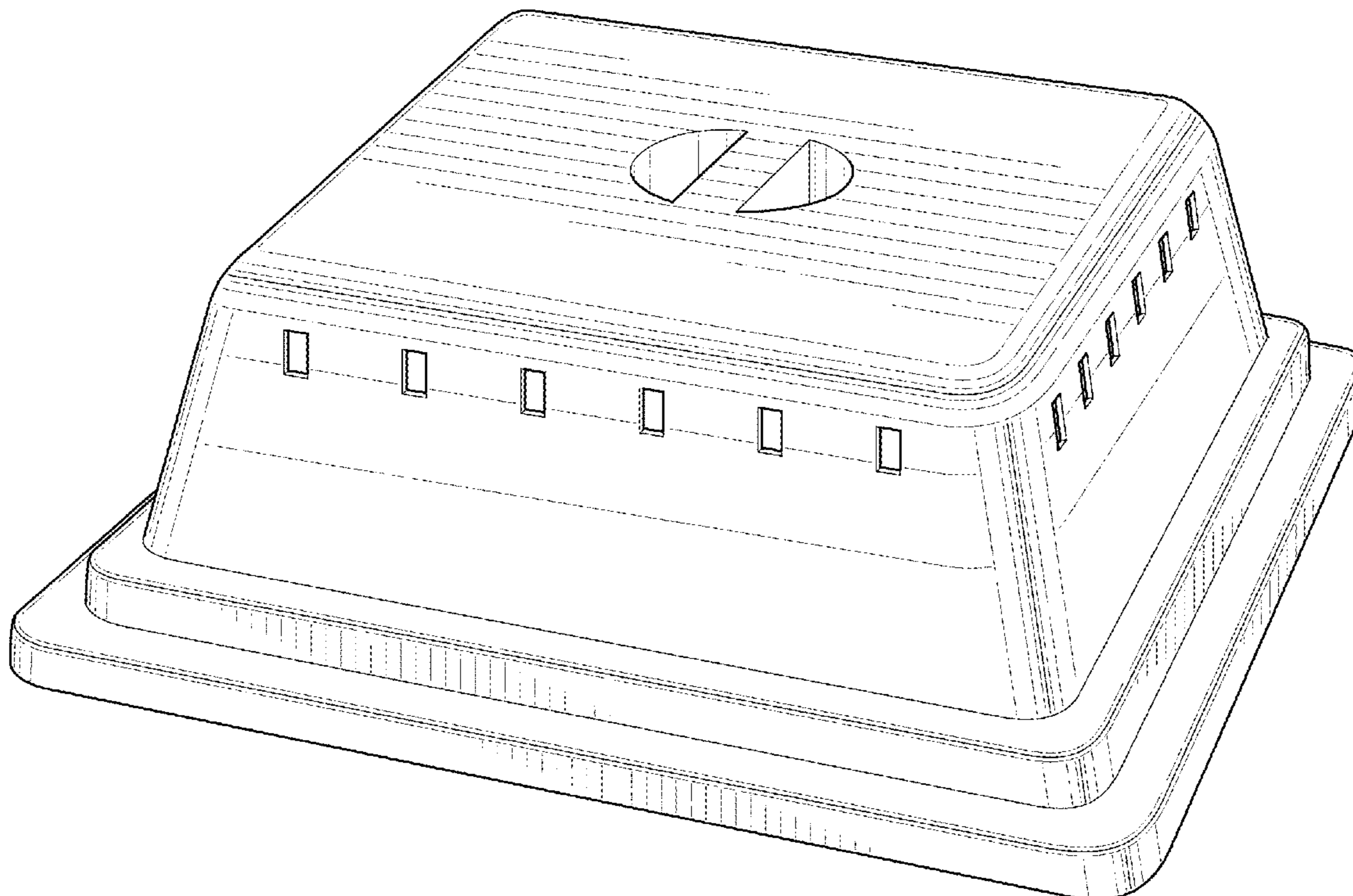
FIG. 1 is a perspective view of the microwave food cover showing my new design;

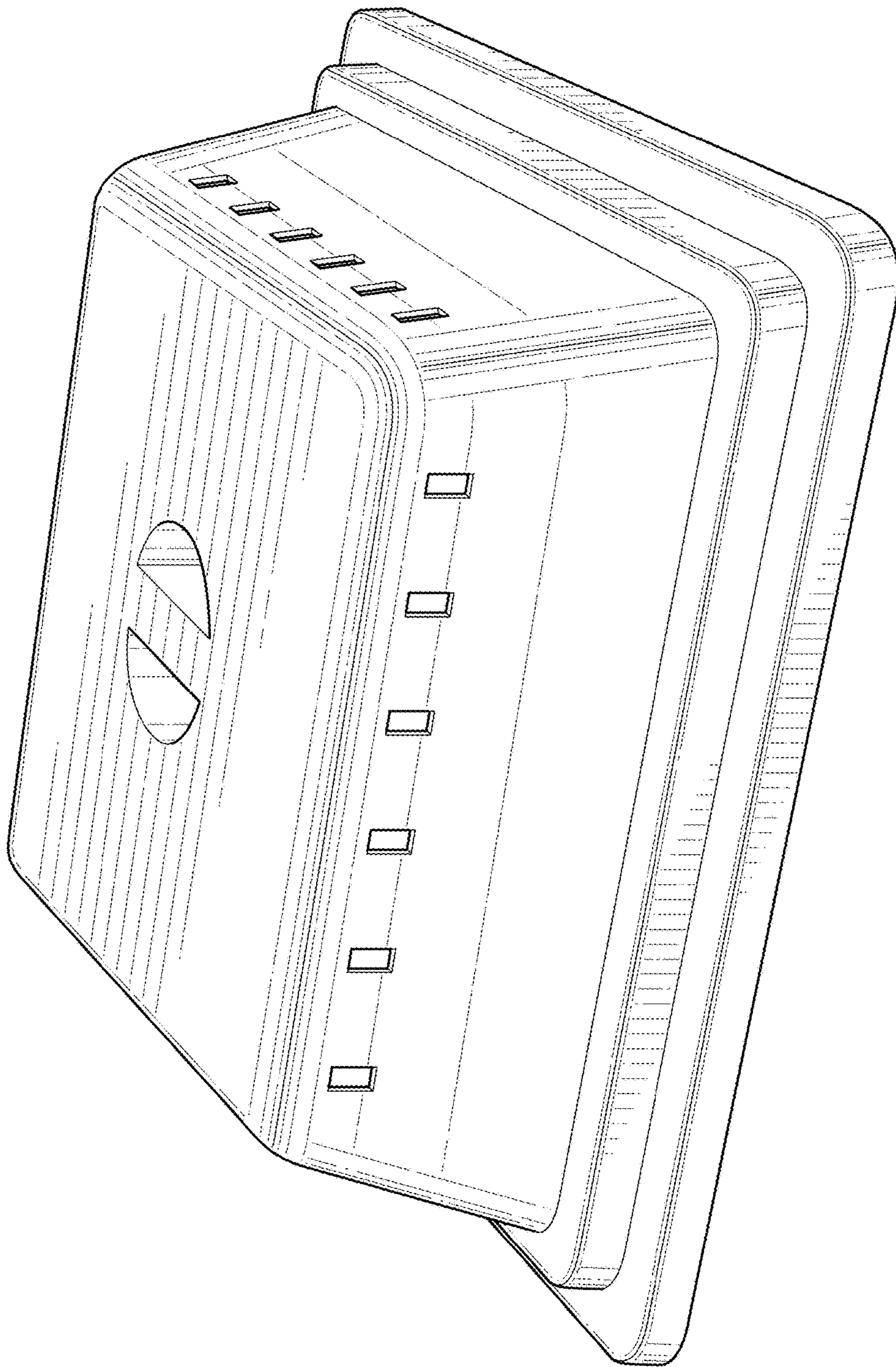

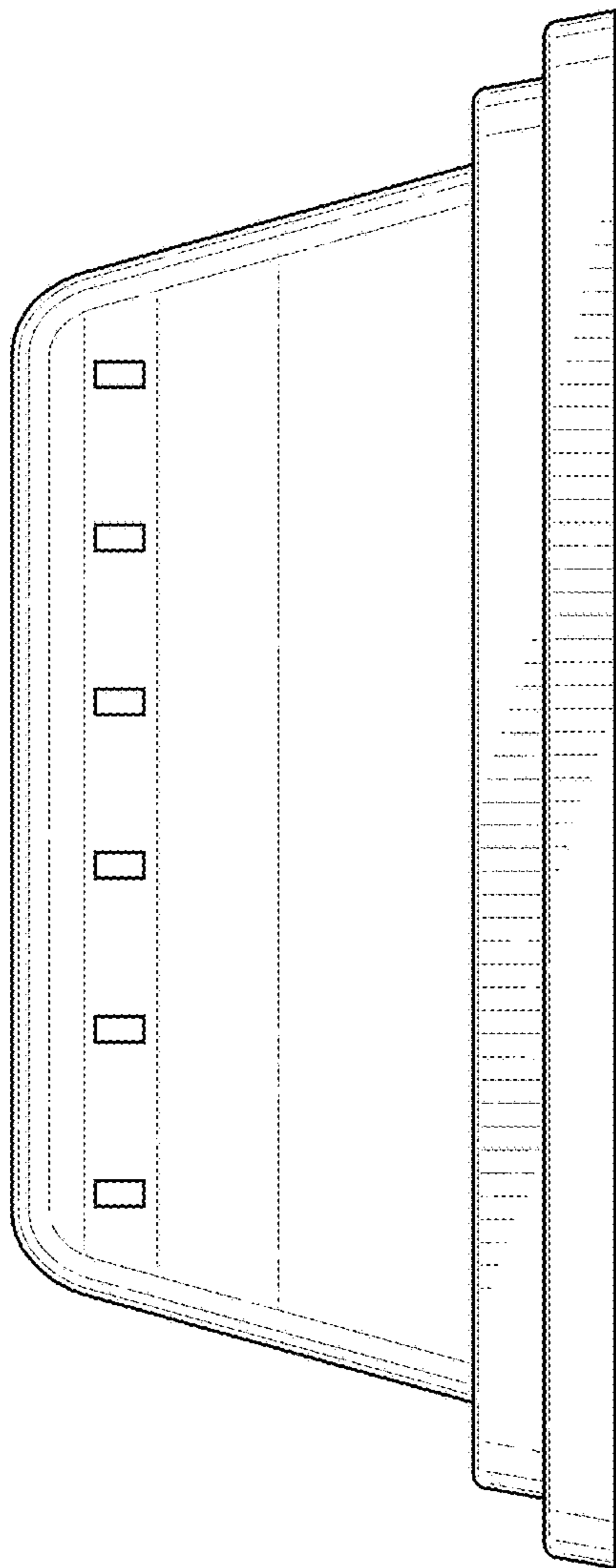

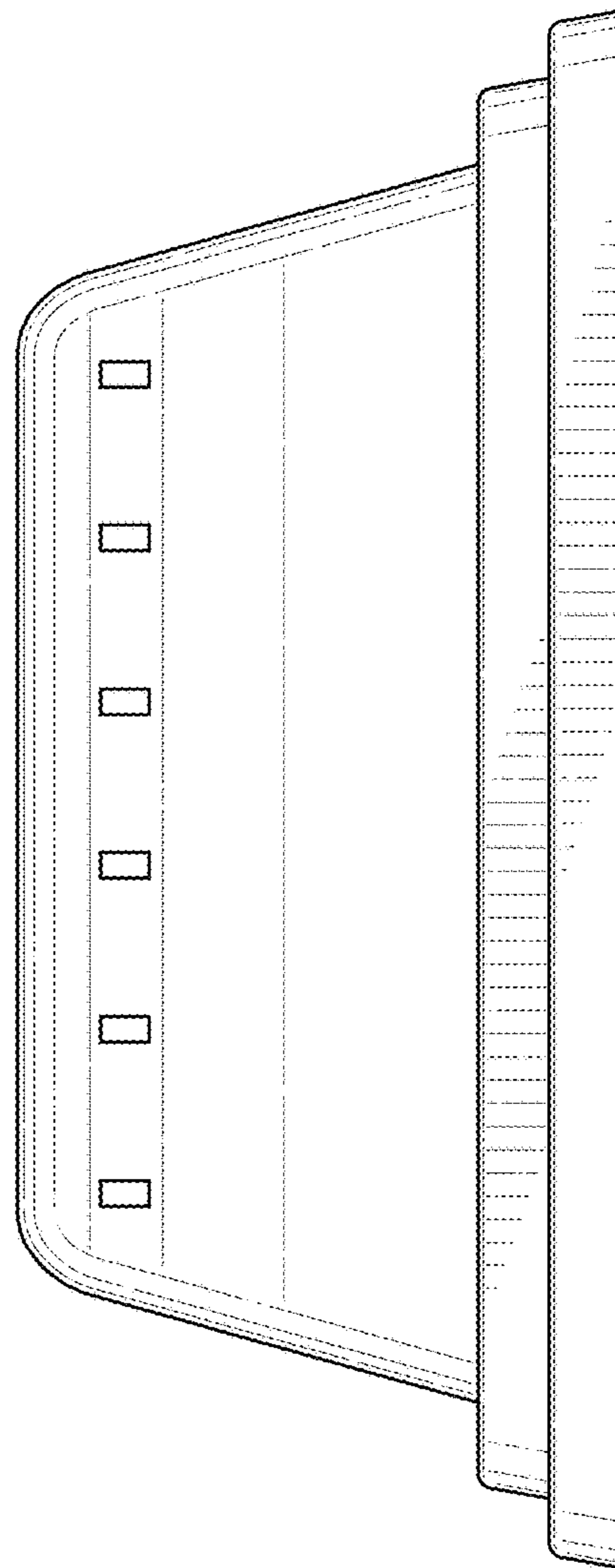
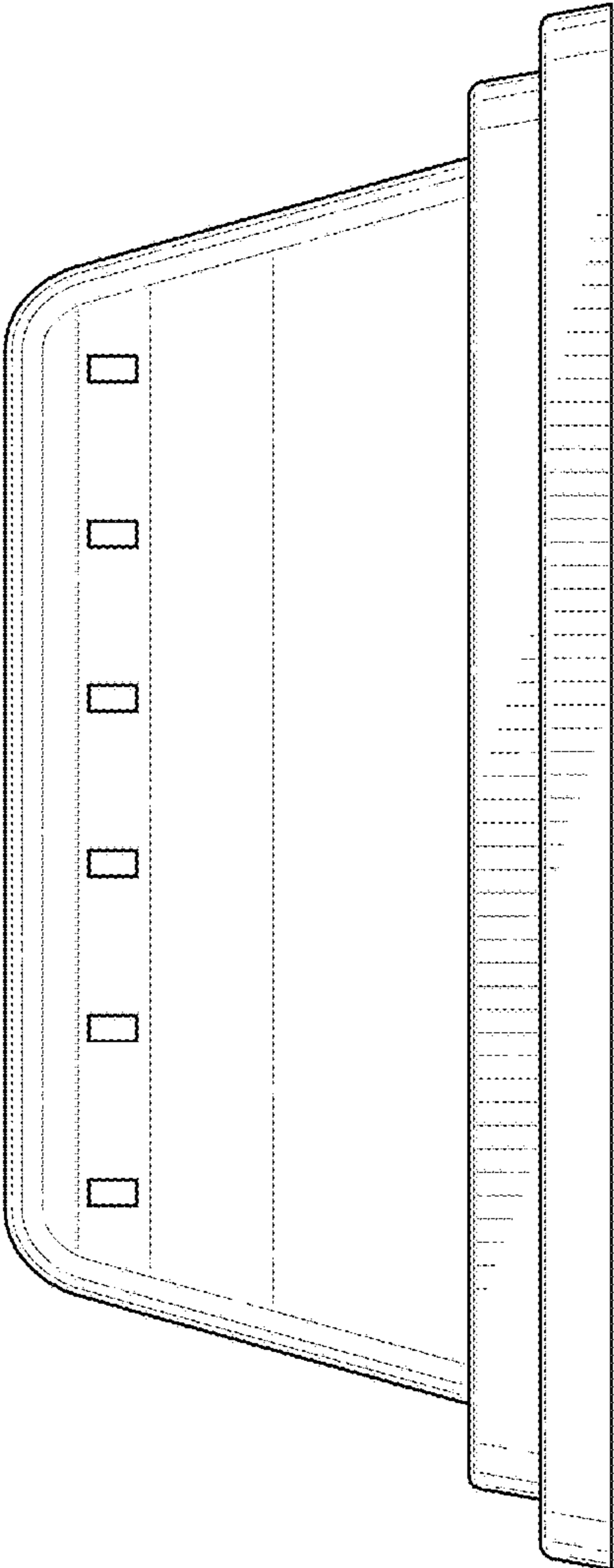
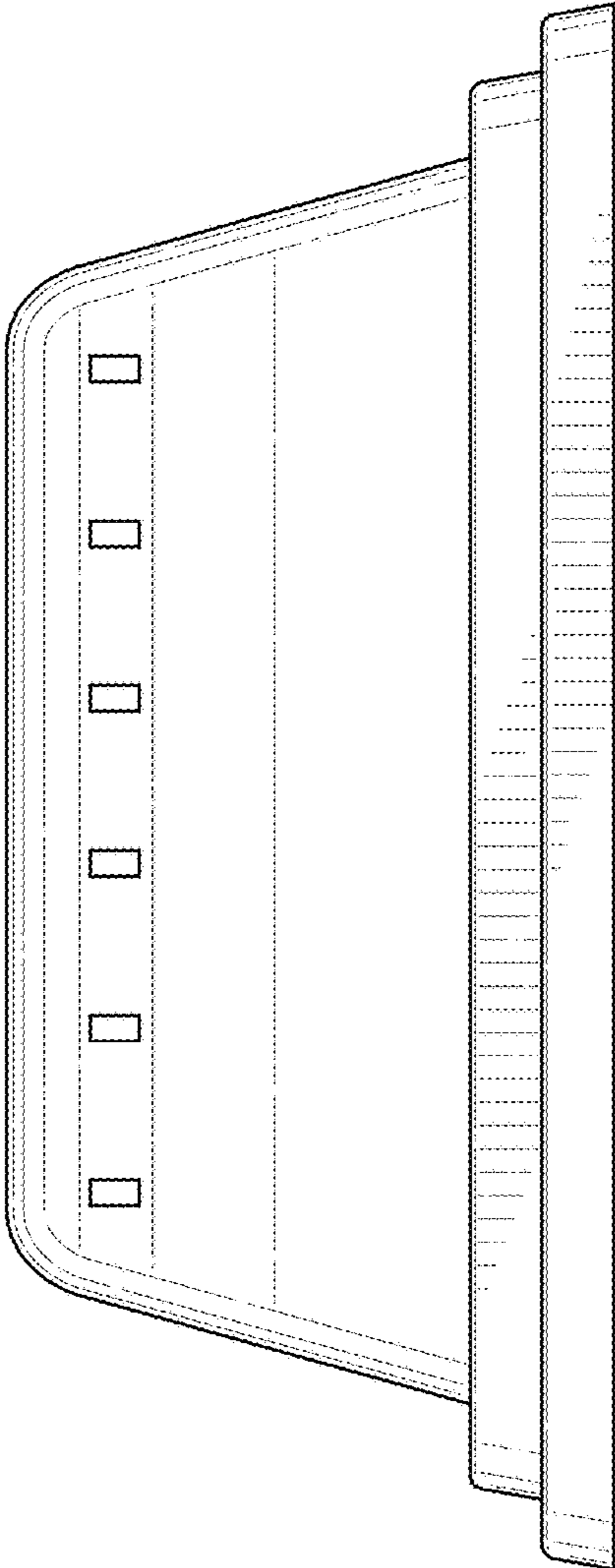

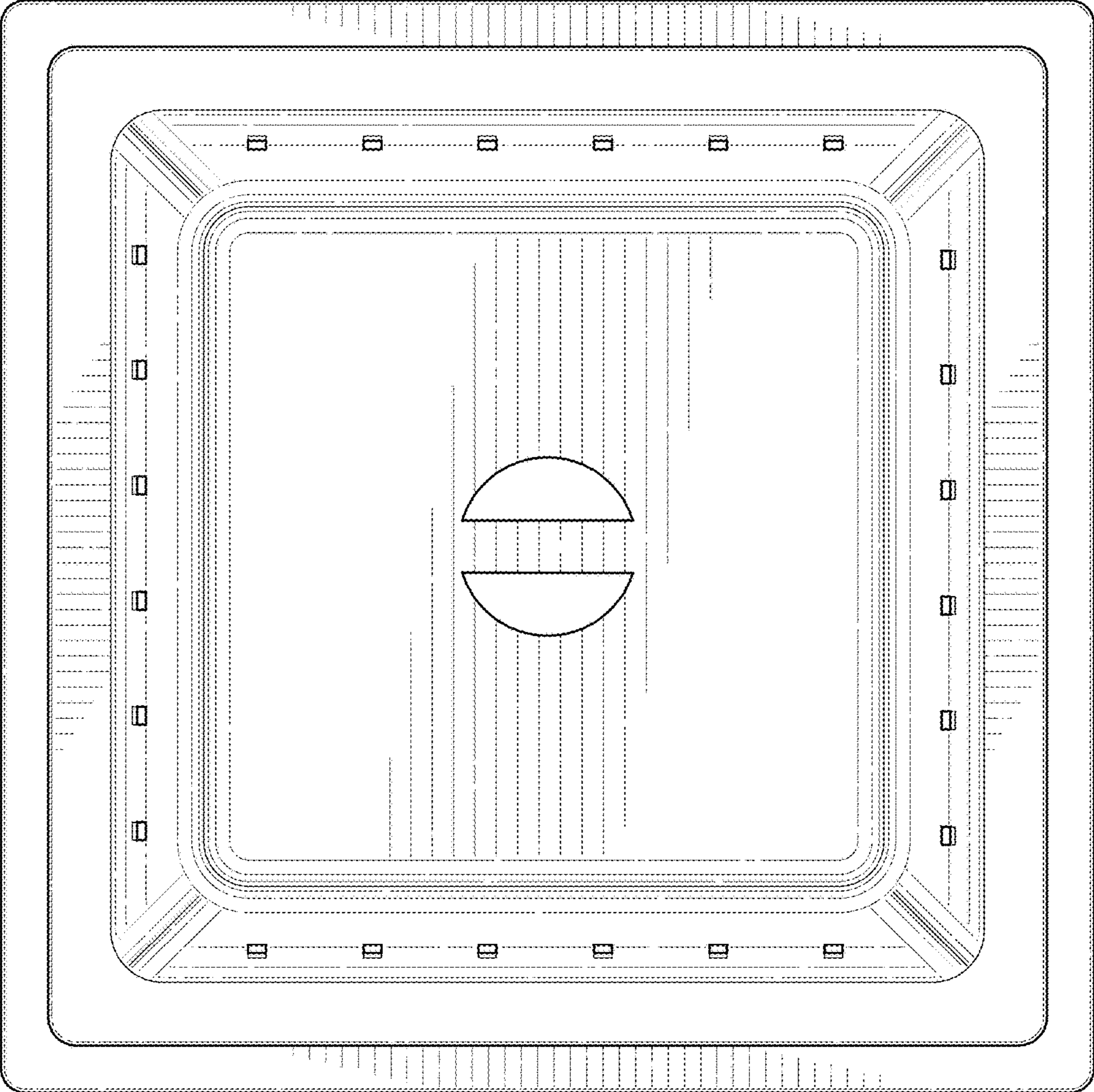

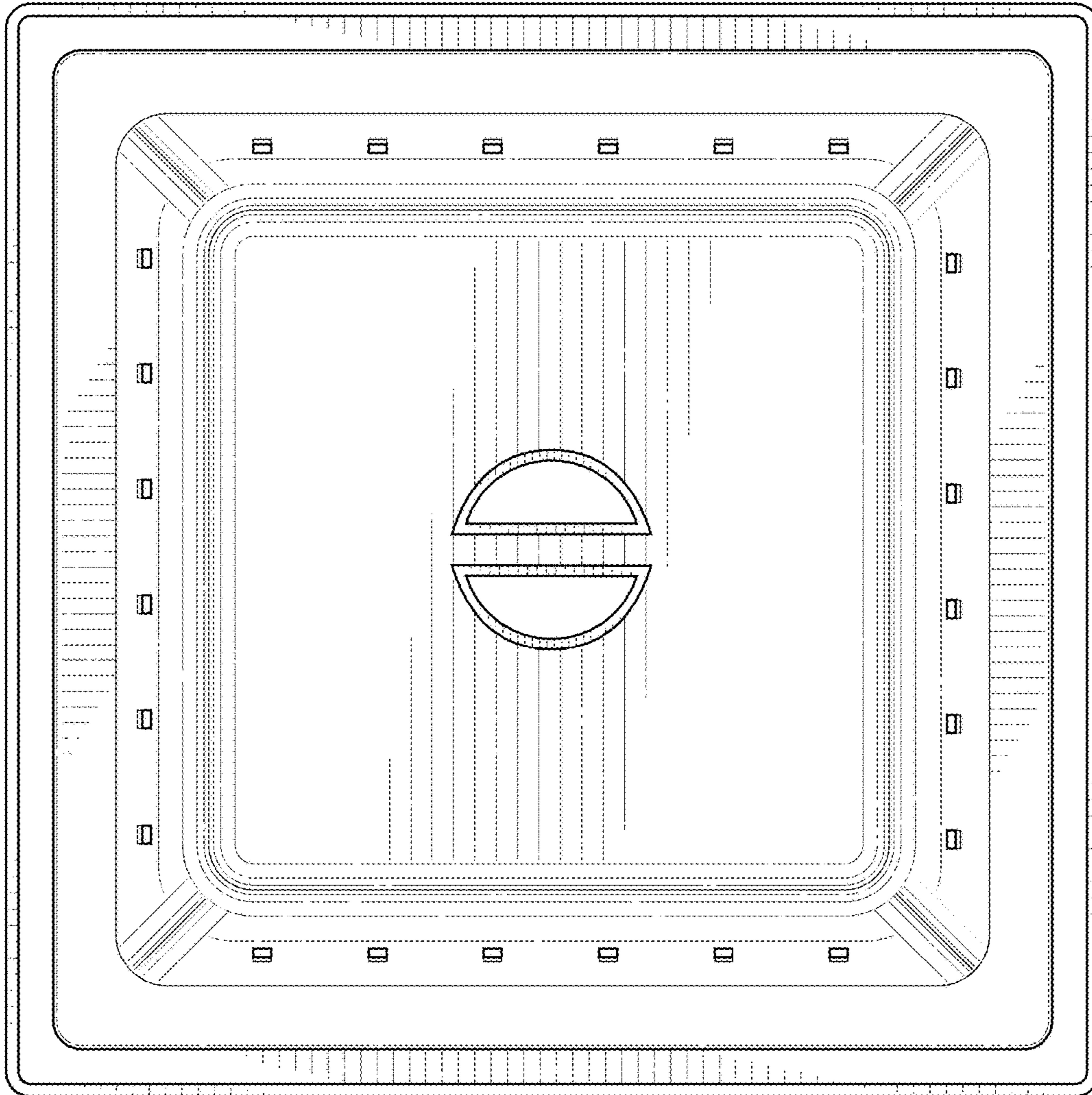
