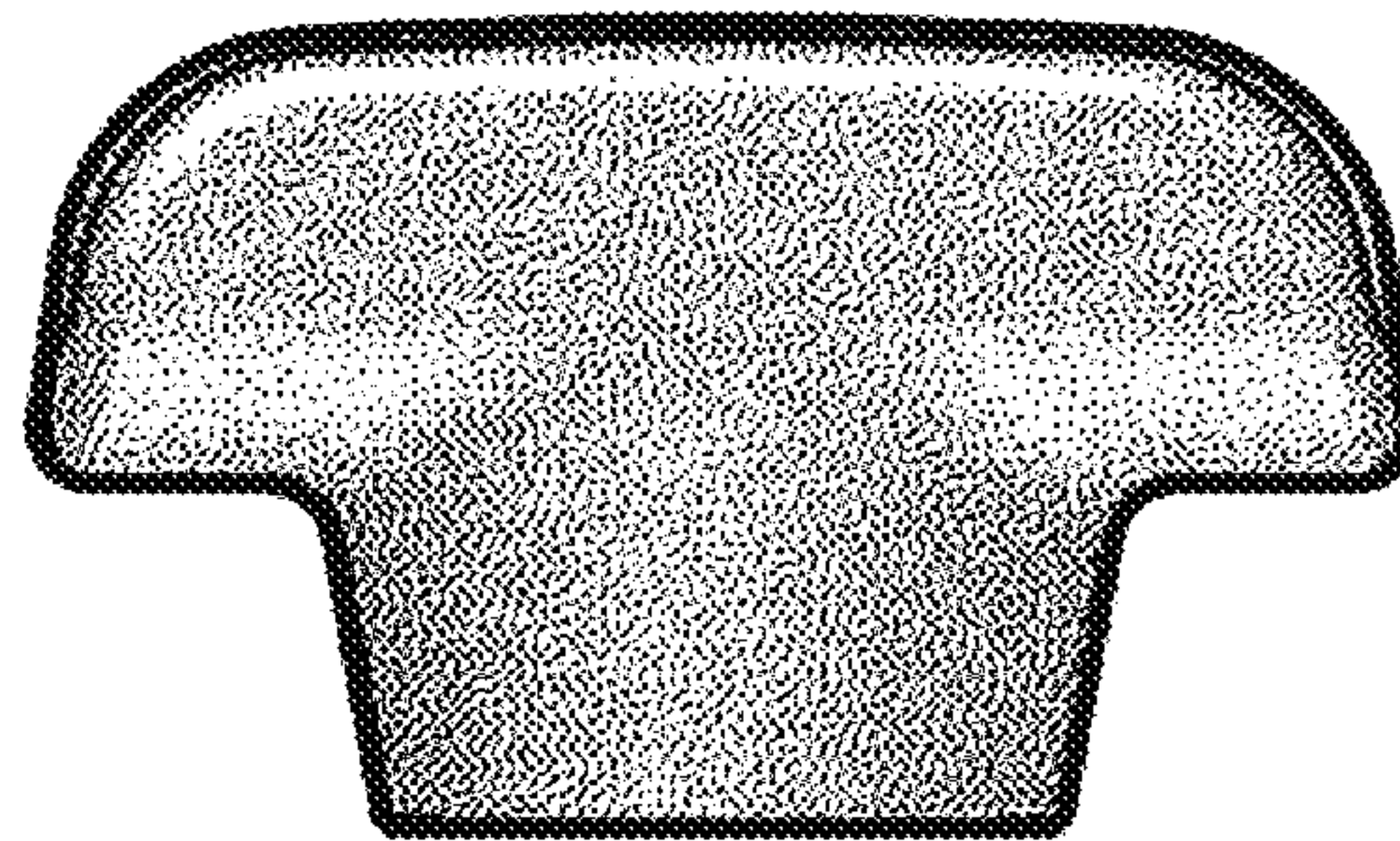
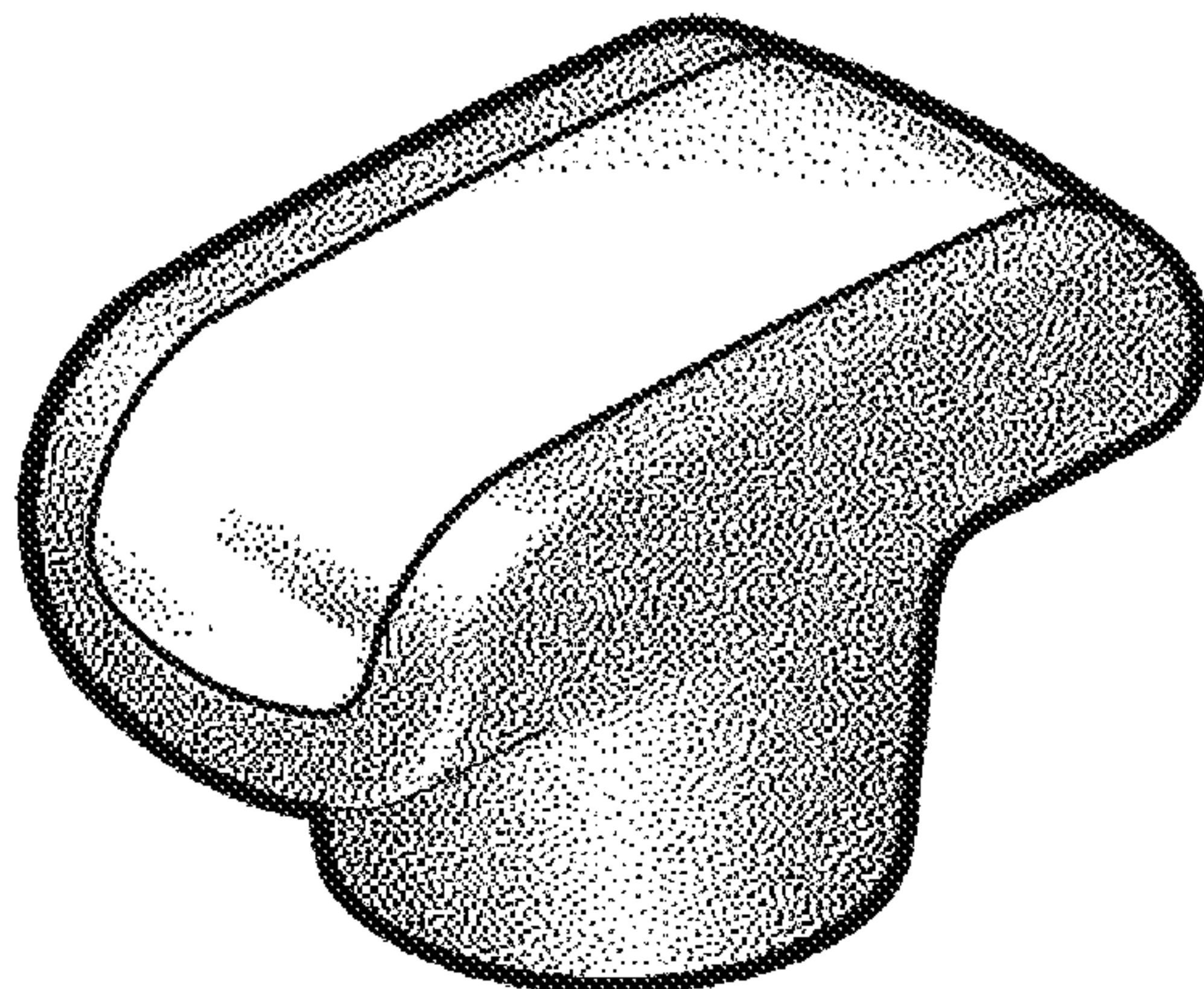
(57) **CLAIM**

The ornamental design for a cookware lid handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the “cookware lid handle”, showing my new design;
FIG. 2 is a right side elevation view thereof; the left side elevation view being the mirror image thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof; and,
FIG. 5 is a front elevation view thereof; the back elevation view being the mirror image thereof.
The broken lines in FIG. 4 are for the purpose of illustrating portions of the handle that form no part of the claimed design.

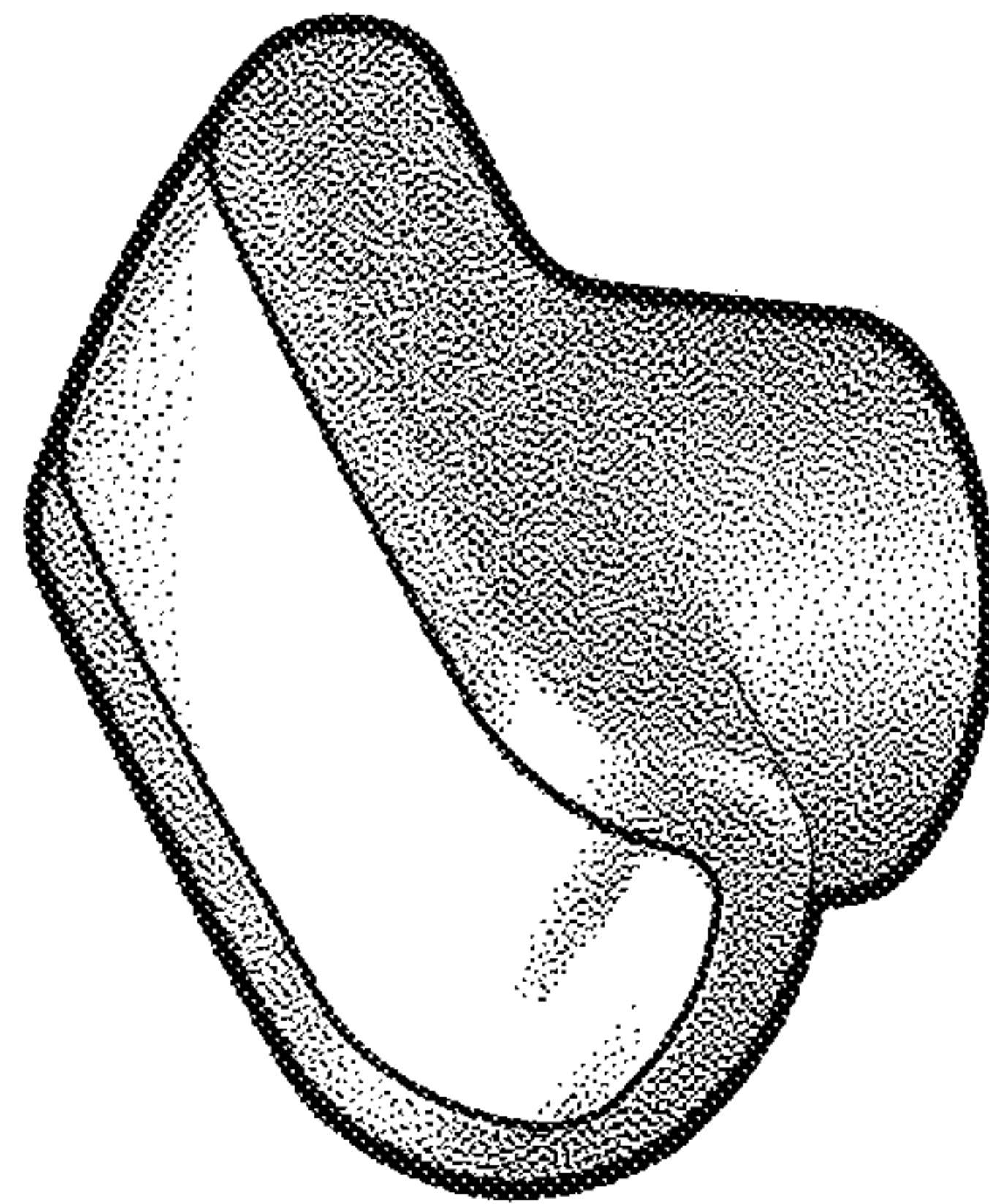

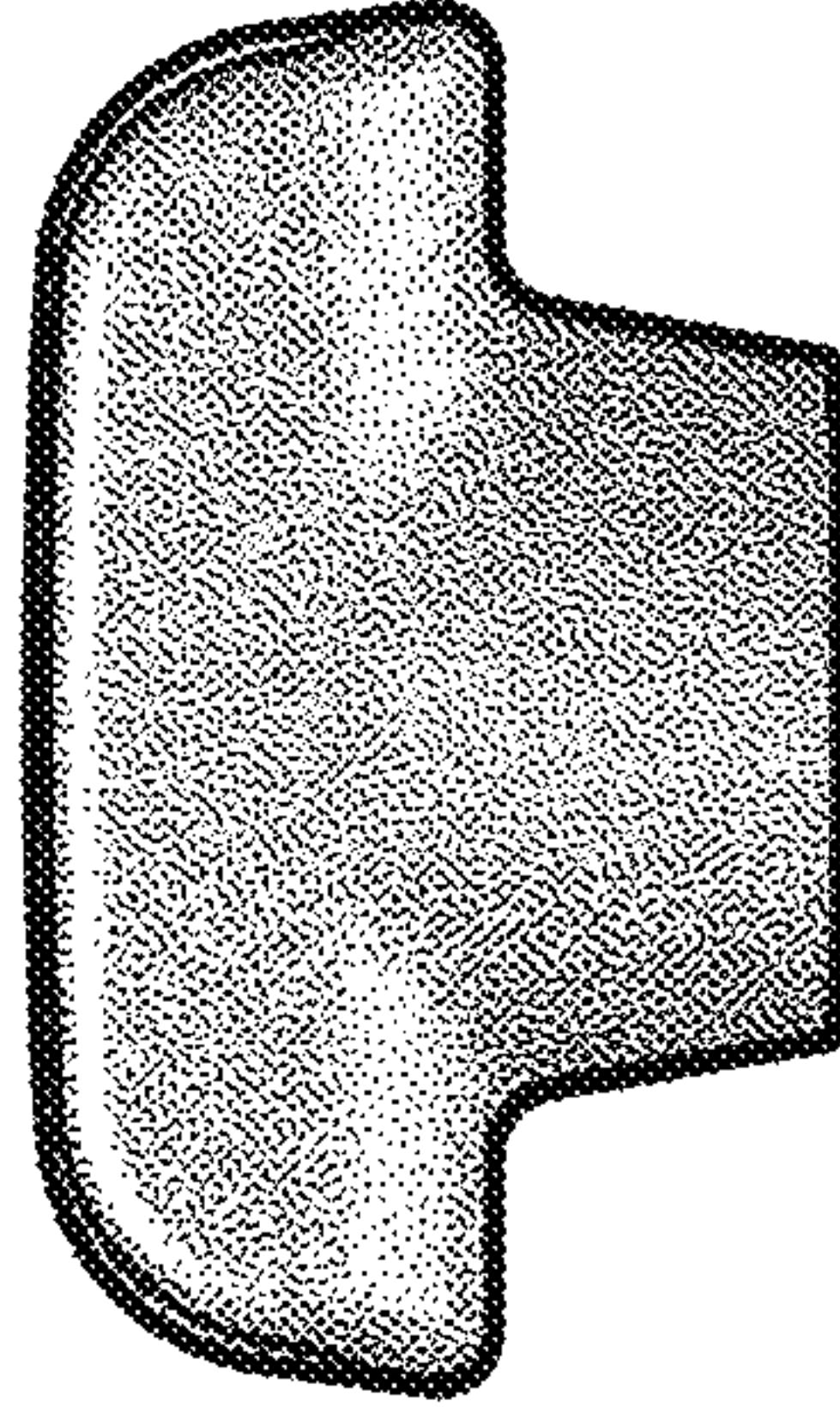

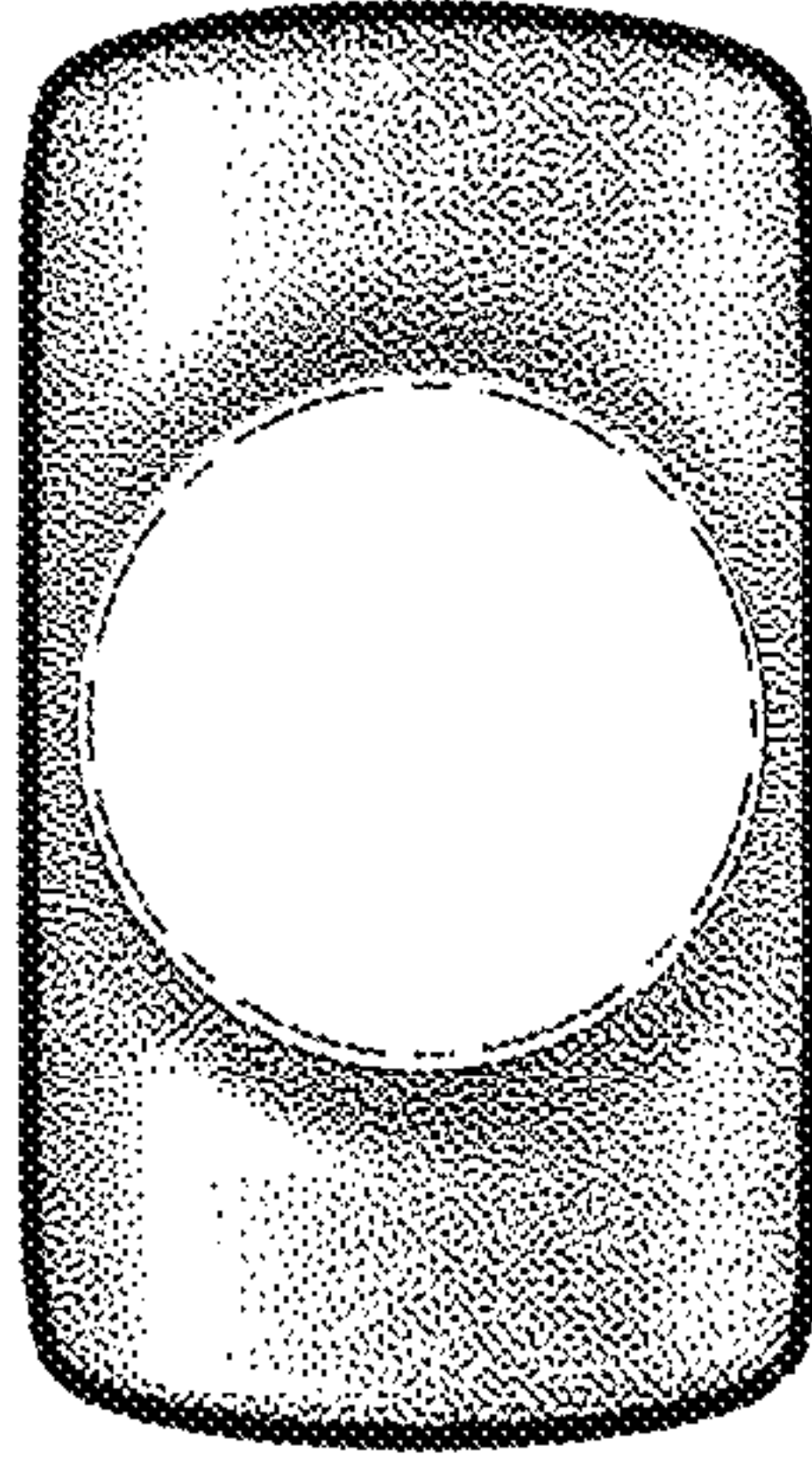

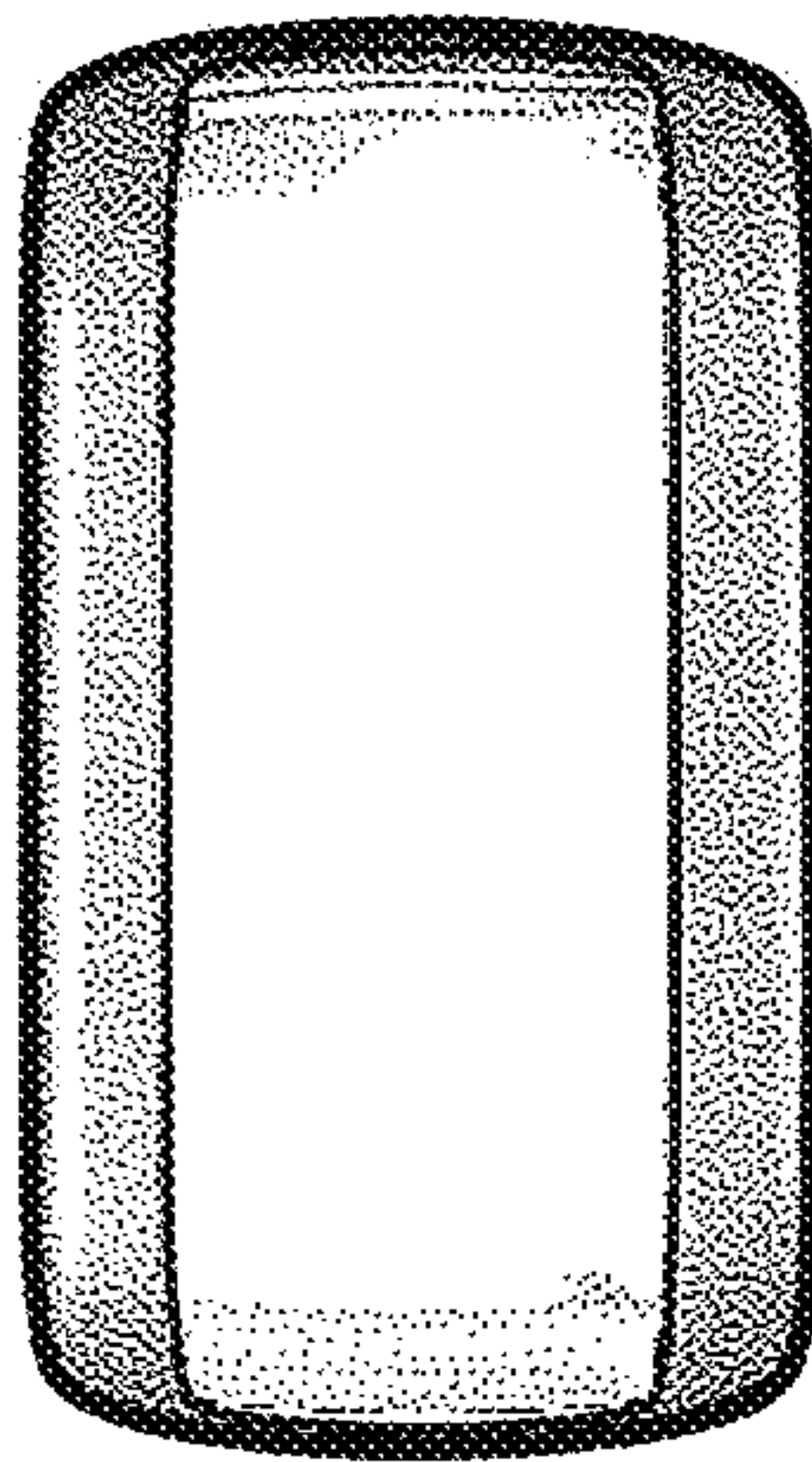

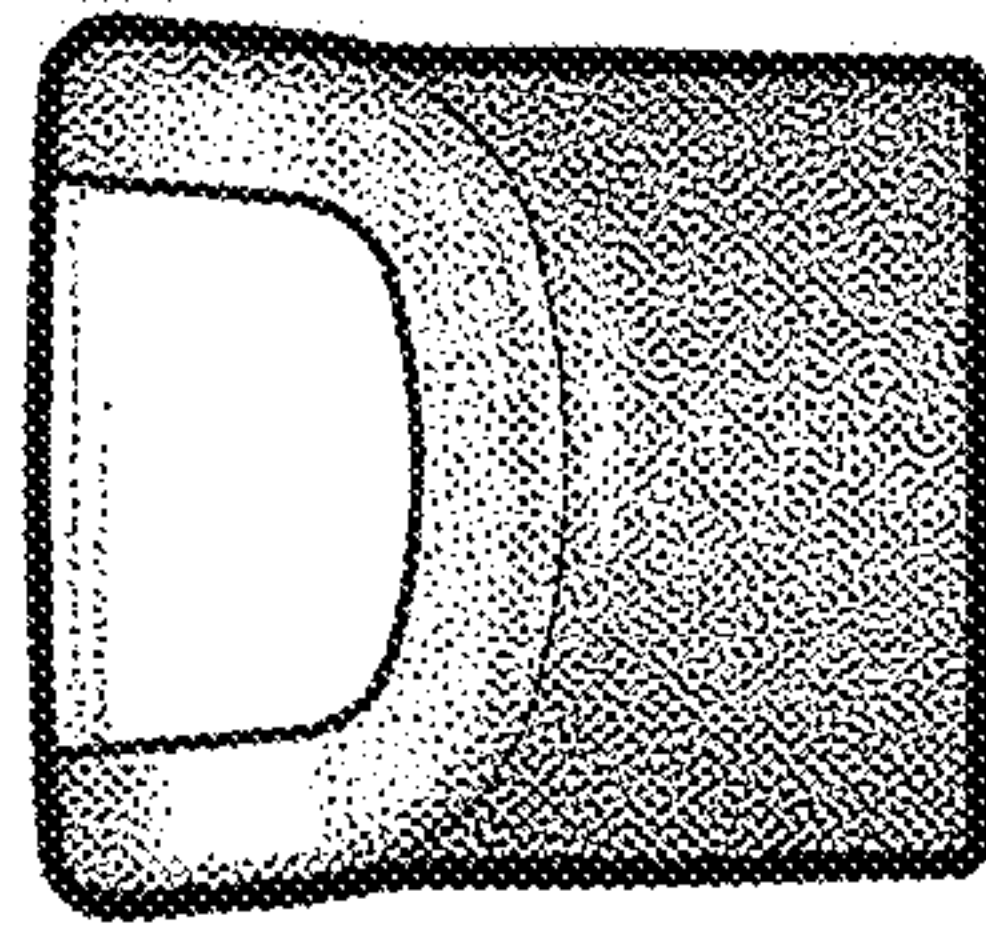
