The ornamental design for a knife blade with handle, as shown and described.

**DESCRIPTION**

- FIG. 1 is an upper left front perspective view of a novel knife blade with handle.
- FIG. 2 is an upper left rear perspective view of the knife blade with handle of FIG. 1.
- FIG. 3 is a lower left front perspective view of the knife blade with handle of FIG. 1.
- FIG. 4 is a lower right rear perspective view of the knife blade with handle of FIG. 1.
- FIG. 5 is a left side view of the knife blade with handle of FIG. 1.
- FIG. 6 is a right side view of the knife blade with handle of FIG. 1.

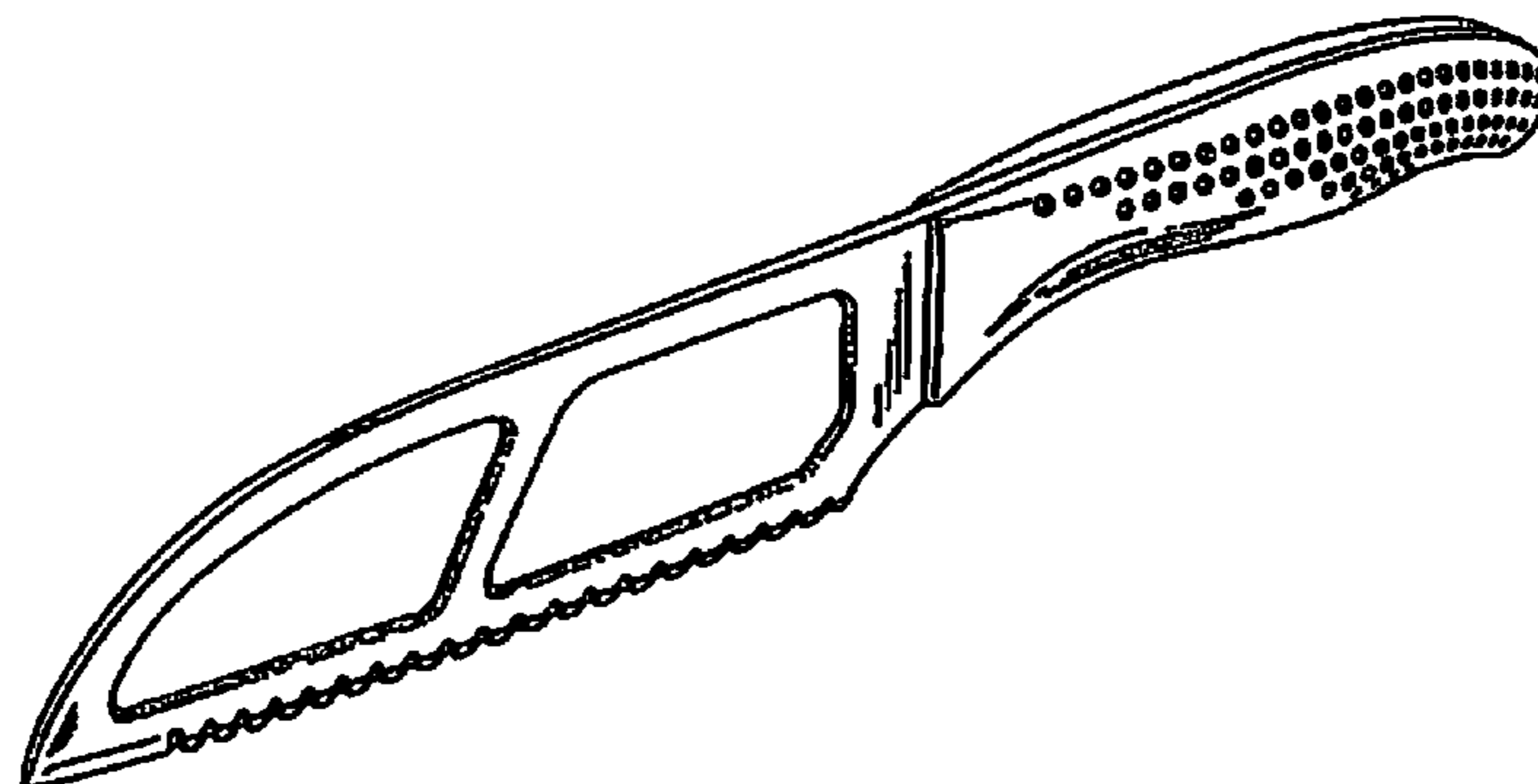


FIG. 8 is a bottom view of the knife blade with handle of FIG. 1.

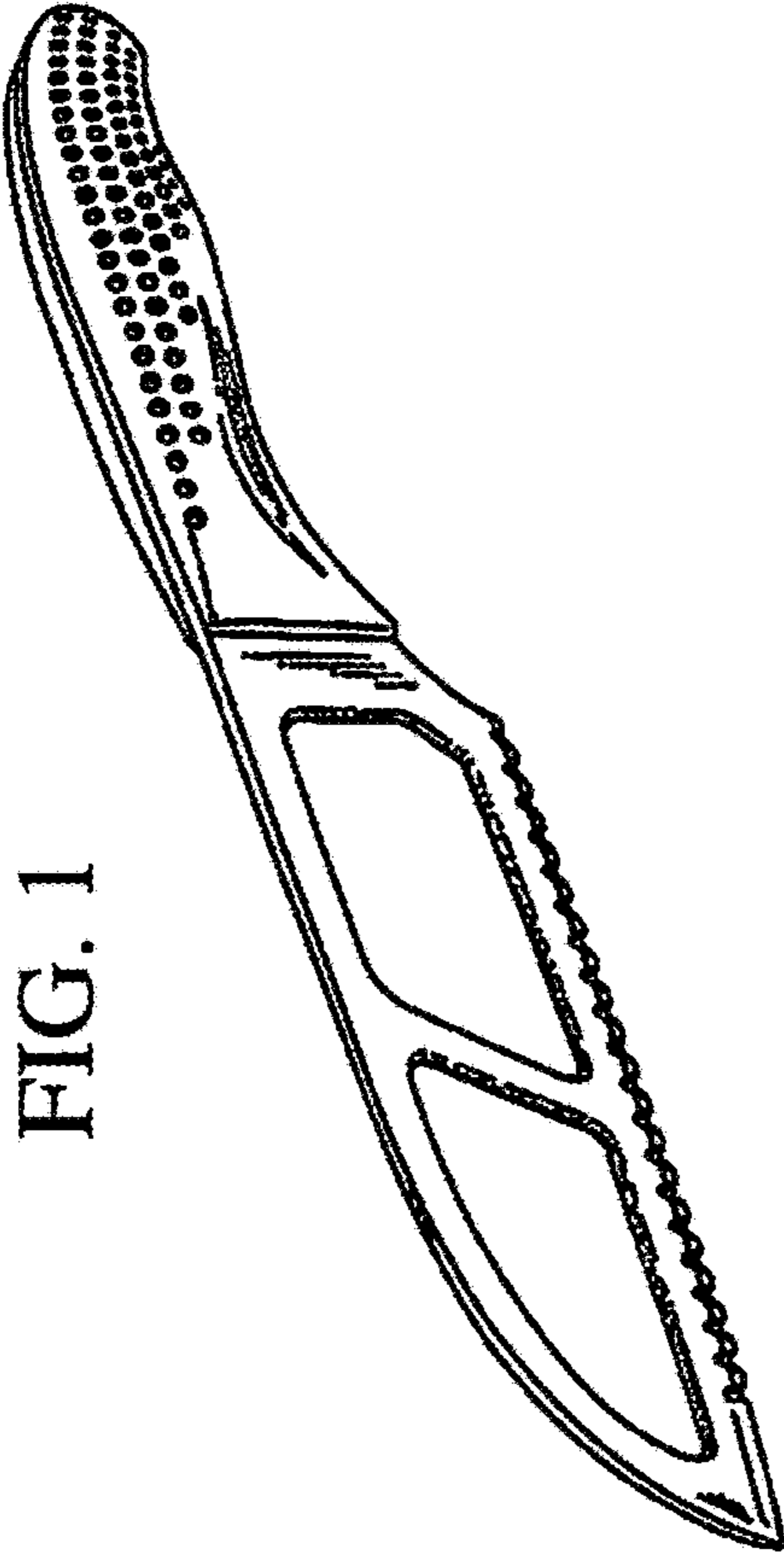

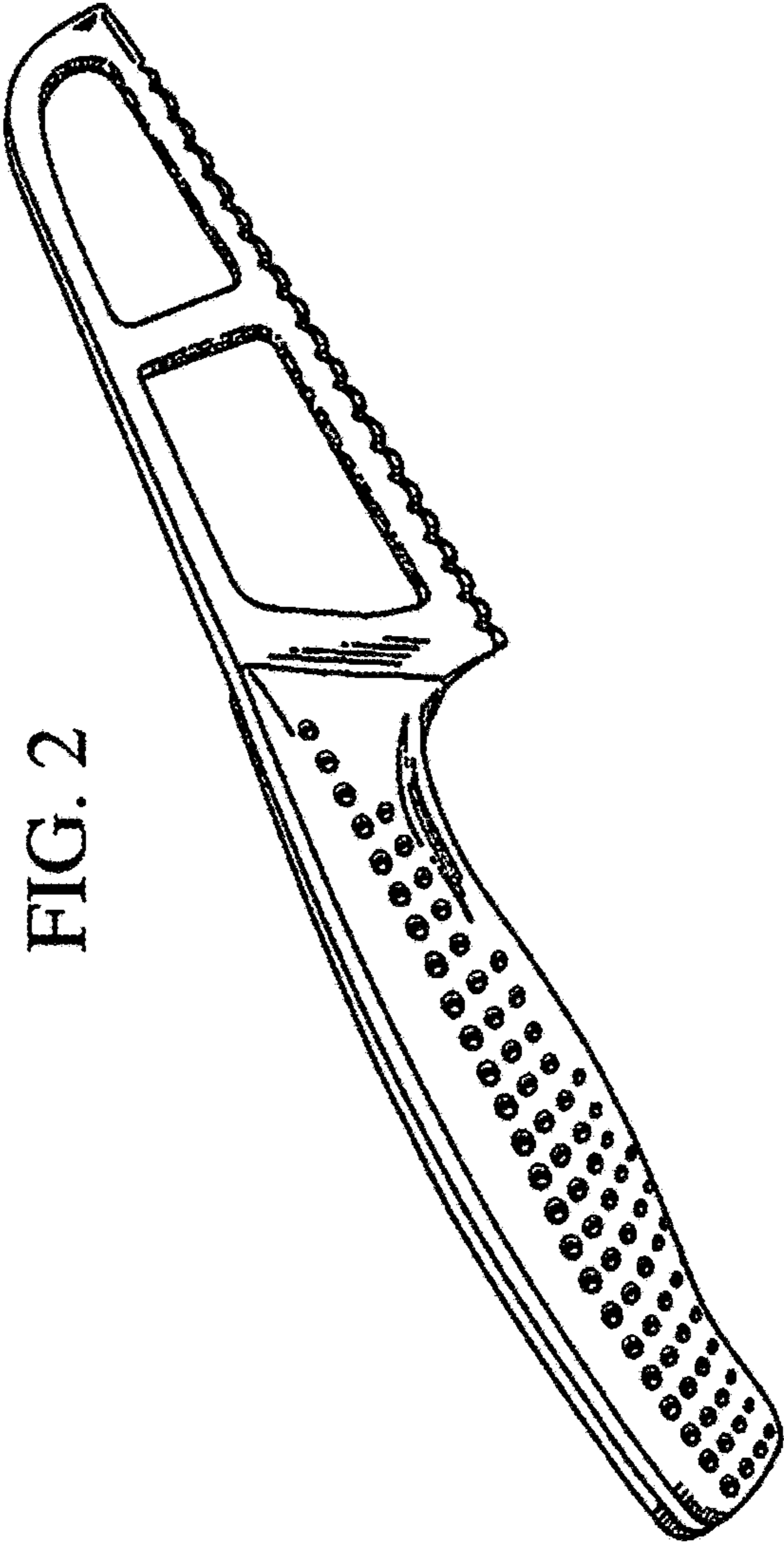

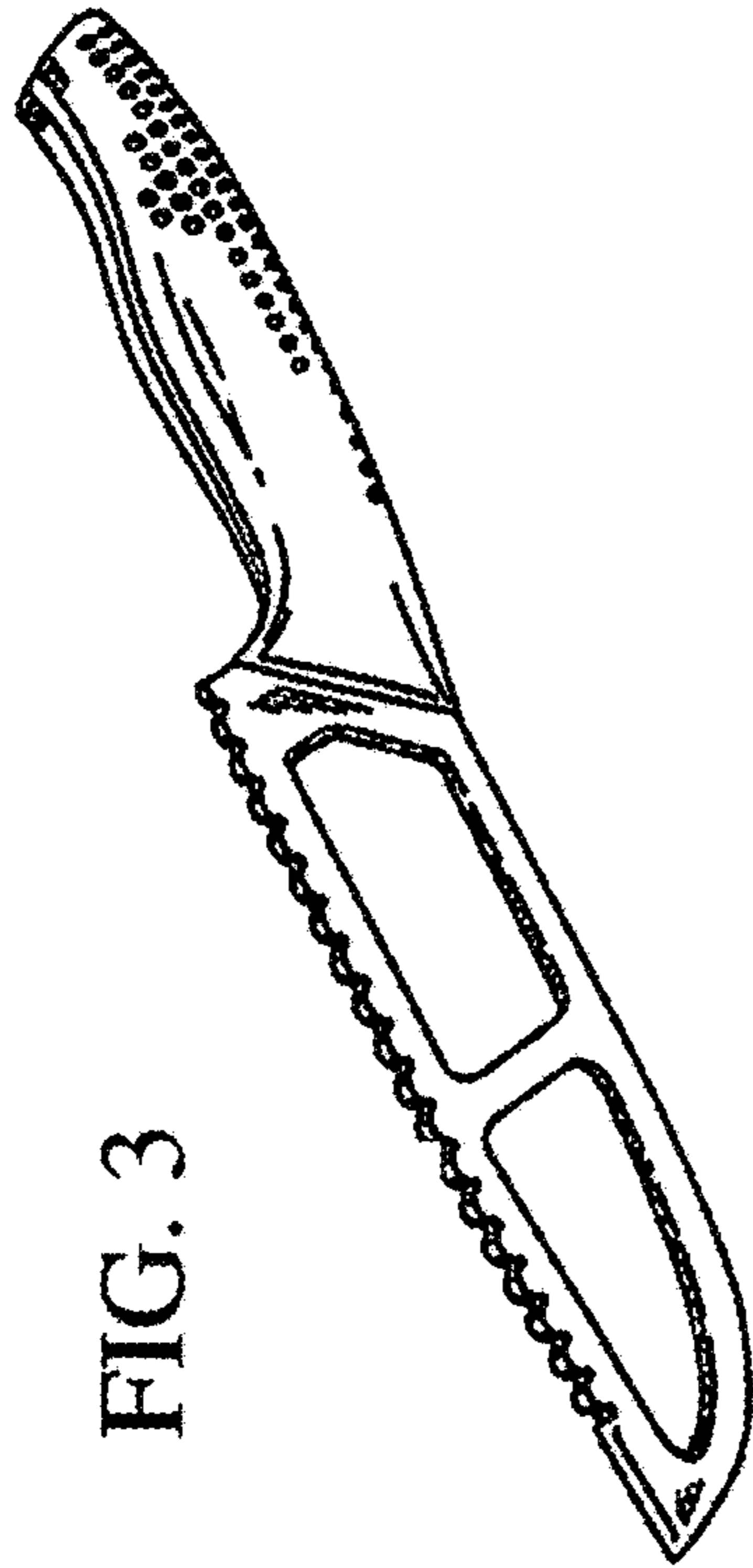

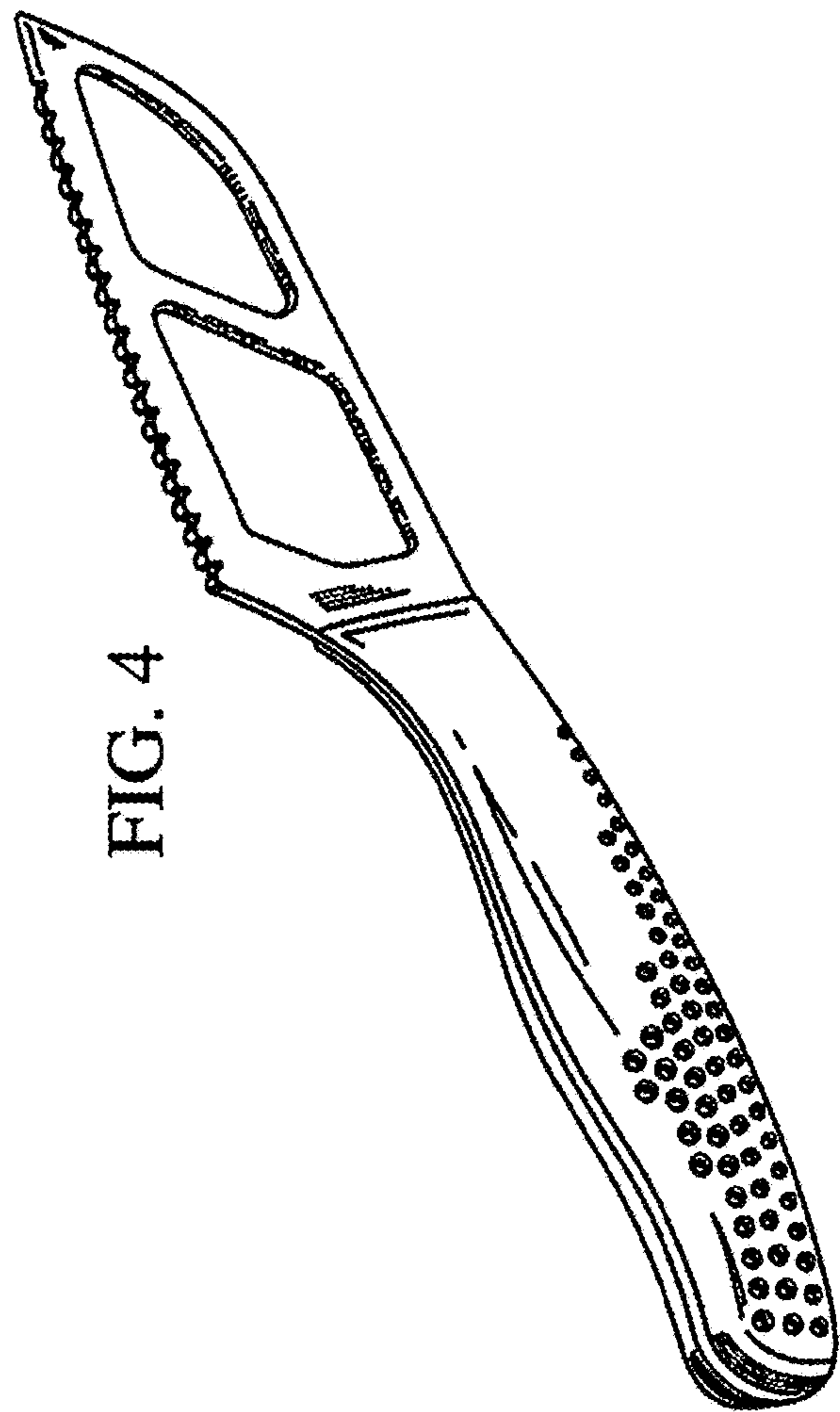

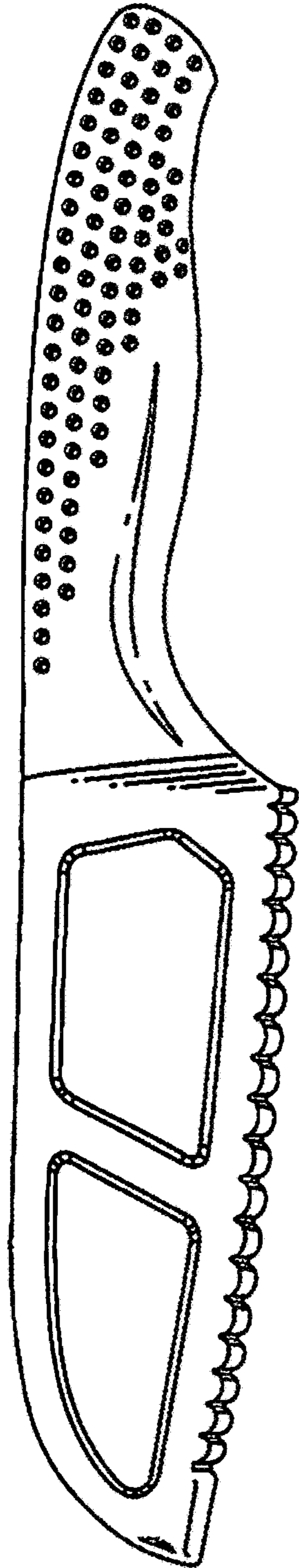

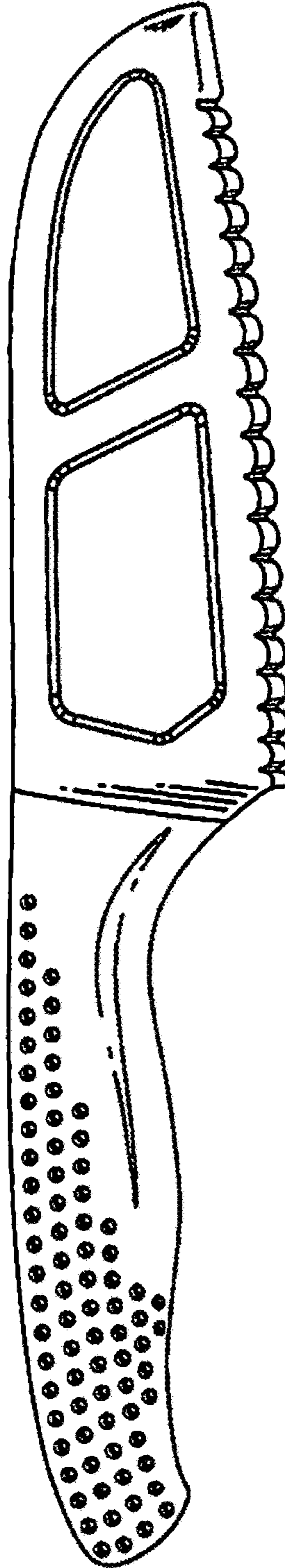

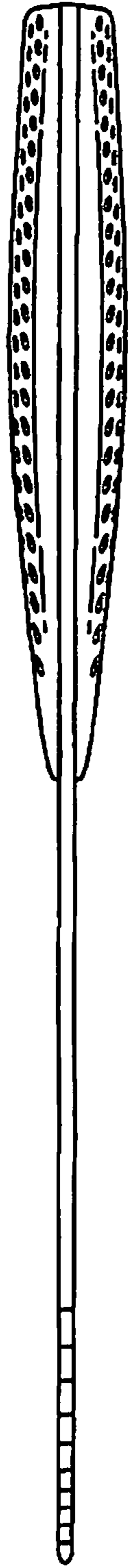

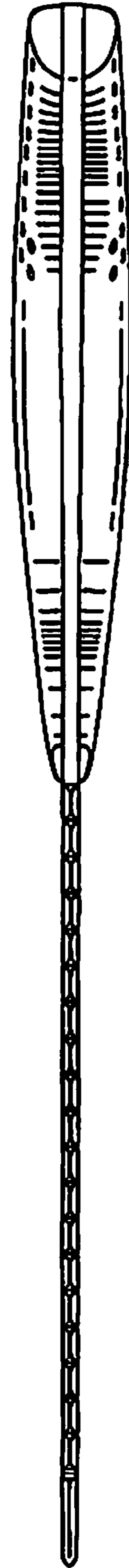

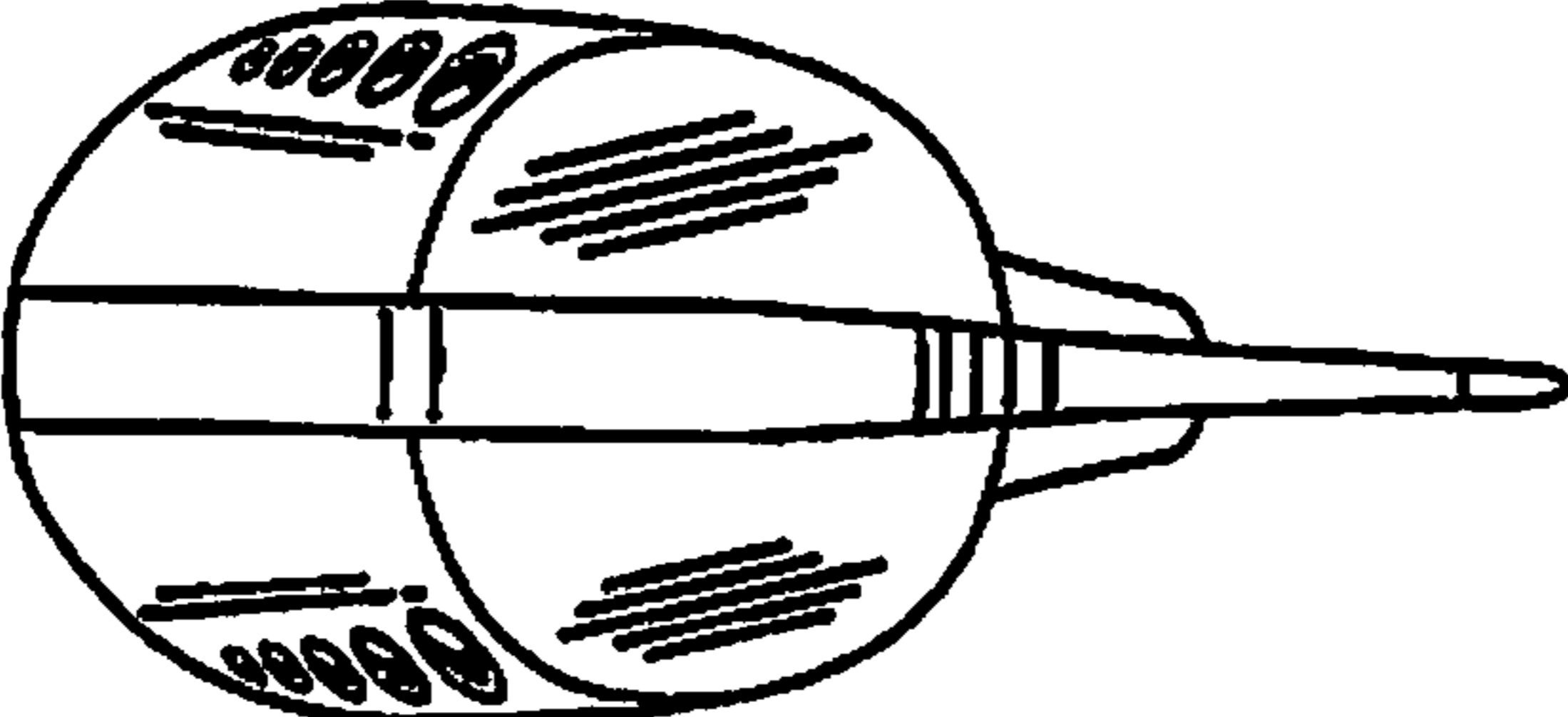
