(57) **CLAIM**

The ornamental design for a handle for a saw, as shown and described.

**DESCRIPTION**

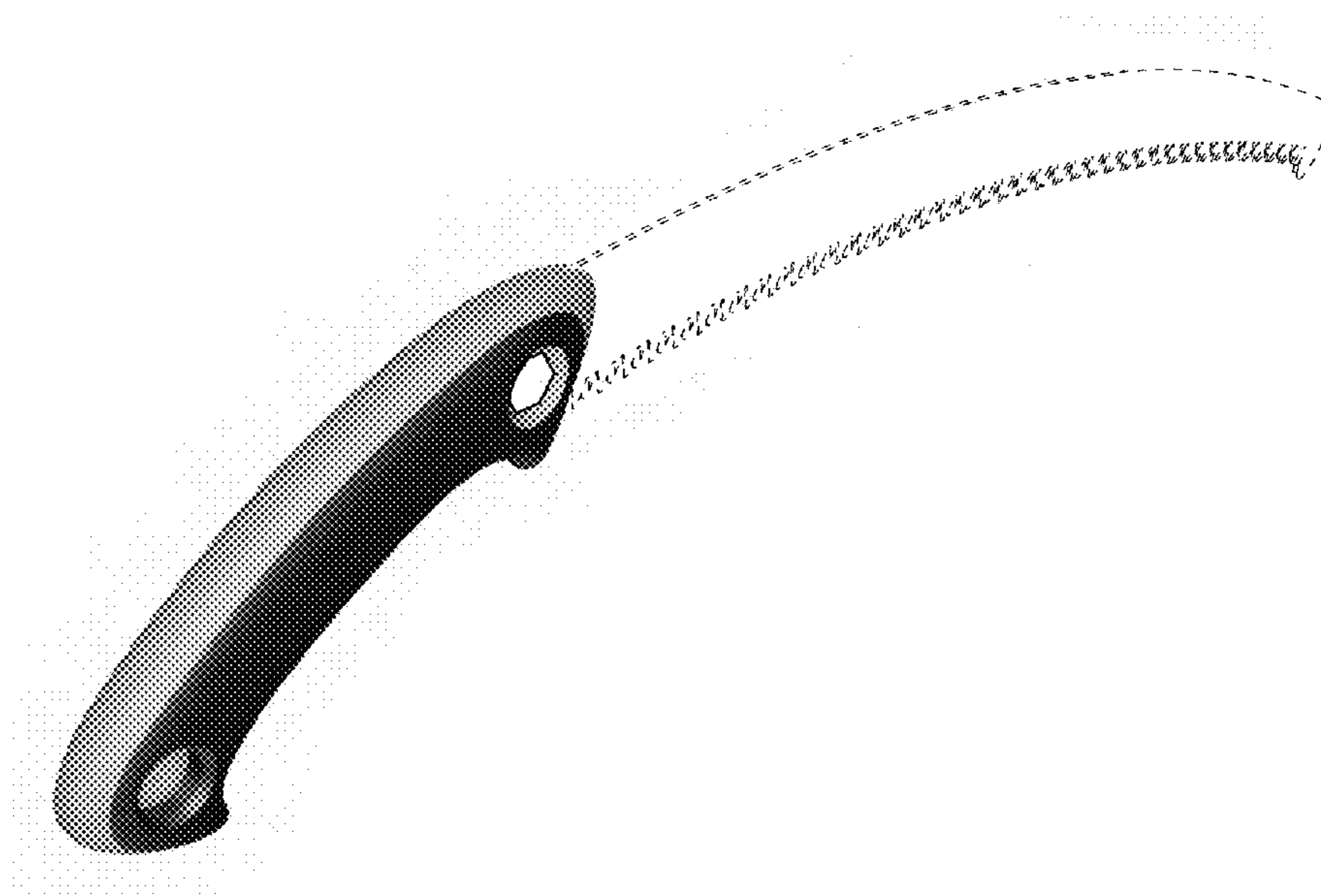

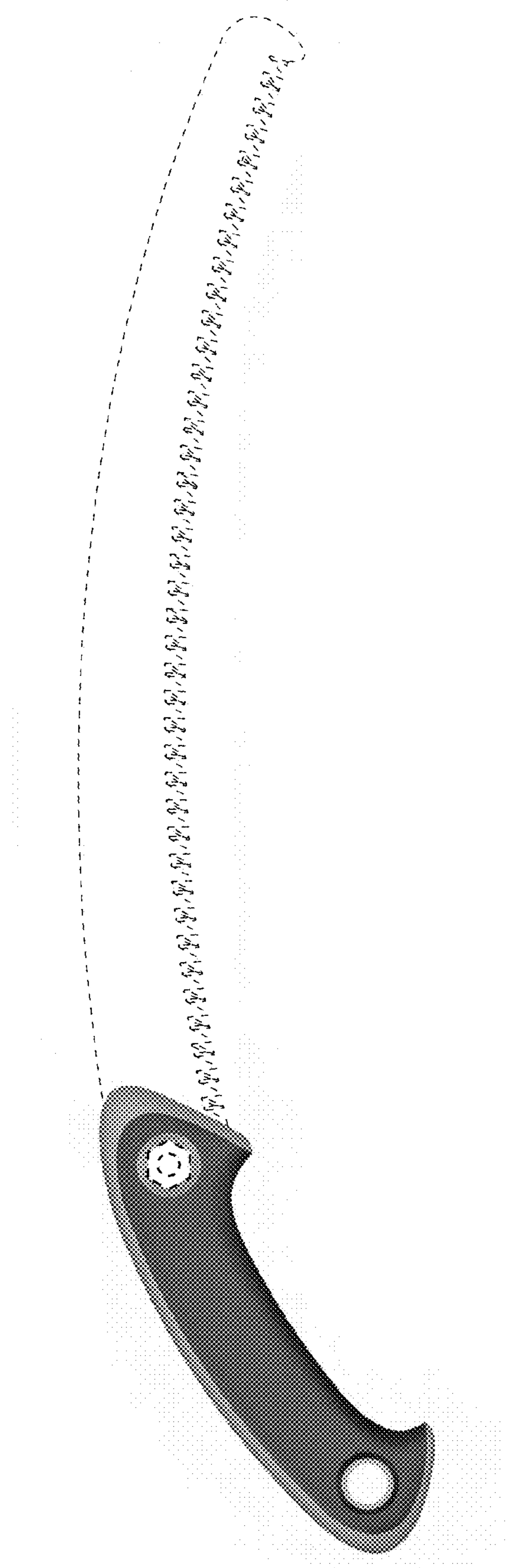

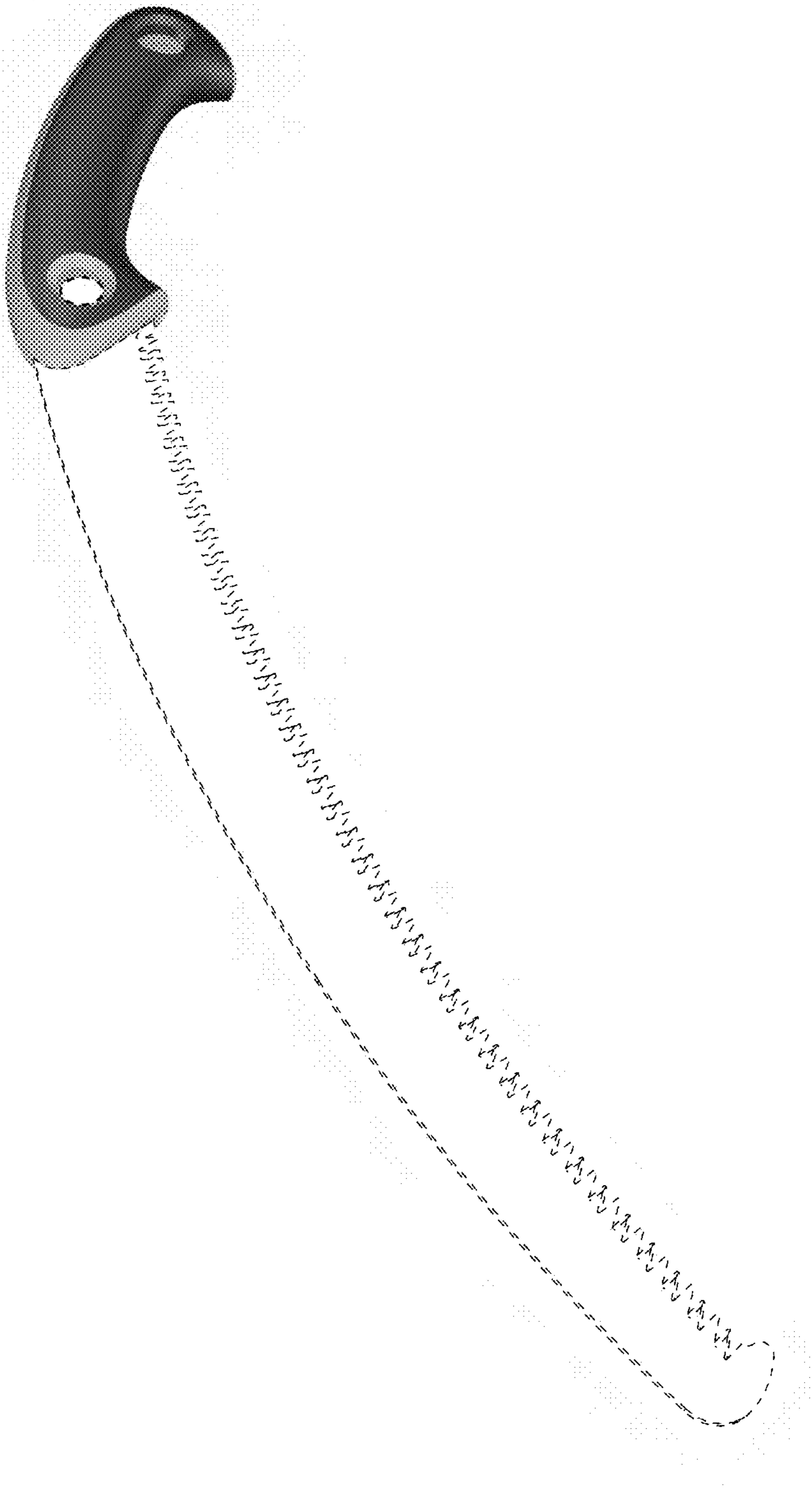

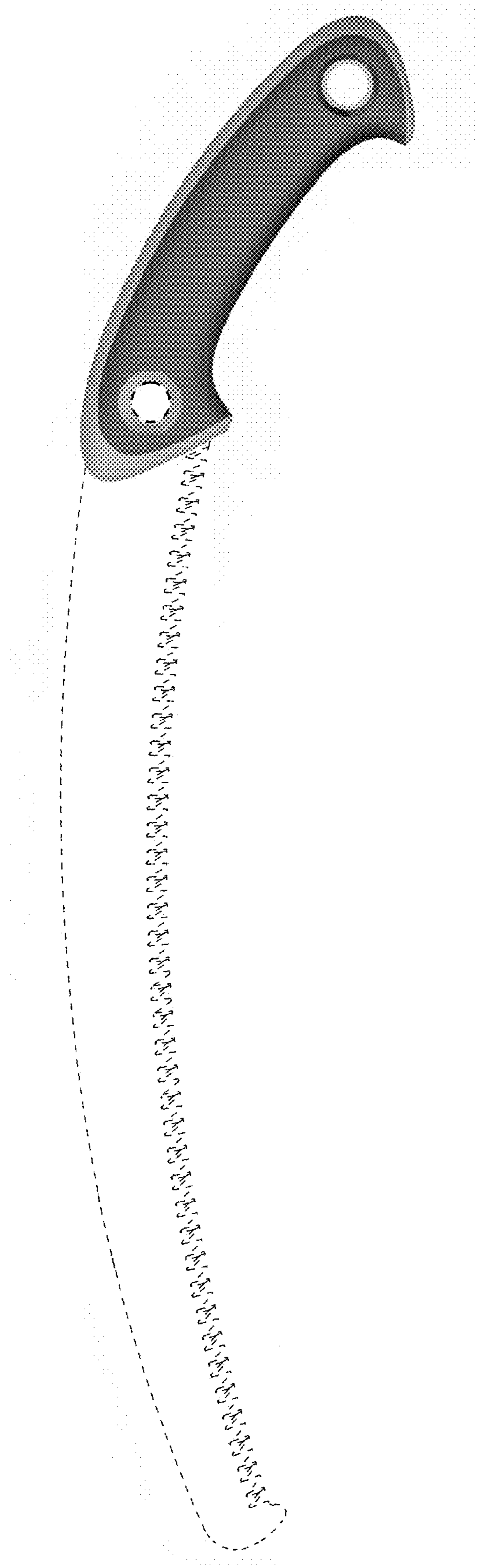

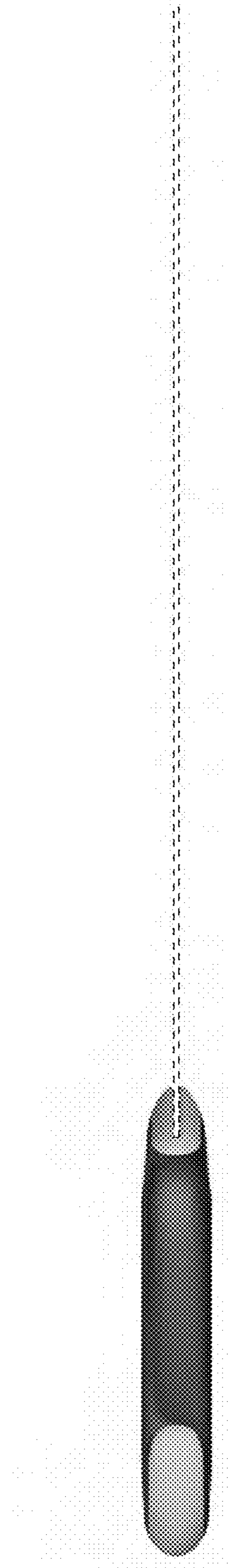

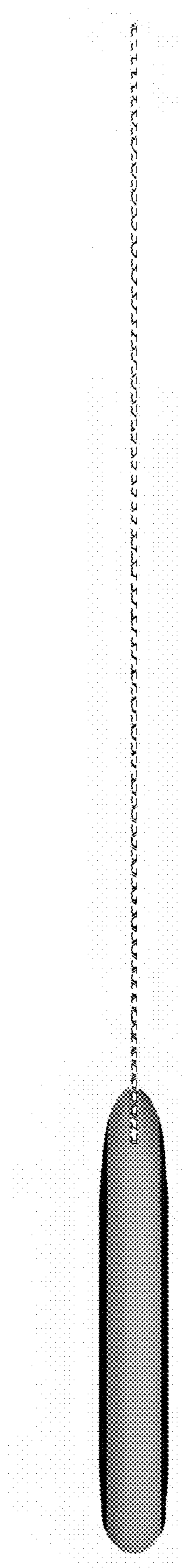

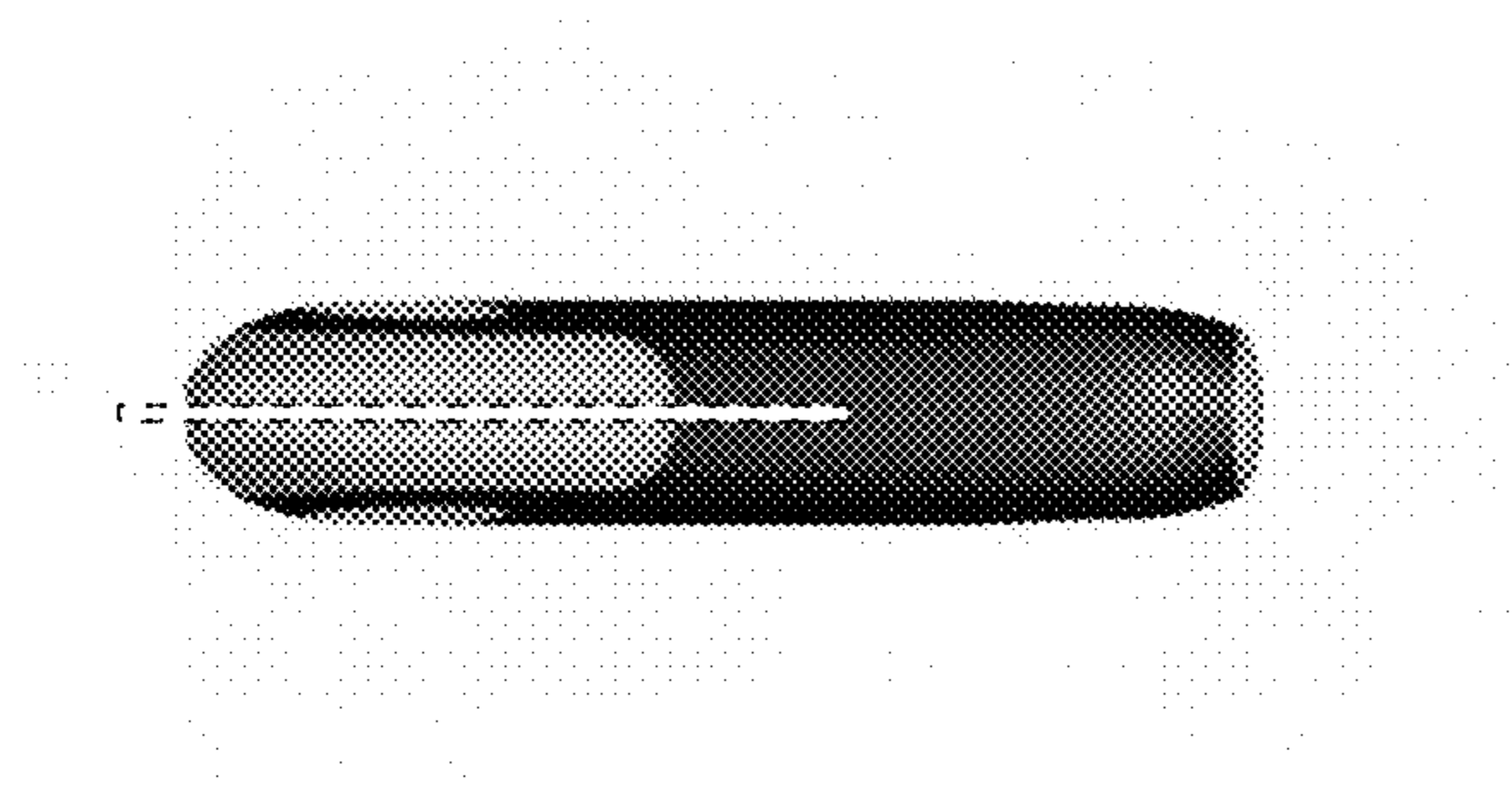
