The ornamental design for a carton, as shown and described.

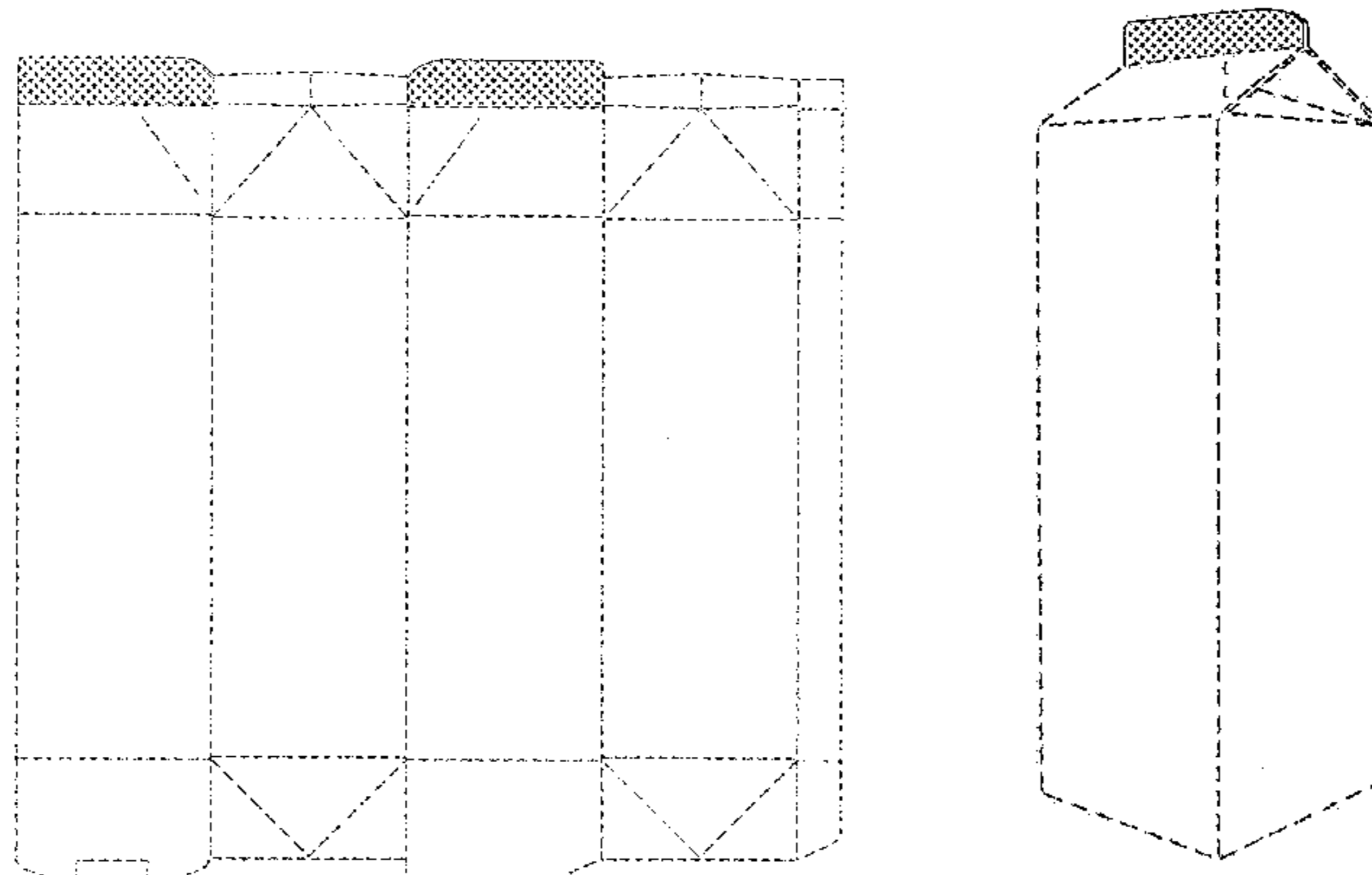
DESCRIPTION

FIG. 1 is a top plan view of a first embodiment of a carton showing my new design in an unfolded blank configuration; FIG. 2 is a top plan view of the carton of FIG. 1 in a partially assembled configuration; FIG. 3 is bottom plan view of the carton of FIG. 1 in a partially assembled configuration; FIG. 4 is a front perspective view of the carton of FIG. 1 in a fully assembled configuration; FIG. 5 is a rear perspective view thereof; FIG. 6 is a front elevation view thereof; FIG. 7 is a rear elevation view thereof; FIG. 8 is a side elevation view thereof; FIG. 9 is another side elevation view thereof; FIG. 10 is a top plan view of a second embodiment of an unfolded carton showing my new design in an unfolded blank configuration; FIG. 11 is a top plan view of the carton of FIG. 10 in a partially assembled configuration; FIG. 12 is a bottom plan view of the carton of FIG. 10 in a partially assembled configuration; FIG. 13 is a front perspective view of the carton of FIG. 10 in a fully assembled configuration; FIG. 14 is a rear perspective view thereof; FIG. 15 is a front elevation view thereof; FIG. 16 is a rear elevation view thereof; FIG. 17 is a side elevation view thereof; and, FIG. 18 is another side elevation view thereof. The broken lines in the drawings represent portions of the carton that form no part of the claimed design.

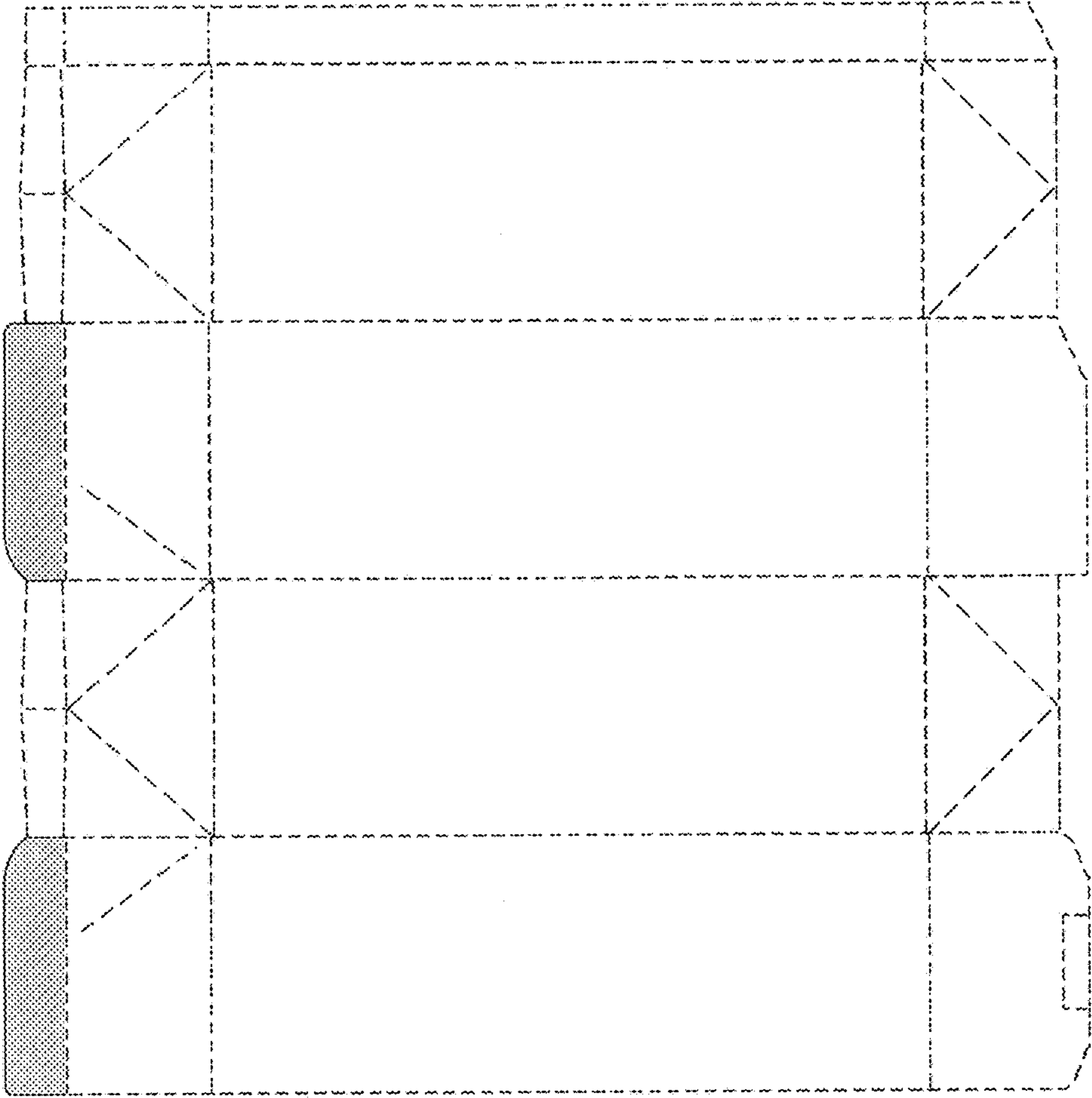

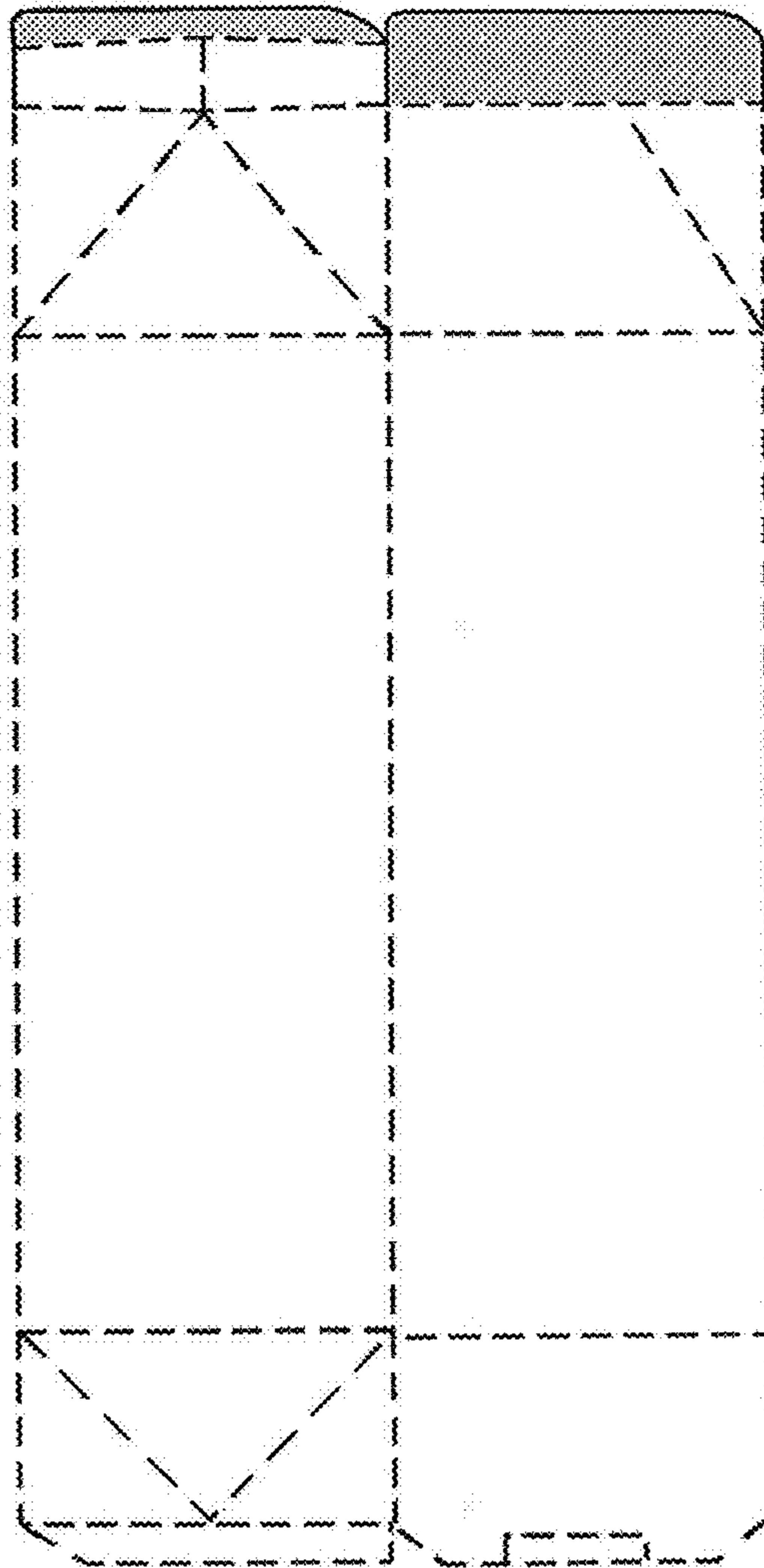

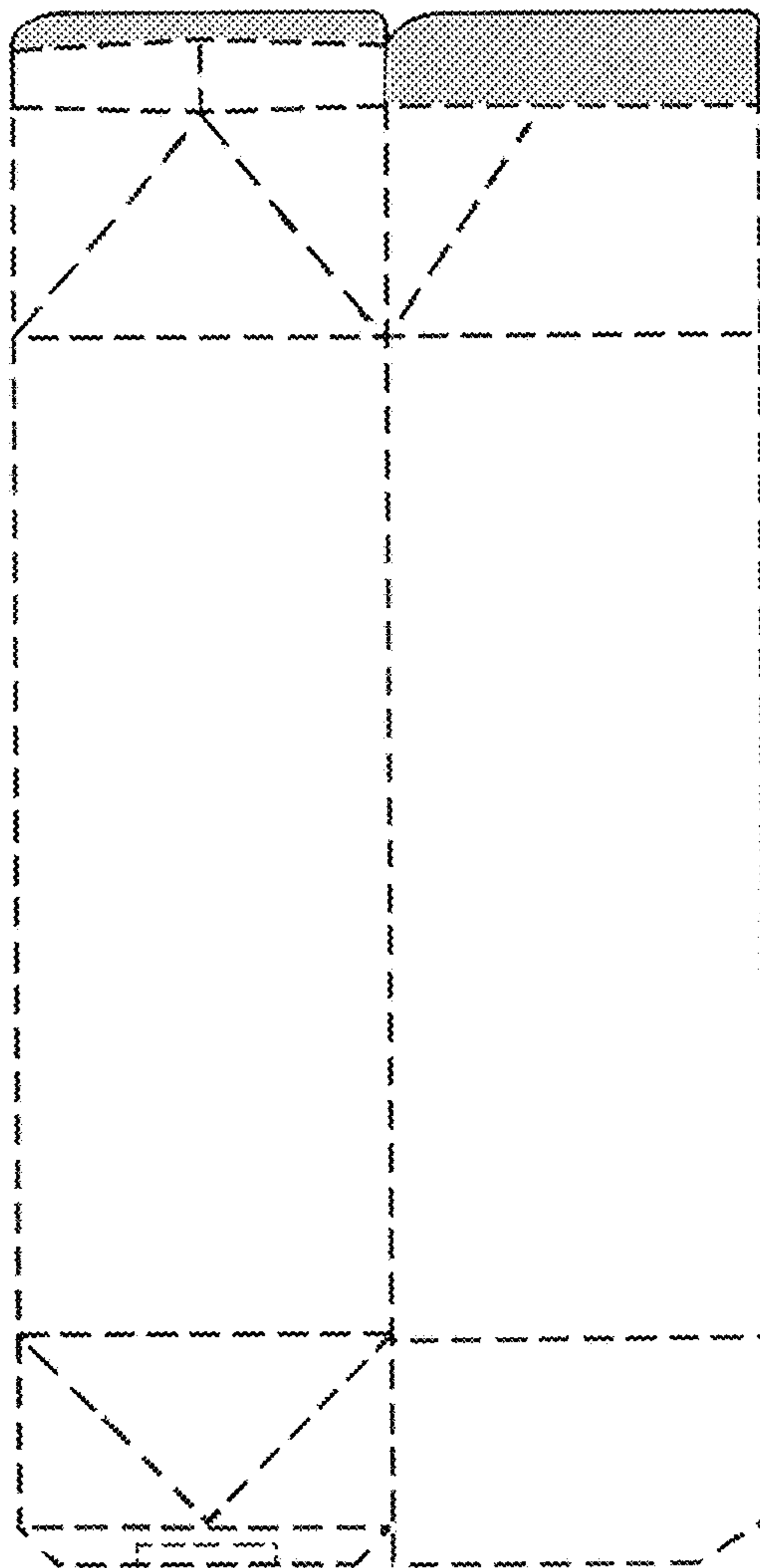

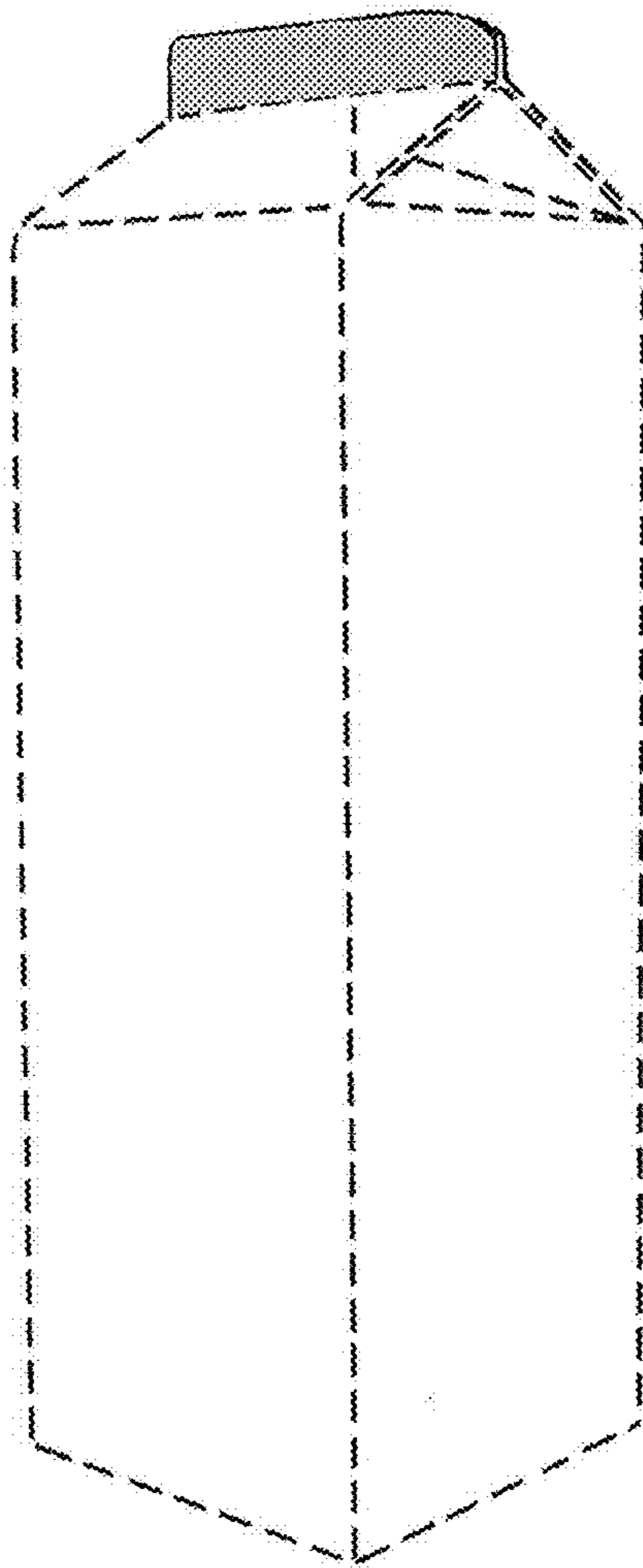

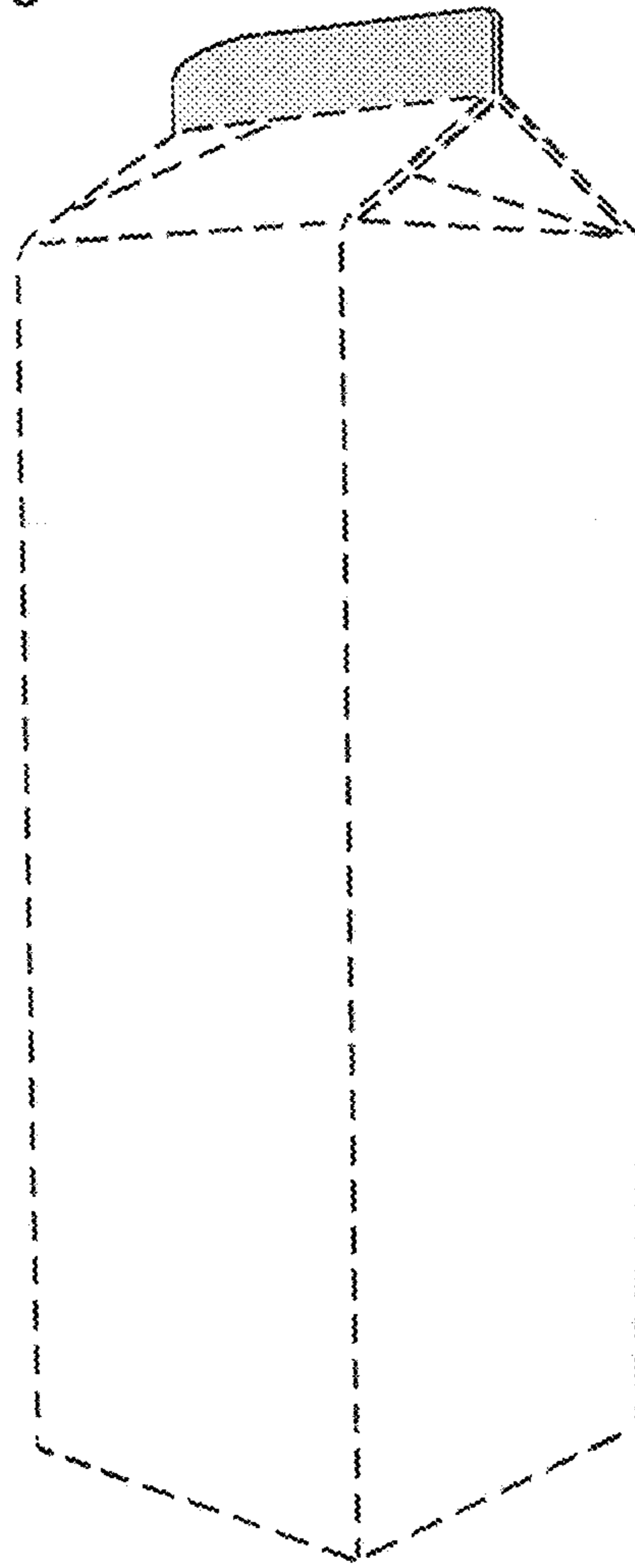

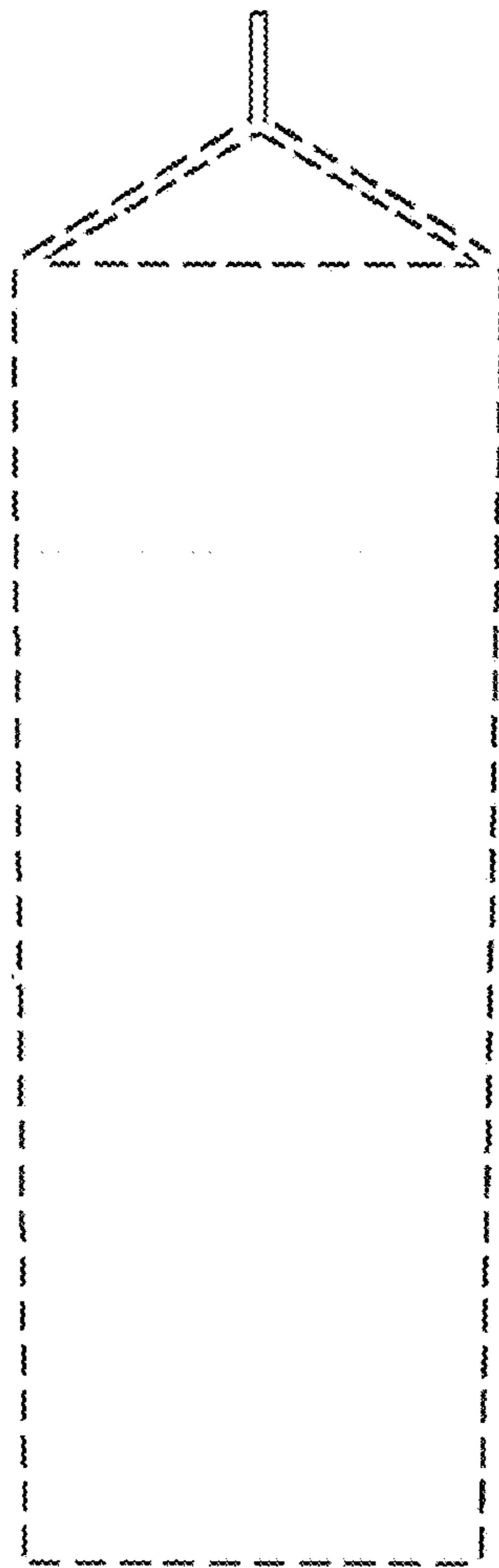

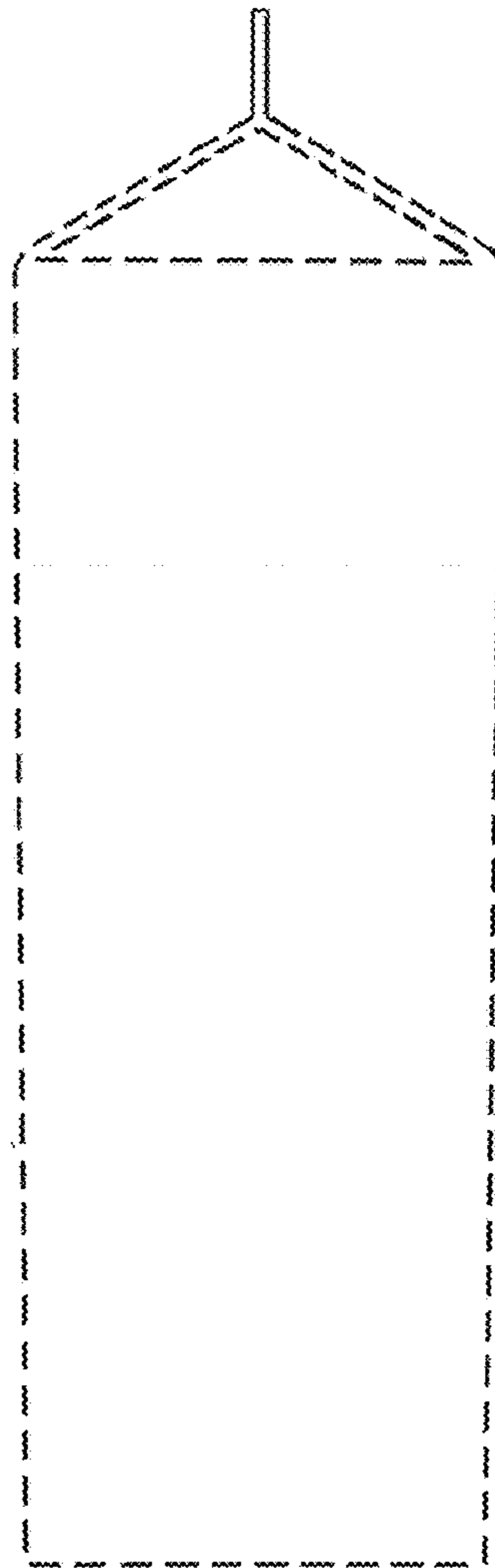

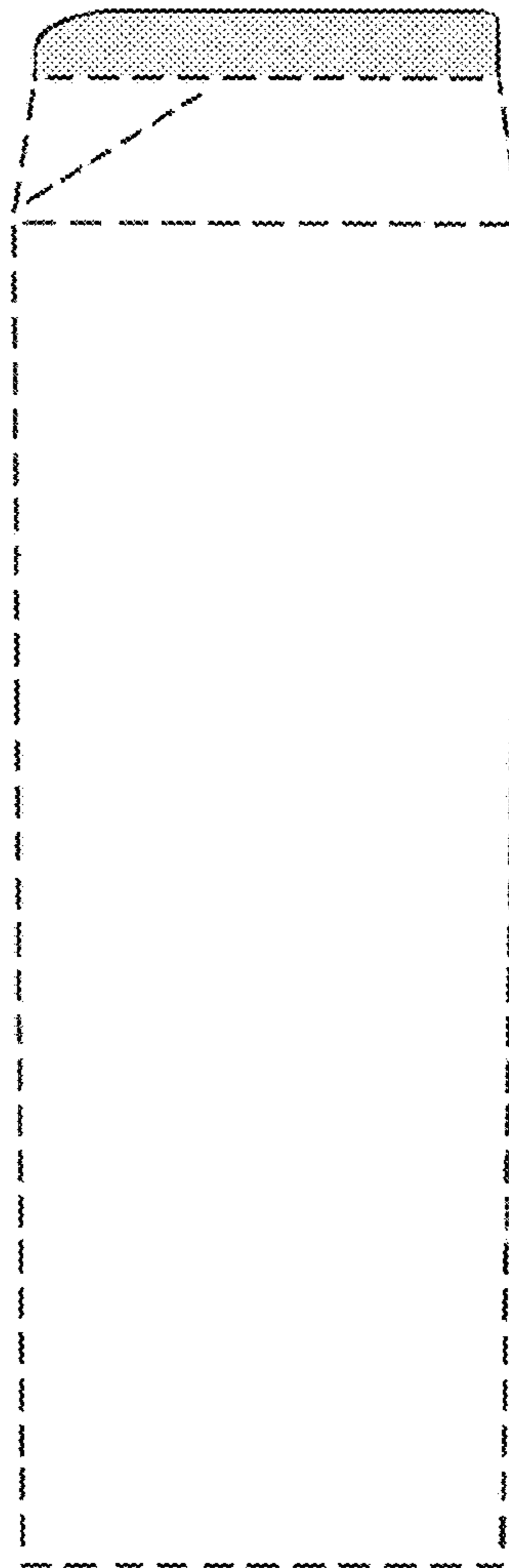

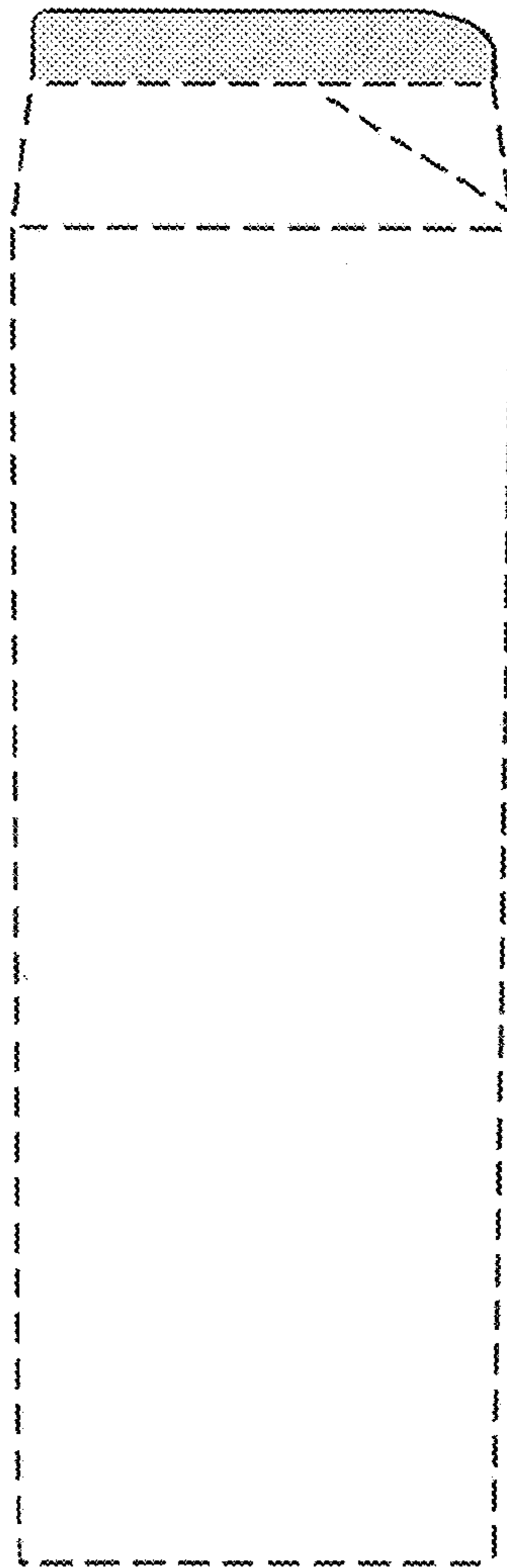

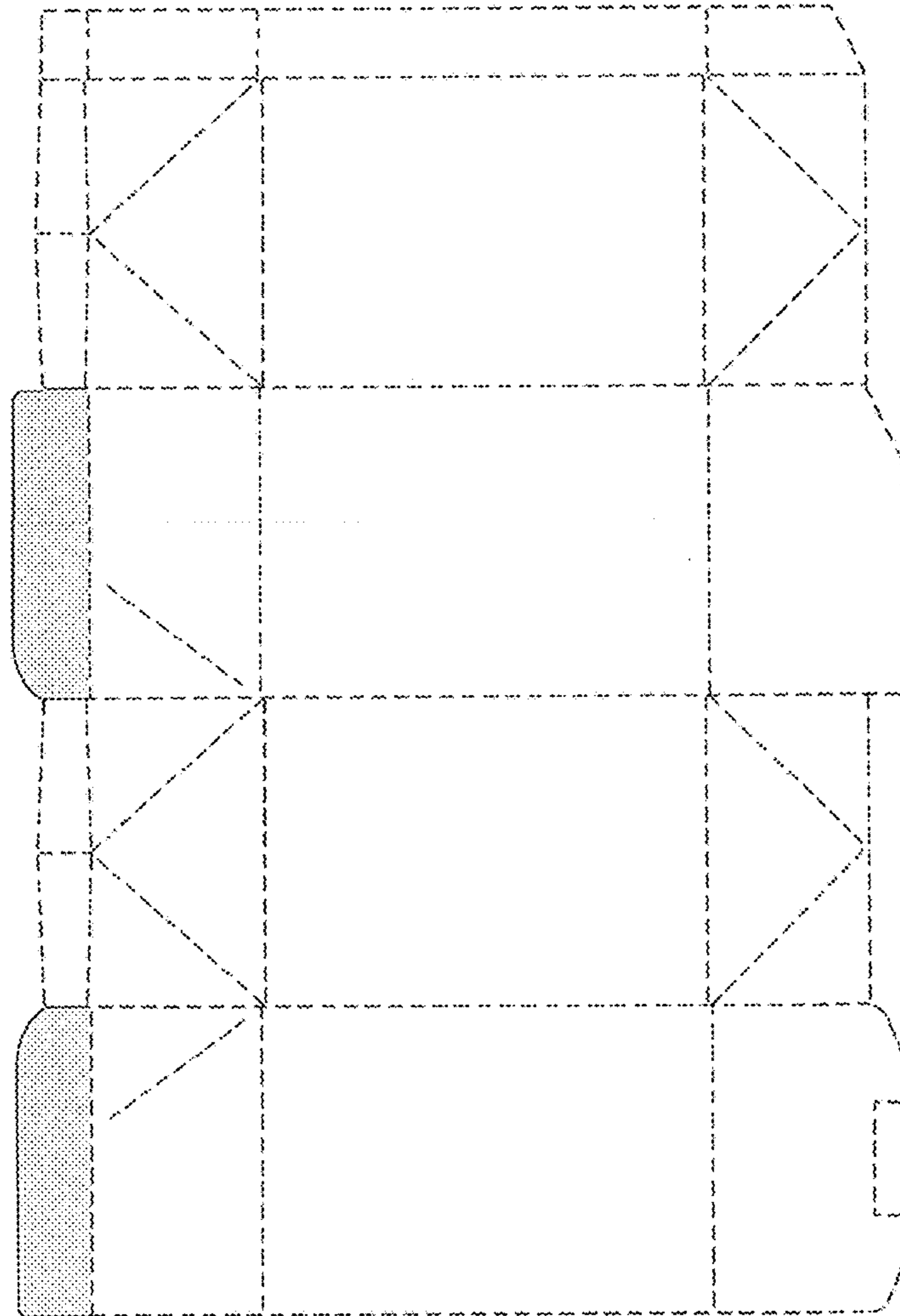

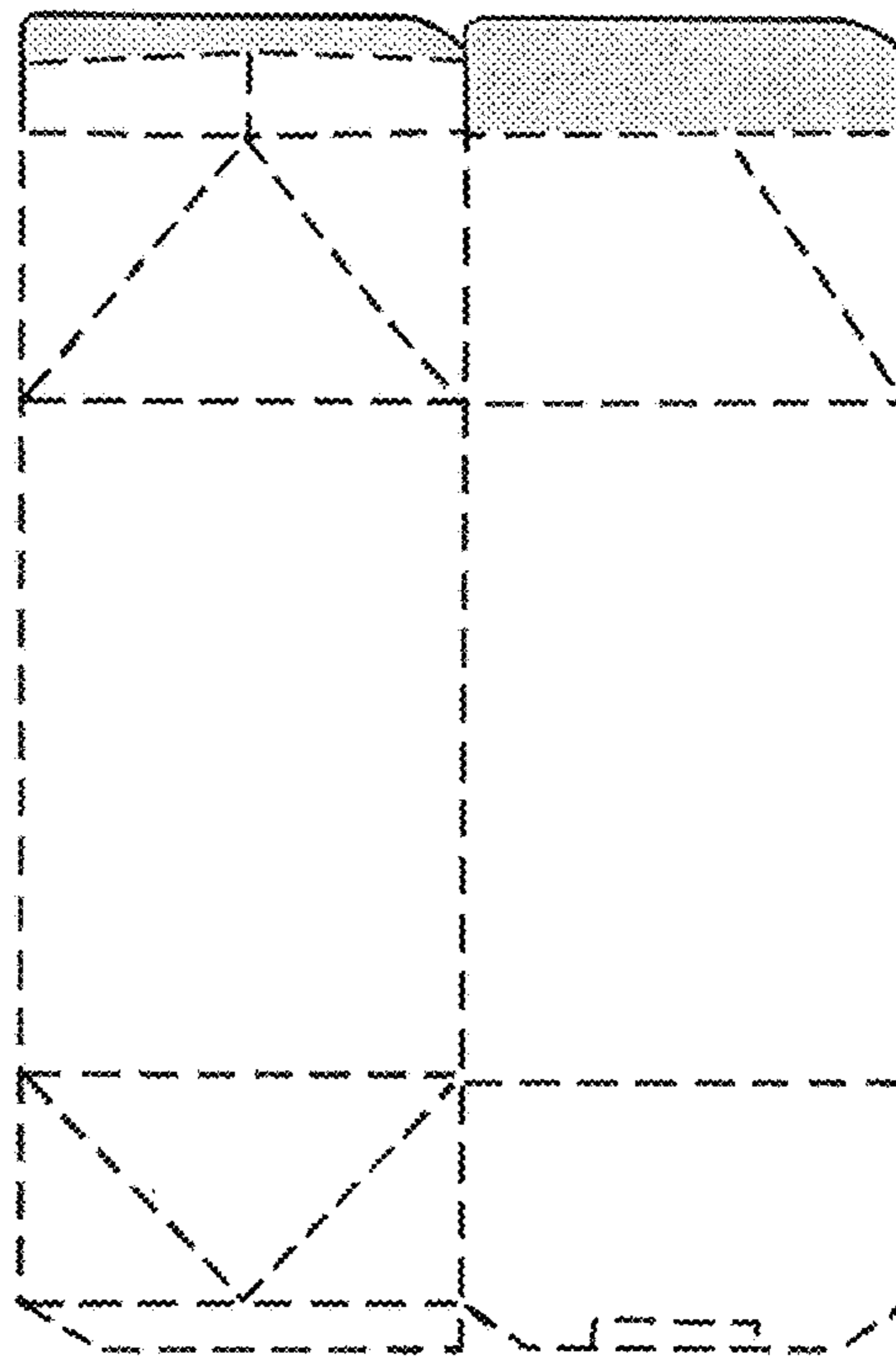

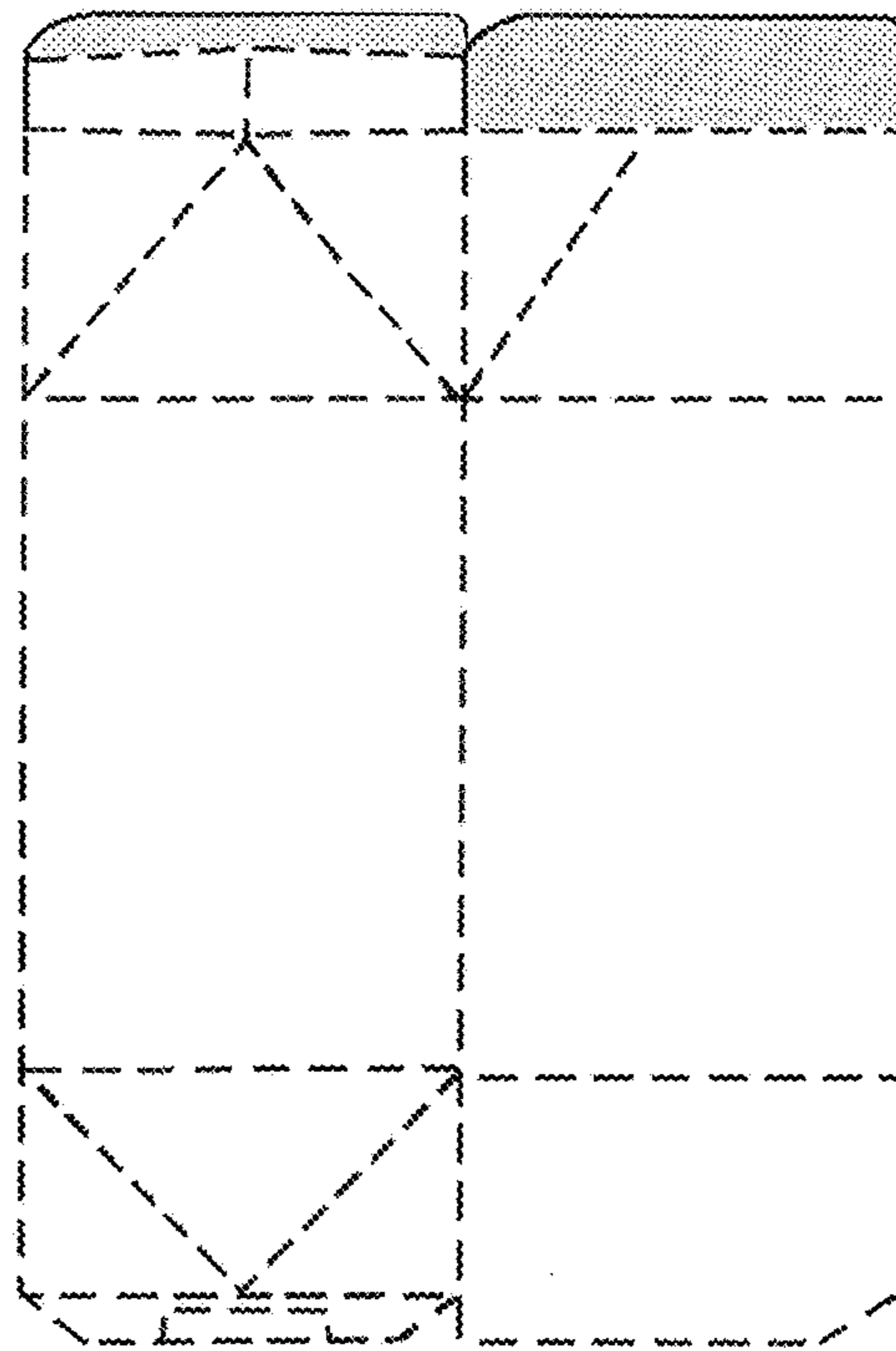

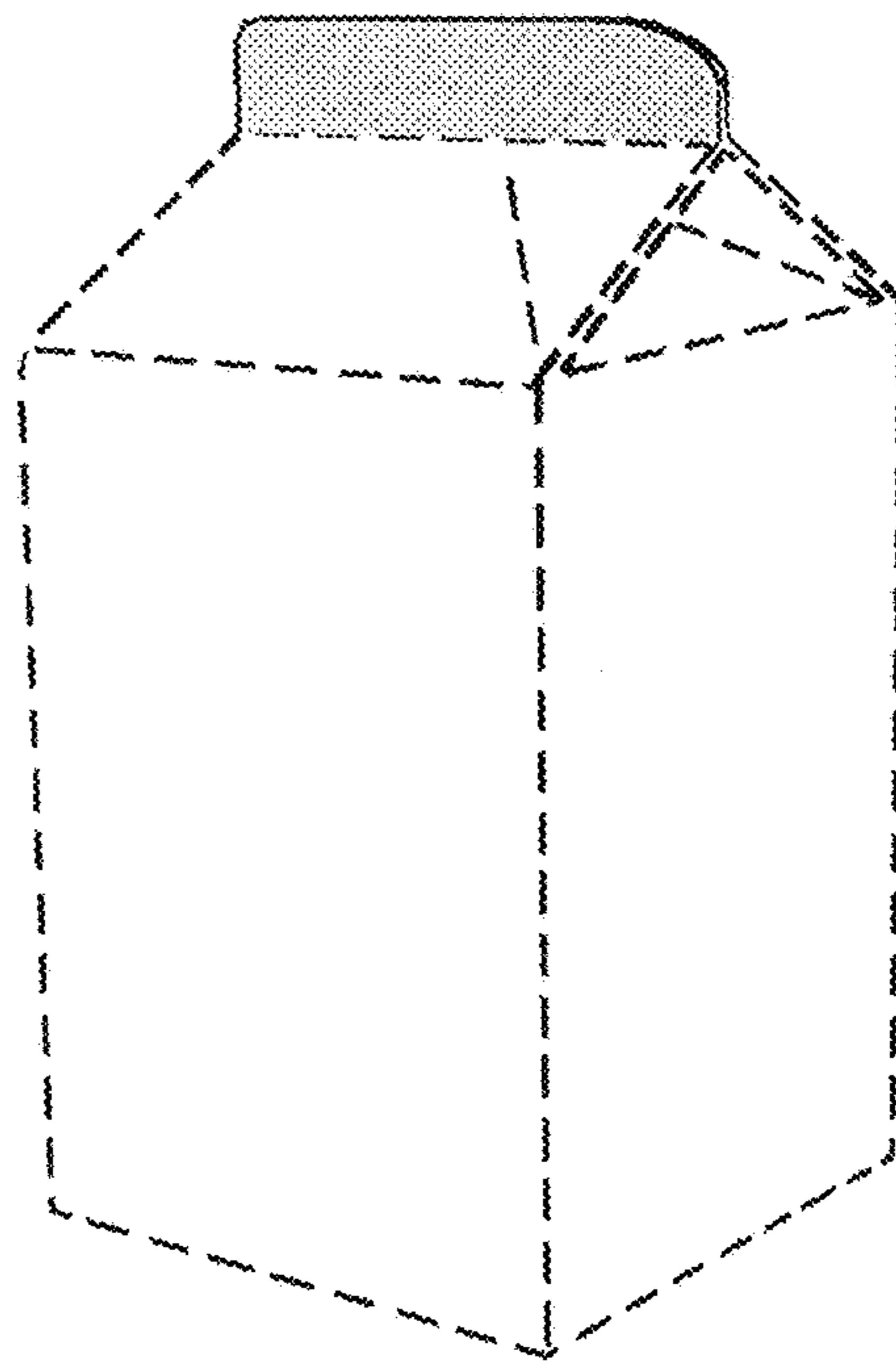

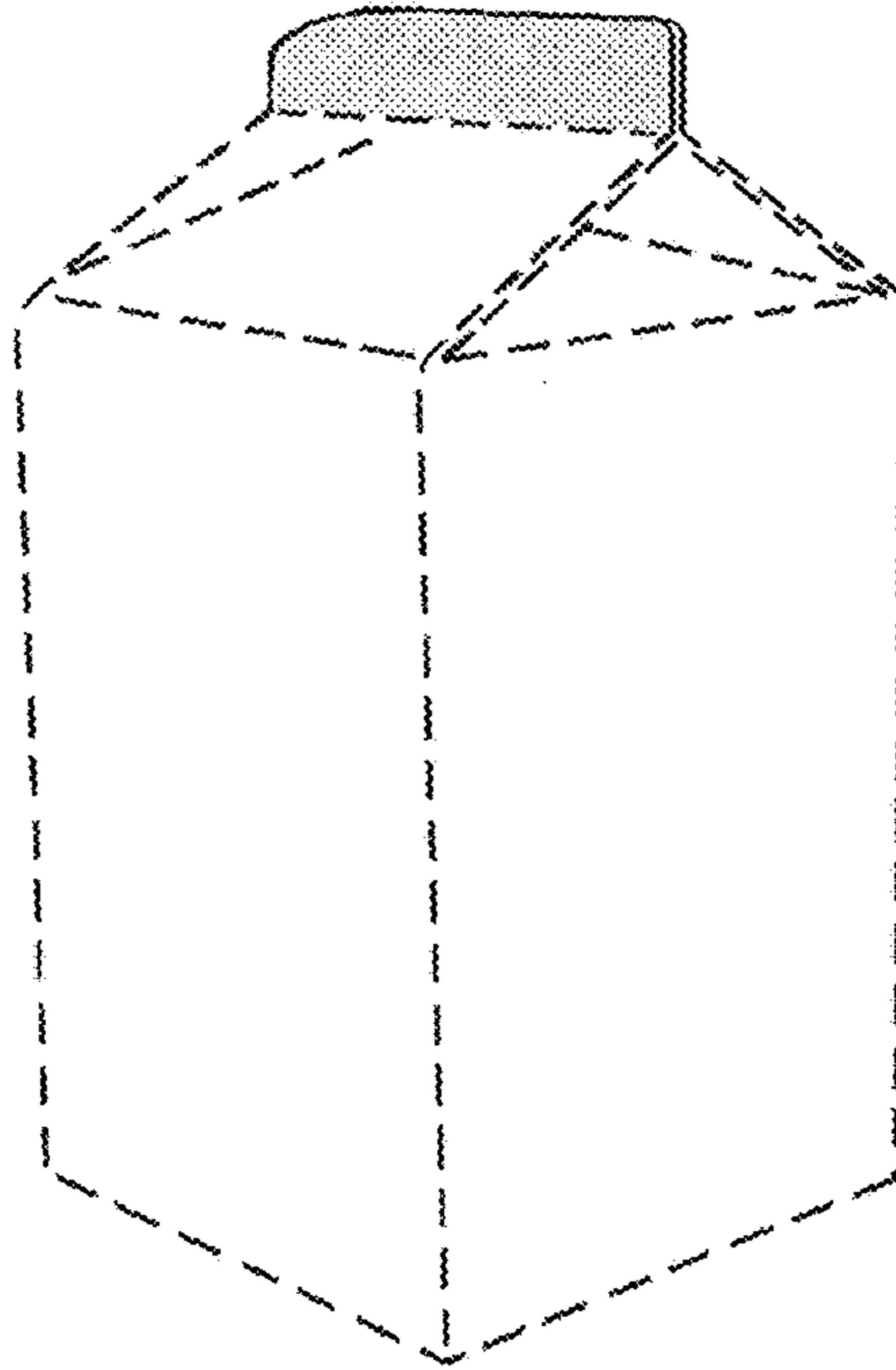

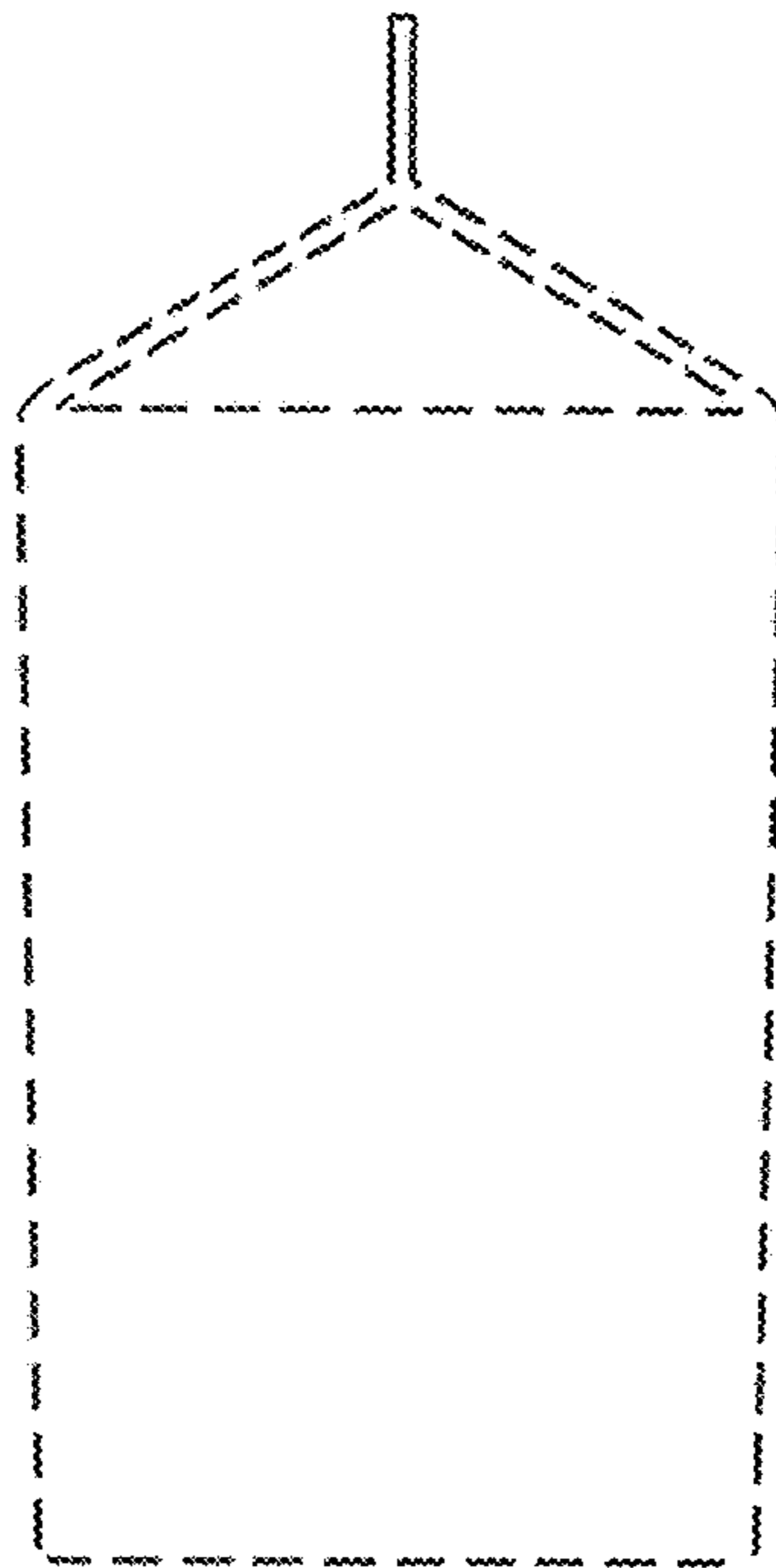

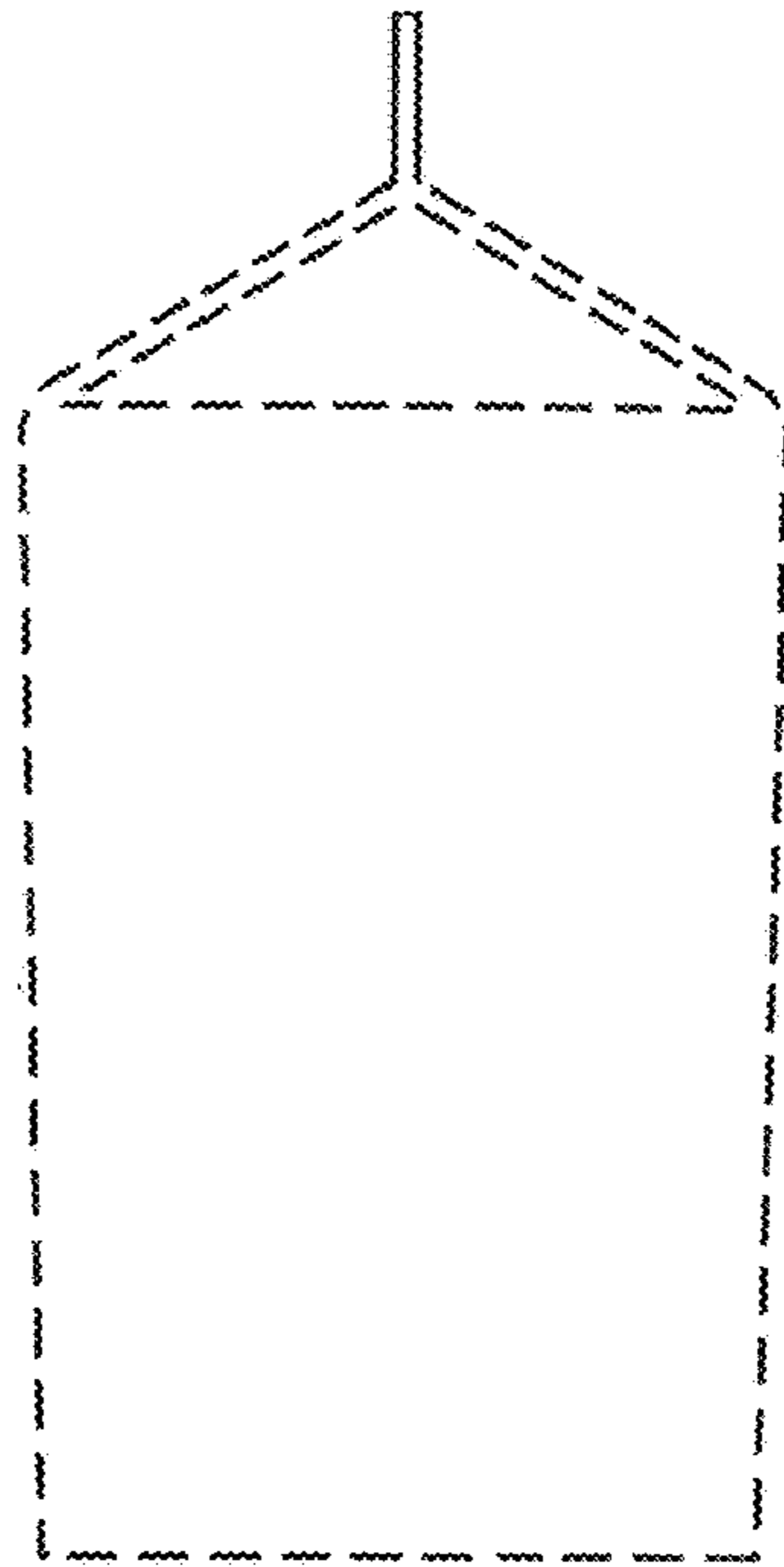

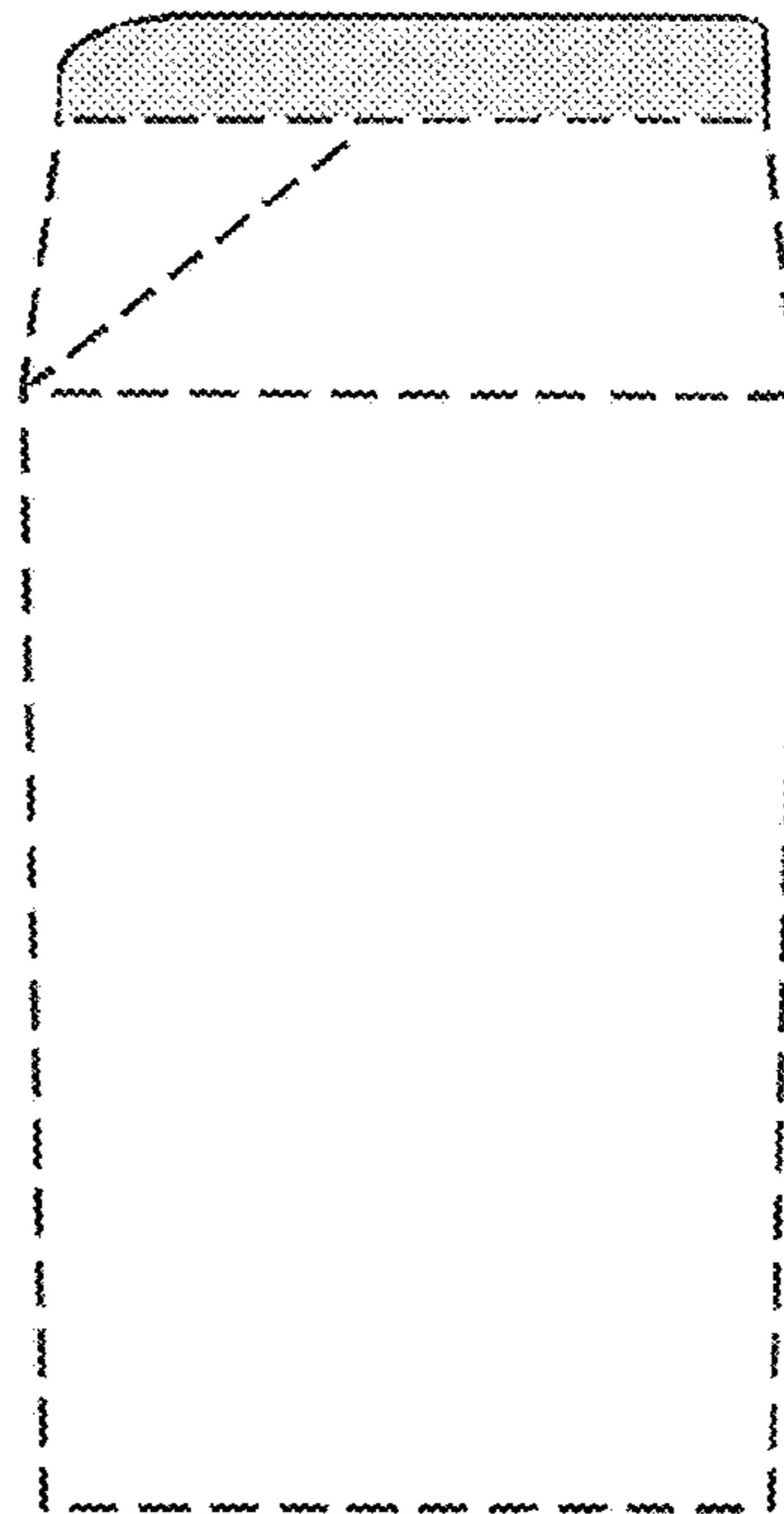
