FIG. 1 is a top, side perspective view of my new design for a cosmetic bottle;

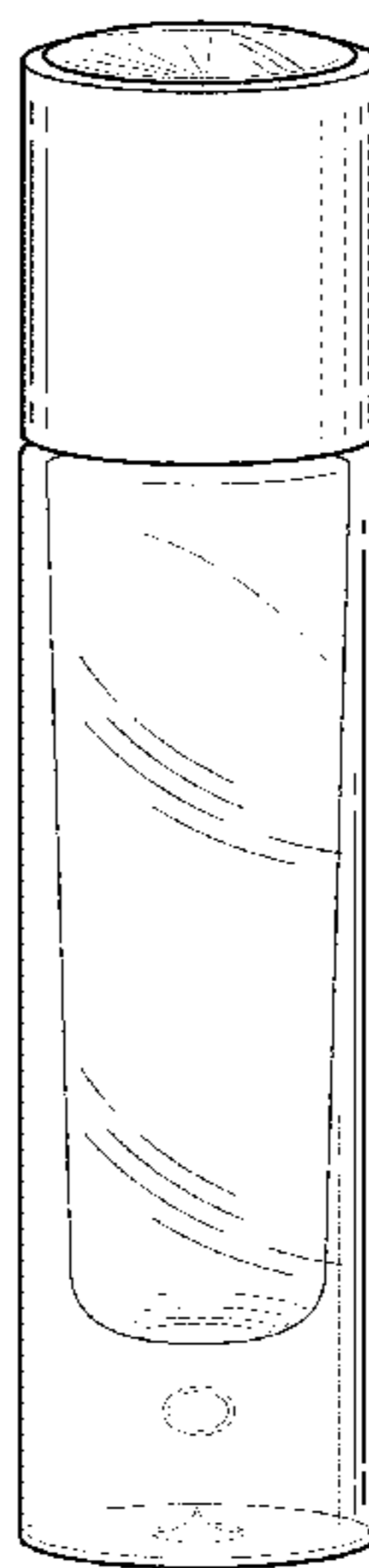
FIG. 2 is a side elevation view of the cosmetic bottle, shown in FIG. 1;

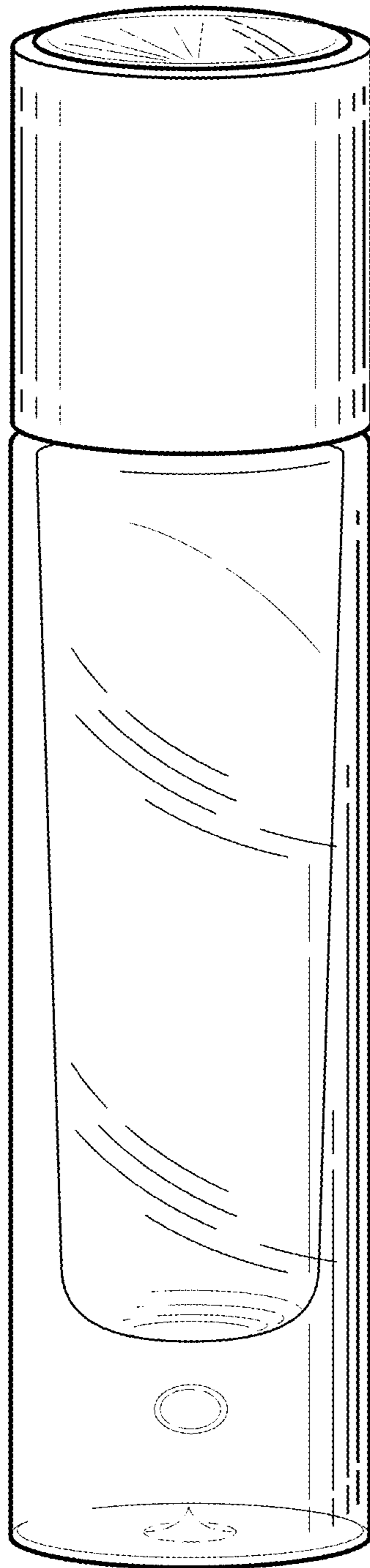

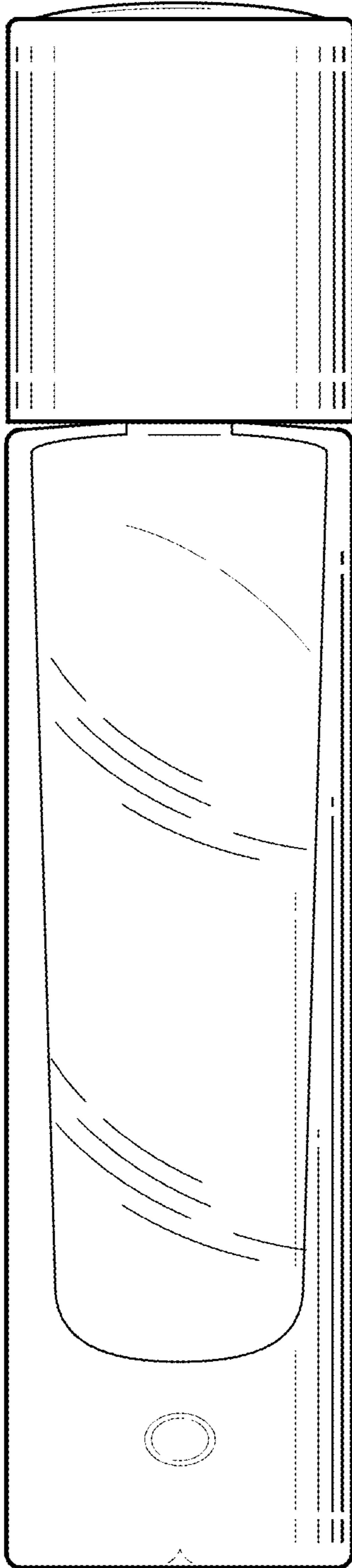

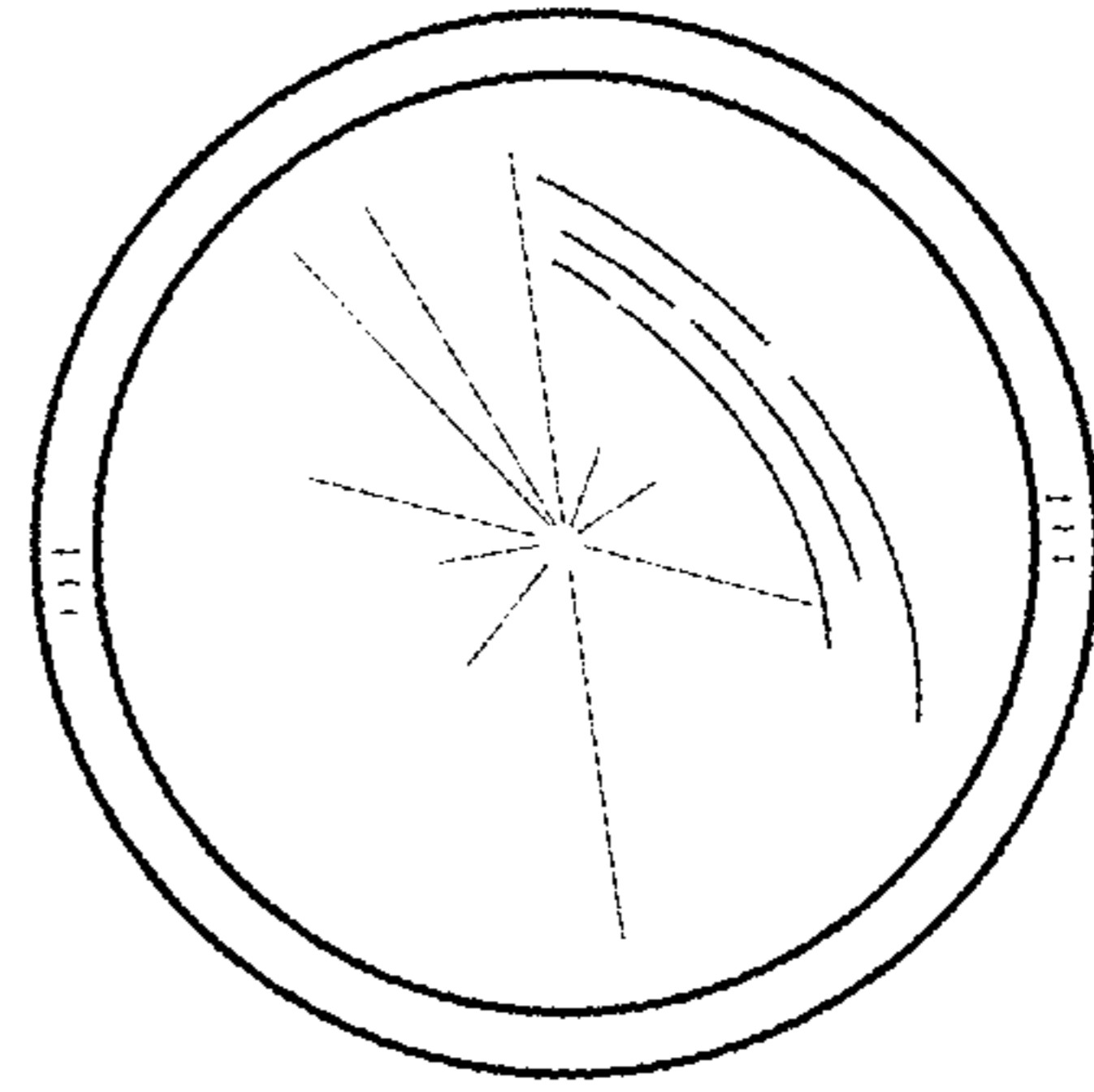
