The broken lines illustrate portions of the bottle and form no part of the claimed design.

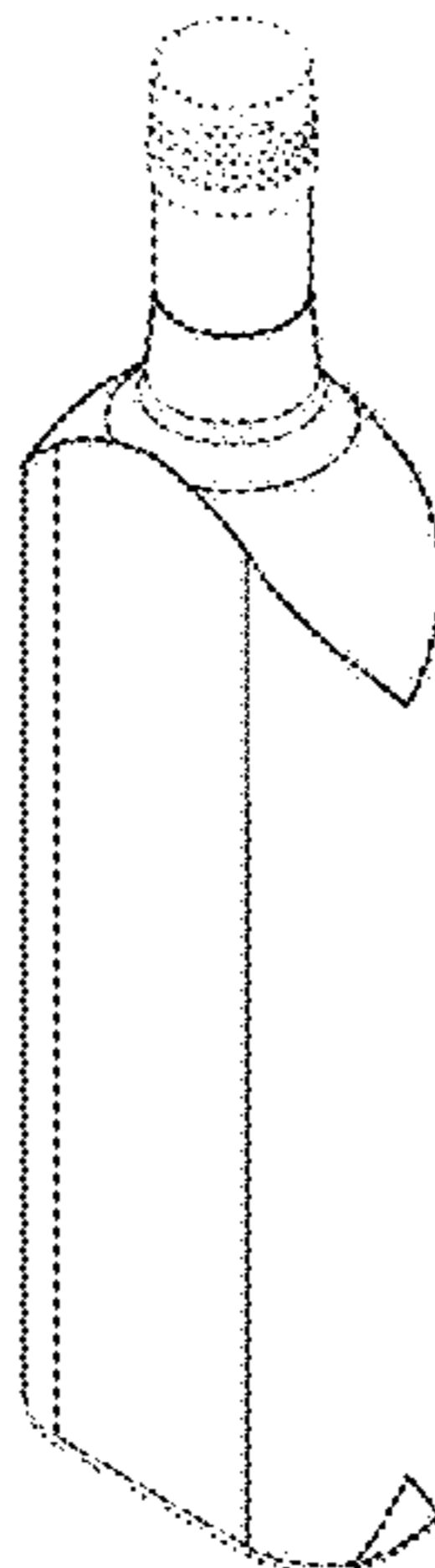

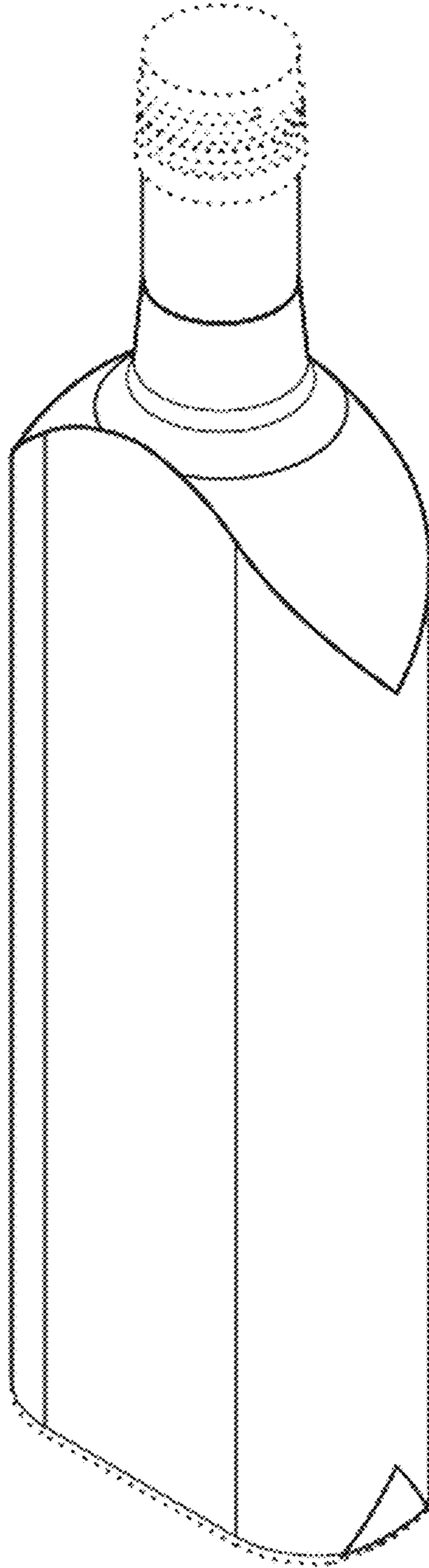

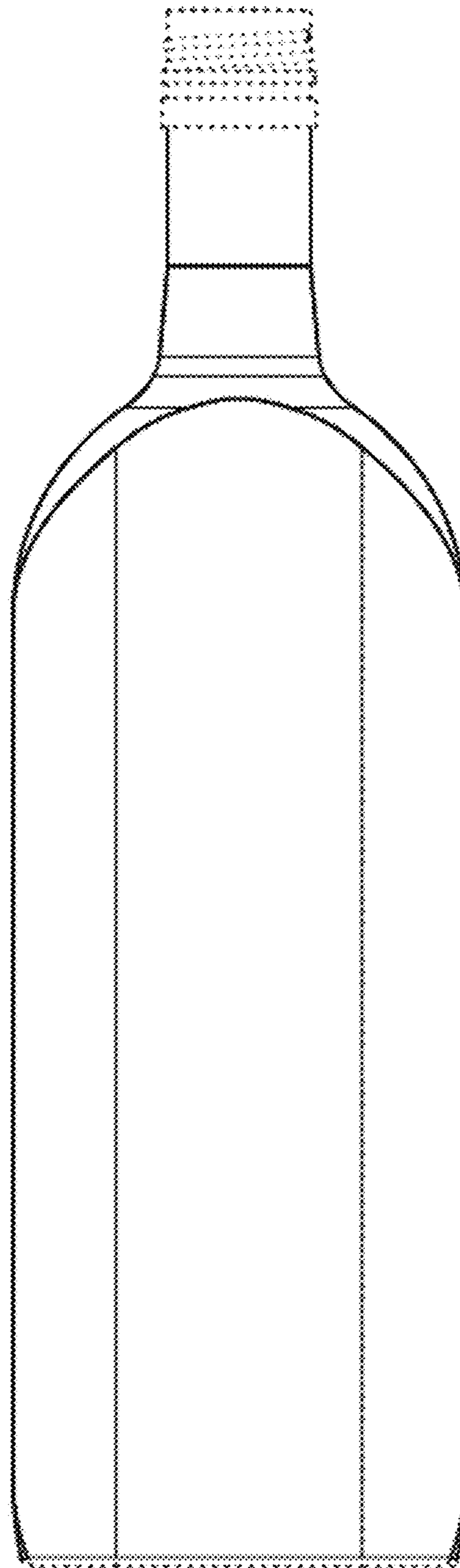

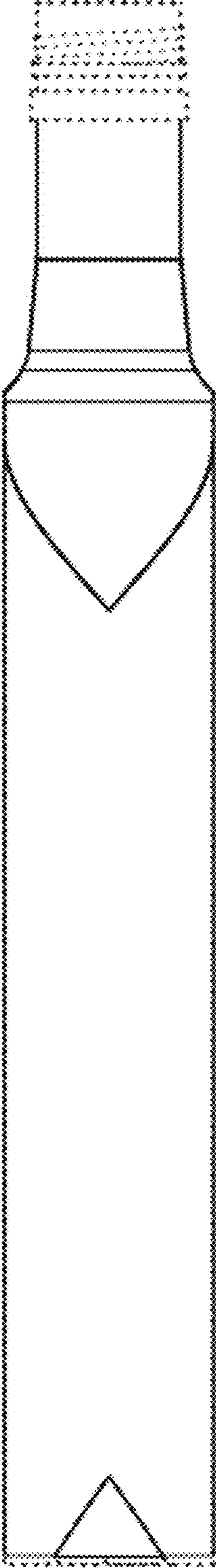

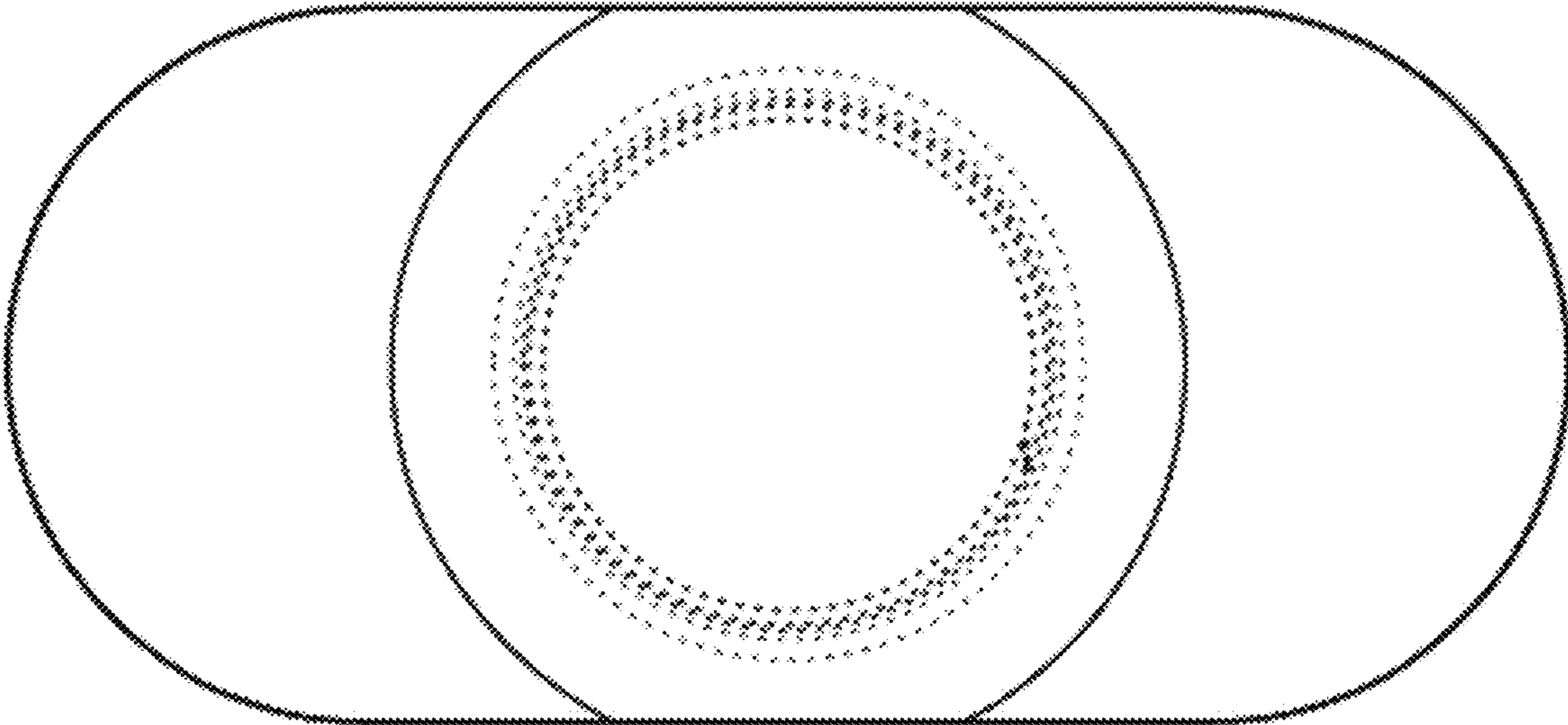
