(57) **CLAIM**

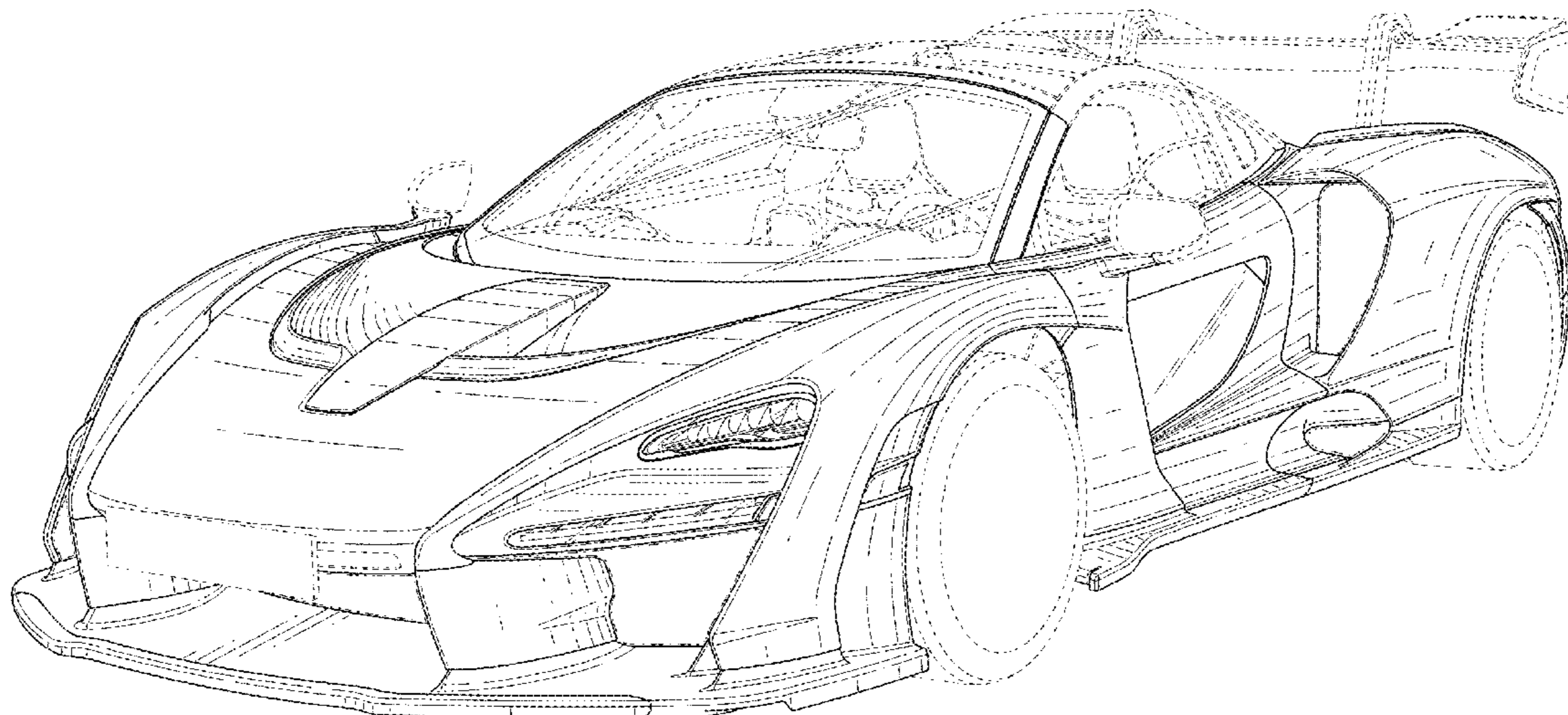
The ornamental design for a car, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a car, showing our new design;
FIG. 2 is a top, rear, left side perspective view thereof;
FIG. 3 is a right side elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a front elevation view thereof;
FIG. 6 is a rear elevation view thereof; and,

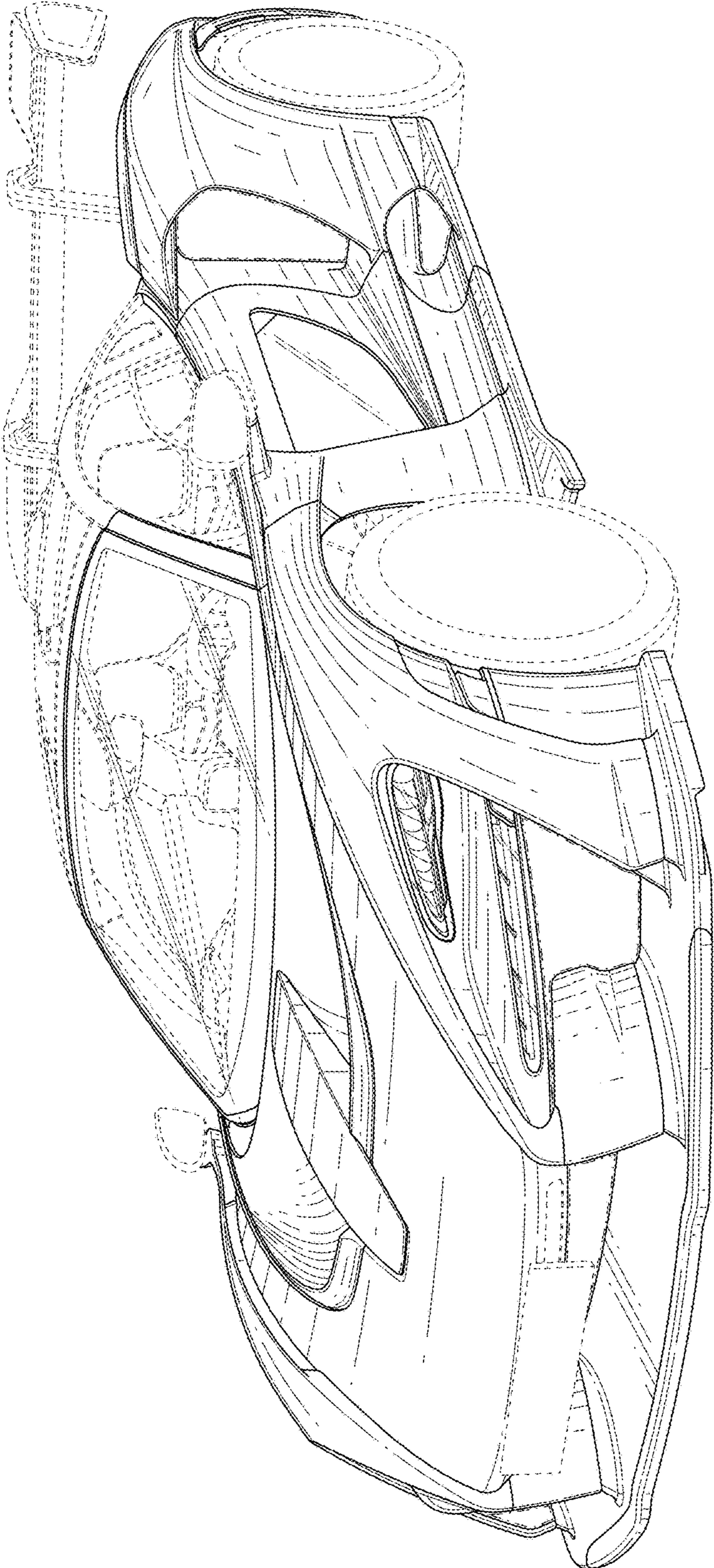

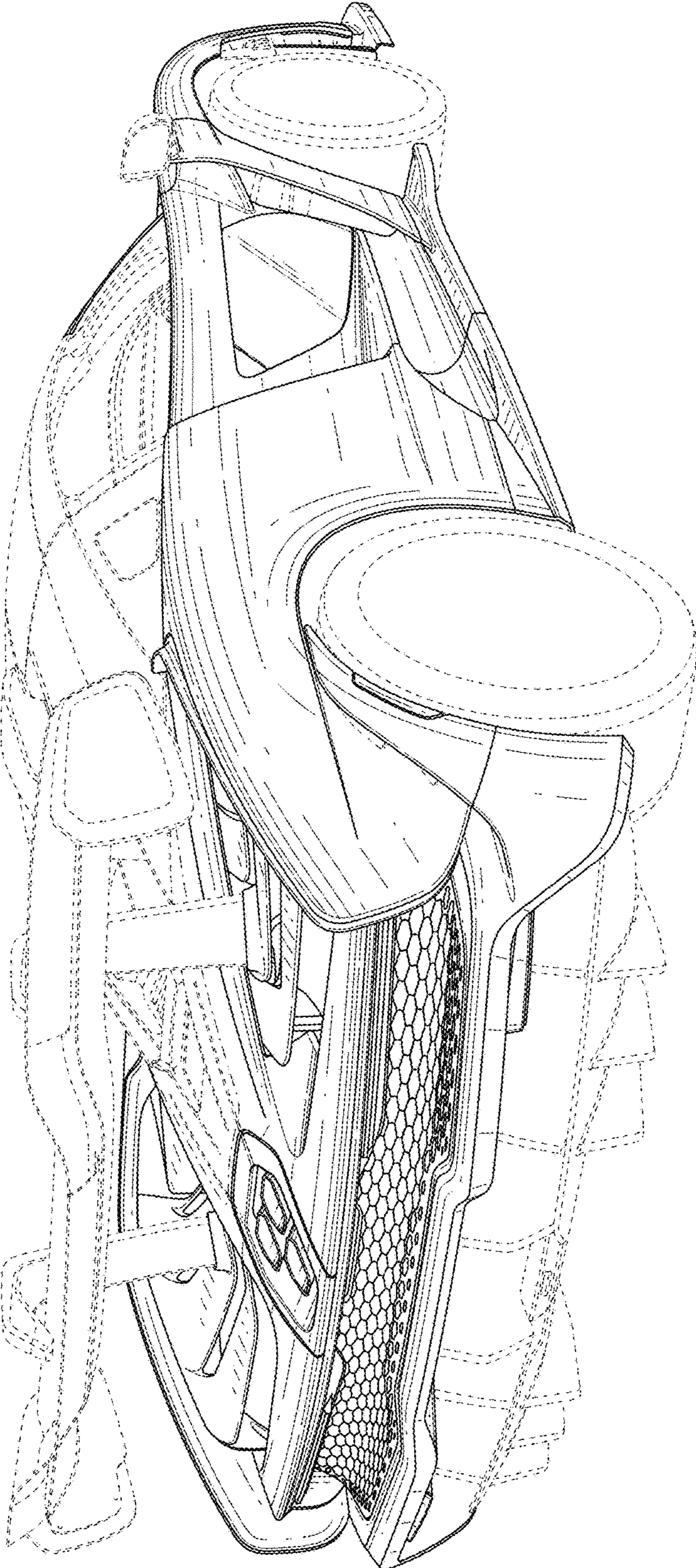

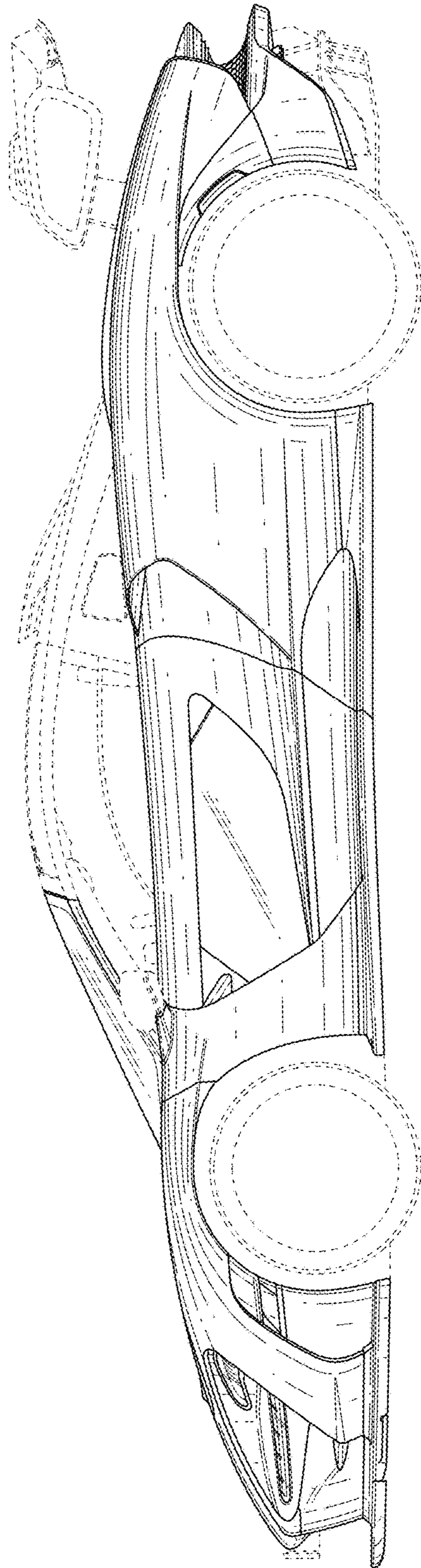

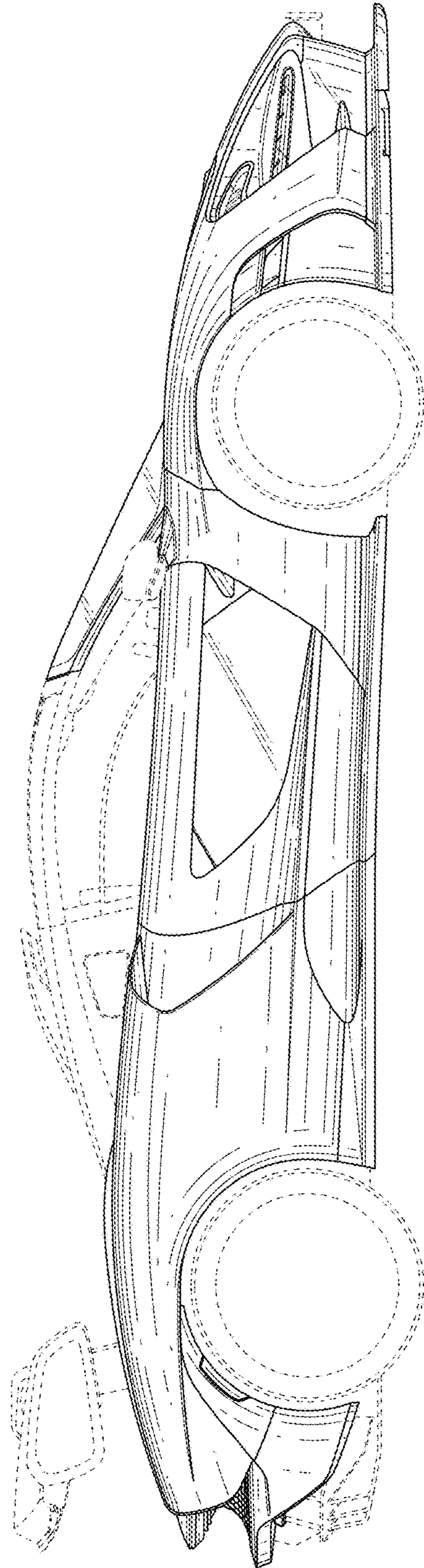

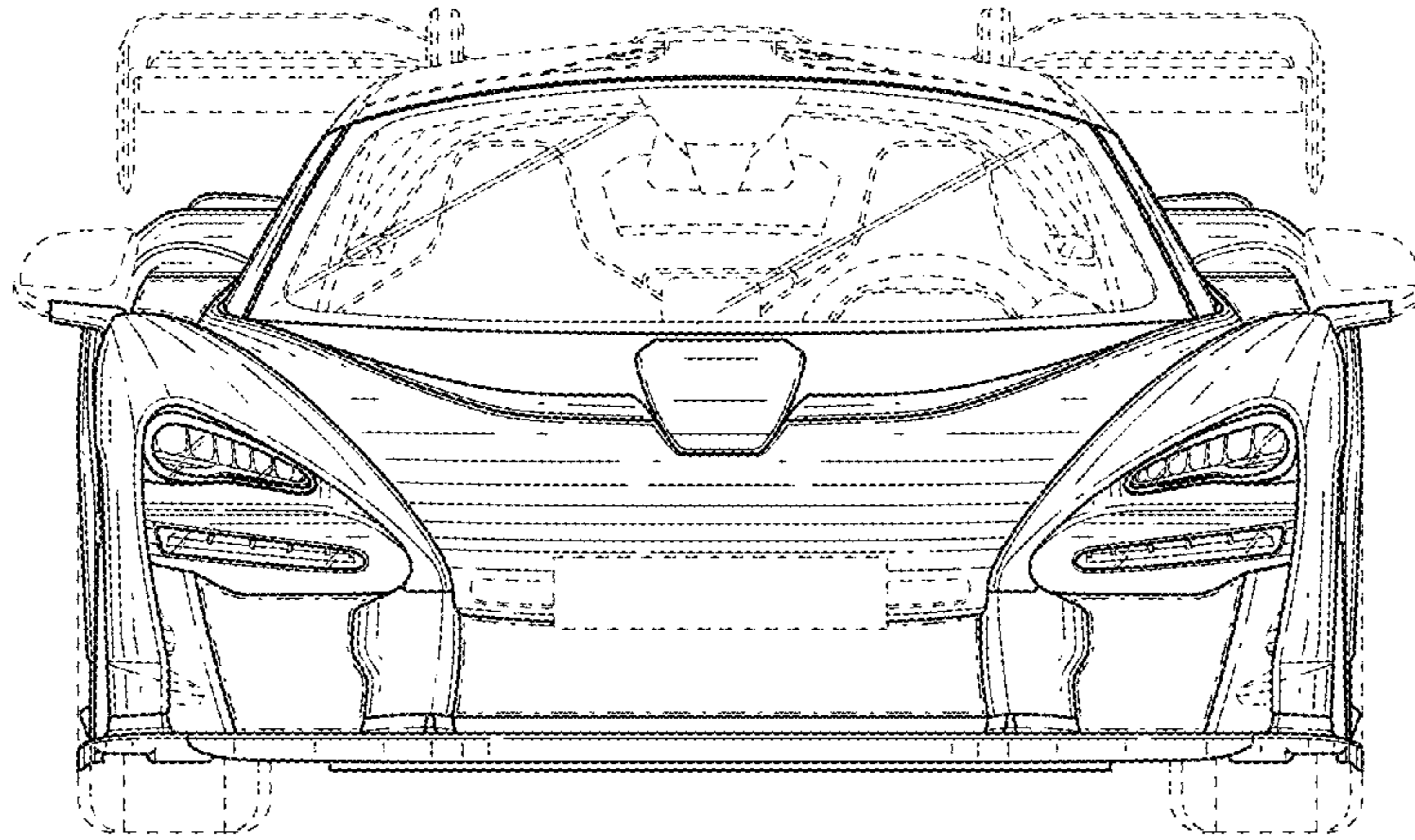

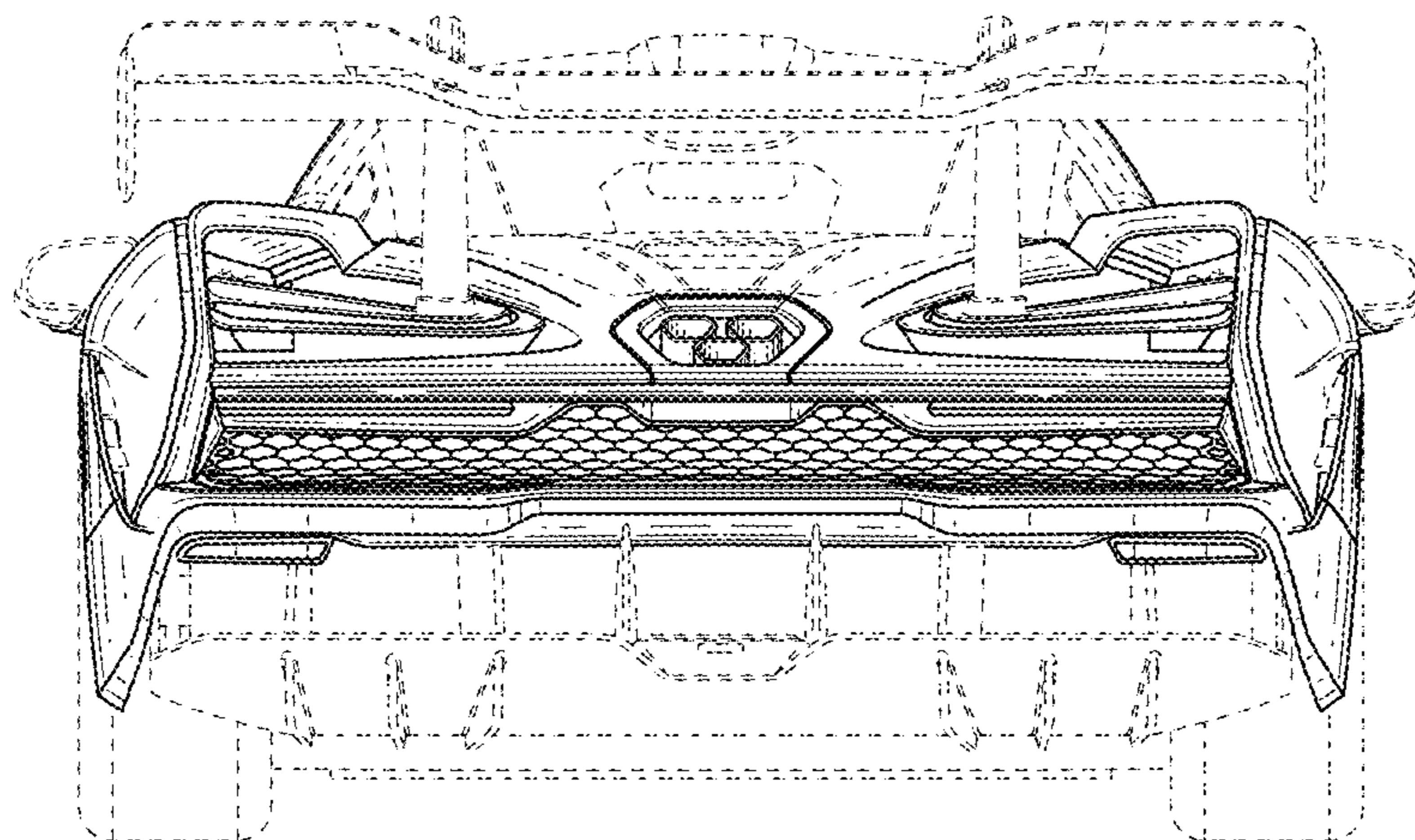

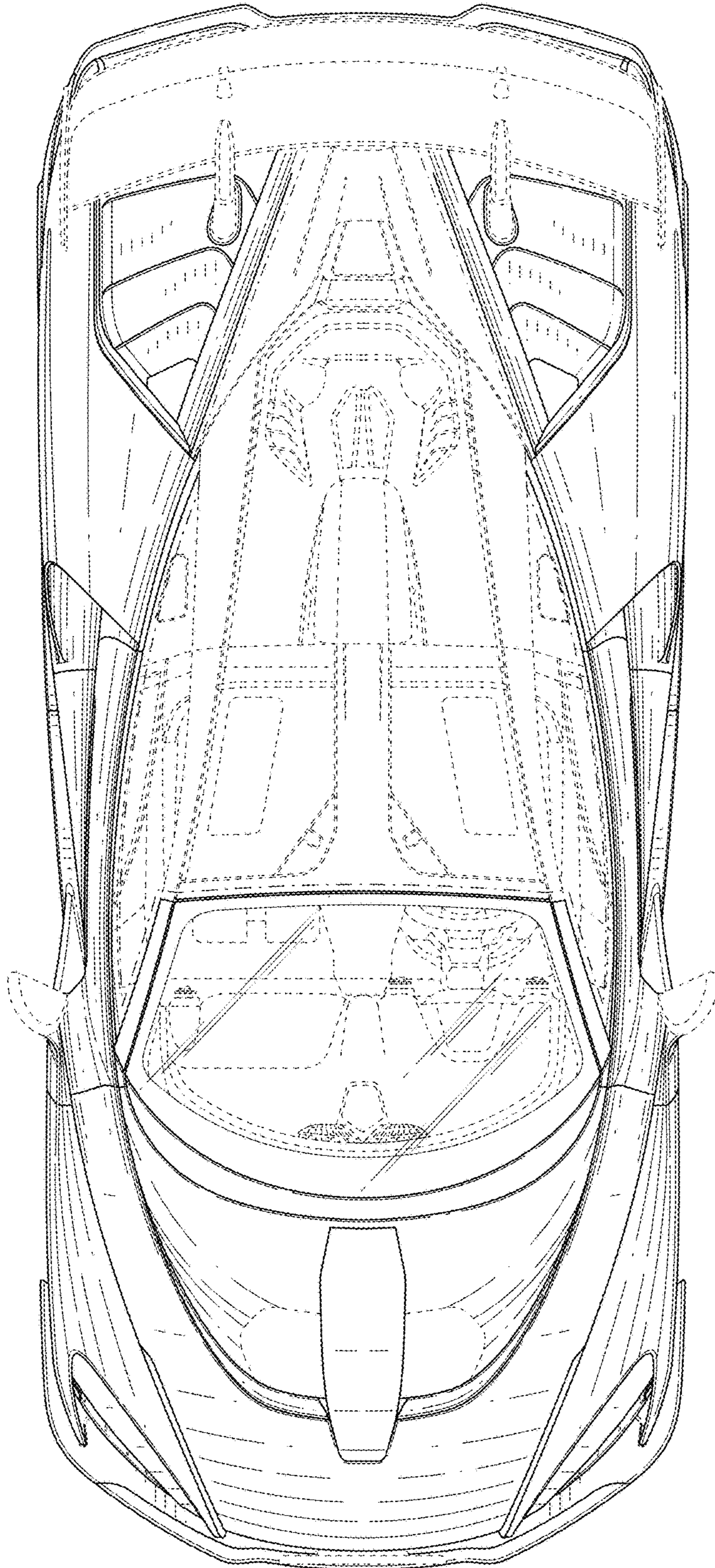
