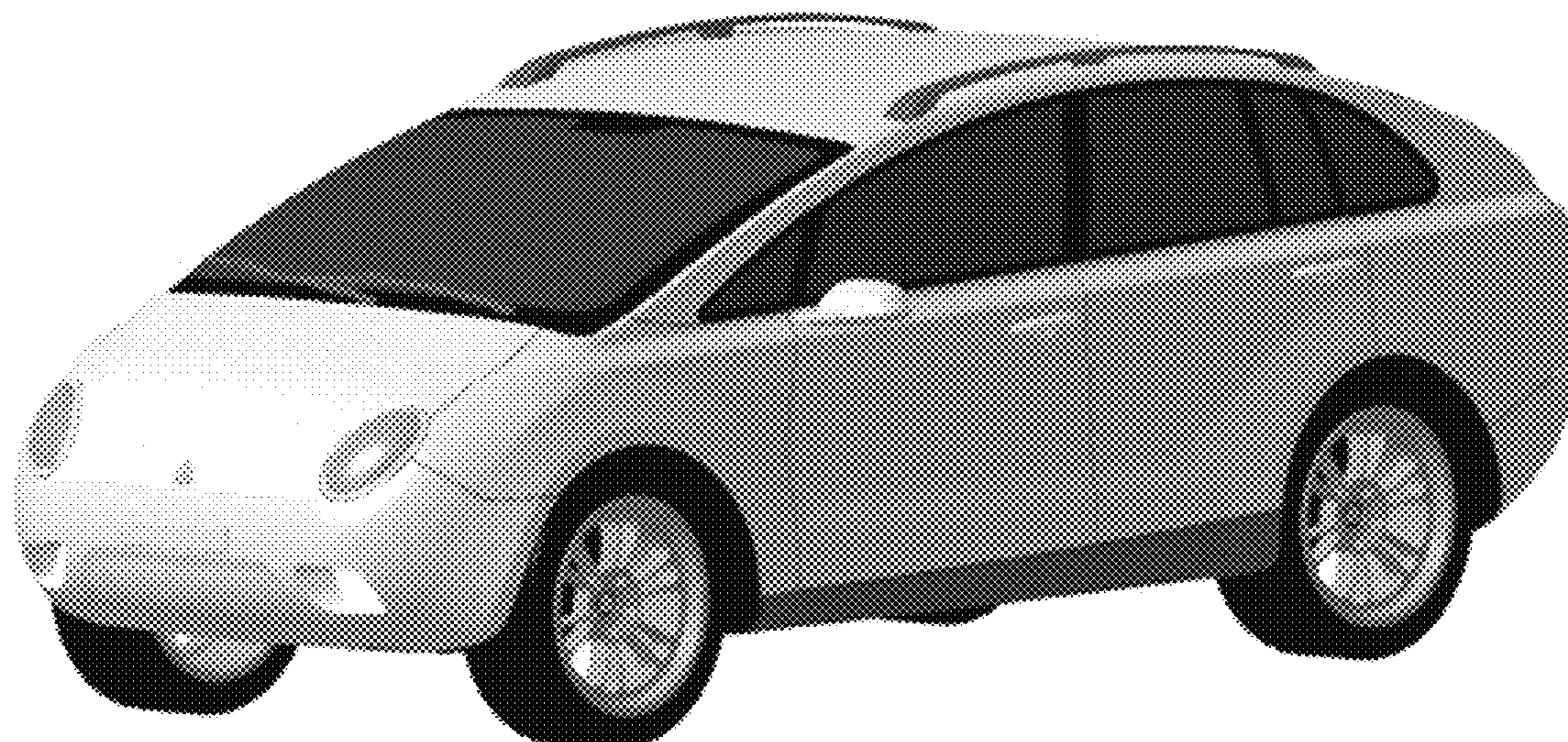
The ornamental design for a motor car, as shown and described.

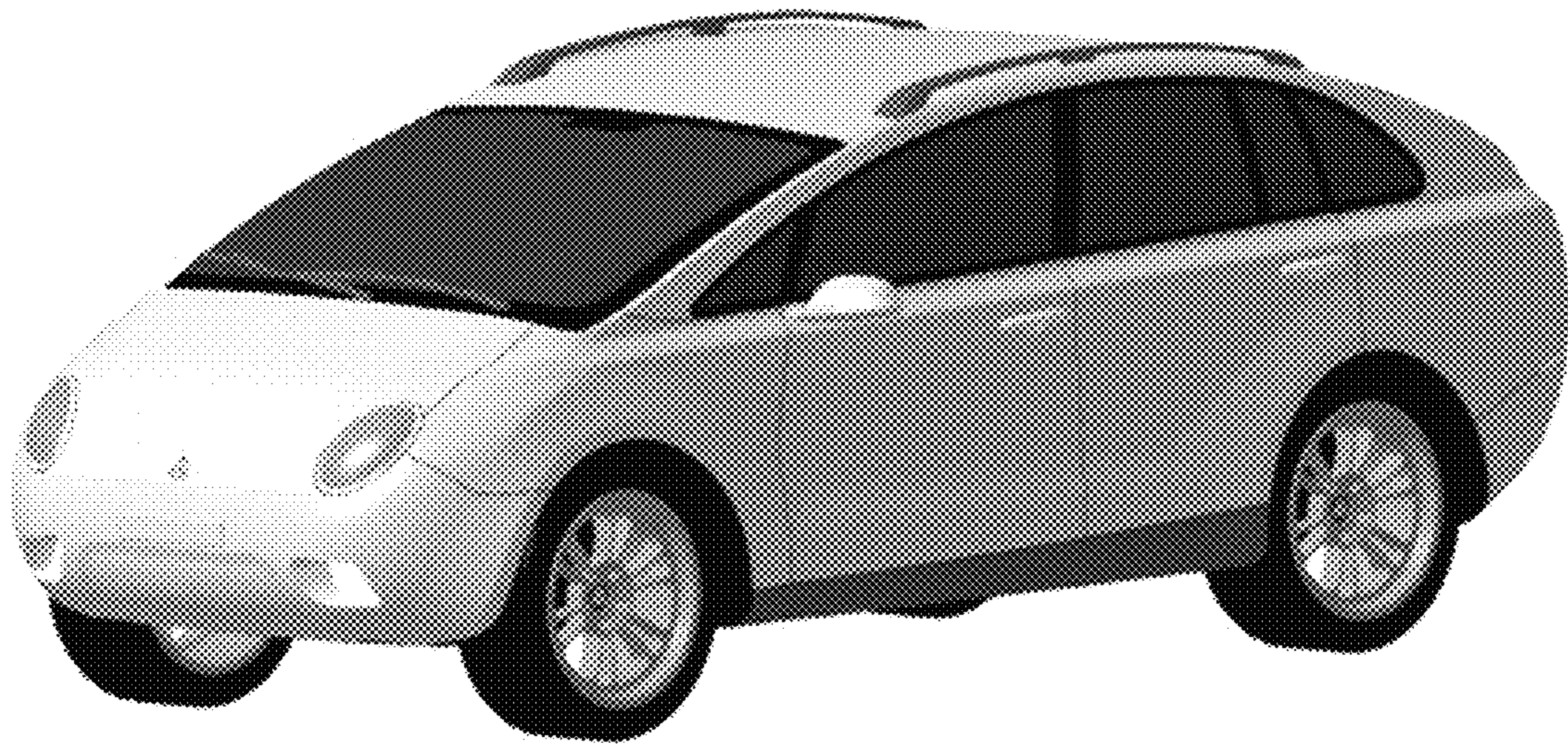
- 1. Motor car

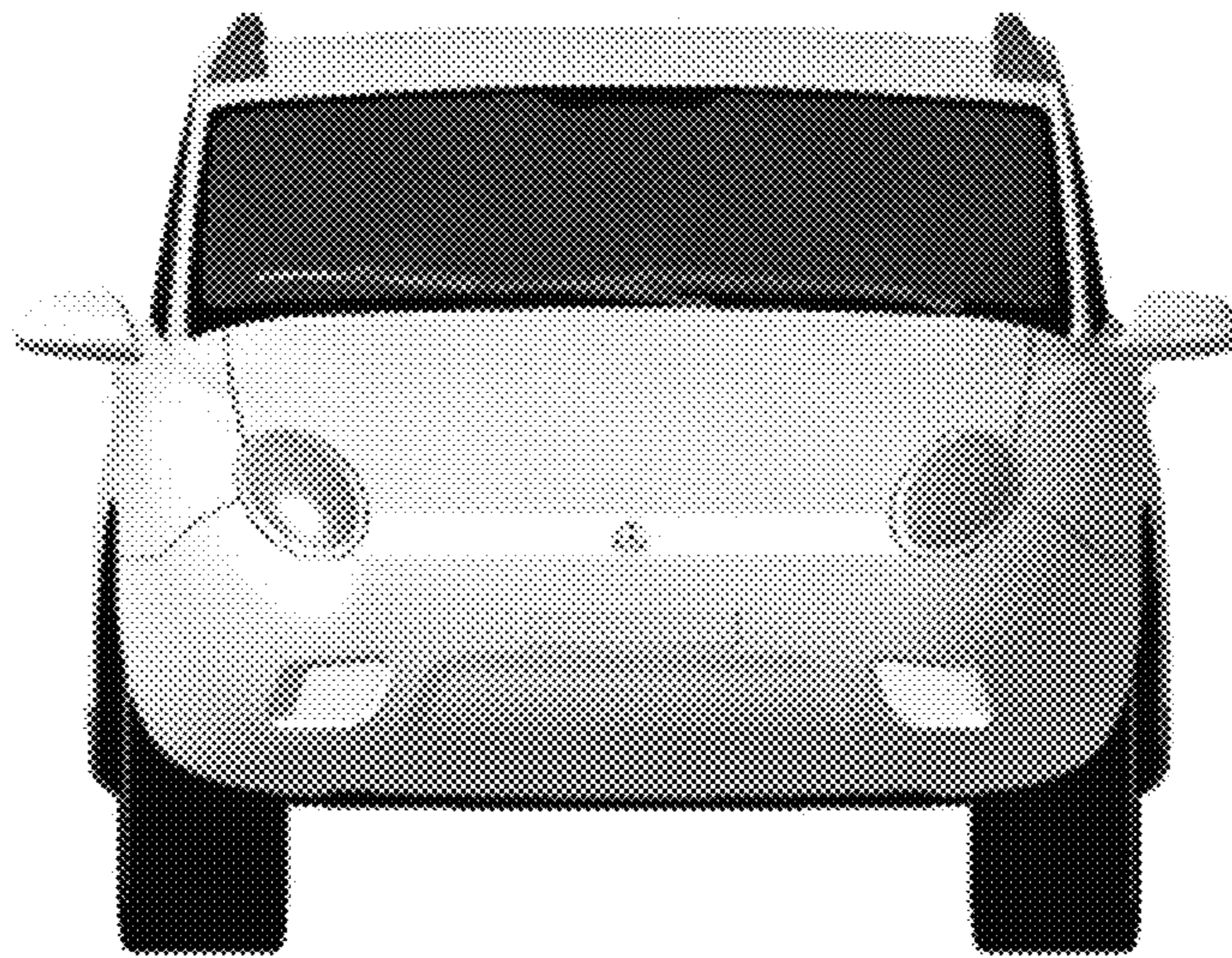




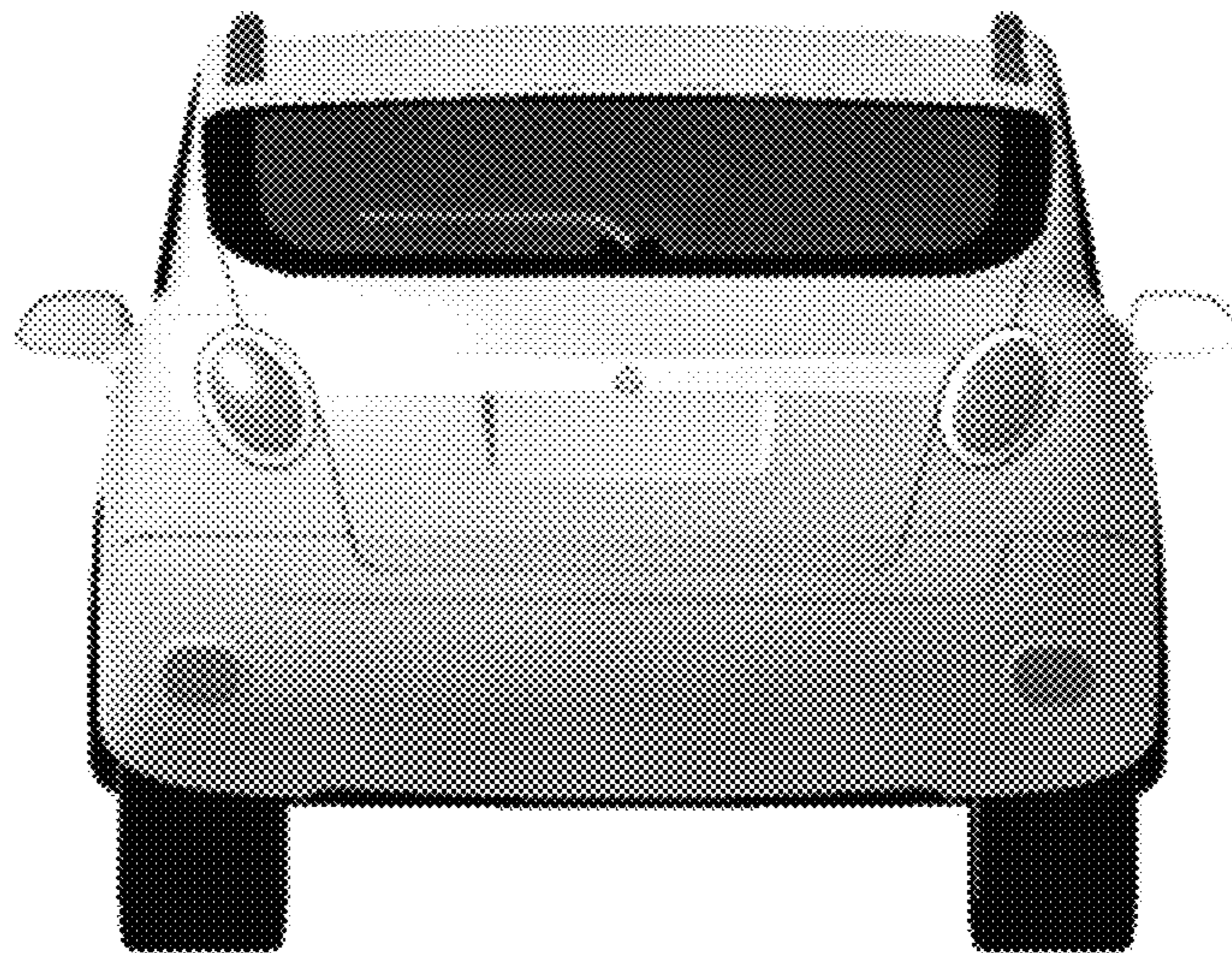

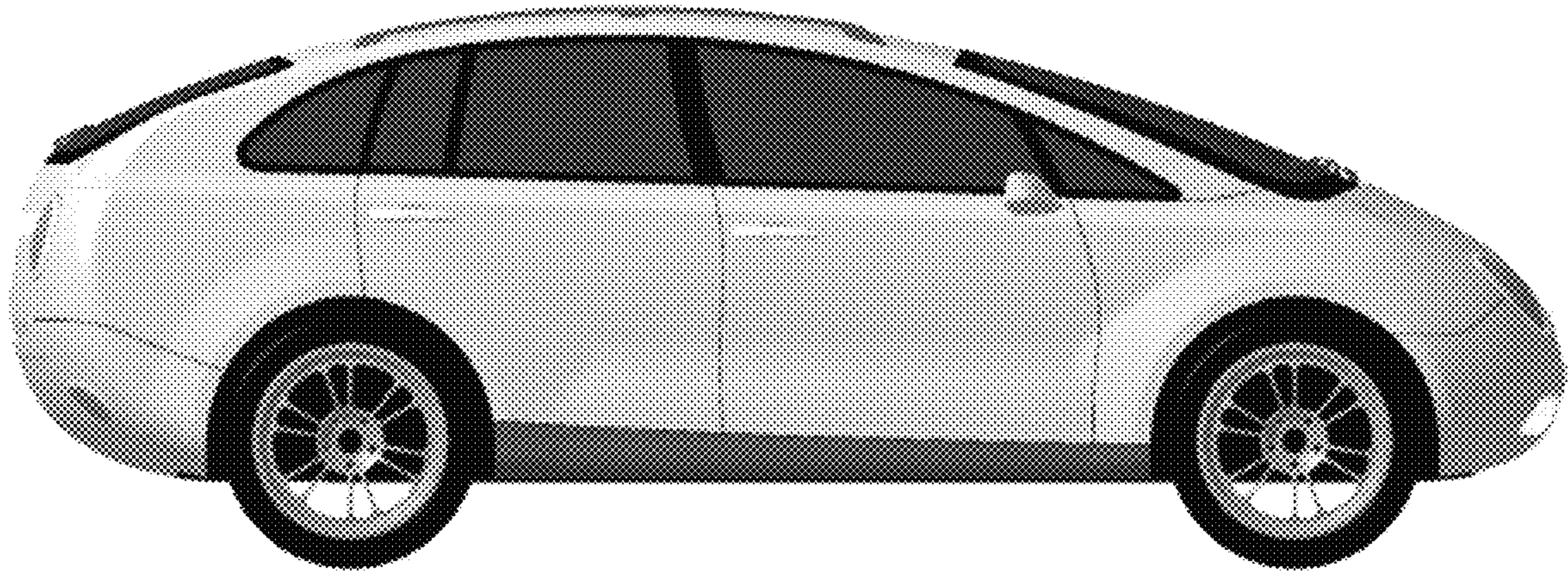

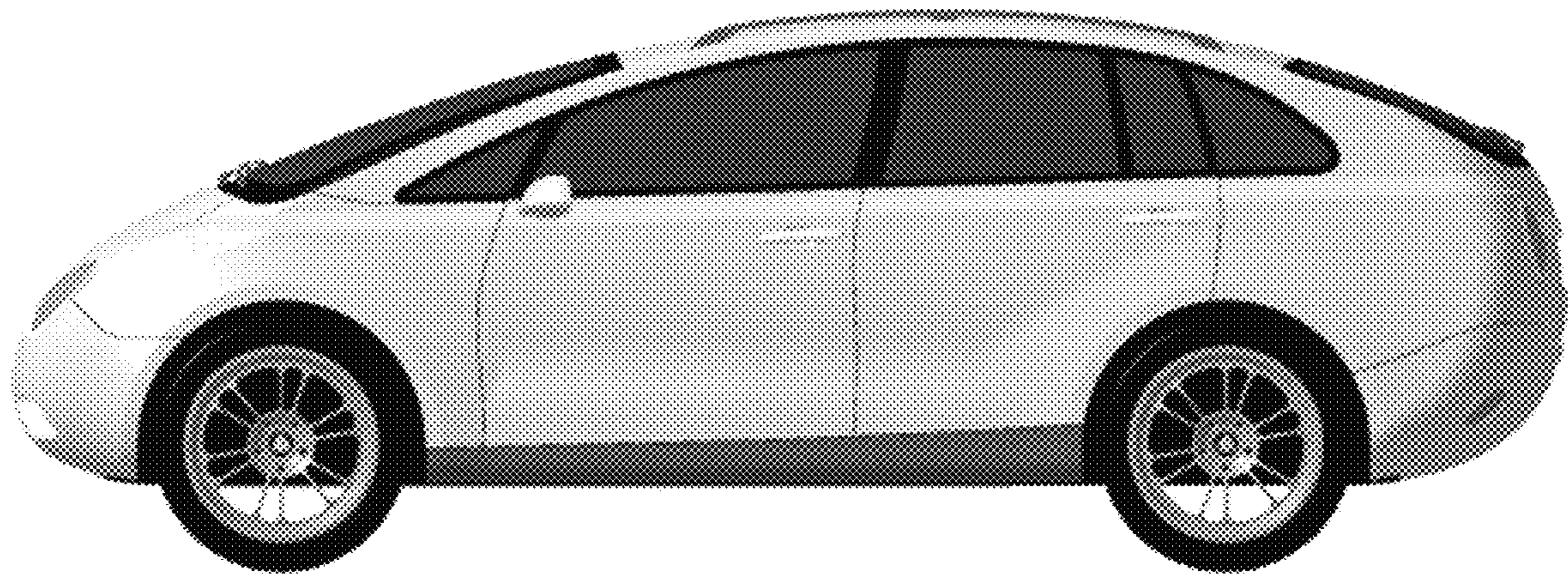

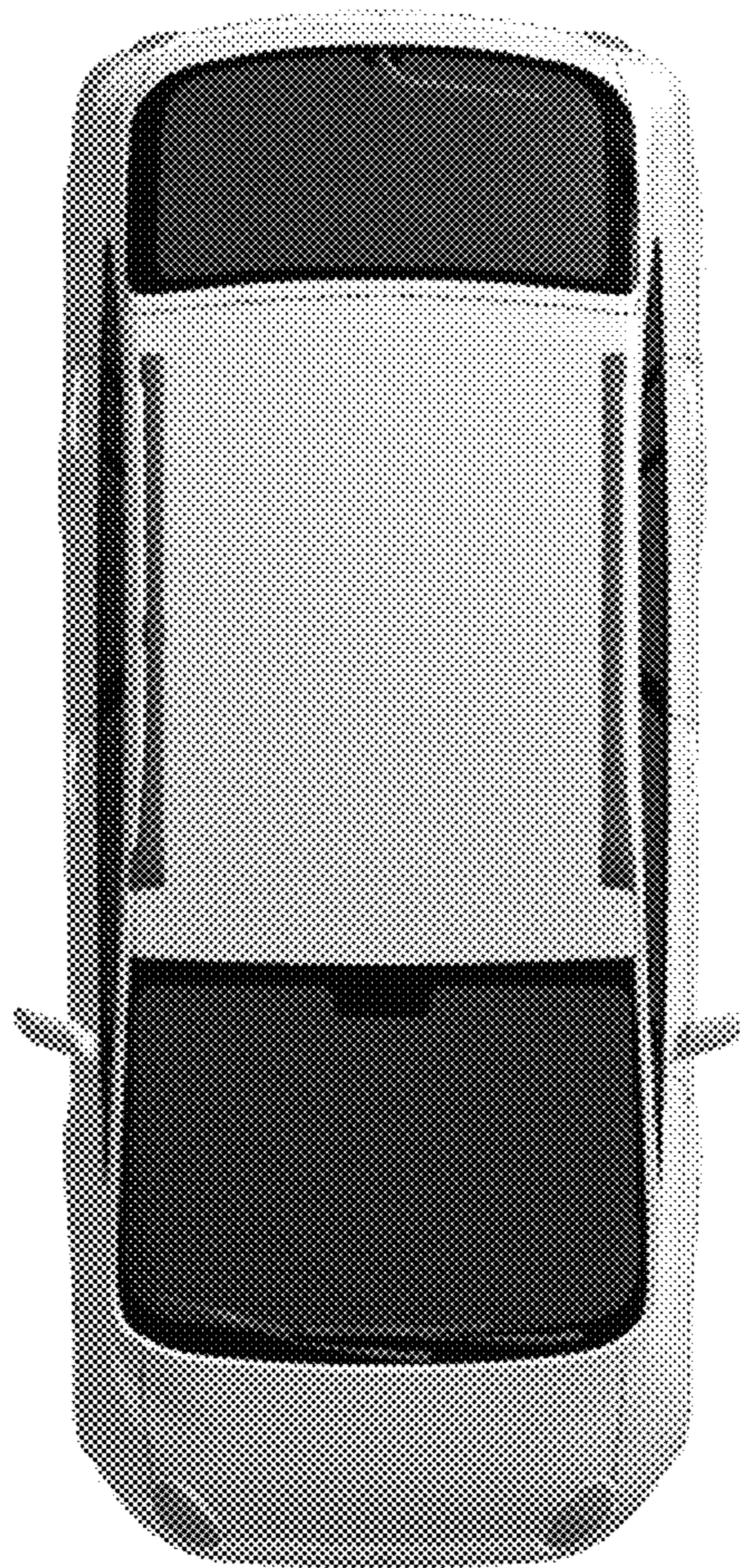
