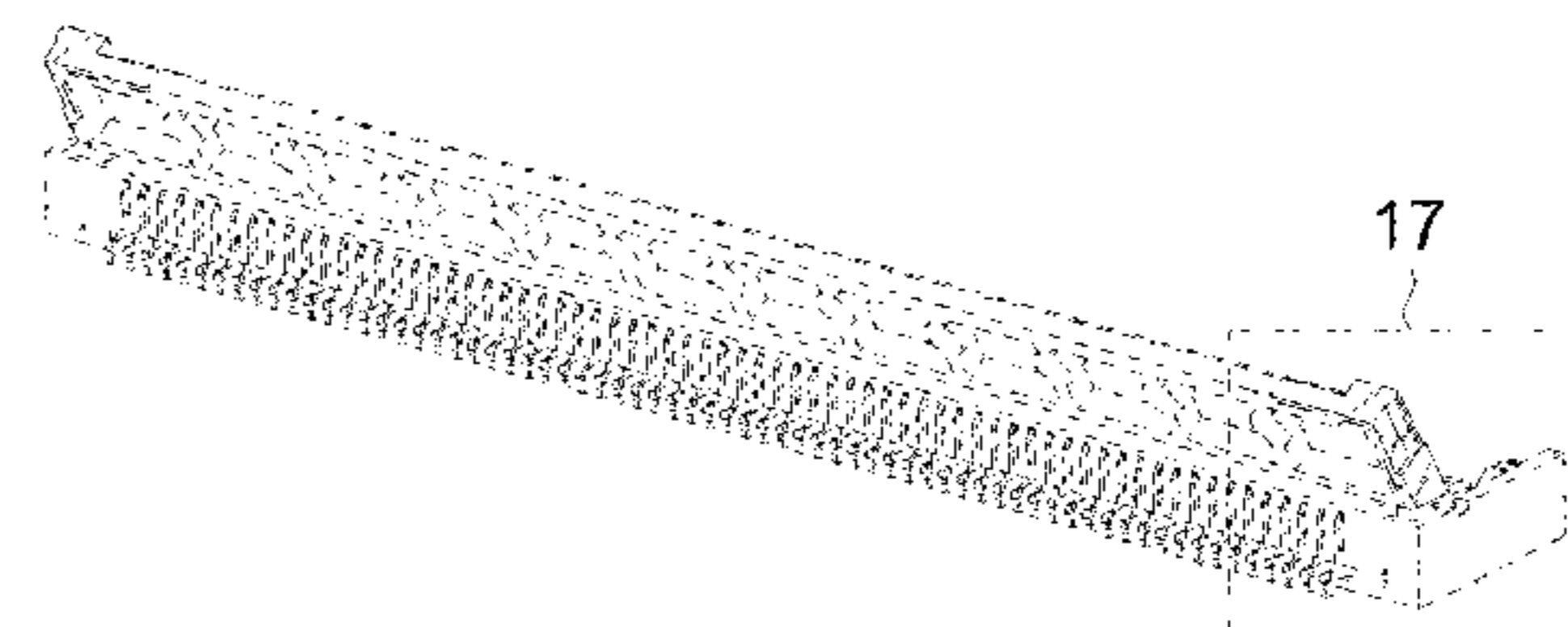
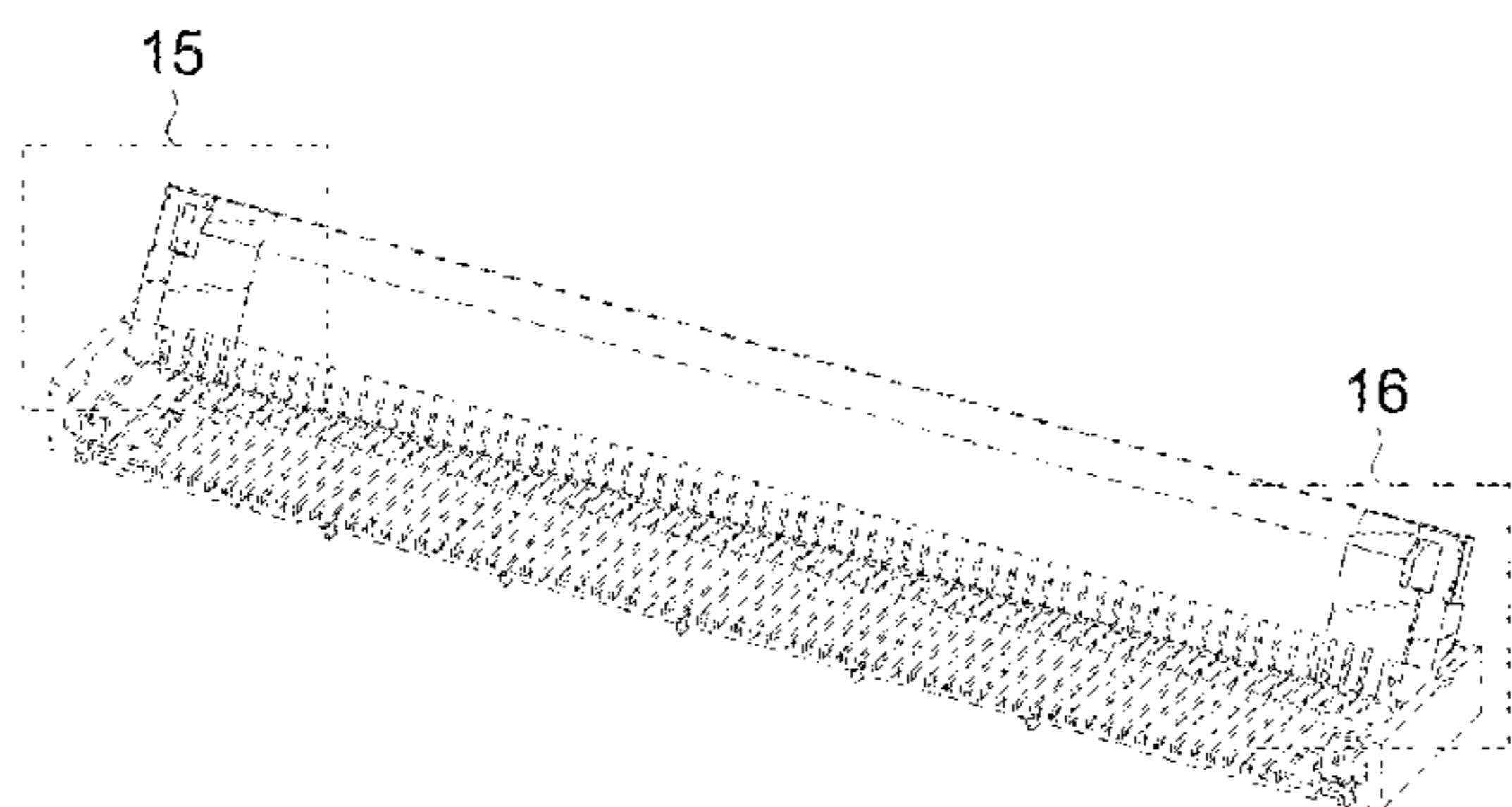
The ornamental design for an electric connector, as shown and described.

DESCRIPTION

FIG. 1 is a front, right, and top perspective view of an electric connector showing my new design;
FIG. 2 is a rear, left, and top perspective view thereof,
FIG. 3 is a rear, left, and bottom perspective view thereof,
FIG. 4 is a front view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a rear view thereof;
FIG. 8 is a bottom view thereof;
FIG. 9 is a section view thereof taken along the line 9-9 in FIG. 4;
FIG. 10 is a section view thereof taken along the line 10-10 of FIG. 4;
FIG. 11 is a front perspective view thereof, looking in the direction of arrow 11 of FIG. 6;
FIG. 12 is a rear perspective view thereof; looking in the direction of arrow 12 of FIG. 6;
FIG. 13 is an enlarged view of a portion thereof taken in FIG. 11;
FIG. 14 is an enlarged view of a portion thereof taken in FIG. 12;
FIG. 15 is an enlarged view of a portion thereof taken in FIG. 1;
FIG. 16 is an enlarged view of a portion thereof taken in FIG. 1;
FIG. 17 is an enlarged view of a portion thereof taken in FIG. 2; and,
FIG. 18 is an enlarged view of a portion thereof taken in FIG. 3.

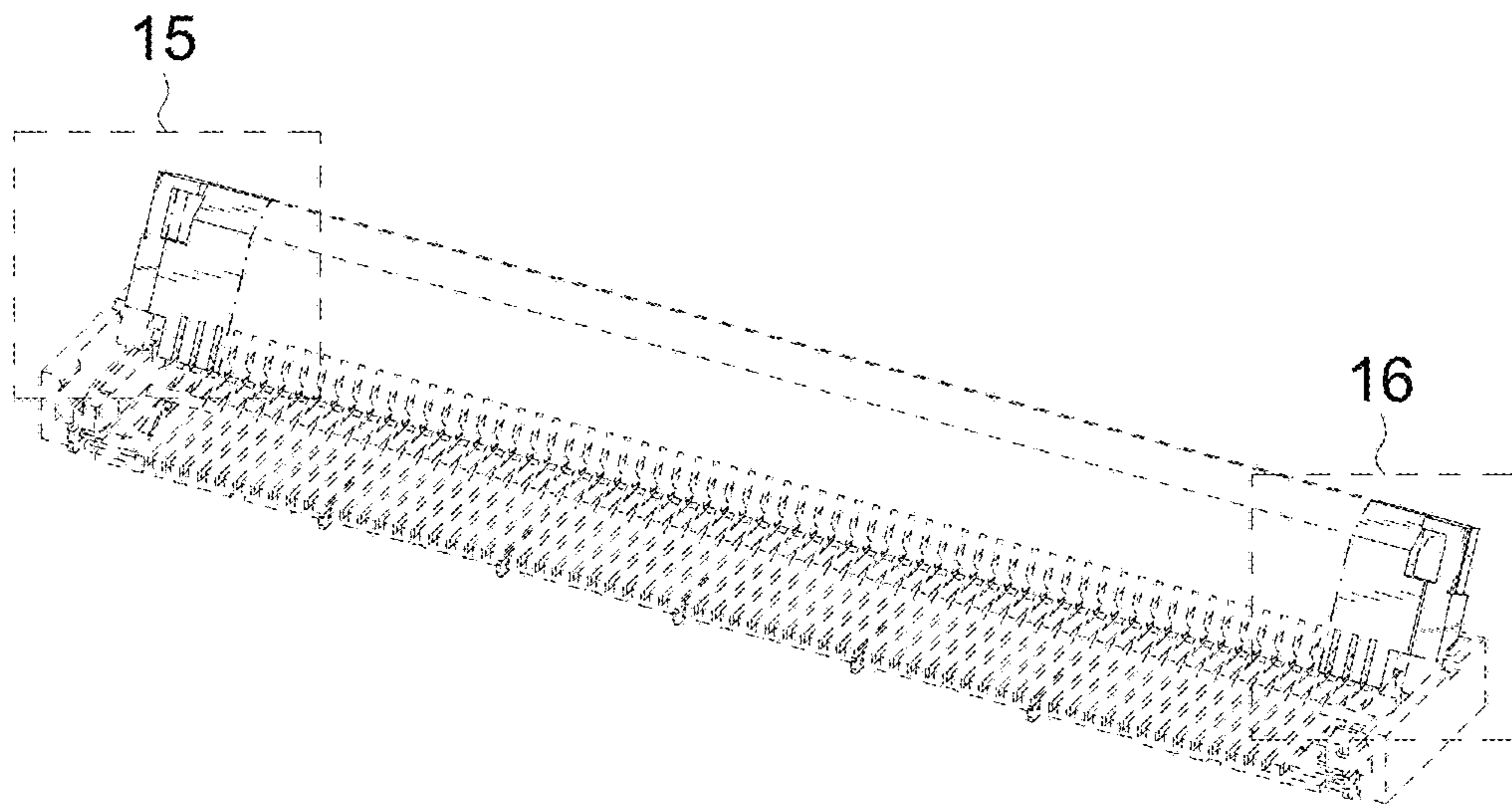

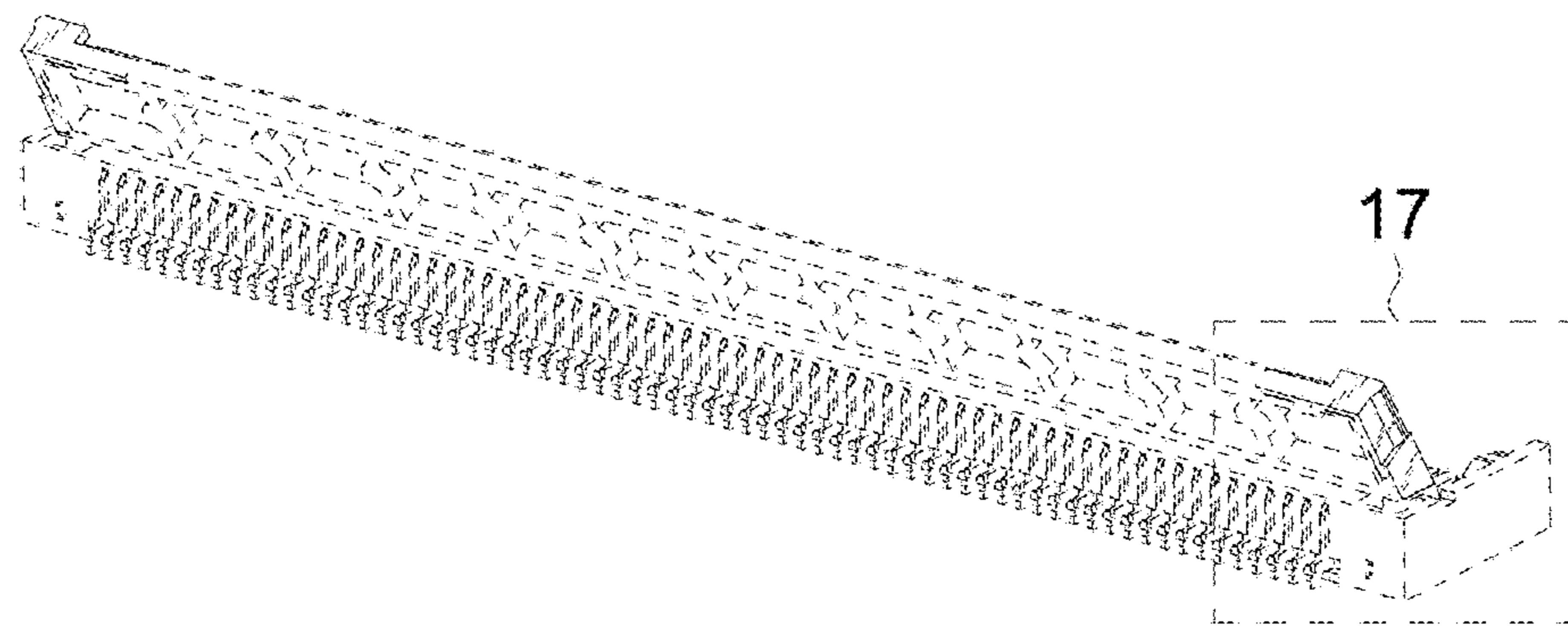

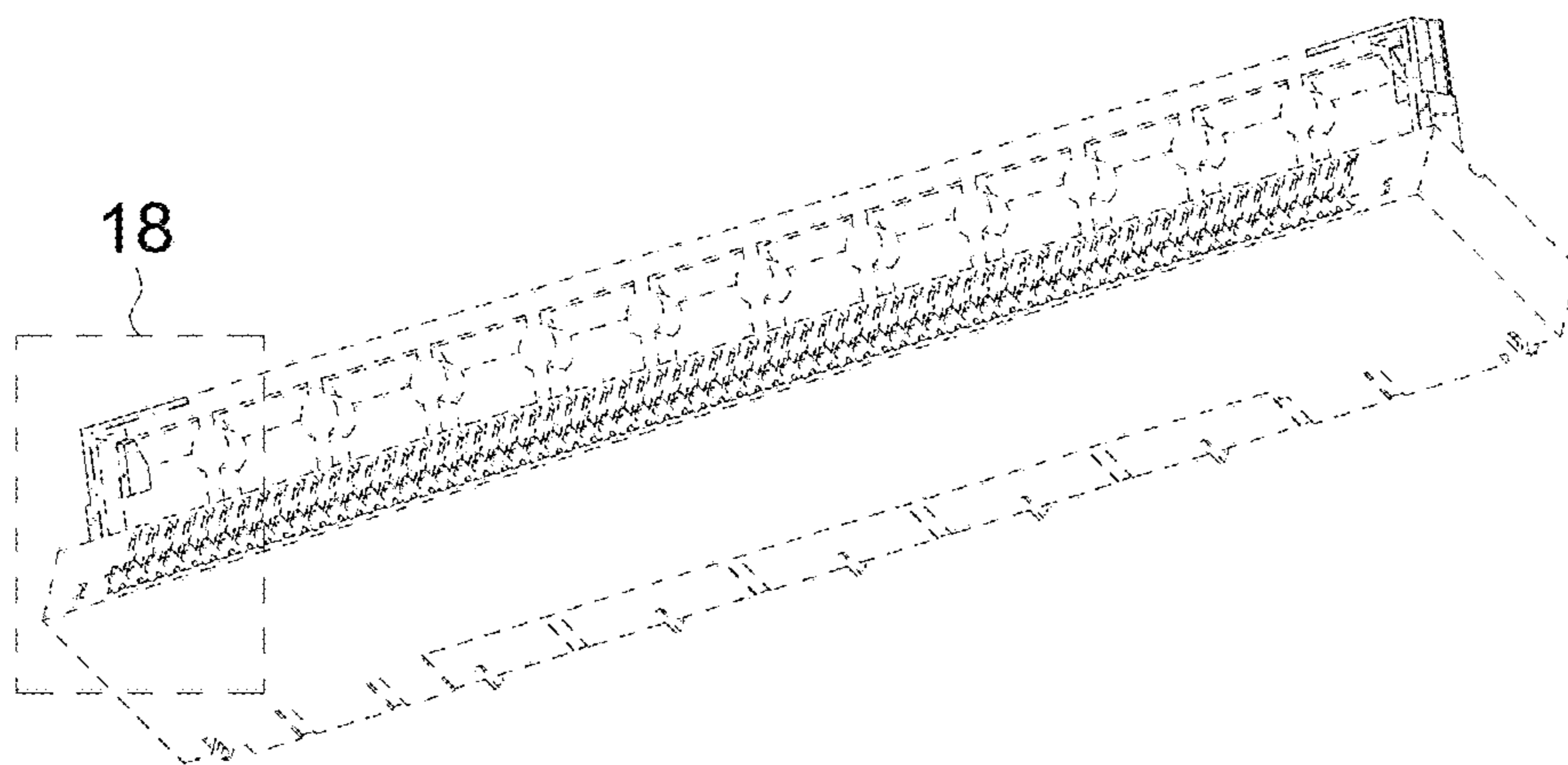

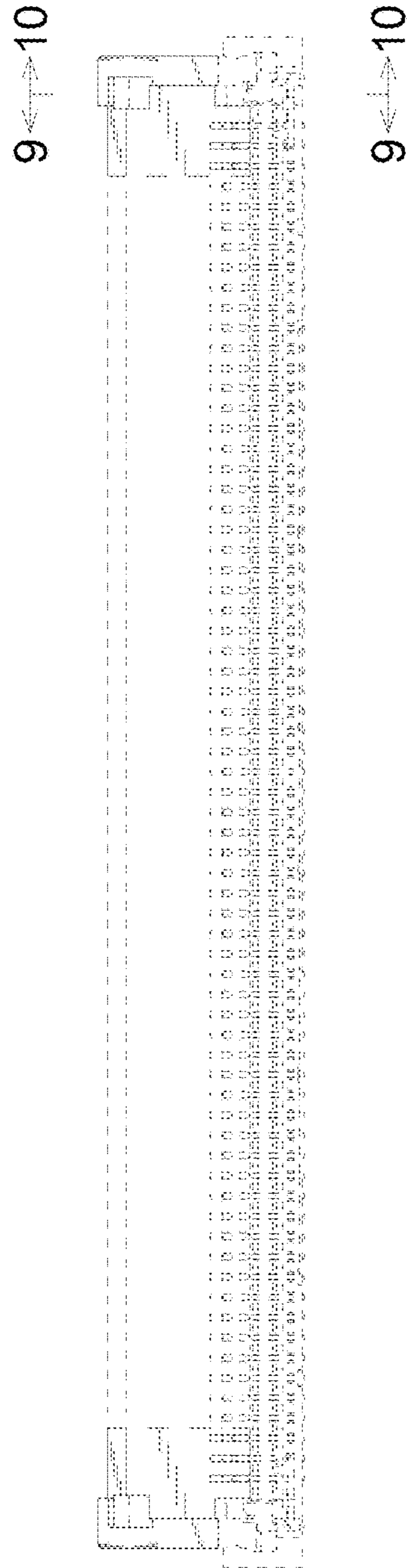

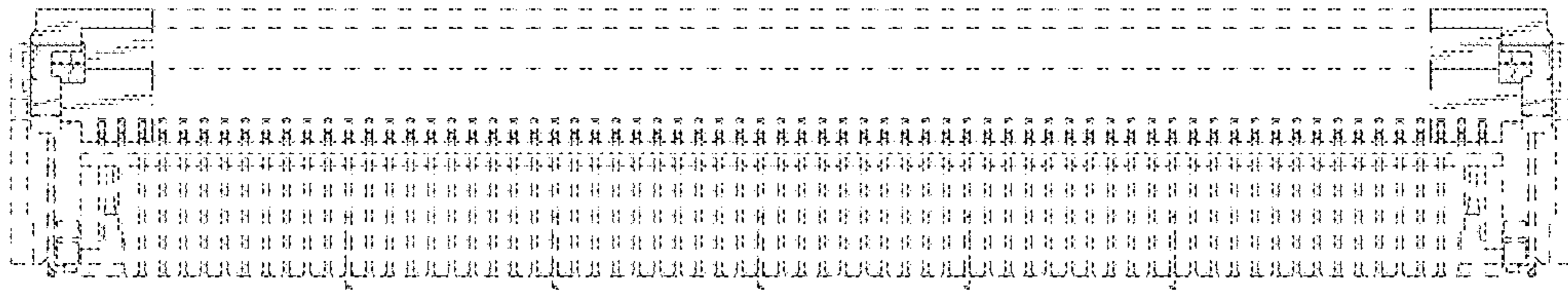

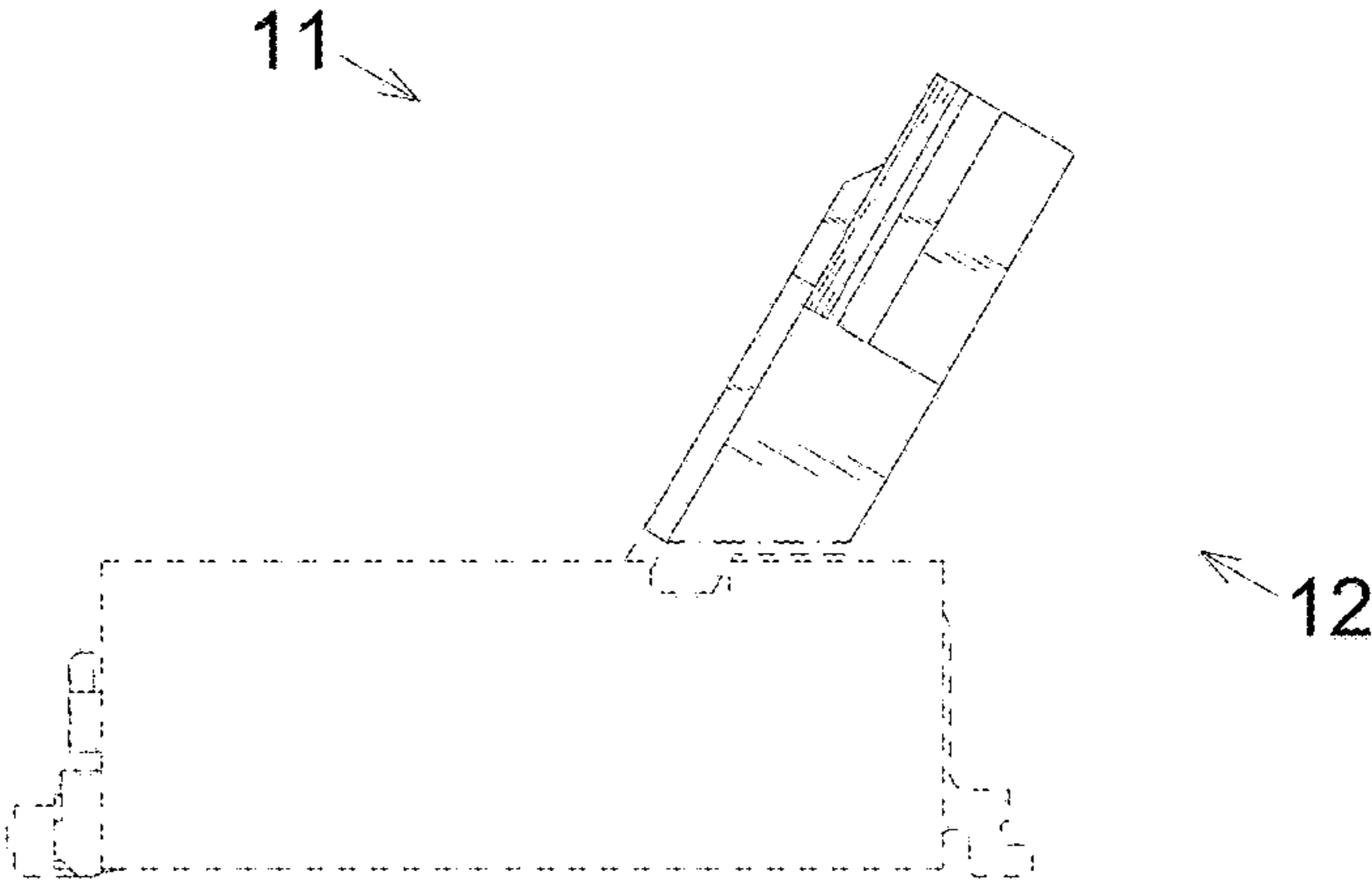

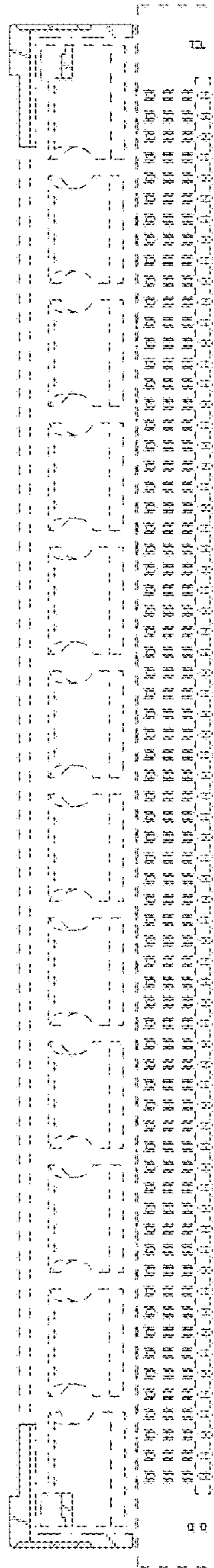

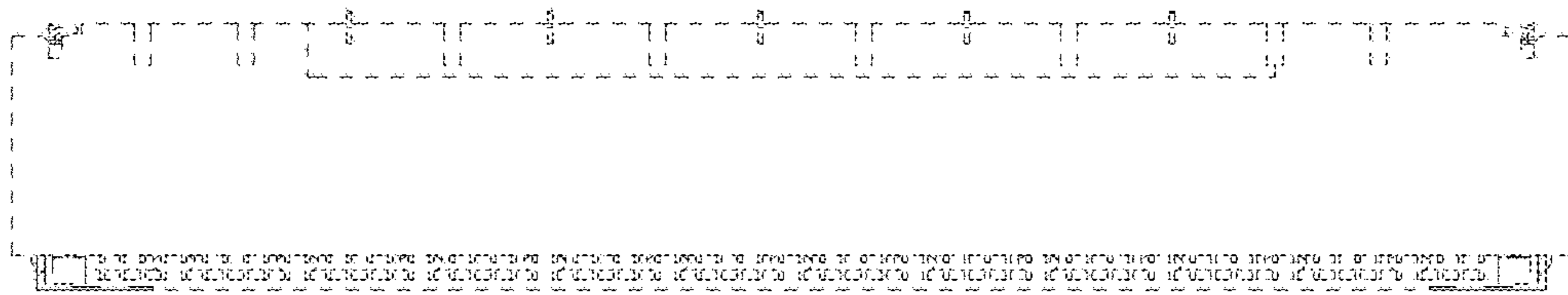

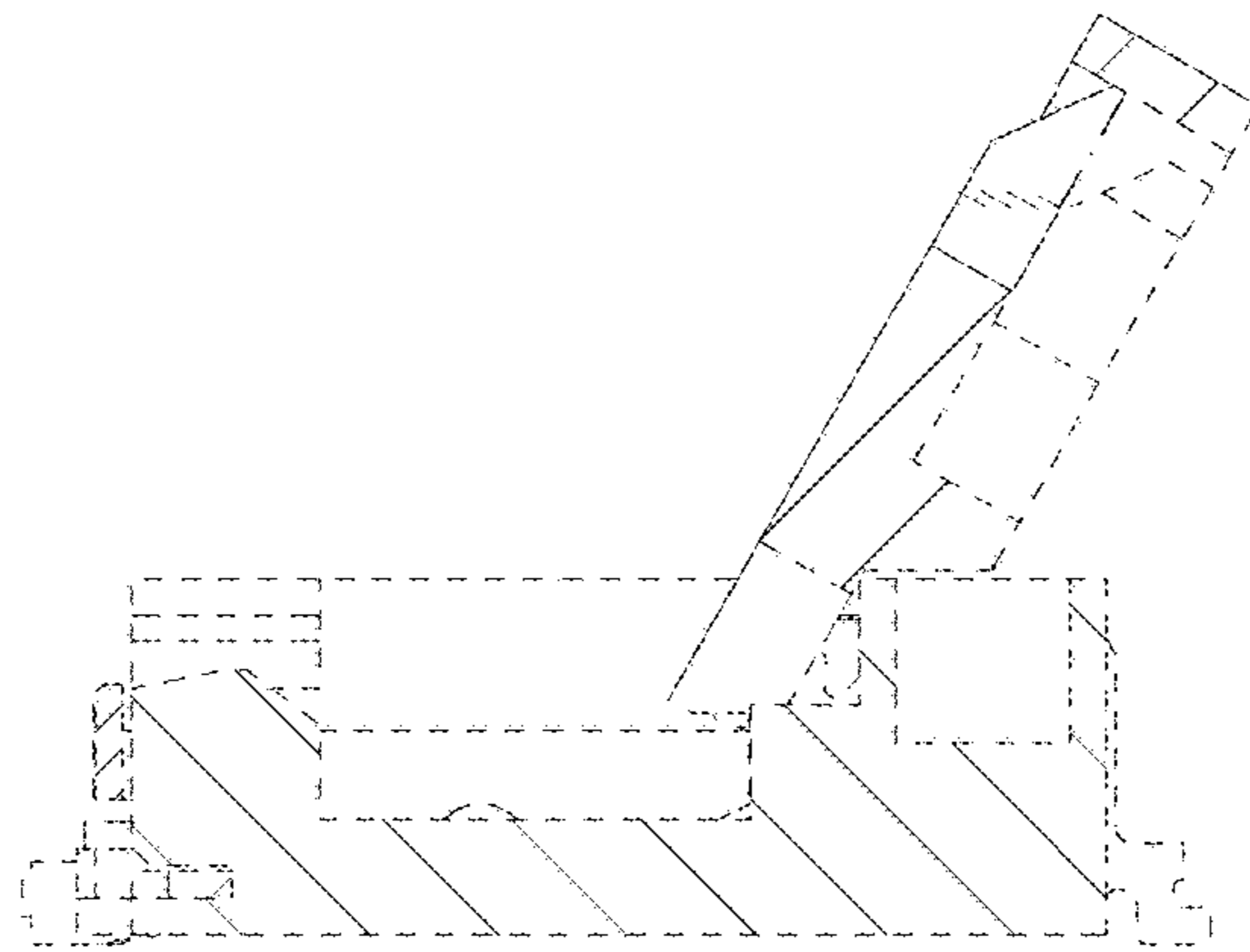

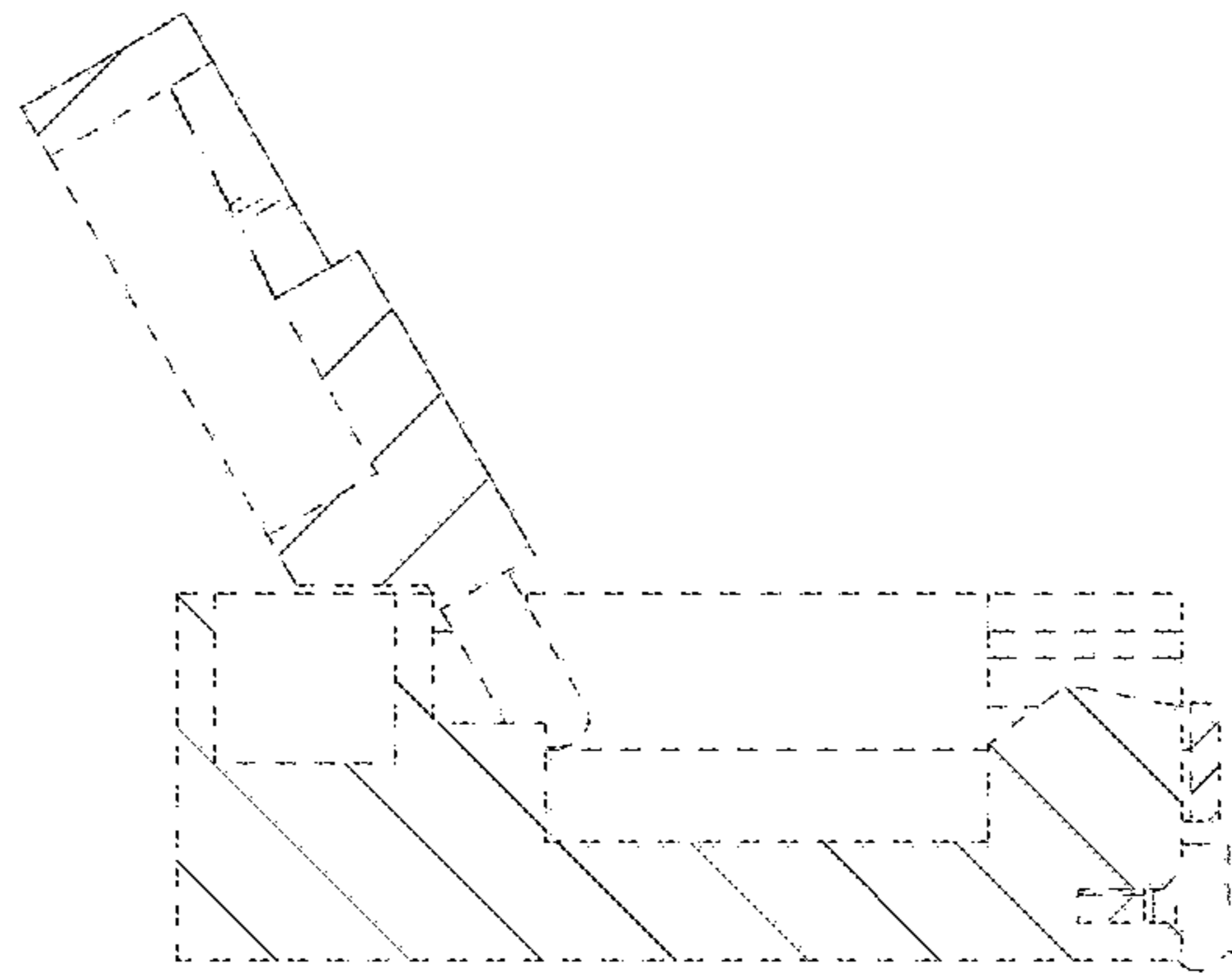

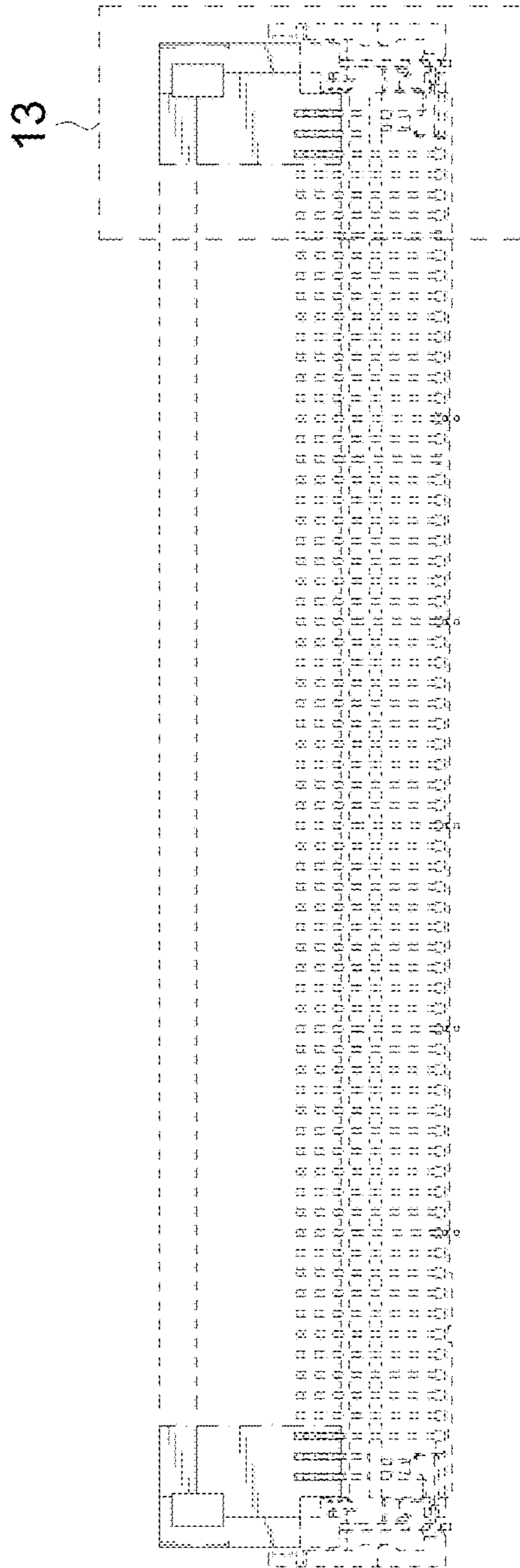

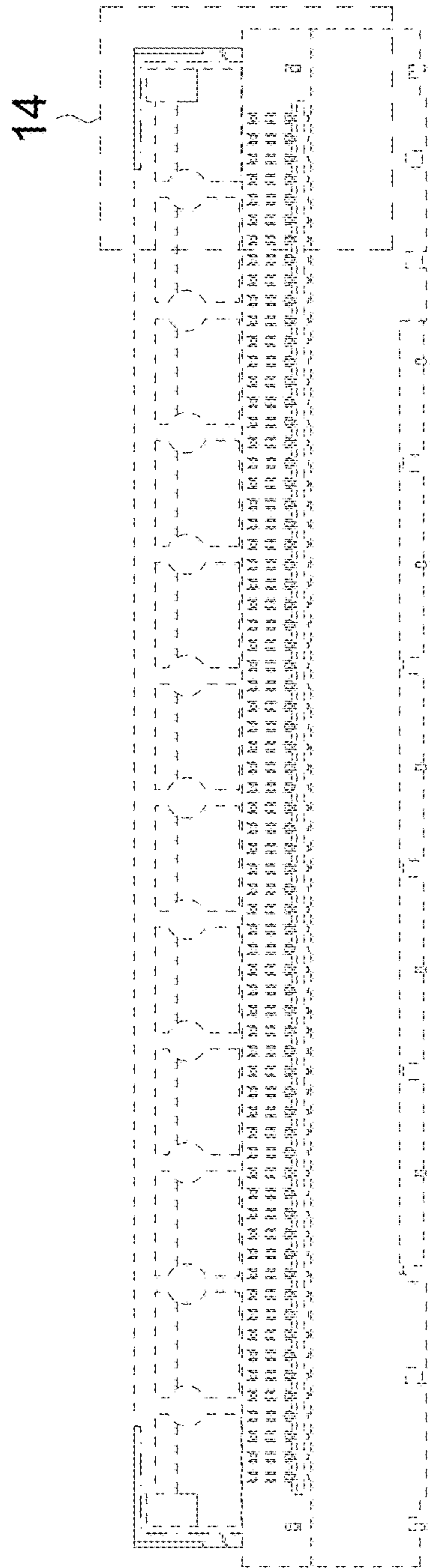

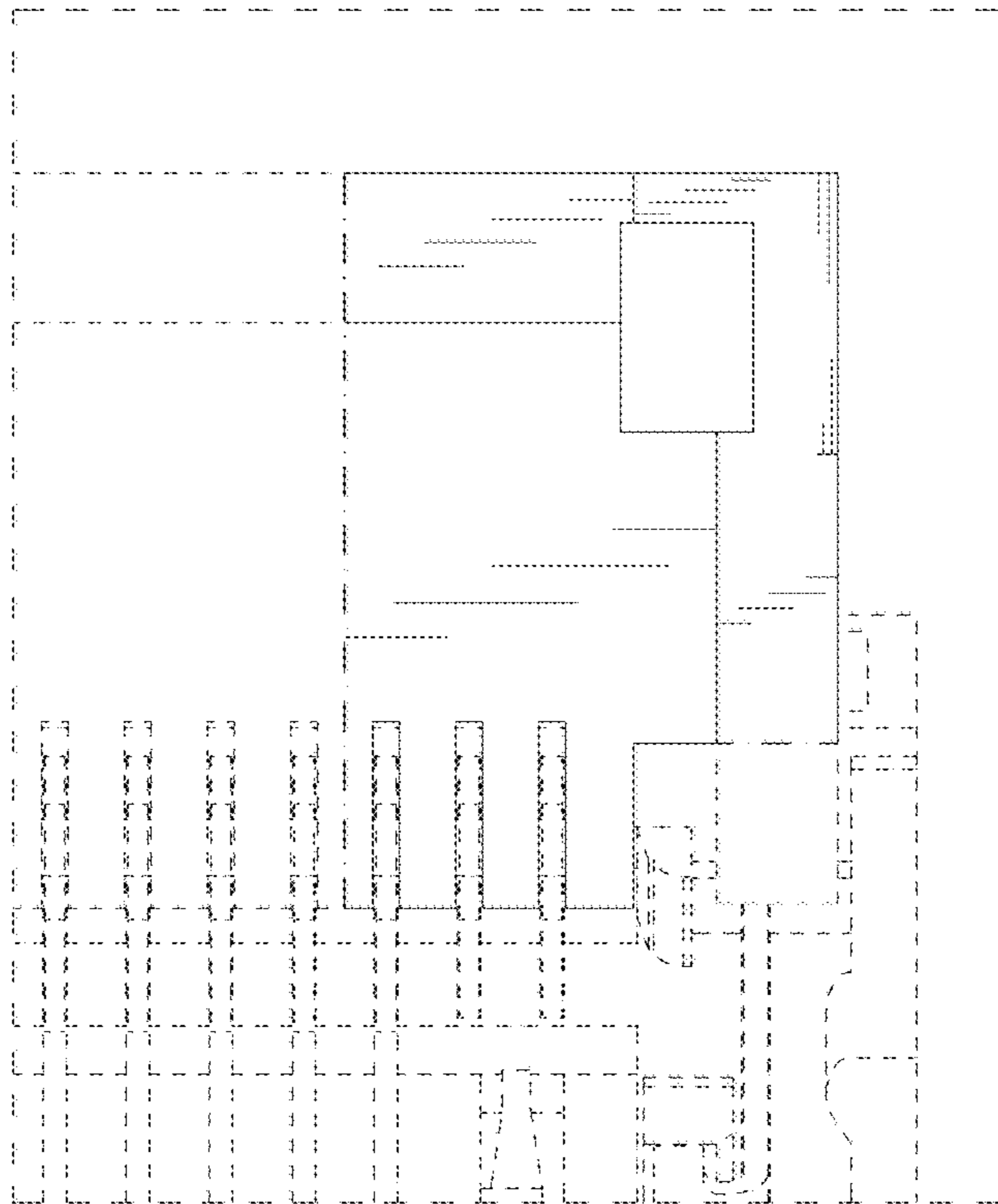

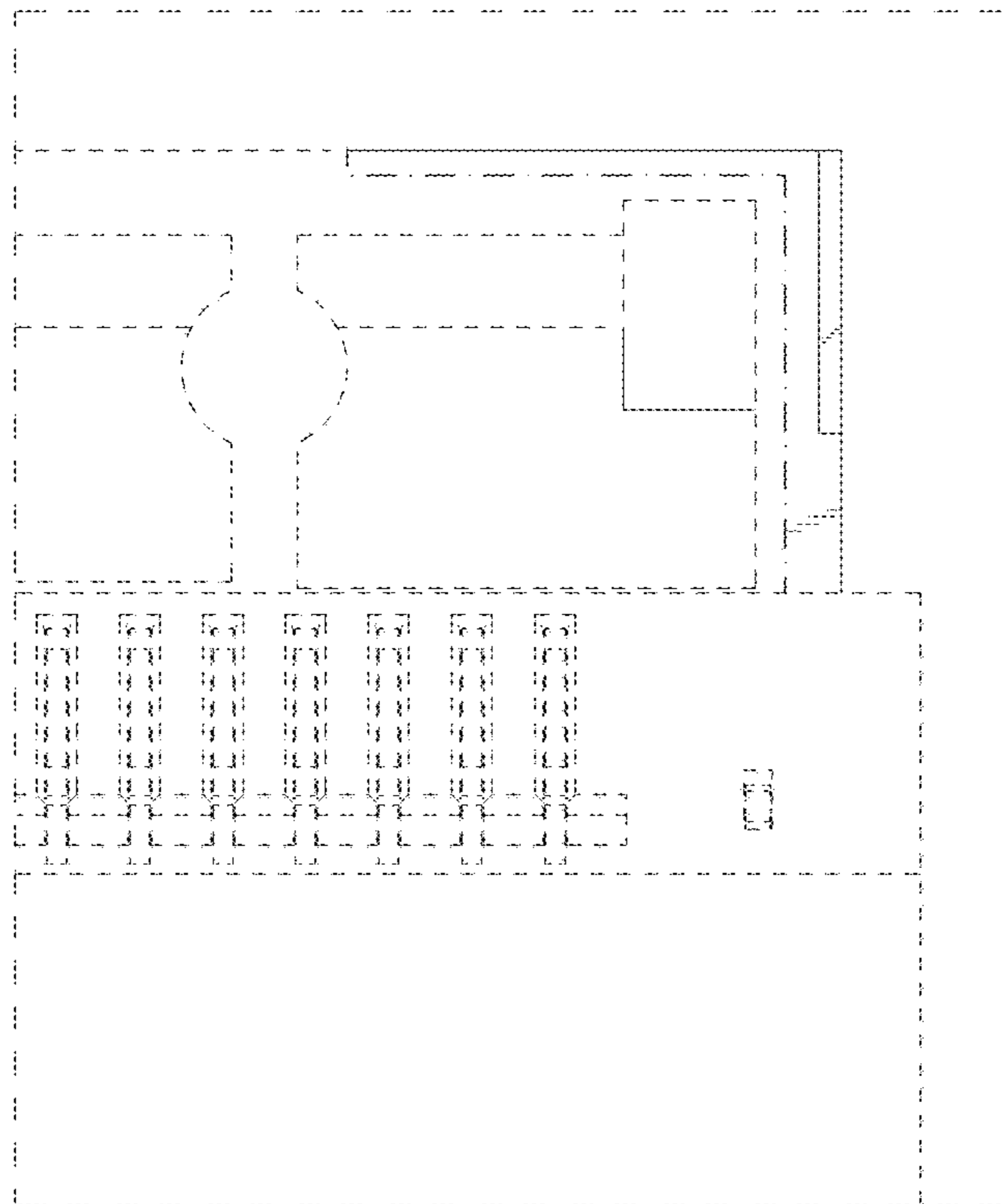

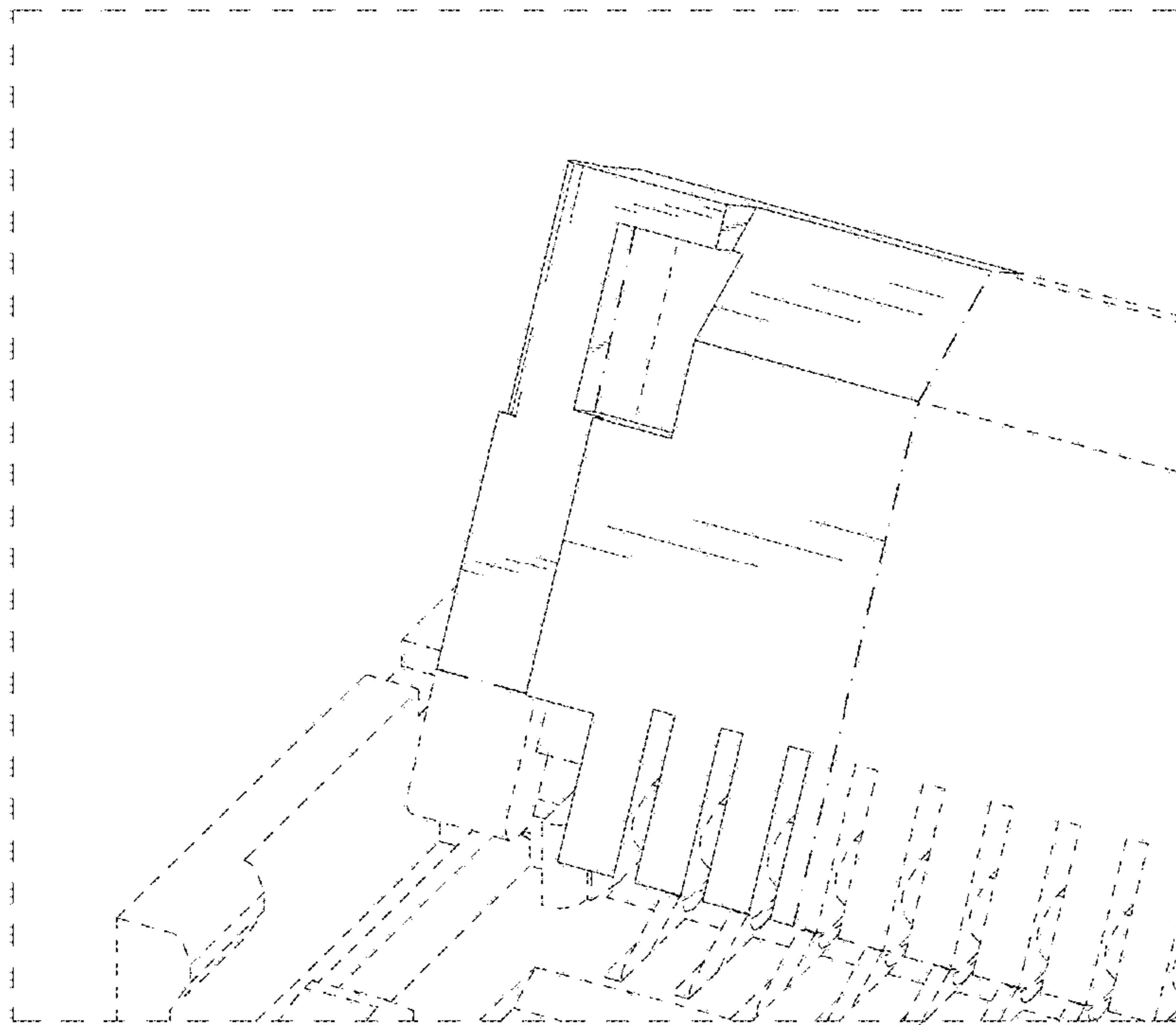

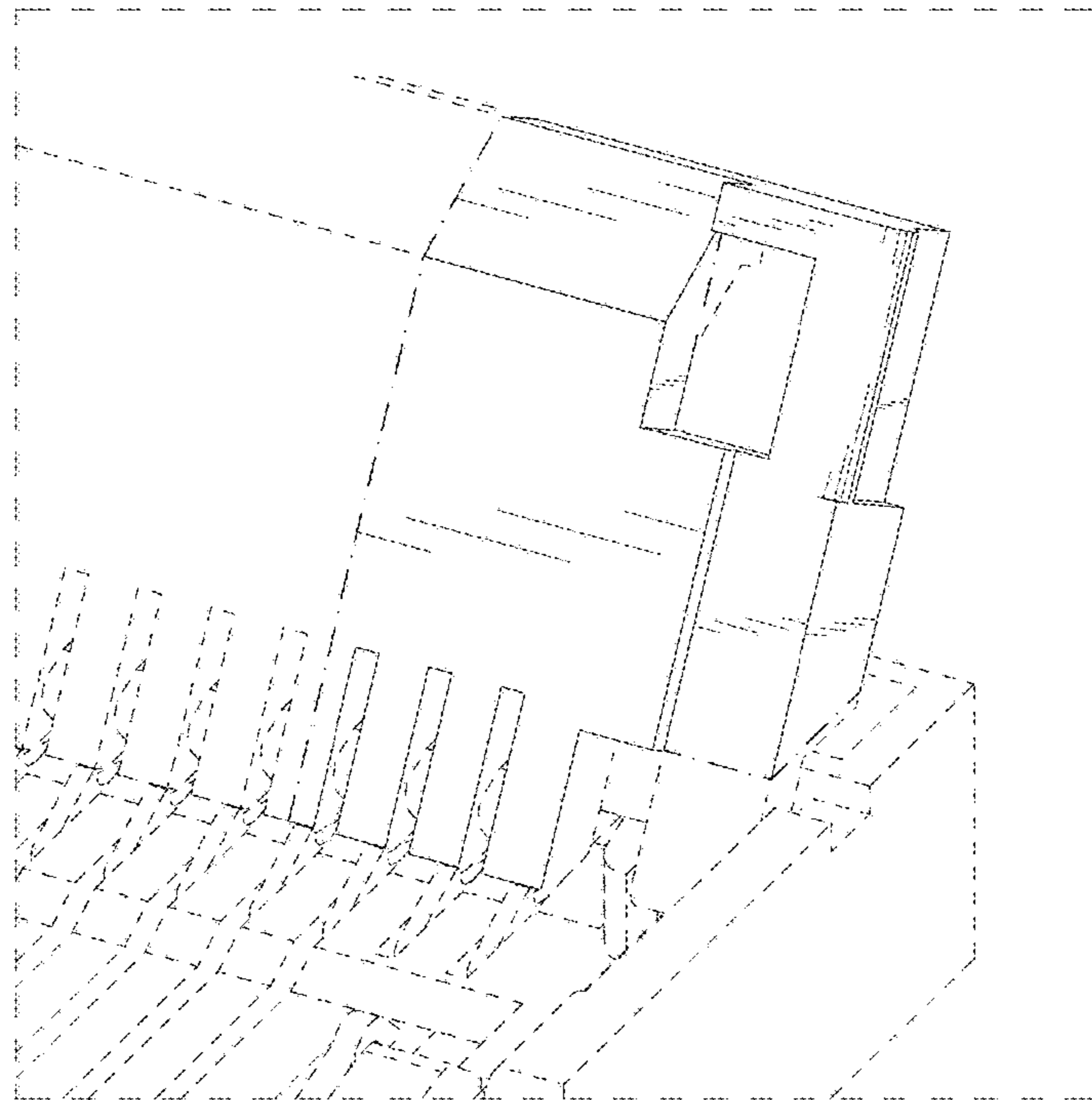

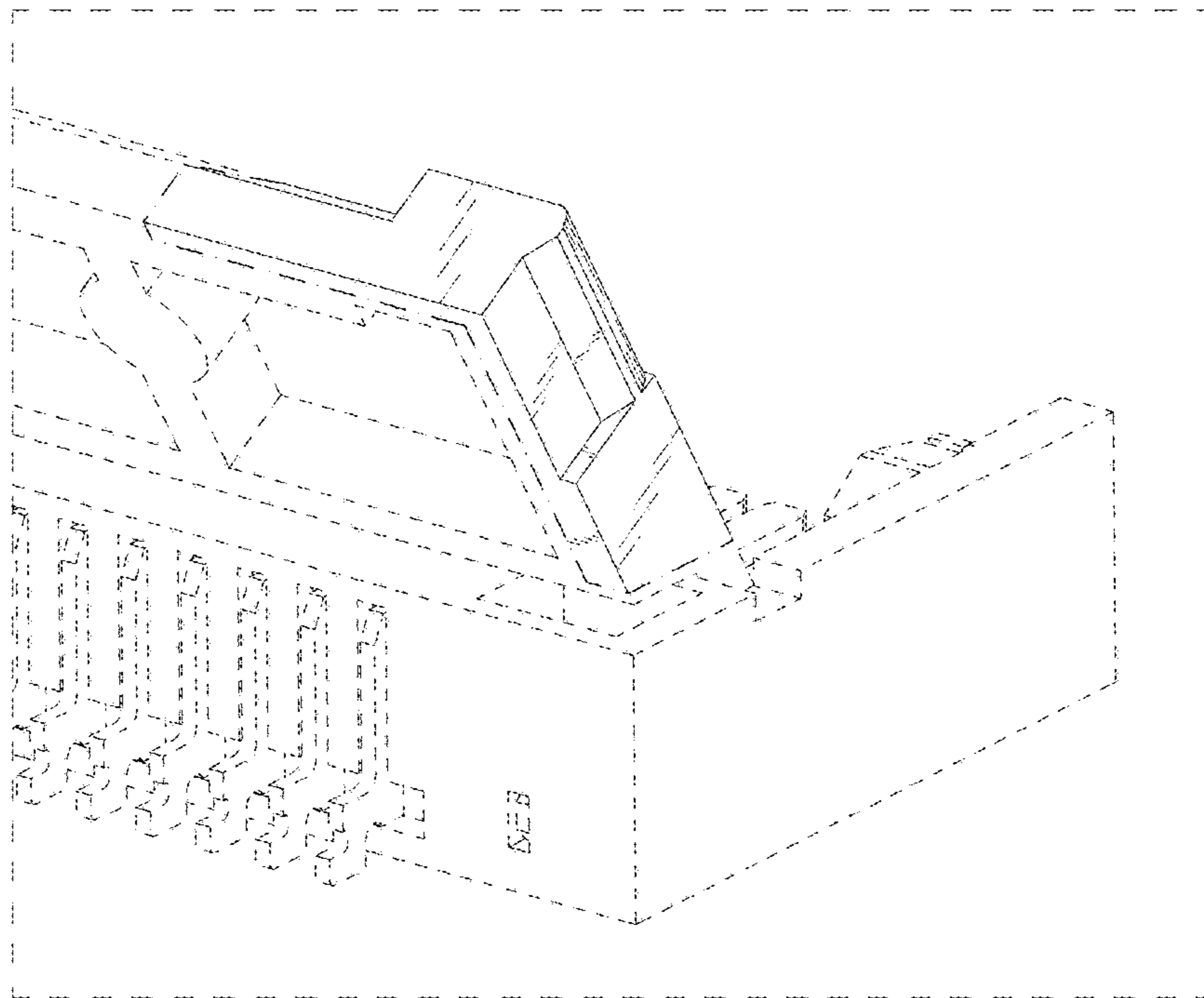
