FIG. 6 is a bottom plan view thereof.

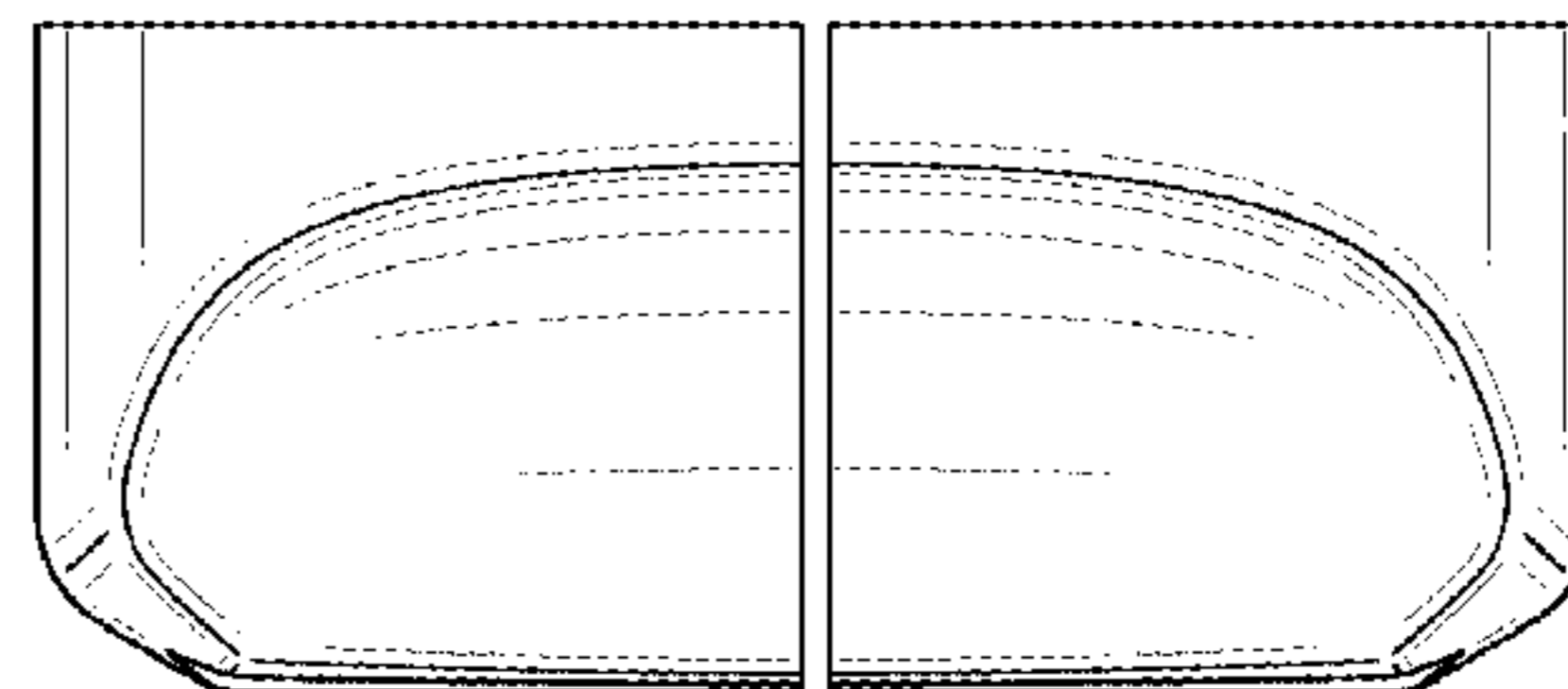
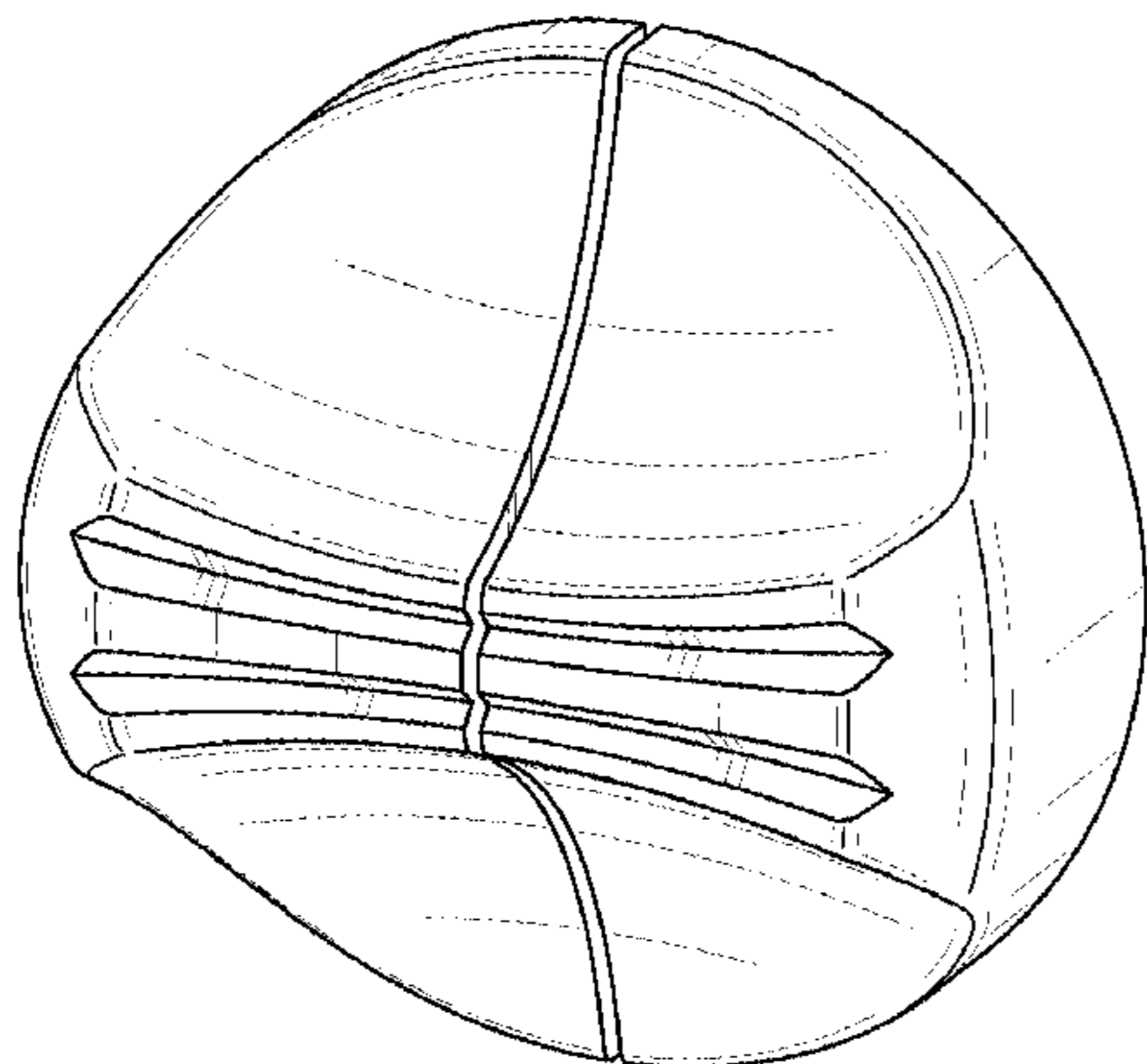
FIG. 7 is a left side elevation view thereof.

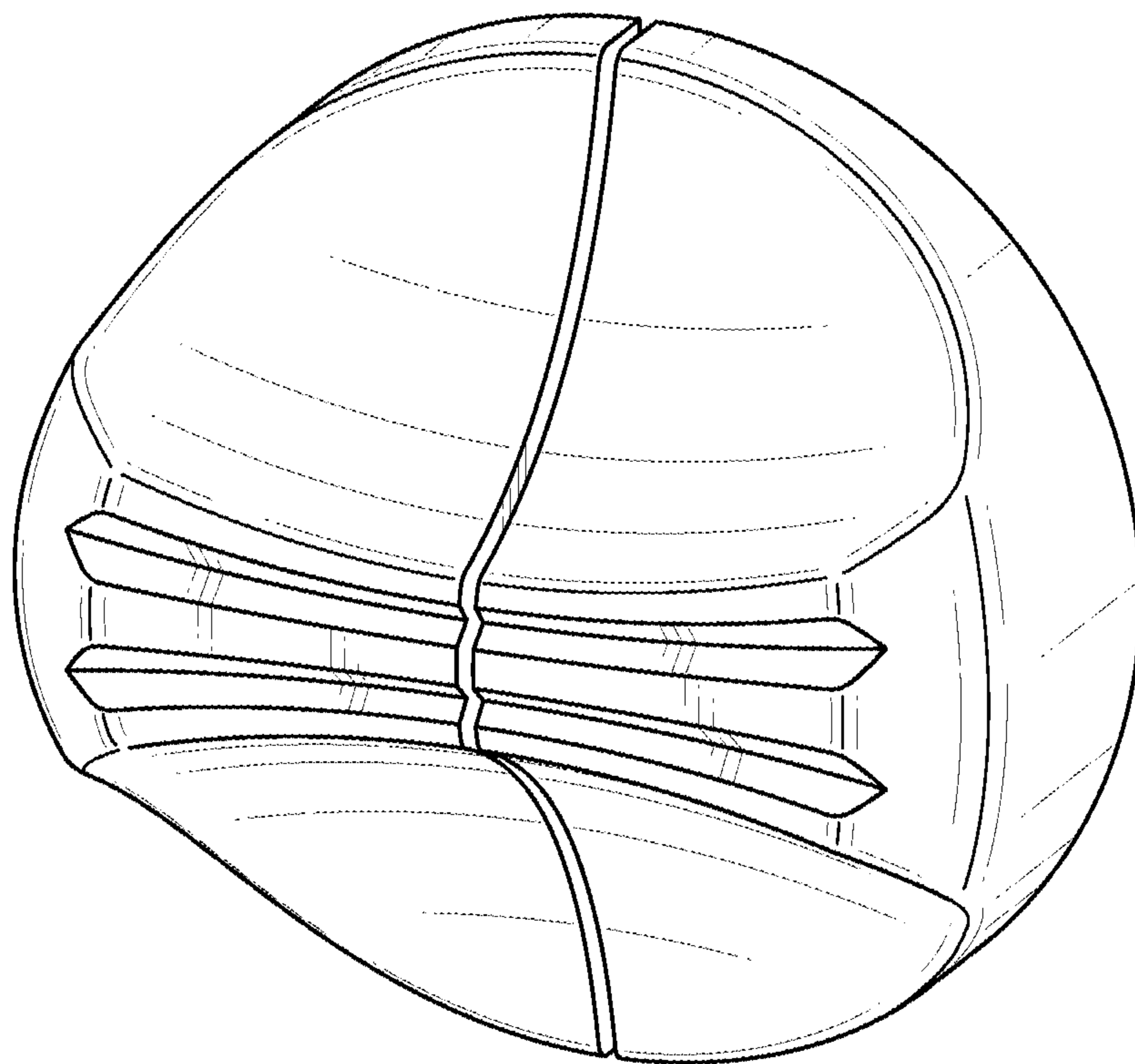

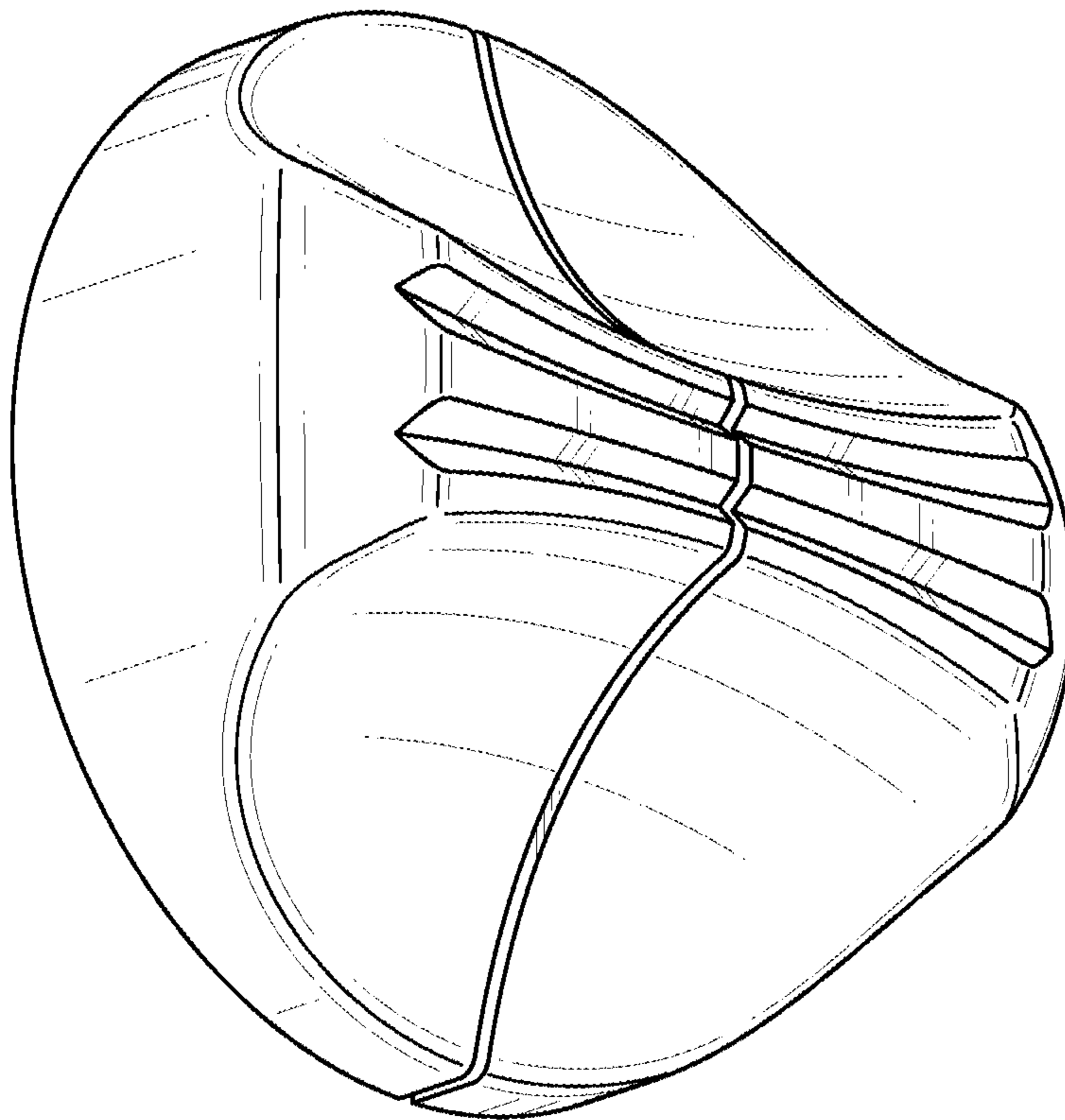

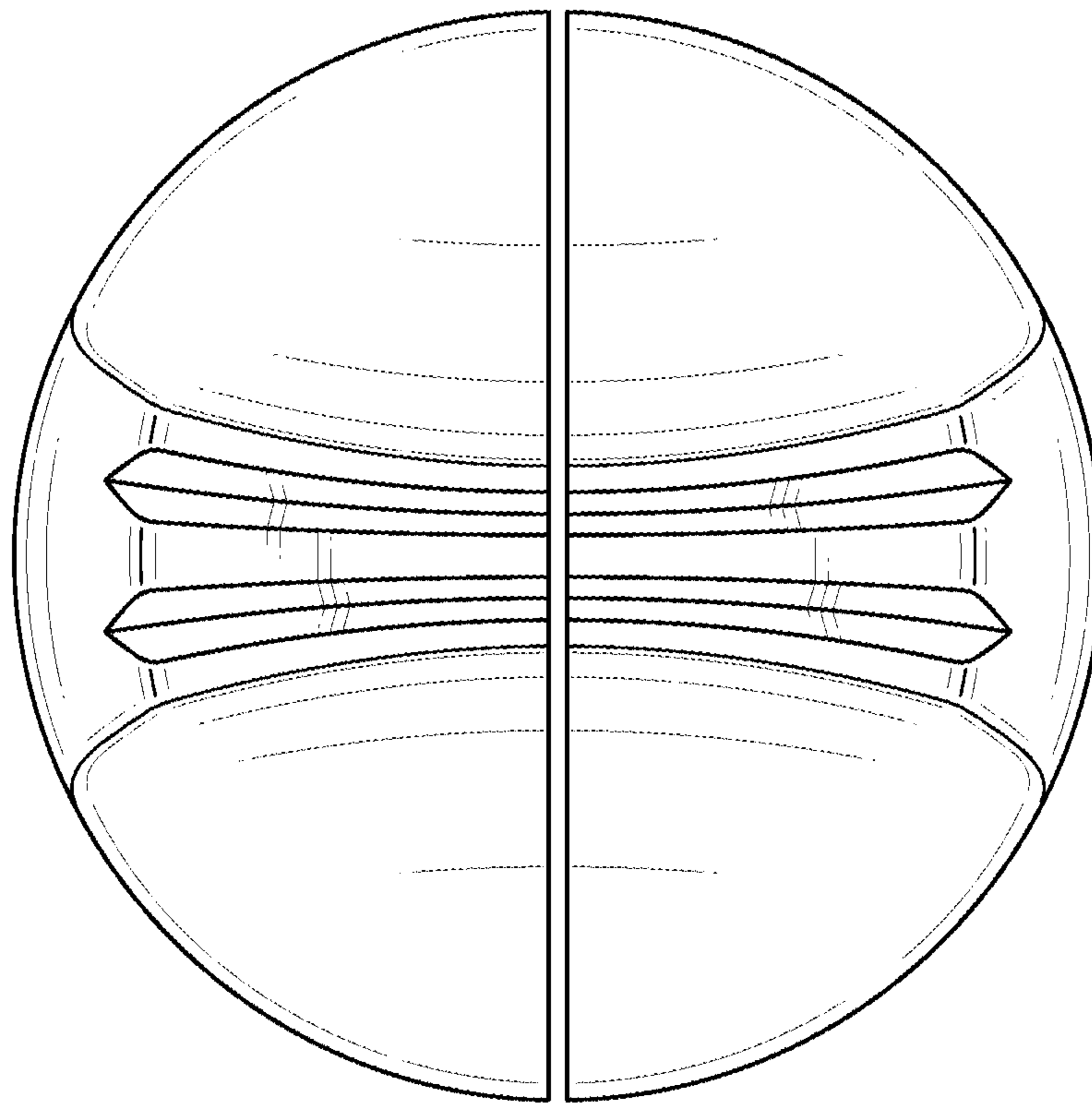

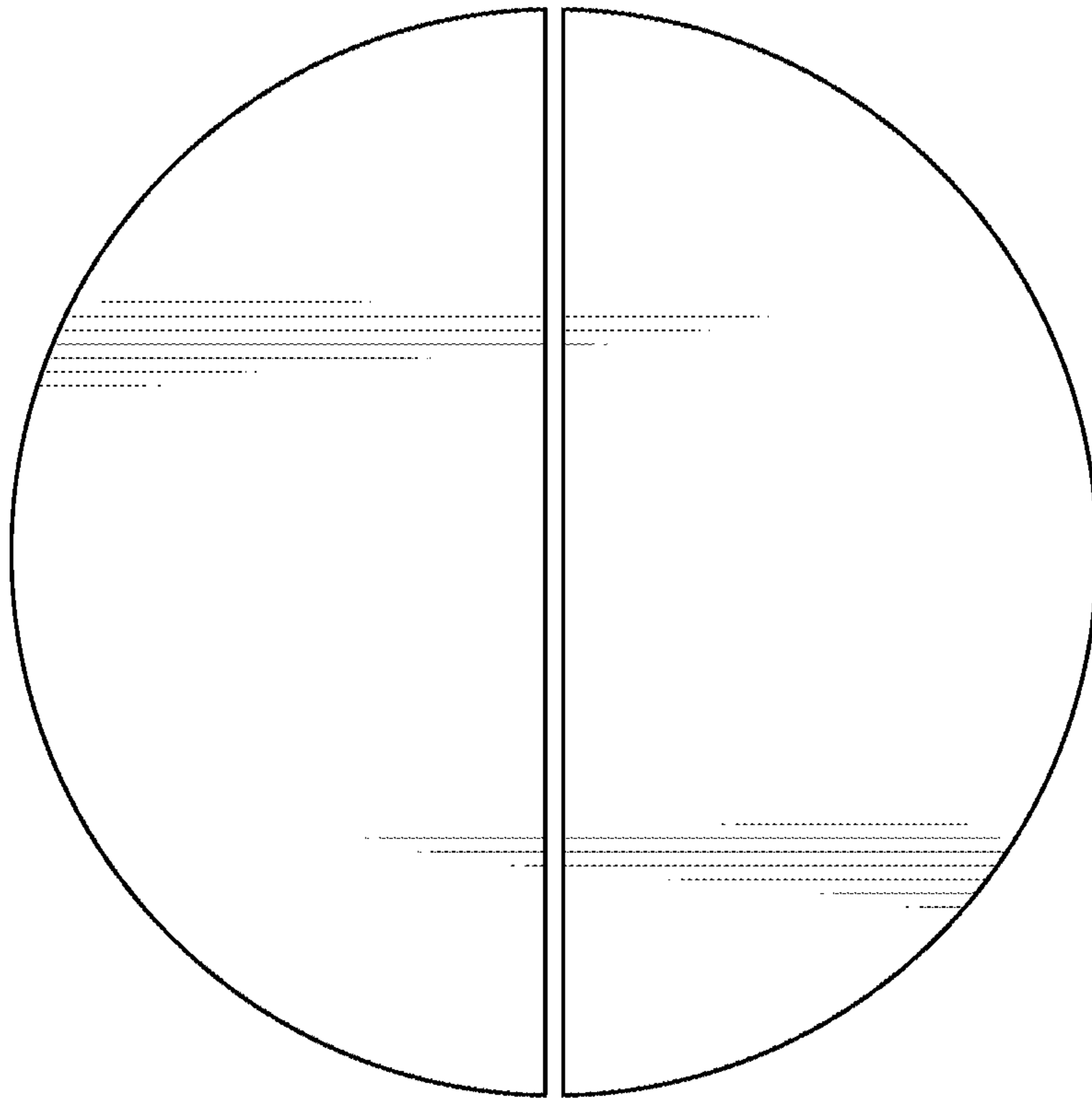

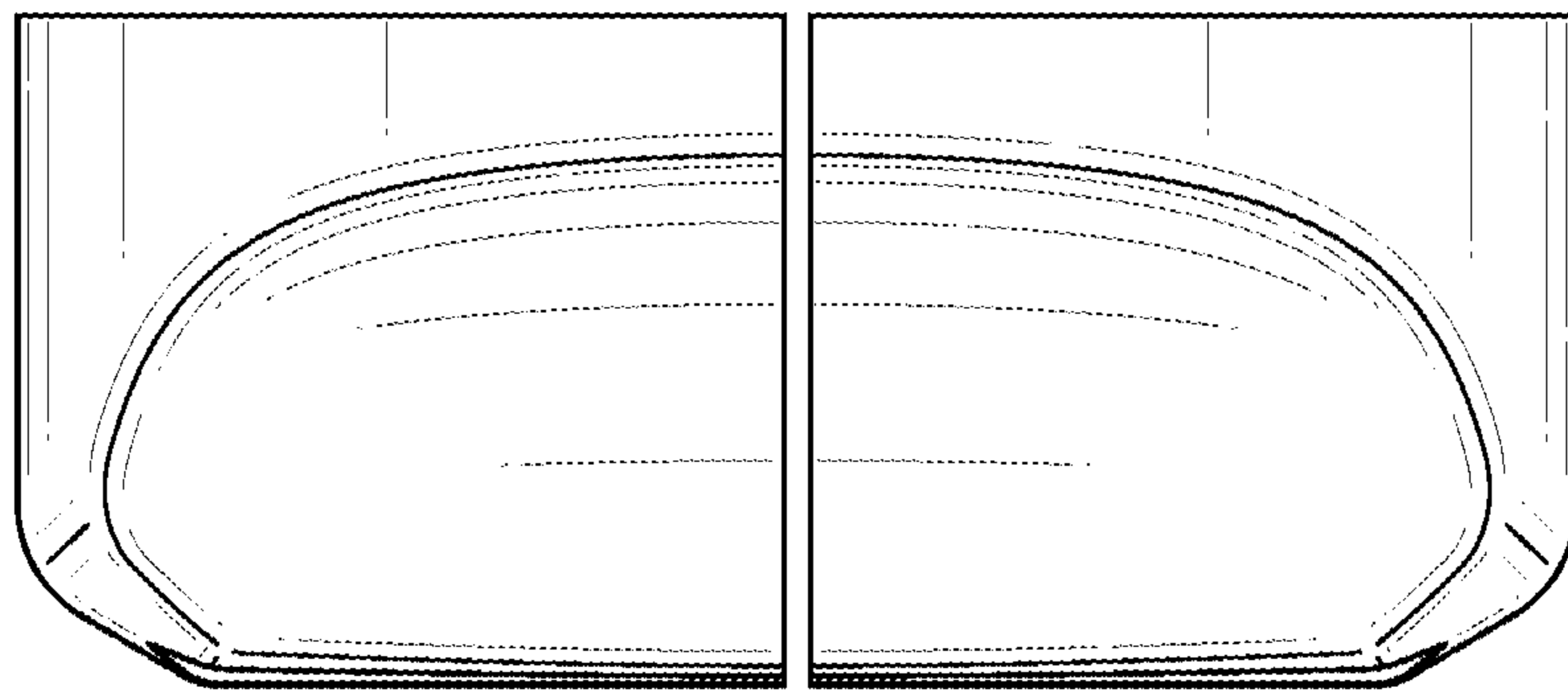

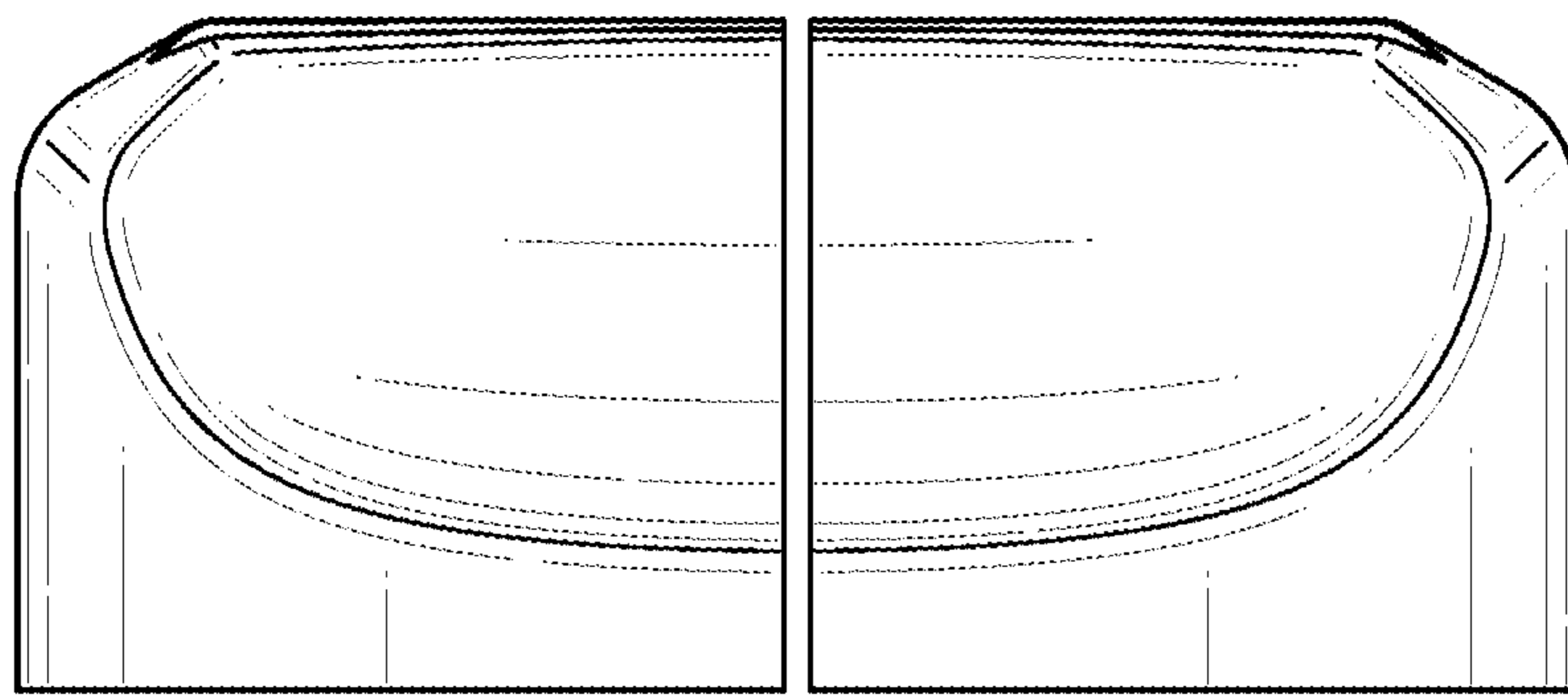

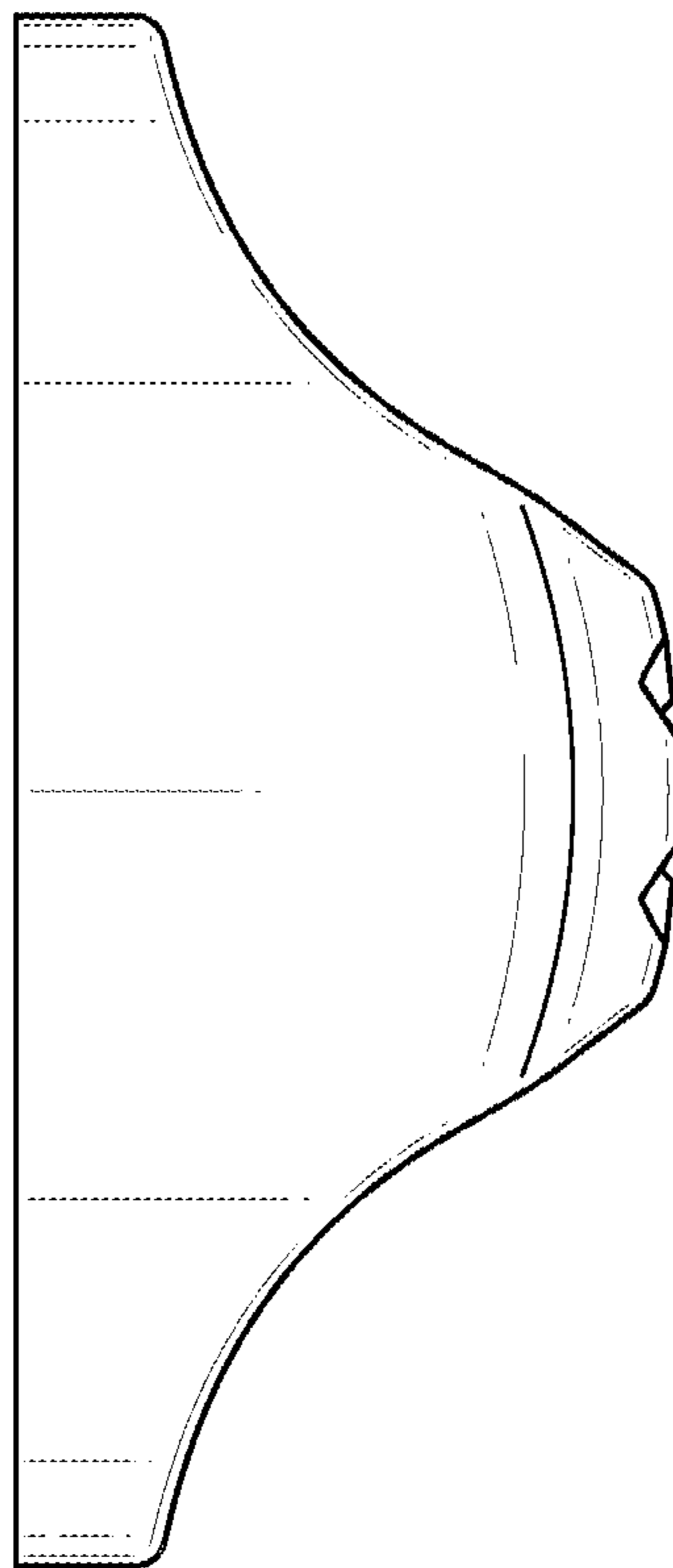

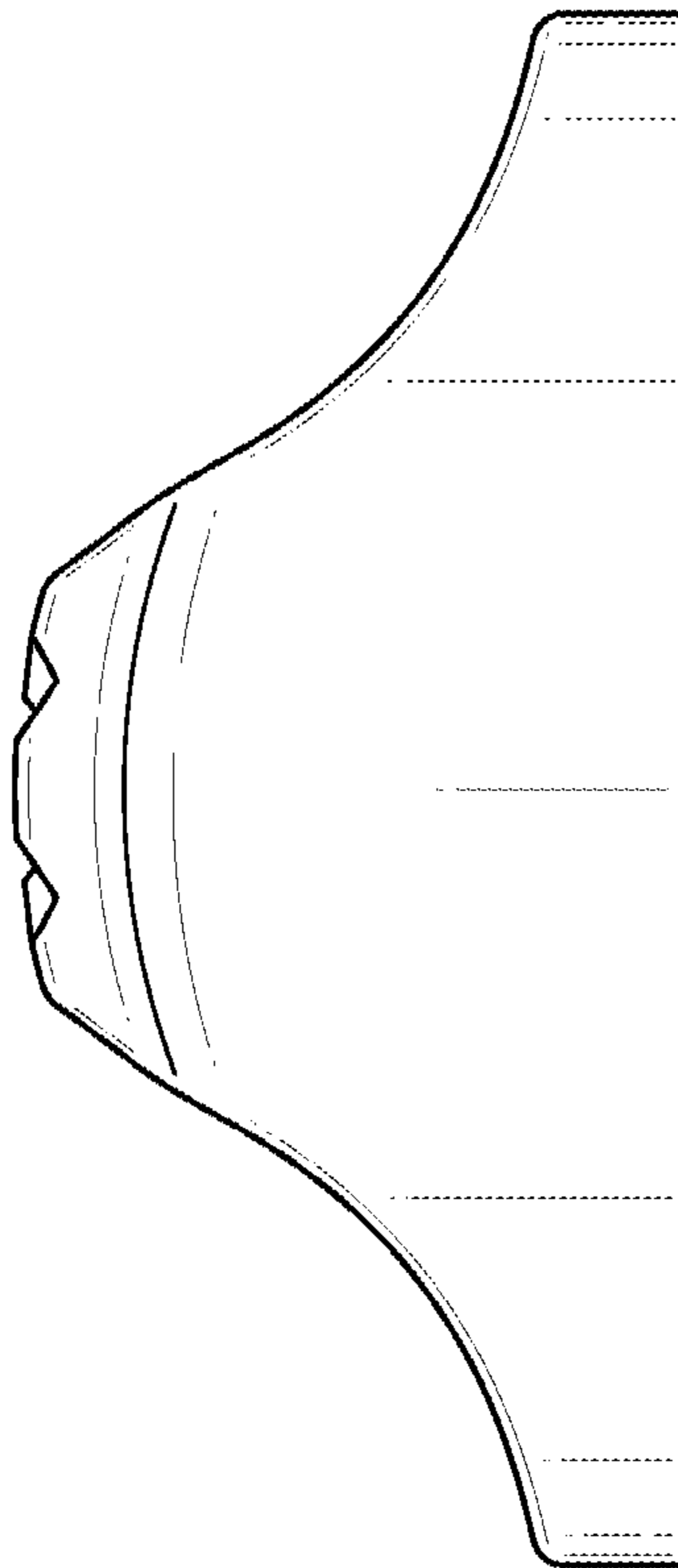
