(57) **CLAIM**

The ornamental design for a cell phone case with inlaid hockey stick shaft segments, as shown and described.

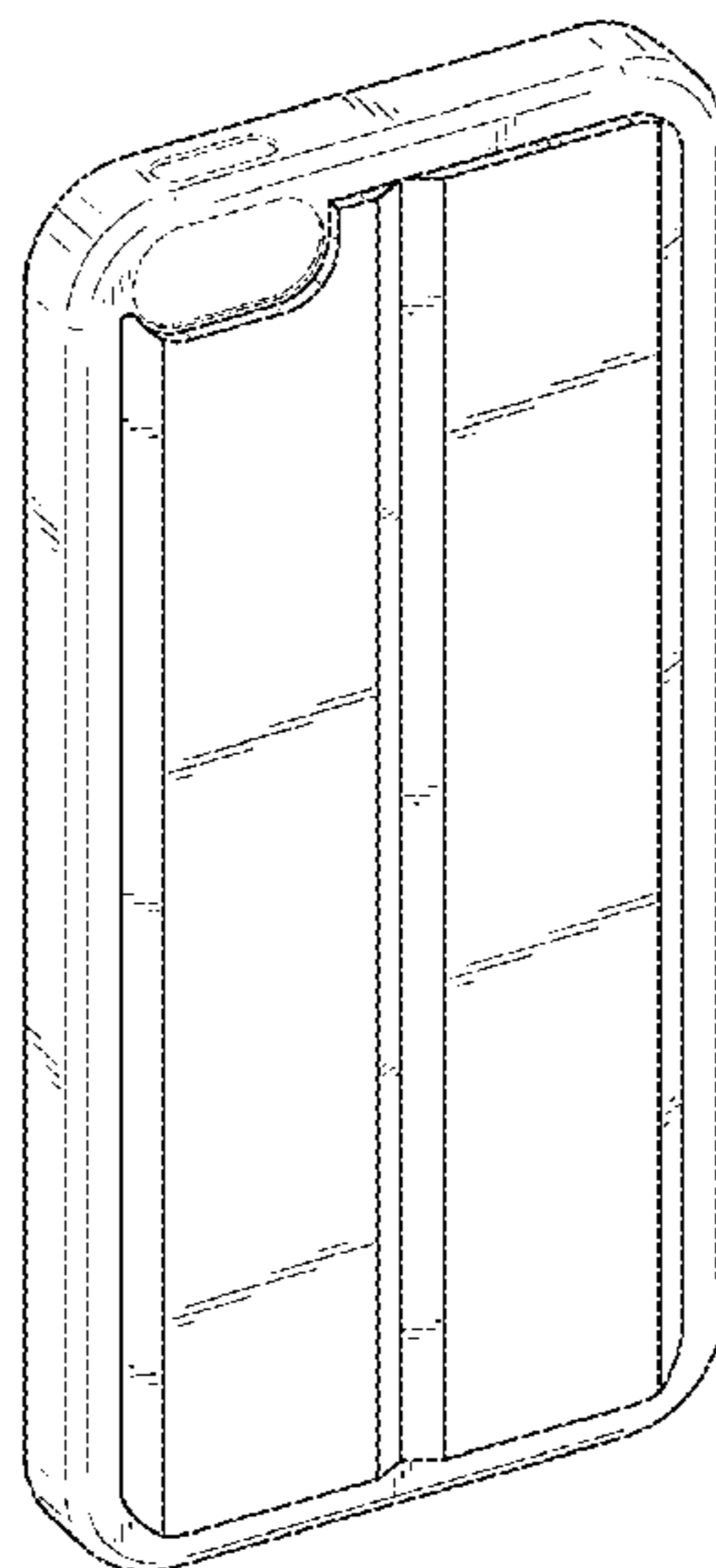
DESCRIPTION

FIG. 1 is a front perspective view of the cell phone case with inlaid hockey stick shaft segments showing my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

The broken lines shown in the drawings illustrate portions of the cell phone case with inlaid hockey stick shaft segments that form no part of the claimed design.

The dash-dot-dash lines shown in FIG. 3 shows a boundary and forms no part of the claim.

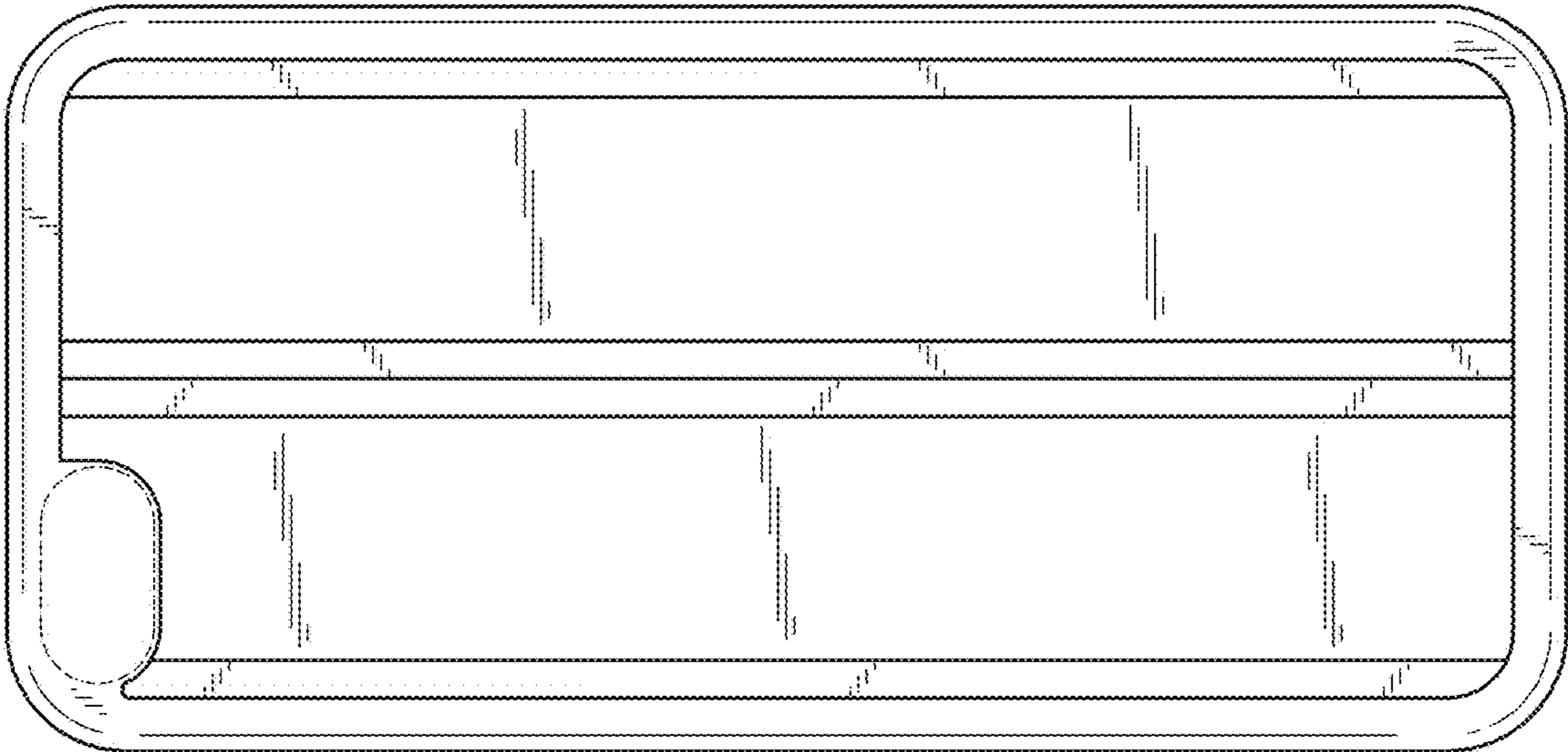

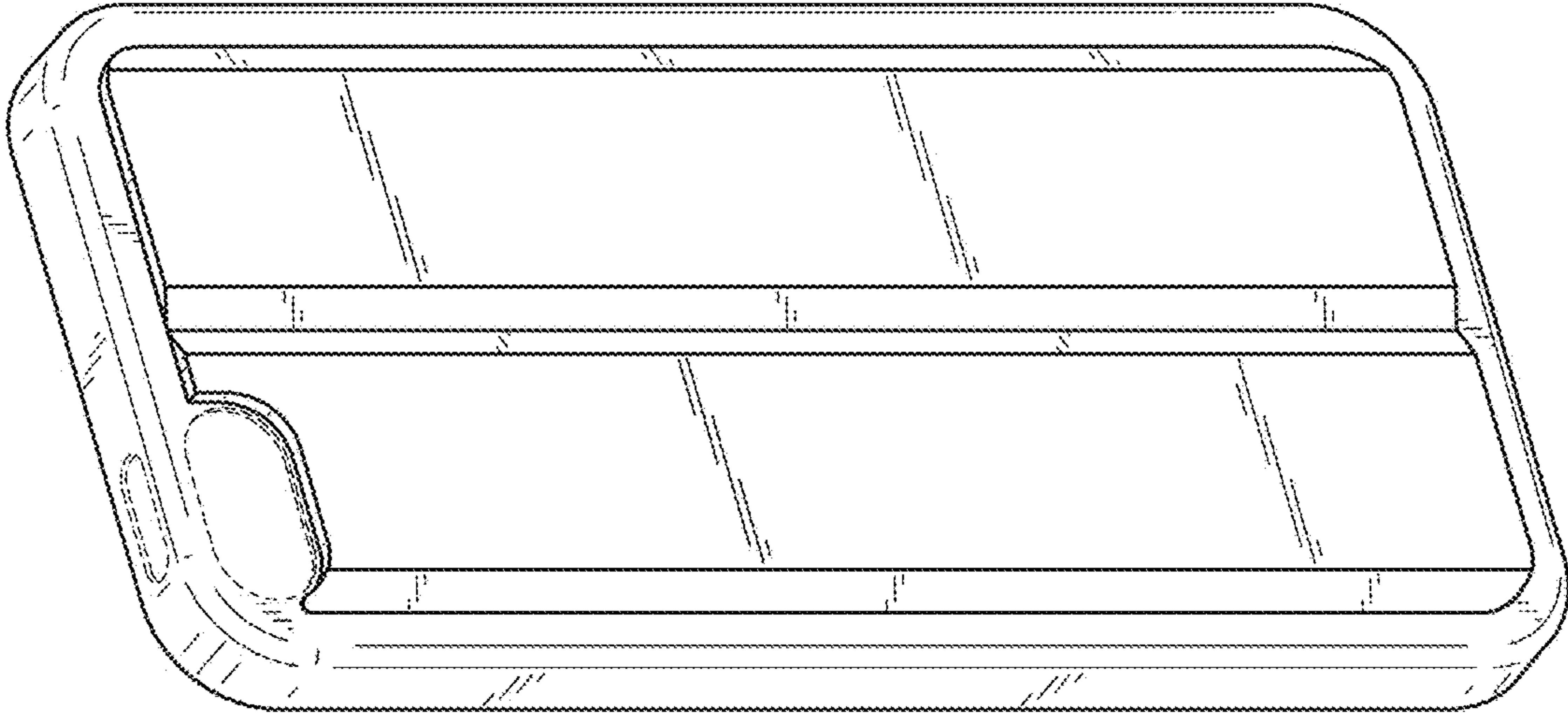

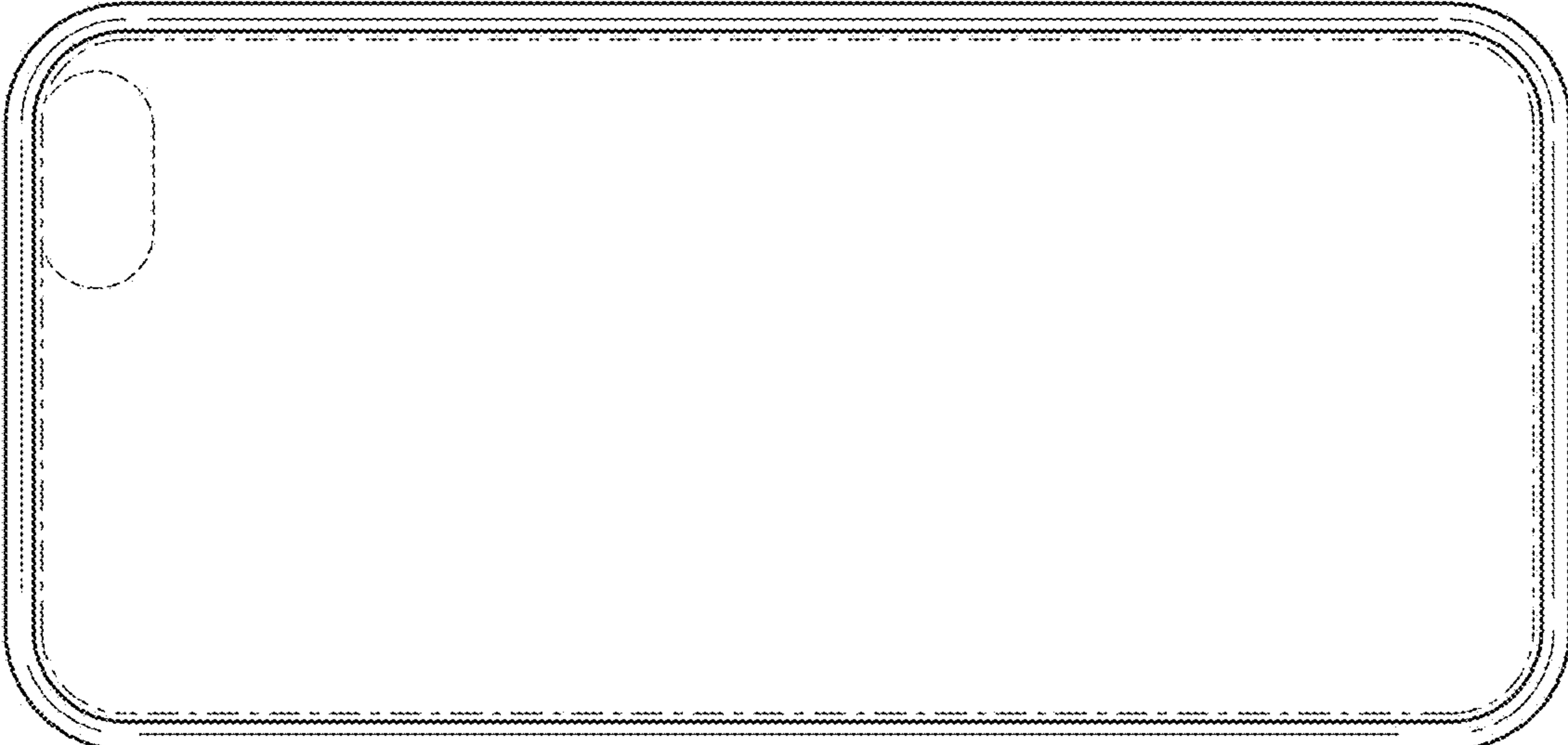

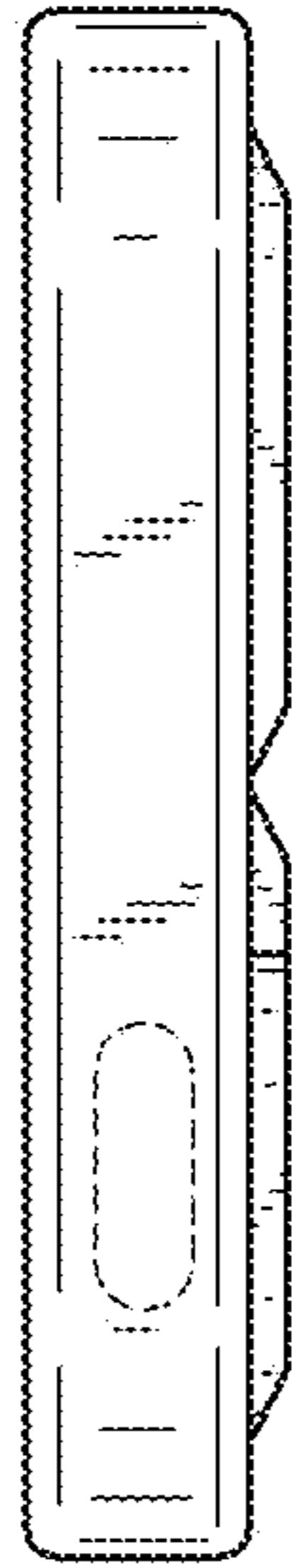

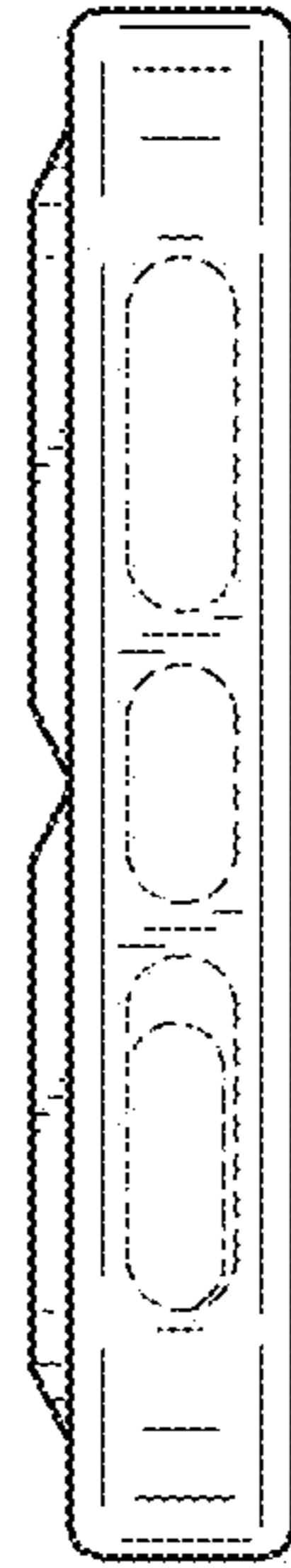
