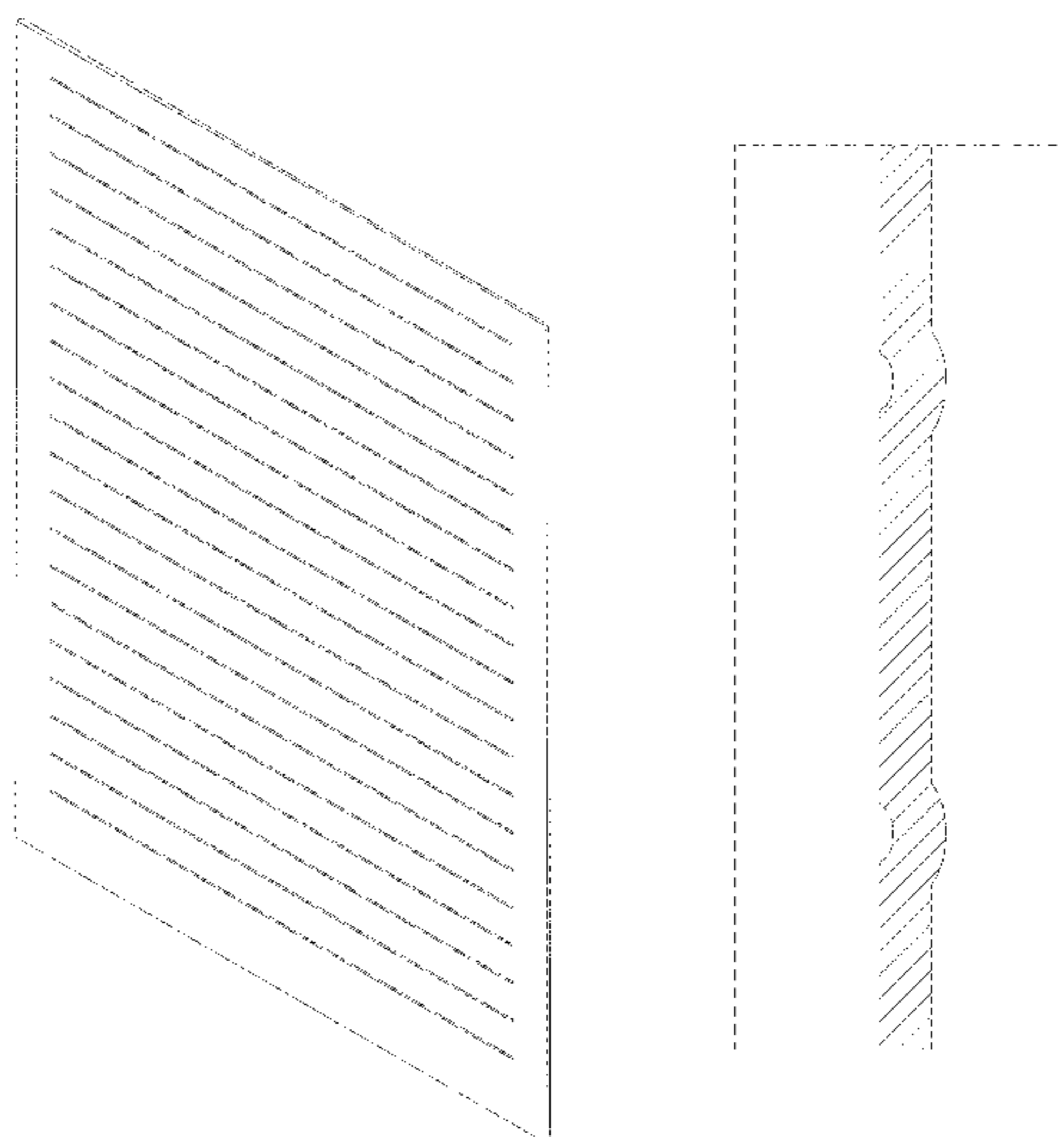

DESCRIPTION

FIG. 1 is a front perspective view of a sheet of paper showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a cross-sectional view taken along line 4-4 in FIG. 2;
FIG. 5 is a top plan view thereof, the bottom plan view being a mirror image thereof; and,
FIG. 6 is an enlarged detail of the circumscribed area in FIG. 4.

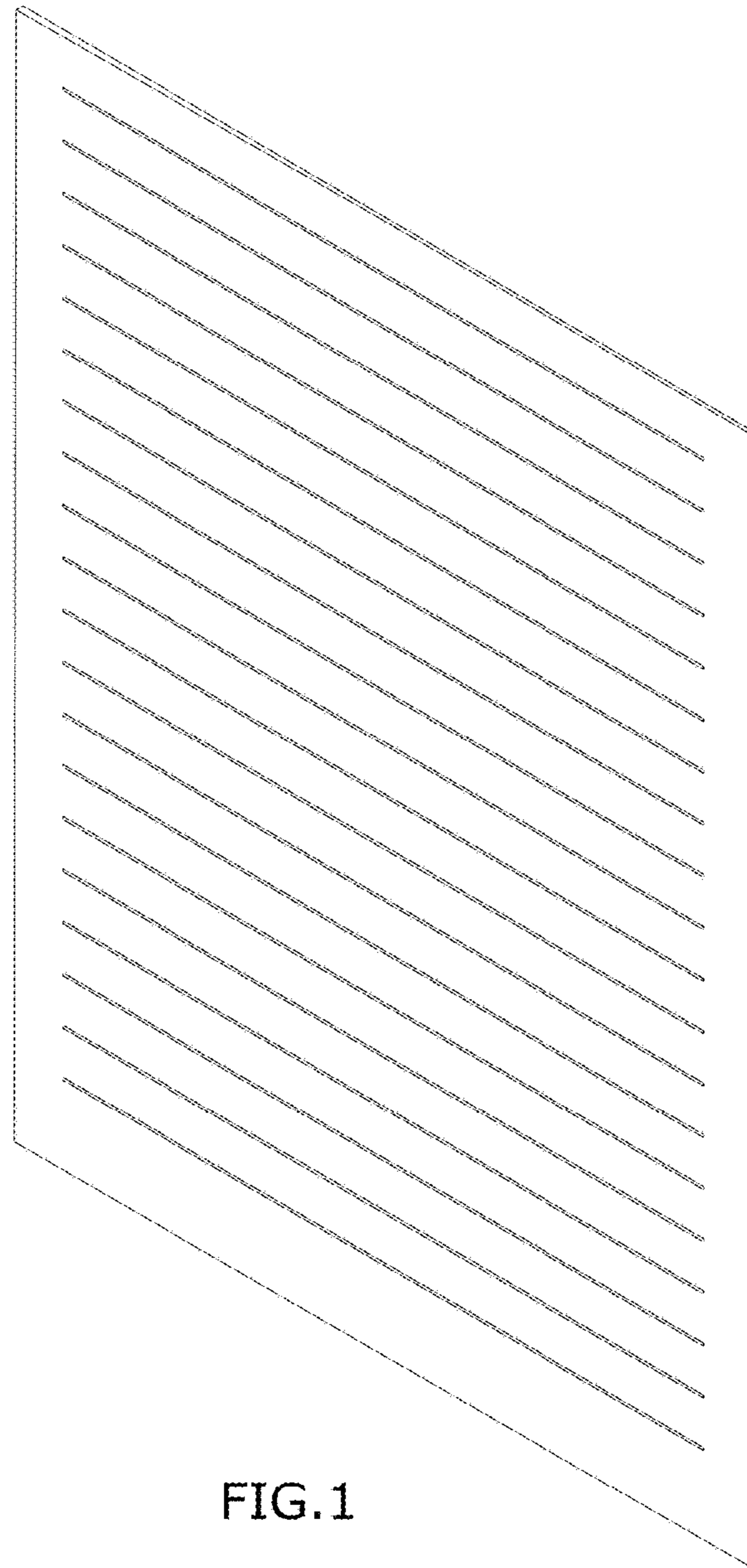

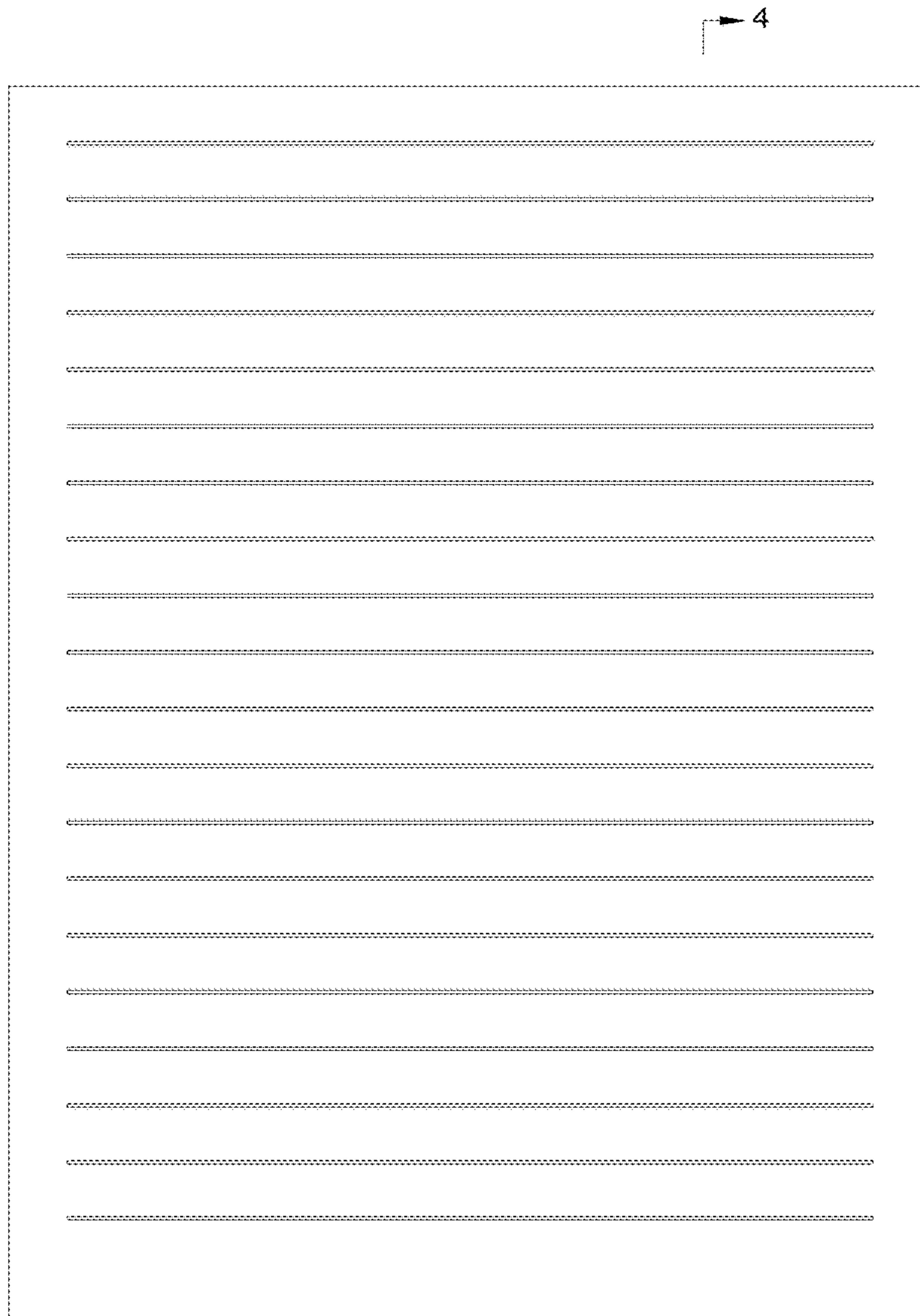

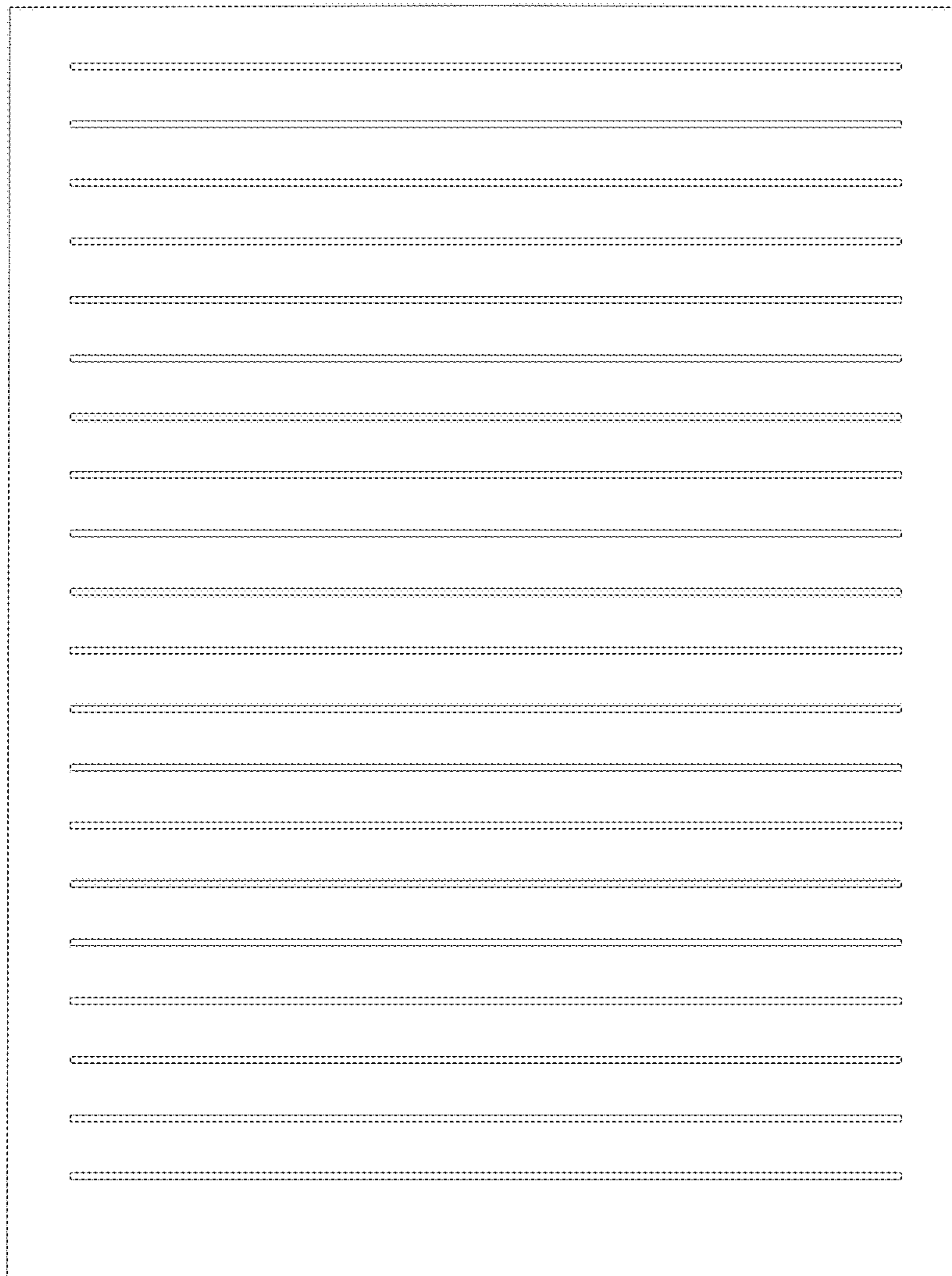

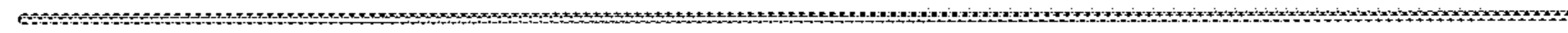

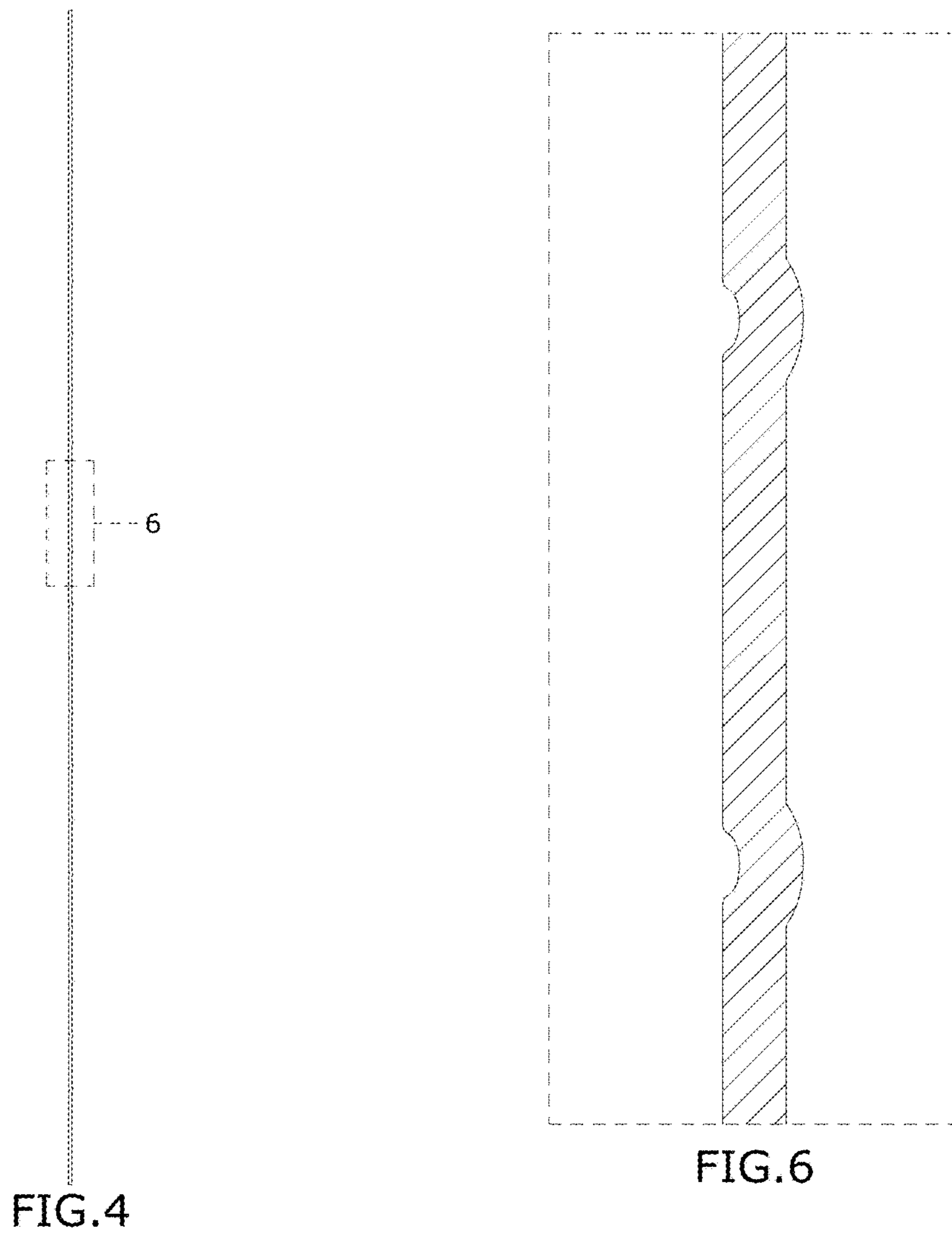
