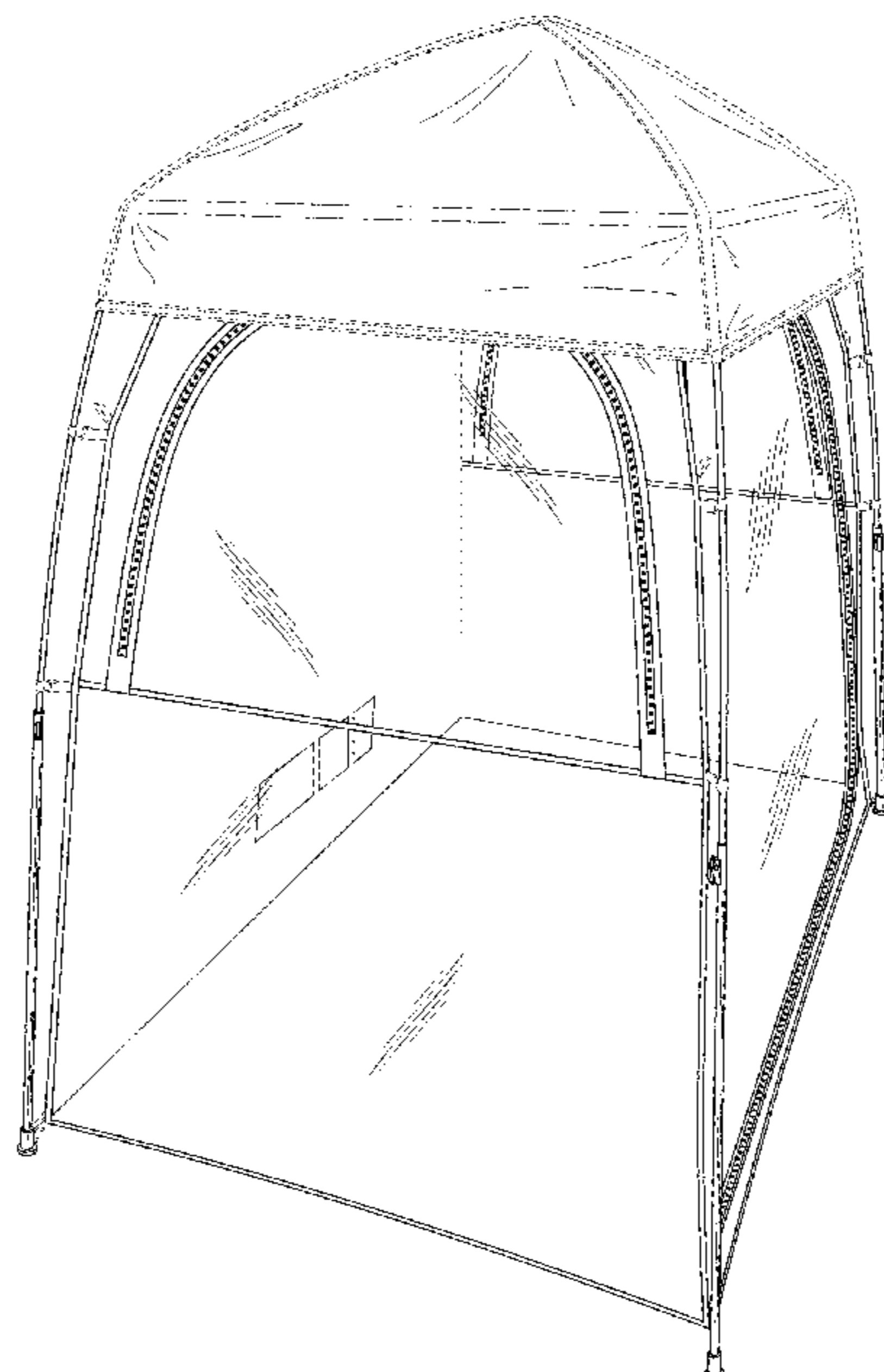
The ornamental design for a tent, as shown and described.

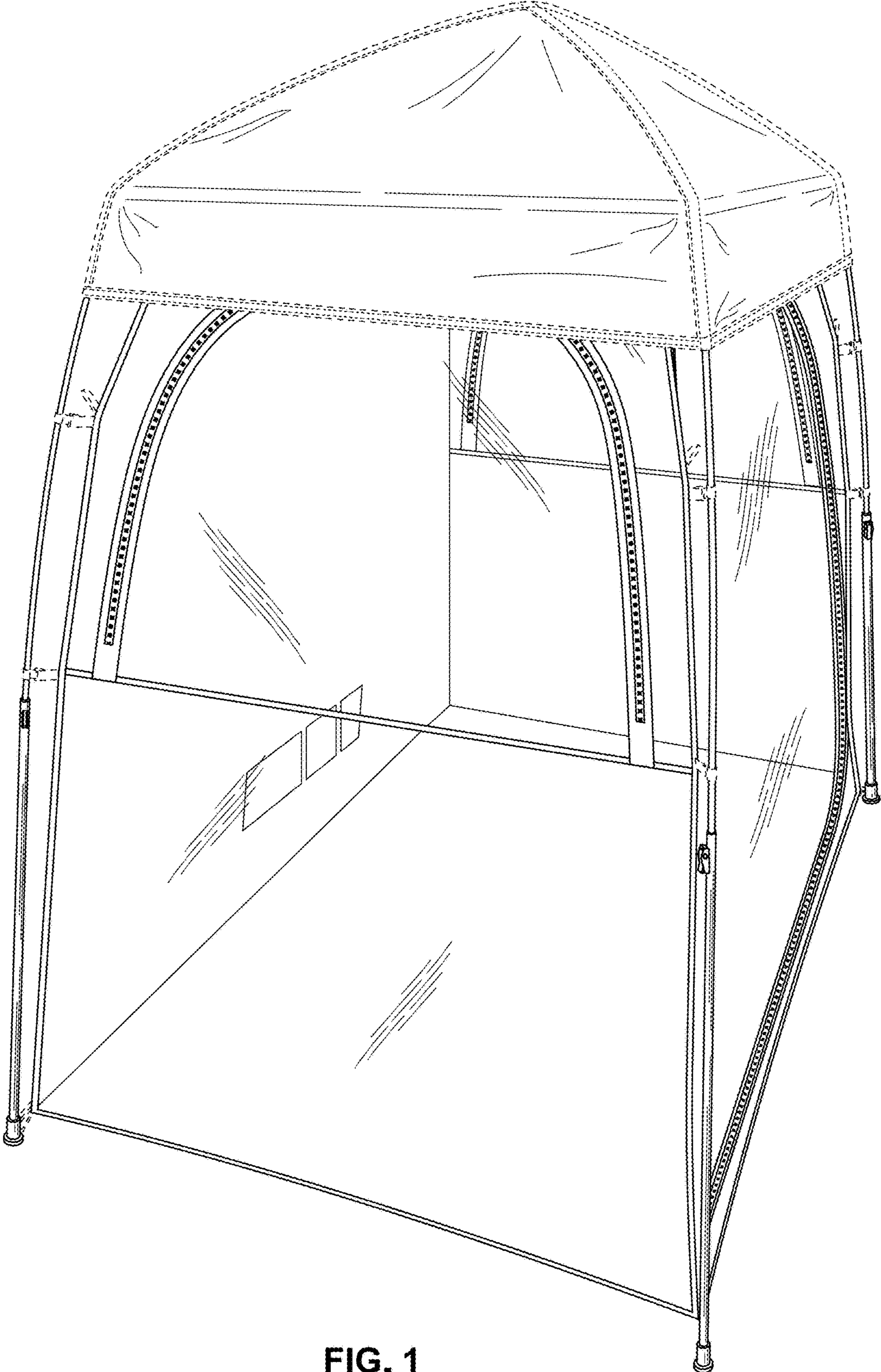

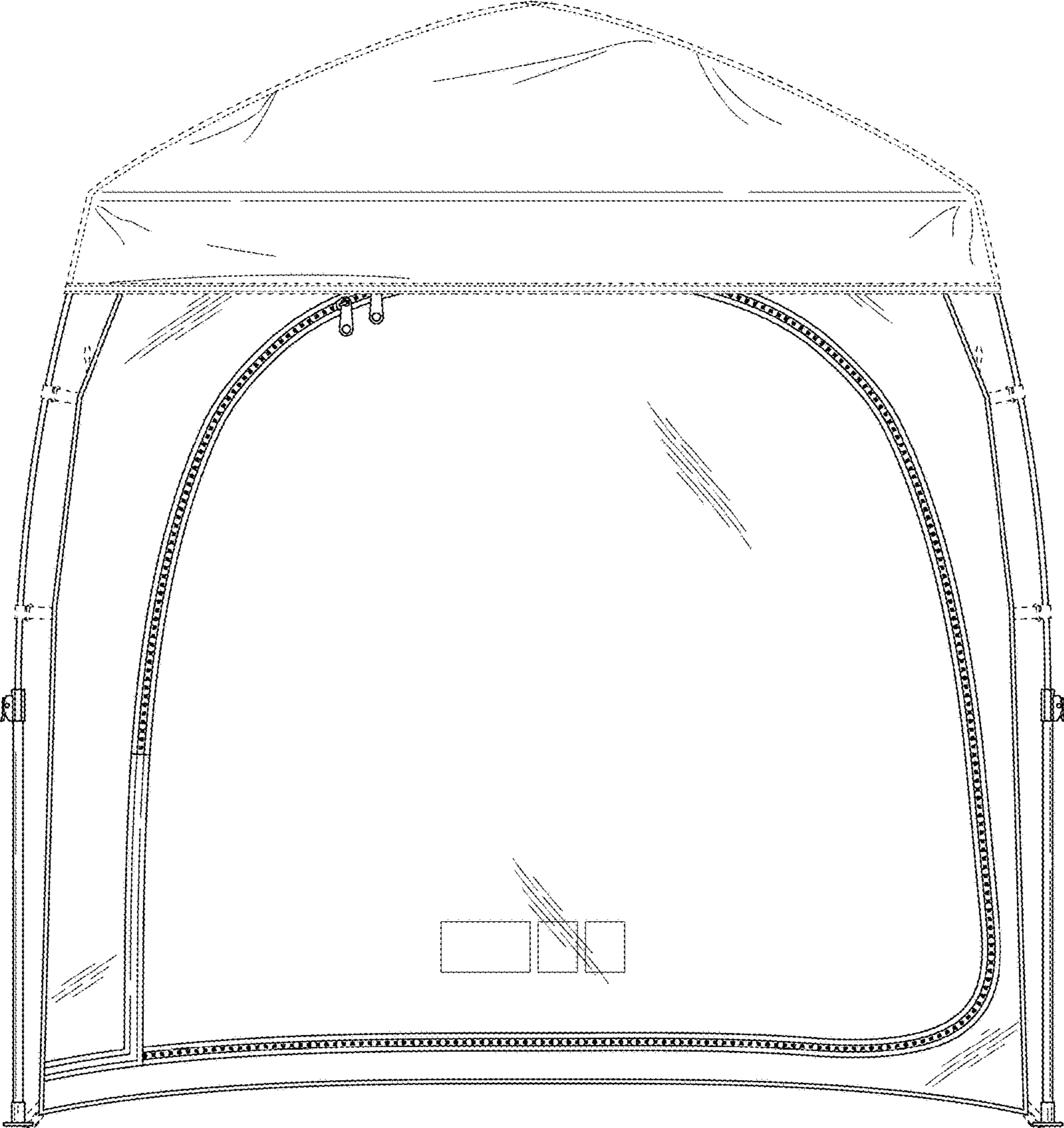

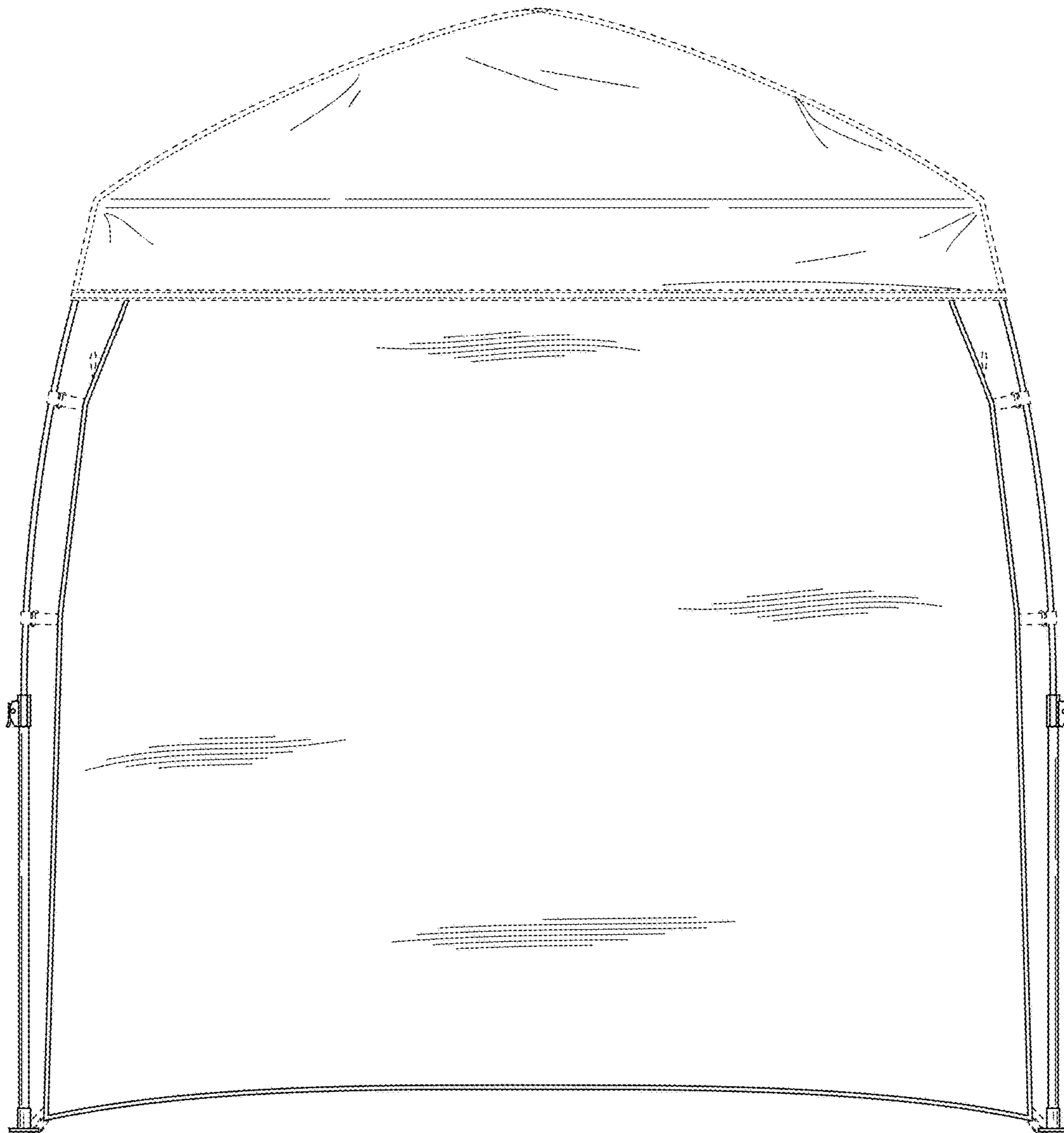

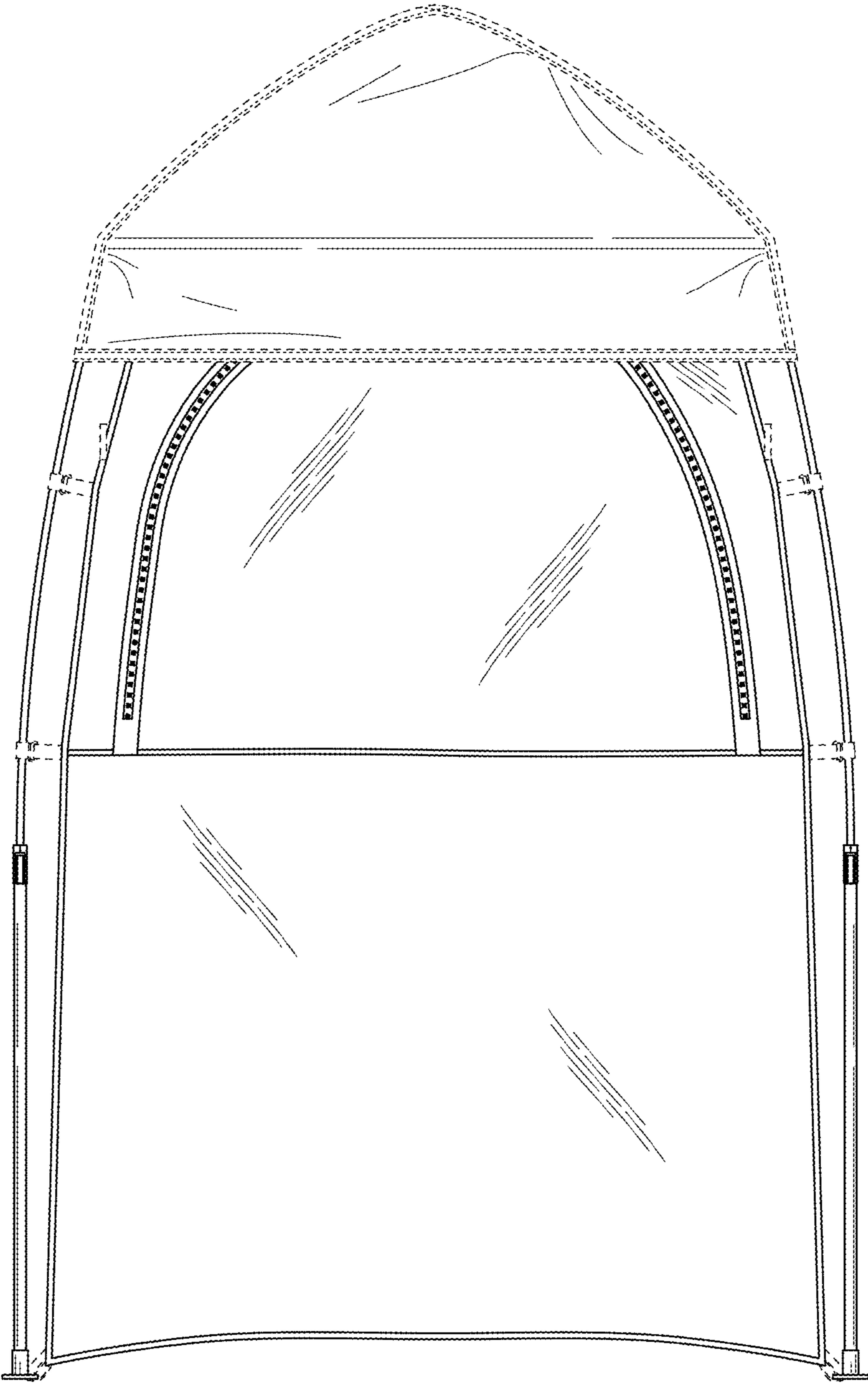

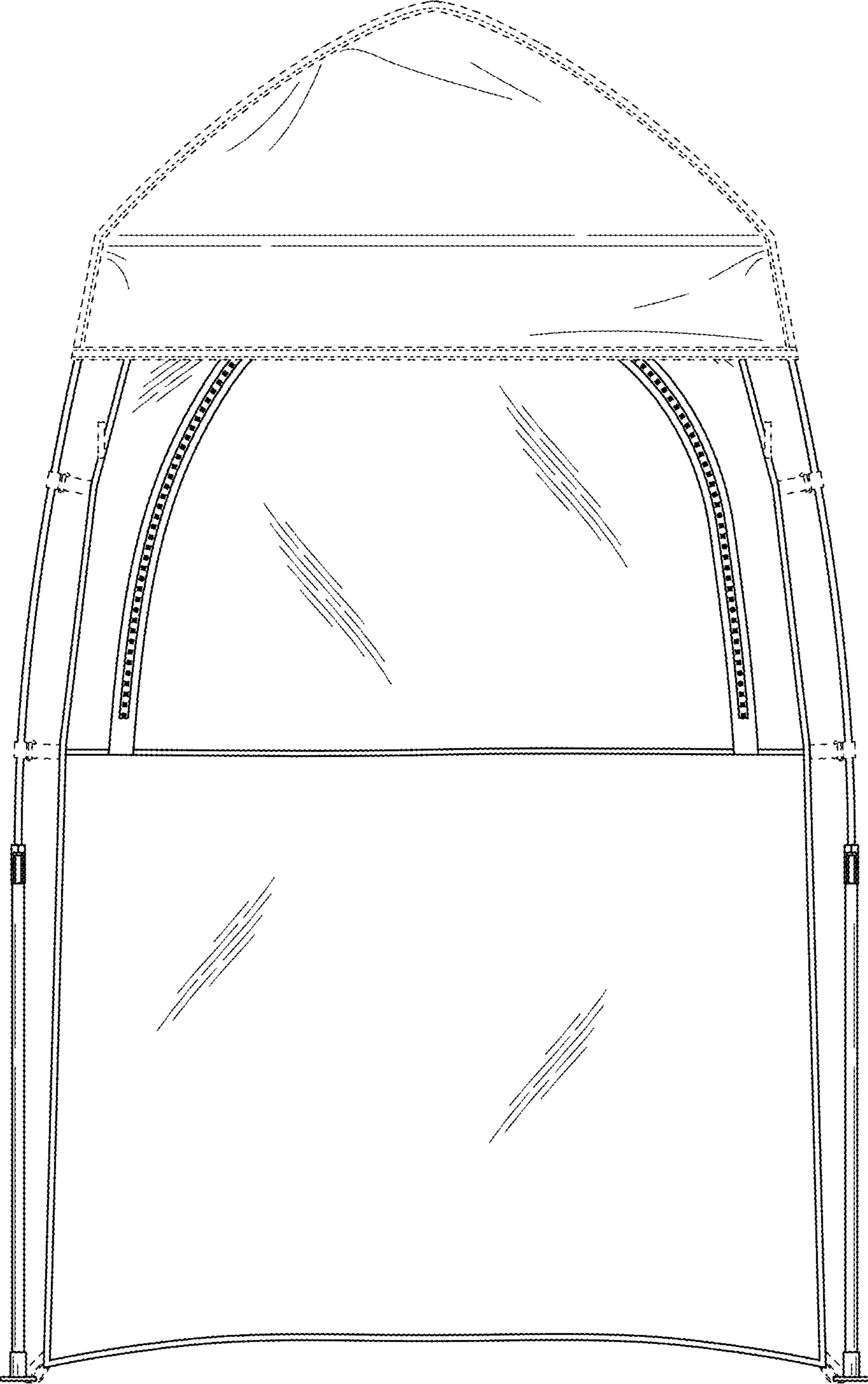

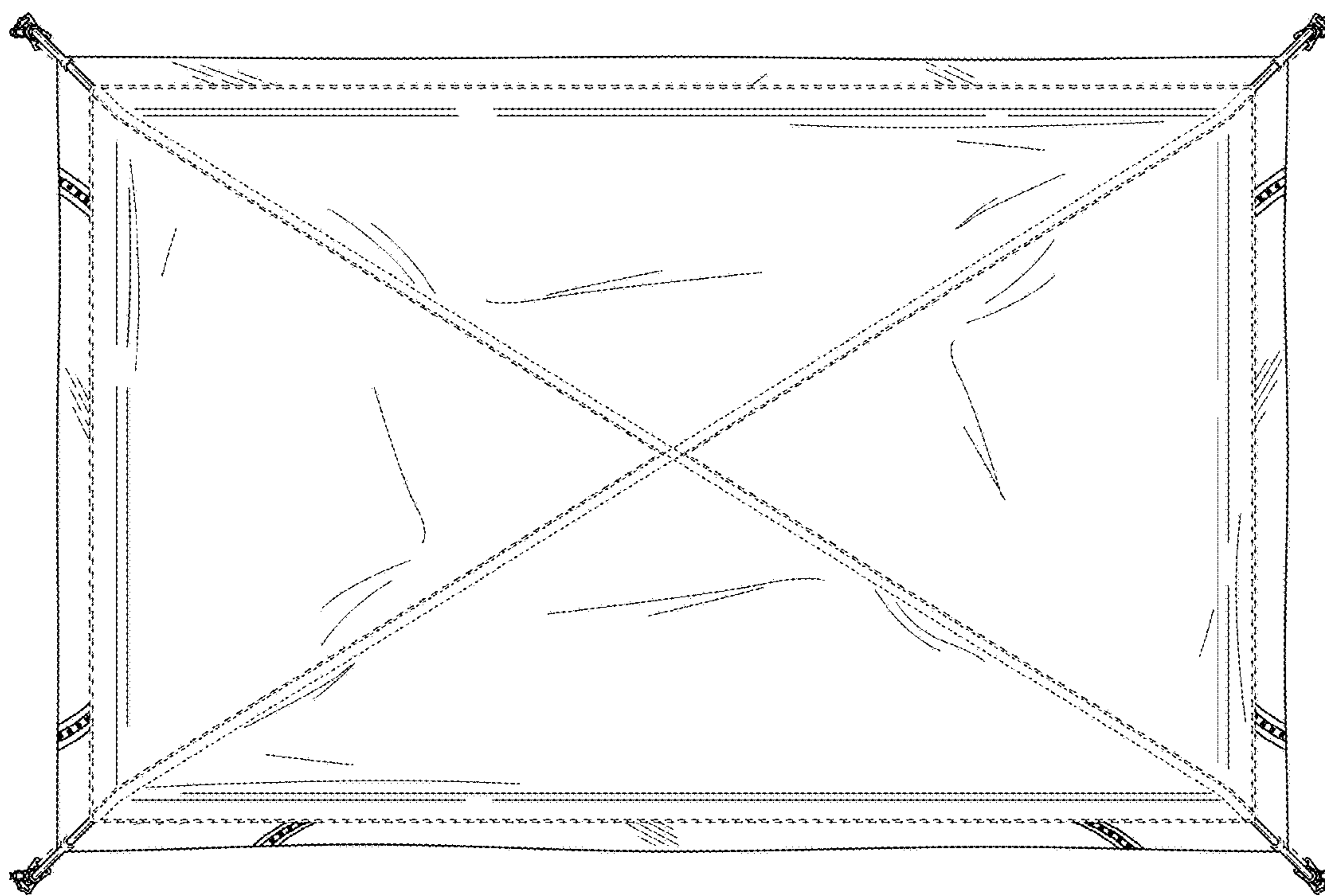

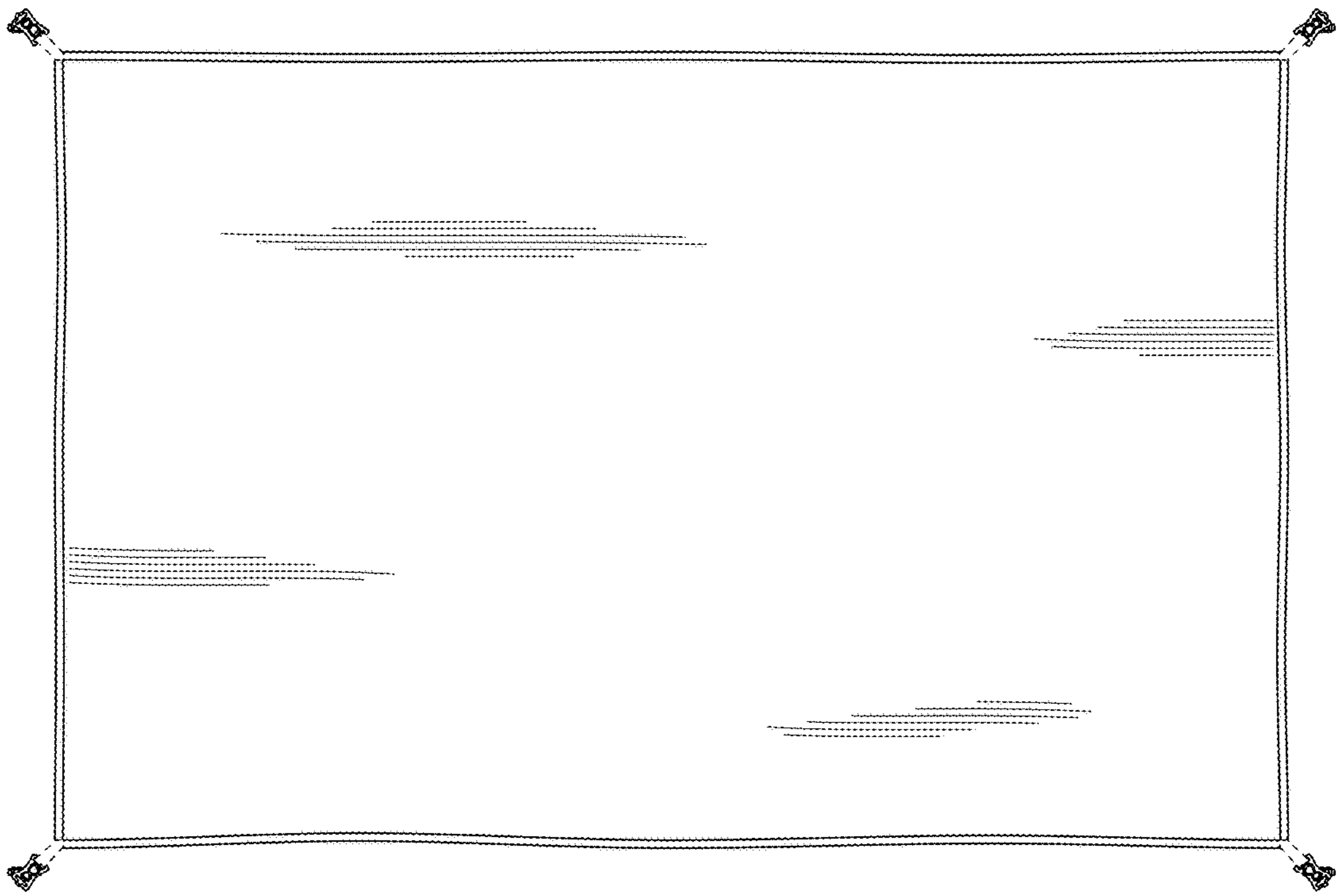
