The ornamental design for a radiosynthesis device, as shown and described.

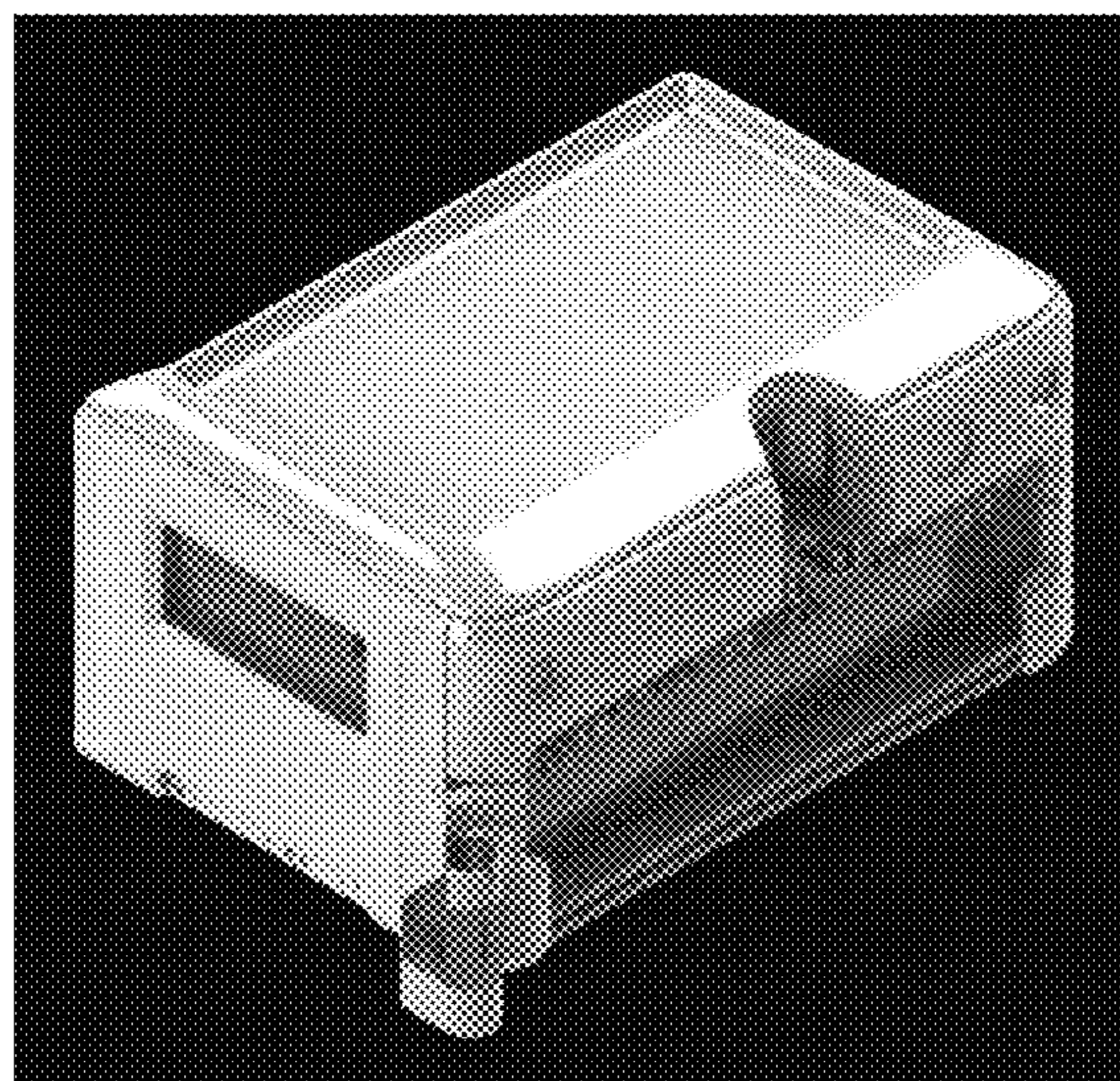
DESCRIPTION

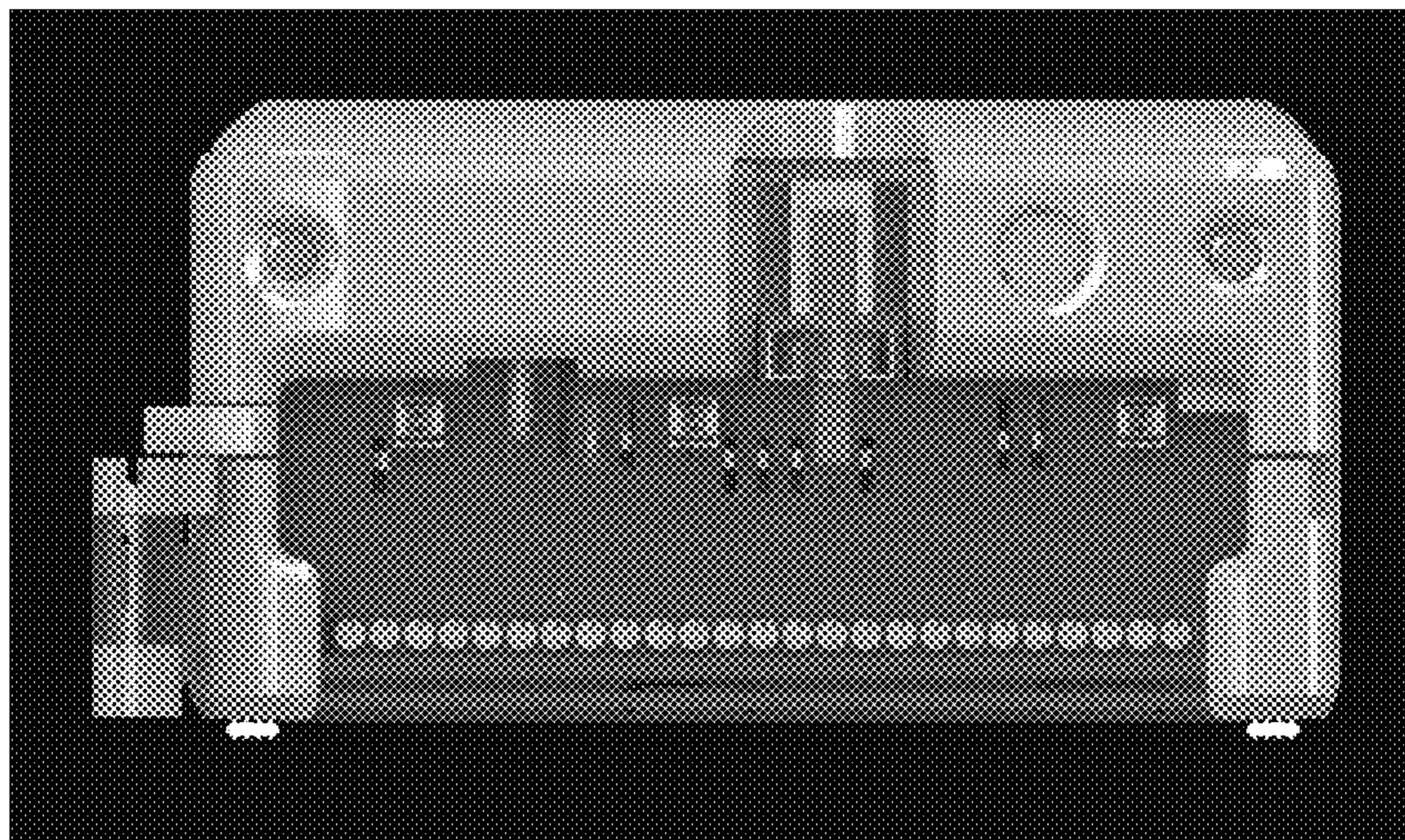

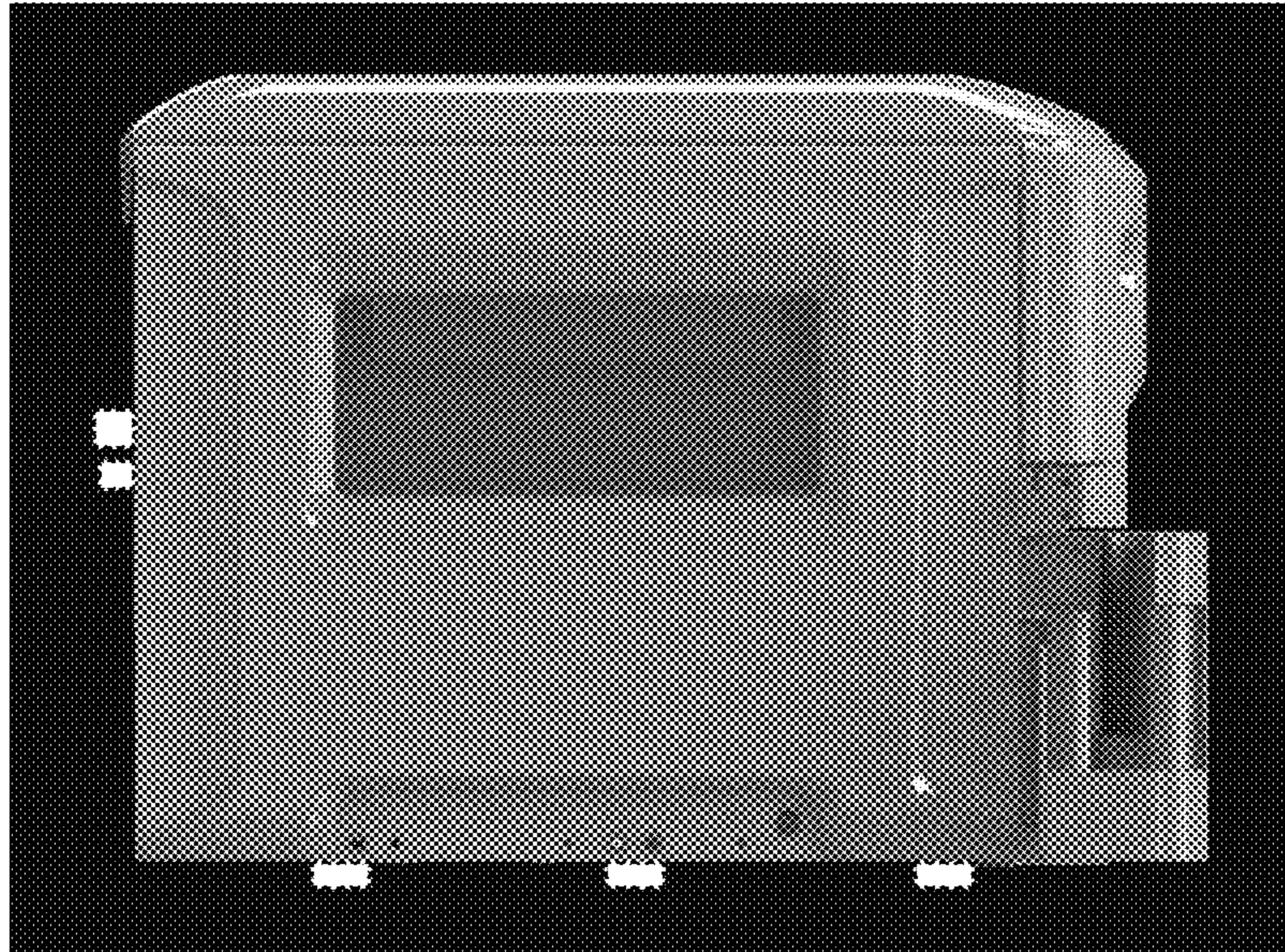

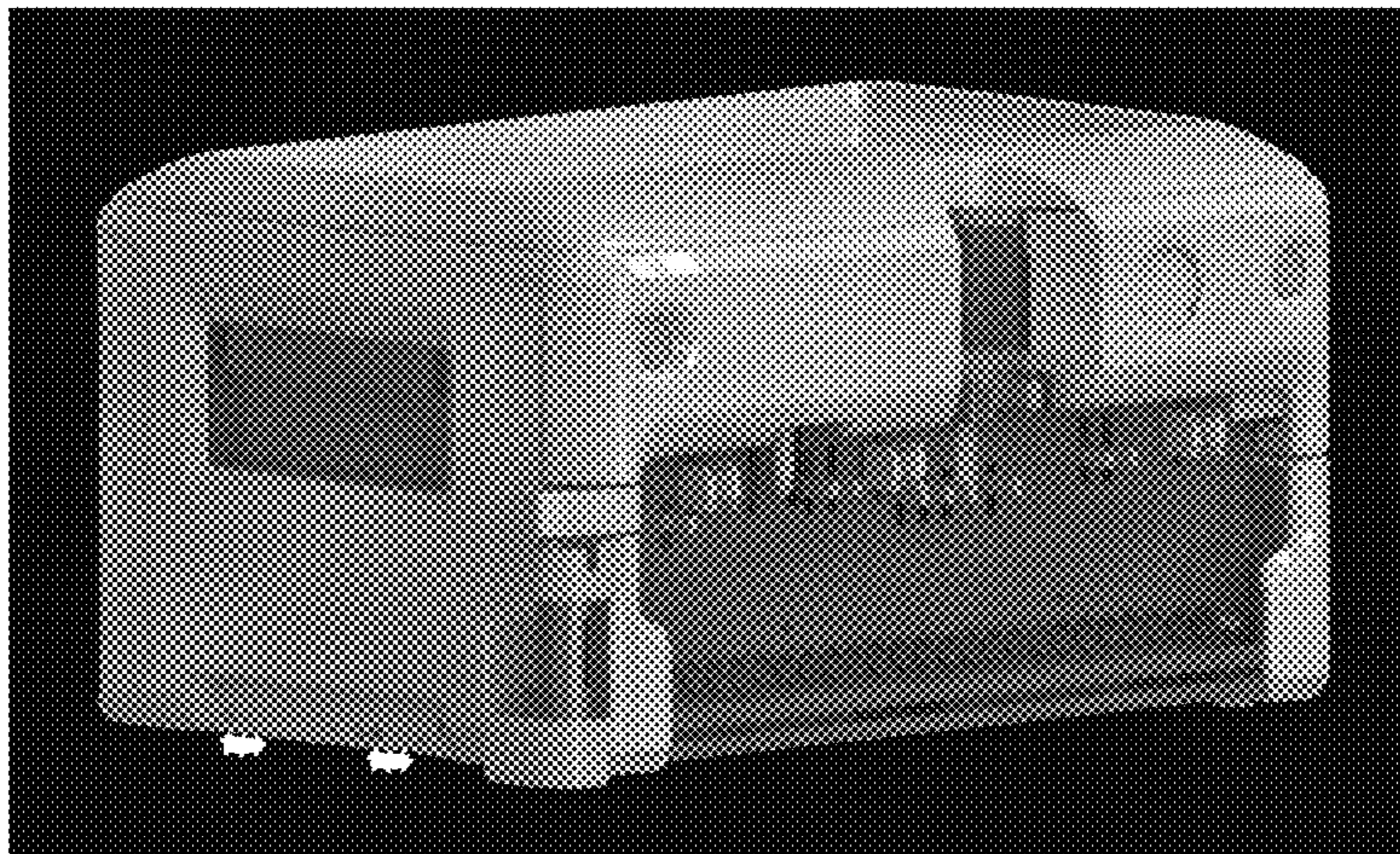

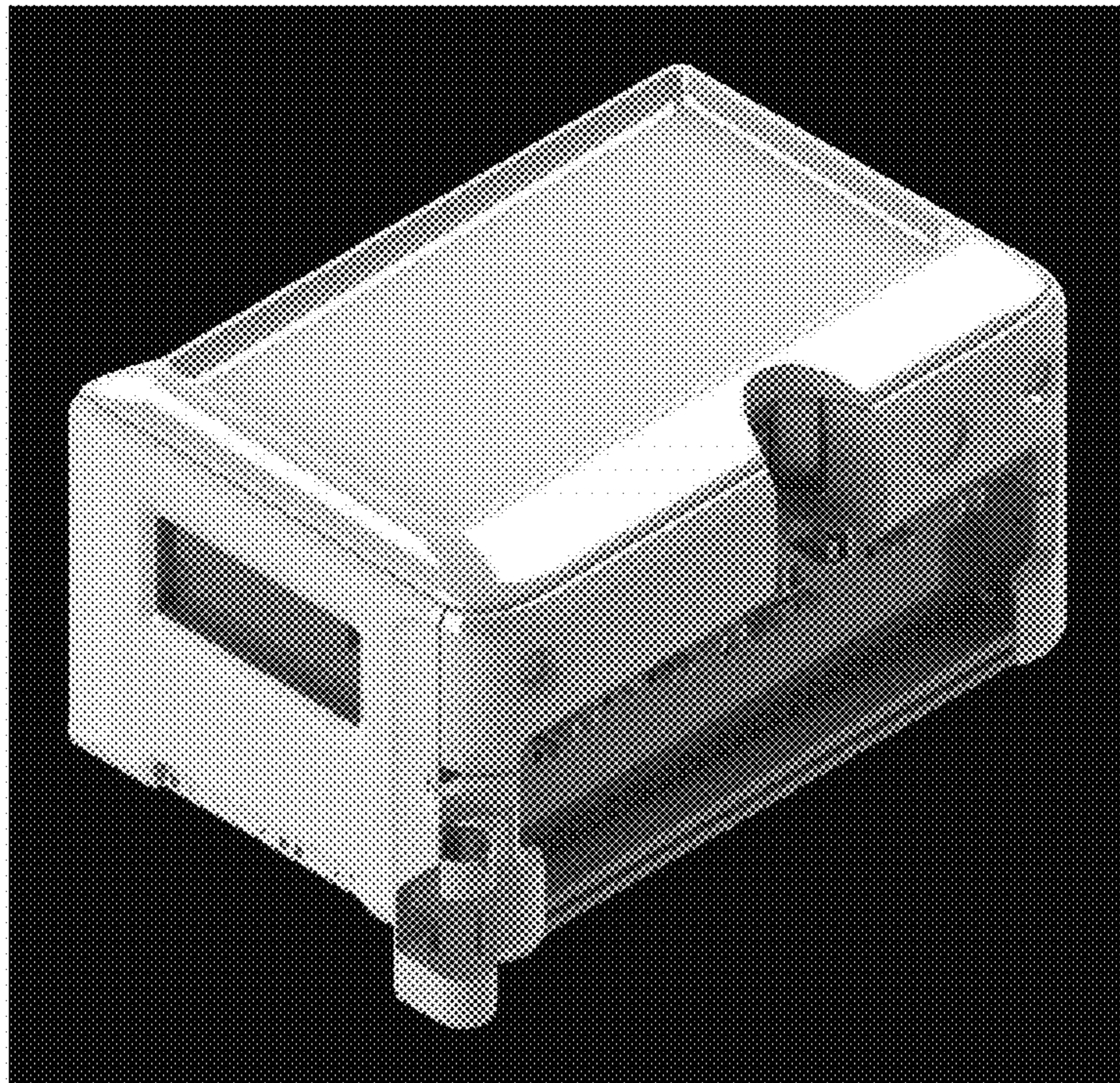

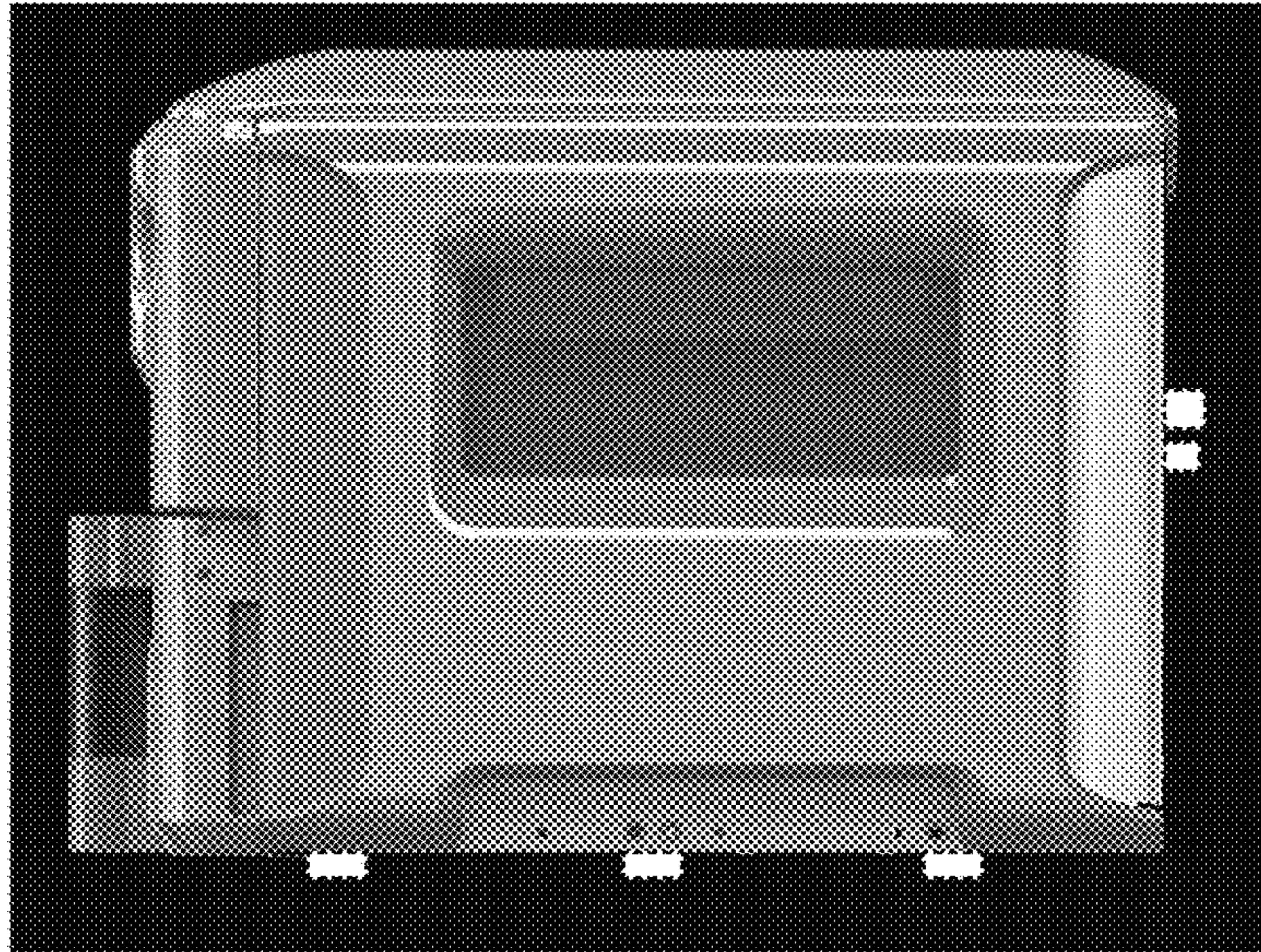

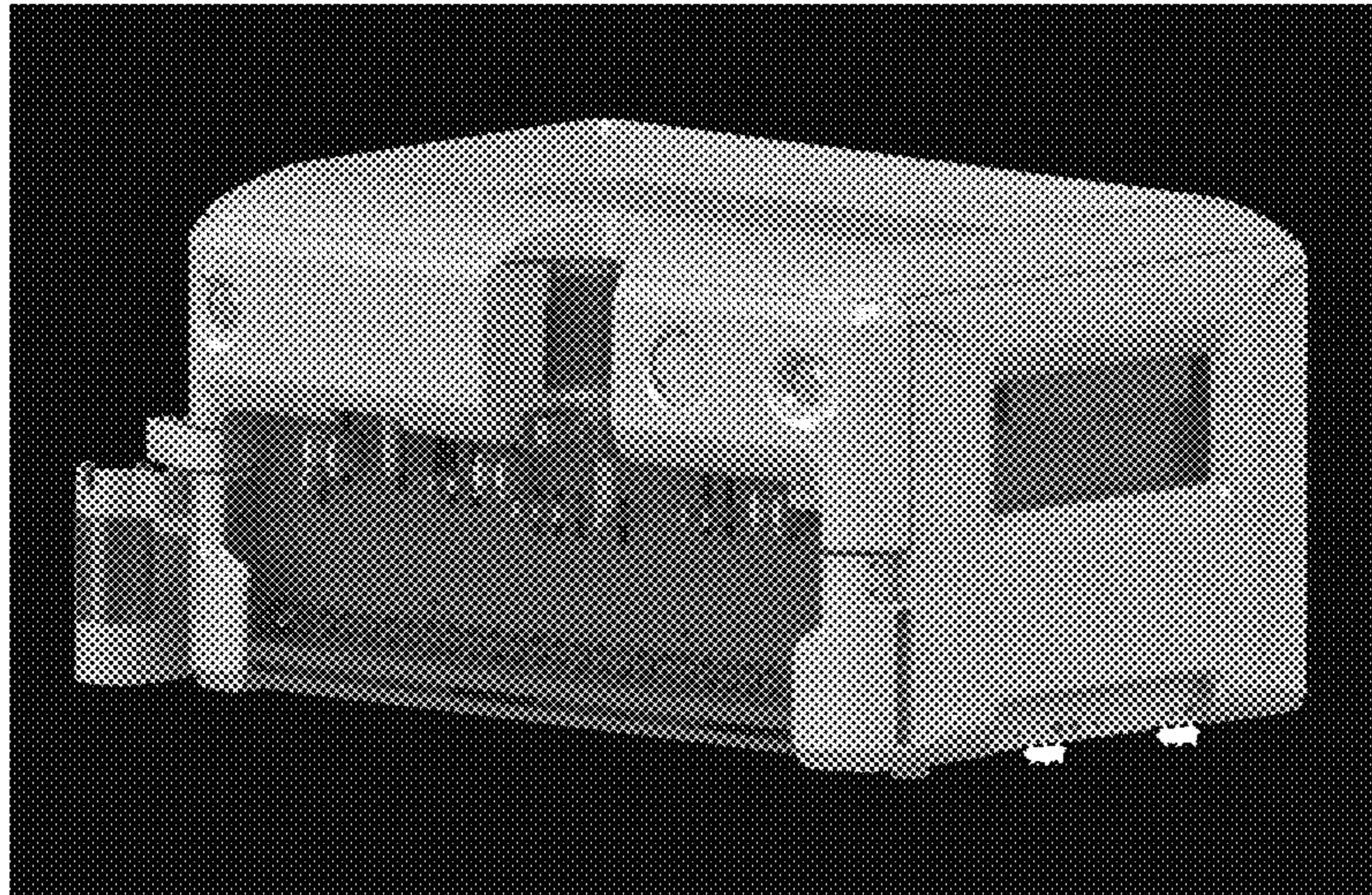

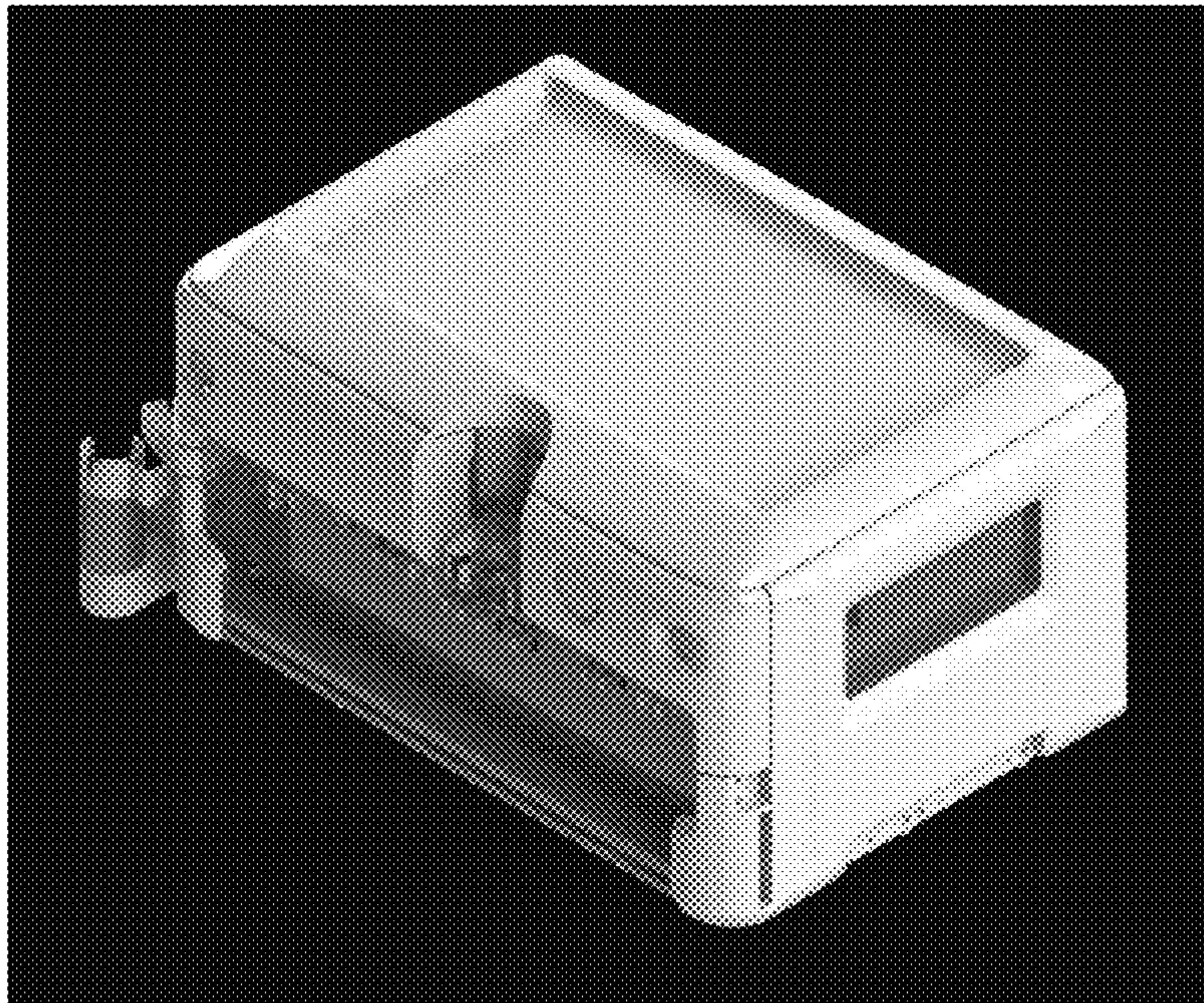

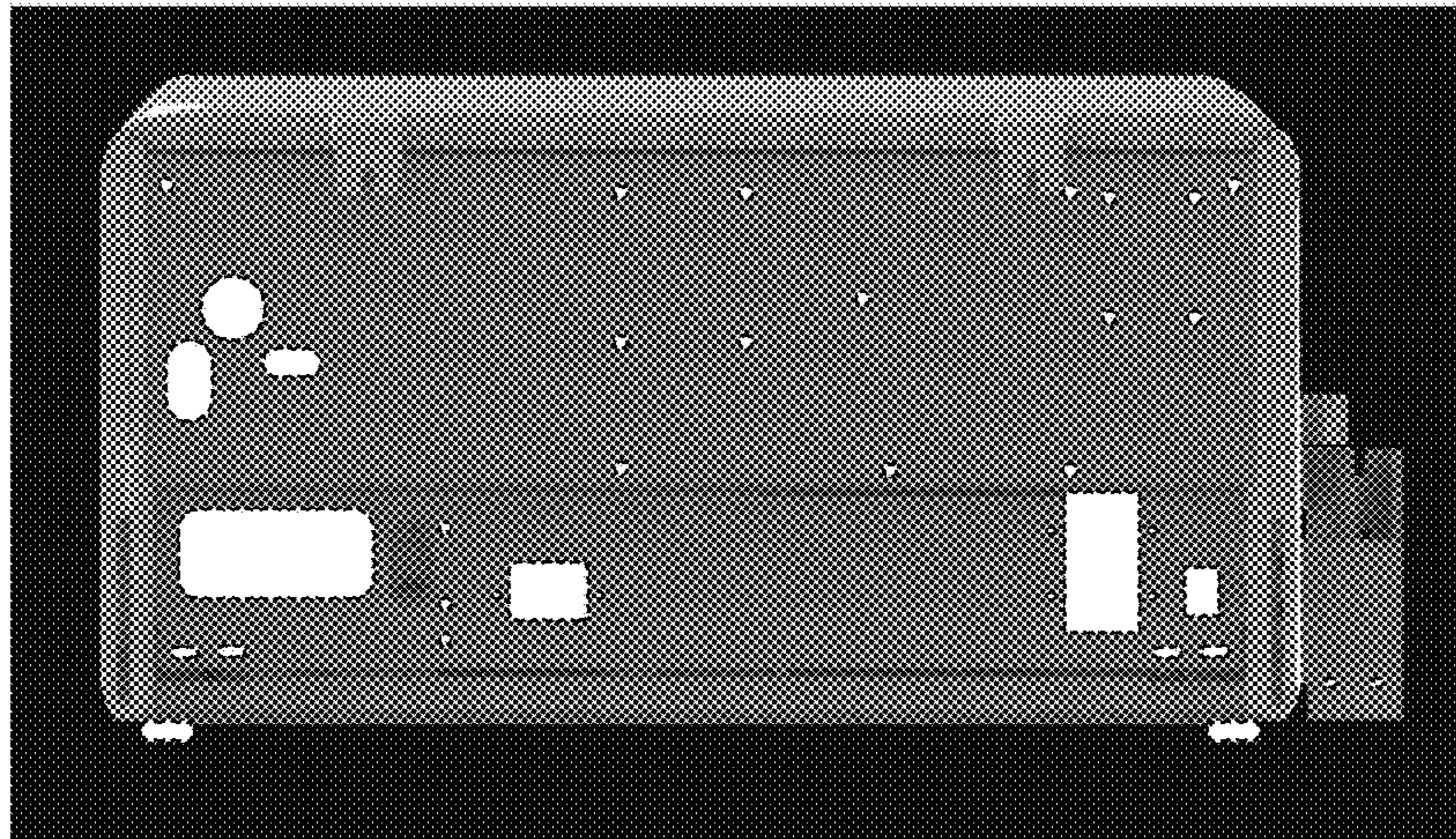

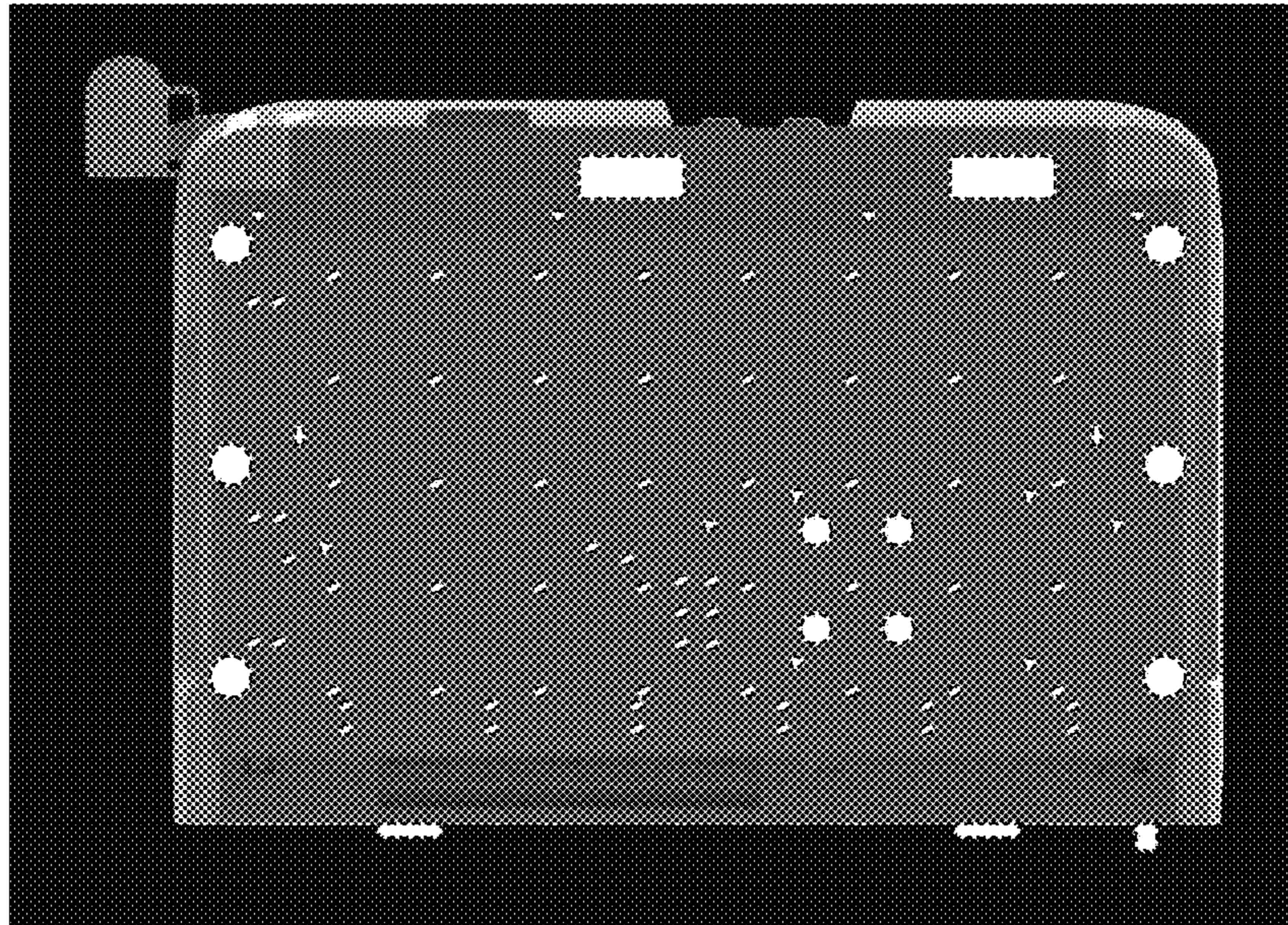

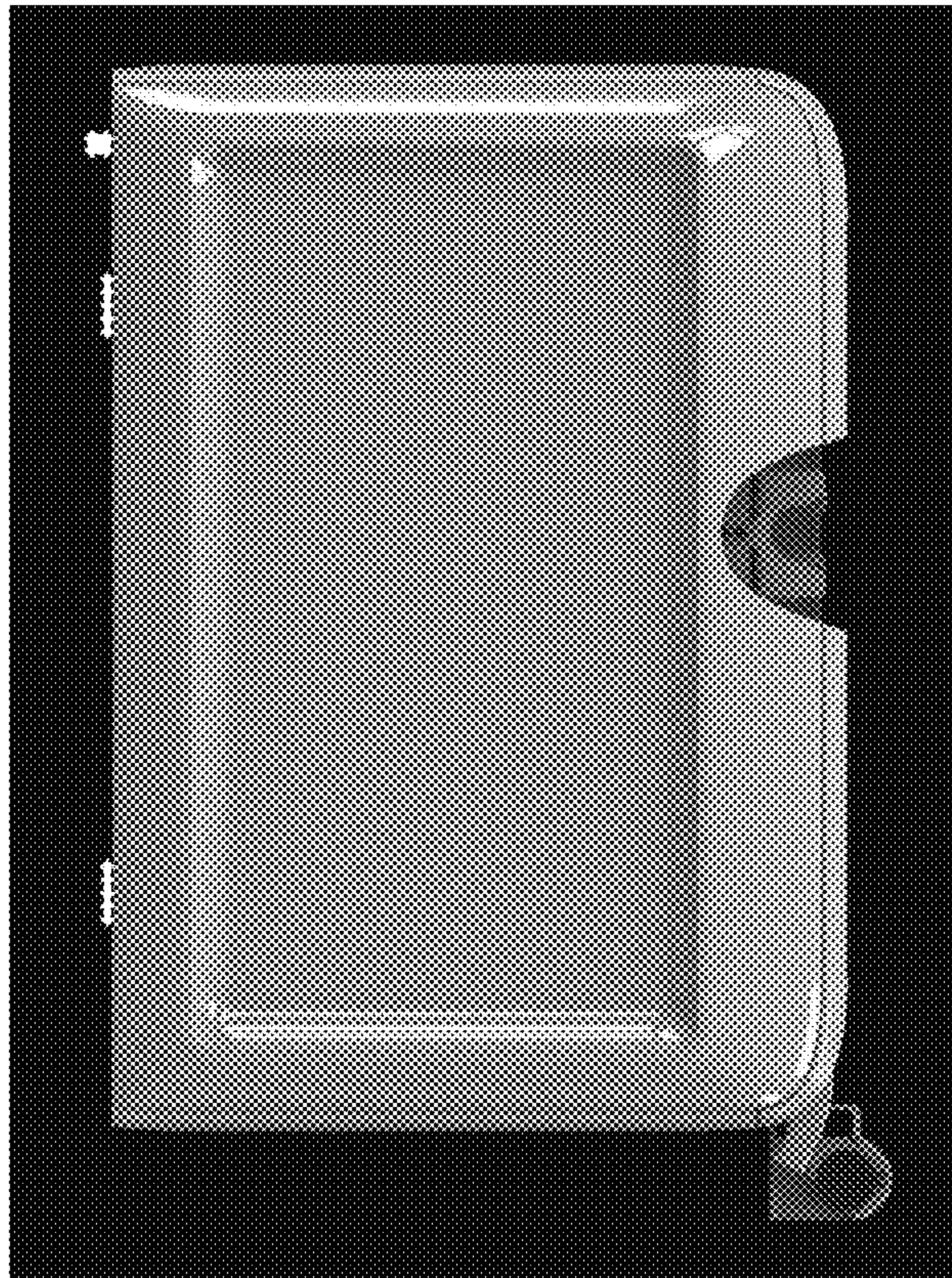
