**DESCRIPTION**

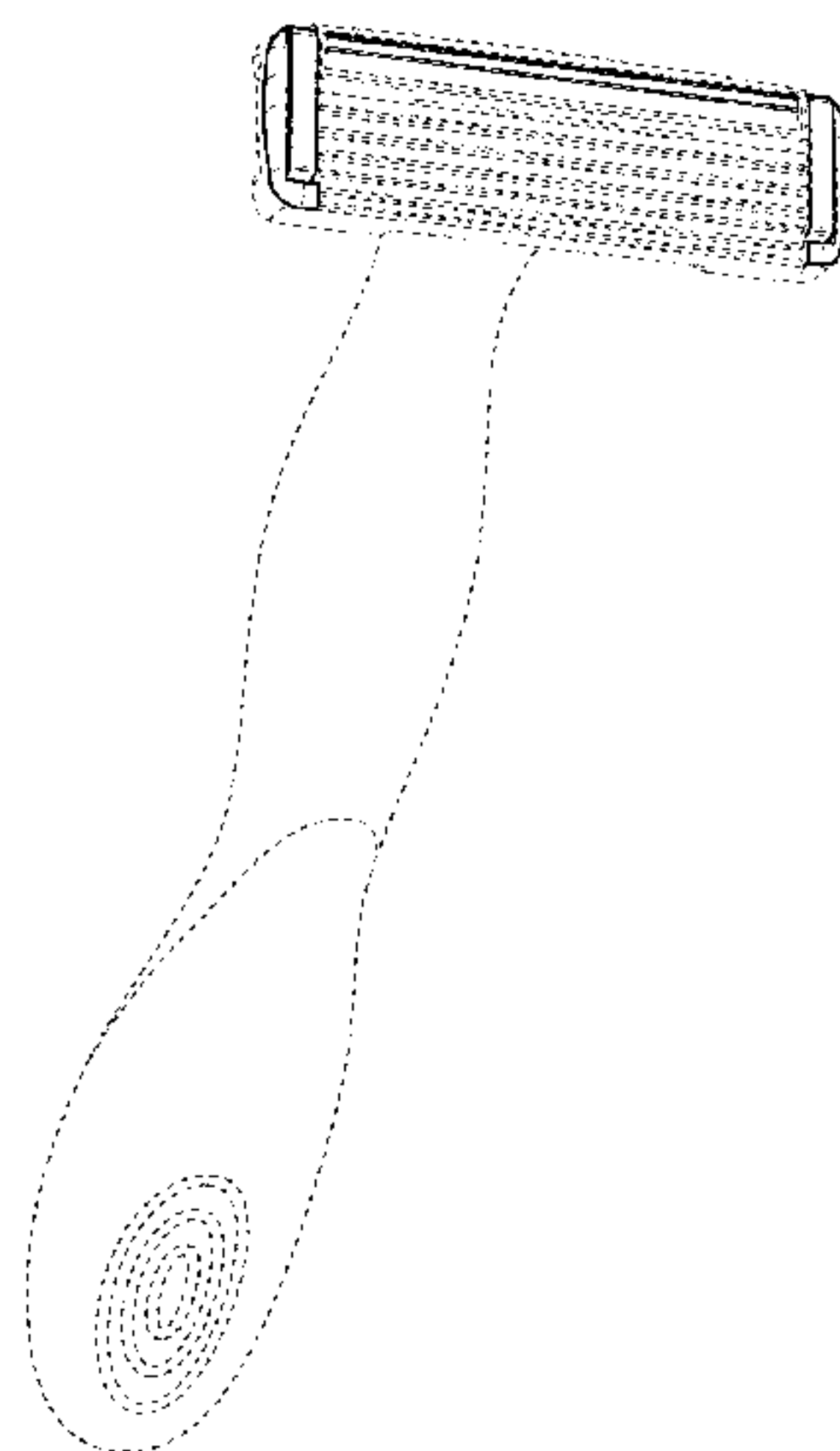
FIG. 1 is a front perspective view of an ornamental design for an embodiment of a shaving blade cartridge according to the present invention;

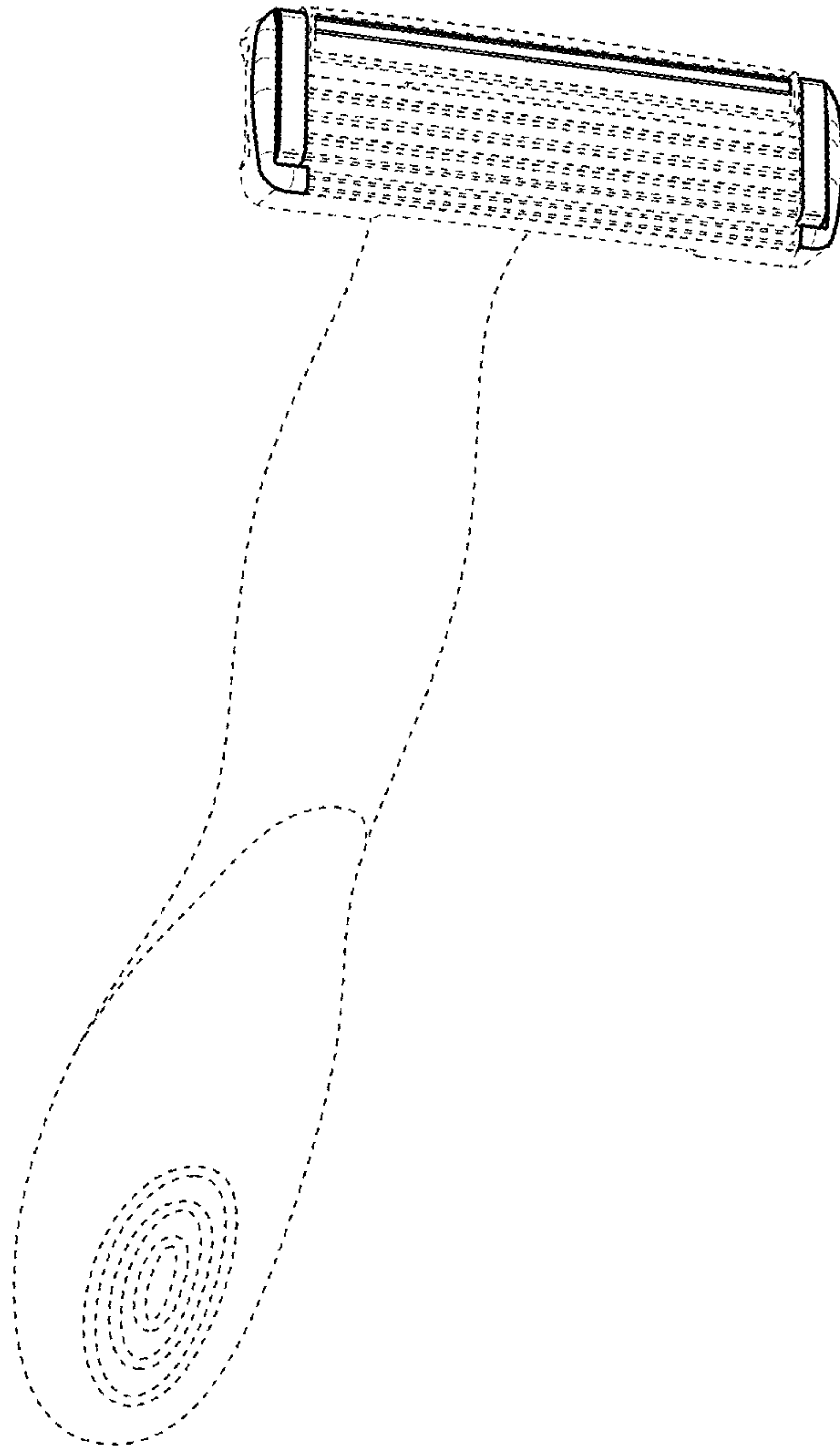

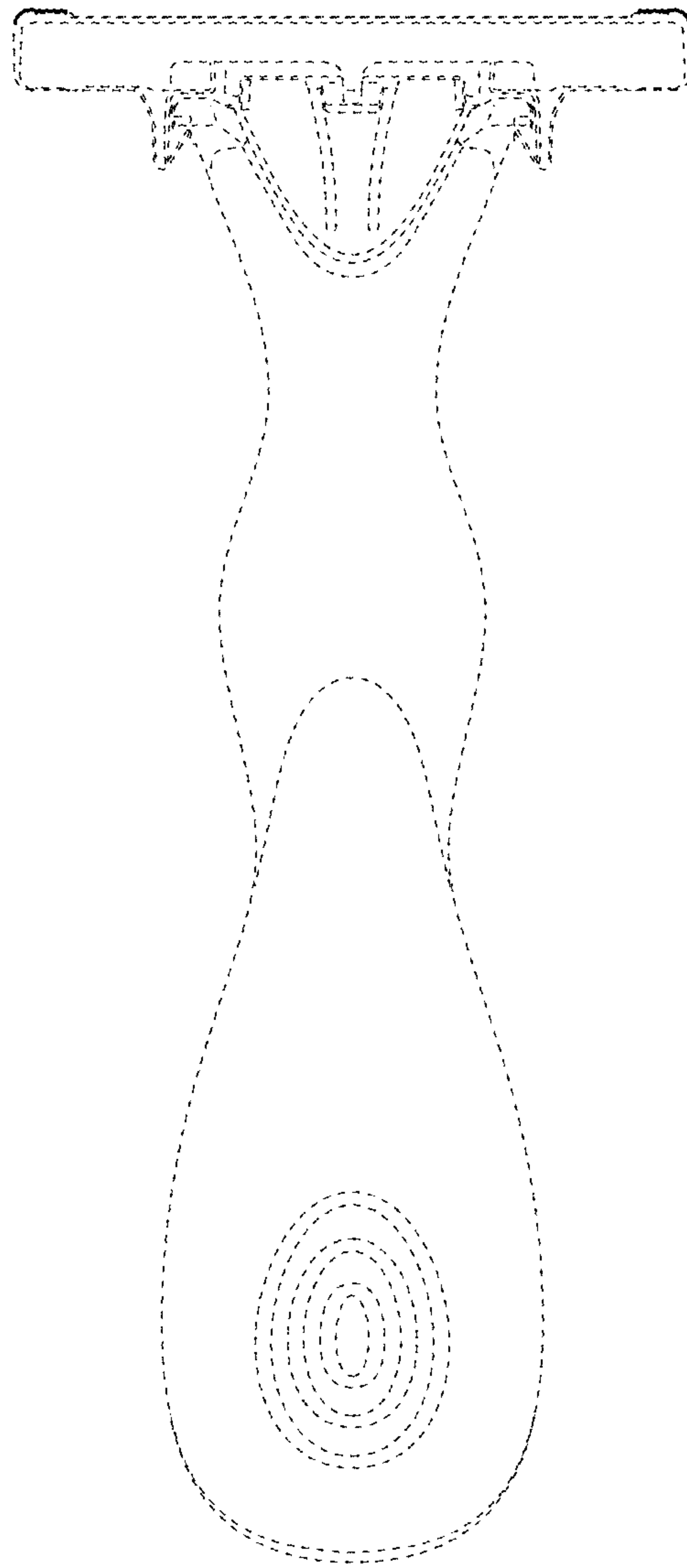

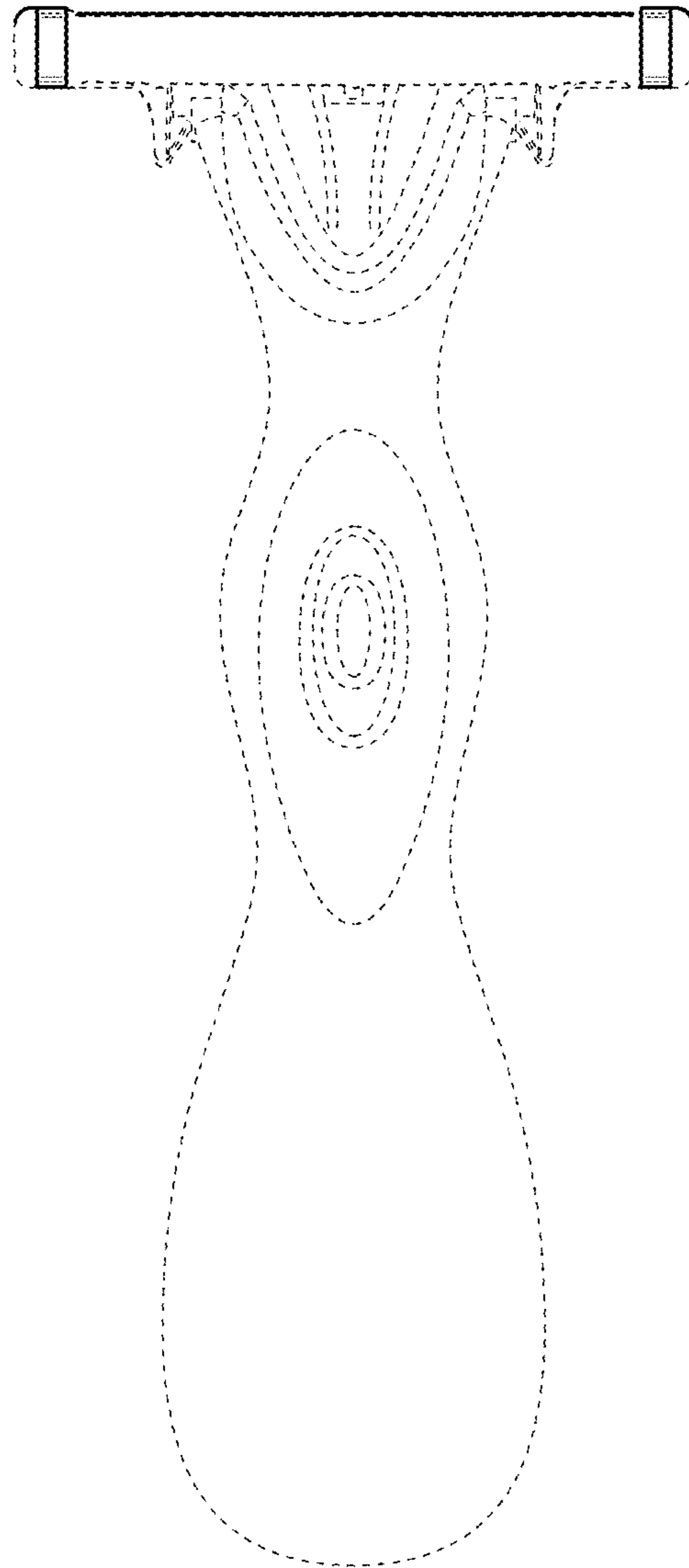

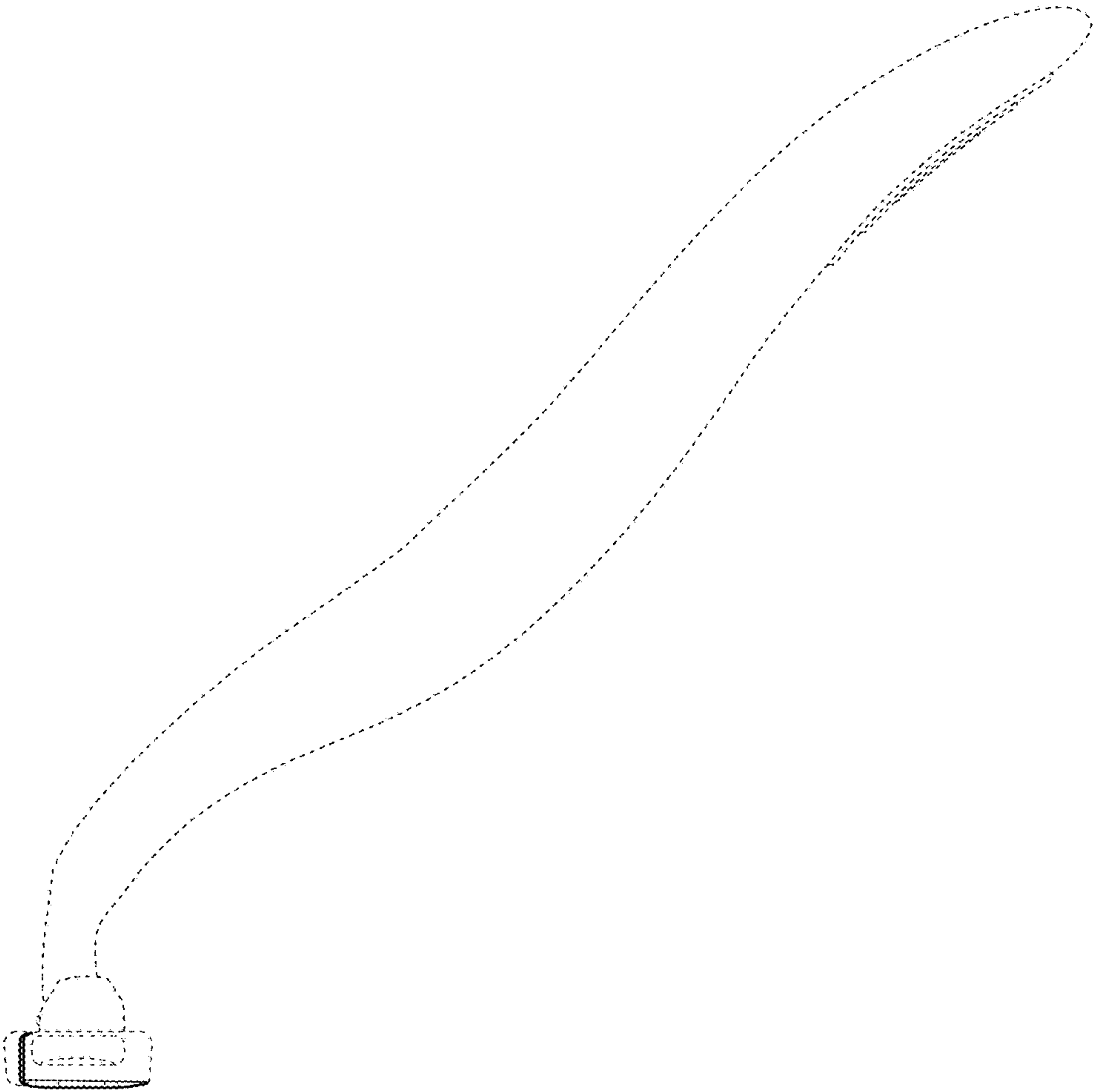

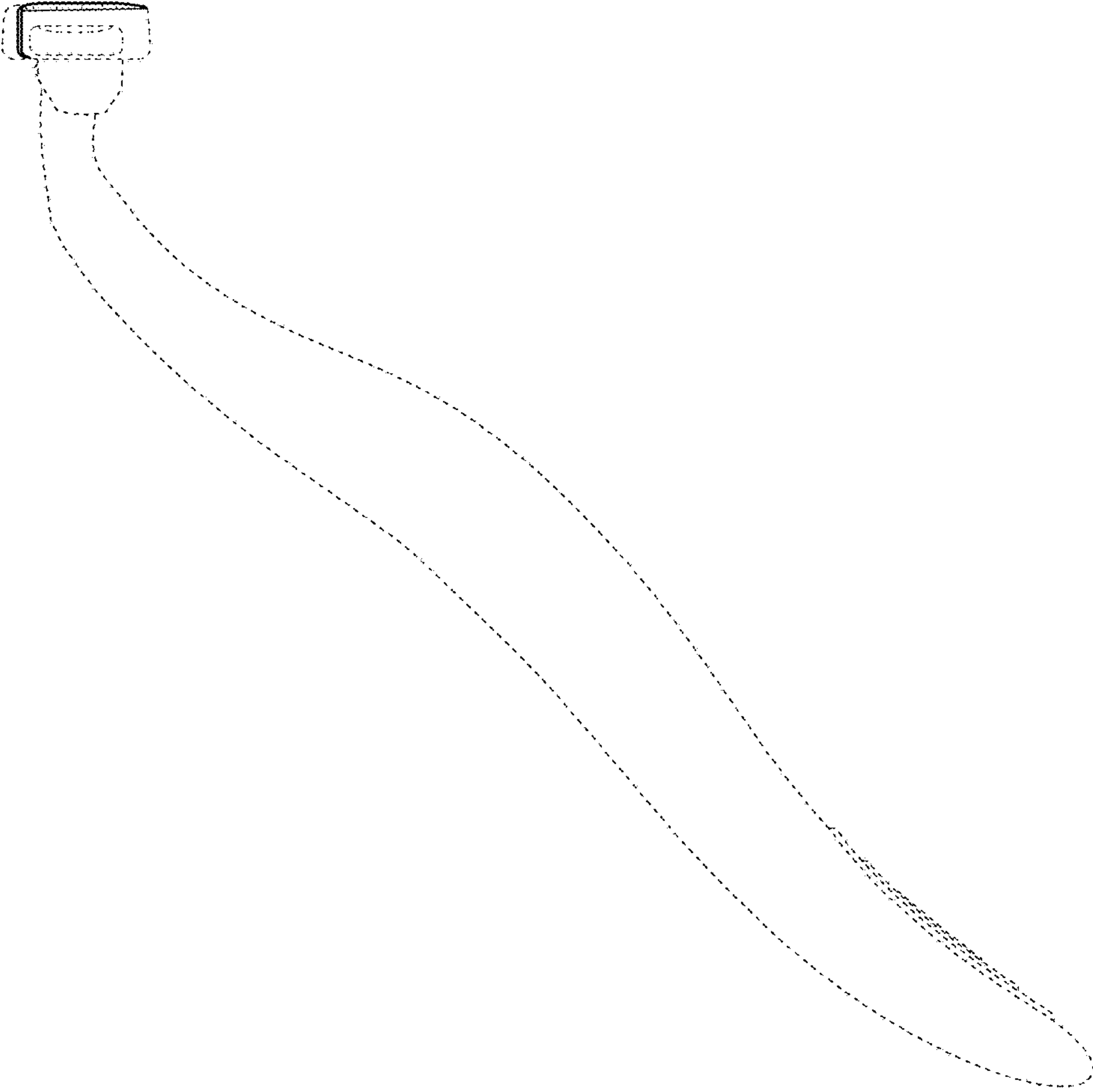
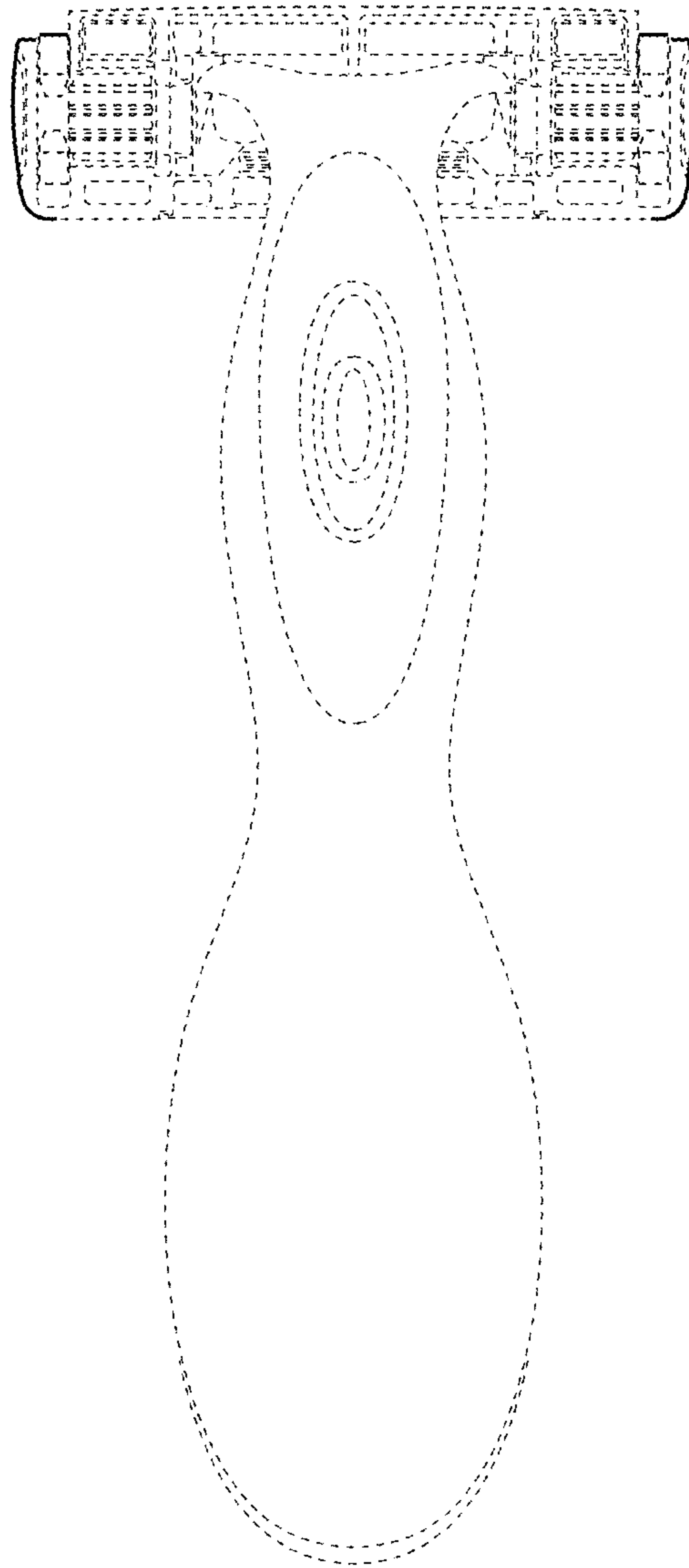
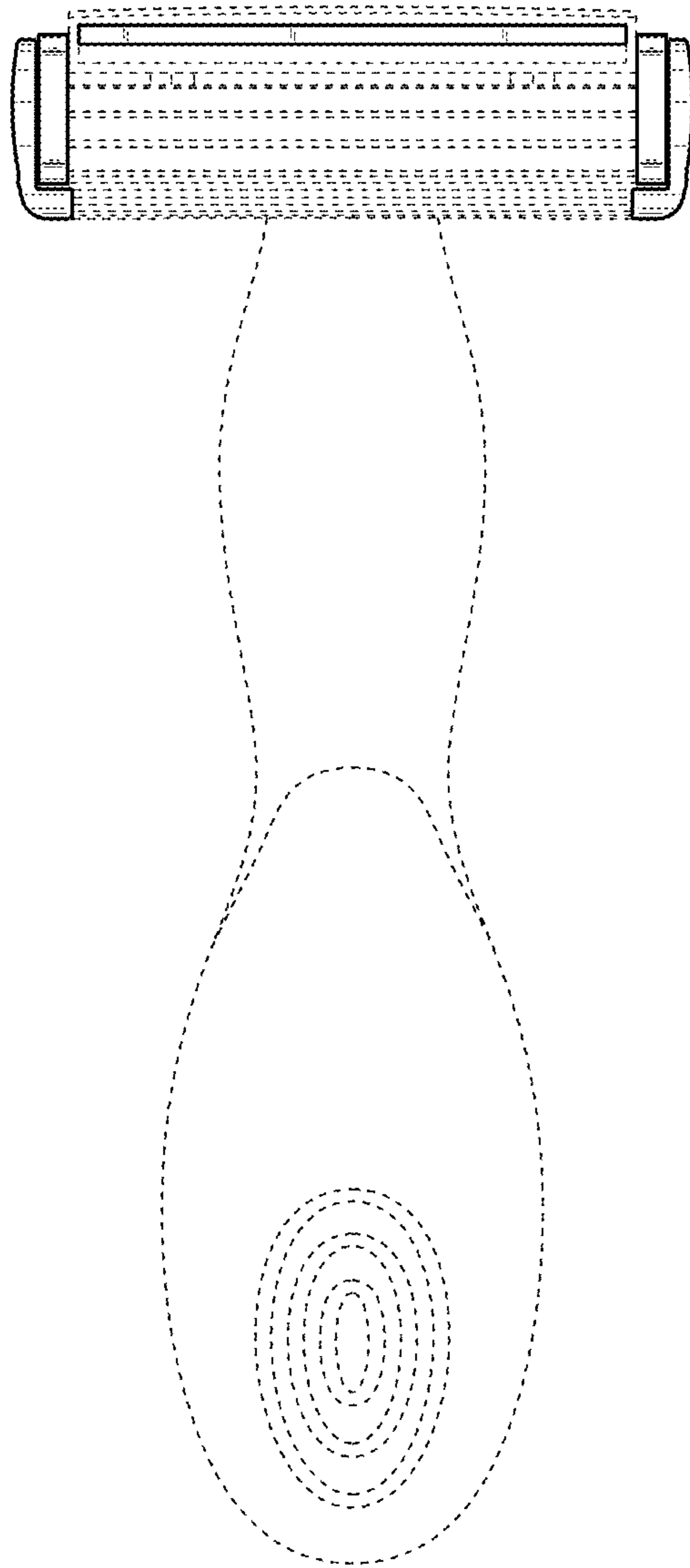

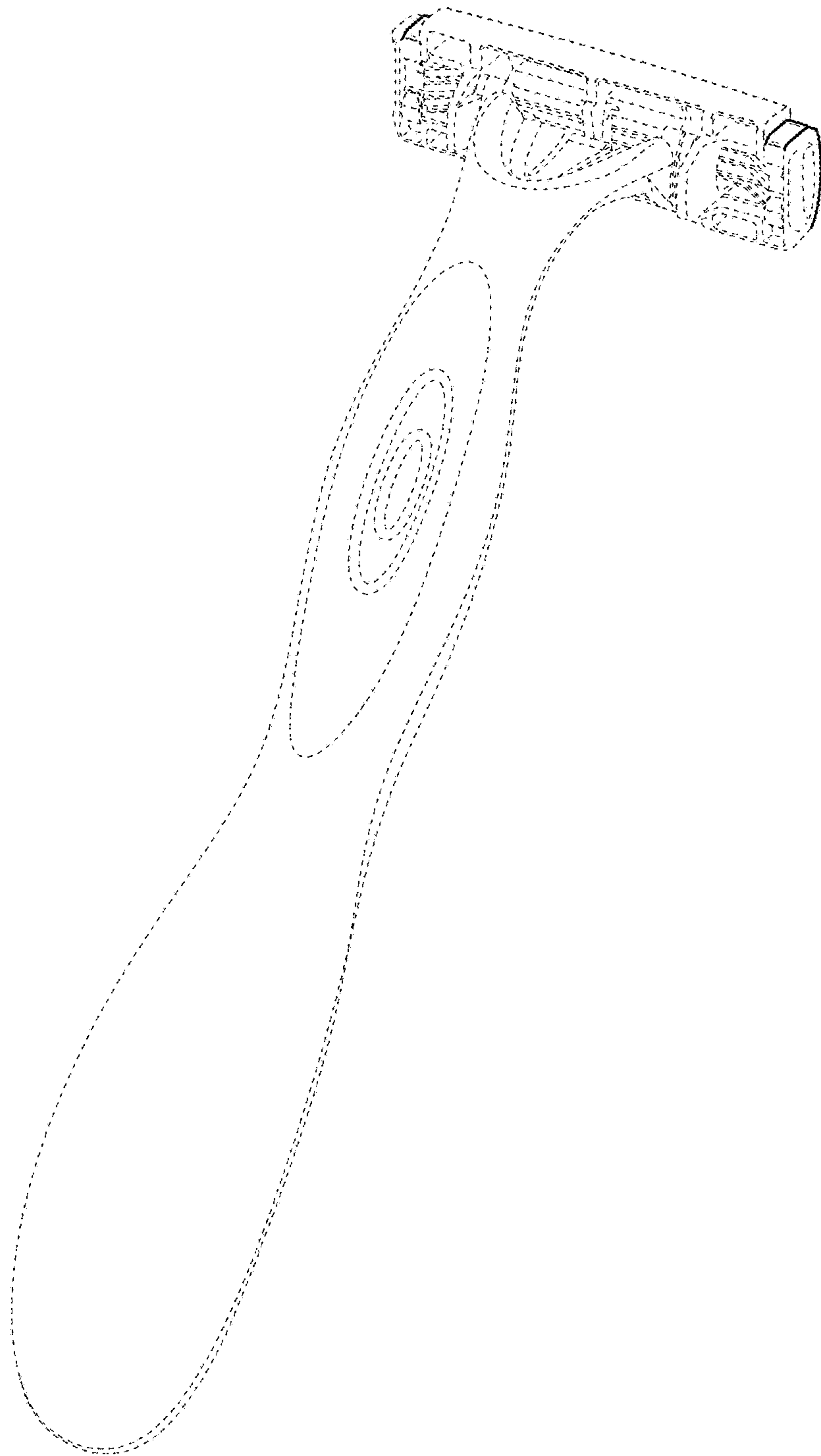
