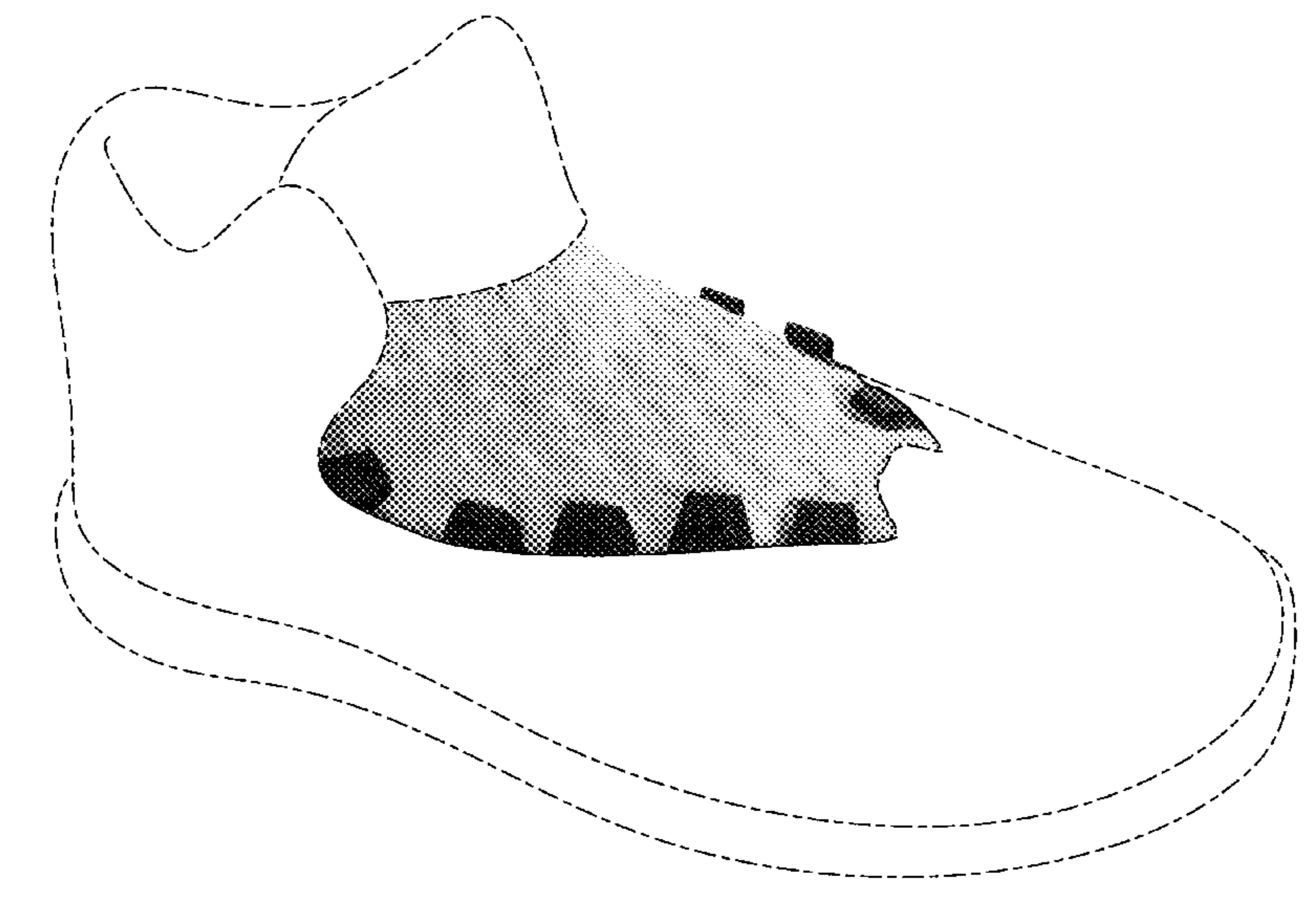
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is a side view thereof;
FIG. 3 is an opposite side thereof;

FIG. 5 is a top view thereof.

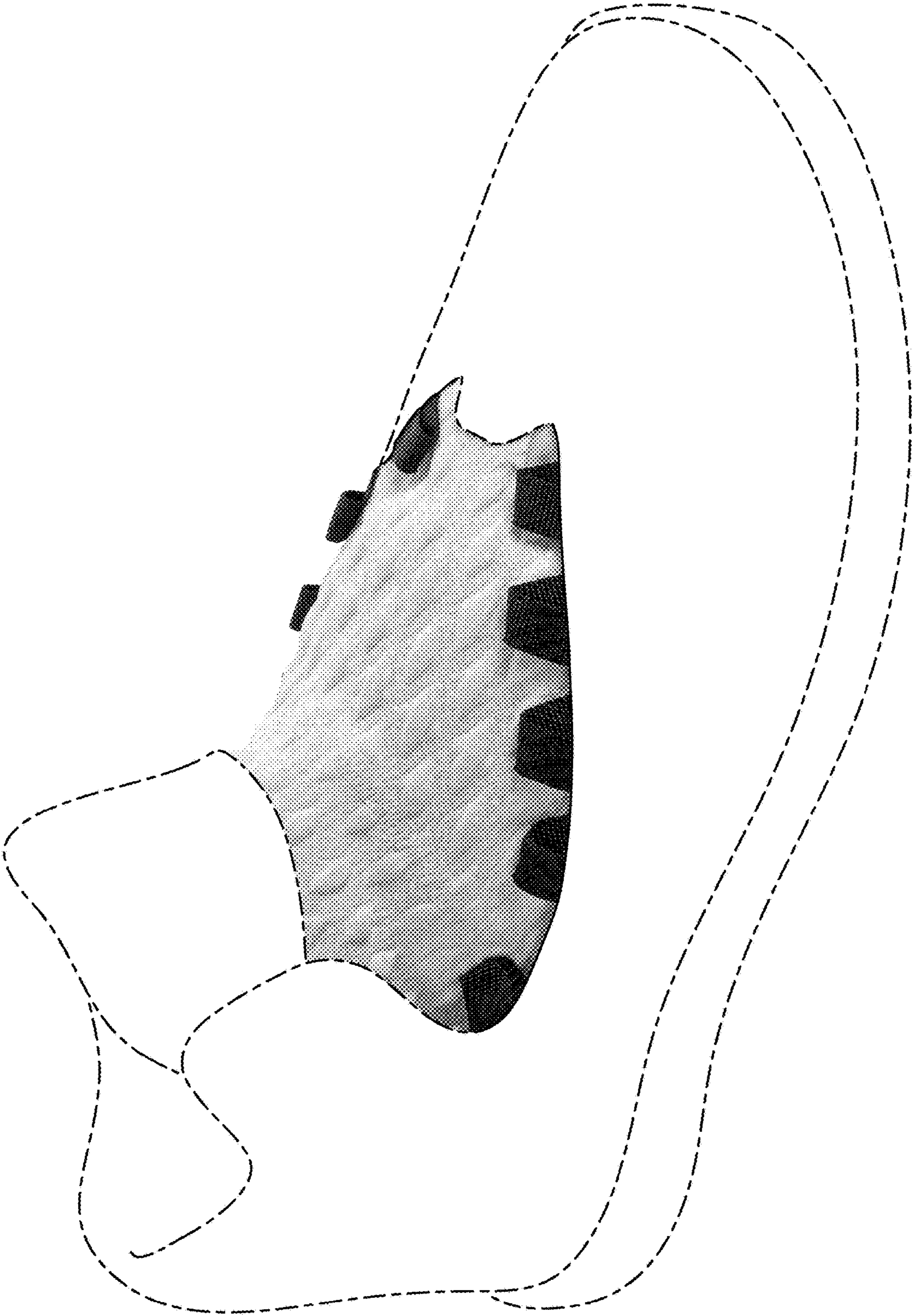

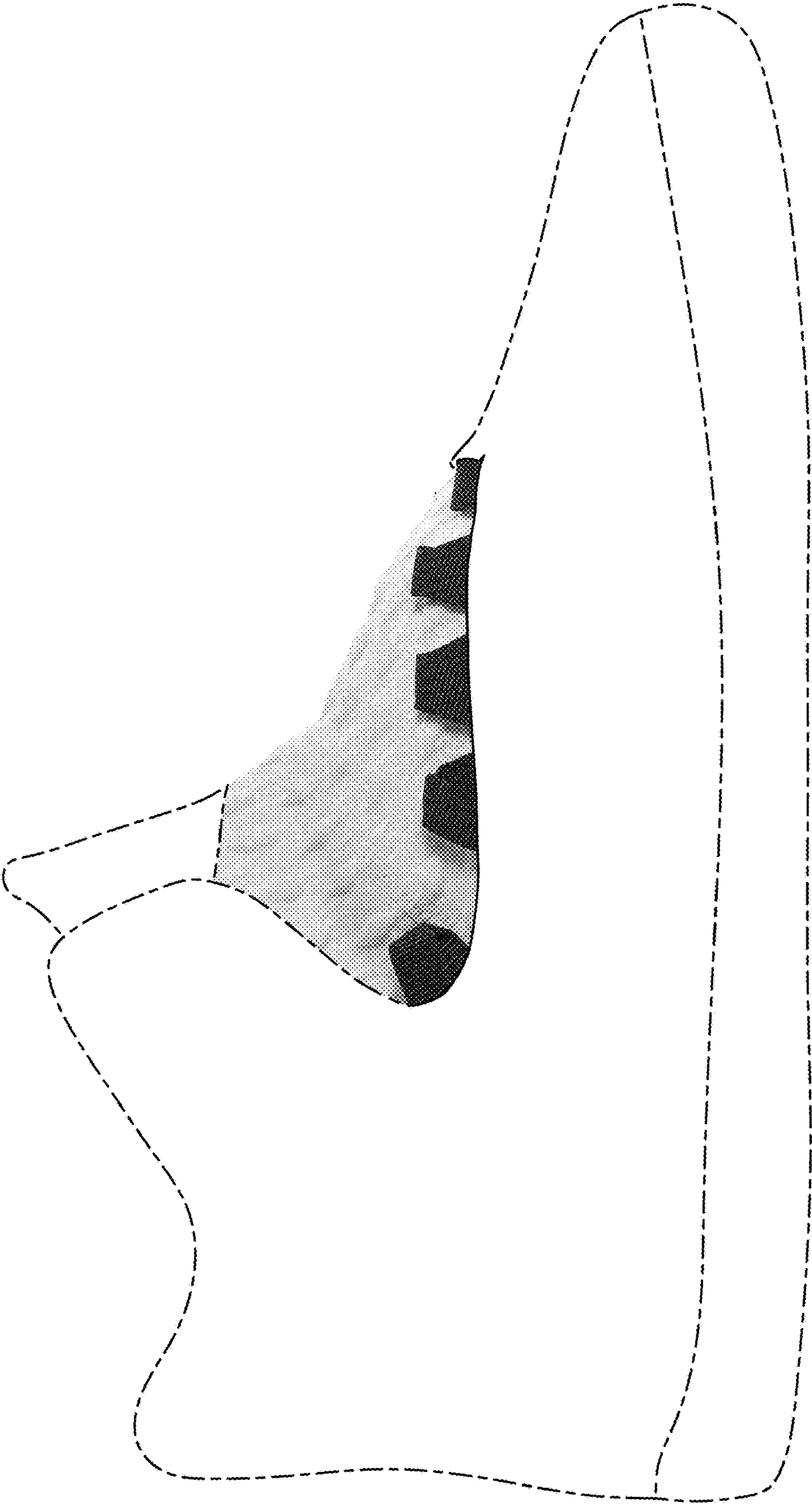

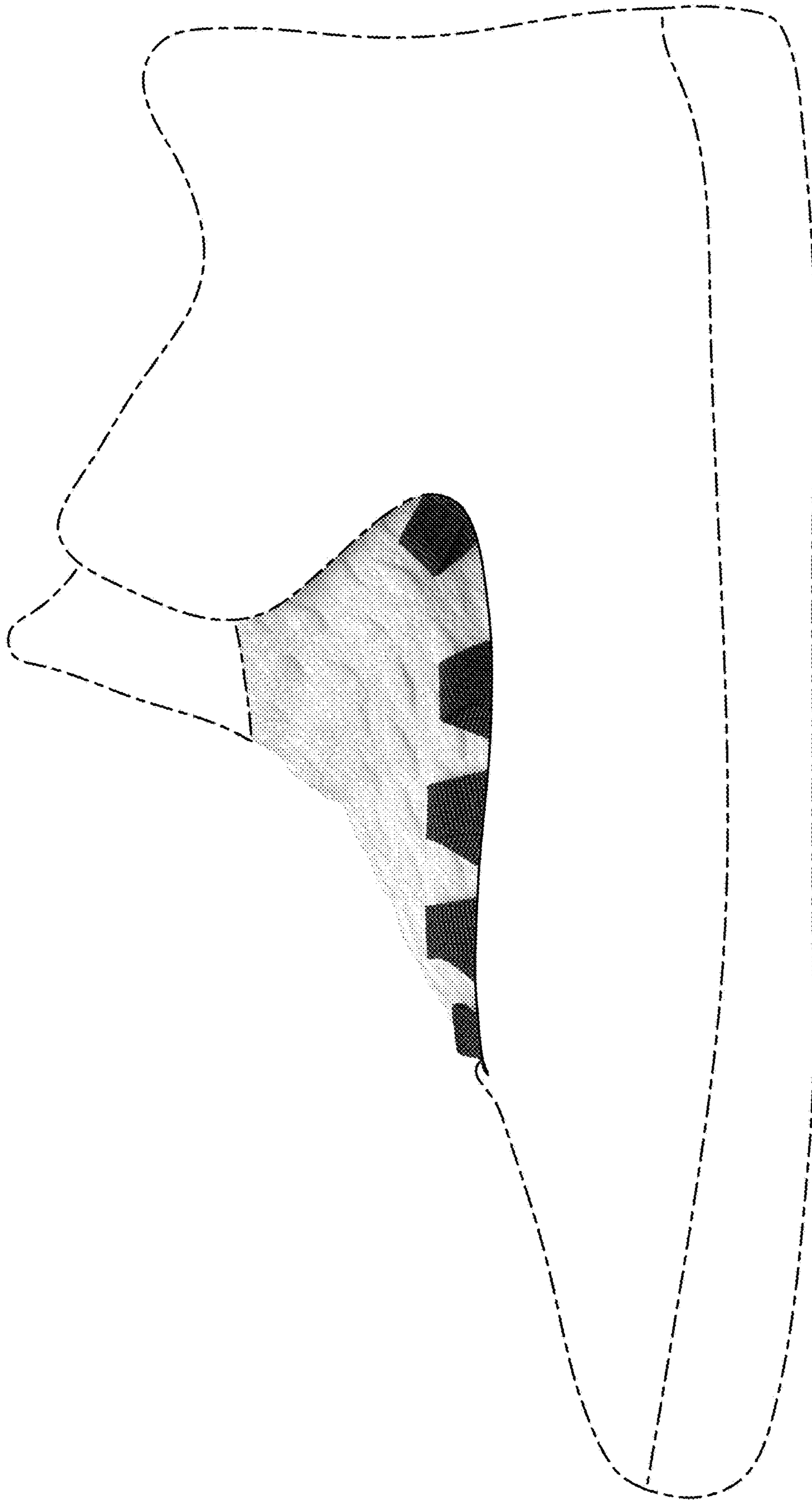

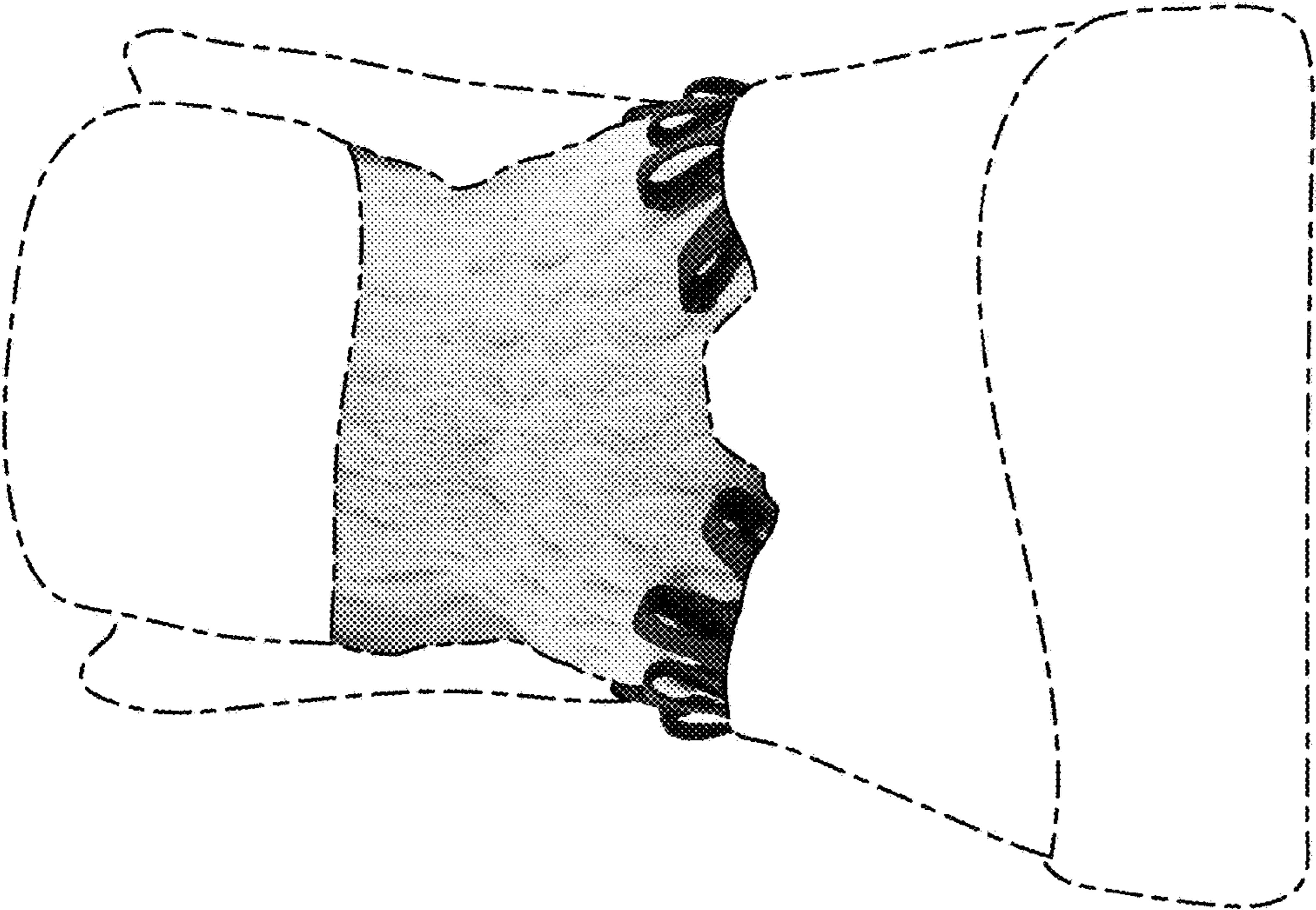

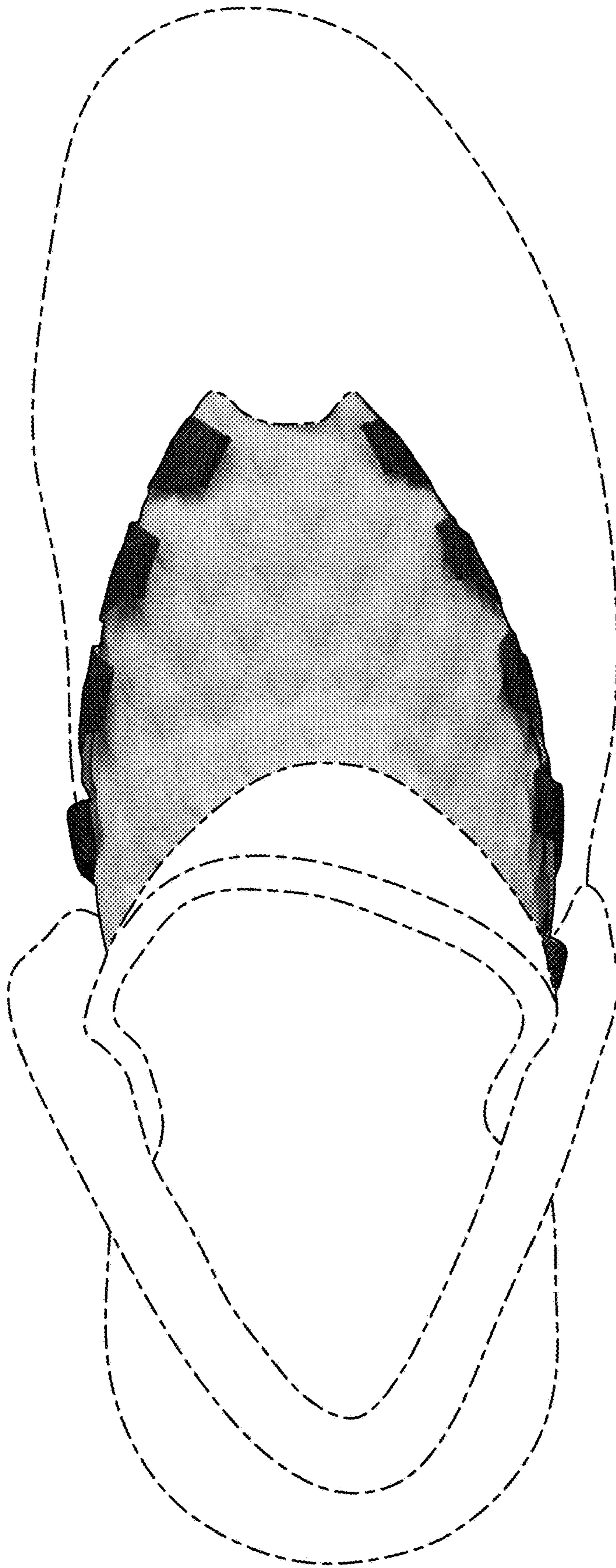
