DESCRIPTION

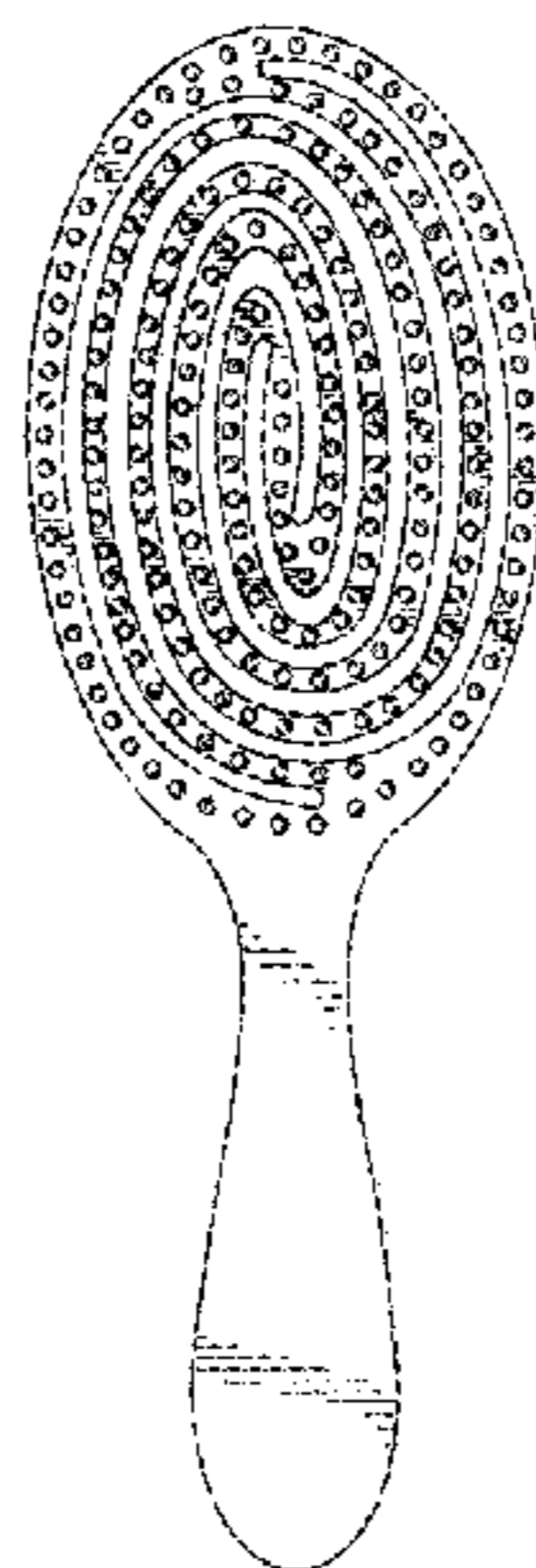
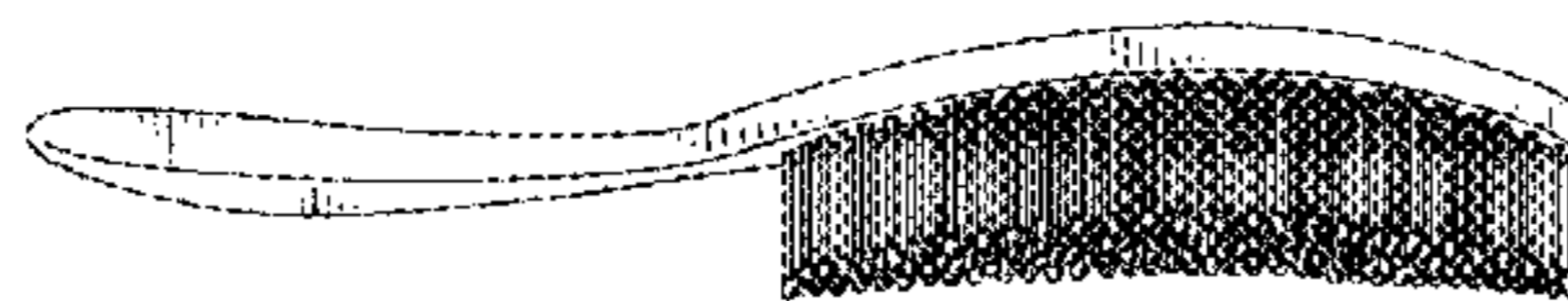
FIG. 1 is a perspective view of a flexible hairbrush showing my new design;

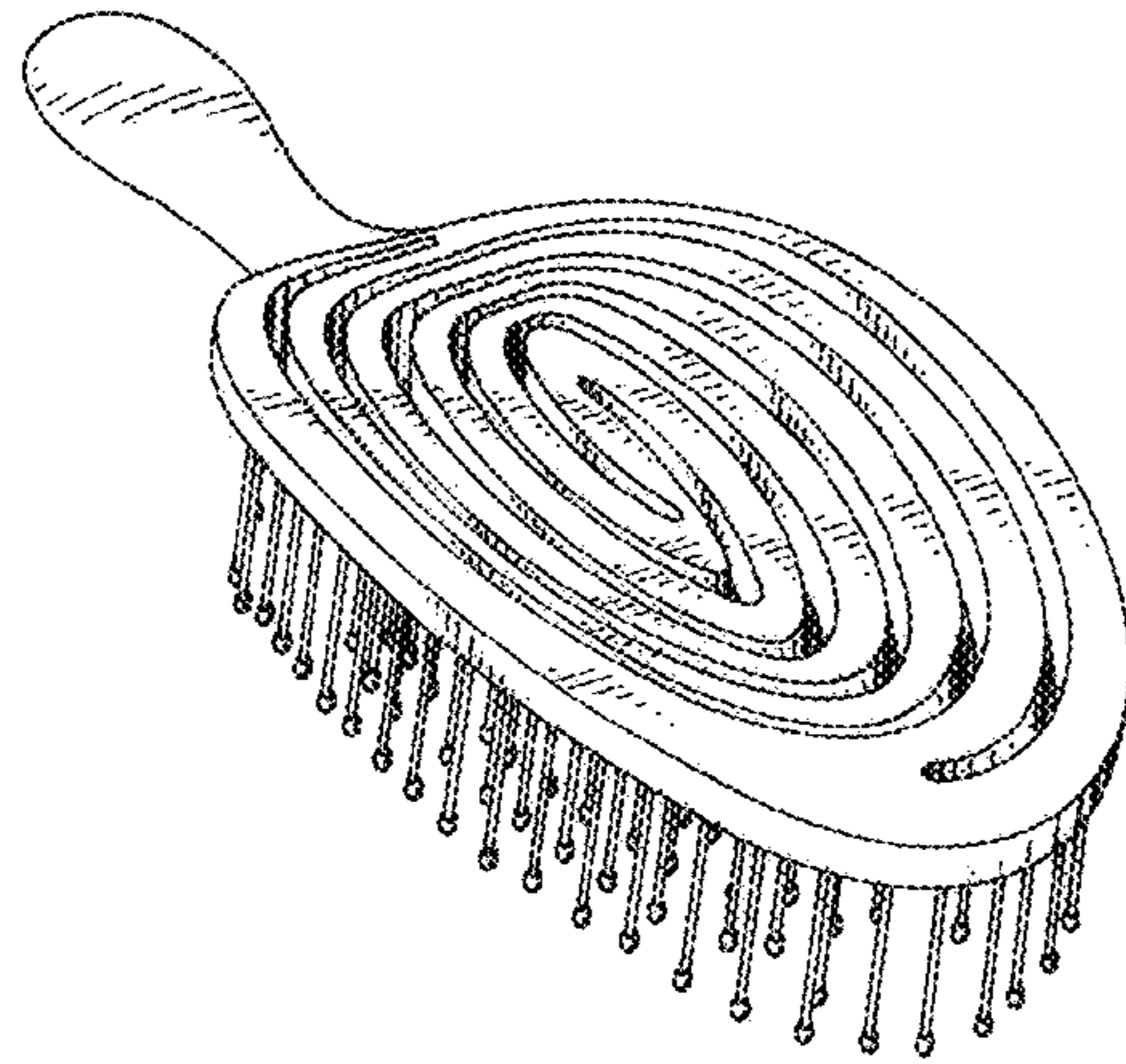

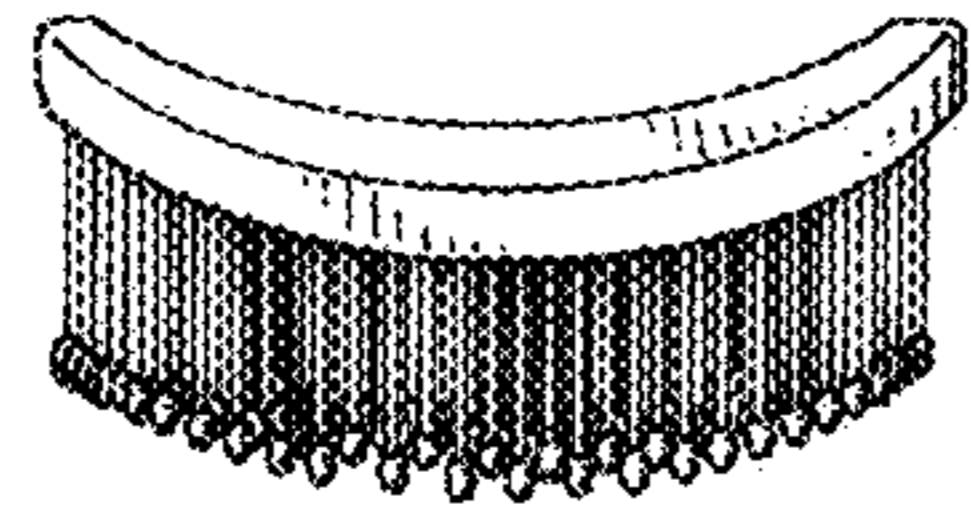

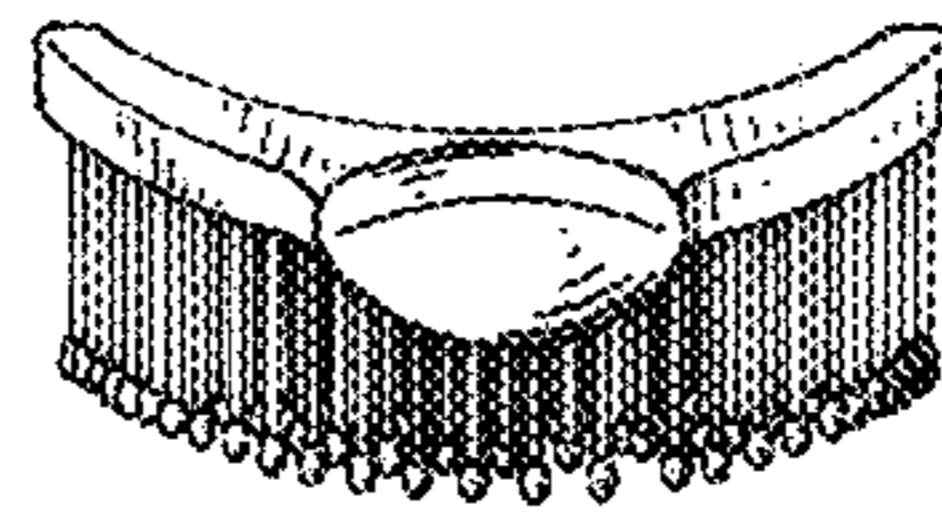

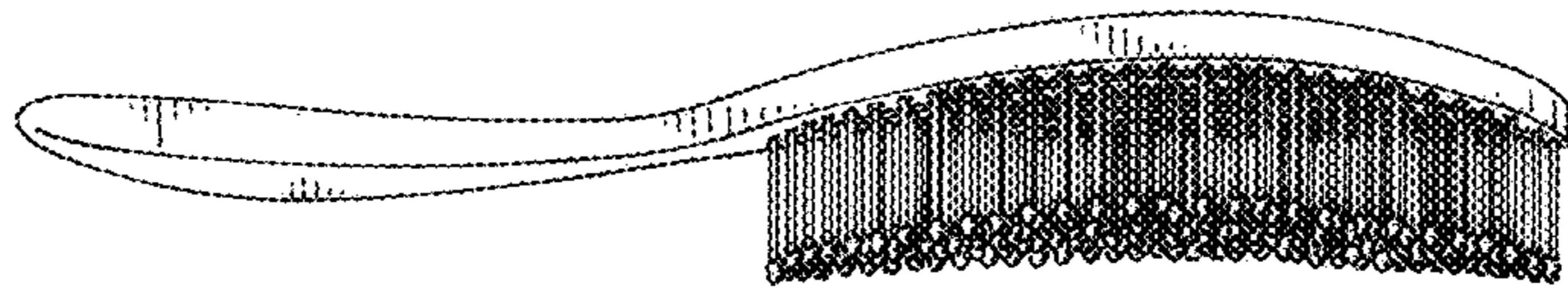

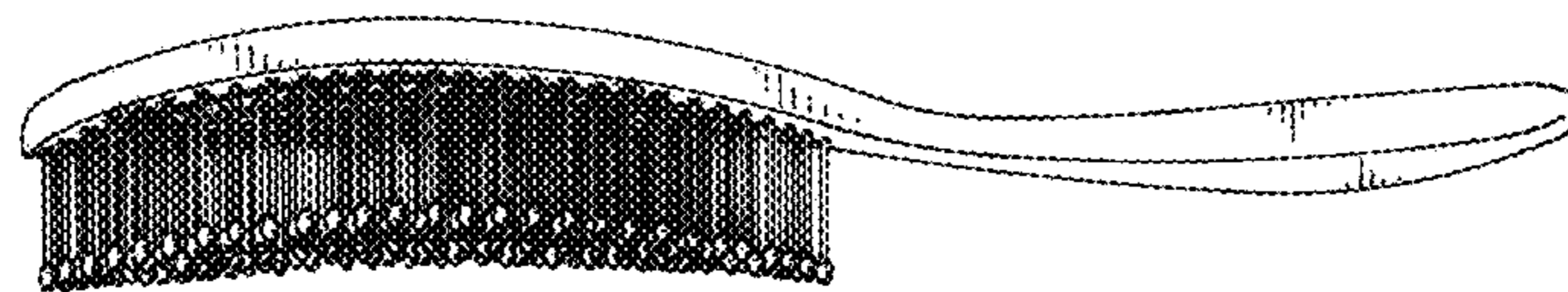

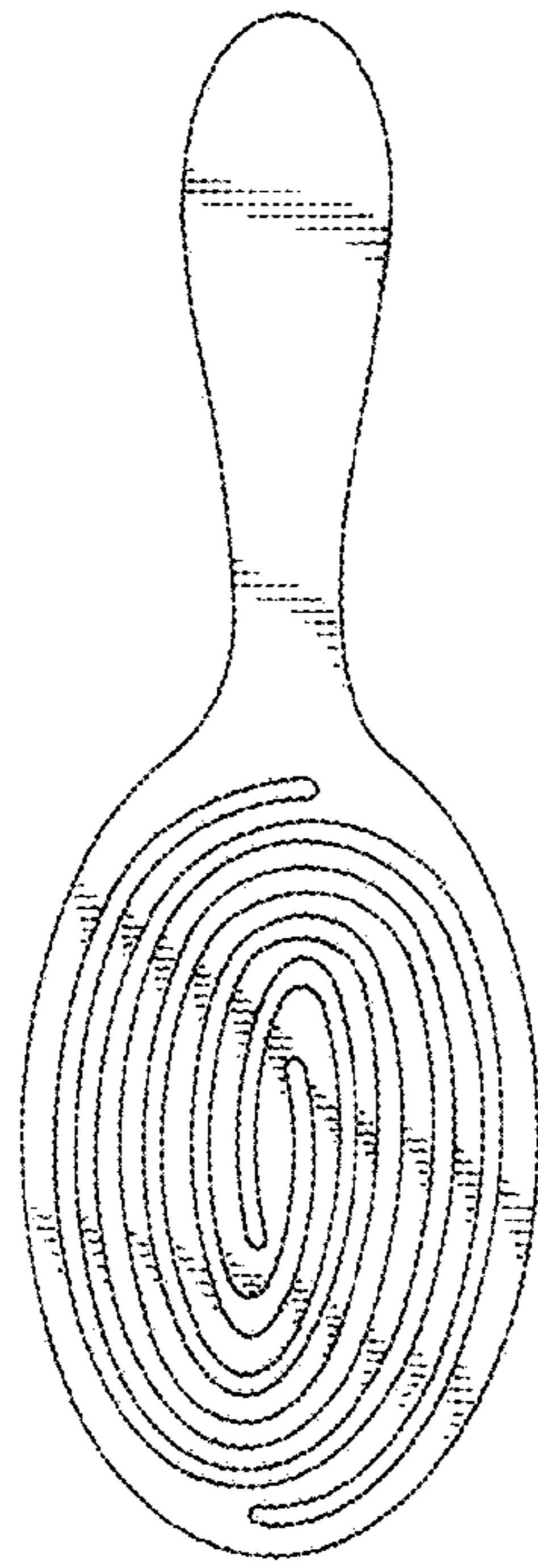

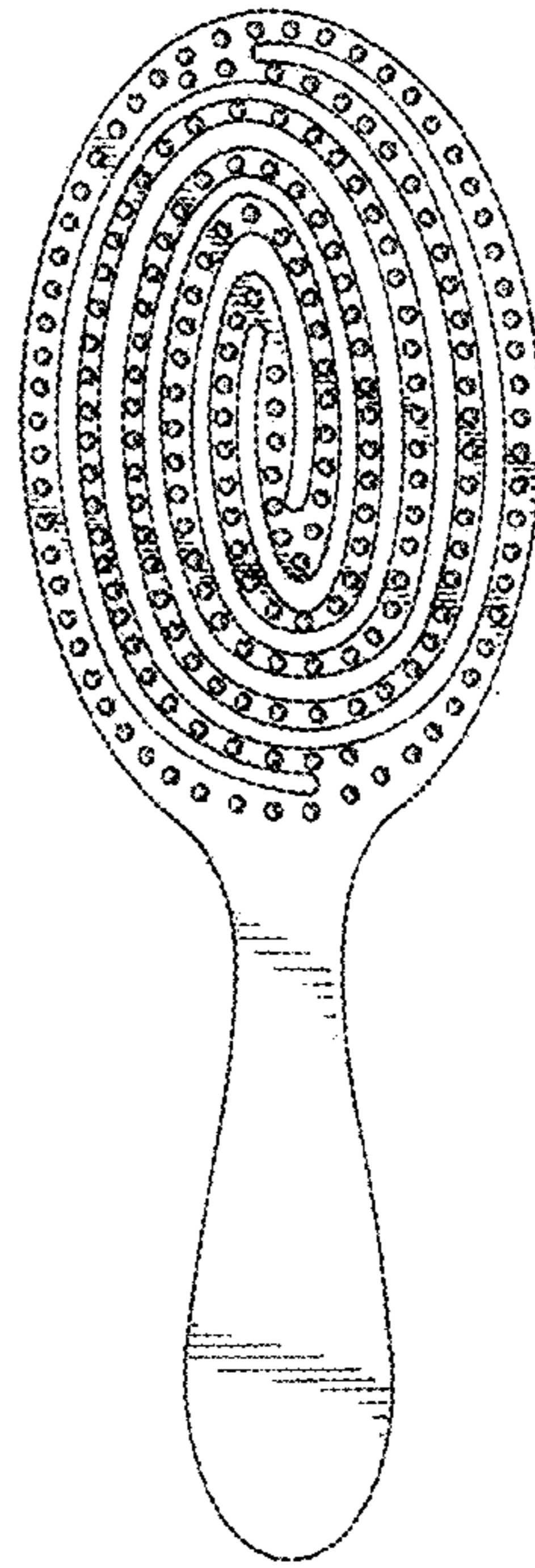
