DESCRIPTION

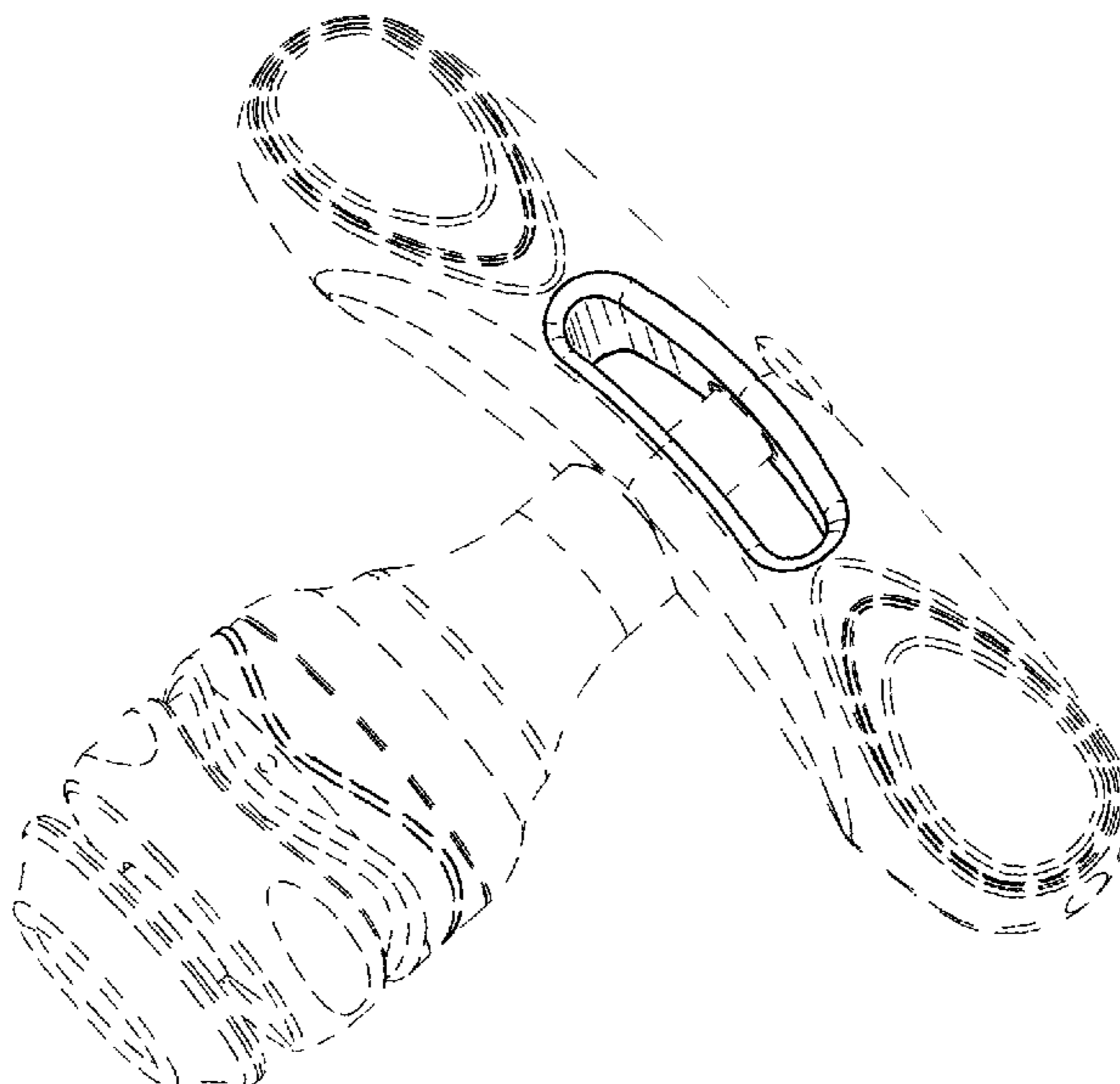
FIG. 1 is a perspective view of a handle embodying my new design;

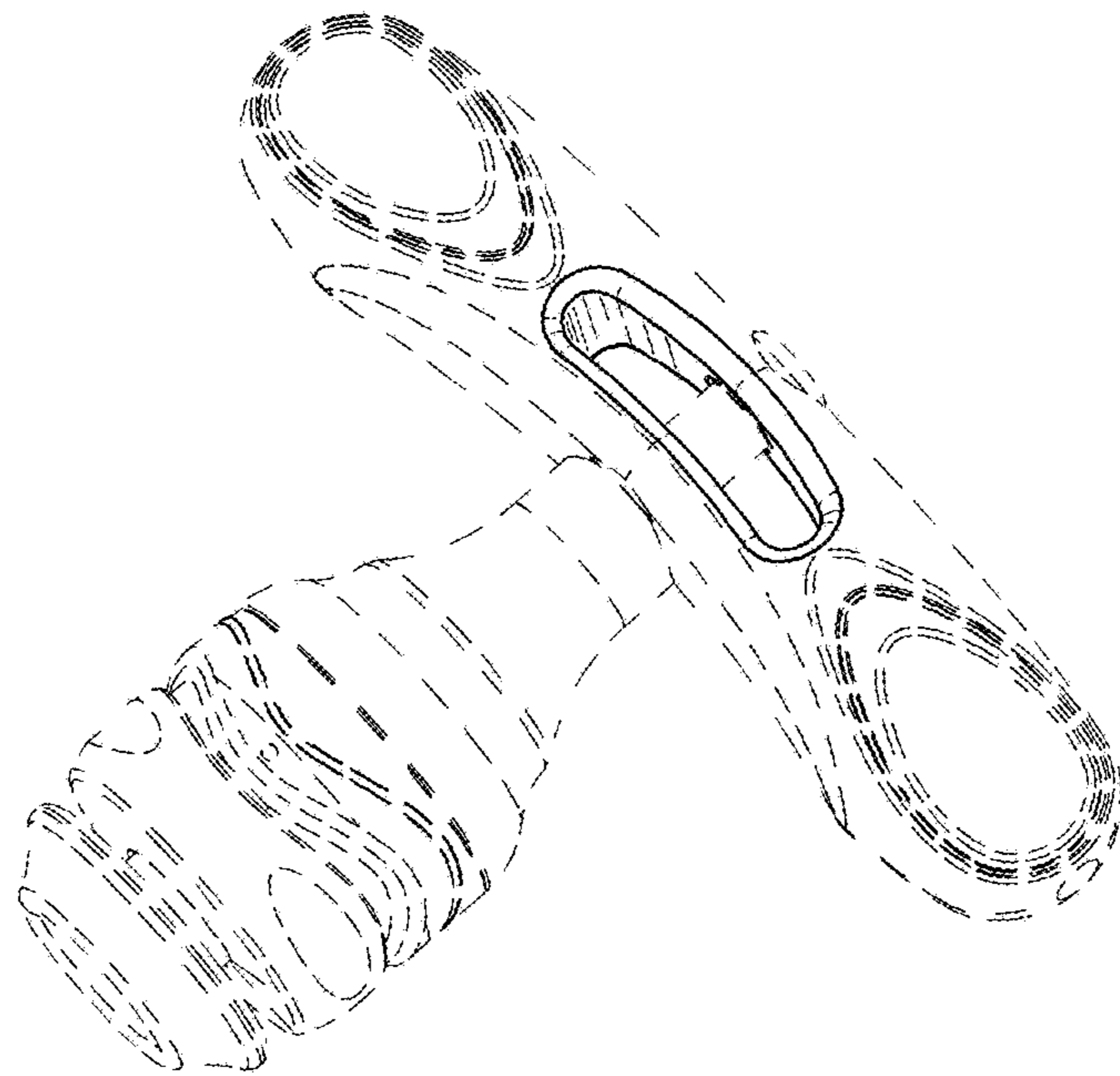

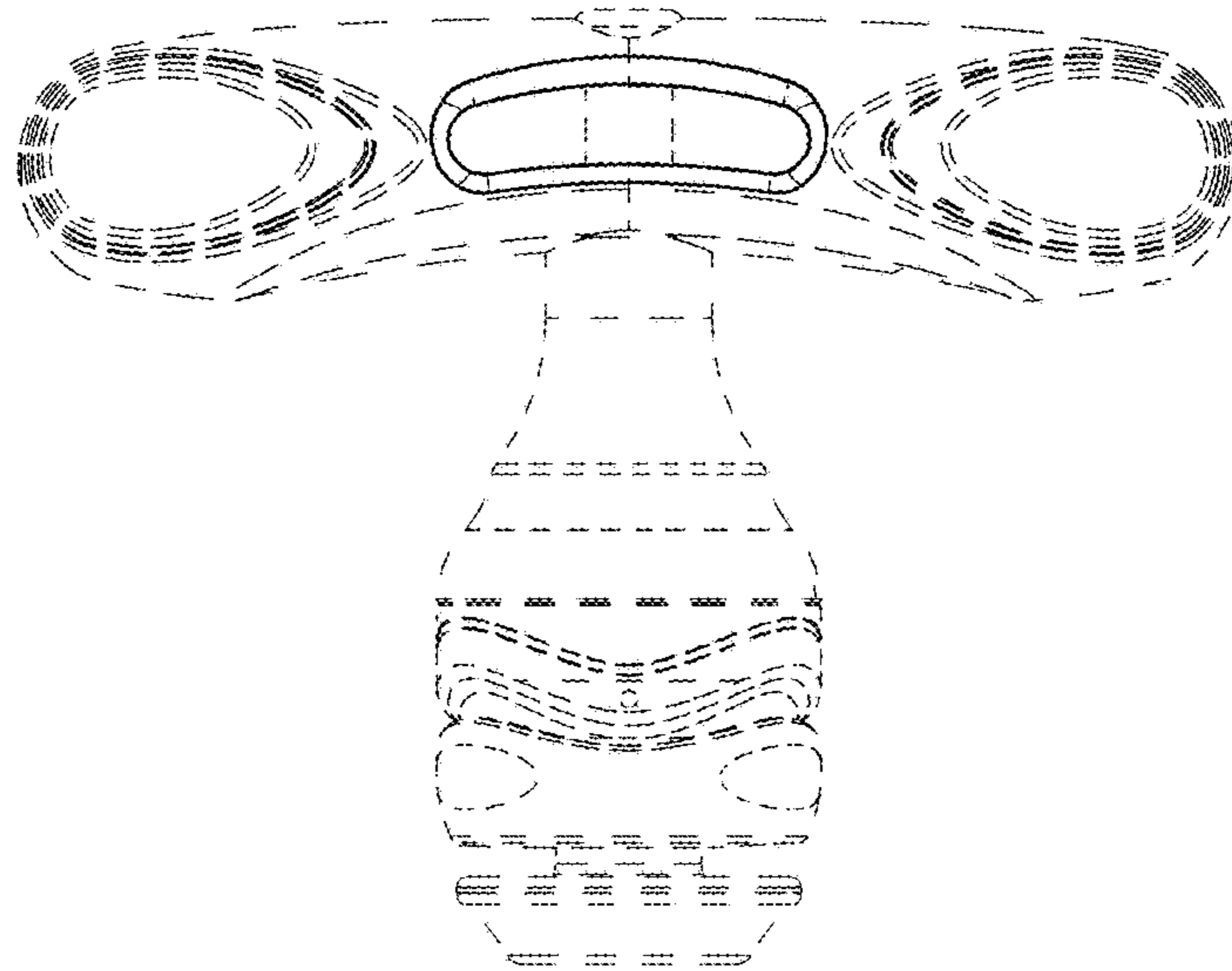

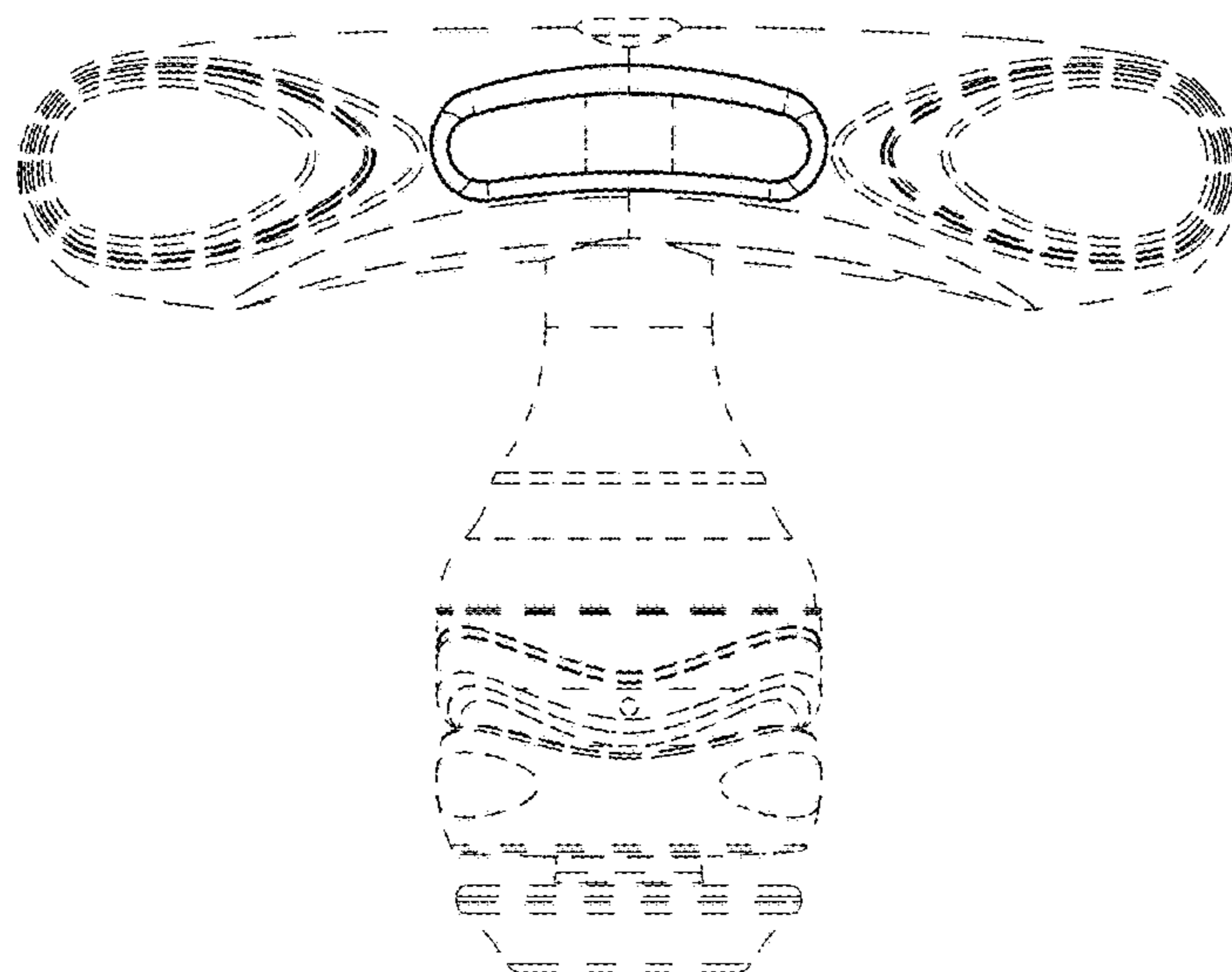

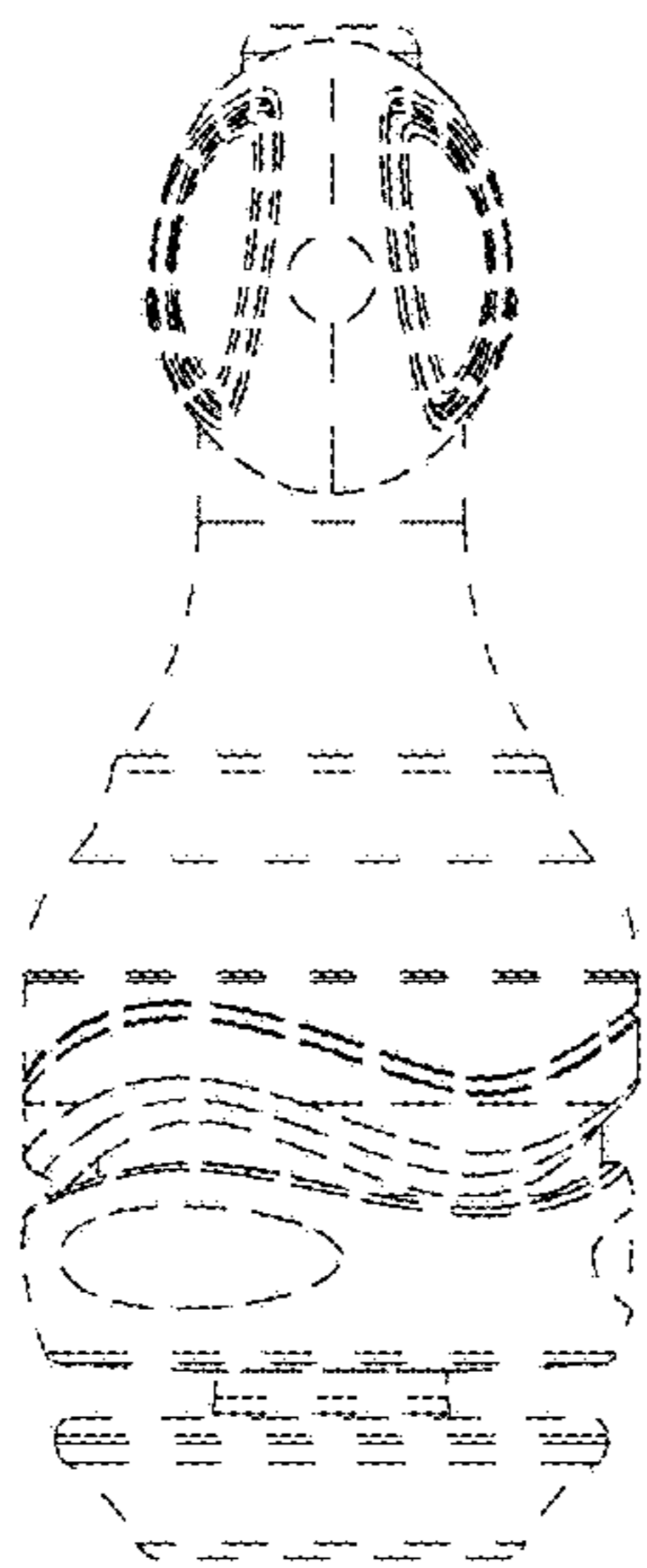

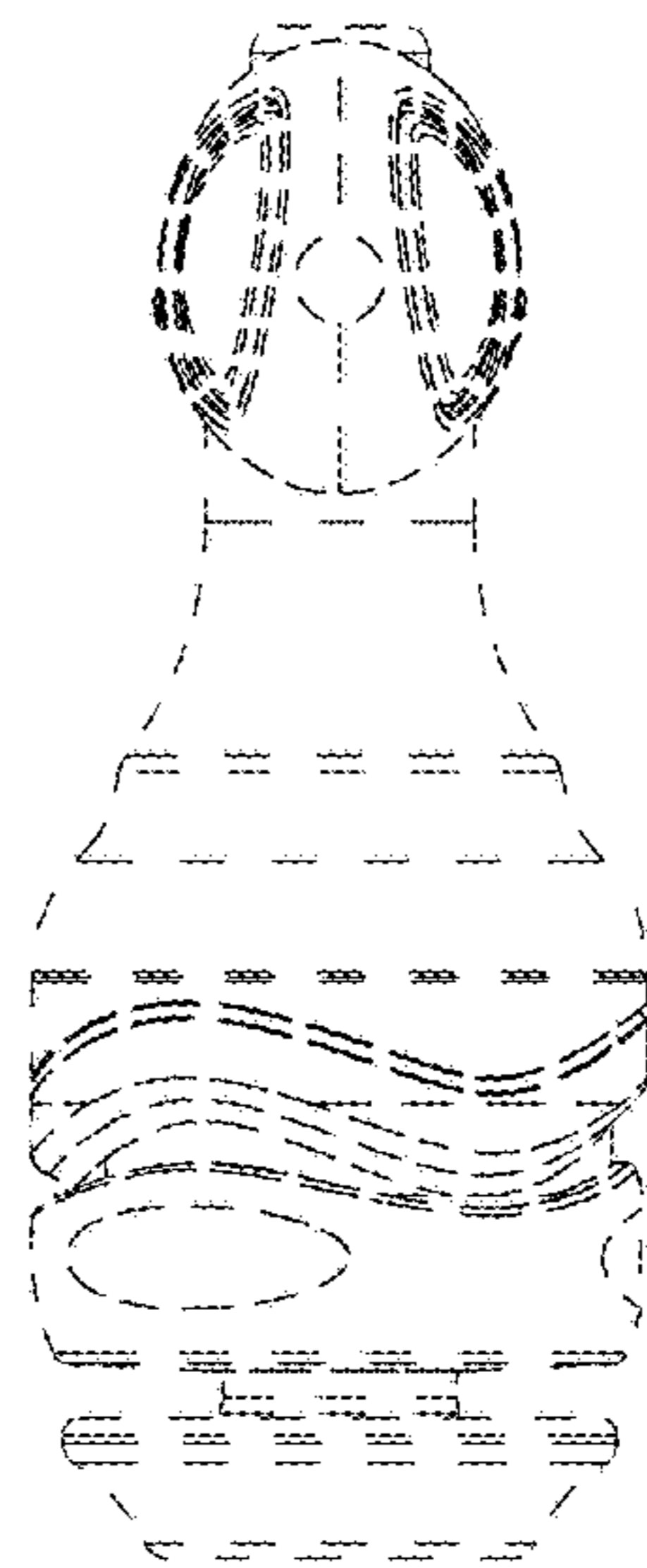

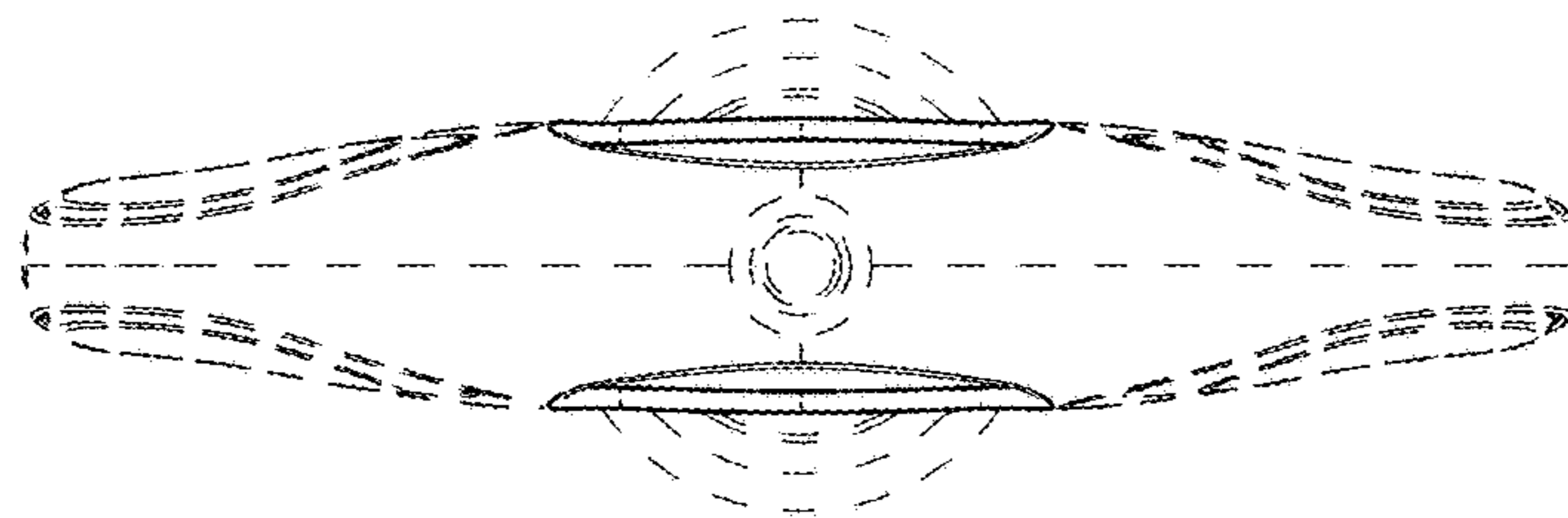

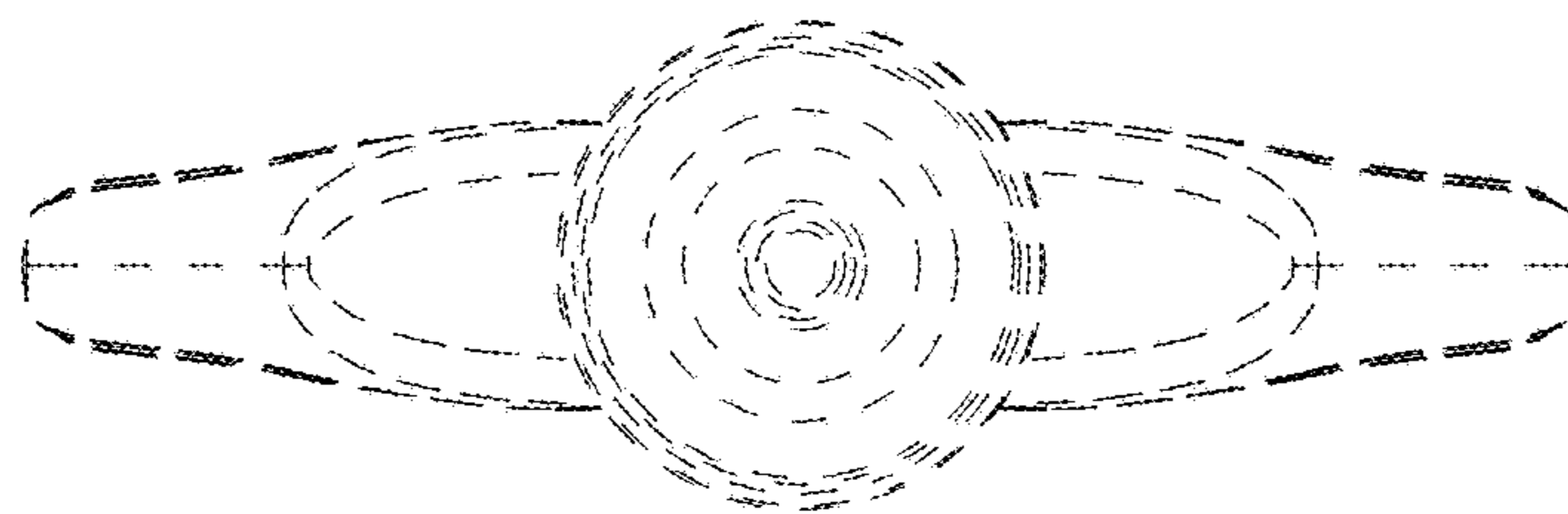
