(57) **CLAIM**

The ornamental design for a wall plate, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a wall plate, showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a perspective view of a second embodiment of a wall plate;  
FIG. 4 is a front view thereof;  
FIG. 5 is a perspective view of a third embodiment of a wall plate;  
FIG. 6 is a front view thereof;  
FIG. 7 is a perspective view of a fourth embodiment of a wall plate;  
FIG. 8 is a front view thereof;  
FIG. 9 is a right side view thereof; the left side view is a mirror image of the right side view and is not shown; the side views of the wall plates of FIGS. 1, 3, and 5 are identical to the side views of the wall plate of FIG. 7 and so are not shown;  
FIG. 10 is a top view thereof; the bottom view is a mirror image of the top view and is not shown; the top and bottom views of the wall plates of FIGS. 1, 3, and 5 are identical to the top and bottom views of the wall plate of FIG. 7 and so are not shown;  
FIG. 11 is a perspective view of a fifth embodiment of a wall plate;  
FIG. 12 is a front view thereof;  
FIG. 13 is a perspective view a sixth embodiment of a wall plate;  
FIG. 14 is a front view thereof;  
FIG. 15 is a perspective view of a seventh embodiment of a wall plate;  
FIG. 16 is a front view thereof;  
FIG. 17 is a right side view thereof; the left side view is a mirror image of the right side view and is not shown; the side views of the wall plates of FIGS. 11, and 13 are identical to the side views of the wall plate of FIG. 17 and so are not shown;

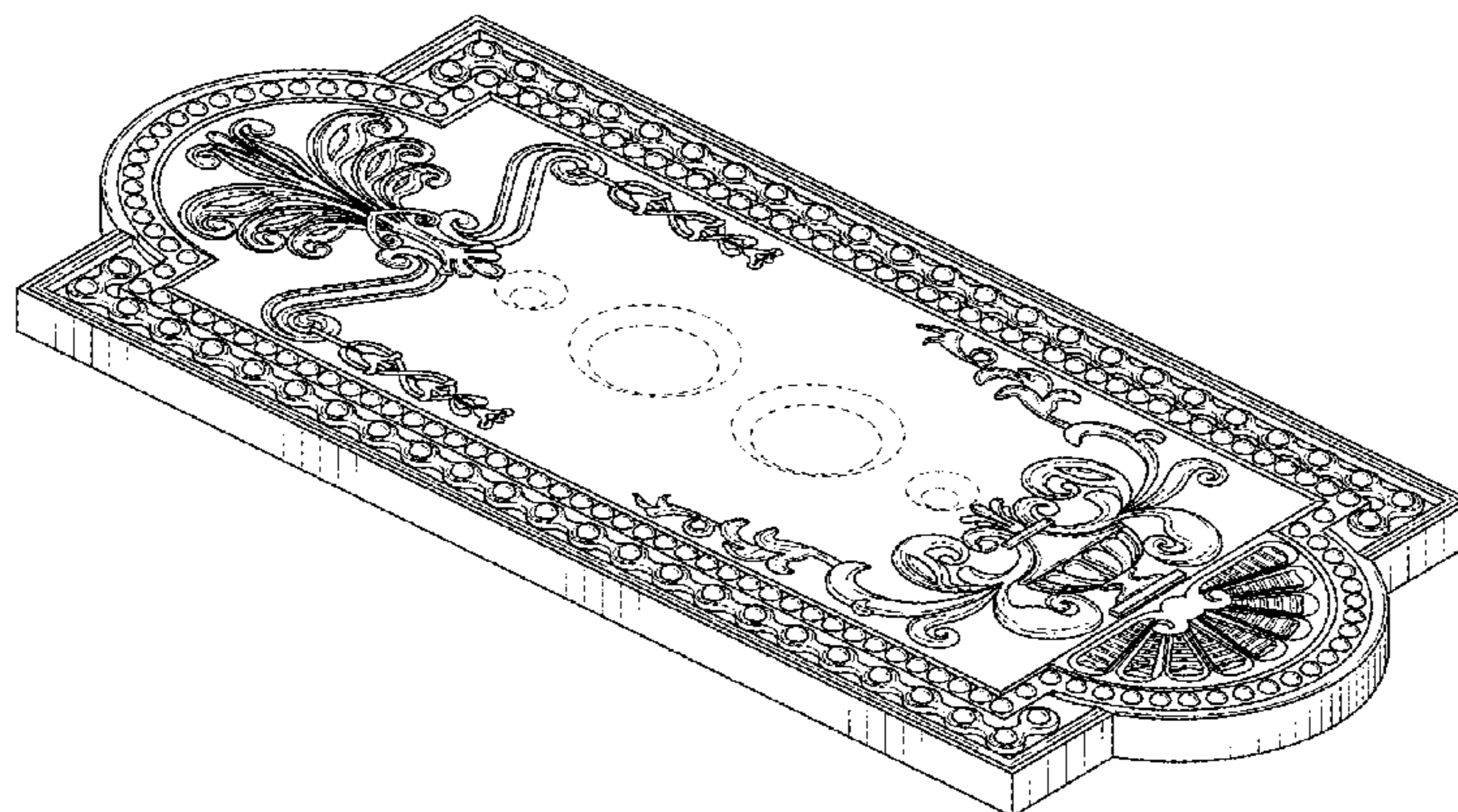

FIG. 26 is a top view thereof; the bottom view is a mirror image of the top view and is not shown; the top and bottom views of the wall plates of FIGS. 19, and 21 are identical to the top and bottom views of the wall plate of FIG. 23 and so are not shown.

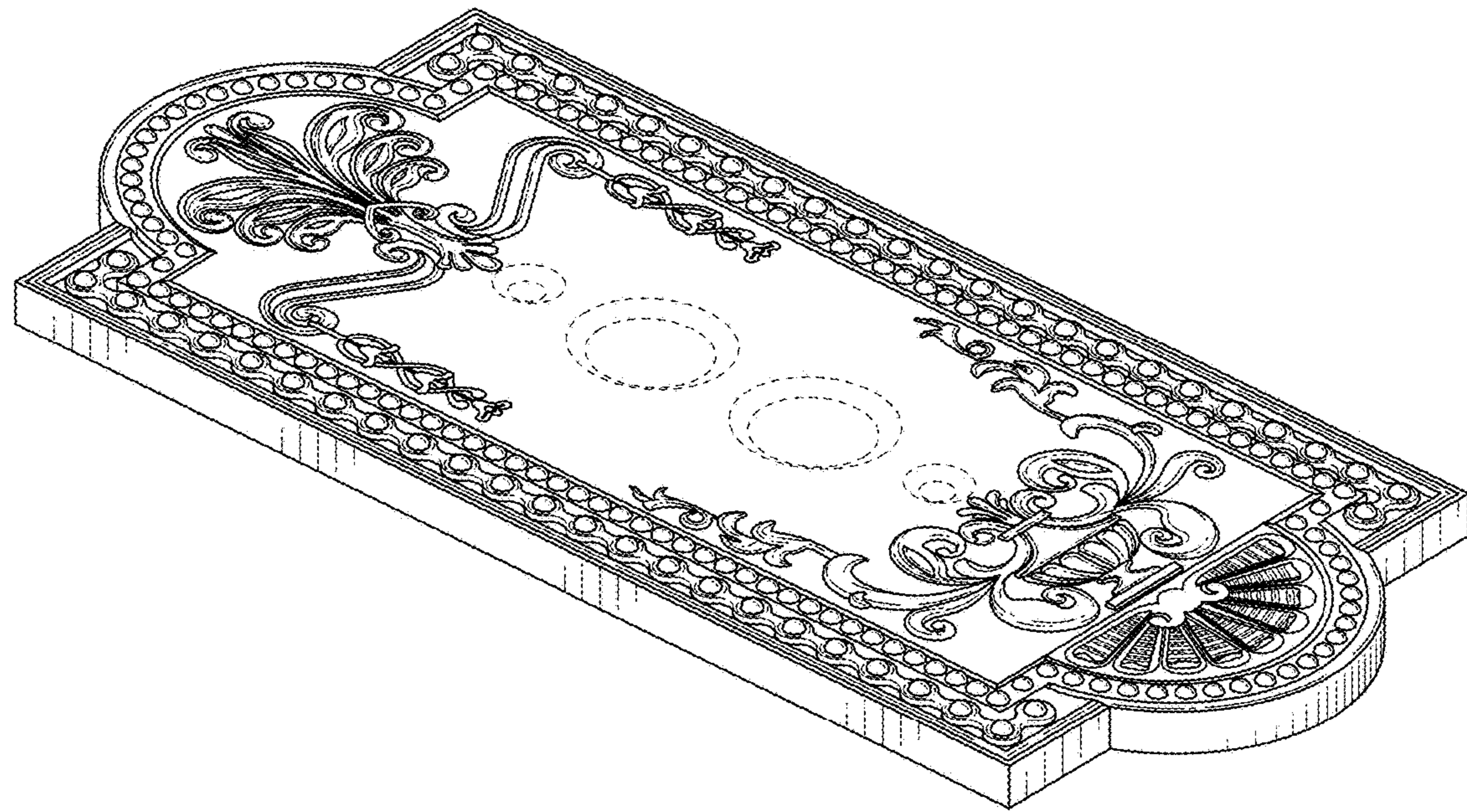

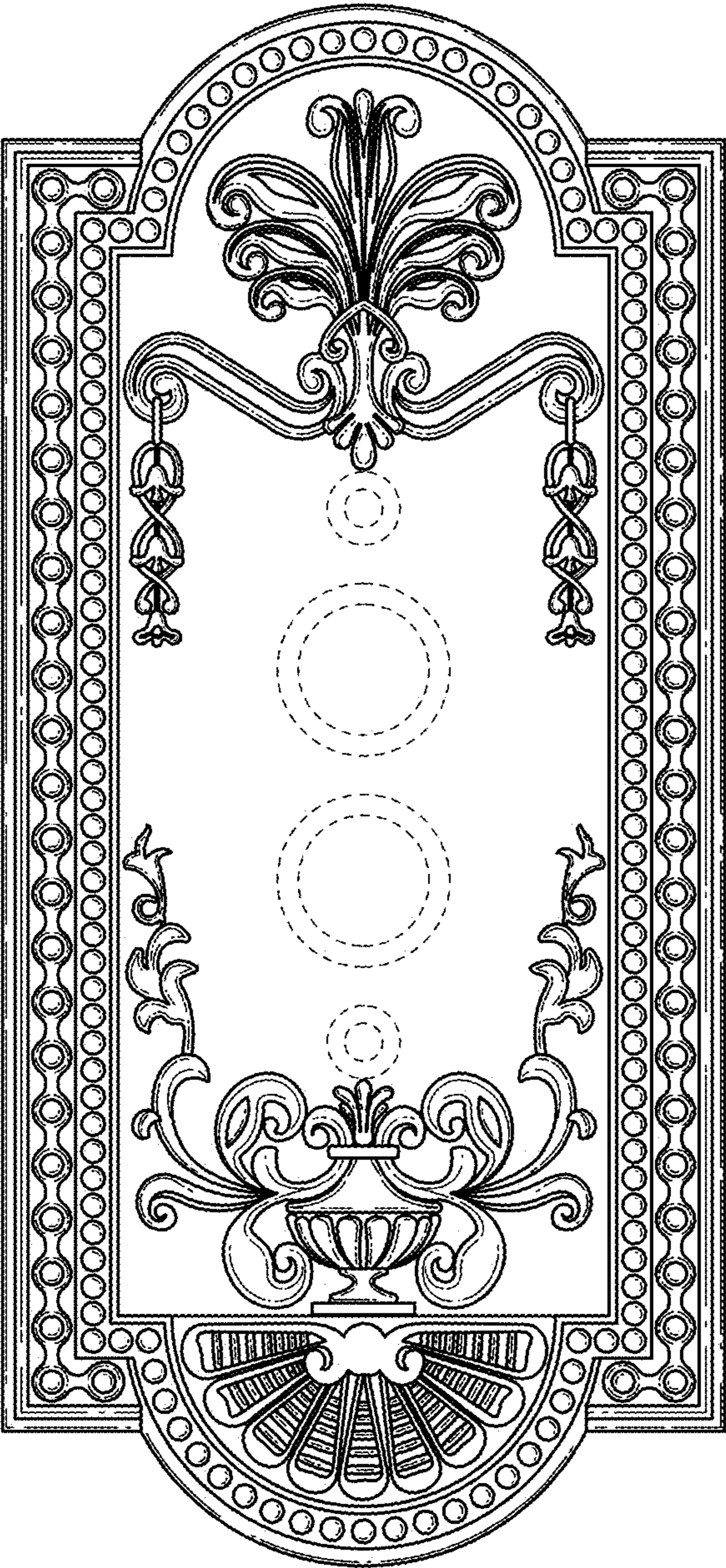

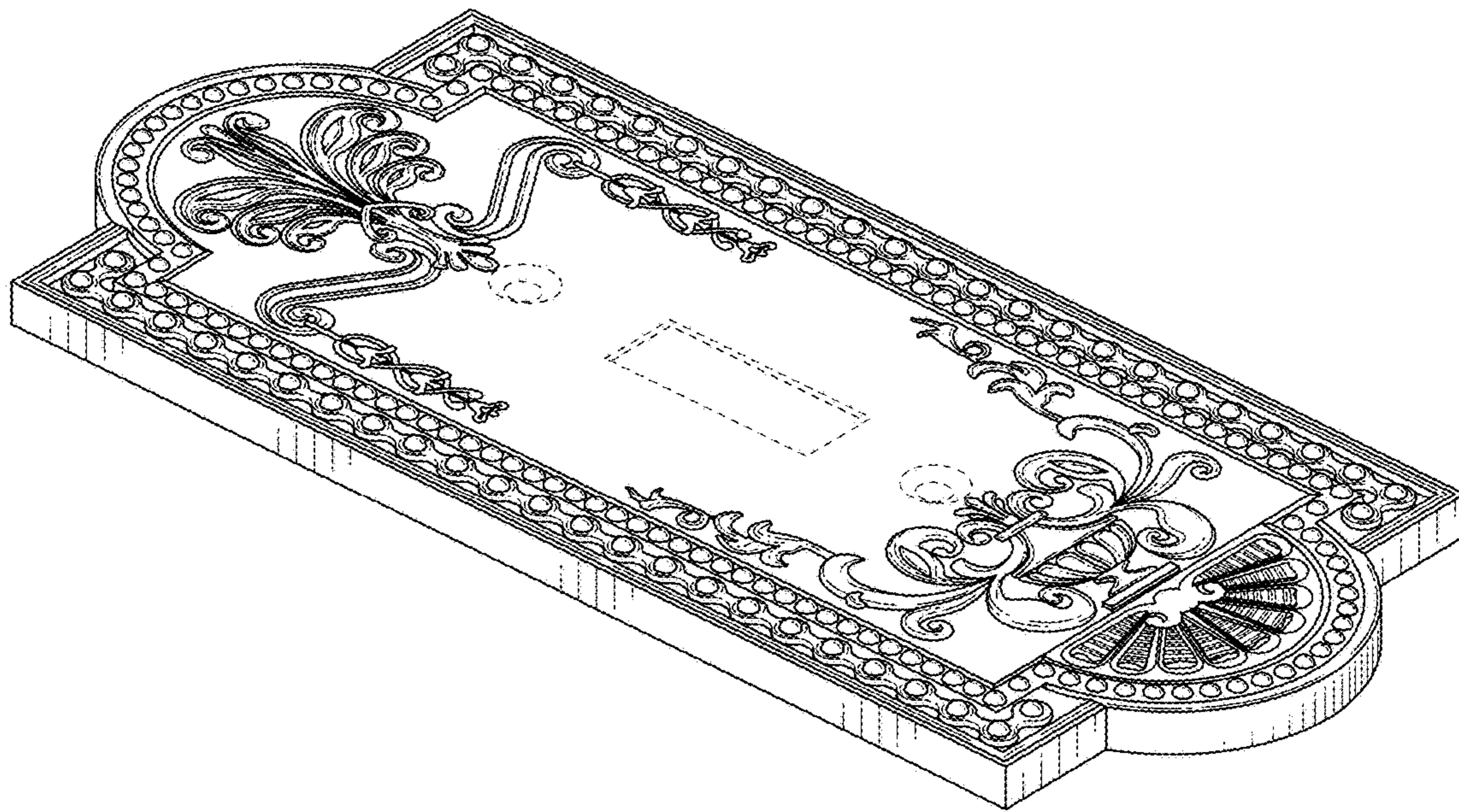

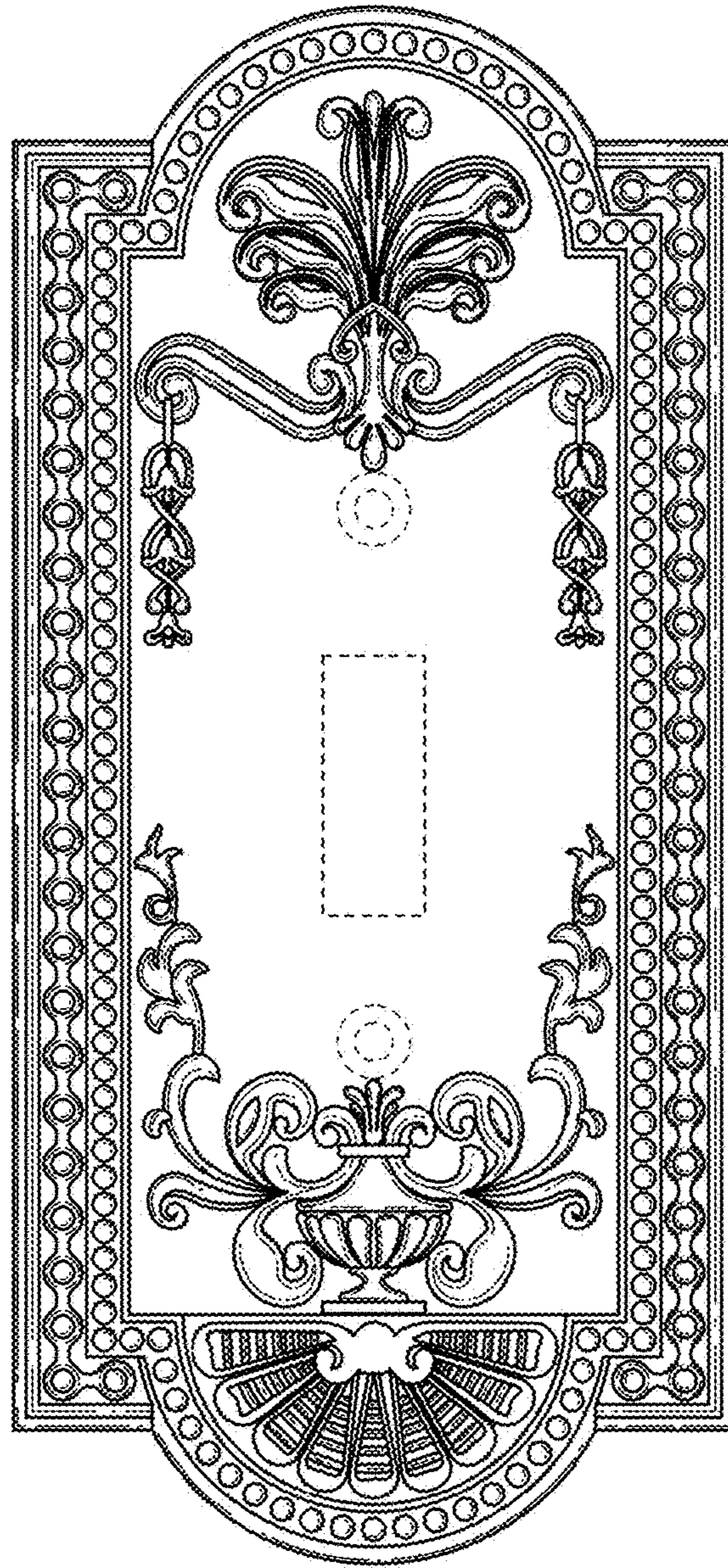

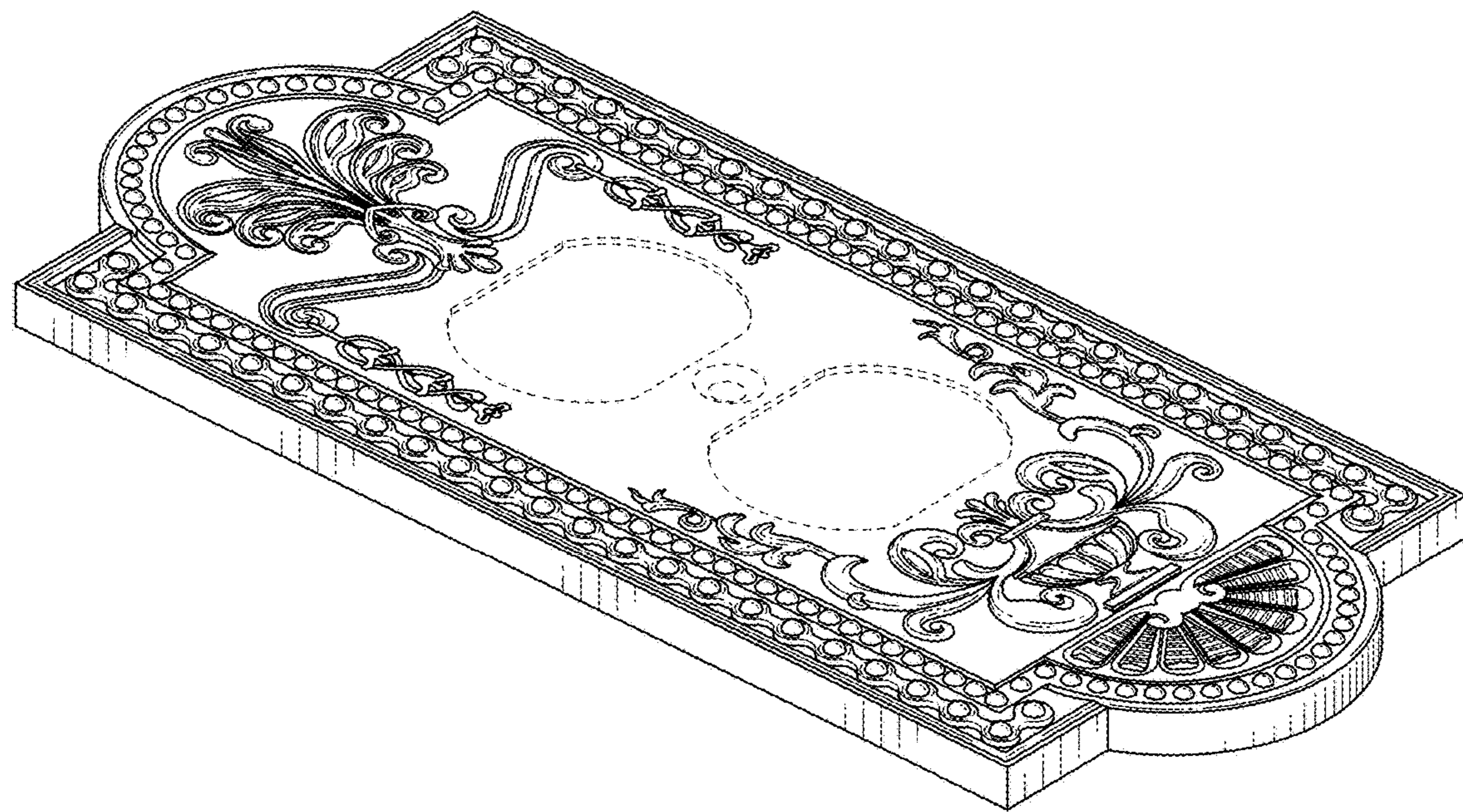

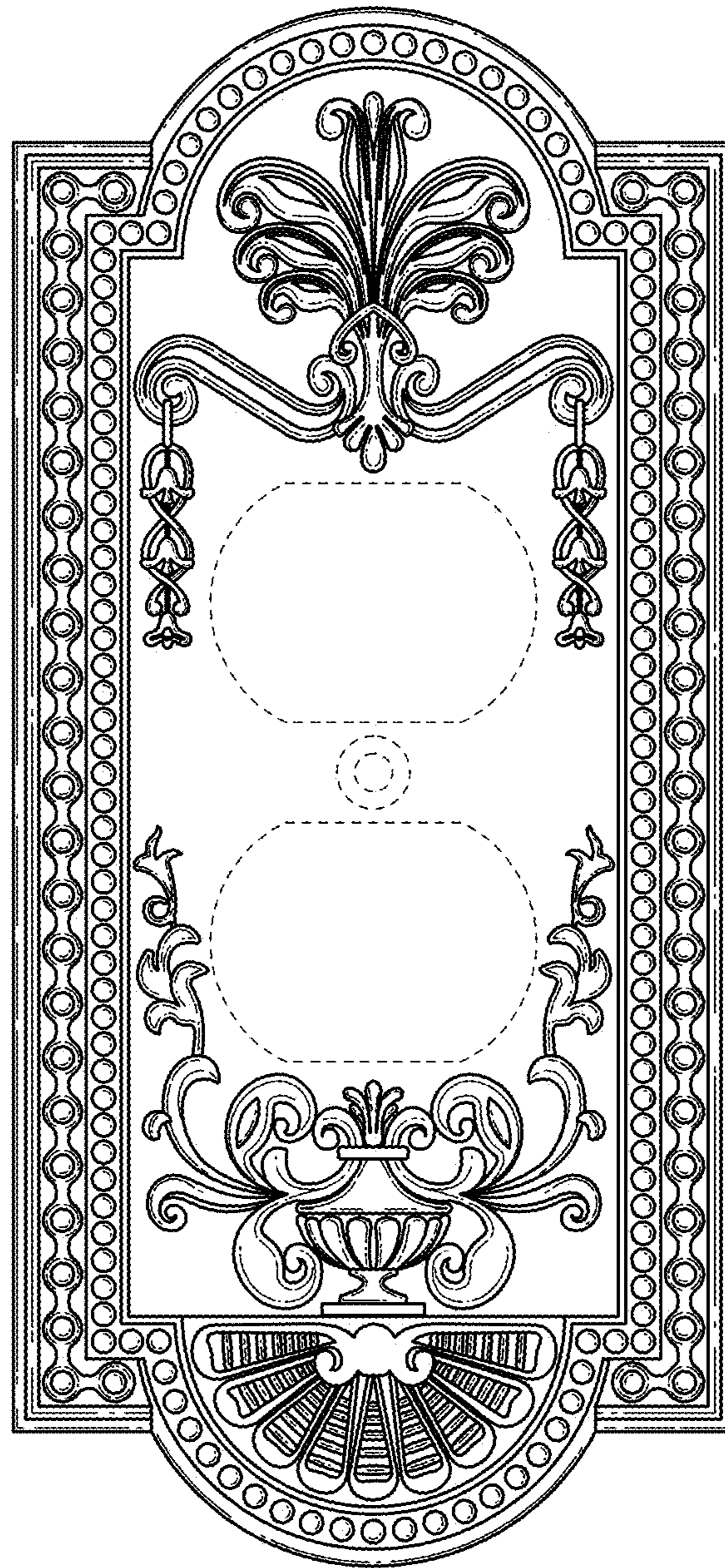

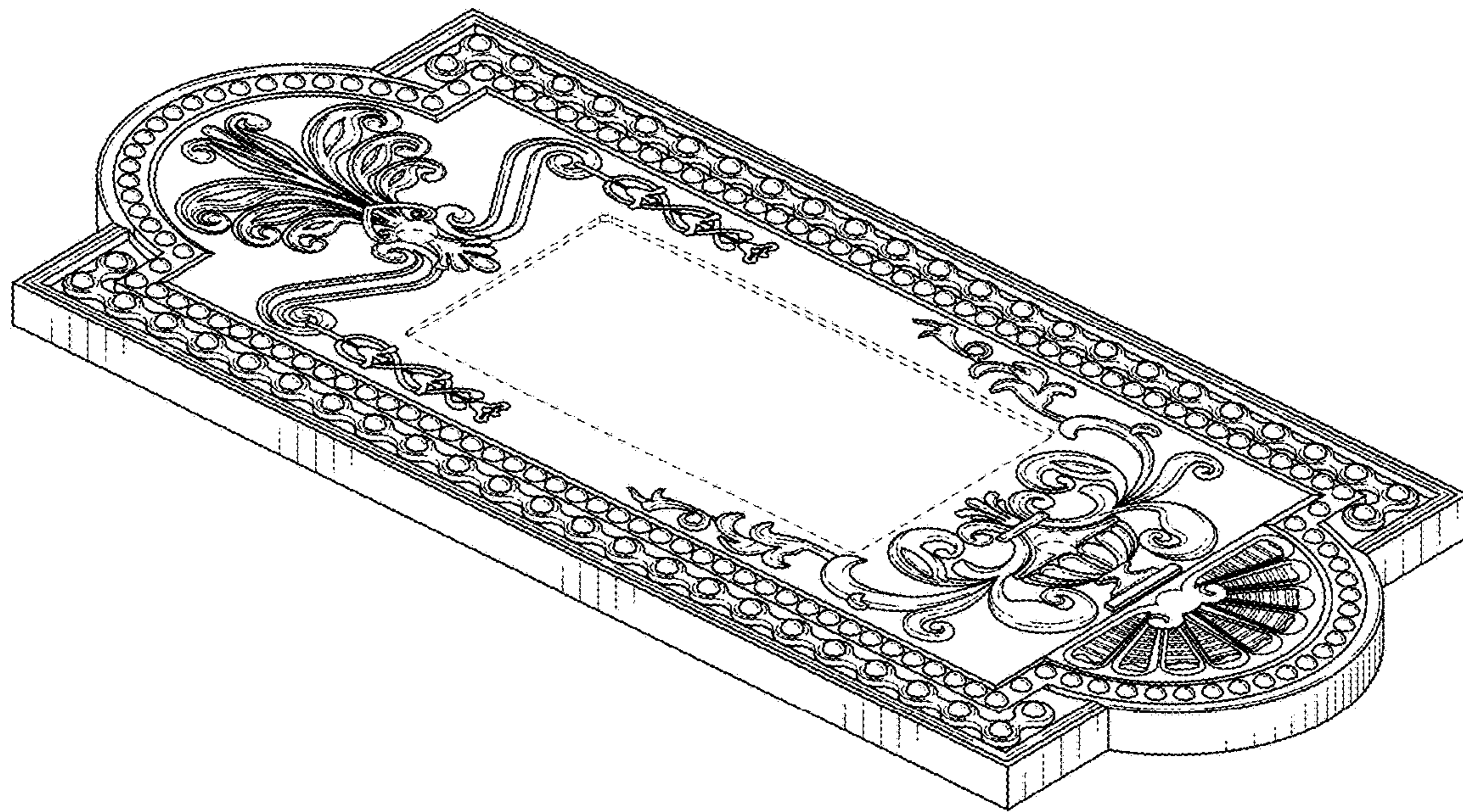

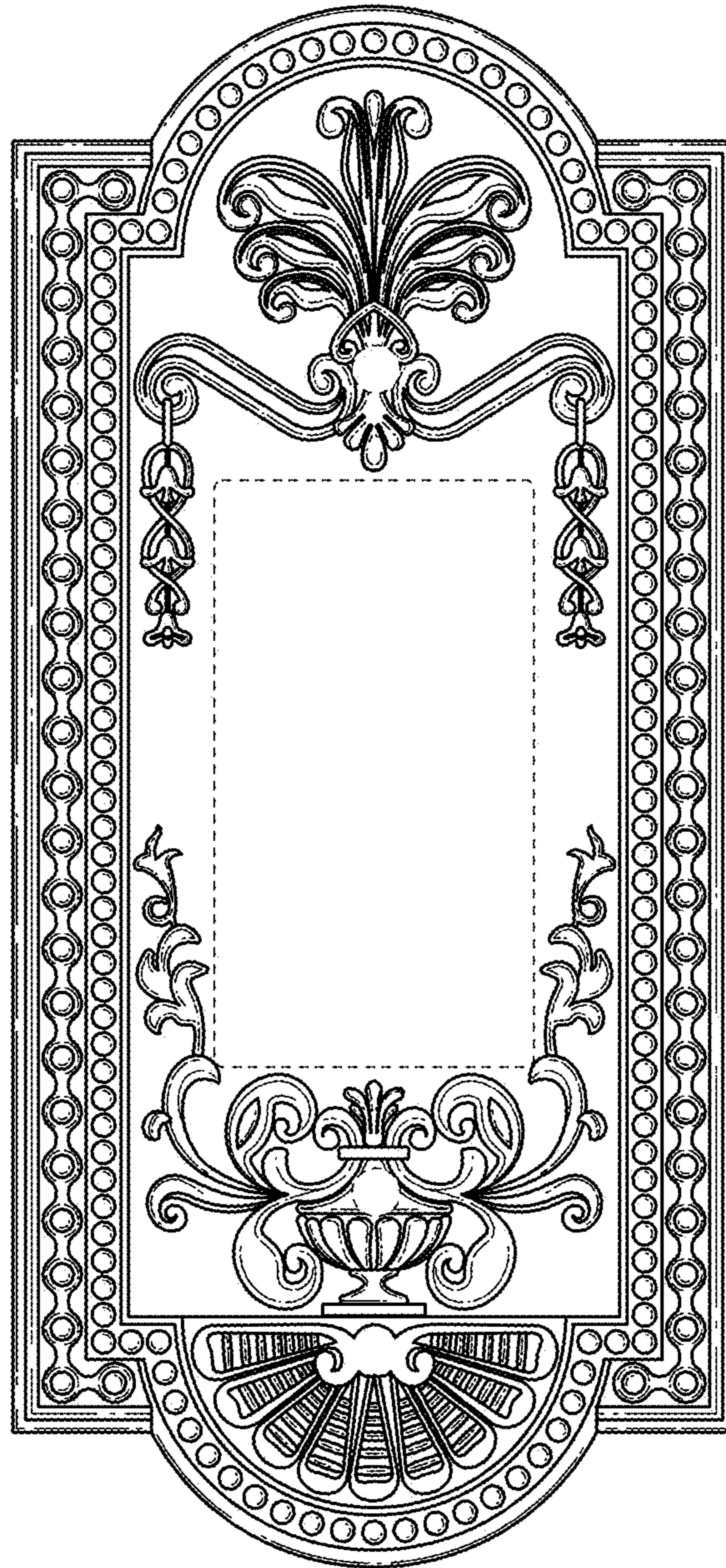

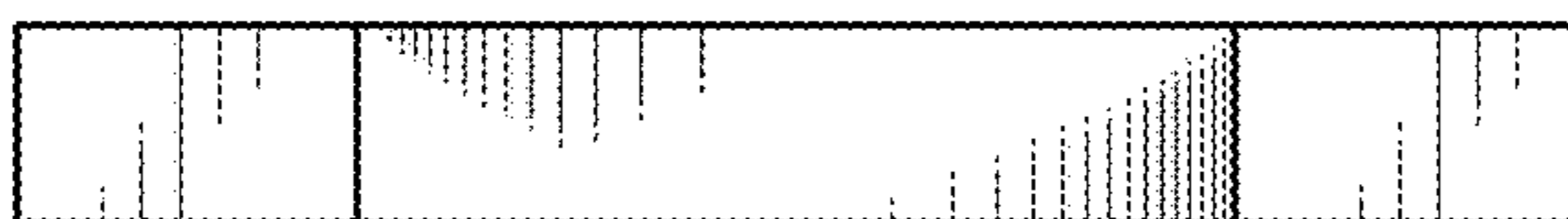

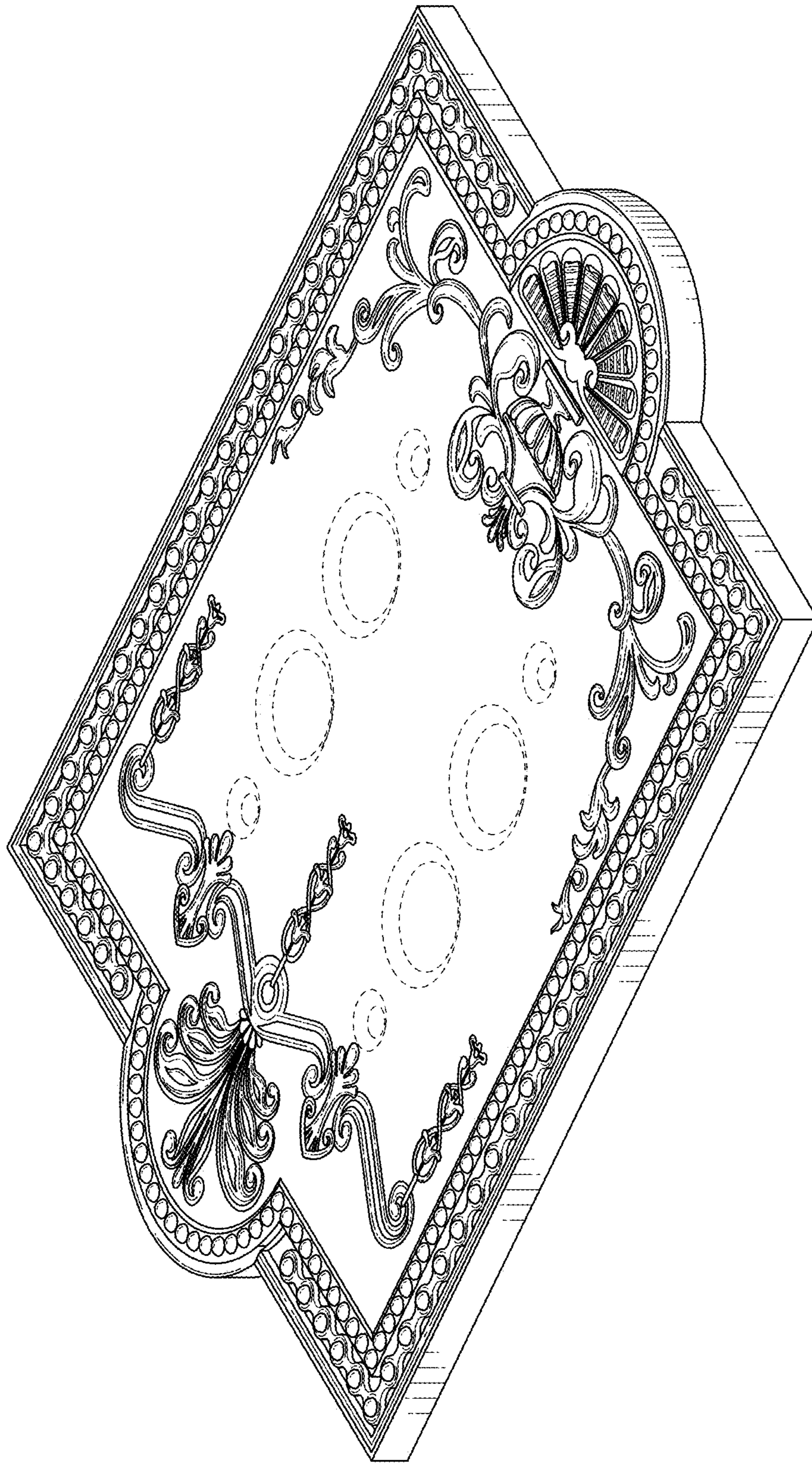

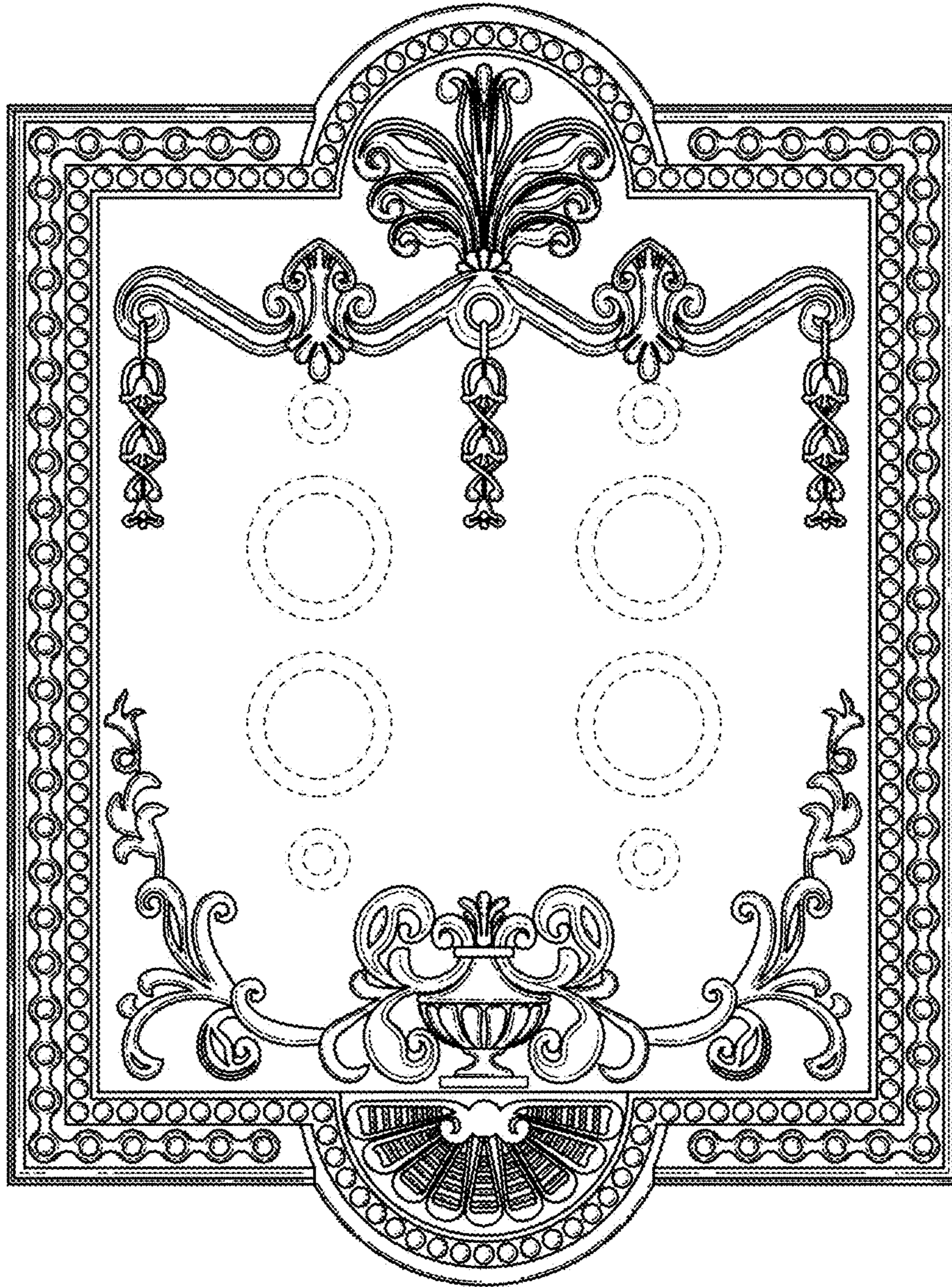

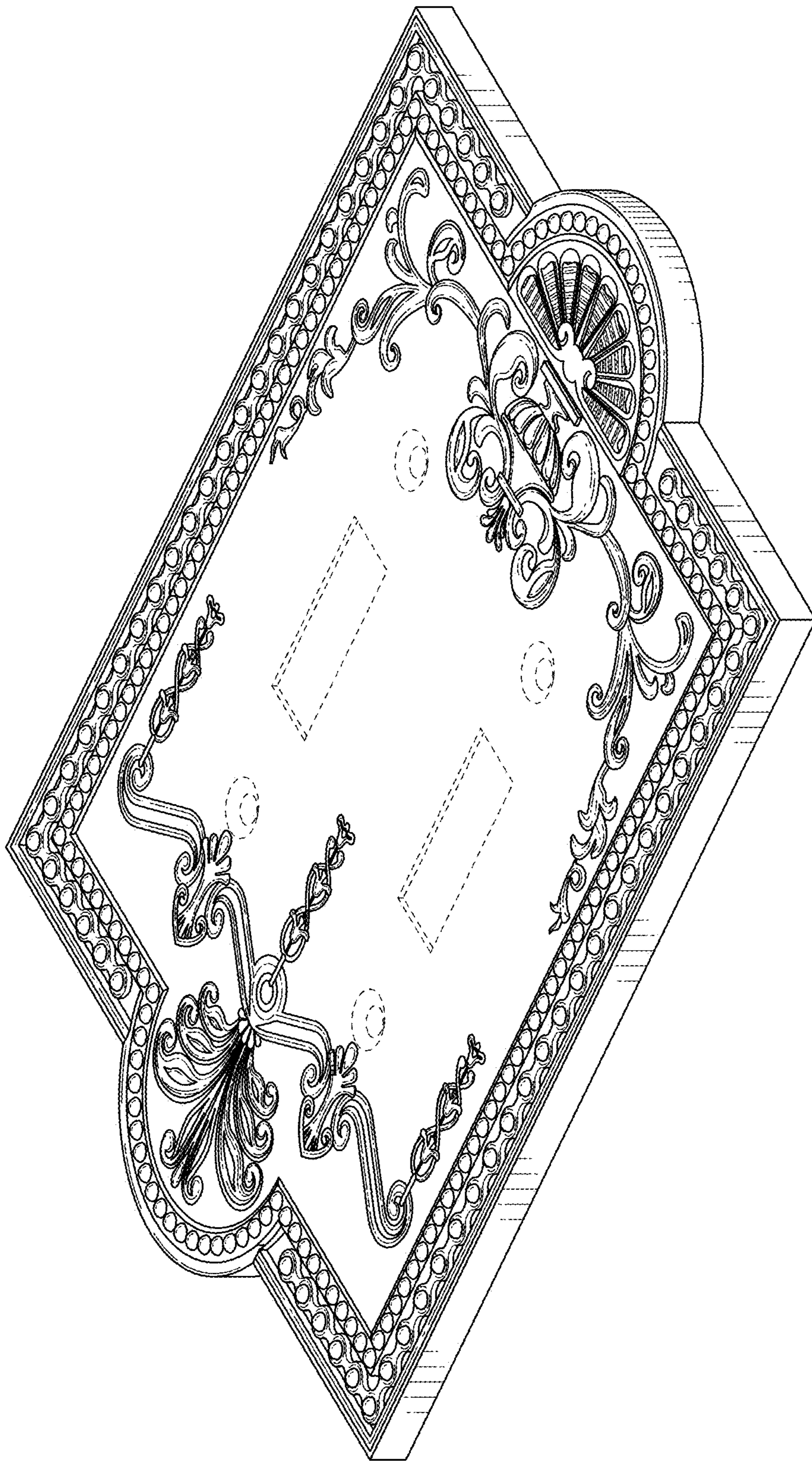

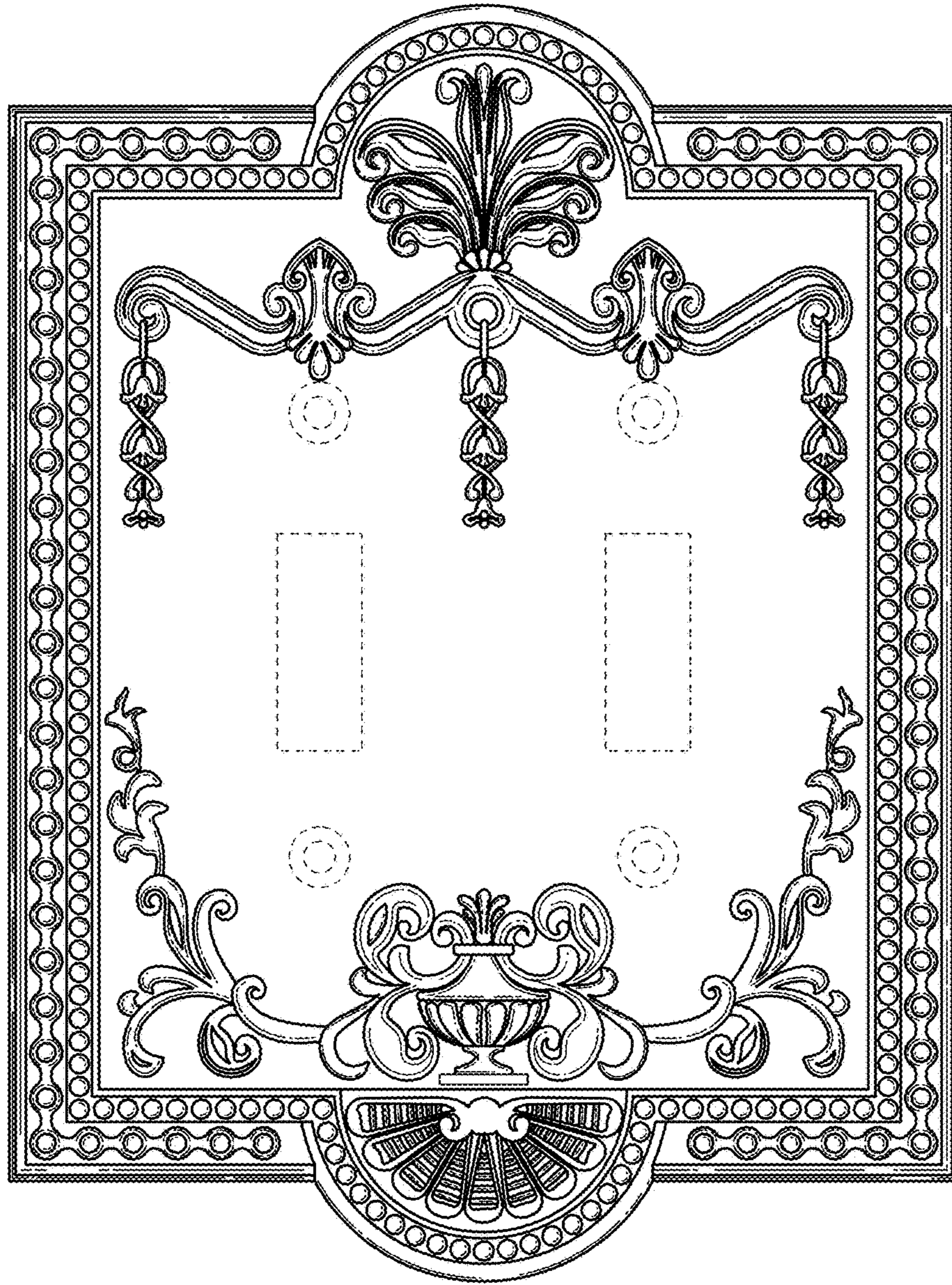

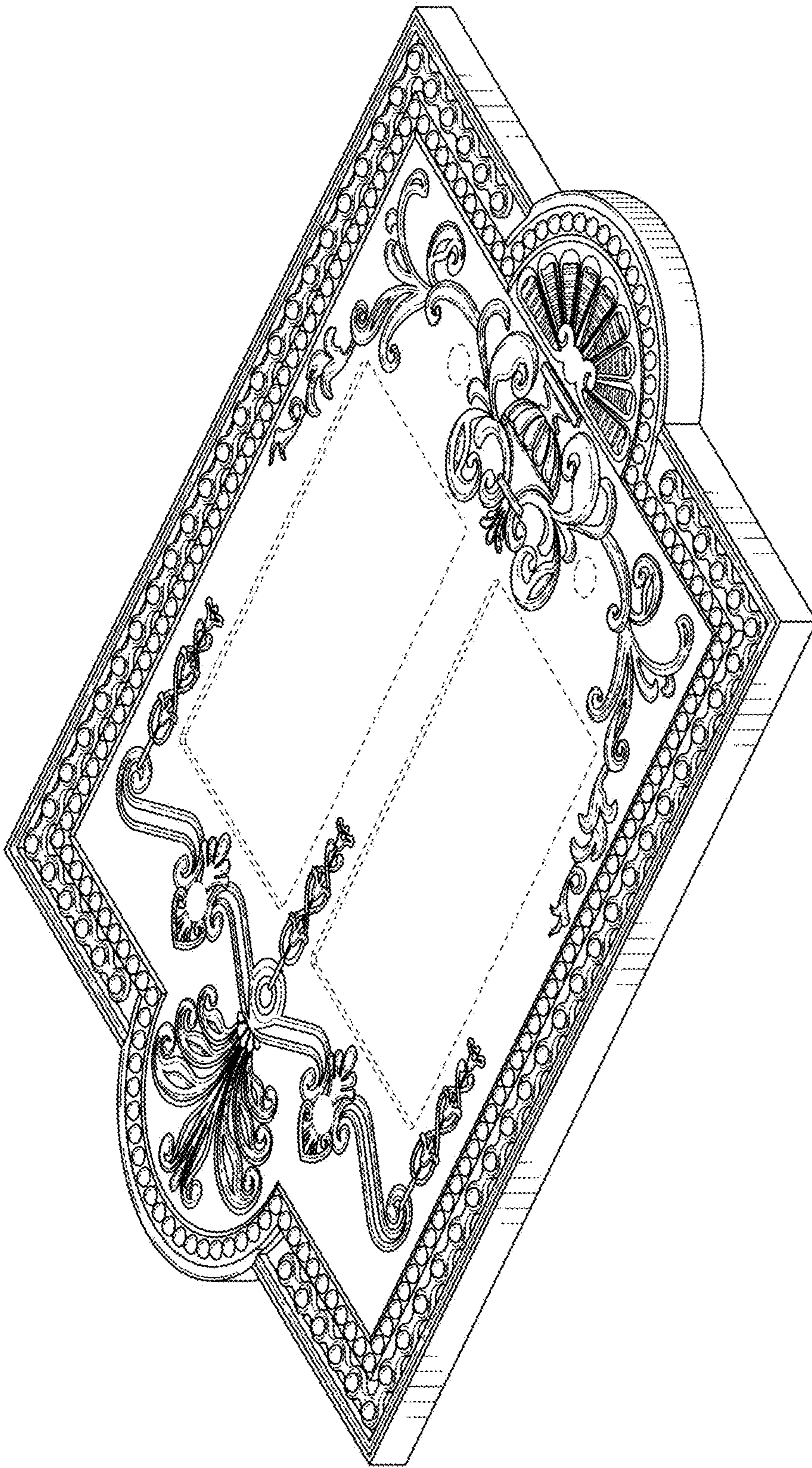

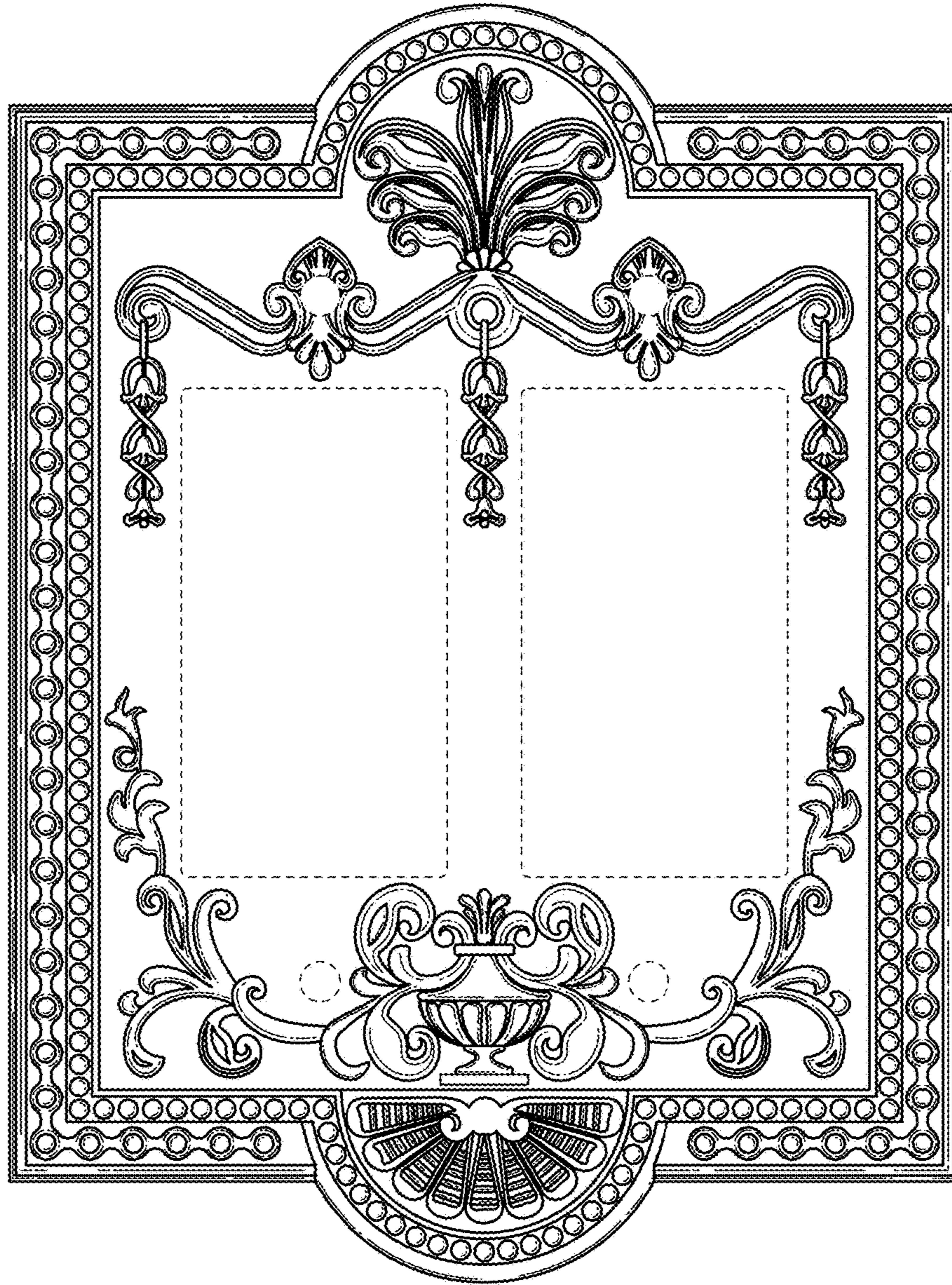

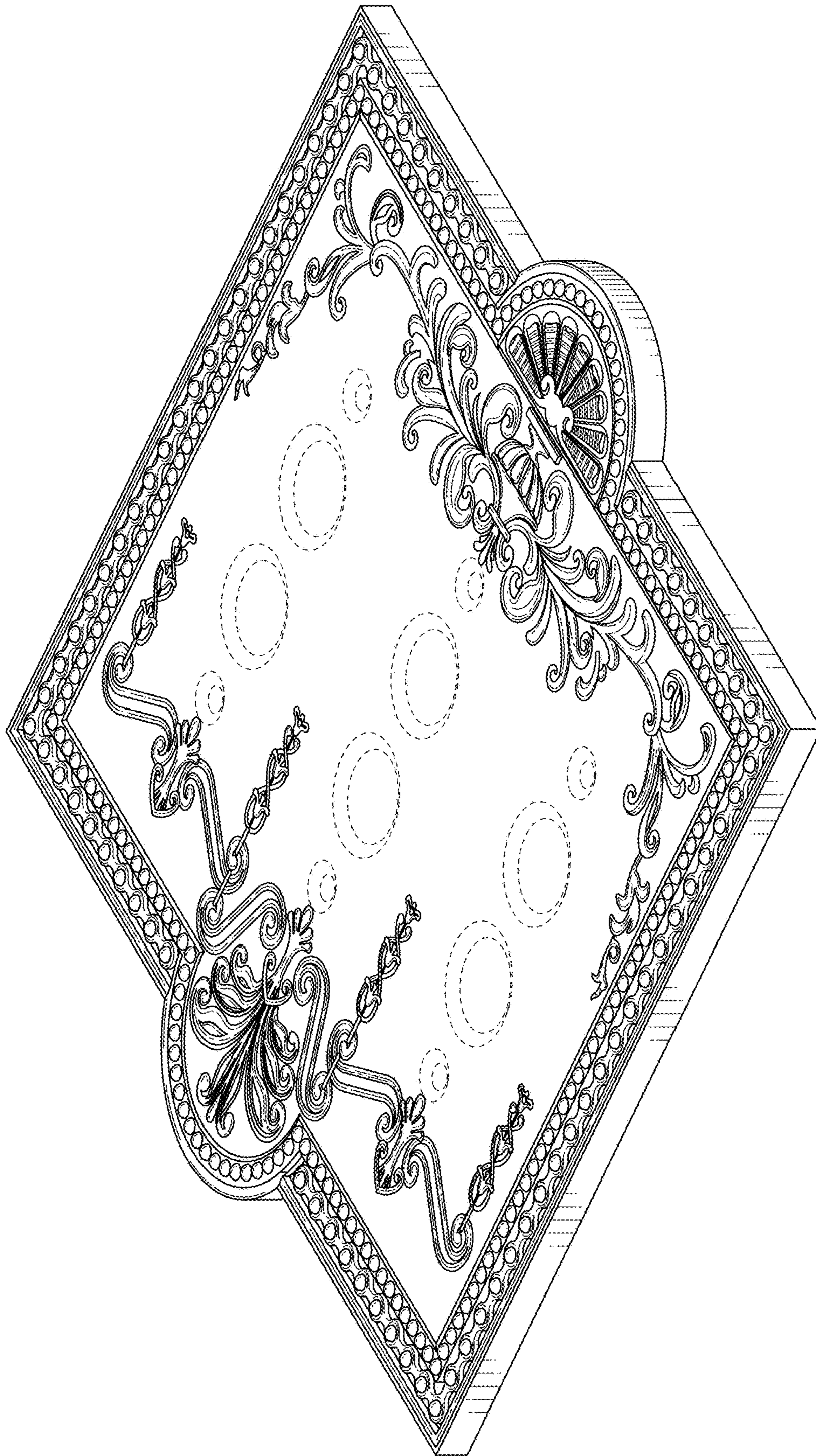

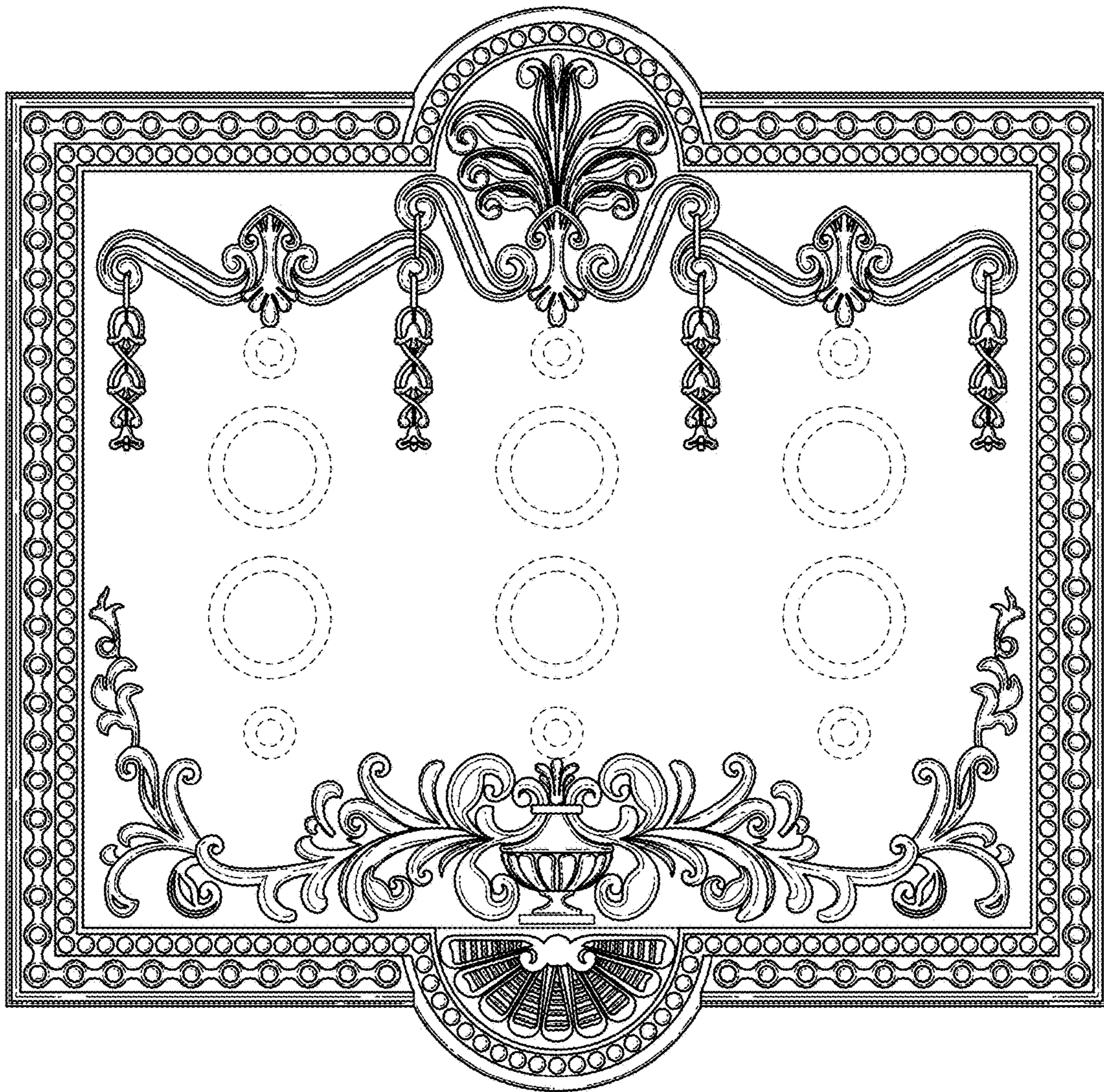

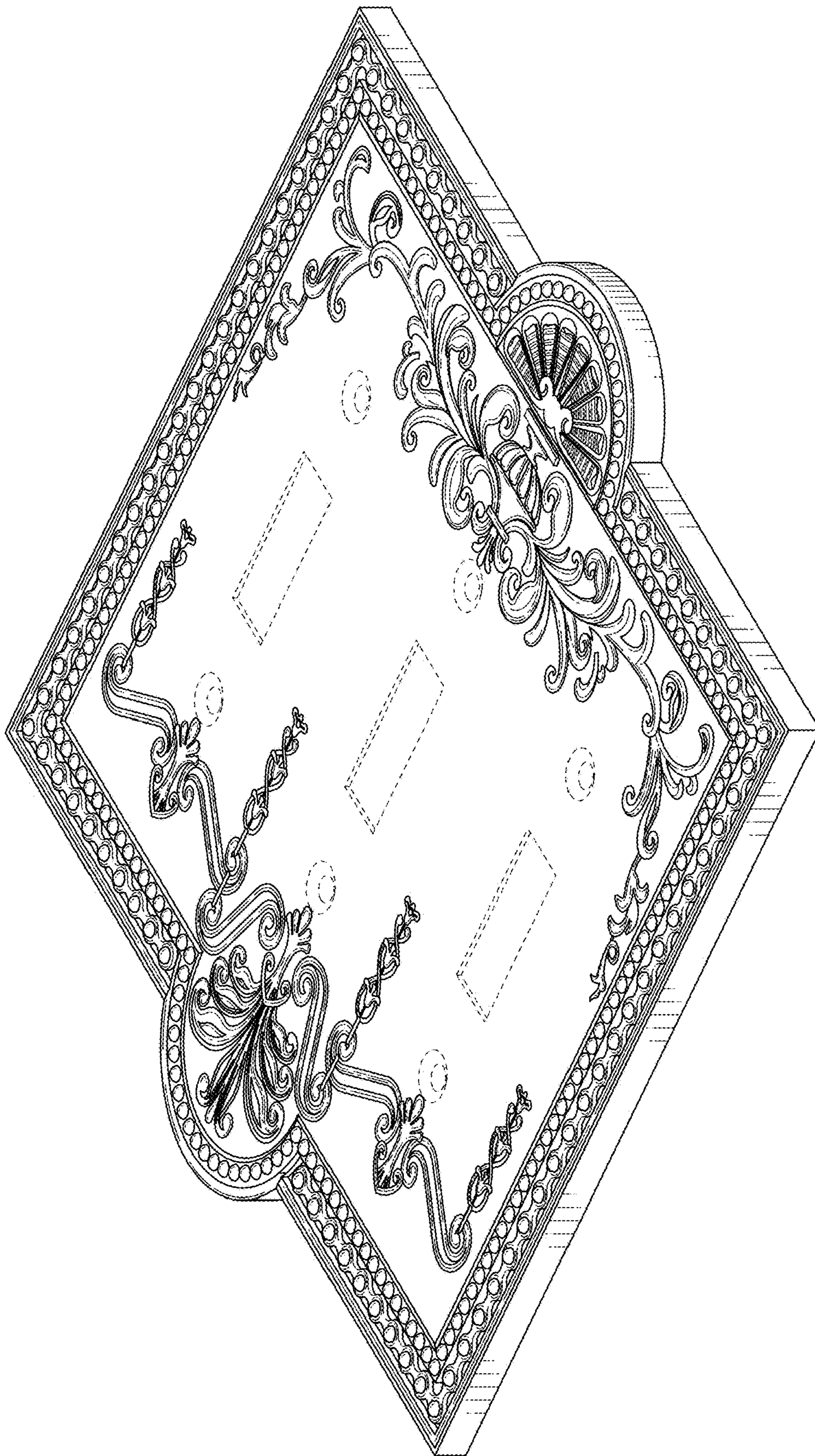

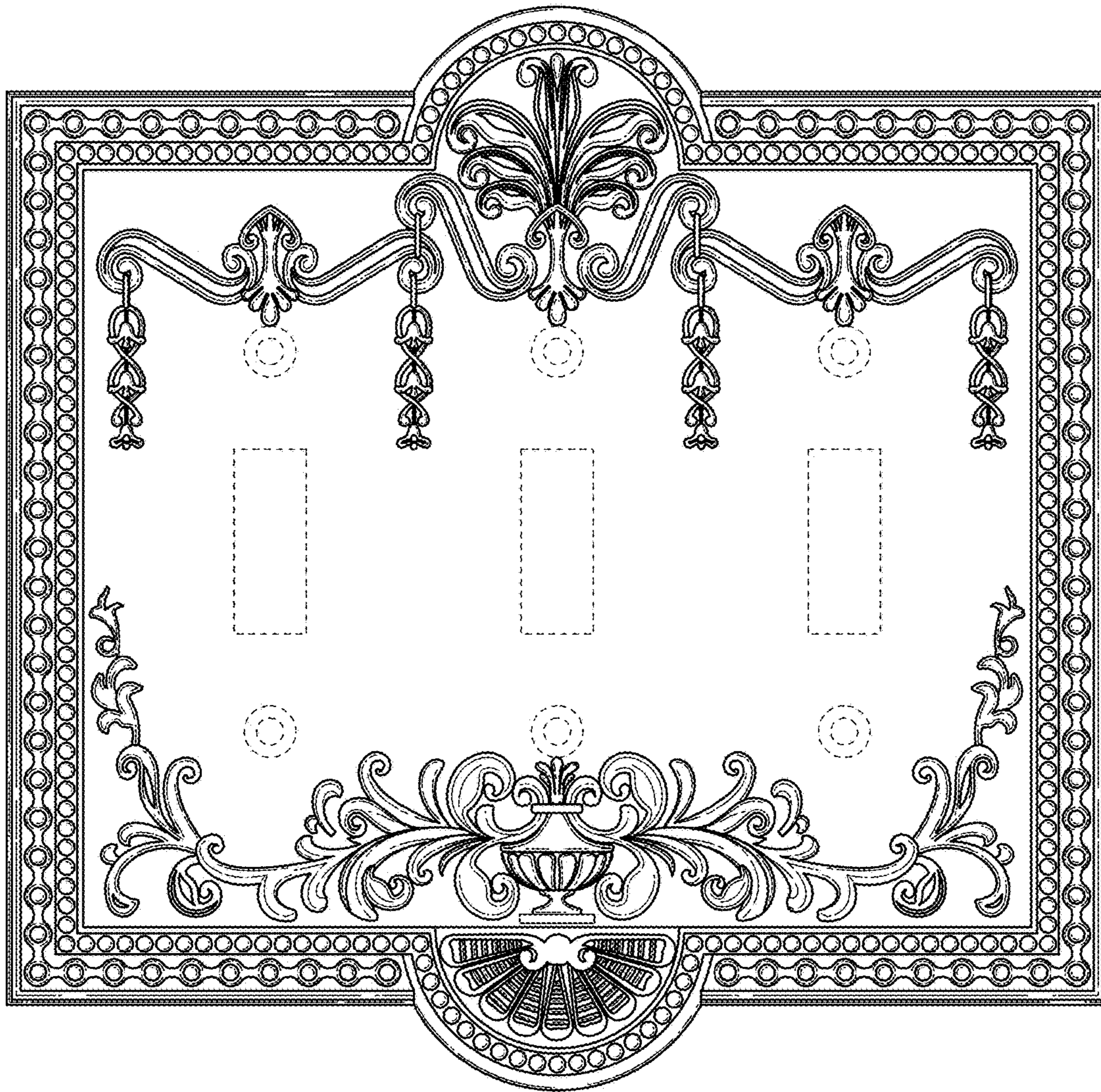

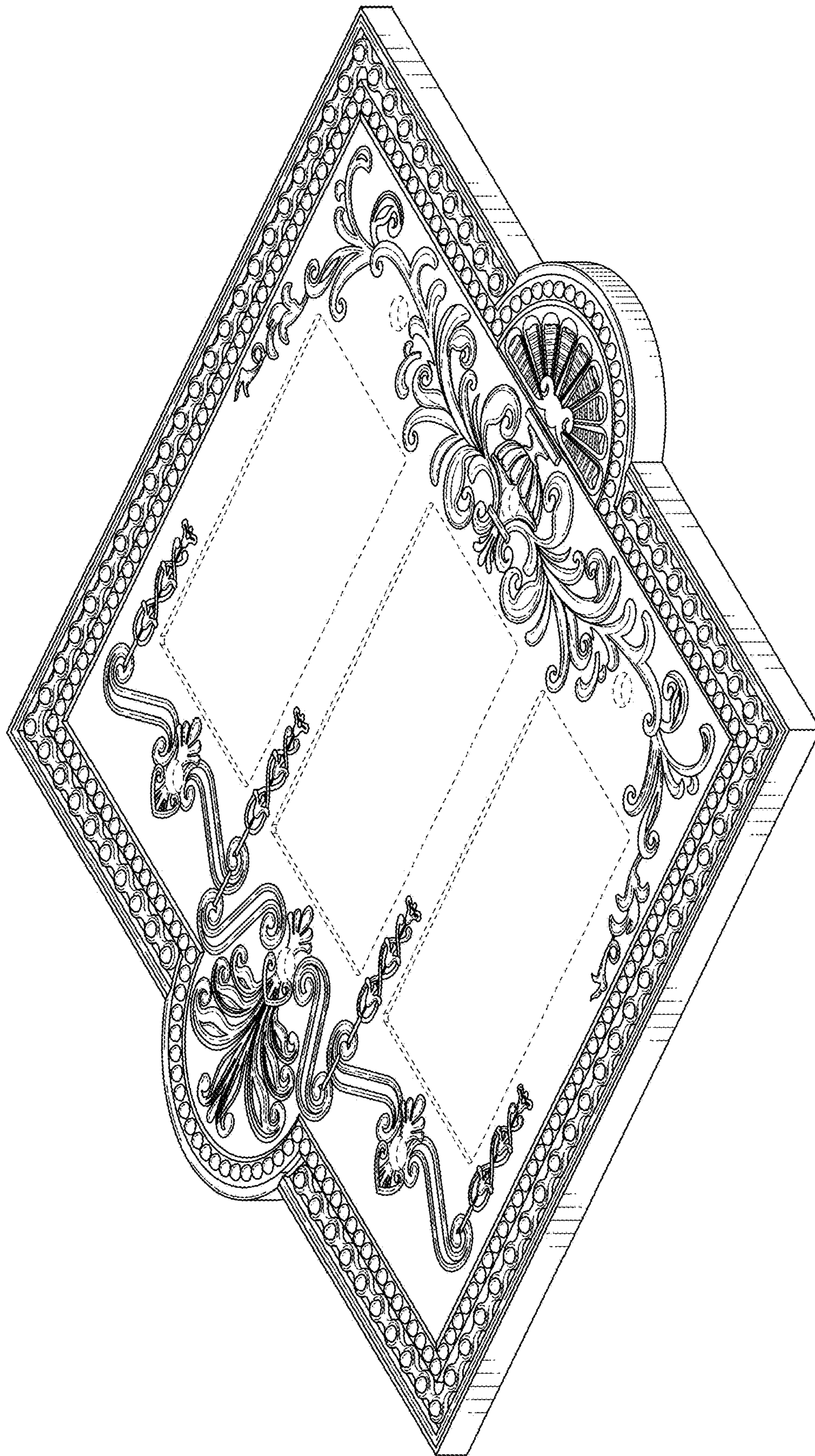

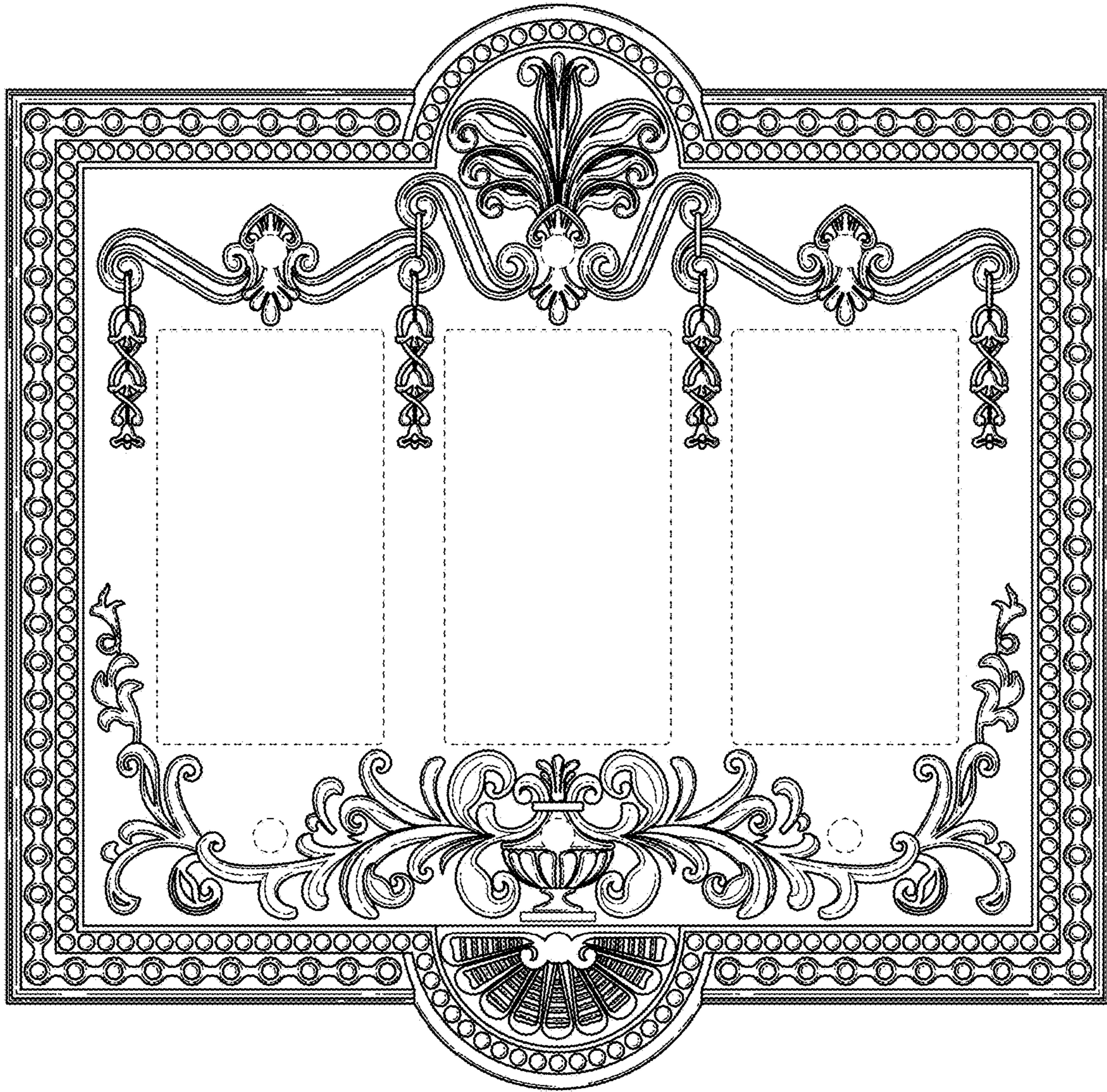
