(57) **CLAIM**

The ornamental design for a hanger for small articles, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hanger for small articles according to the invention;  
 FIG. 2 is a front elevation view of the hanger for small articles of FIG. 1;  
 FIG. 3 is a rear elevation view of the hanger for small articles of FIG. 1;  
 FIG. 4 is a top plan view of the hanger for small articles of FIG. 1;  
 FIG. 5 is a bottom plan view of the hanger for small articles of FIG. 1; and,  
 FIG. 6 is a right side elevation view of the hanger for small articles of FIG. 1, the left side elevation view being a mirror image thereof.

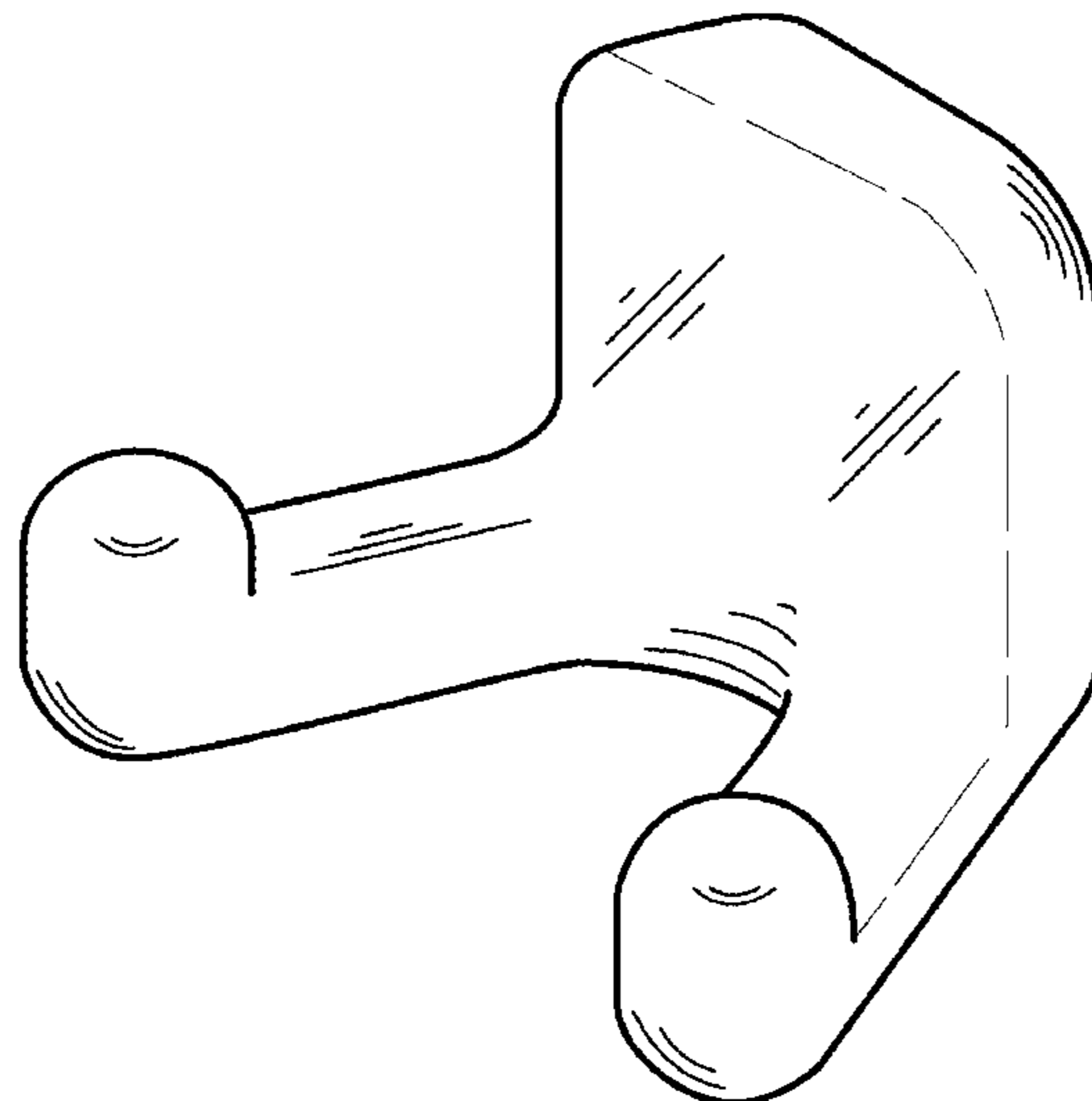

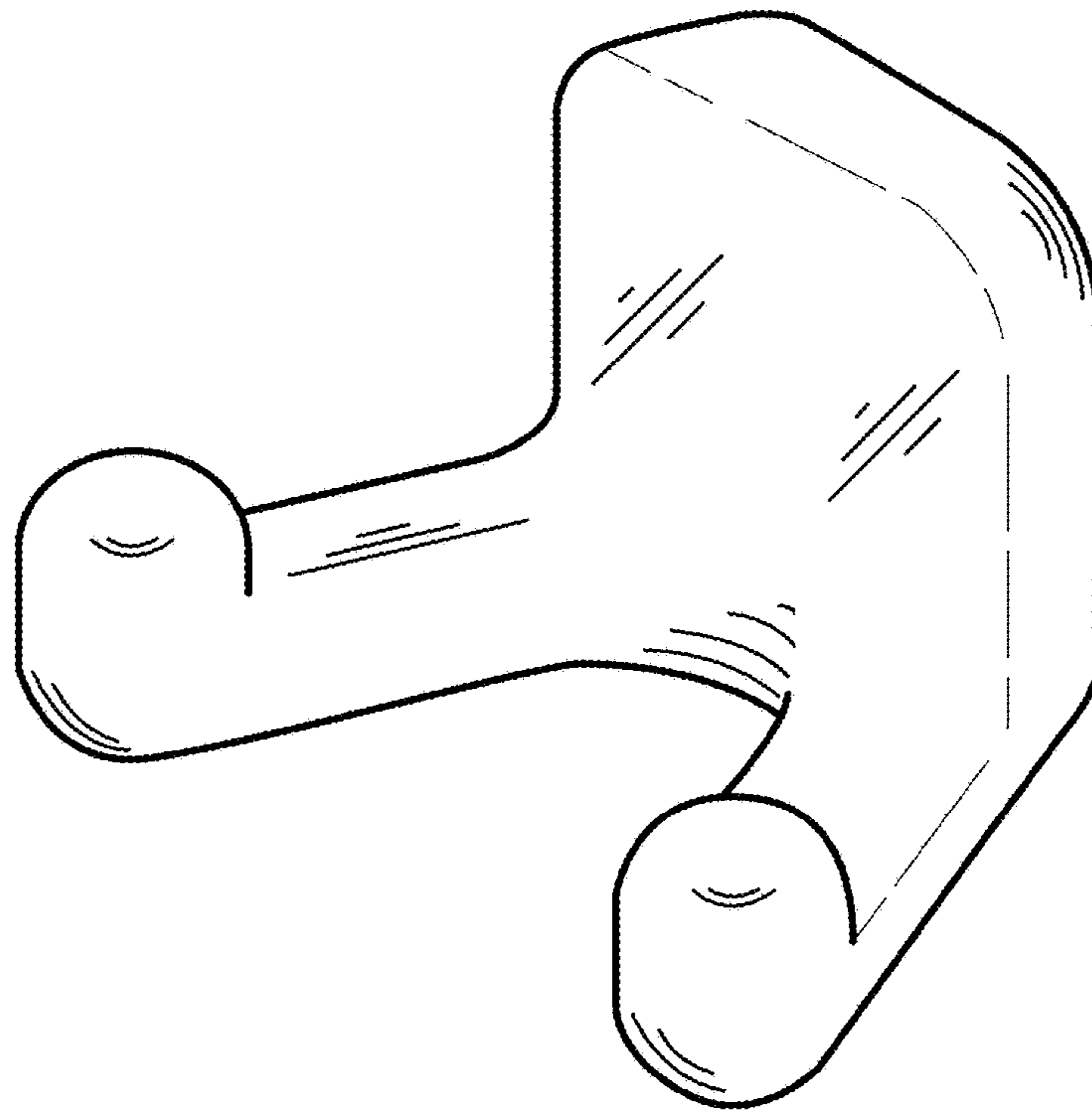

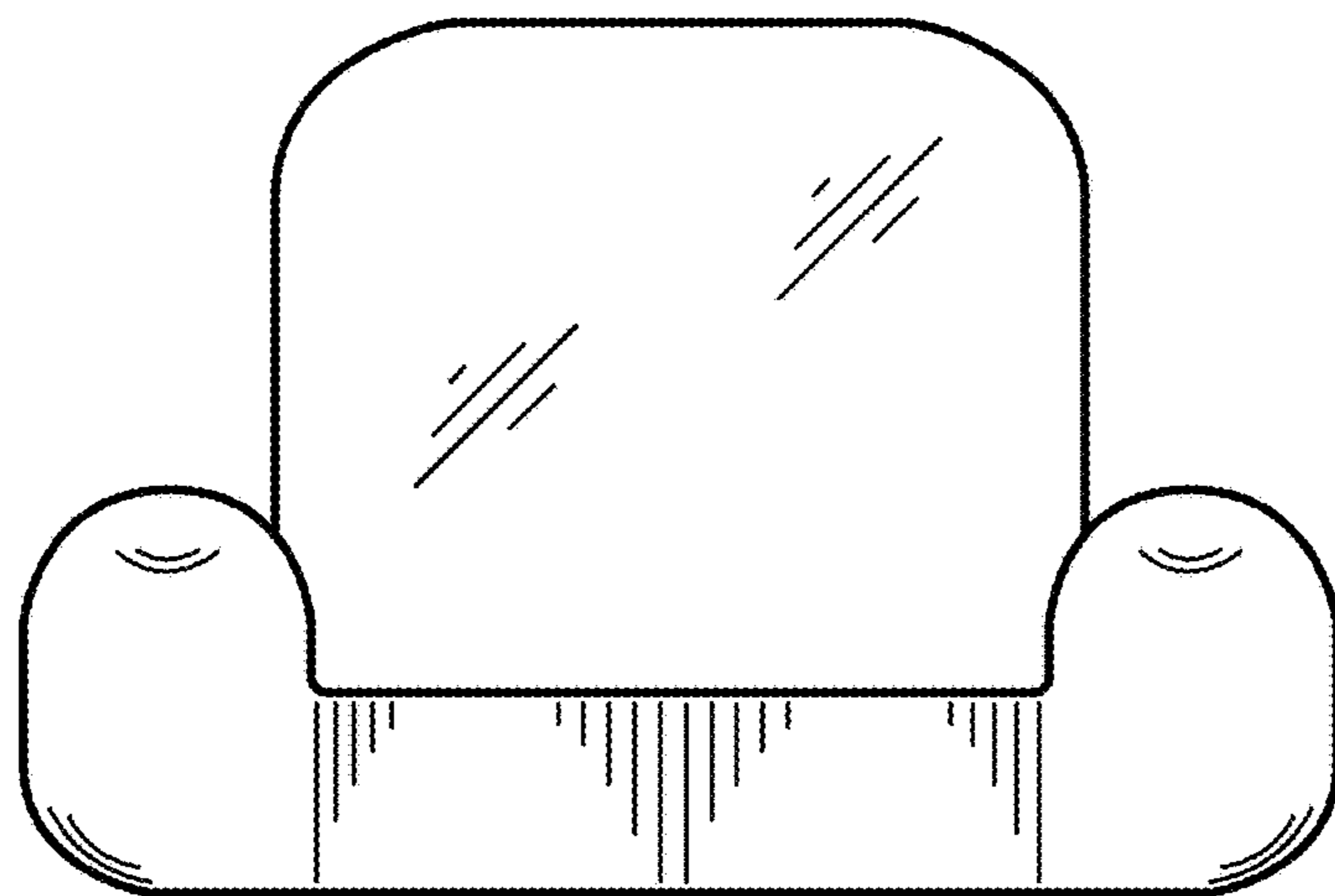

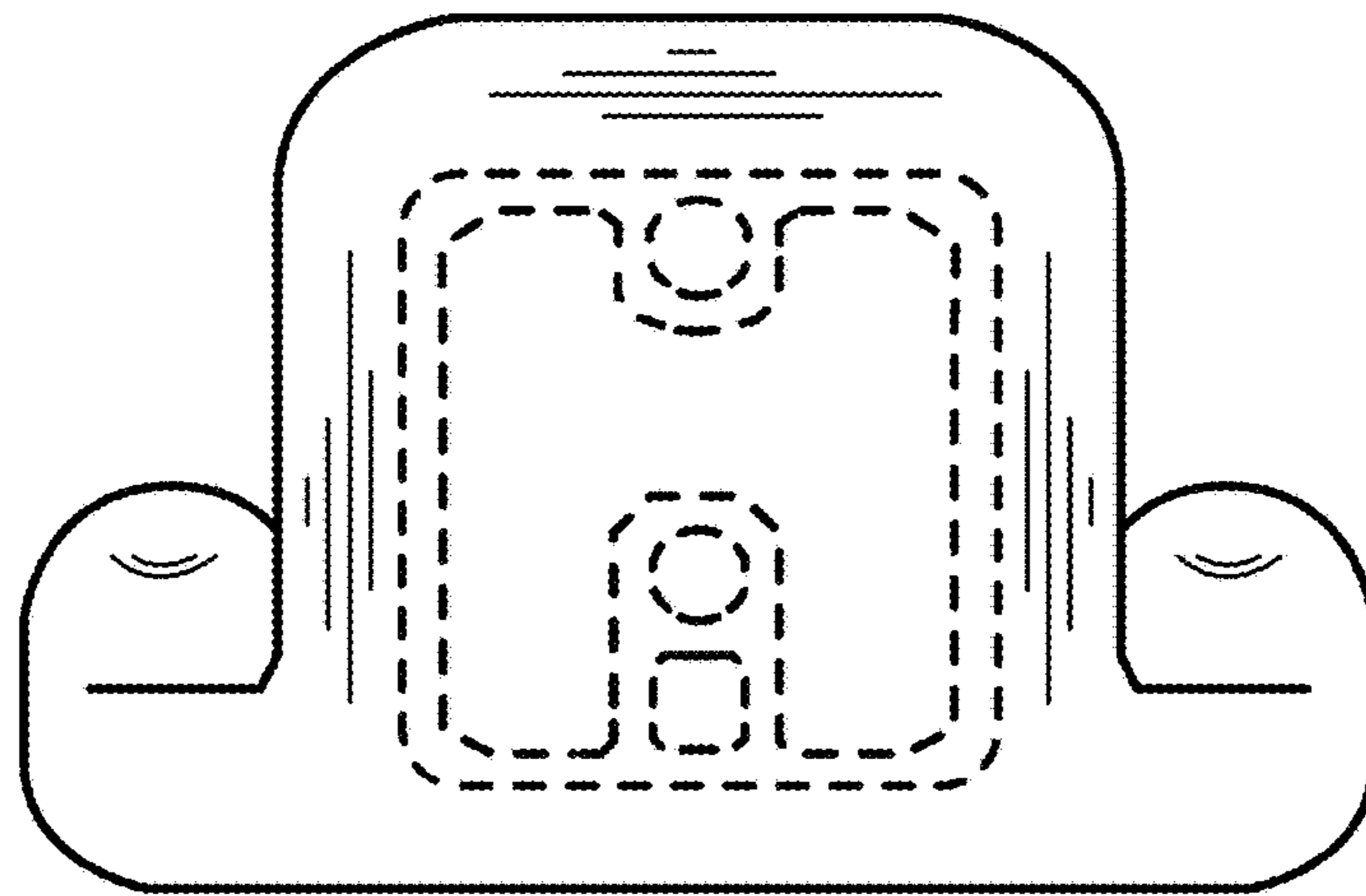

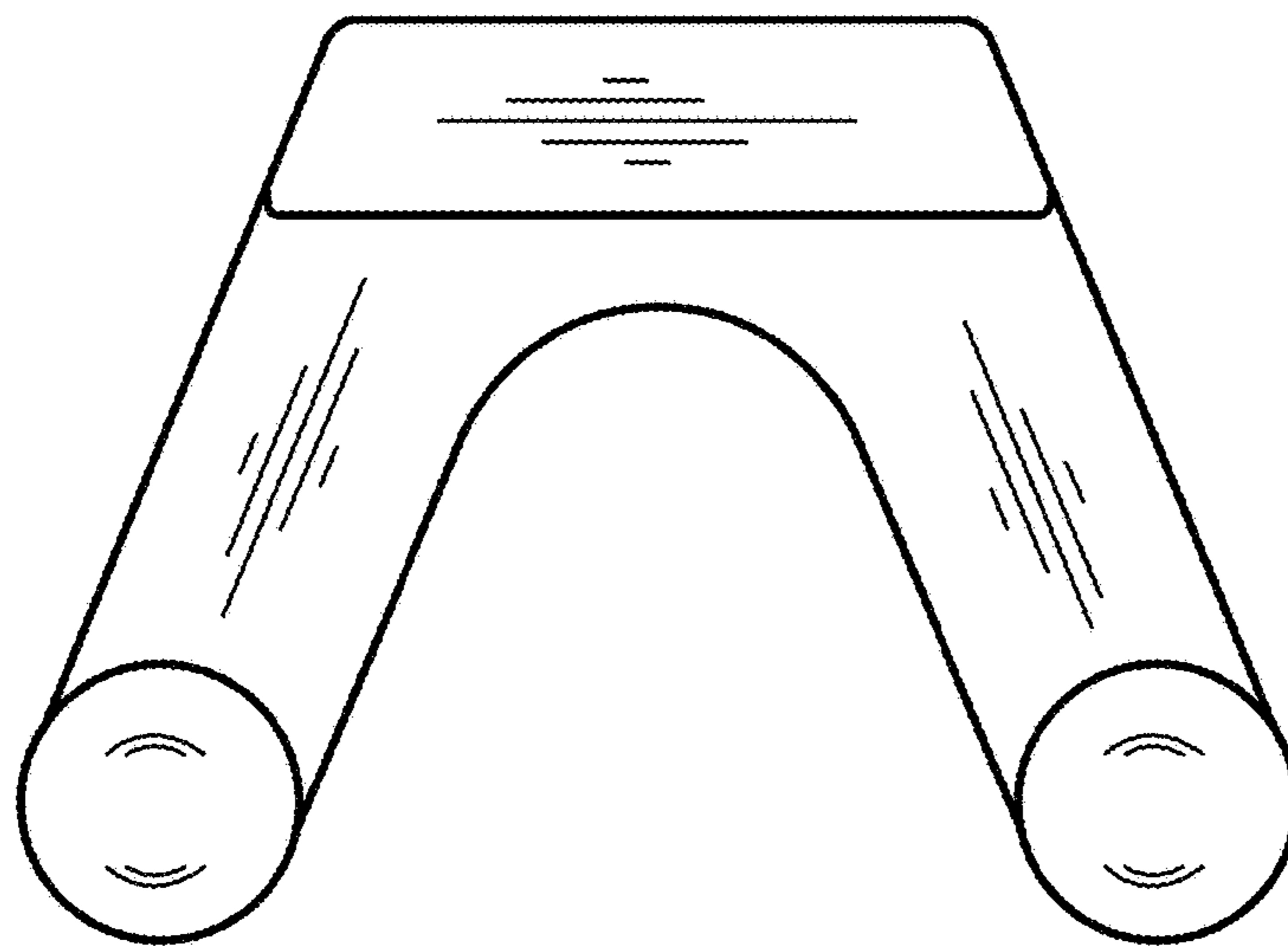

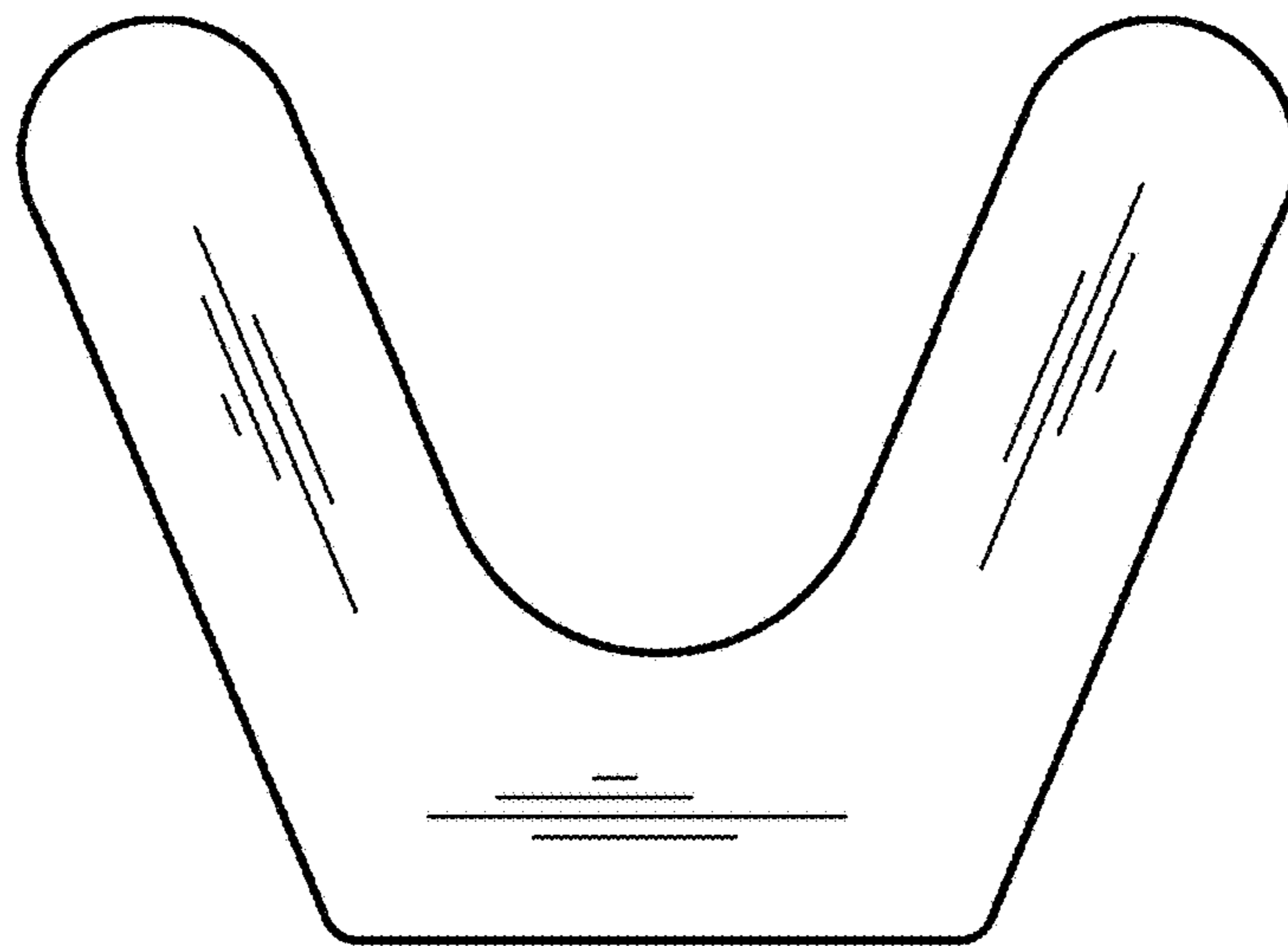
