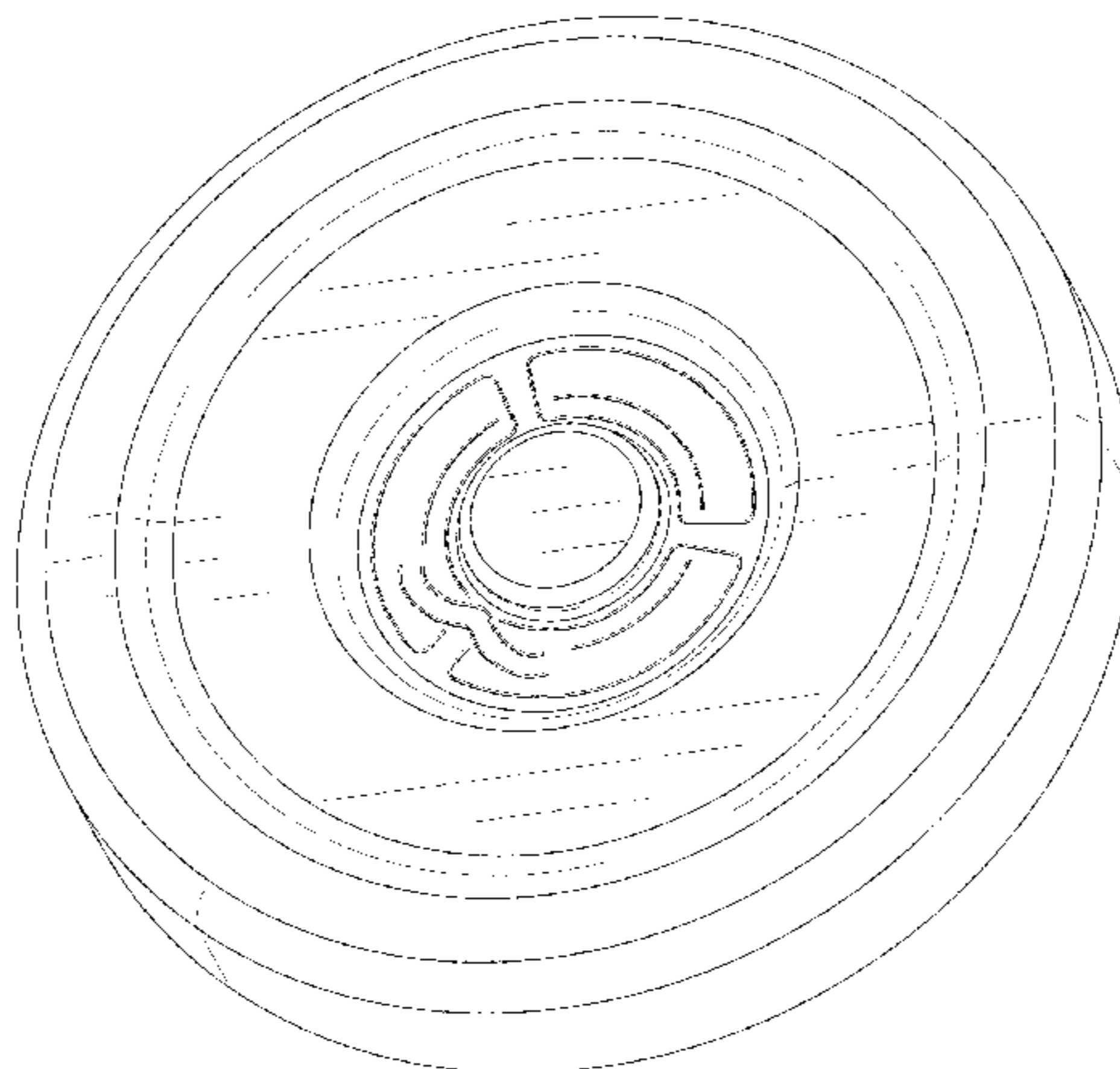


FIG. 8 is a section view of the push button closure taken in the direction of line 8-8 shown in FIG. 5.

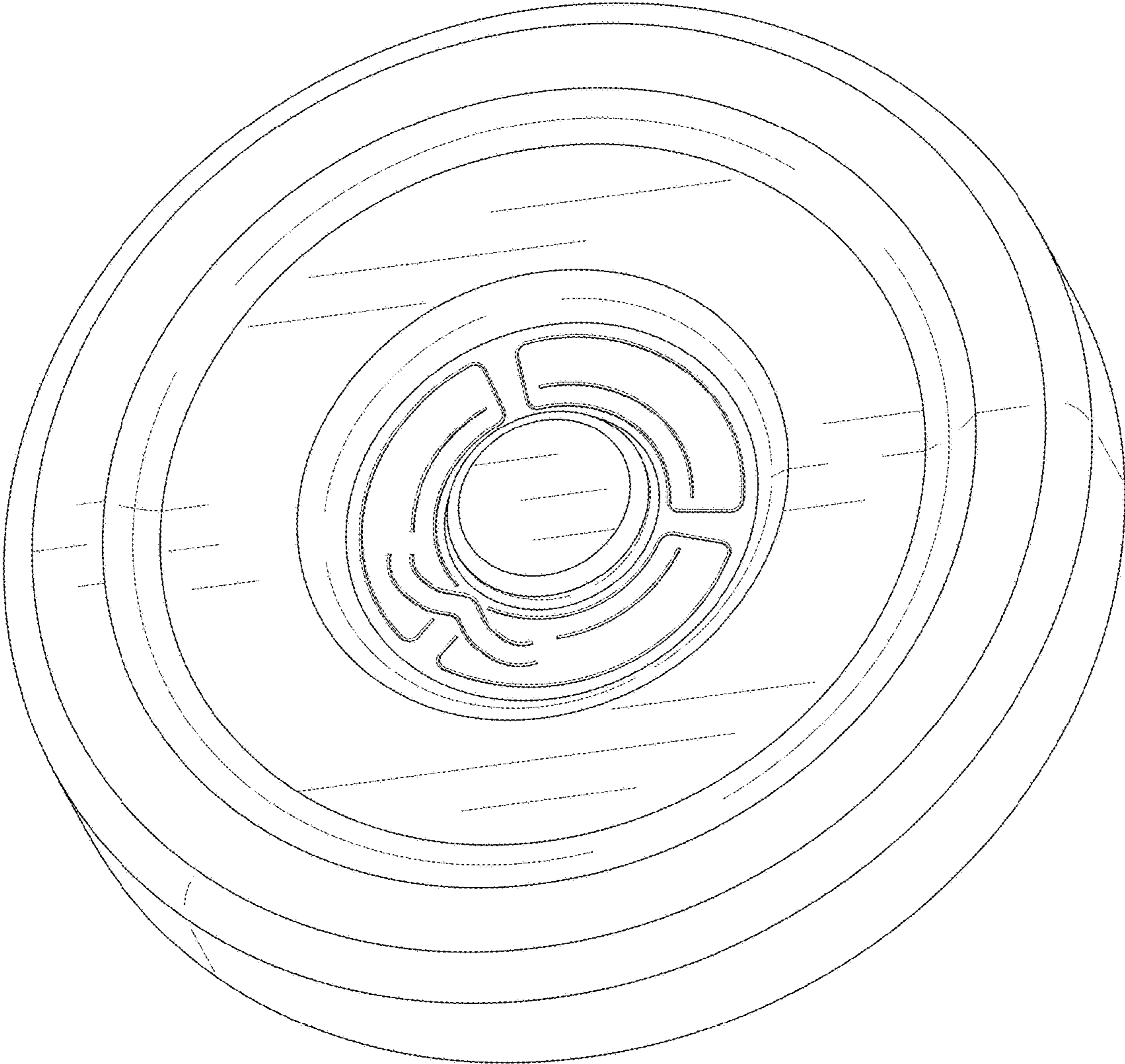

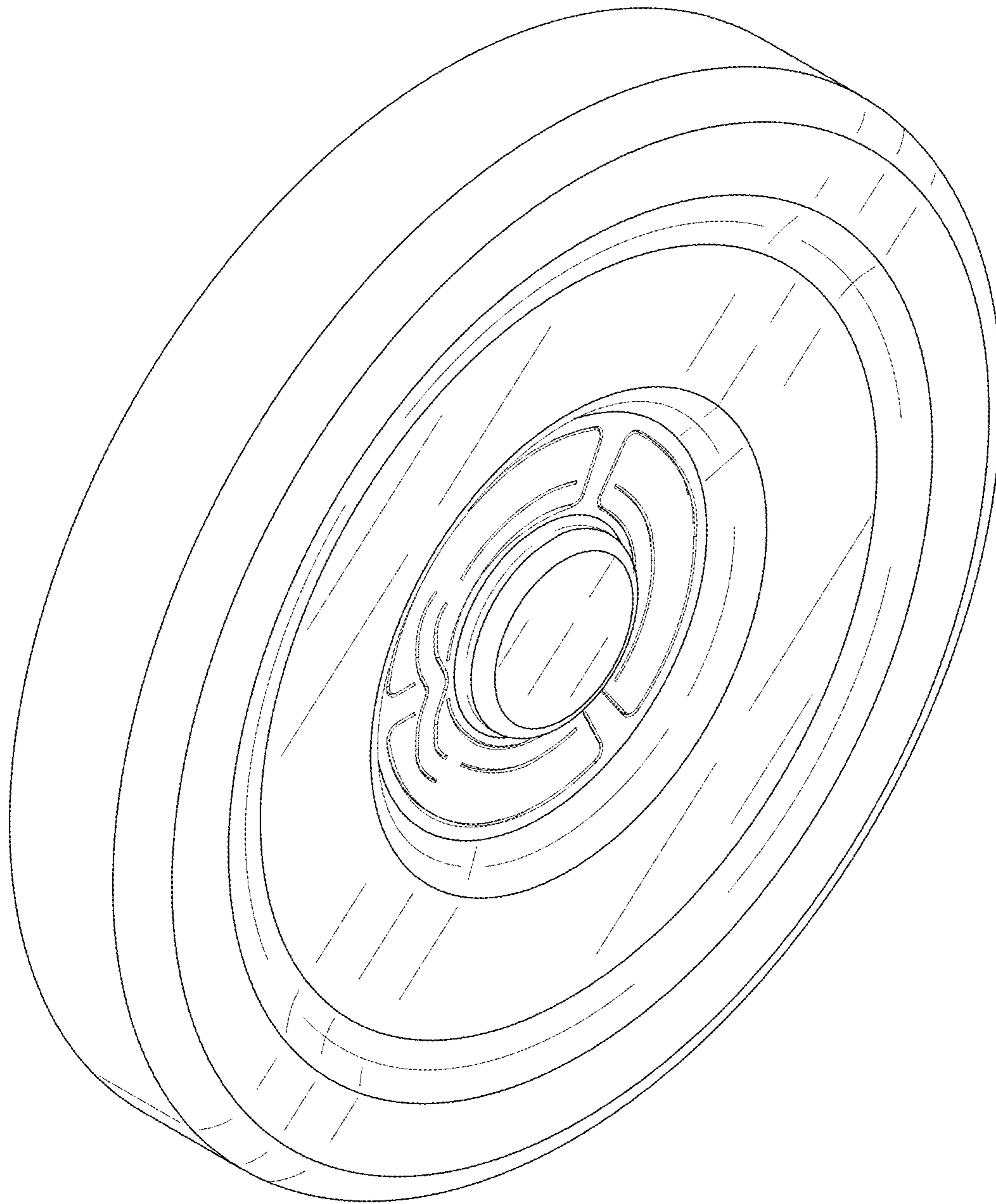

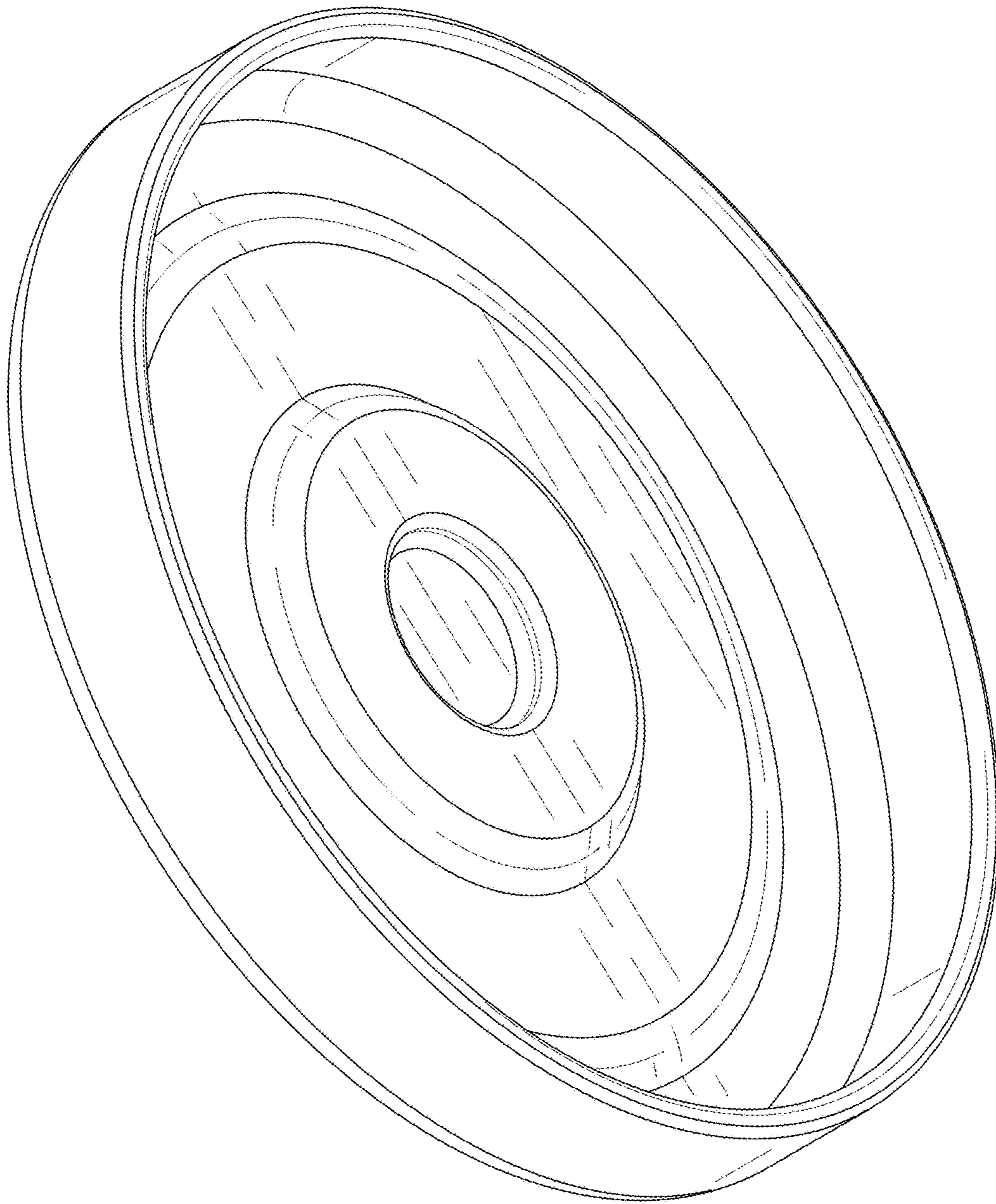

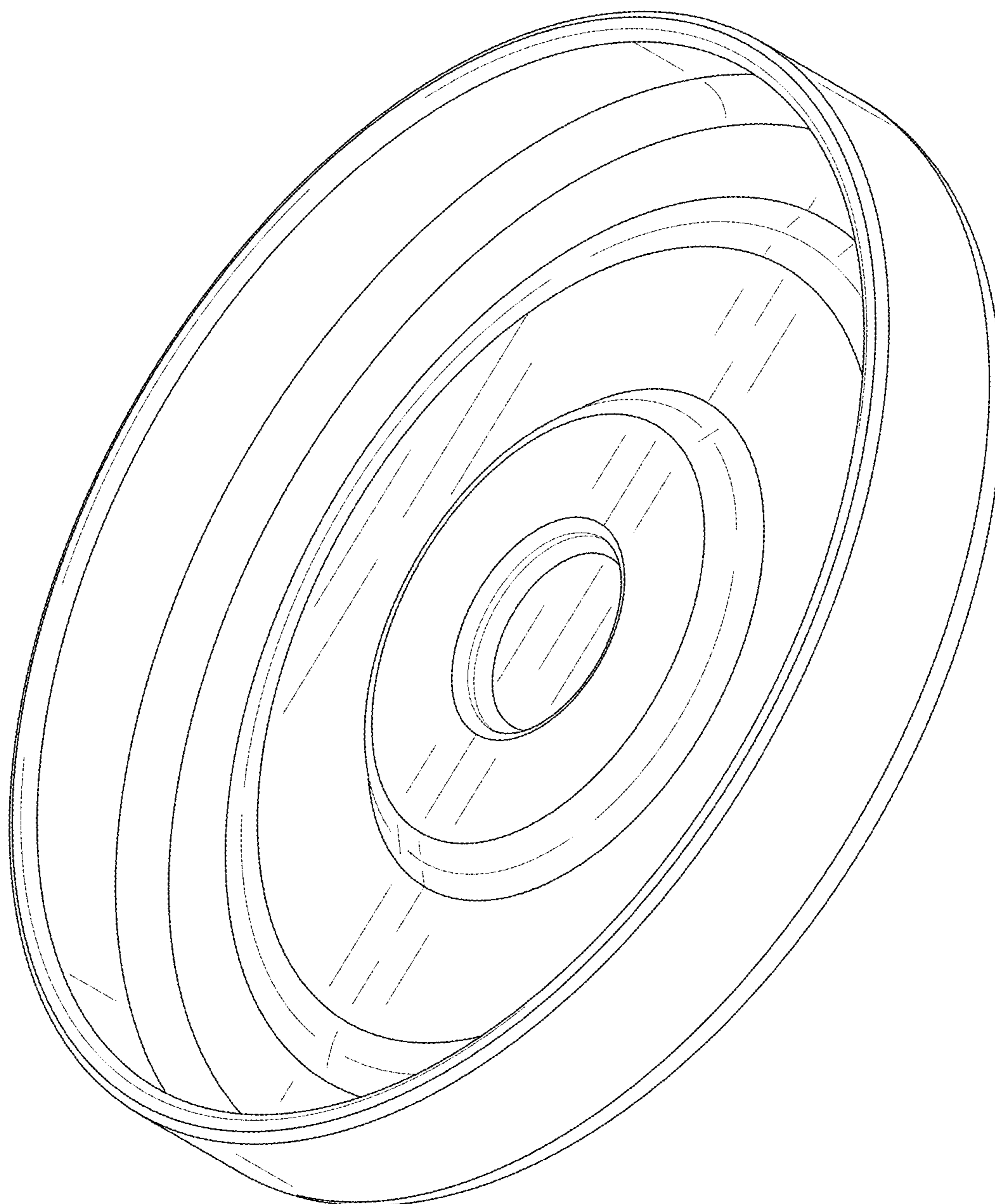

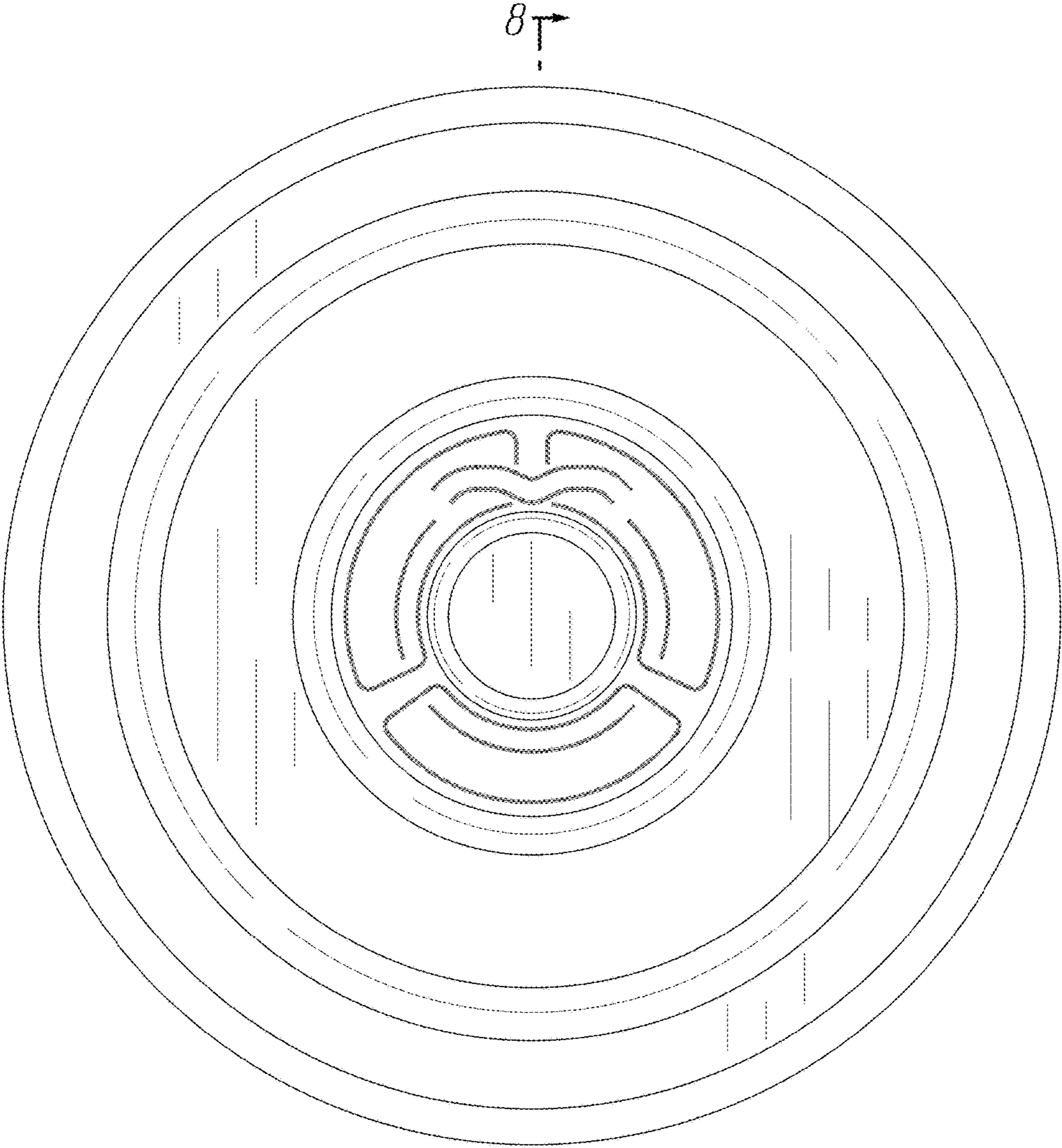

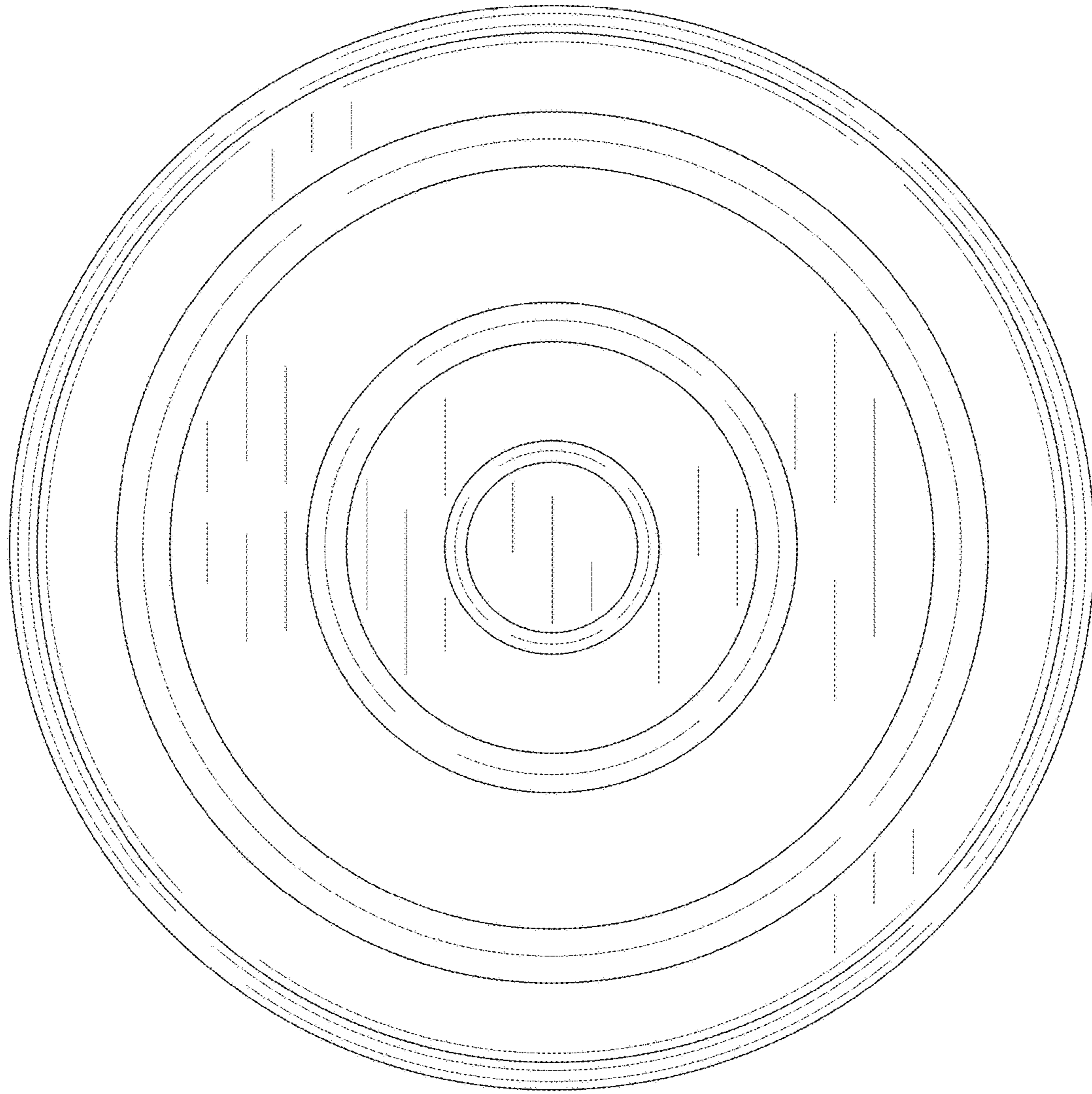

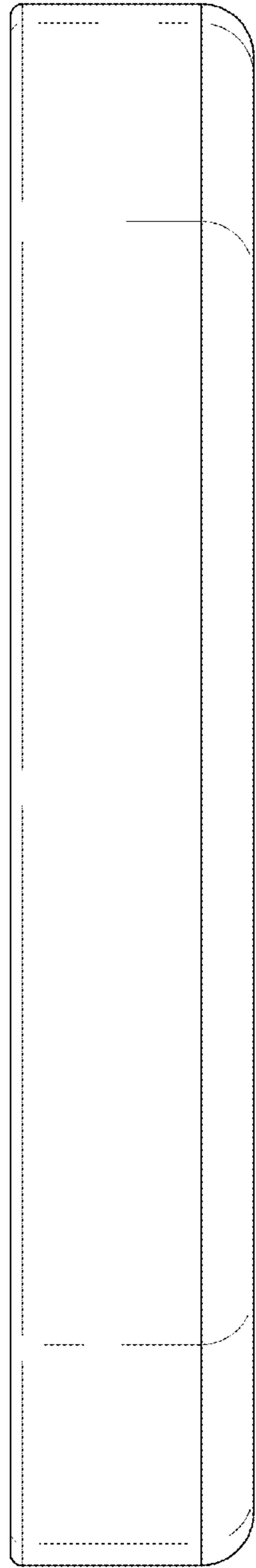

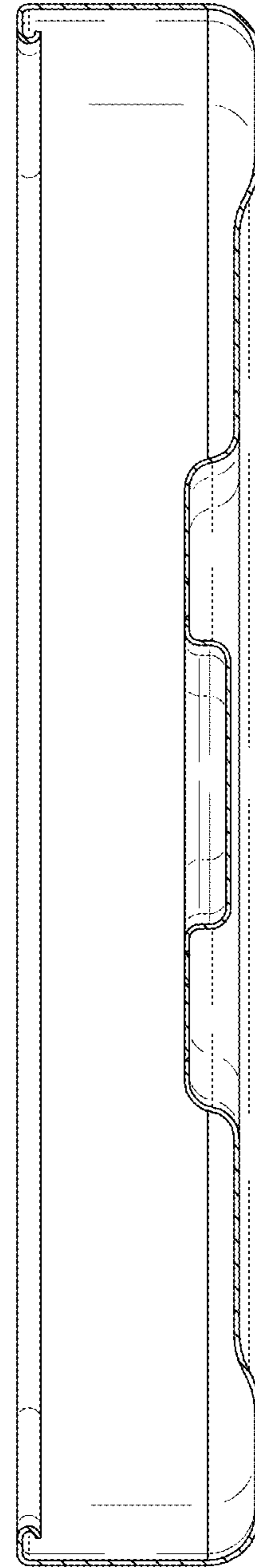
