(57) **CLAIM**

The ornamental design for a refrigerant pressure probe, as shown and described.

DESCRIPTION

FIG. 1 is a rear/top/left perspective view of a first embodiment of a refrigerant pressure probe, showing our new design;

FIG. 2 is a front/bottom/right perspective view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a left side view thereof;

FIG. 7 is a rear elevation view thereof;

FIG. 8 is a front elevation view thereof;

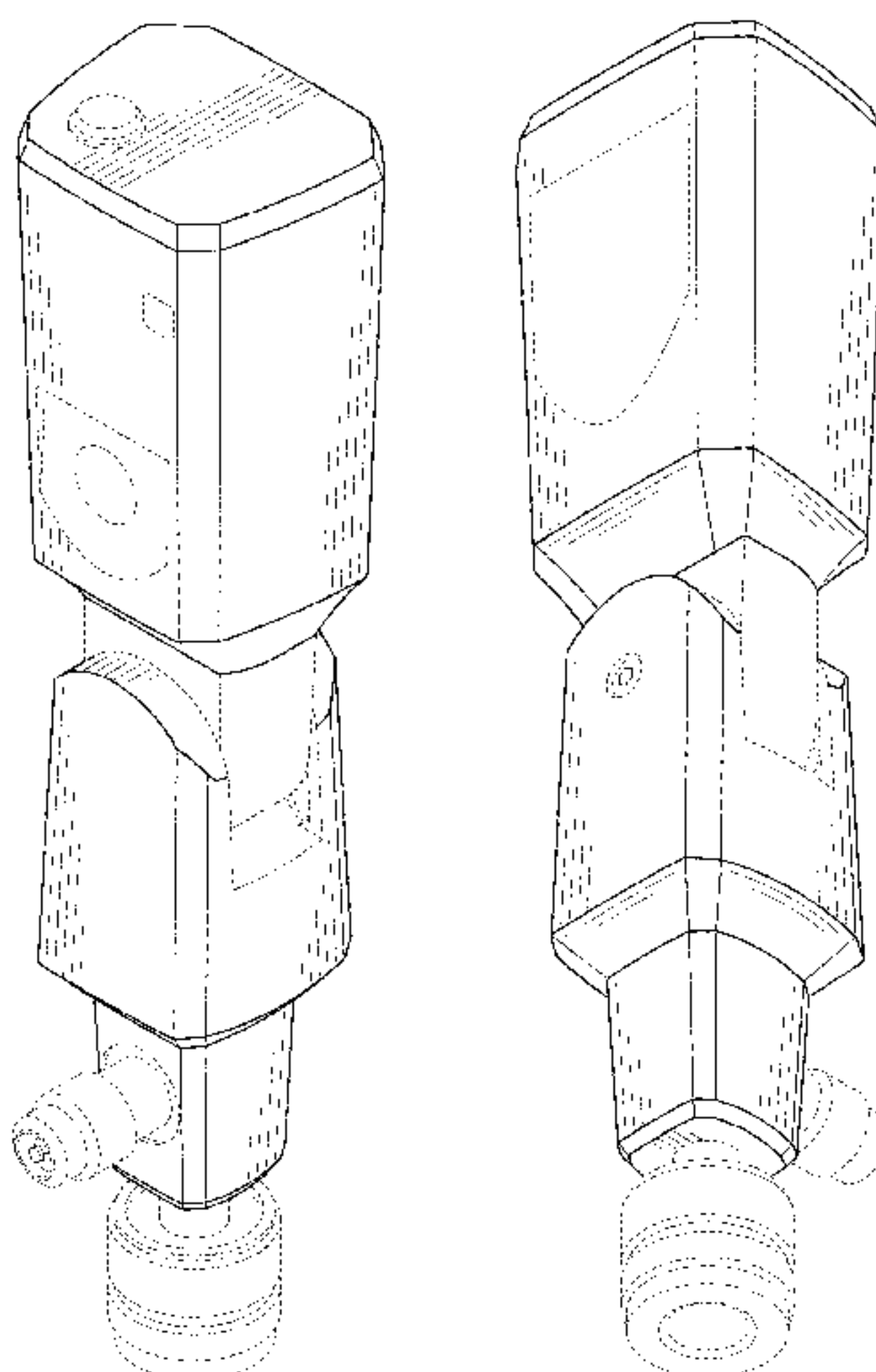
FIG. 9 is a top/left perspective view of the refrigerant pressure probe in an optional folded configuration;

FIG. 10 is a rear/top/left perspective view of a second embodiment of a refrigerant pressure probe, wherein the stippled areas represent a contrasted color, the contrasted color being non-black but otherwise not representing a specific color or color combination; and,

FIG. 11 is a front/bottom/right perspective view thereof.

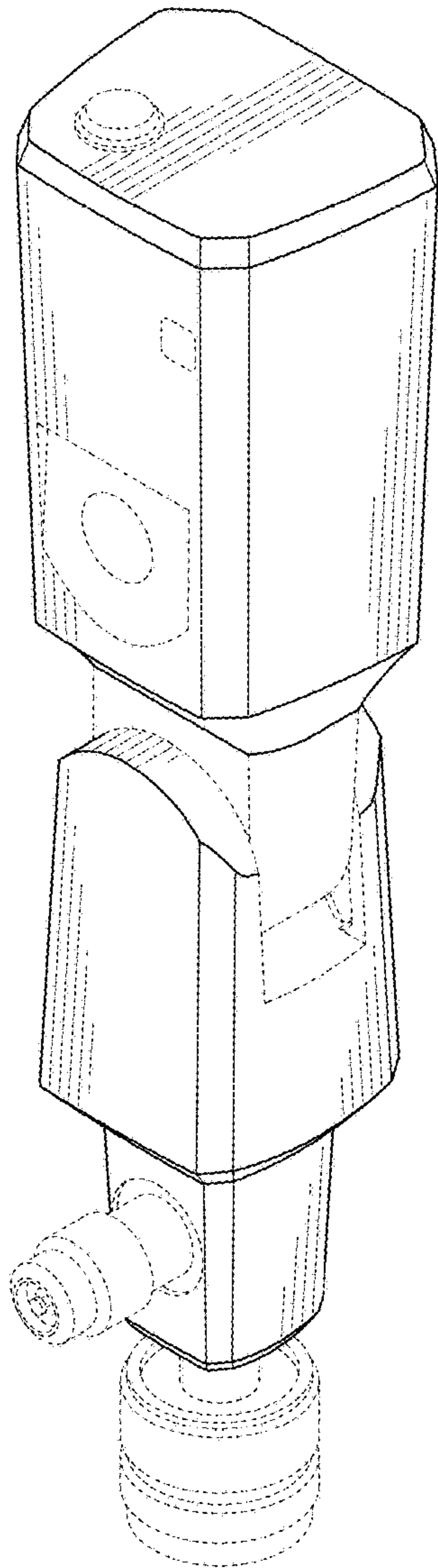

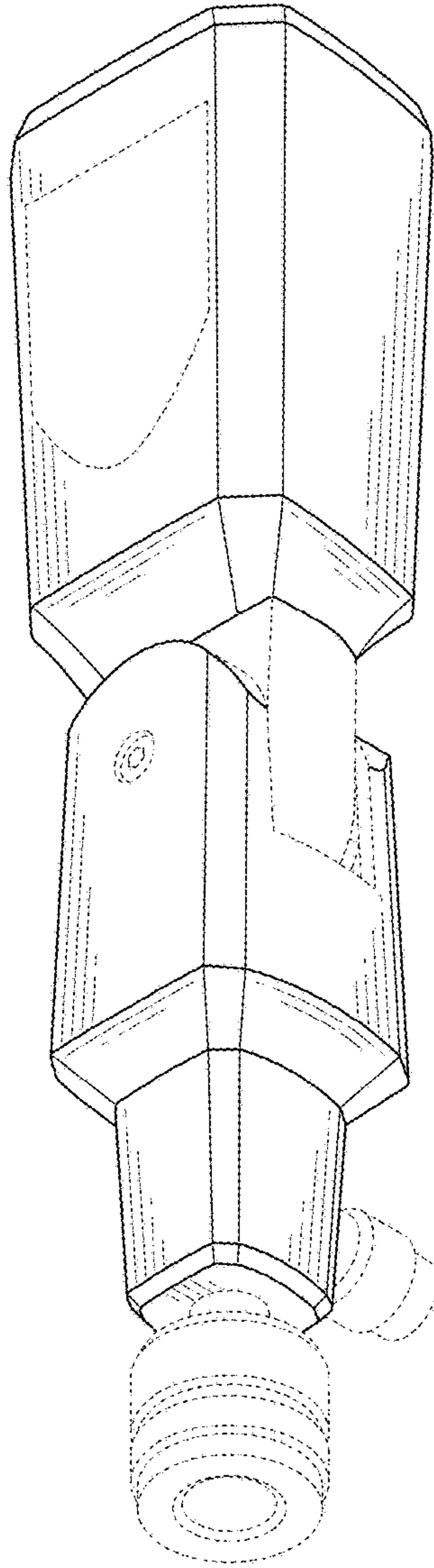

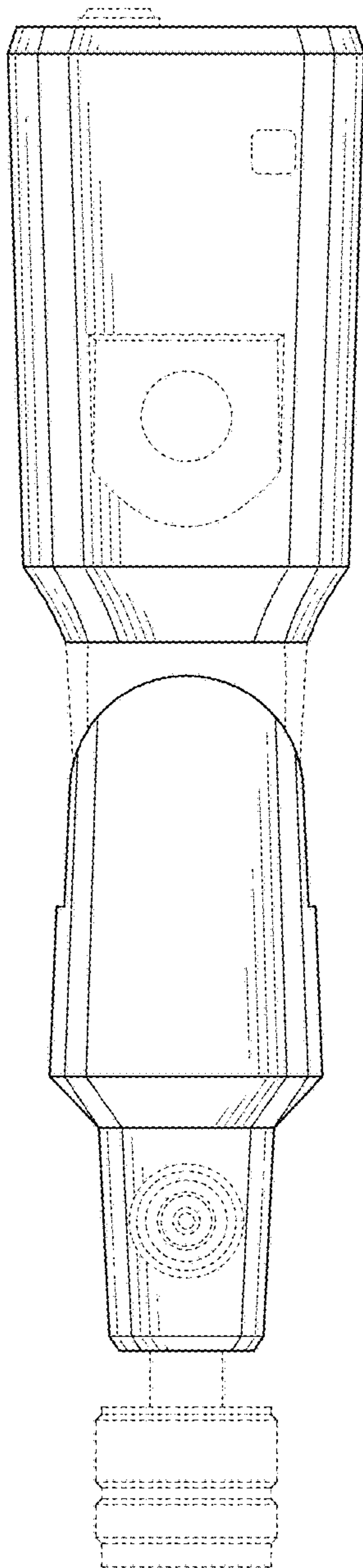

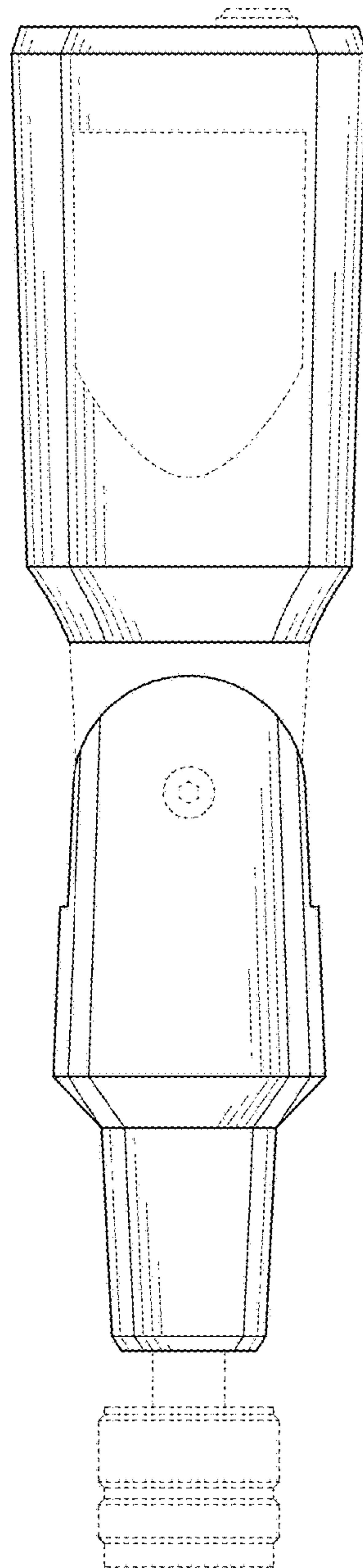

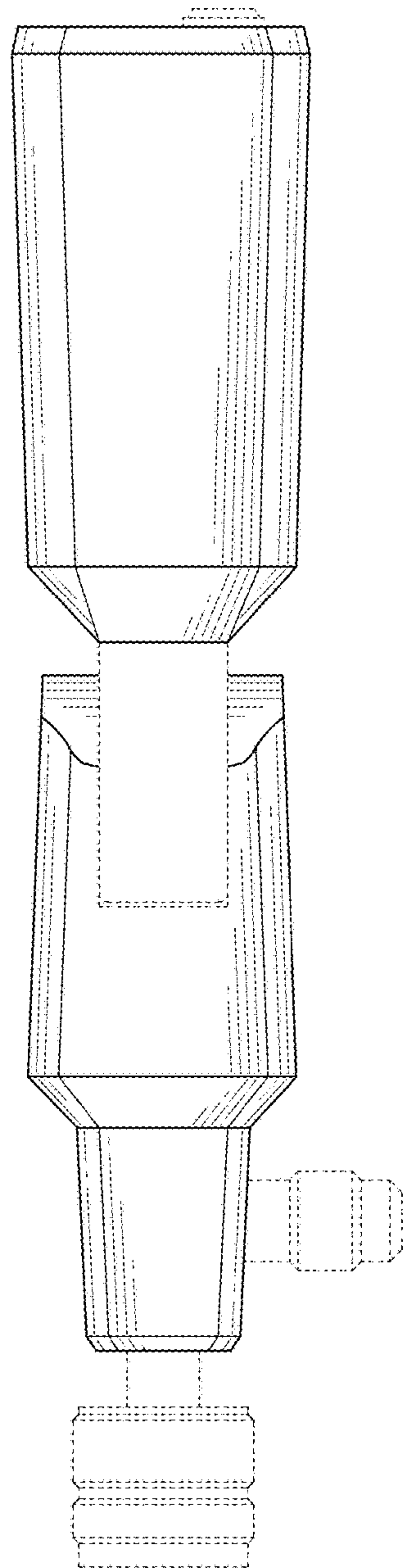

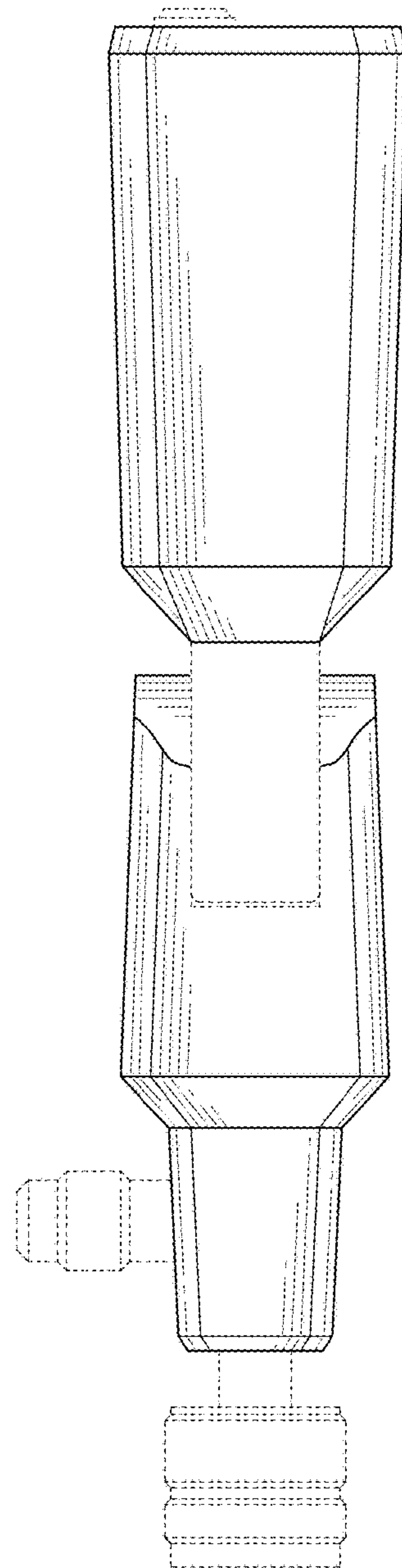

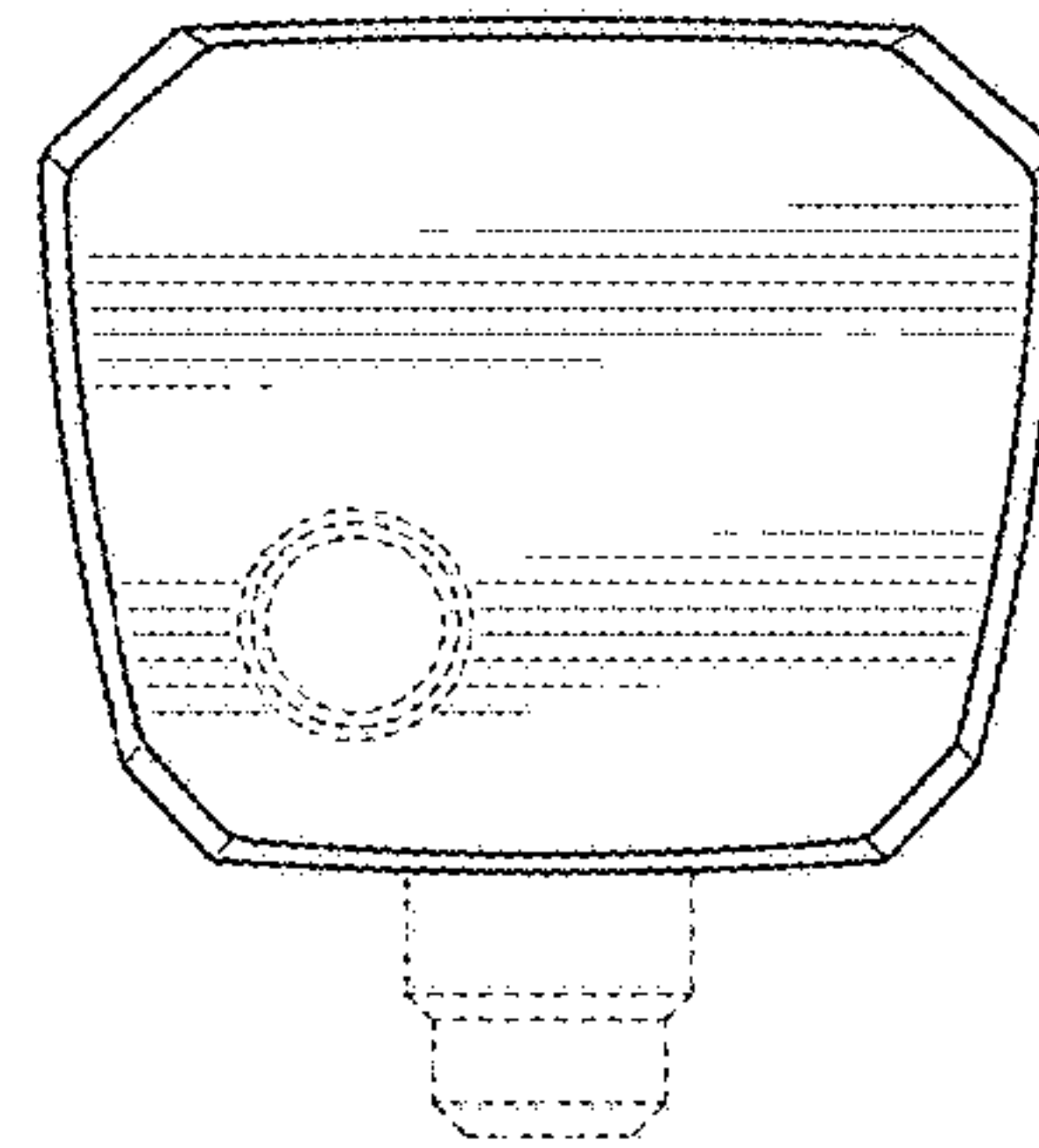

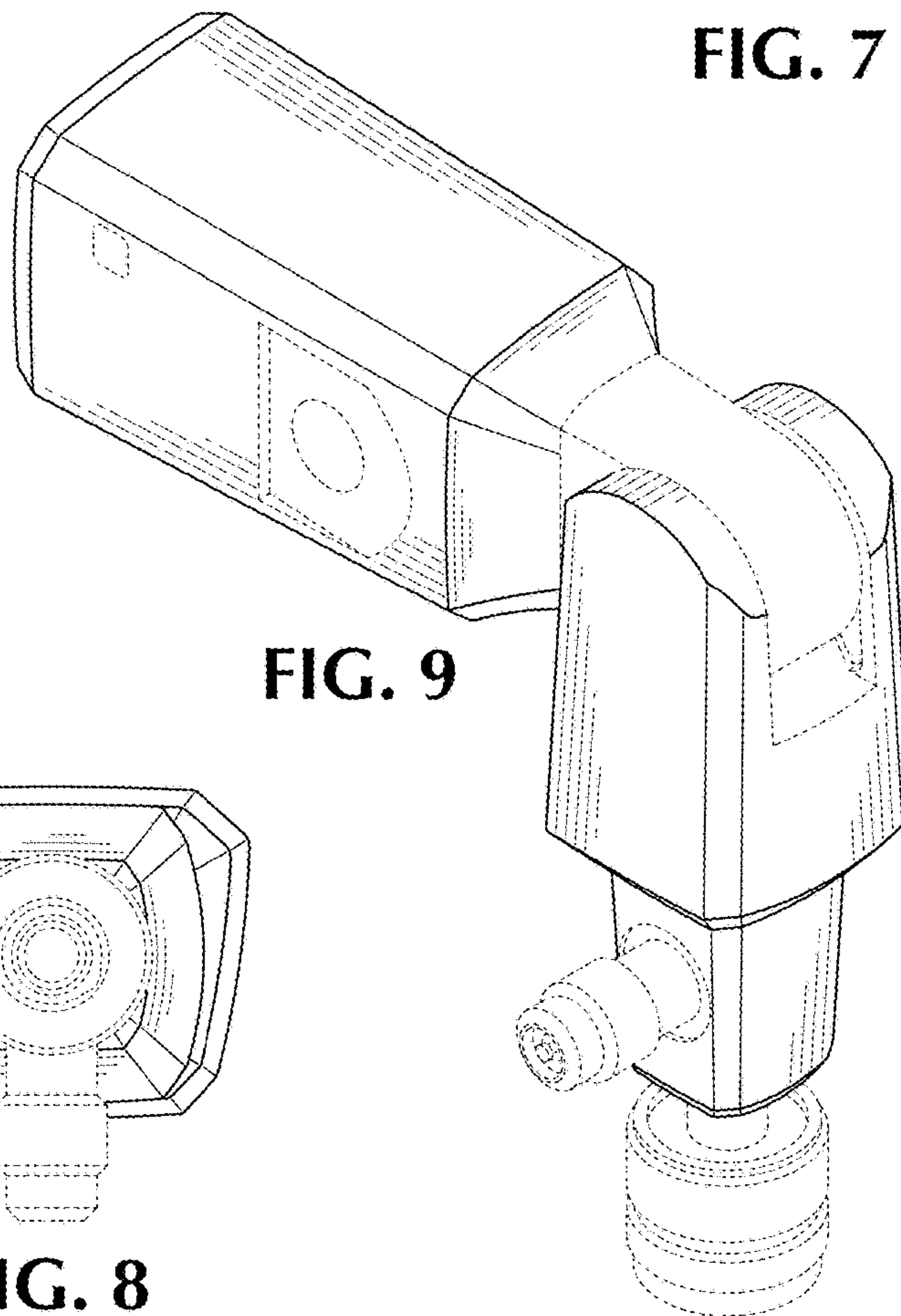

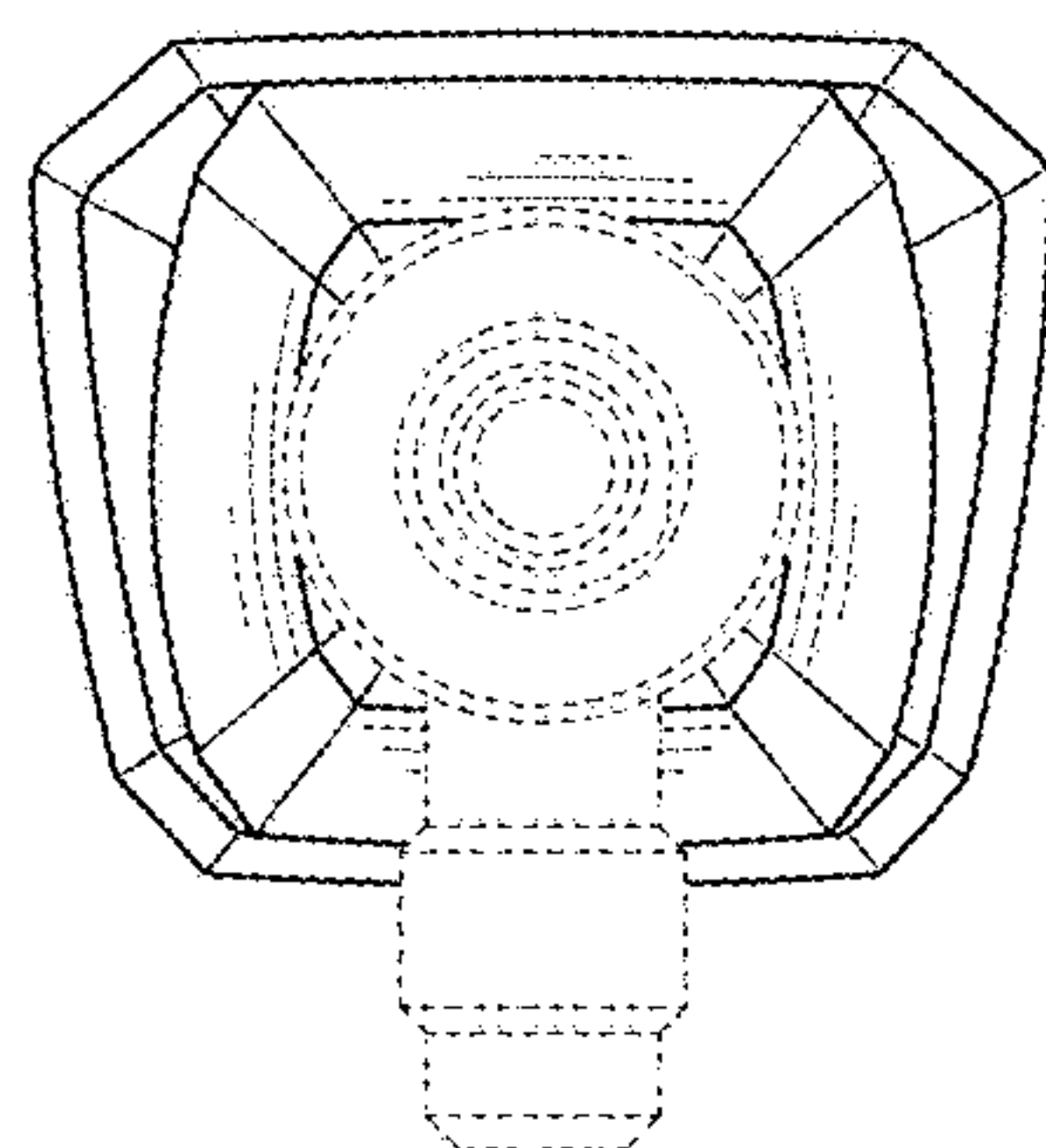

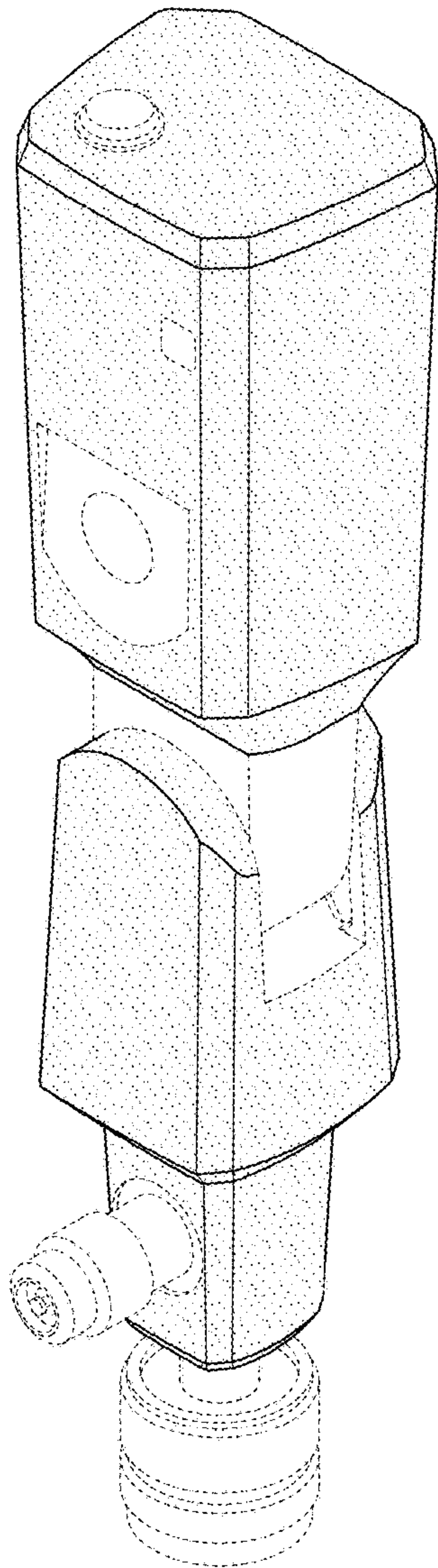

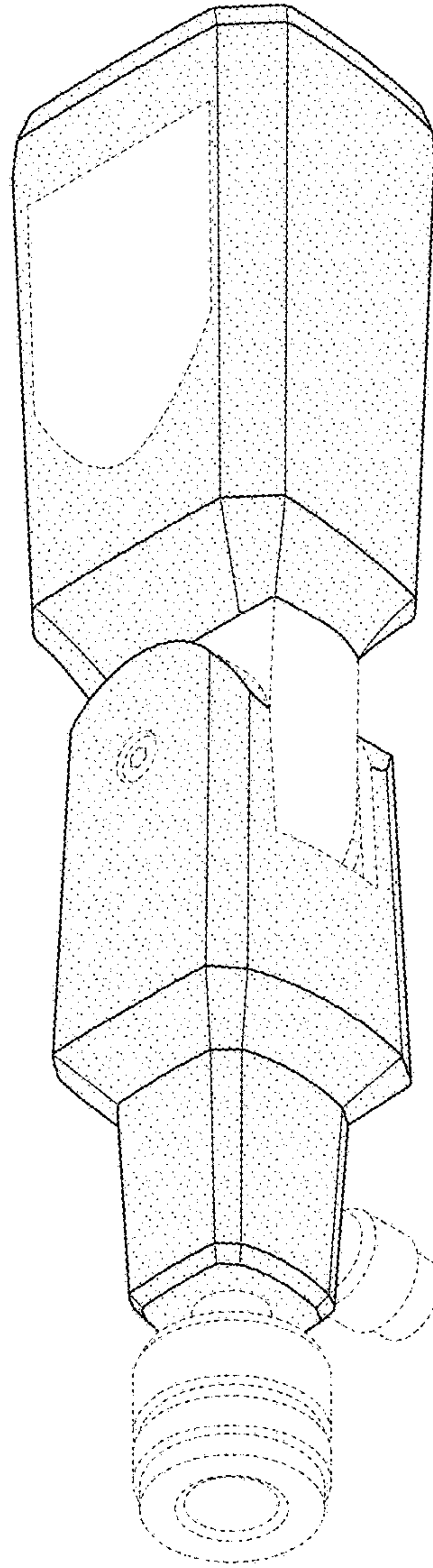
