DESCRIPTION

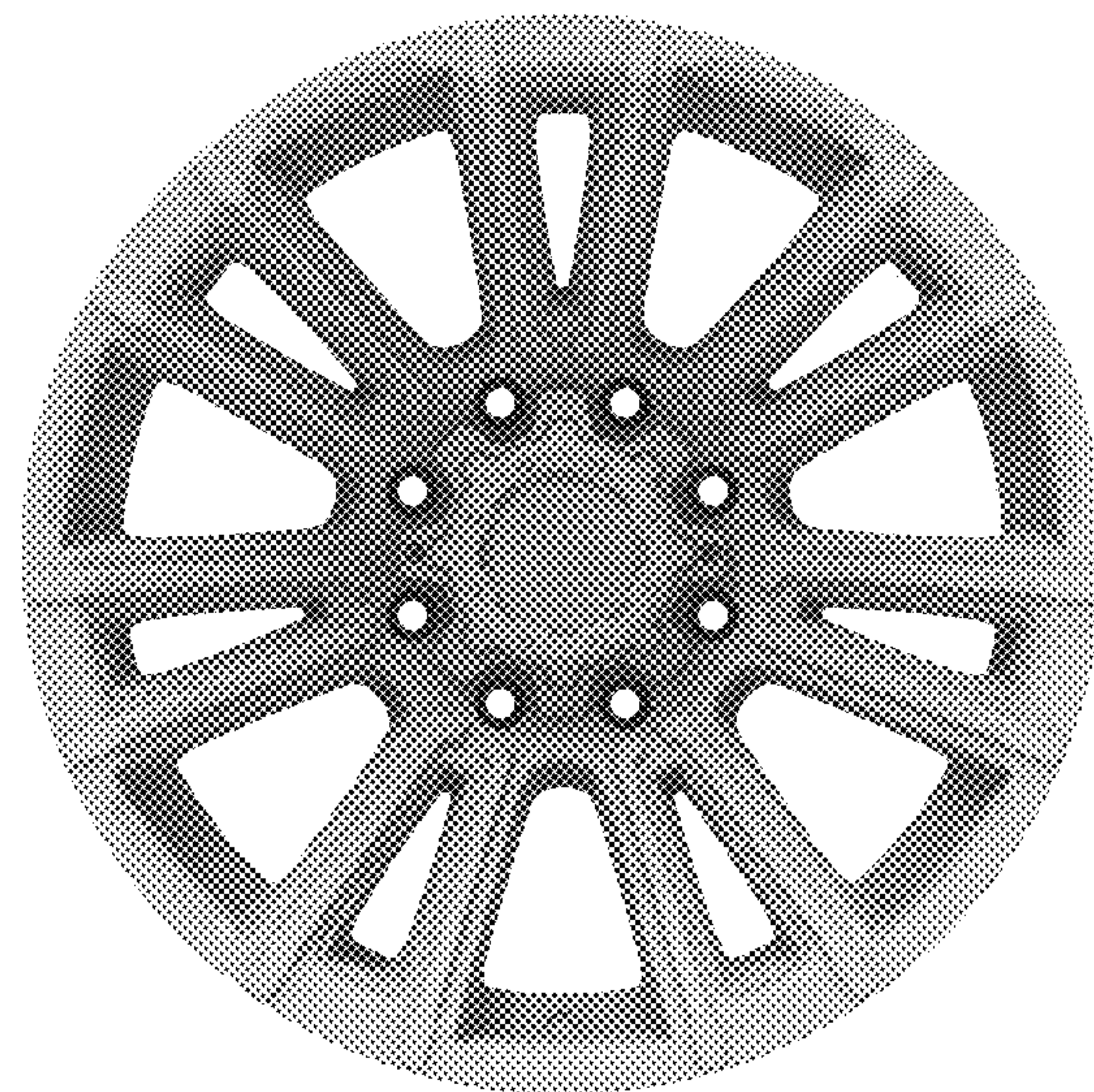
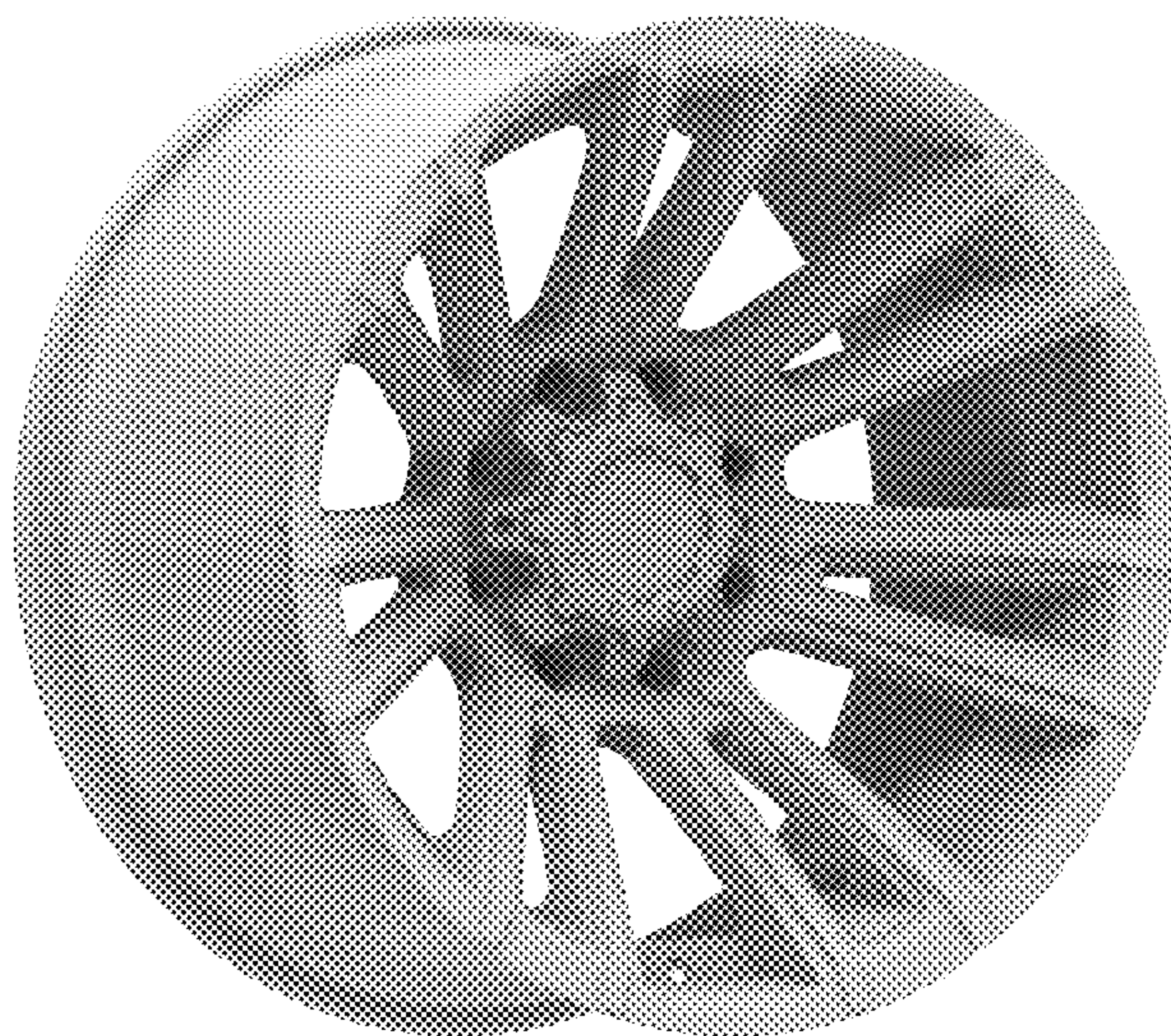
