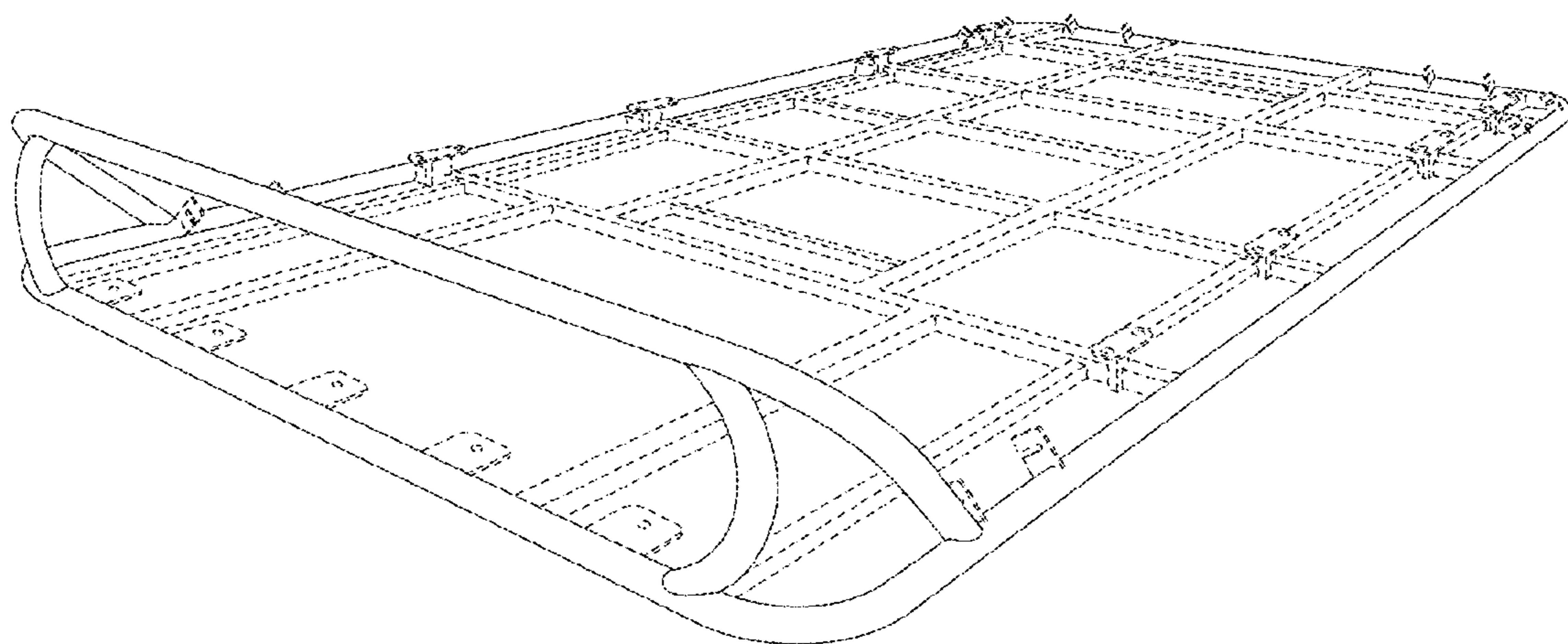
(57) **CLAIM**

The ornamental design for a roof rack, as shown and described.

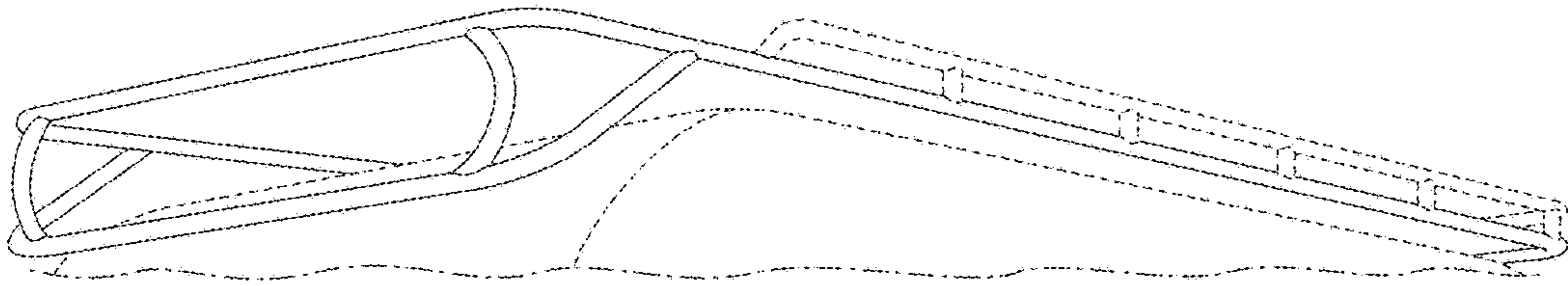
**DESCRIPTION**

The broken lines shown in the drawings illustrate portions of the roof rack and form no part of the claimed design.

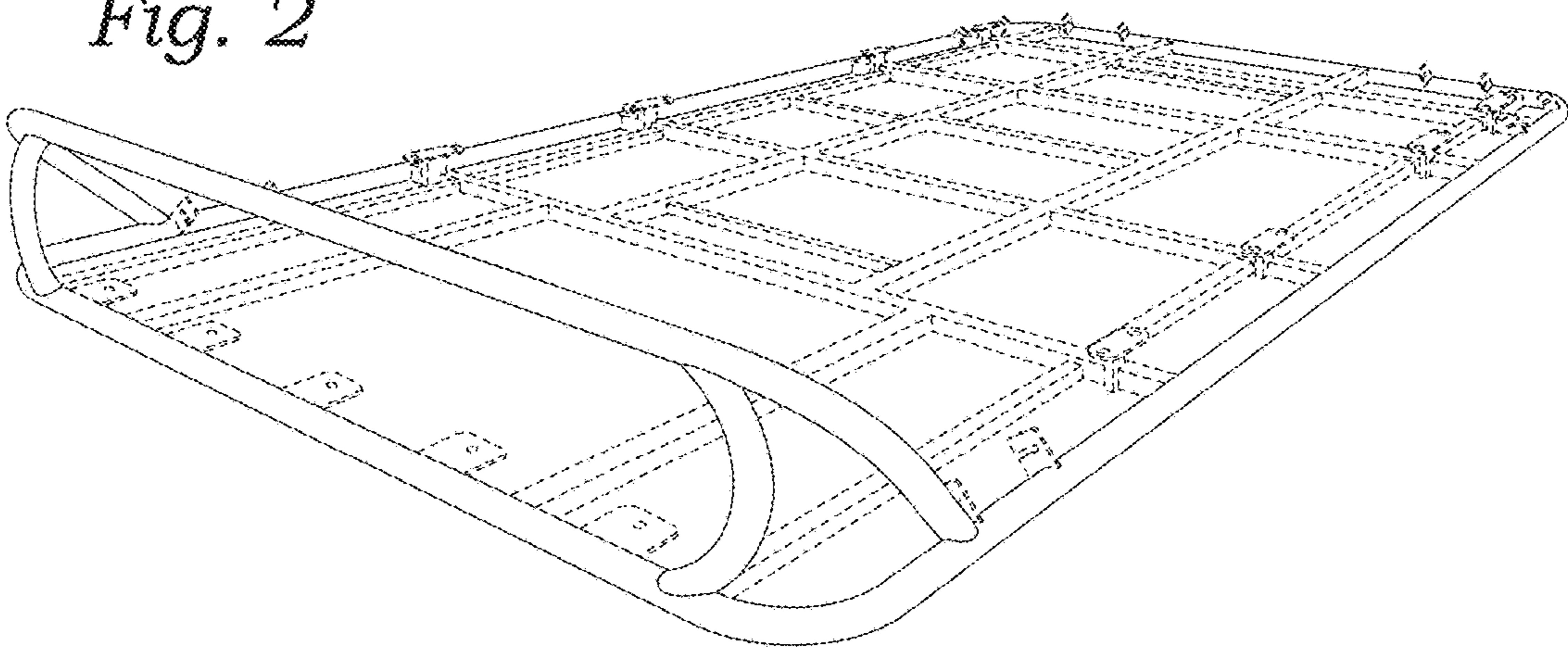

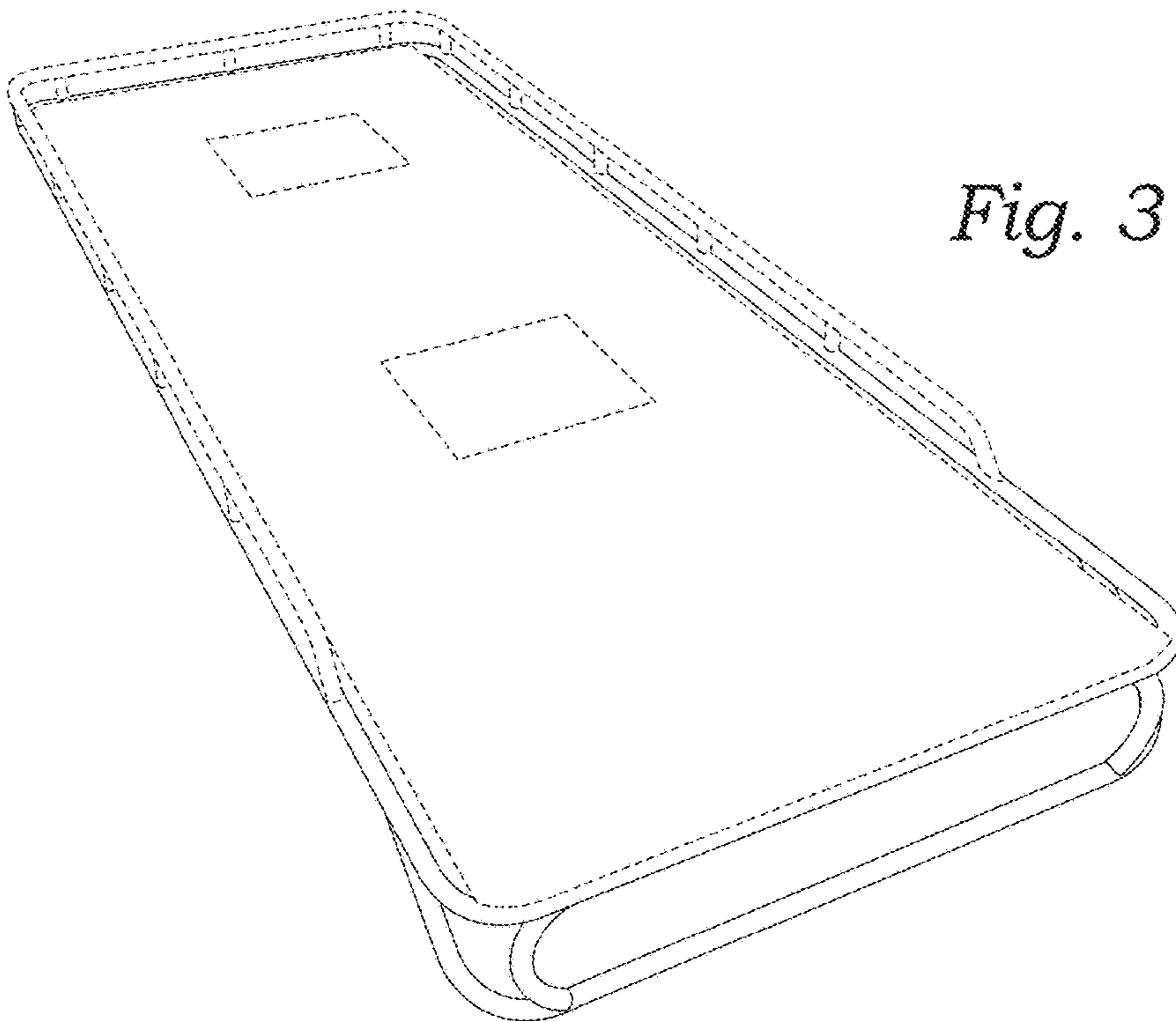

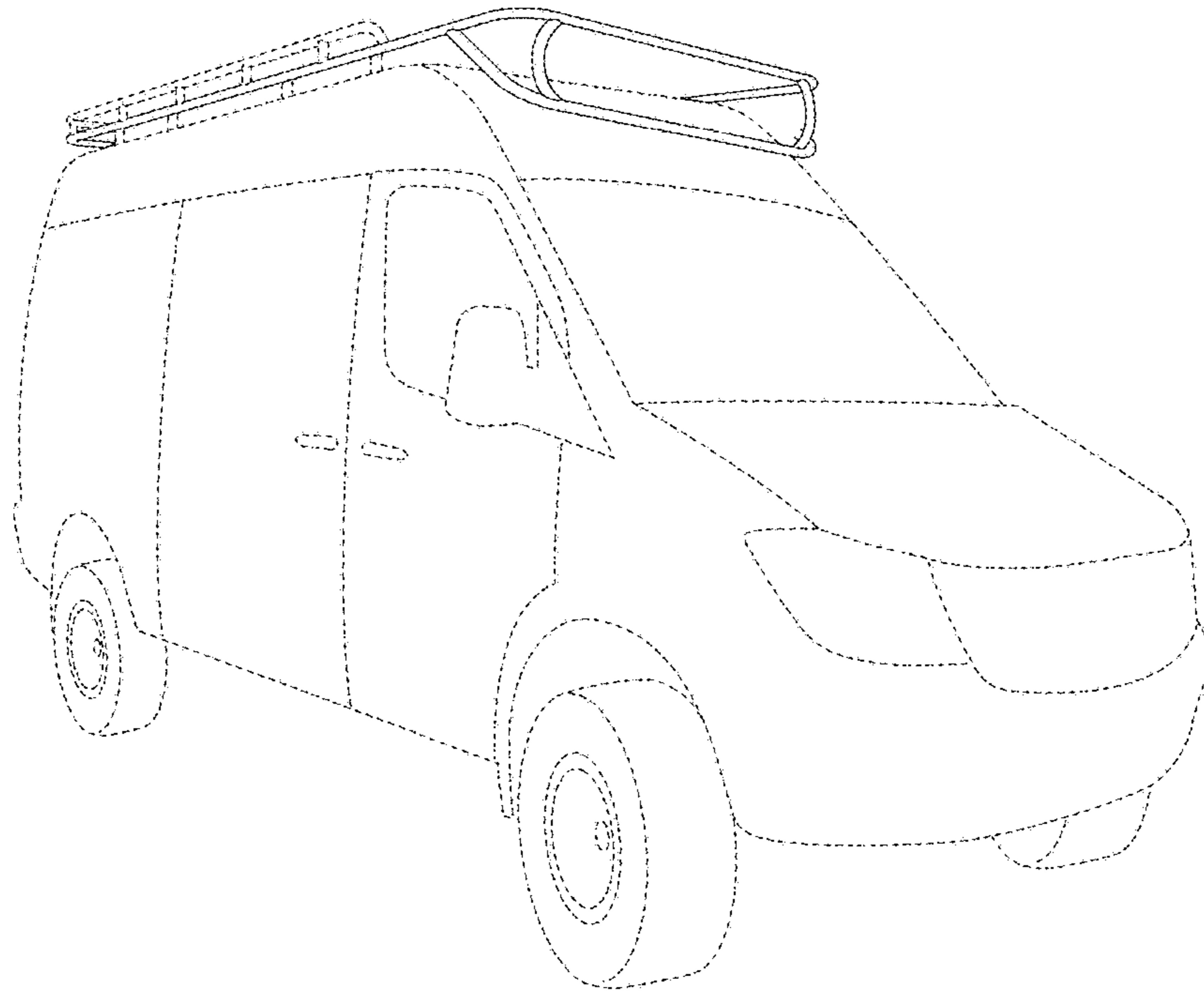

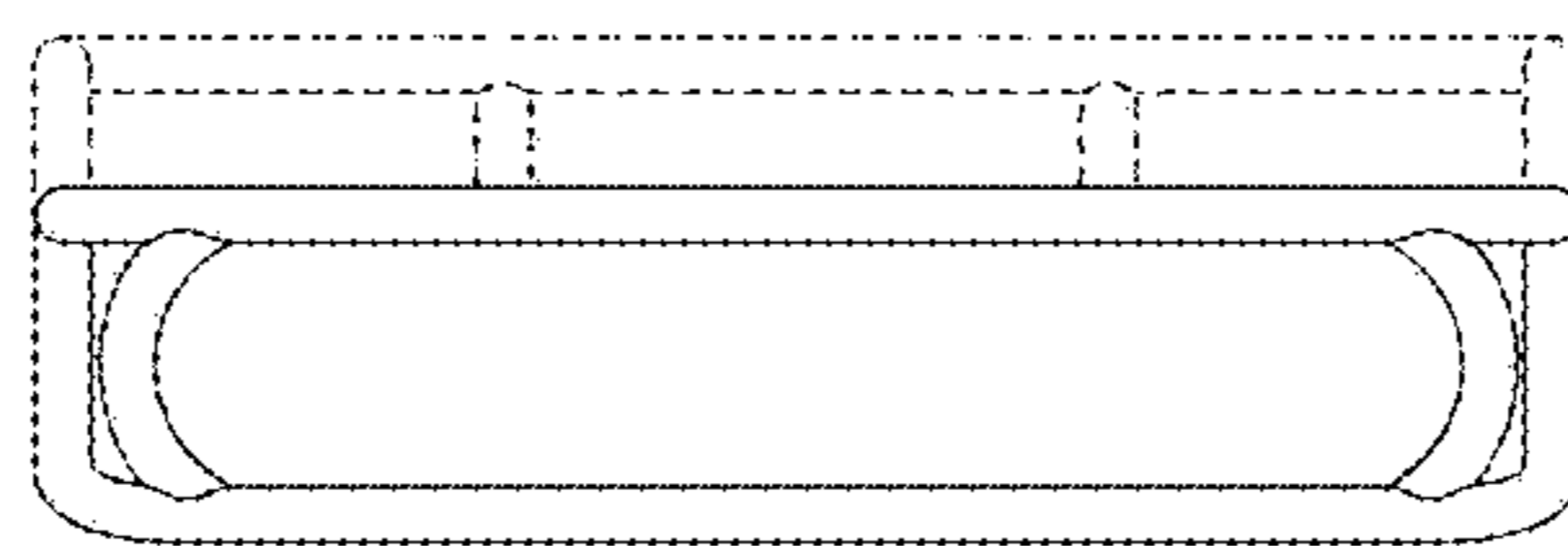
