(57) **CLAIM**

The ornamental design for a protection case for mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a protection case for mobile phone in an assembled state showing my new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a bottom, rear, left side perspective view thereof; FIG. 8 is a bottom, rear, right side perspective view thereof; FIG. 9 is a bottom, front, right side perspective view thereof; FIG. 10 is a bottom, front, left side perspective view thereof; FIG. 11 is a second front elevational view showing the protection case for mobile phone in a disassembled state; FIG. 12 is a second bottom, front, right side perspective view showing the protection case for mobile phone in a disassembled state; and, FIG. 13 is a top, rear, left side perspective view showing the protection case for mobile phone in a disassembled state.

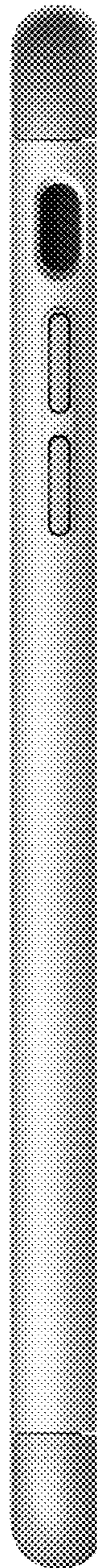

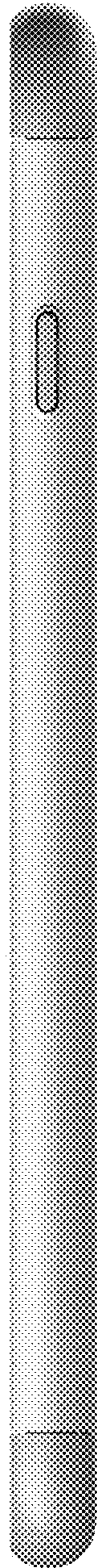

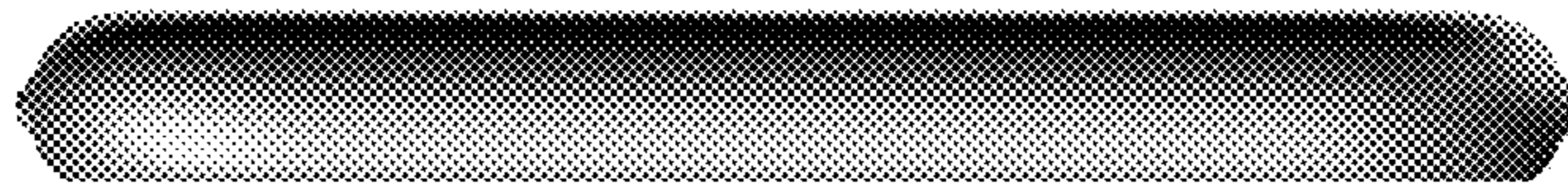

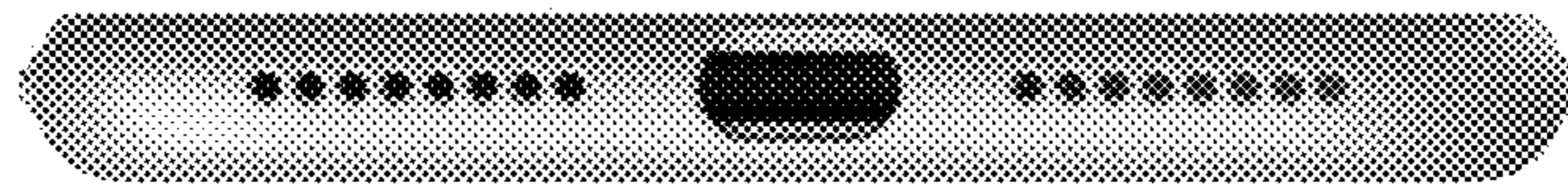
