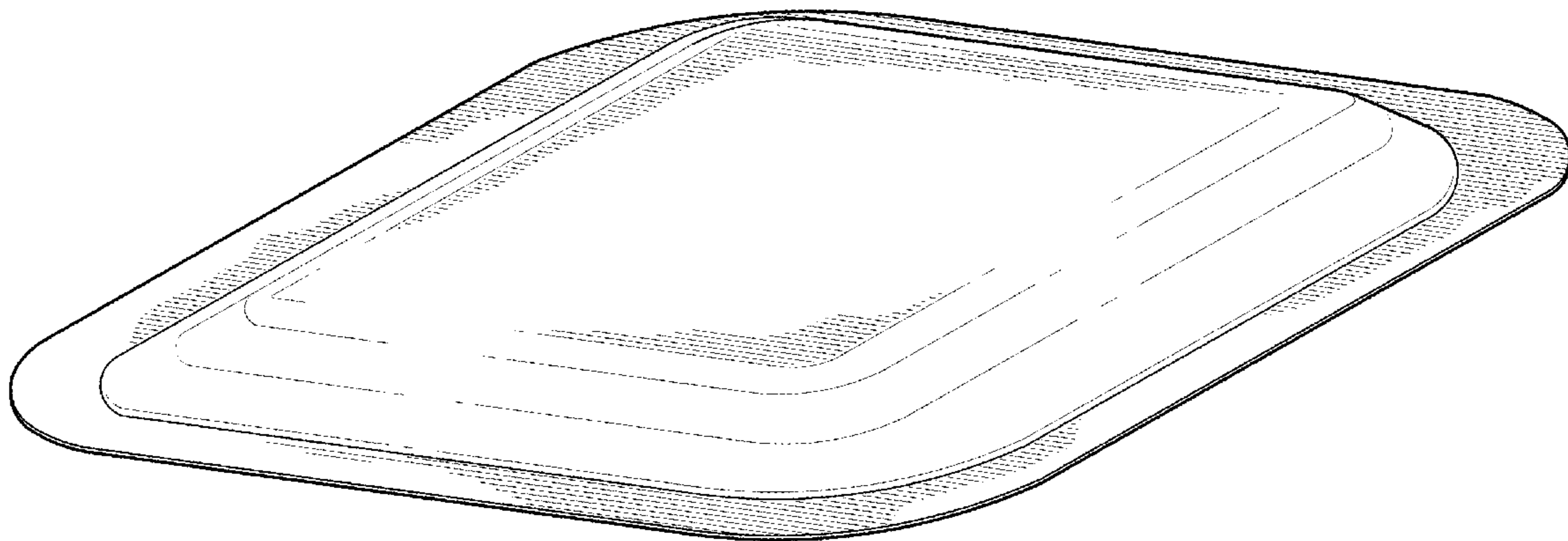
(57) **CLAIM**

The ornamental design for a cover member for electronic component, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a cover member for electronic component showing our new design; FIG. 2 is a top plan view of the cover member of FIG. 1; FIG. 3 is a bottom plan view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a front elevation view thereof; FIG. 6 is a left side elevation view thereof; FIG. 7 is a right side elevation view thereof; and, FIG. 8 is a sectional view through the cross-sectional plane shown in FIG. 2.

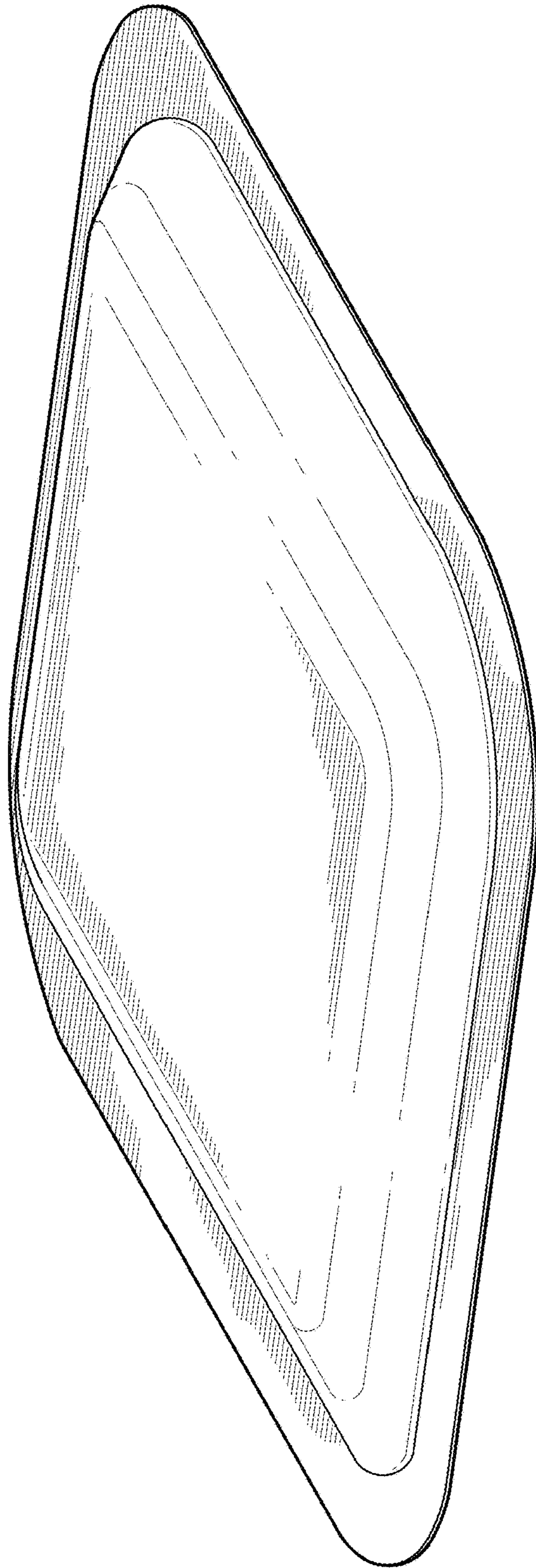

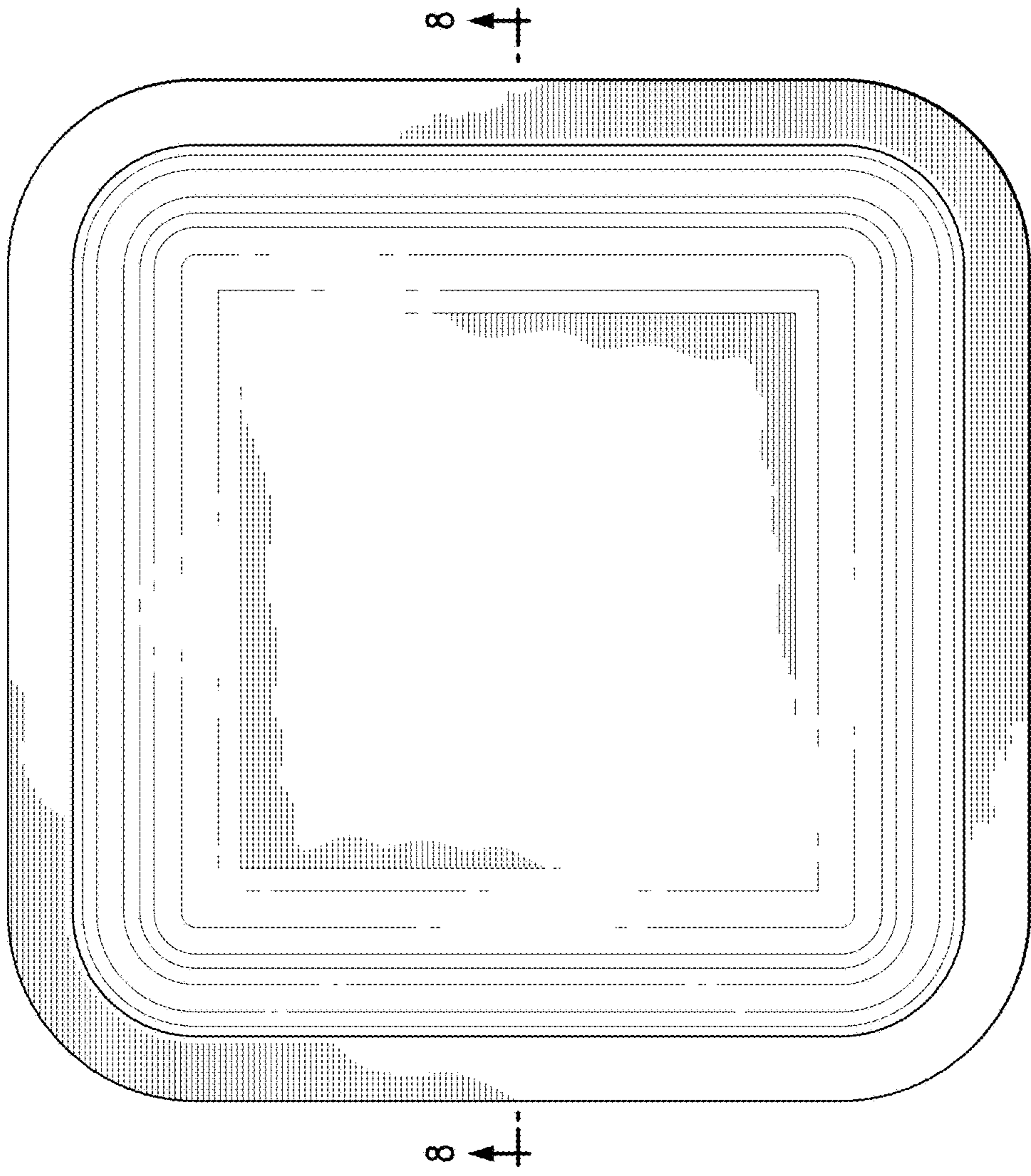

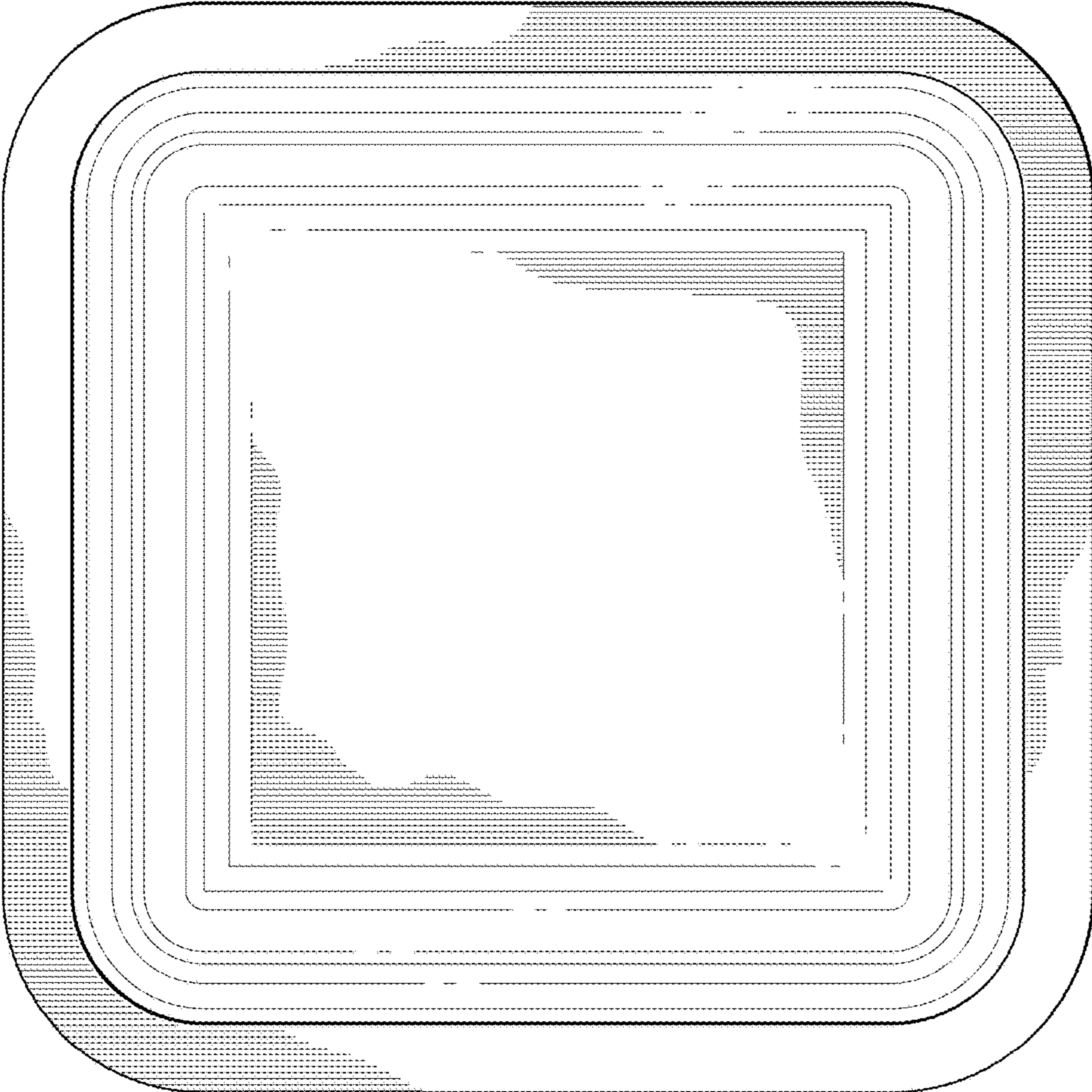

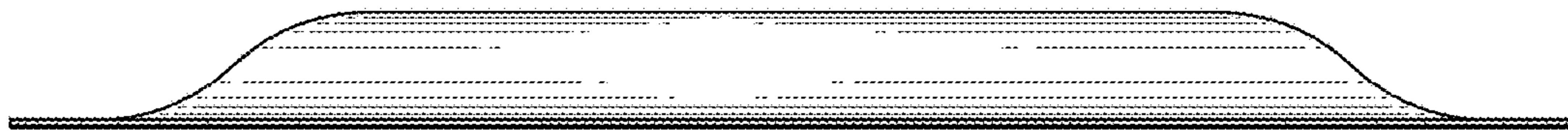

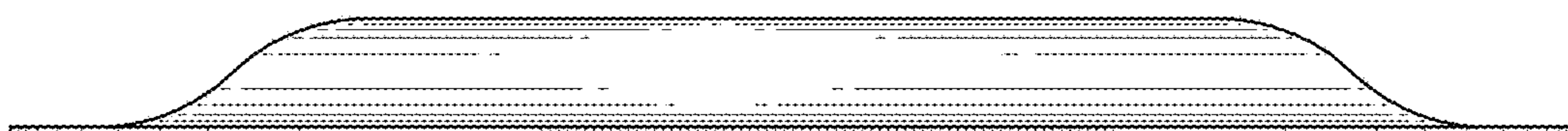

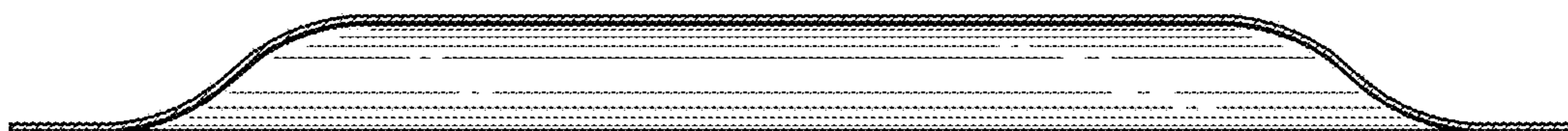
