FIG. 3 is an enlarged fragmented lower view of the reminder rib.

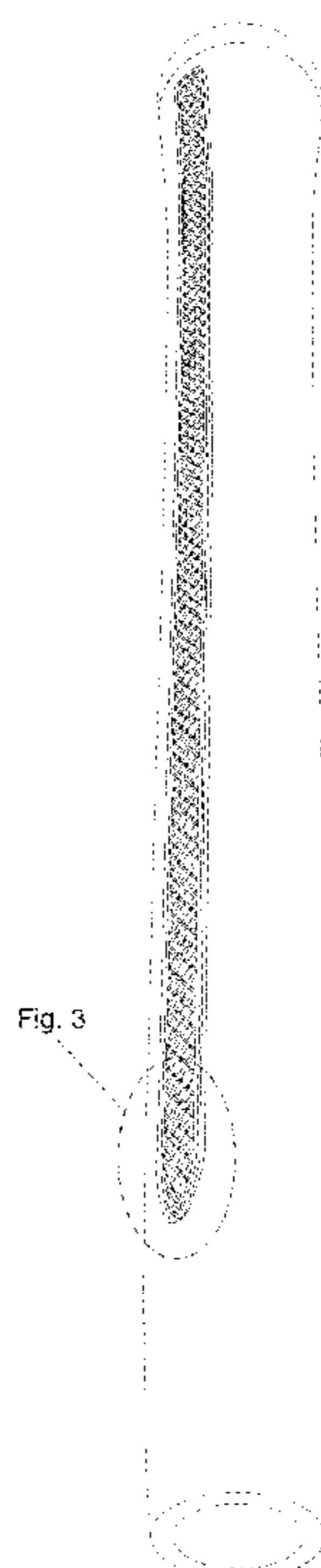

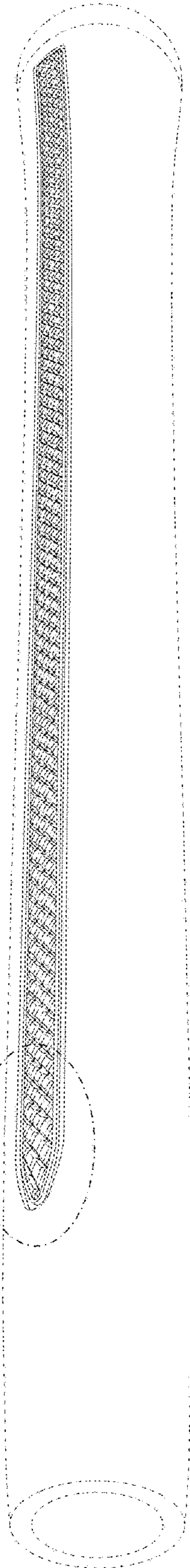

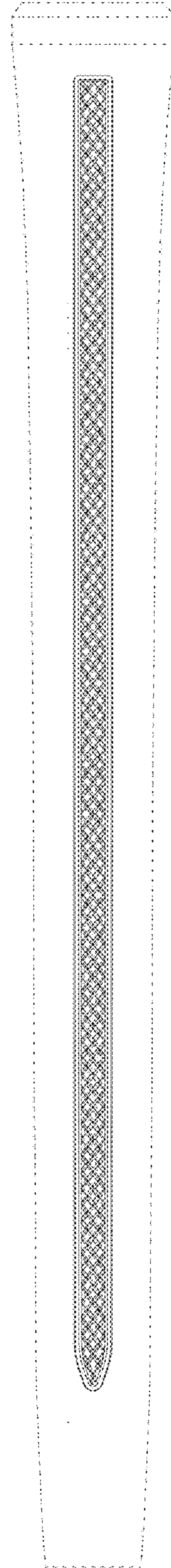

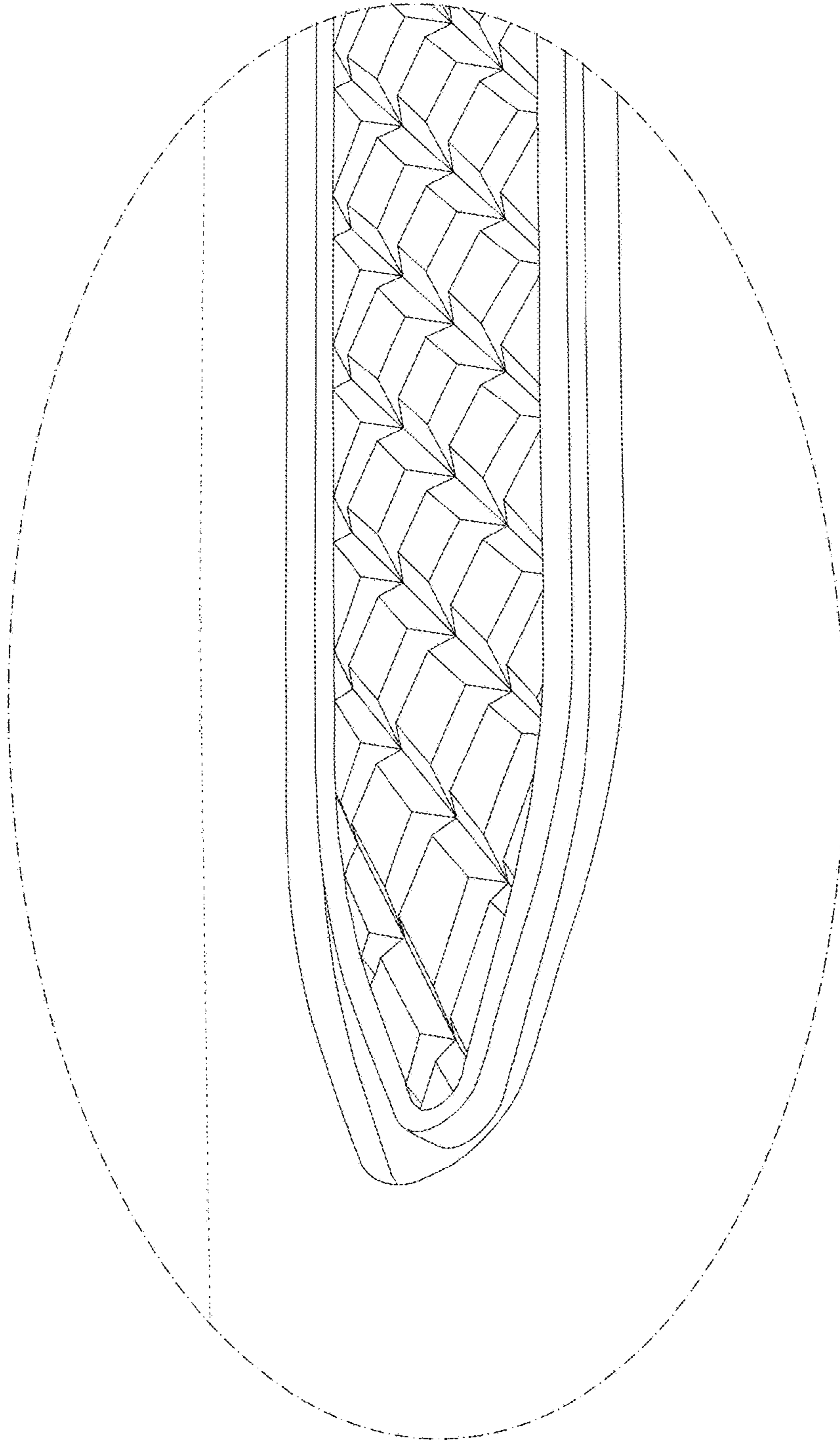
