(57) **CLAIM**

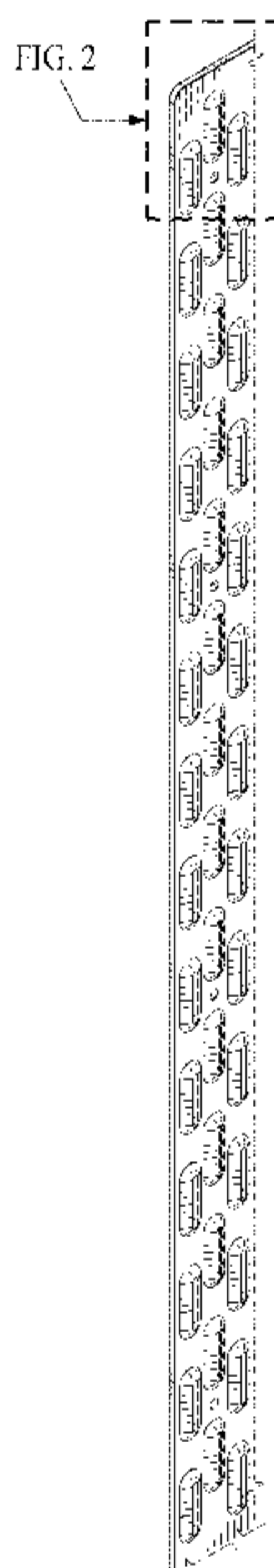
The ornamental design for a ramp skid plate, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a ramp skid plate showing my new design;  
FIG. 2 is a magnified sectional view of the area marked in FIG. 1;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a rear top plan view thereof;  
FIG. 5 is a right side elevation view thereof;  
FIG. 6 is a left side elevation view thereof;  
FIG. 7 is an end view thereof;  
FIG. 8 is the other end view thereof;  
FIG. 9 is a rear perspective view thereof; and,  
FIG. 10 is a magnified sectional view of the area marked in FIG. 9.

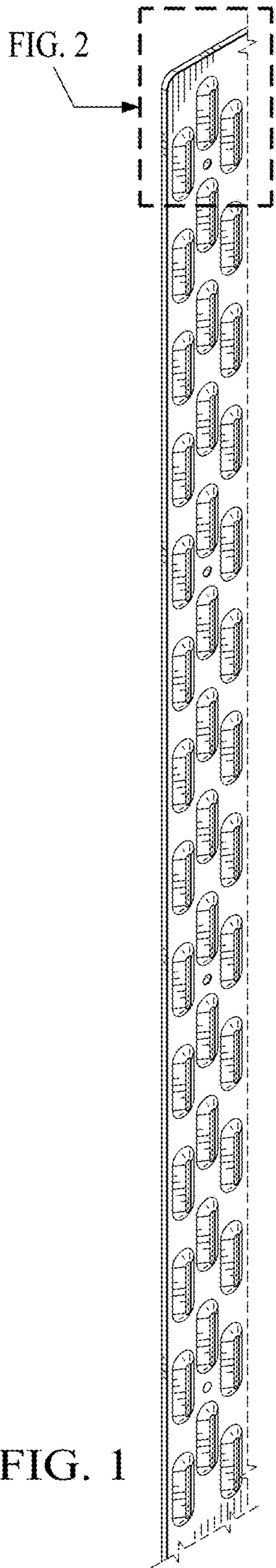

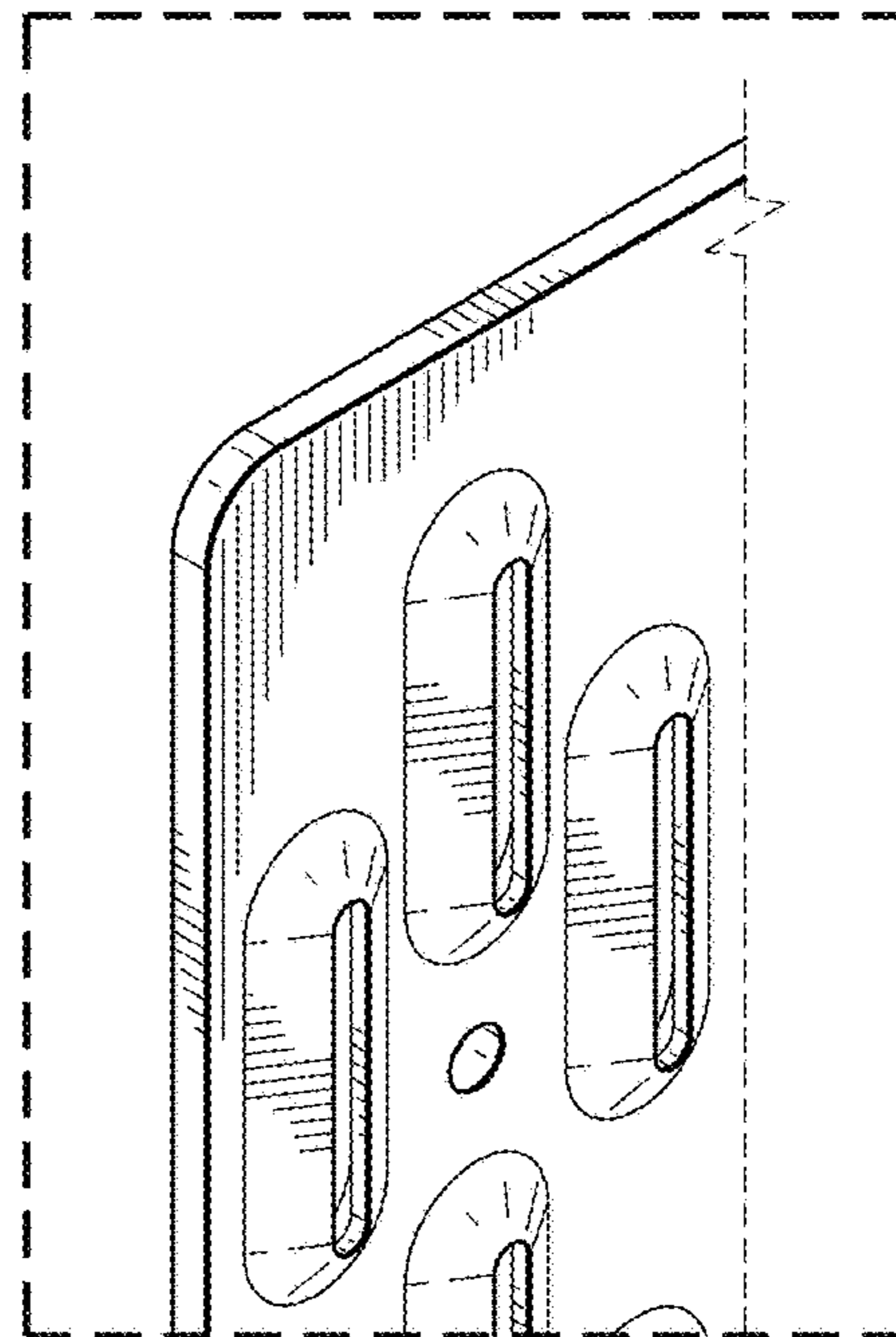

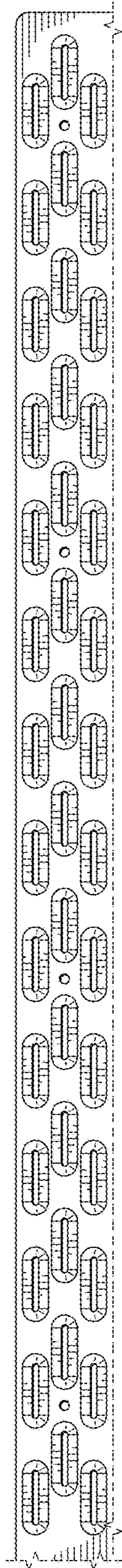

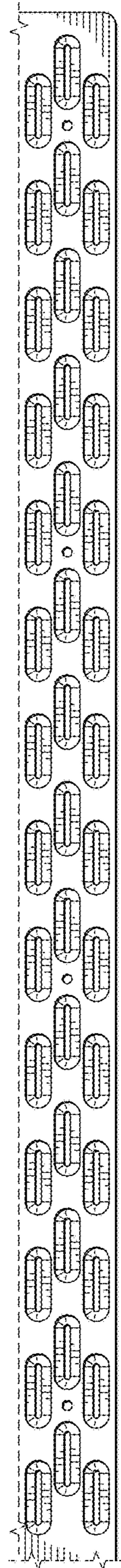

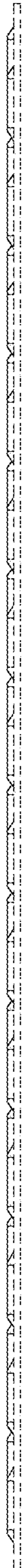

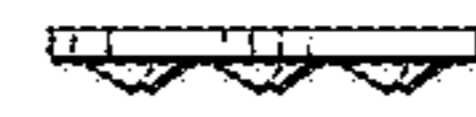

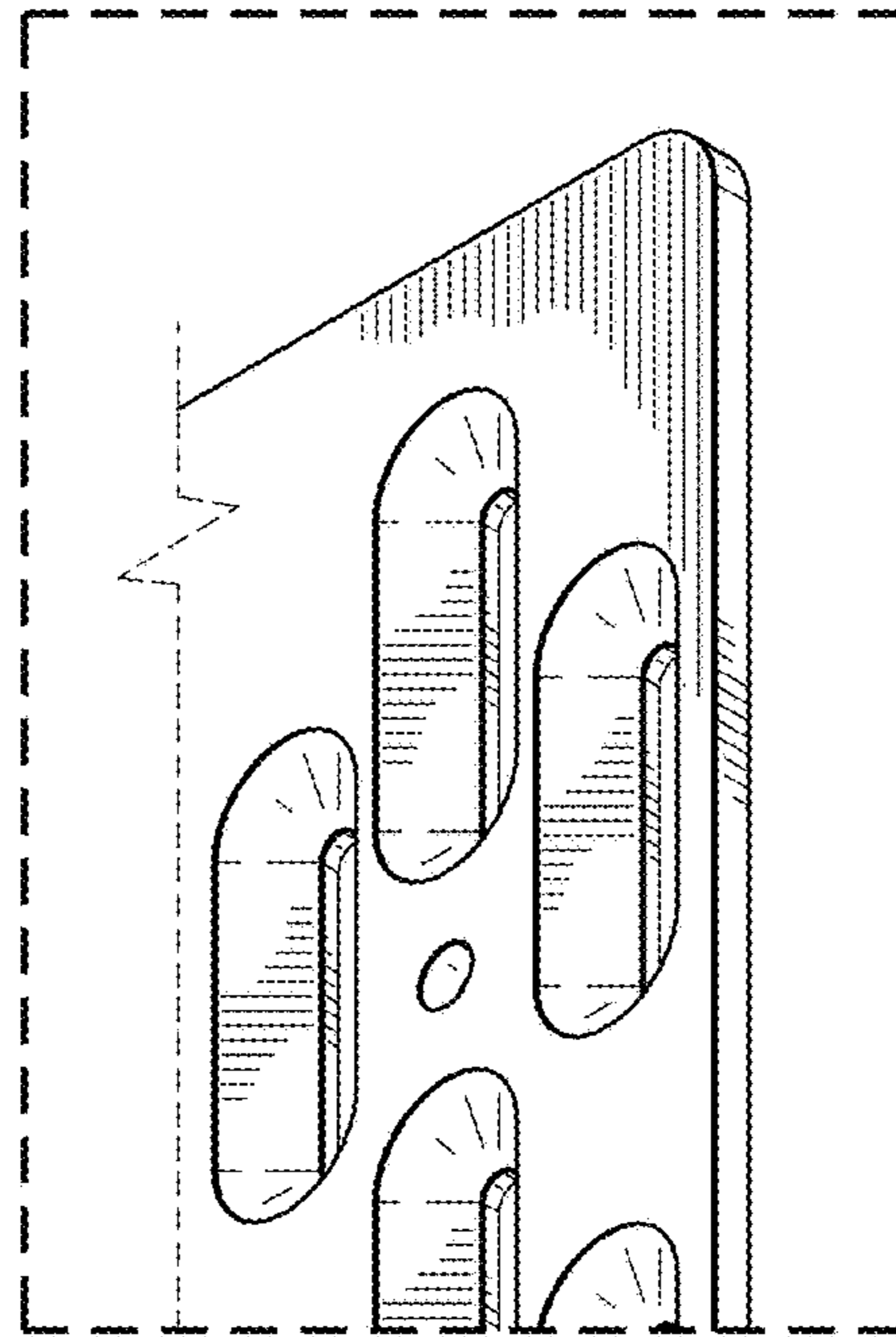
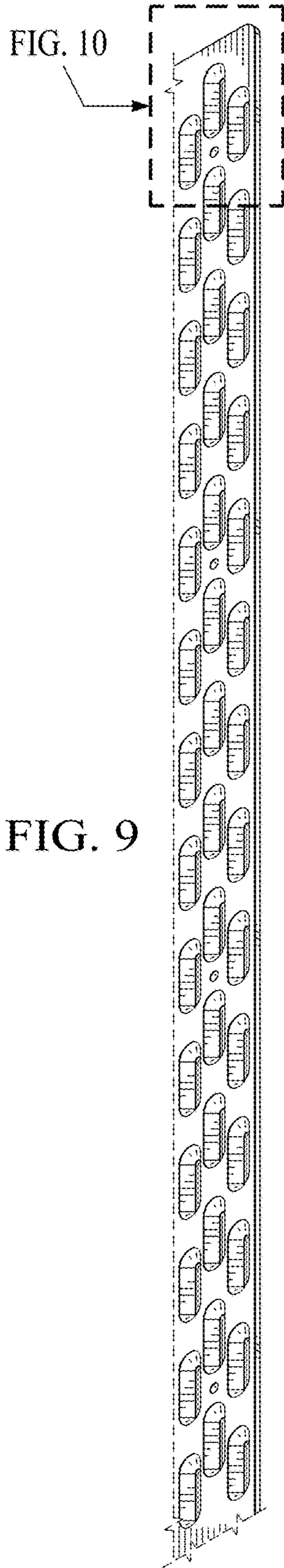
