FIG. 7 is a bottom plan view of the cleavage-enhancing garment insert.

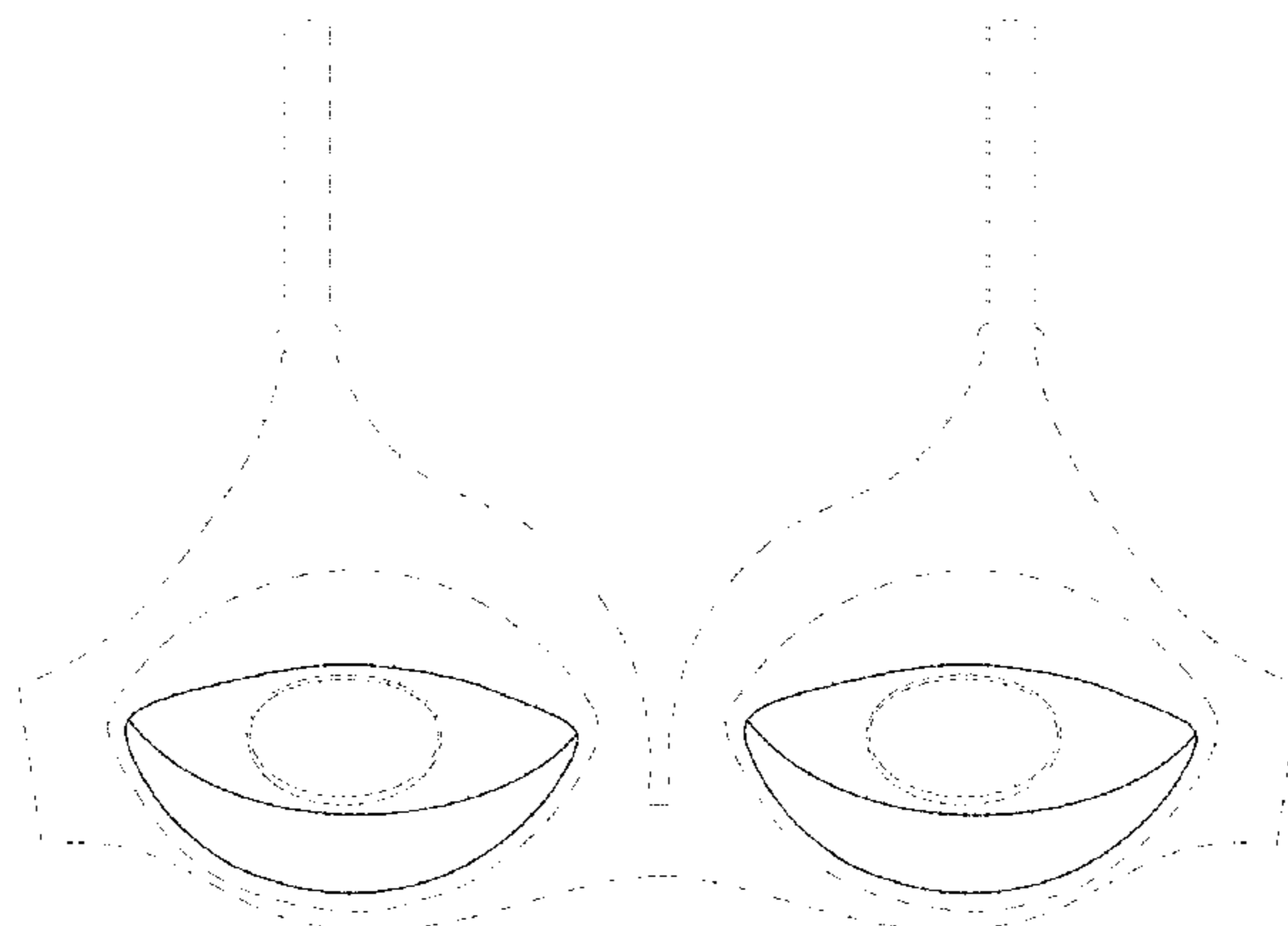

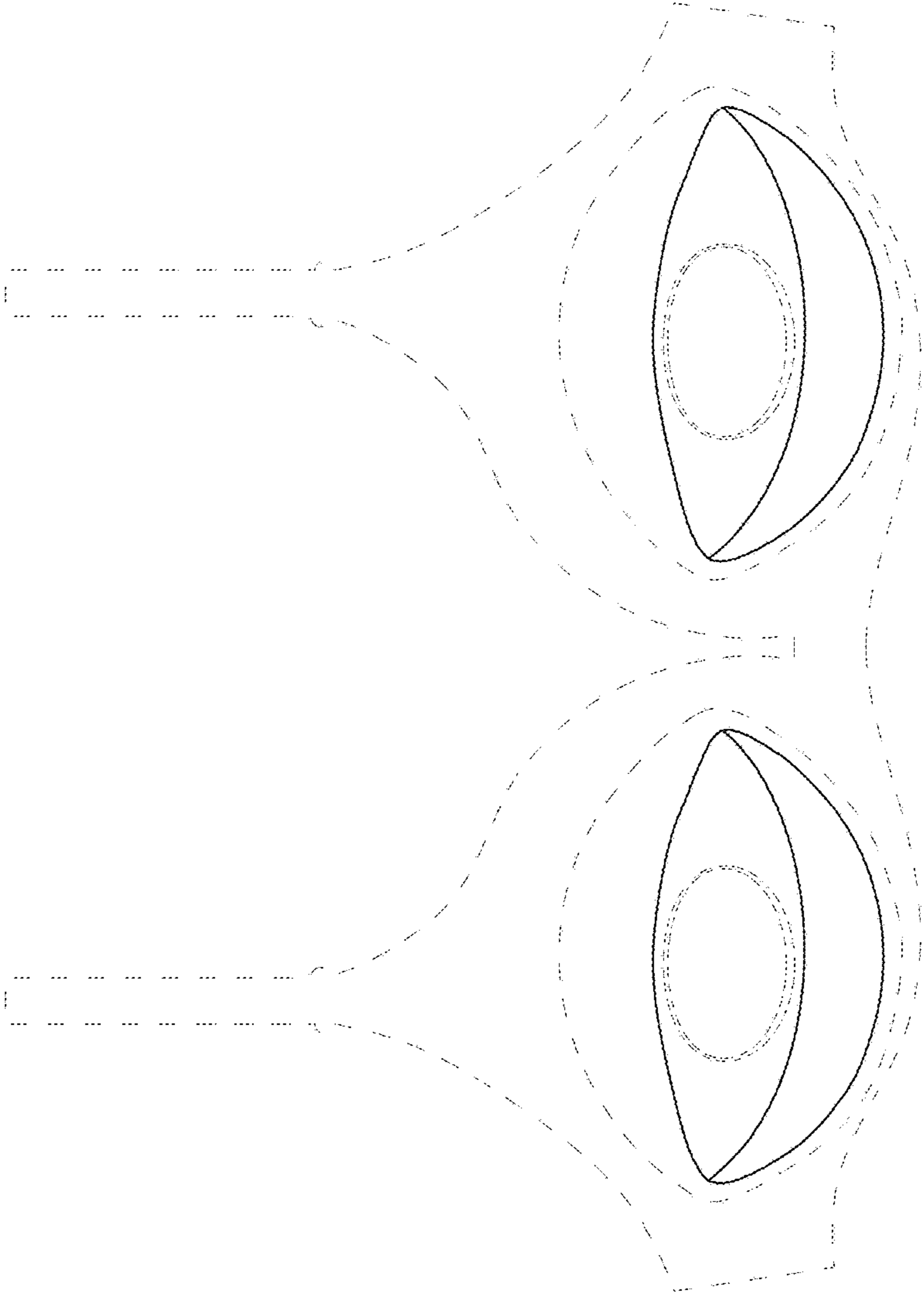

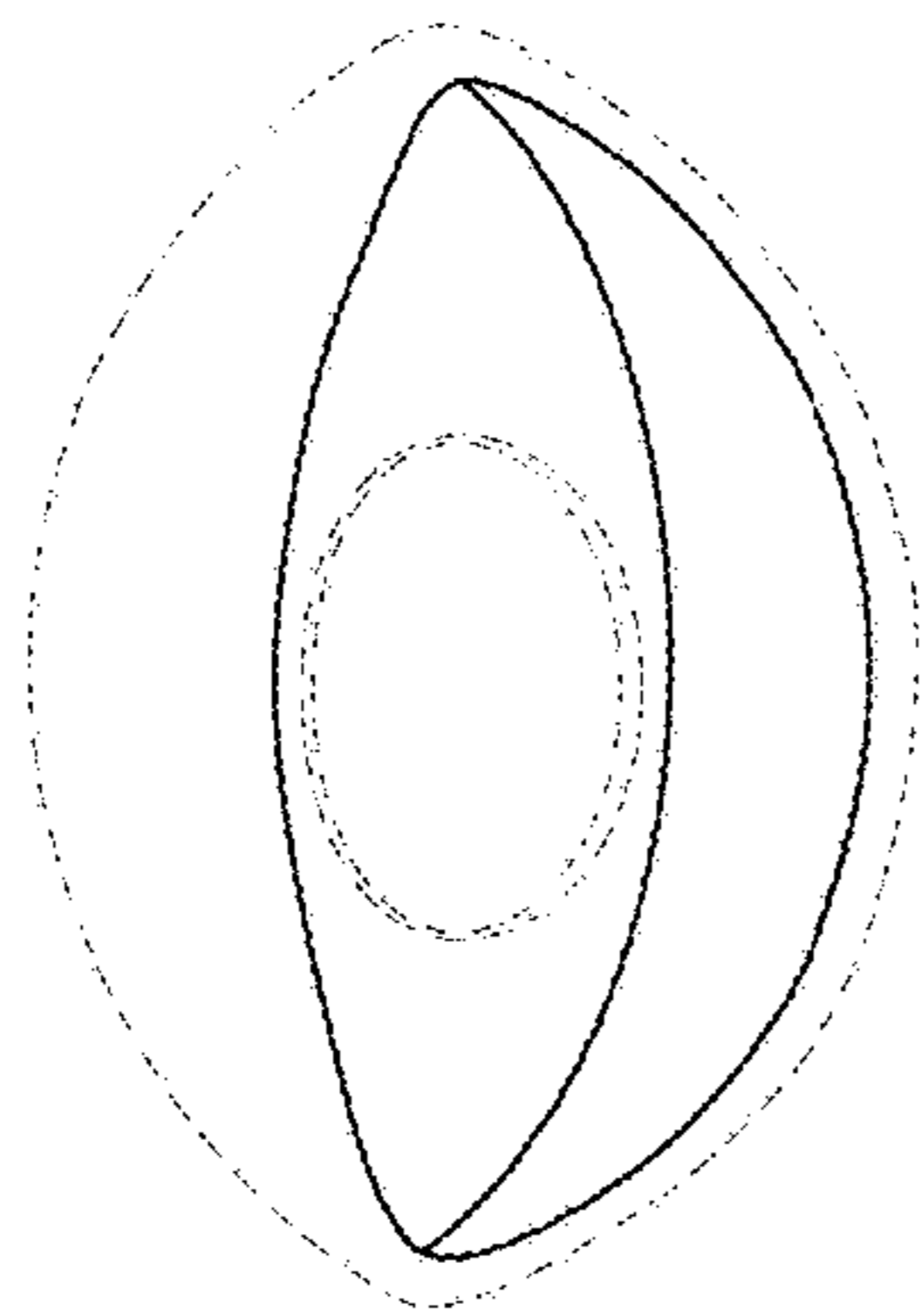

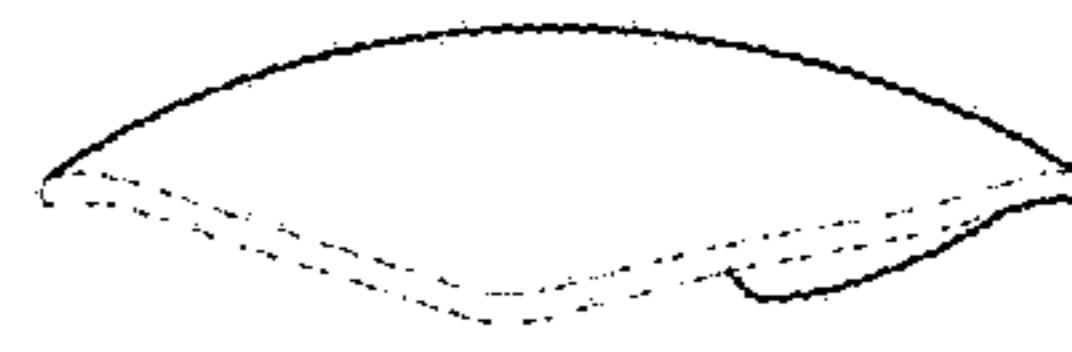

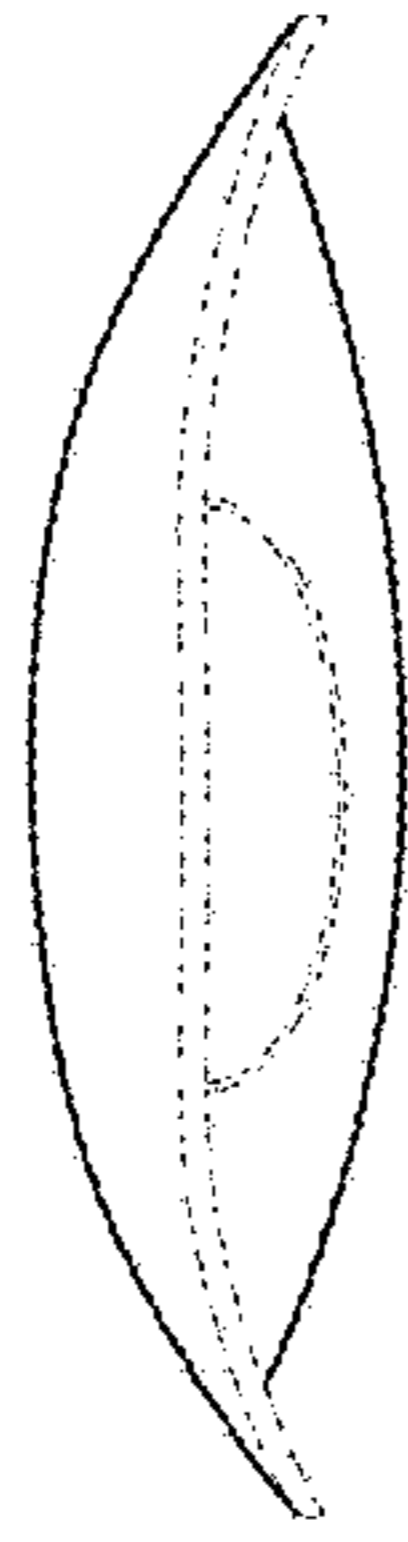

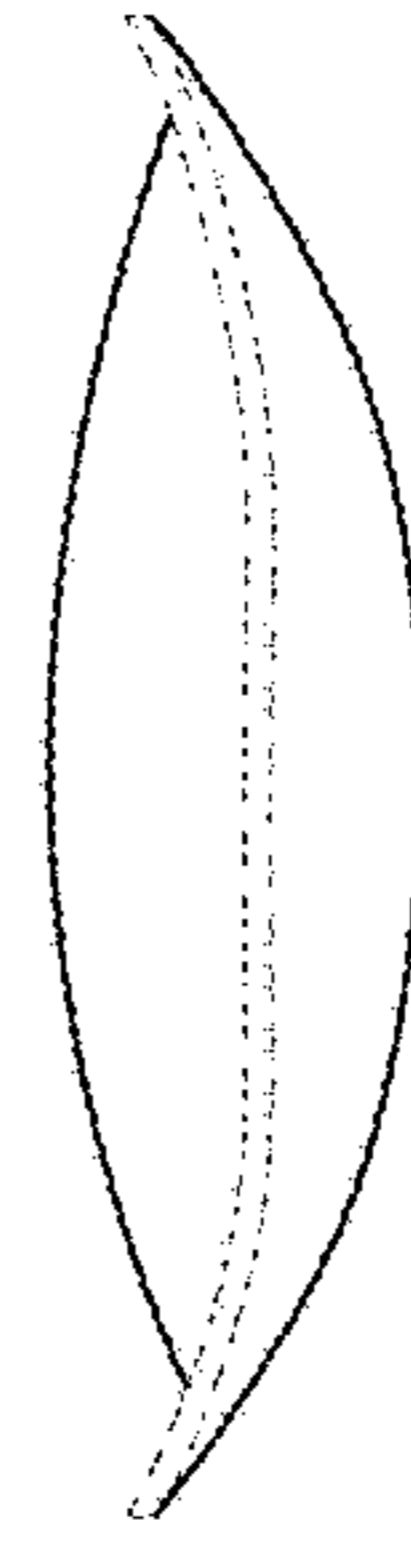

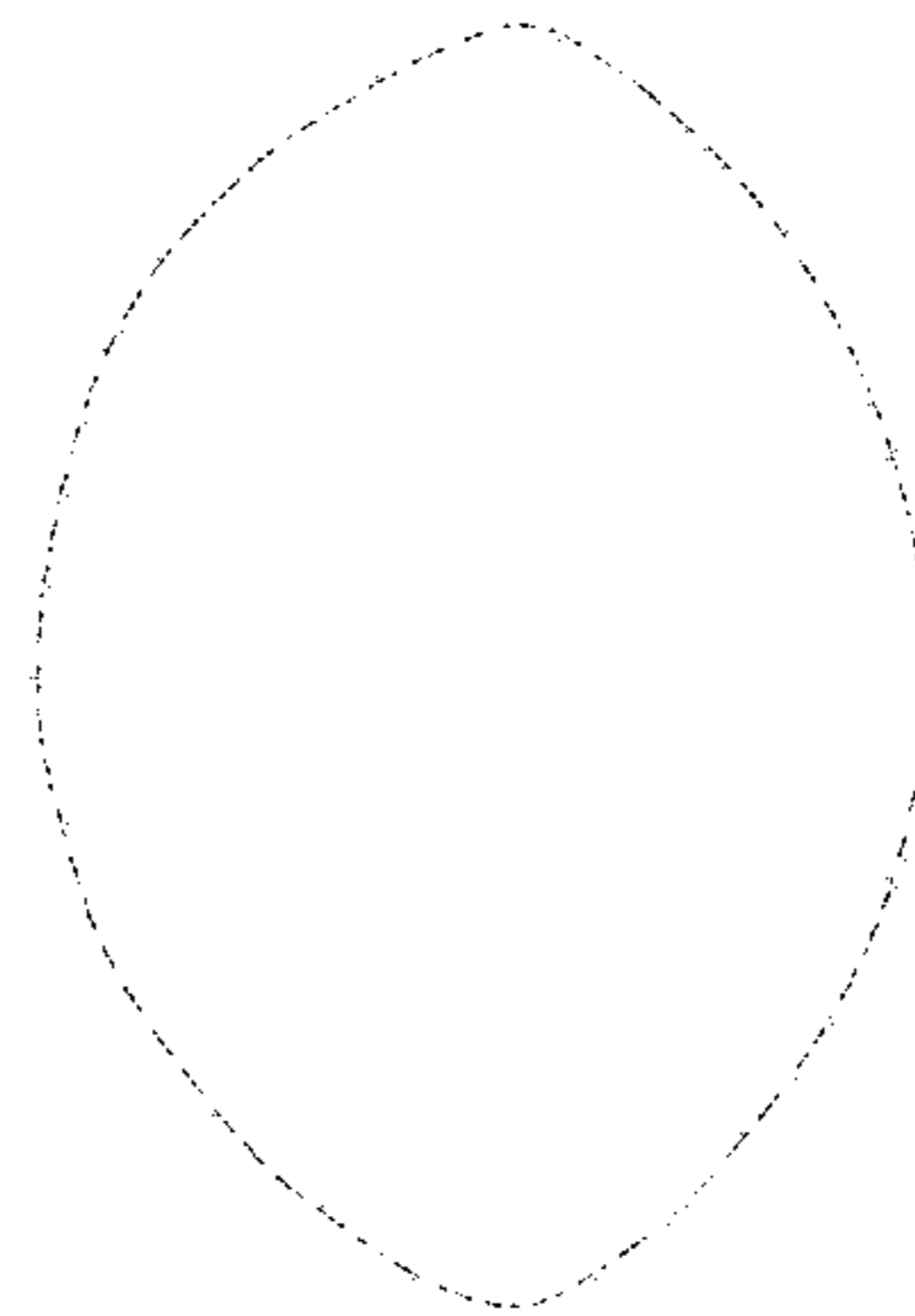
