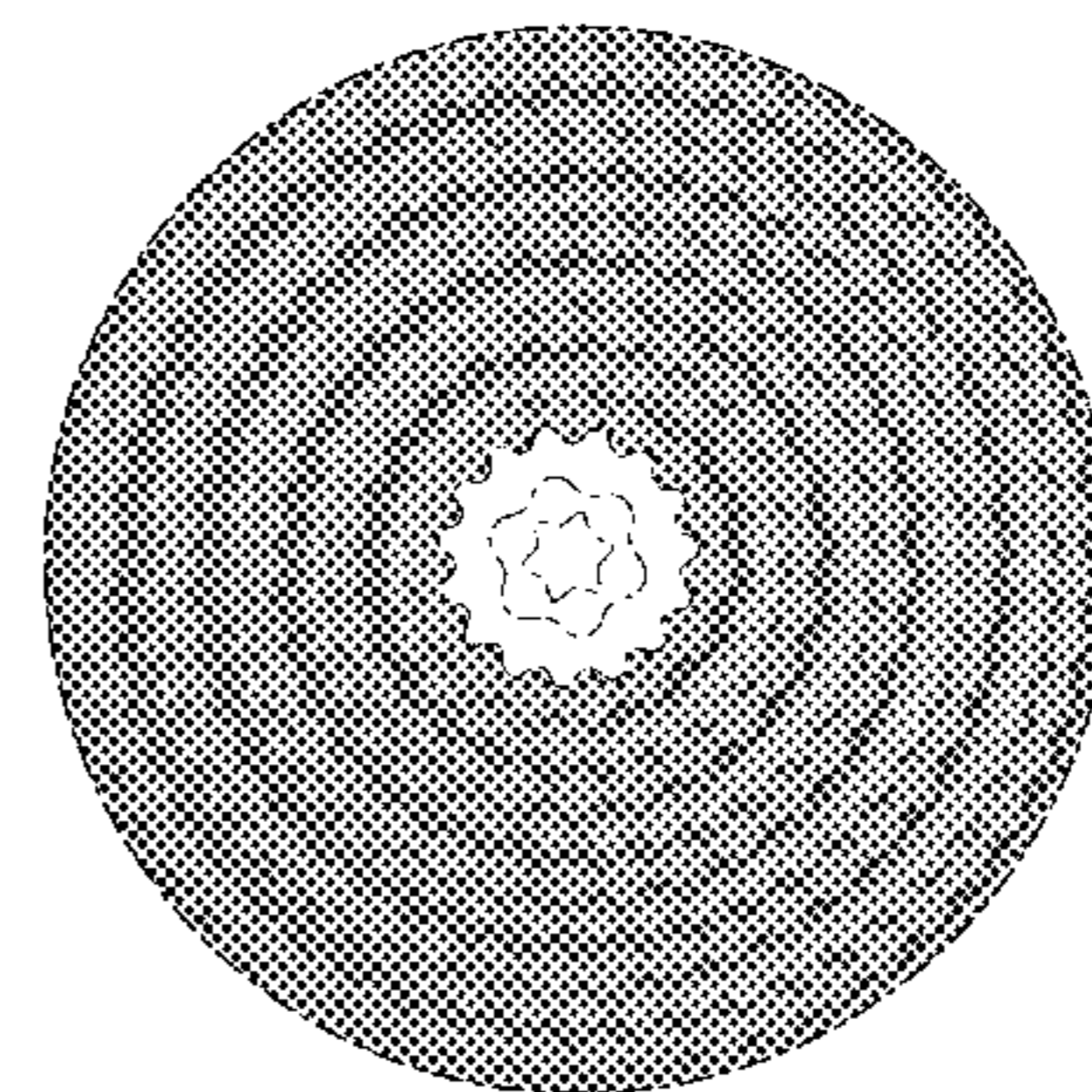
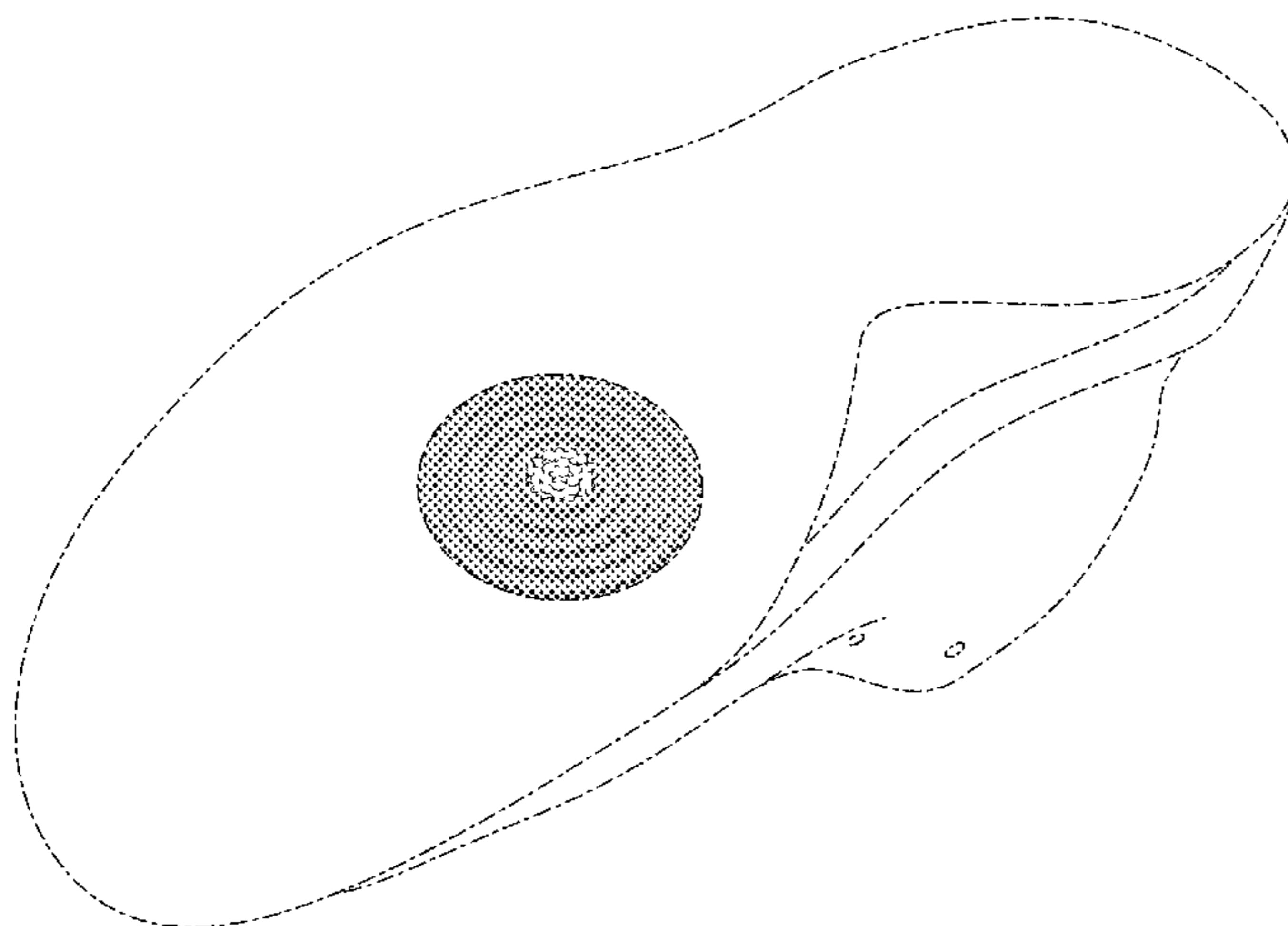
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing our new design;
 FIG. 2 is a bottom view thereof;
 FIG. 3 is a rear perspective view thereof;
 FIG. 4 is an enlarged partial view of FIG. 1; and,
 FIG. 5 is an enlarged partial view of FIG. 2.
 The broken lines immediately adjacent to the photographic area define the bounds of the claimed design and form no part thereof. The unshaded region within the photographic area that is demarcated by broken lines forms no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

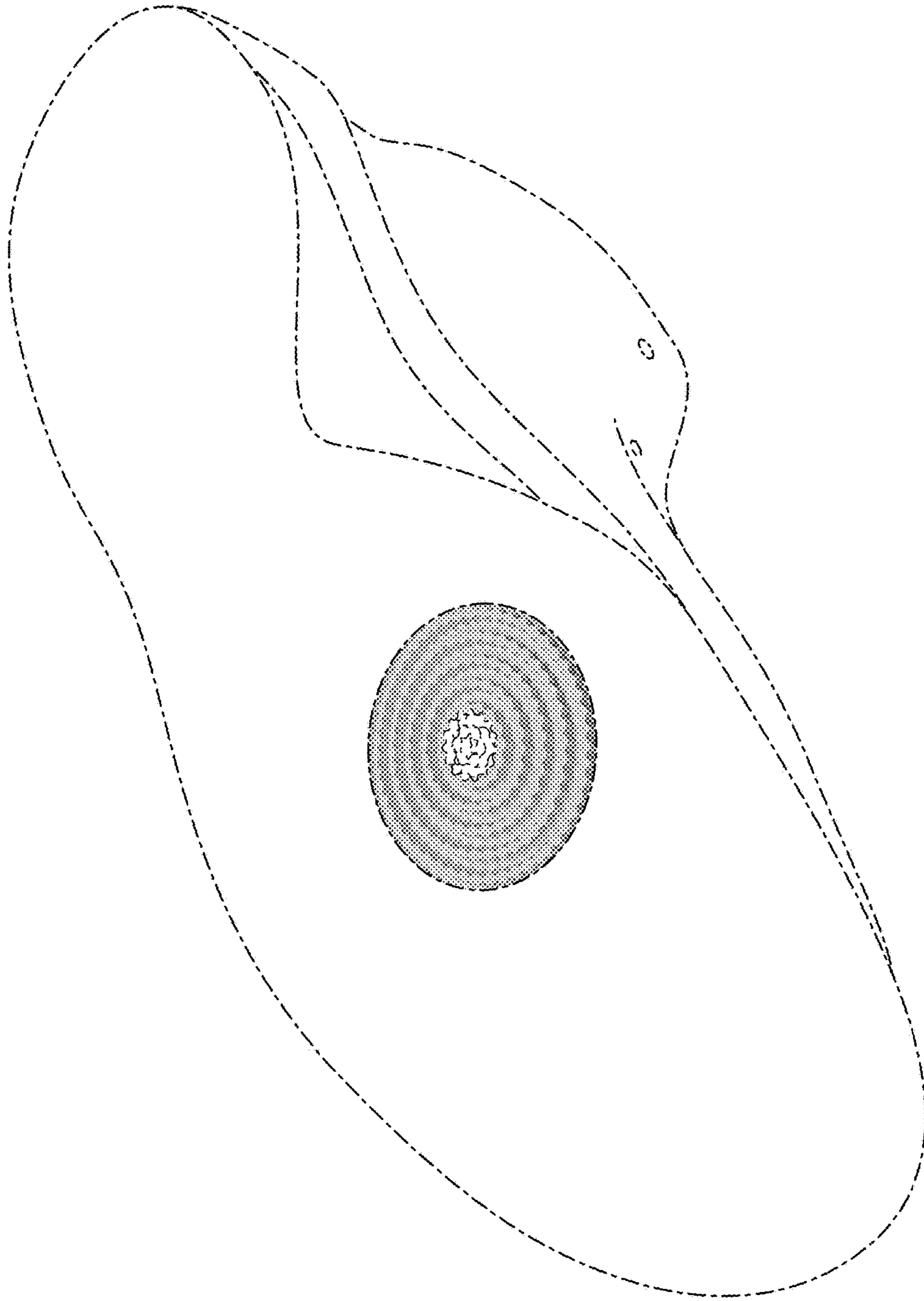

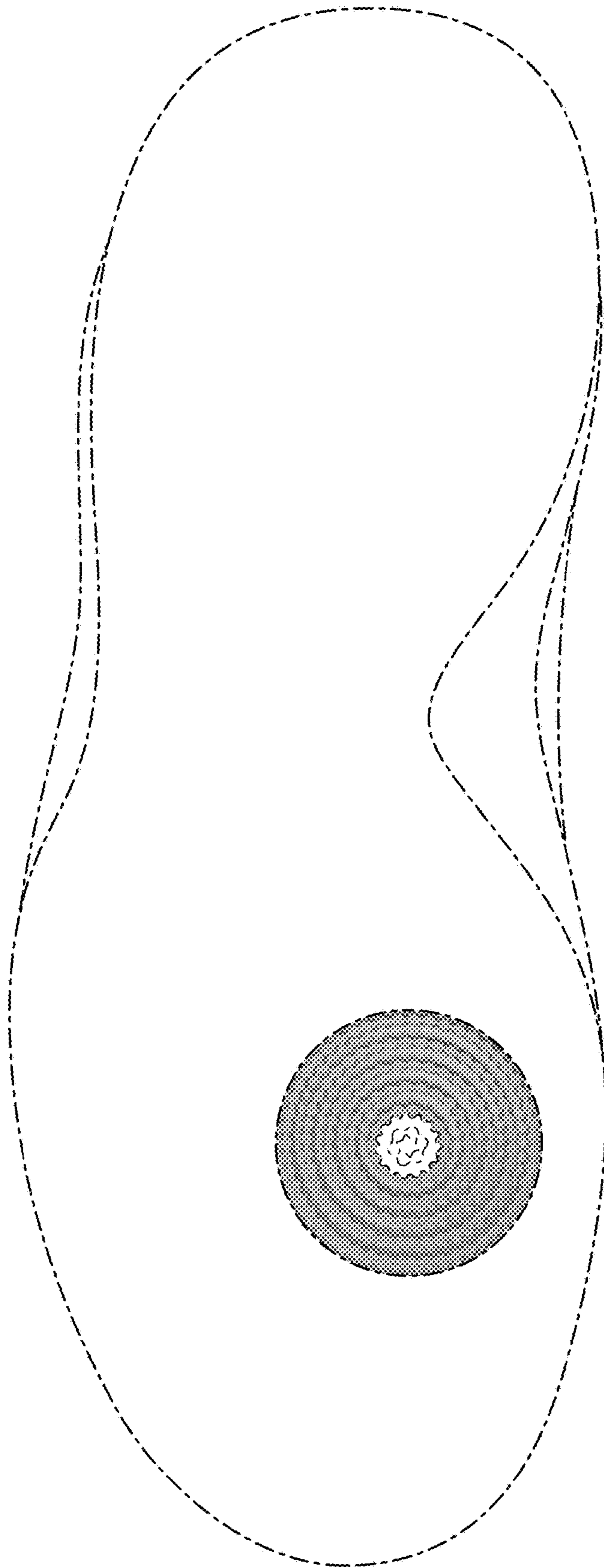

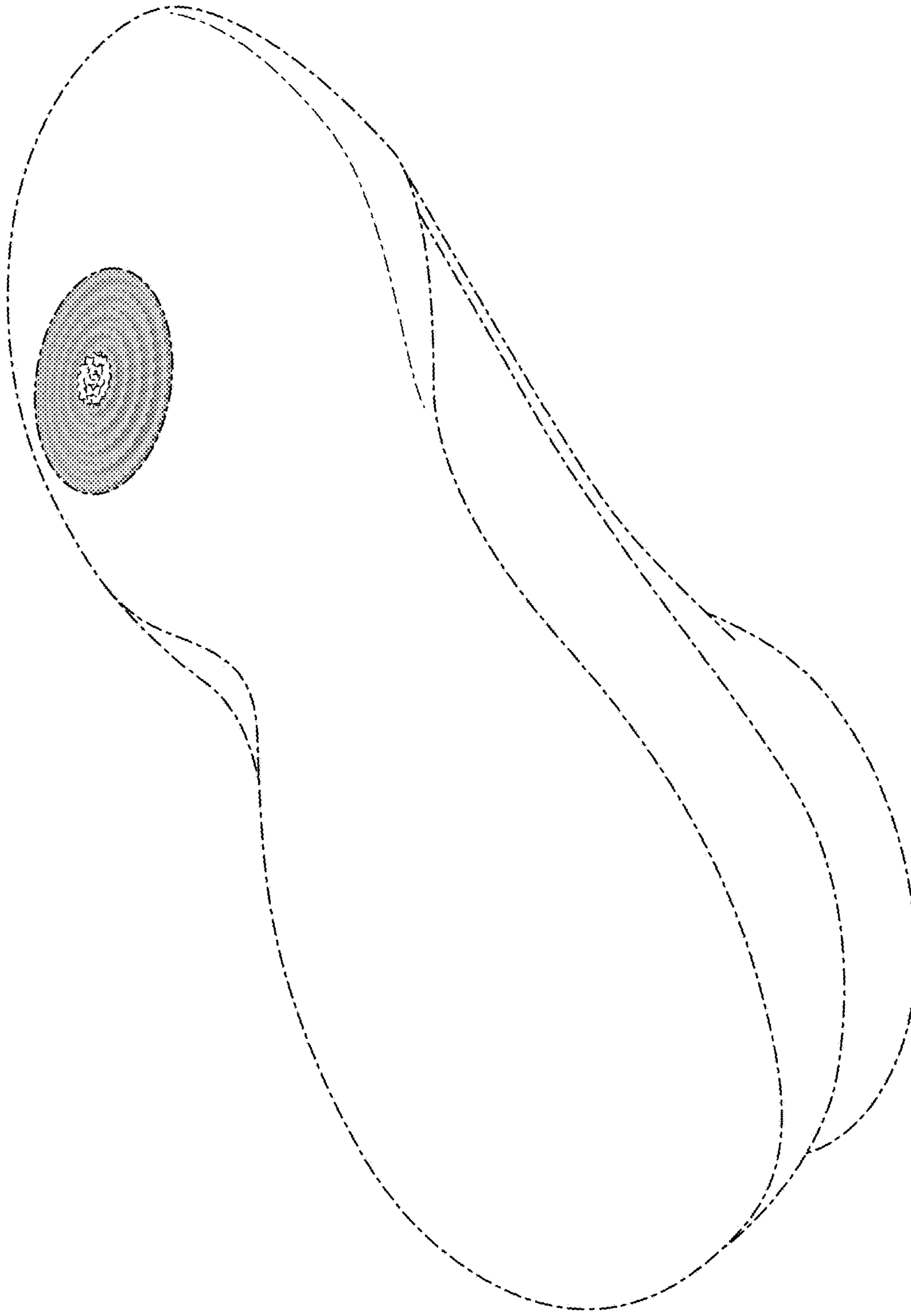

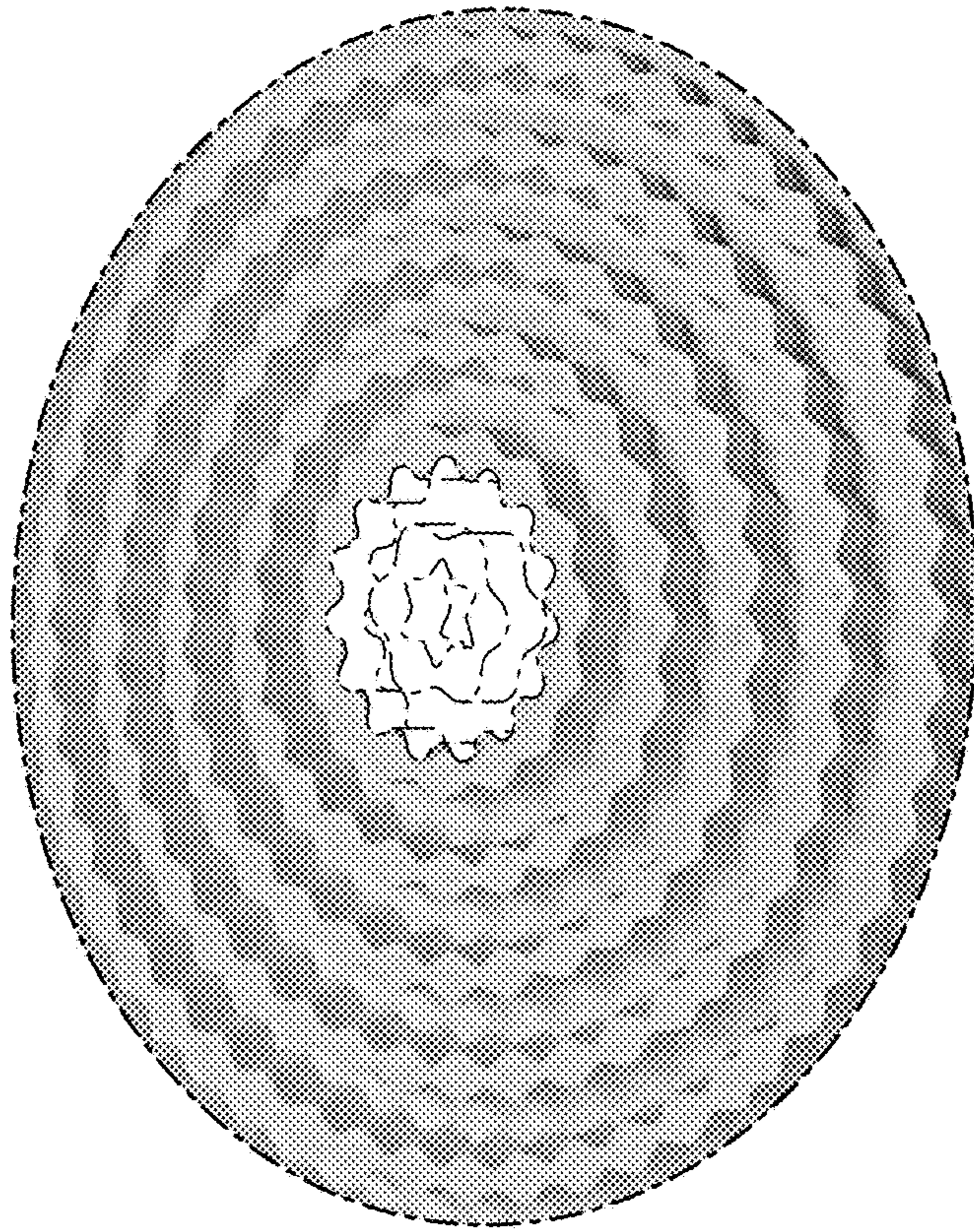

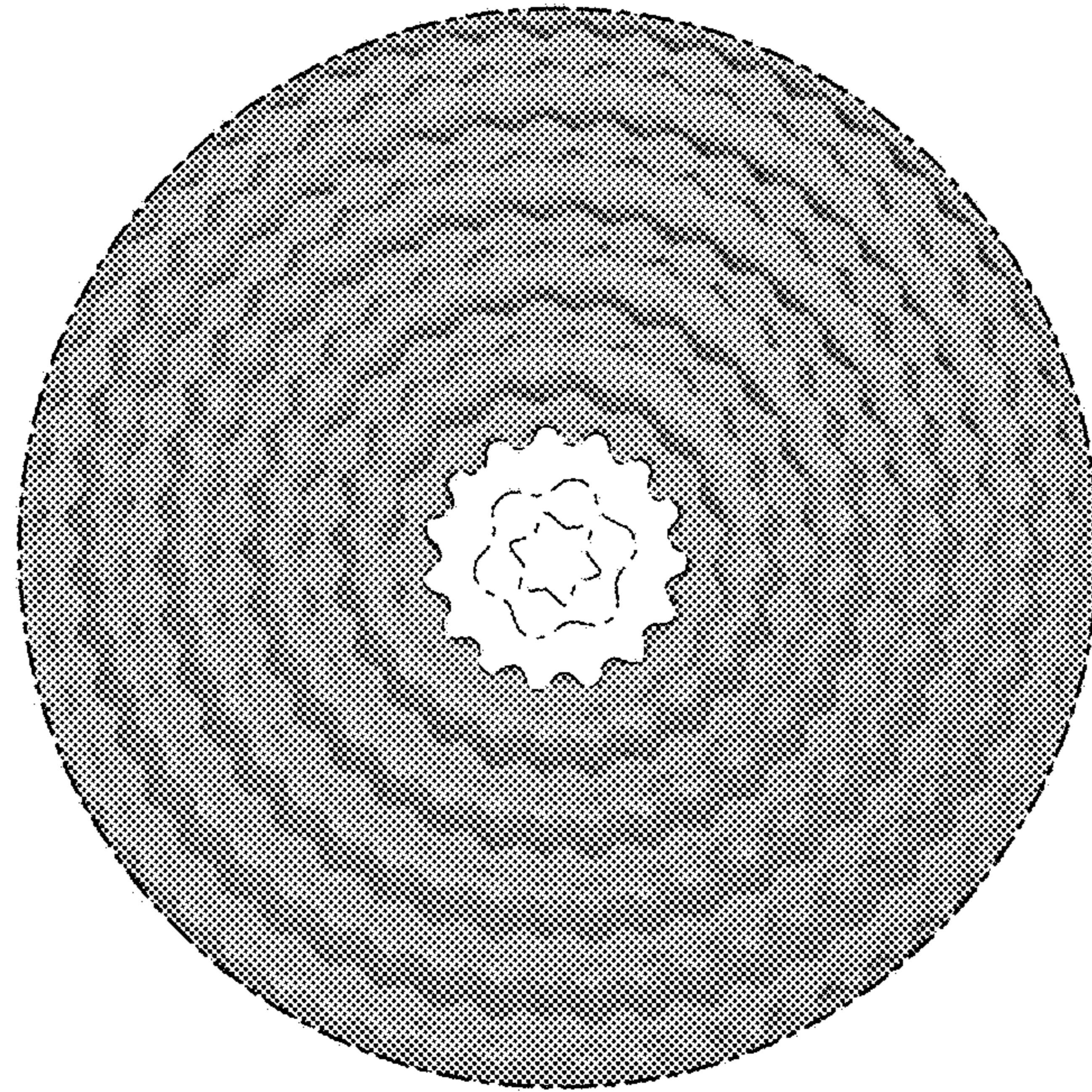
