1.3 is a top view thereof;


1.4 is a right-side view thereof;

1.5 is a rear view thereof;


1.6 is a bottom view thereof; and


1.7 is a left-side view thereof.

The hook portion of the garment hanger that is shown in blue wash is excluded from protection.









