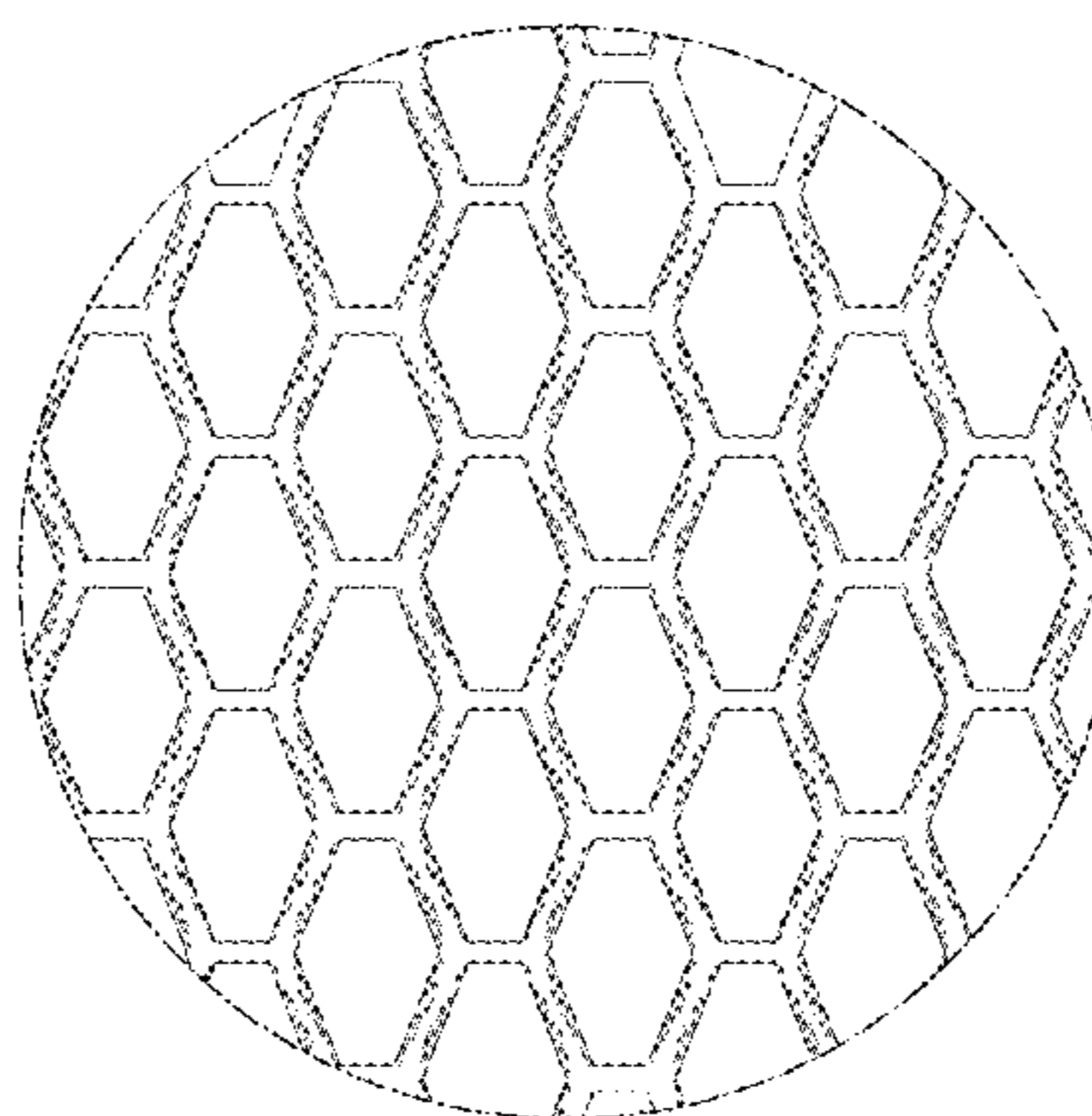
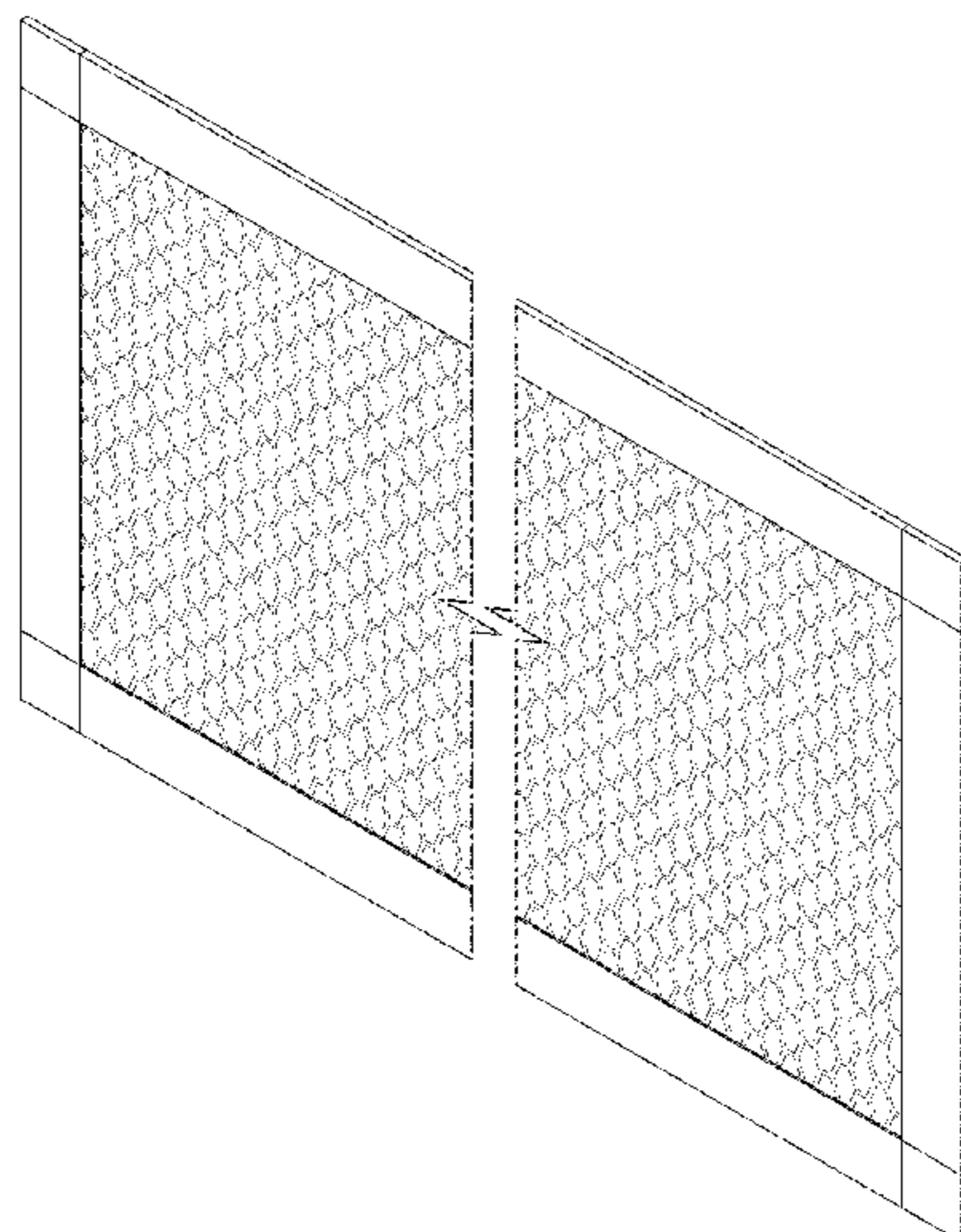
I claim the ornamental design for the crib liner, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view thereof.
FIG. 2 is a front elevation view thereof;
FIG. 3 is a back elevation view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is an enlarged detail view of area 8 circumscribed within FIG. 2.

The crib liner is shown with a symbolic break in its longest dimension. The symbolic break and the appearance of the article between the symbolic break lines forms no part of the claimed design.

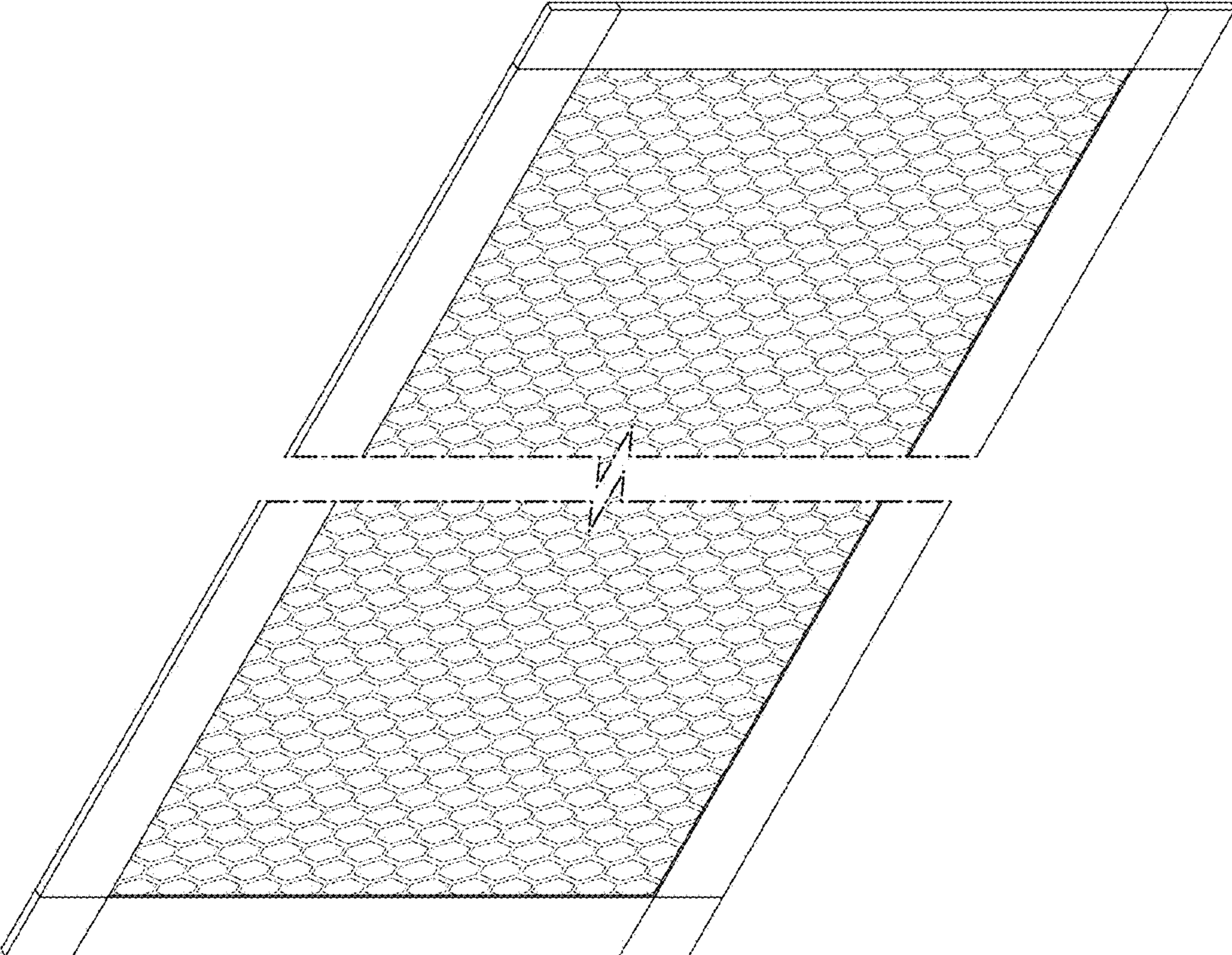

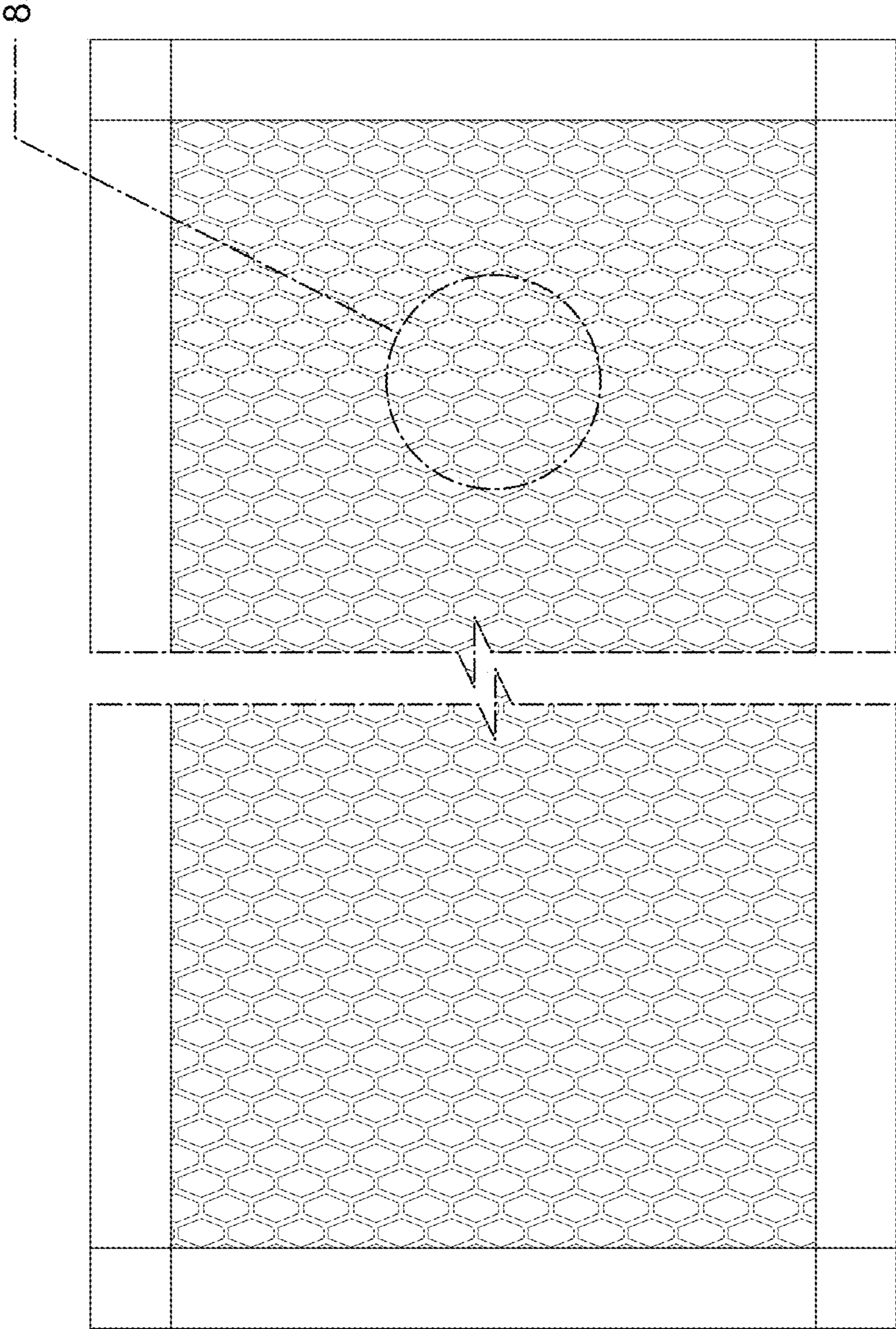

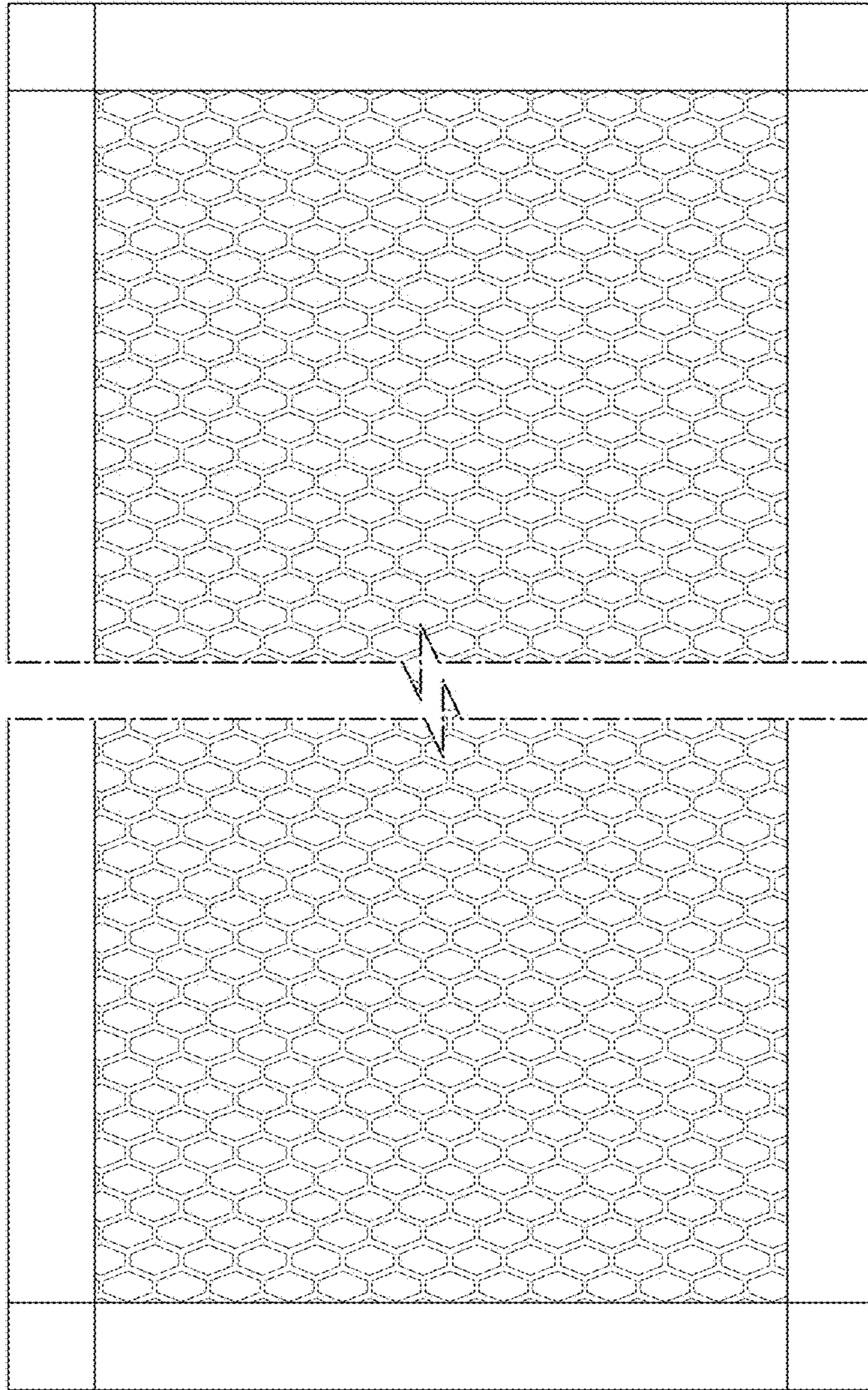

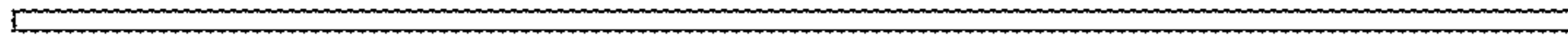

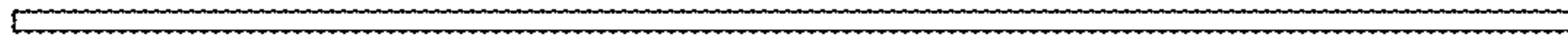

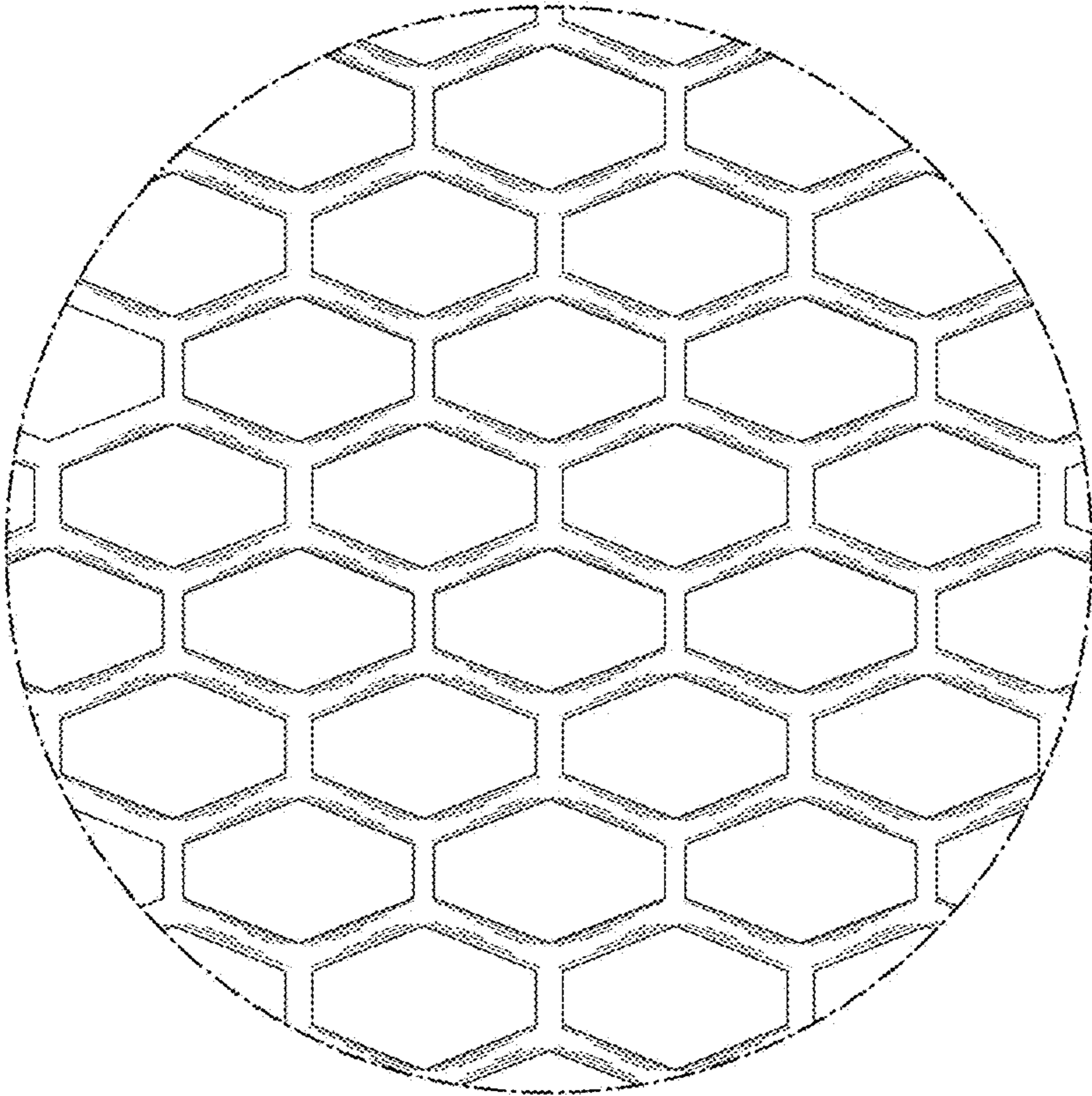
